FIG. 3 is a top plan view of an ornamental design for a pipe according to this invention disclosed and claimed herein;

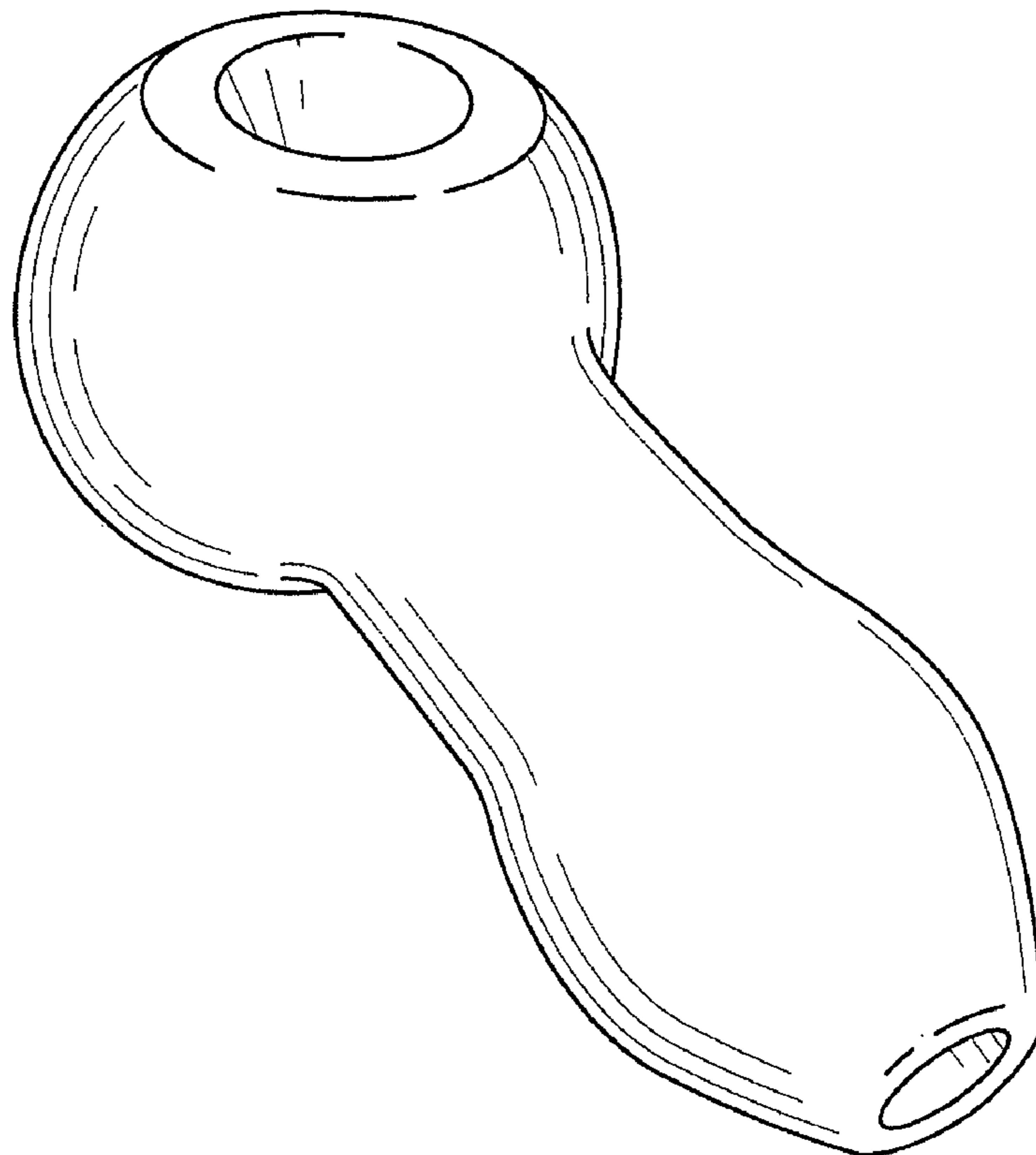
FIG. 4 is a bottom plan view of an ornamental design for a pipe according to this invention disclosed and claimed herein;

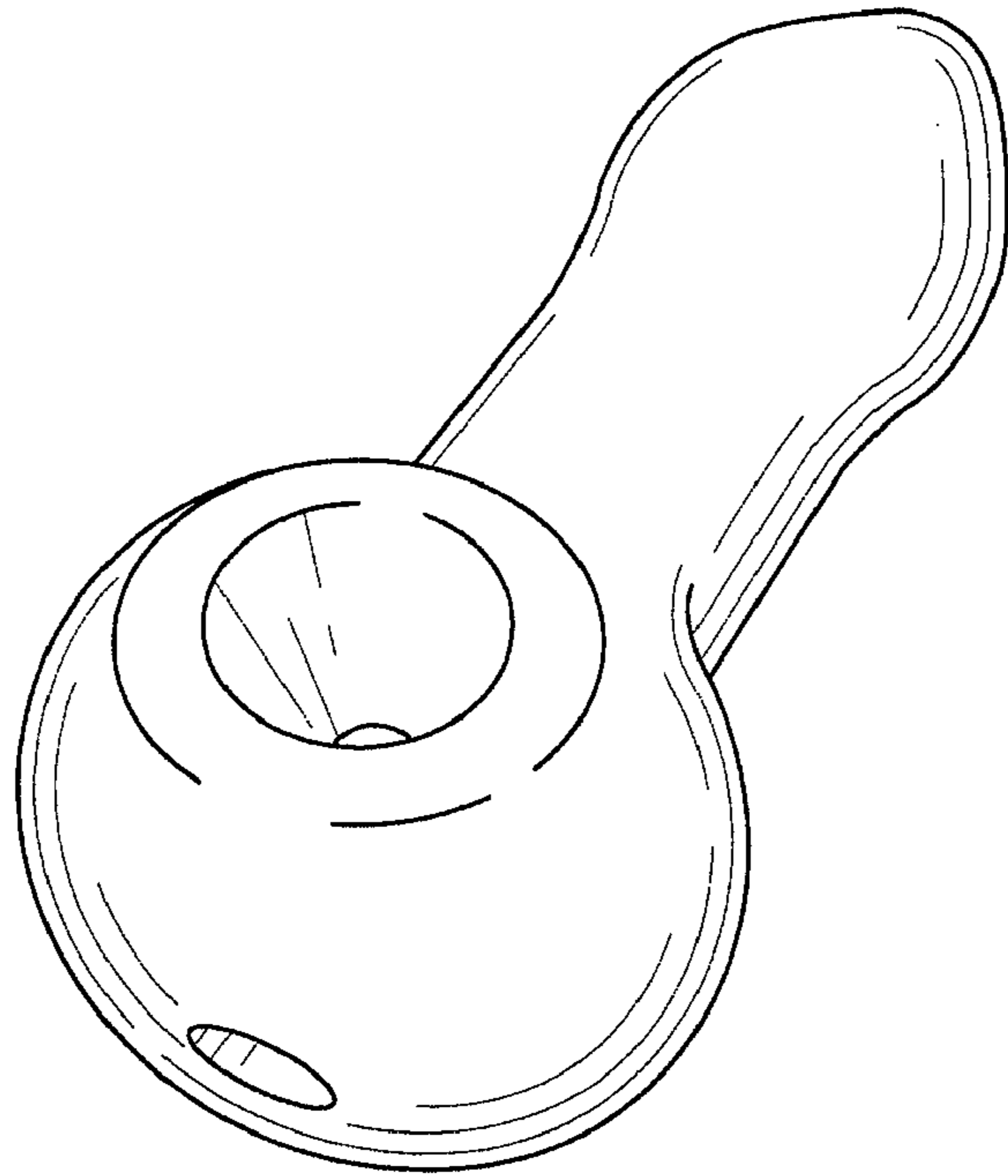
FIG. 5 is a side view of an ornamental design for a pipe according to this invention disclosed and claimed herein;

FIG. 6 is a front view of an ornamental design for a pipe according to this invention disclosed and claimed herein; and,

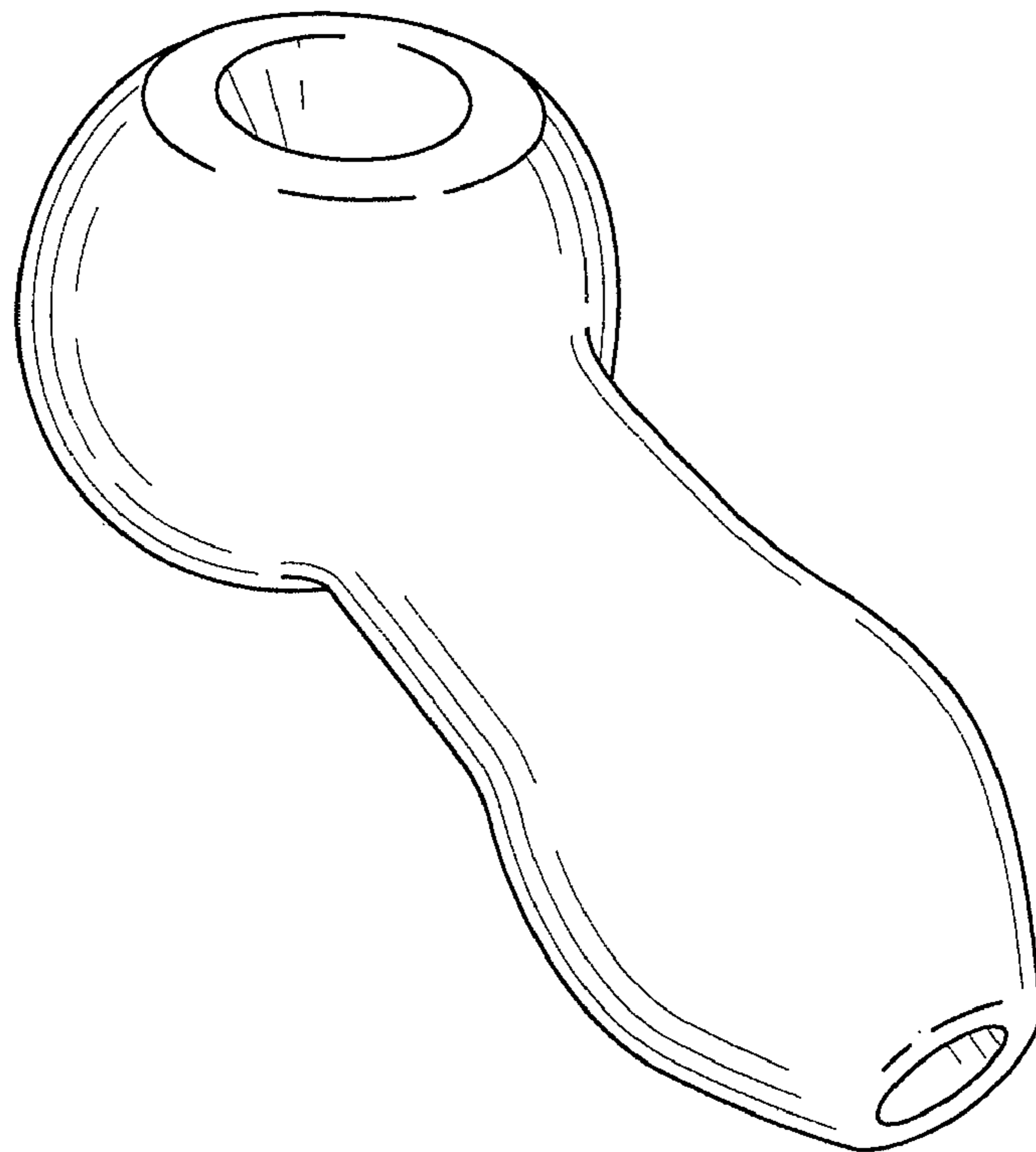
FIG. 7 is a rear view of an ornamental design for a pipe according to this invention disclosed and claimed herein.

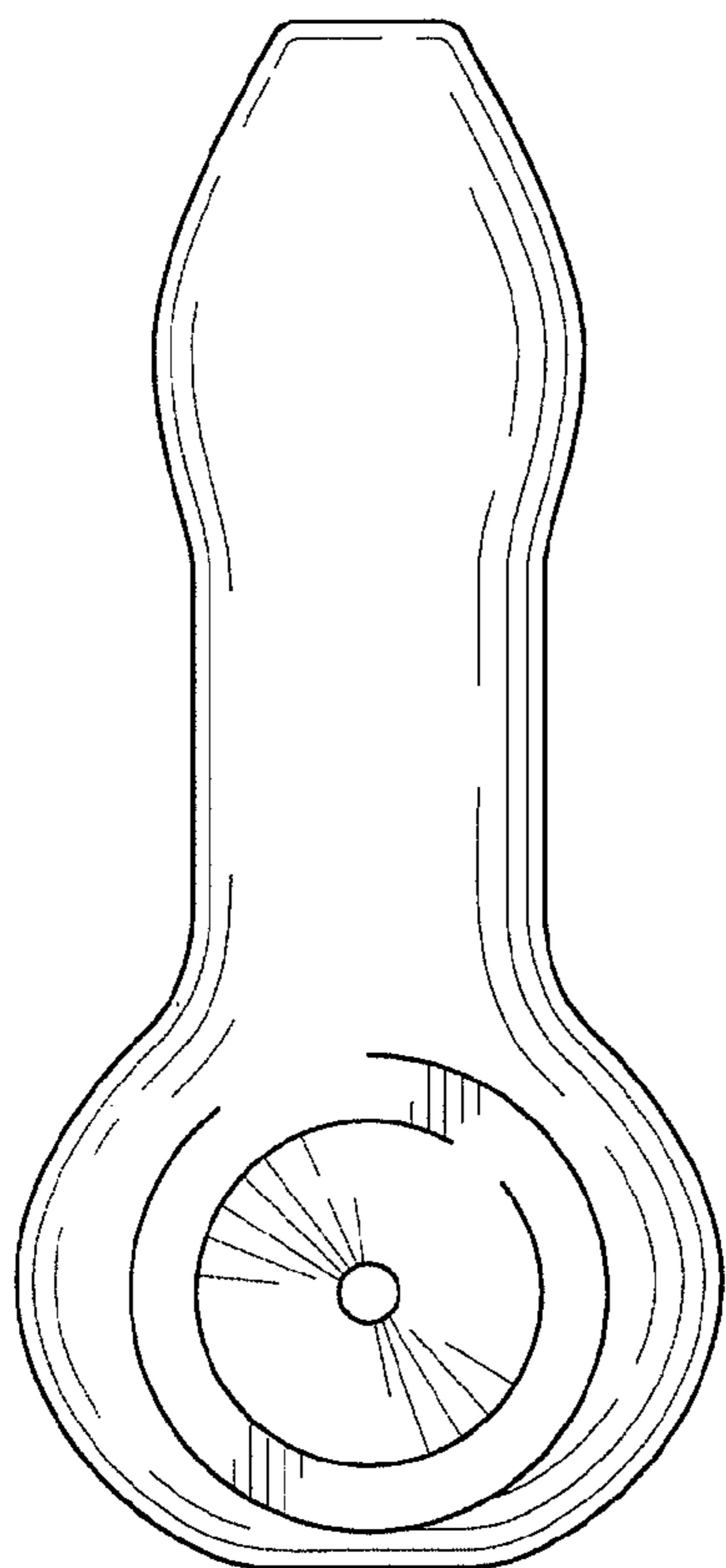




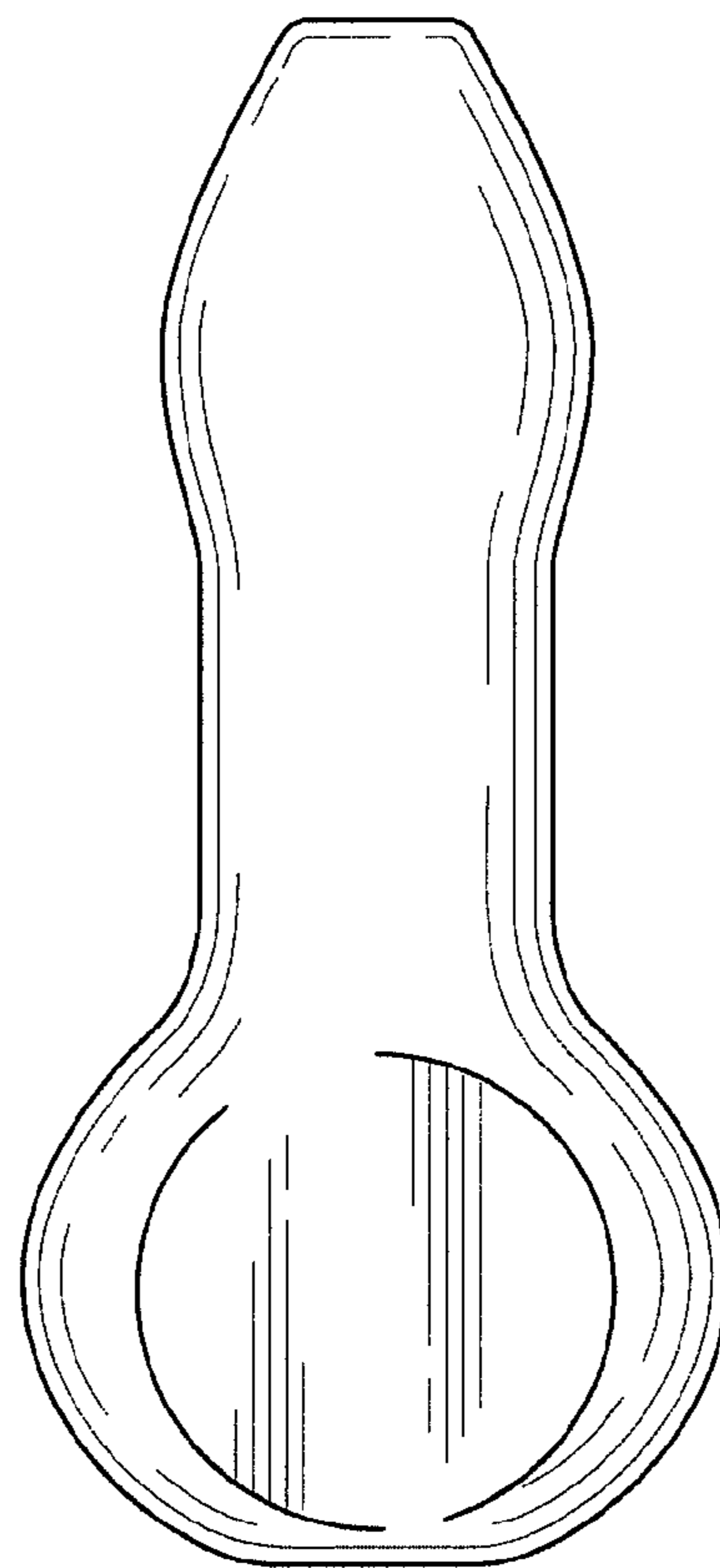

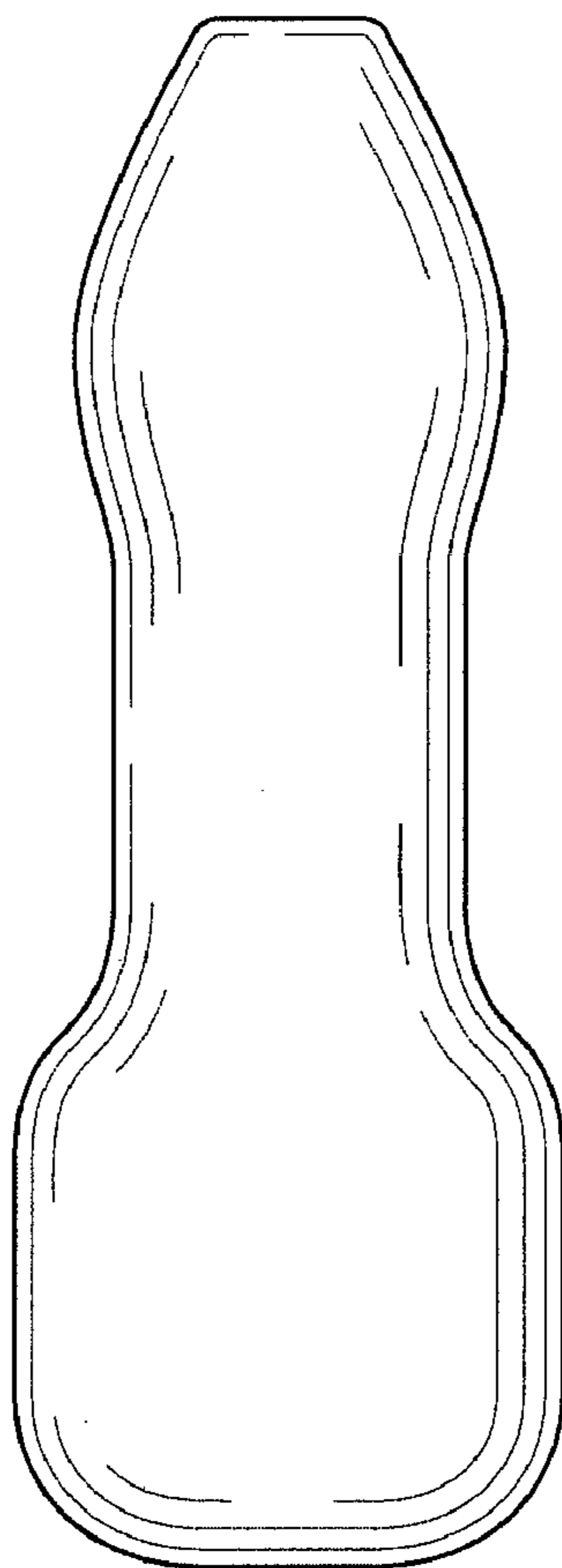

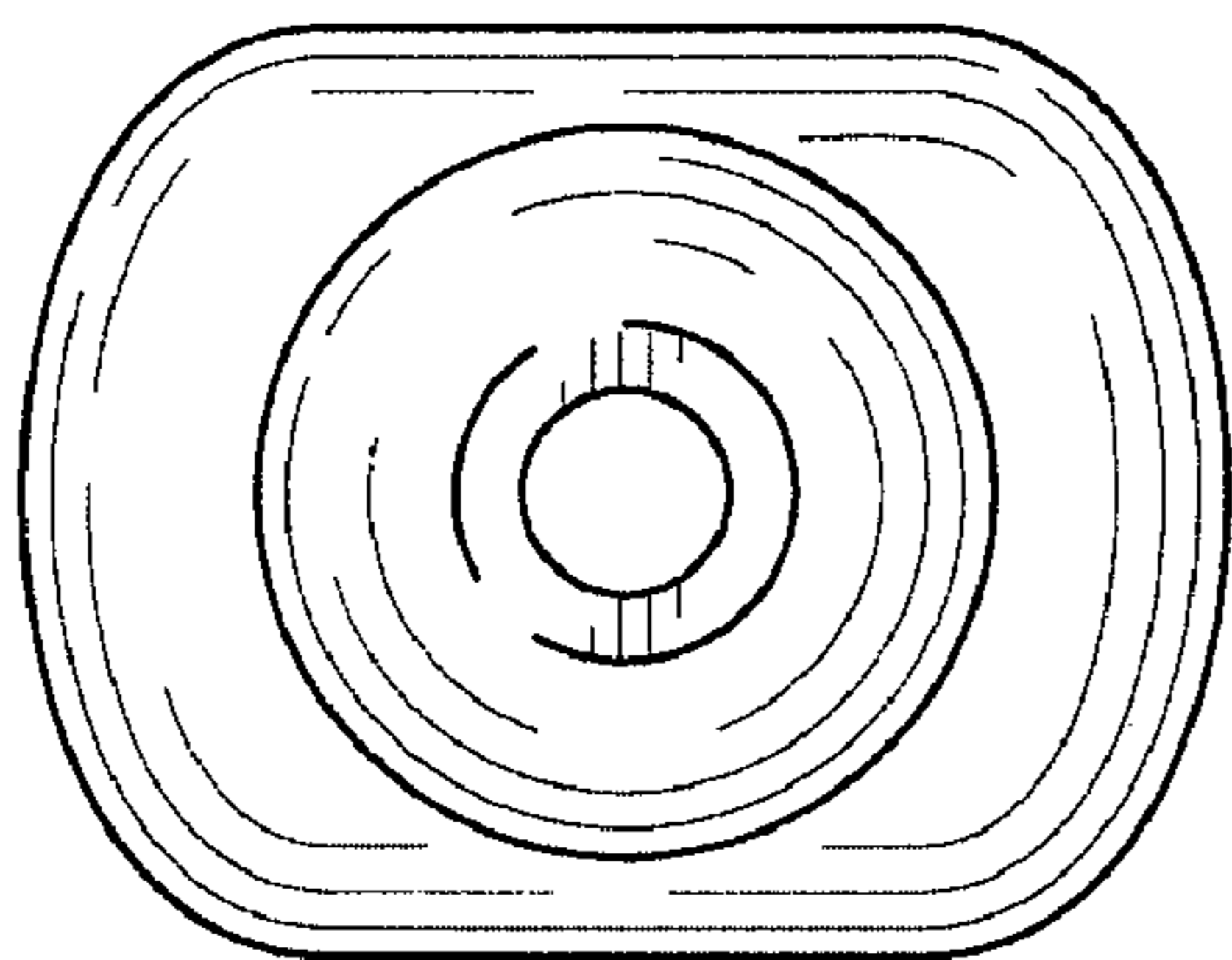

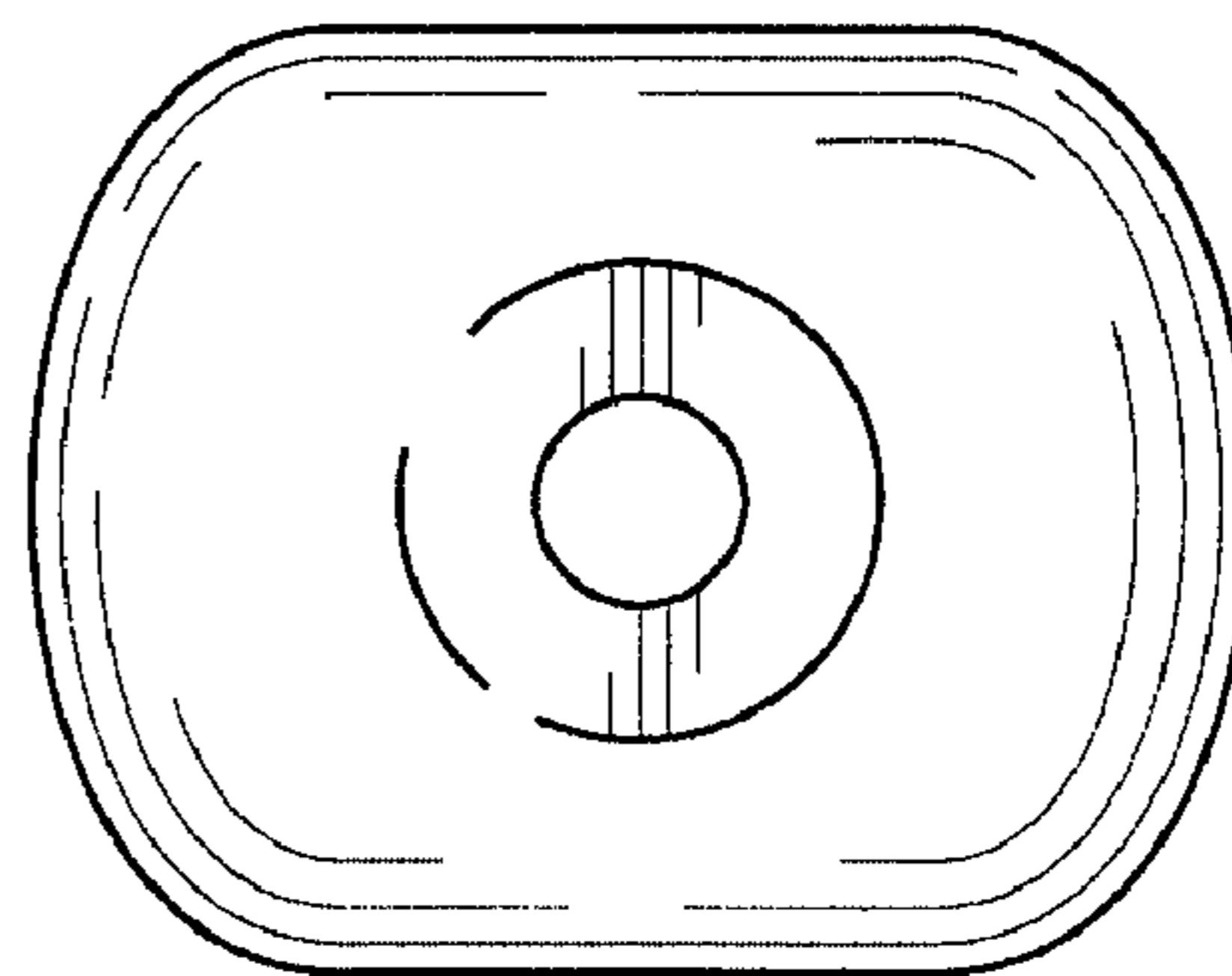
