We claim the ornamental design for a washing machine, as shown and described.

**DESCRIPTION**

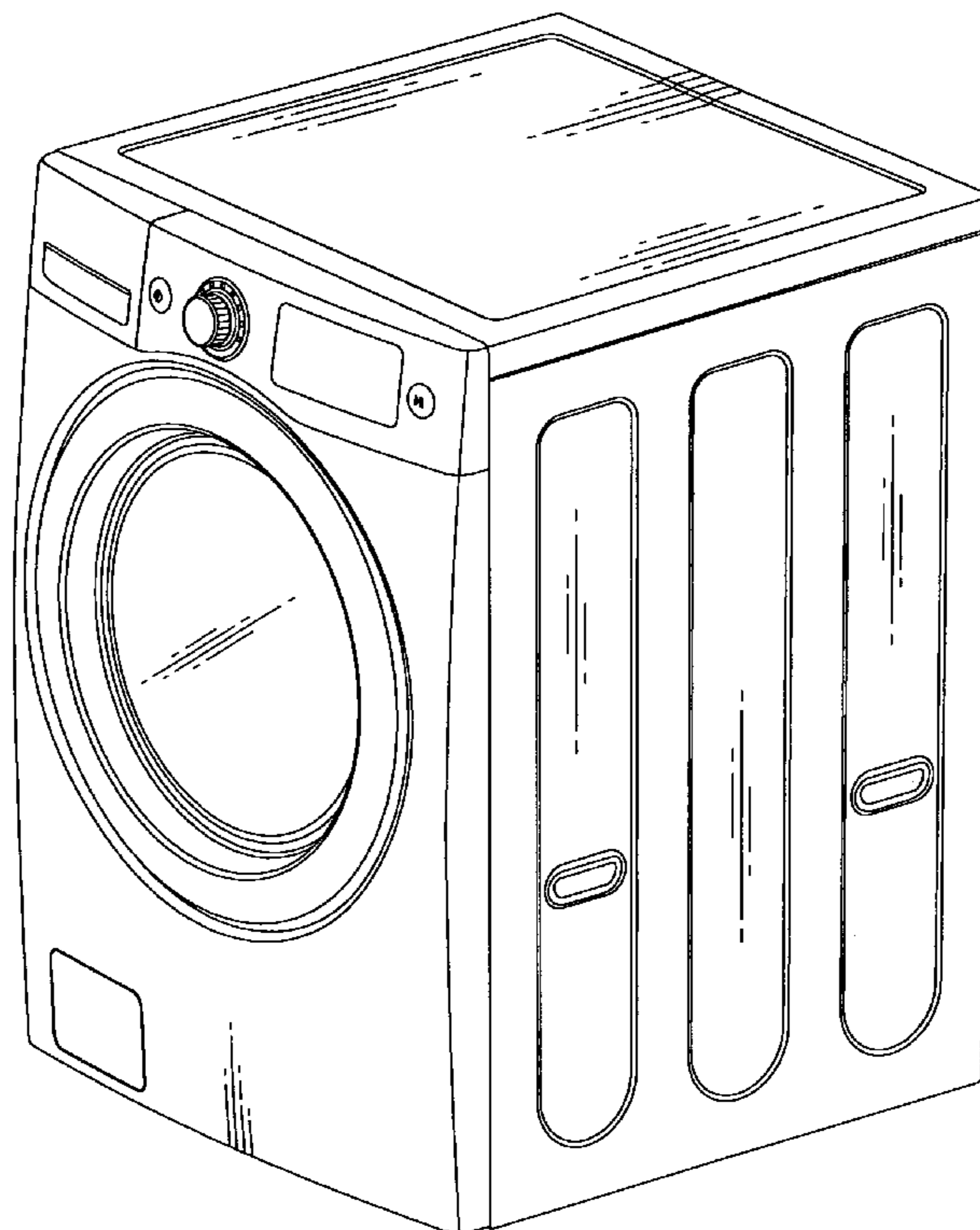

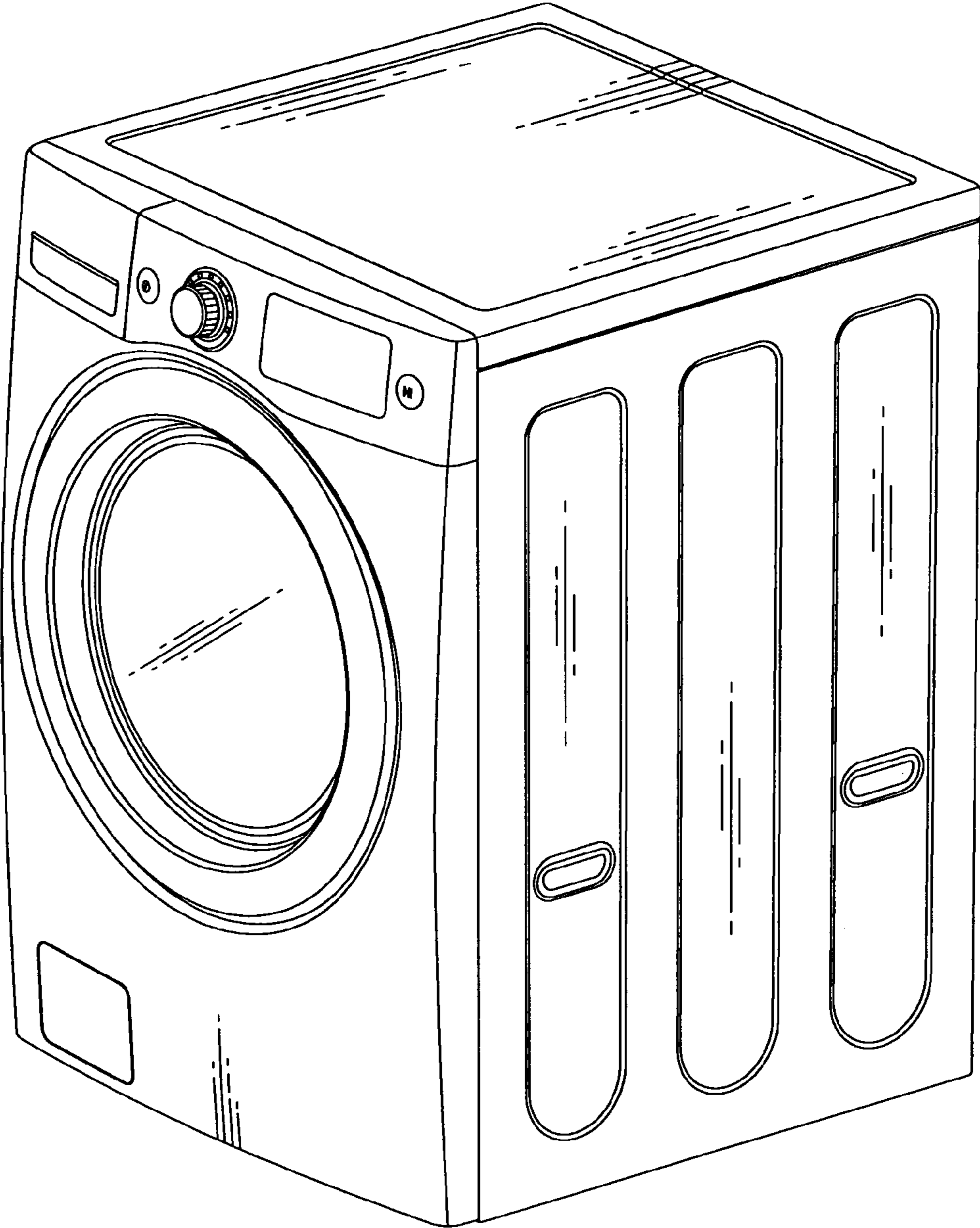

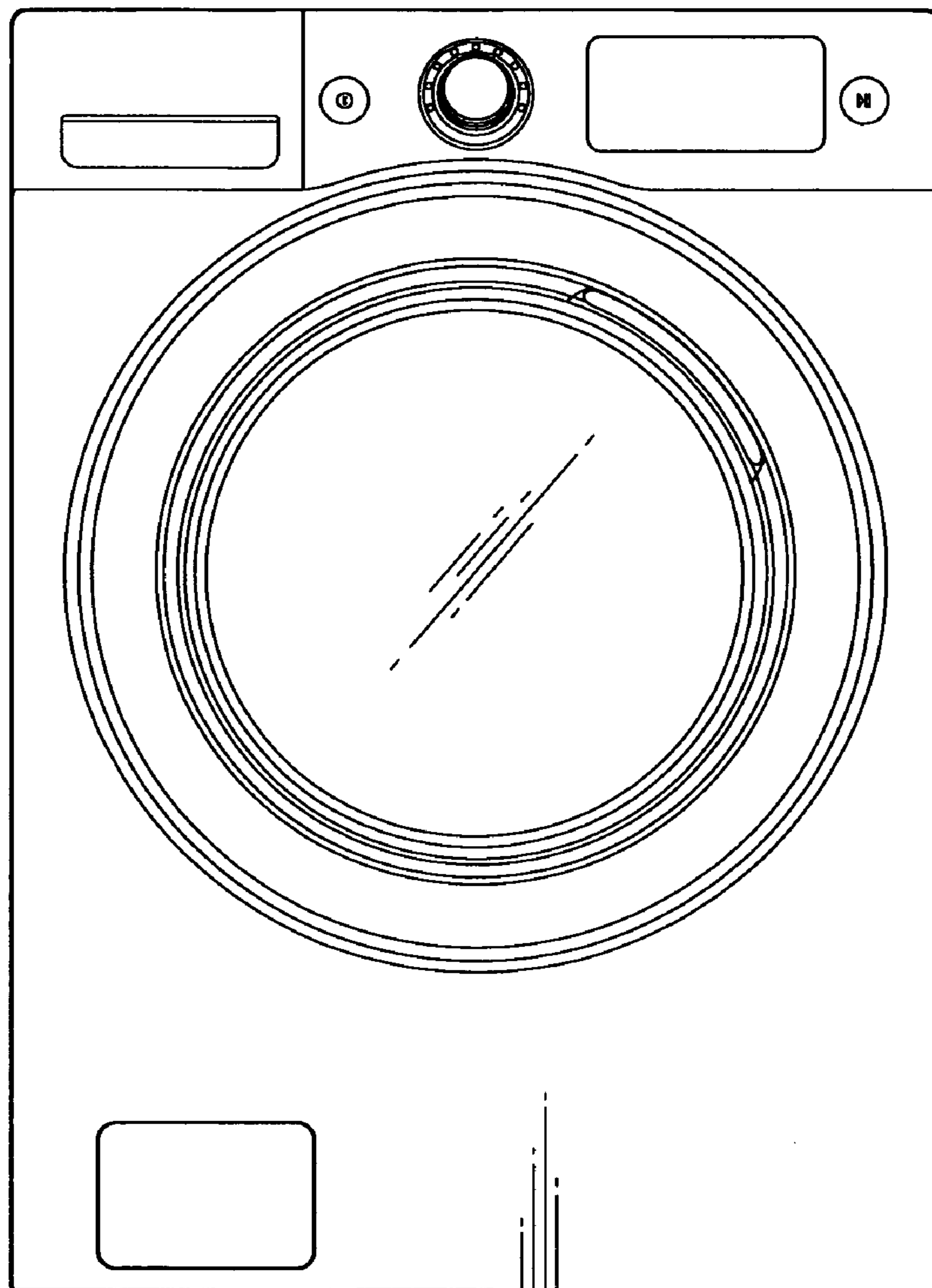

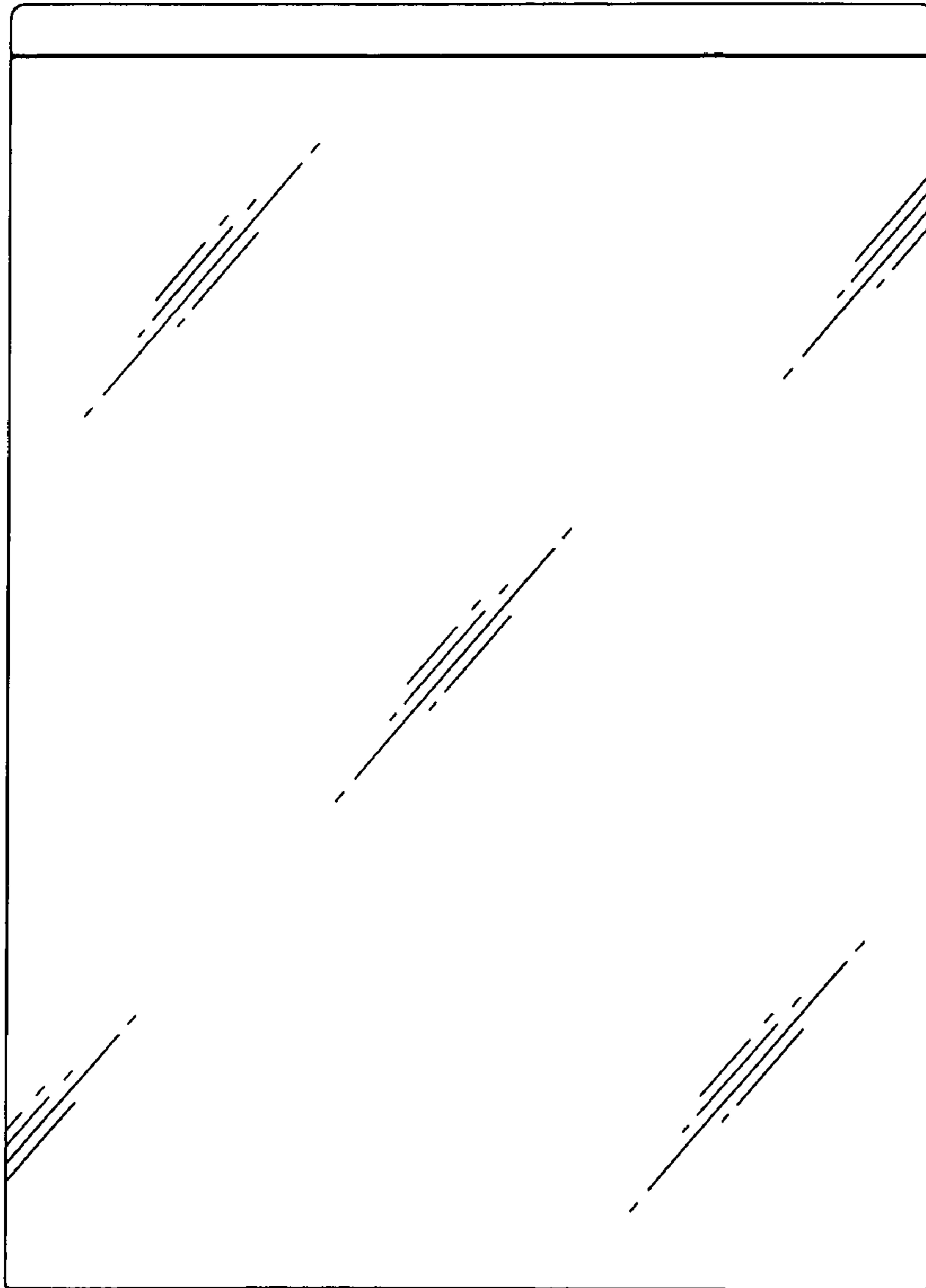

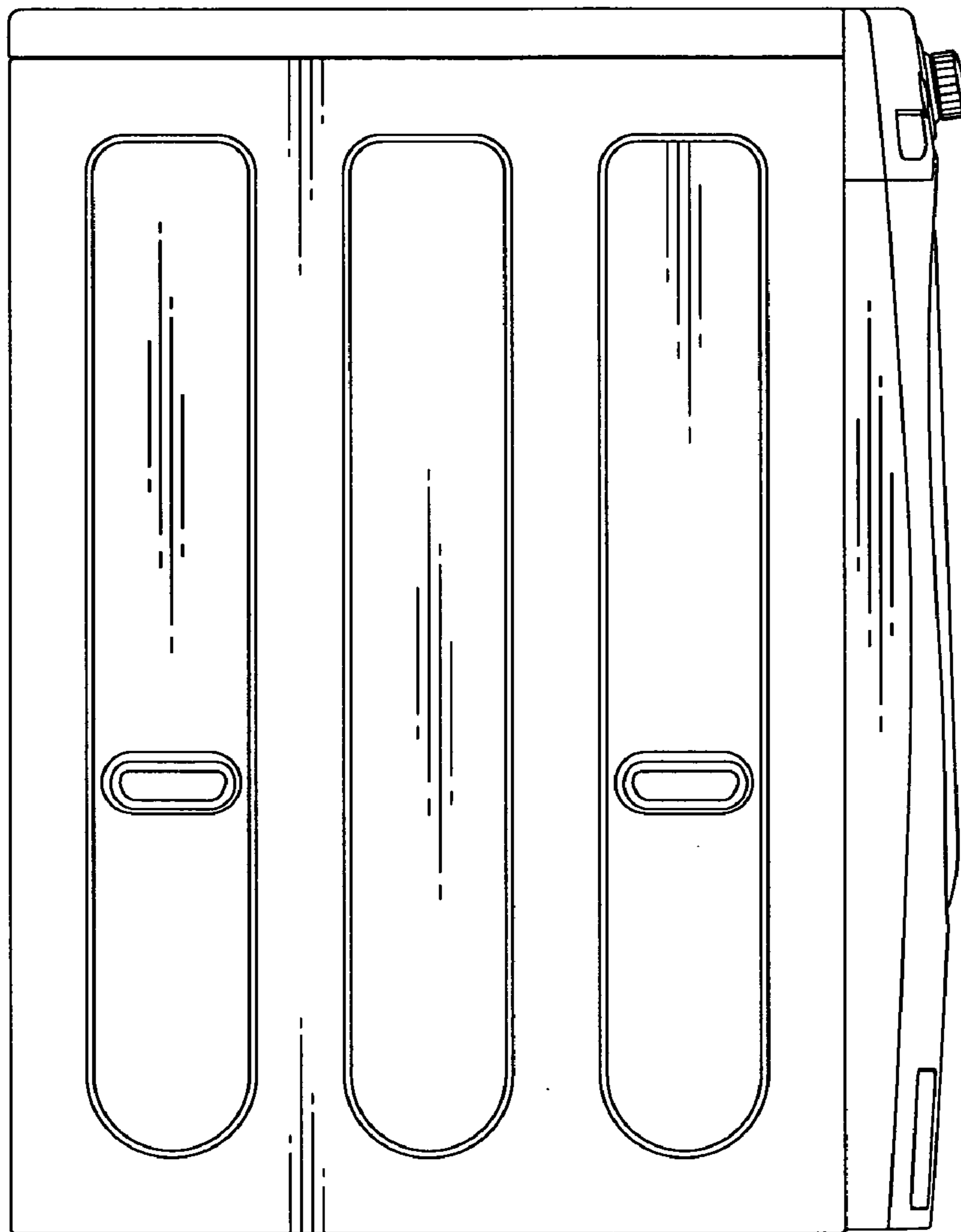

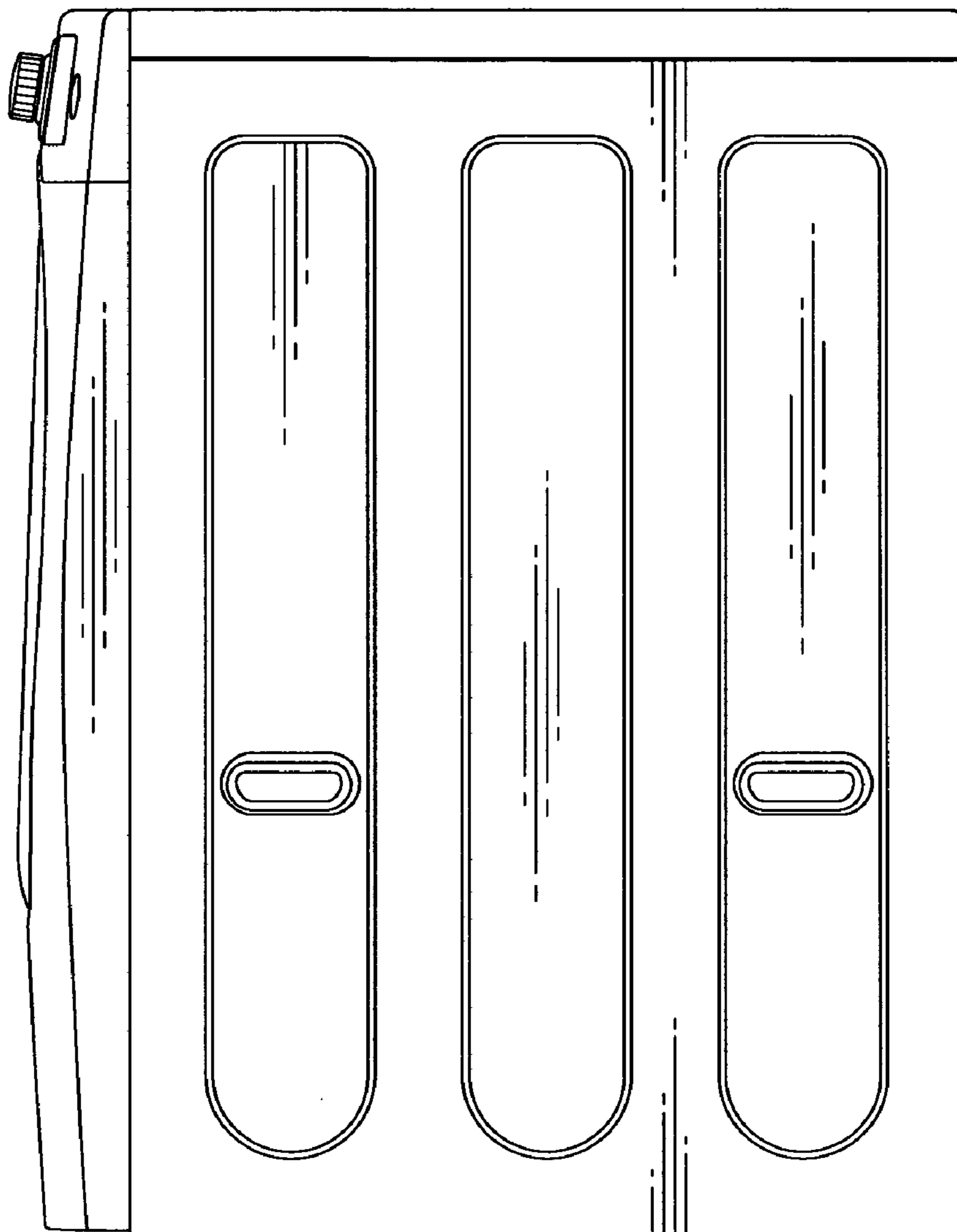

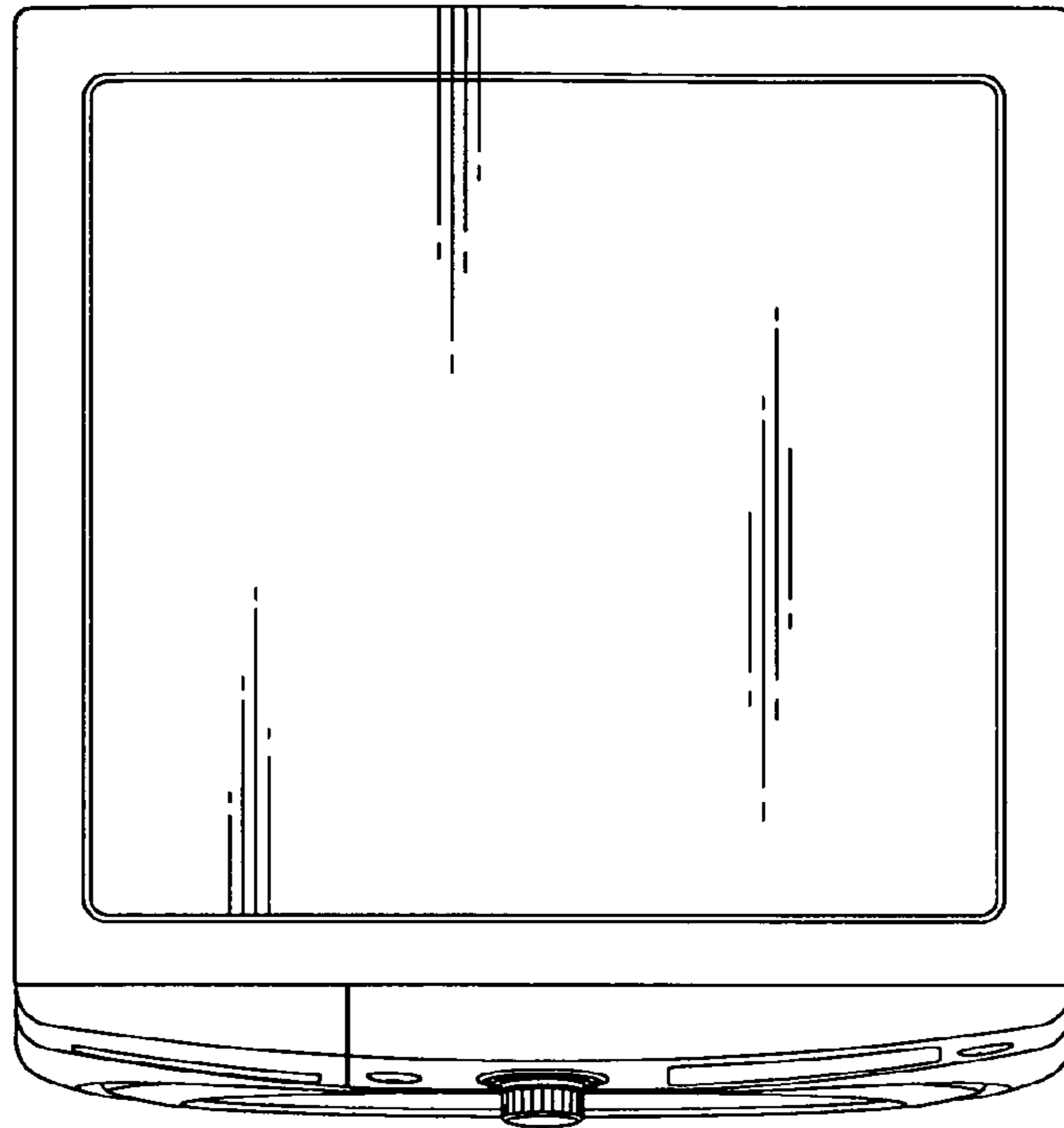
