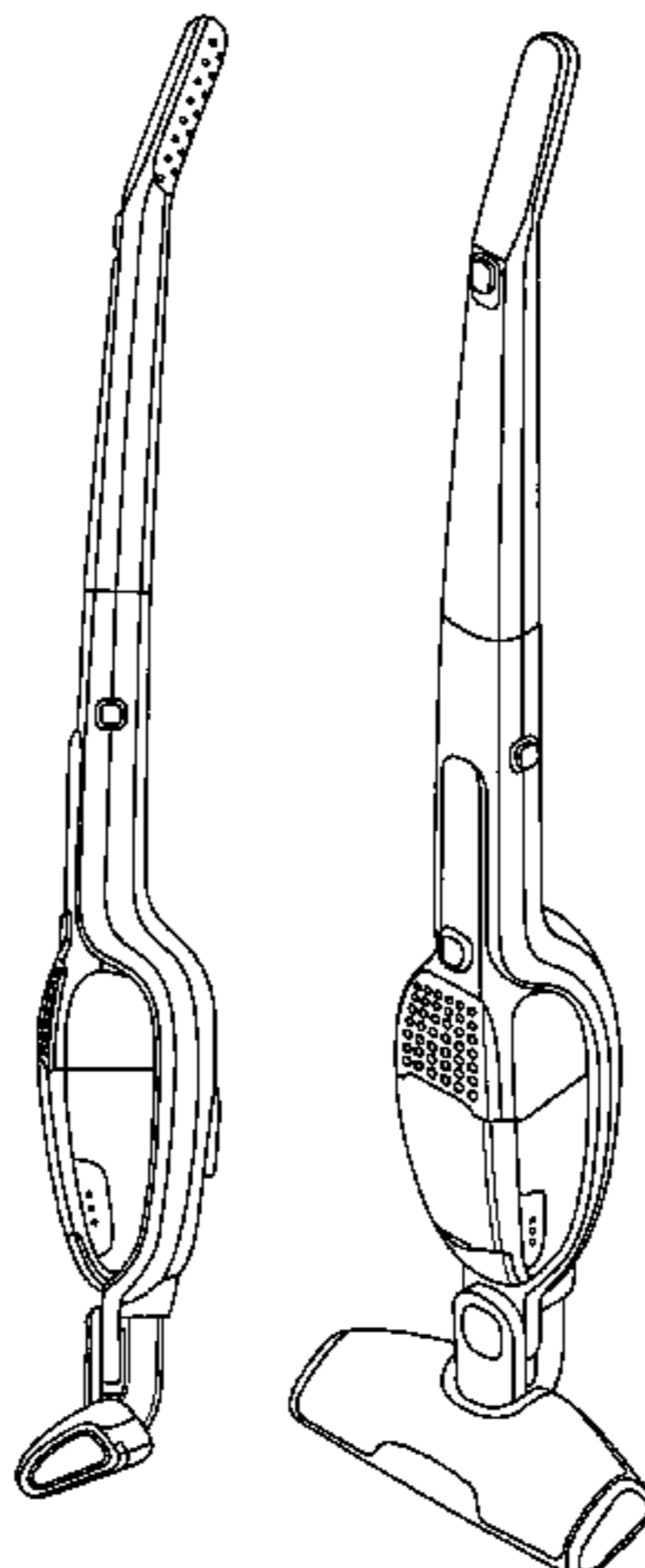
(57) **CLAIM**

We claim the ornamental design for a convertible stick vacuum, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a convertible stick vacuum showing our new design;

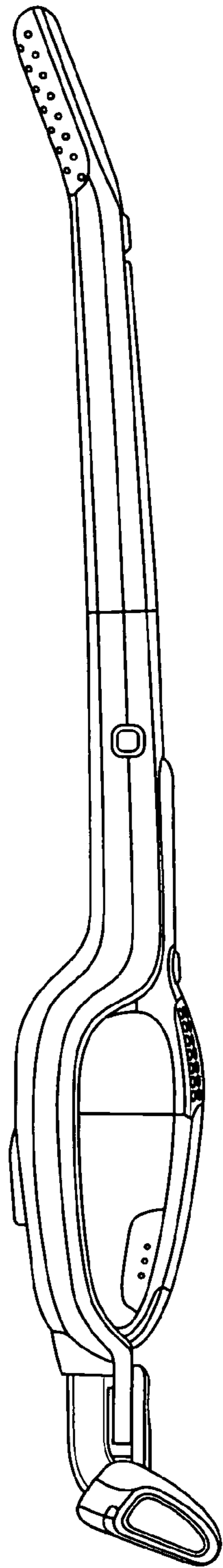

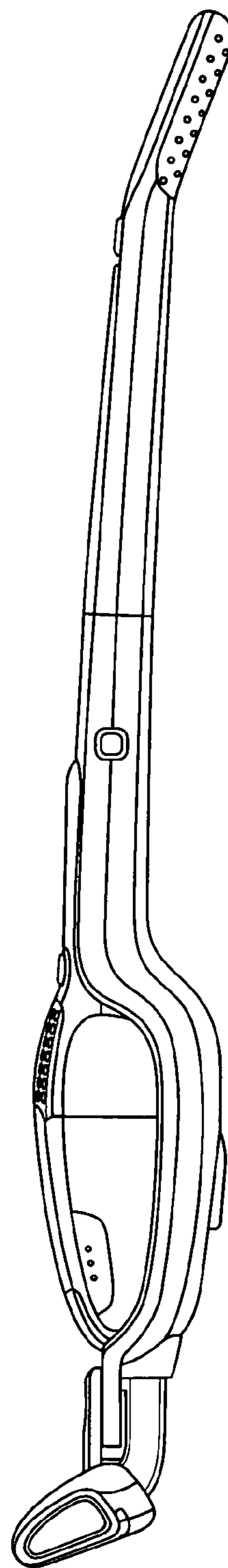

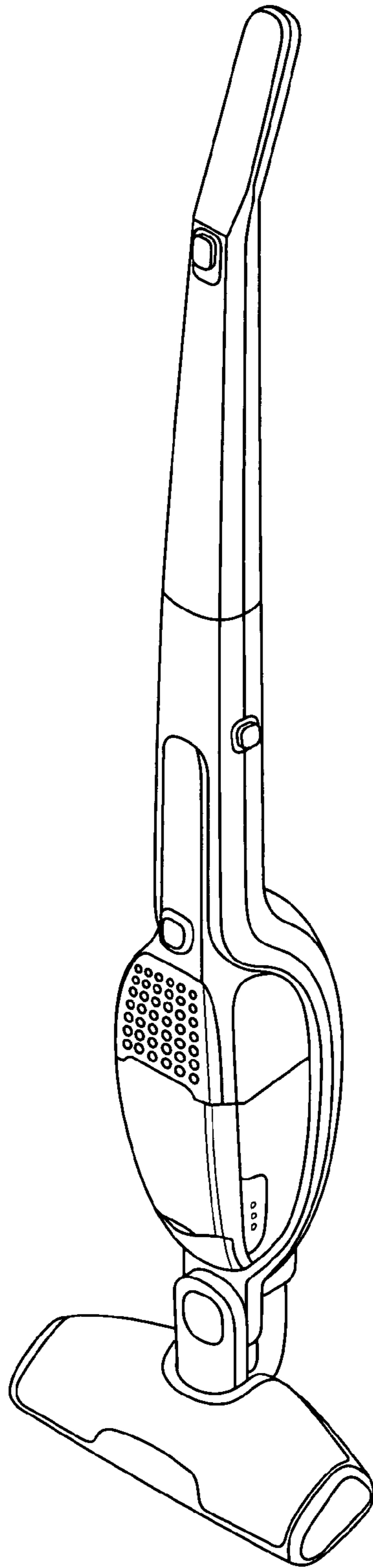

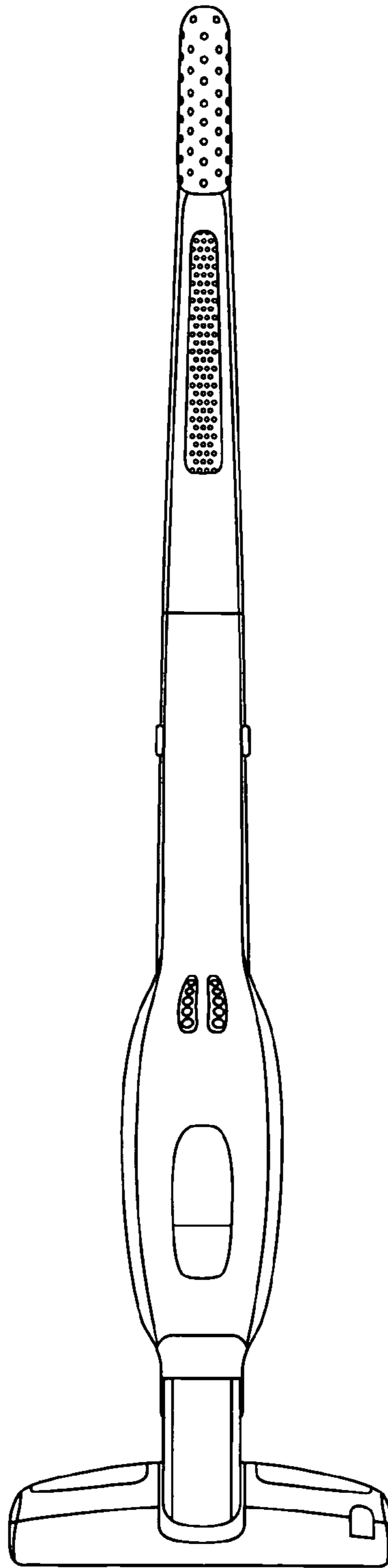

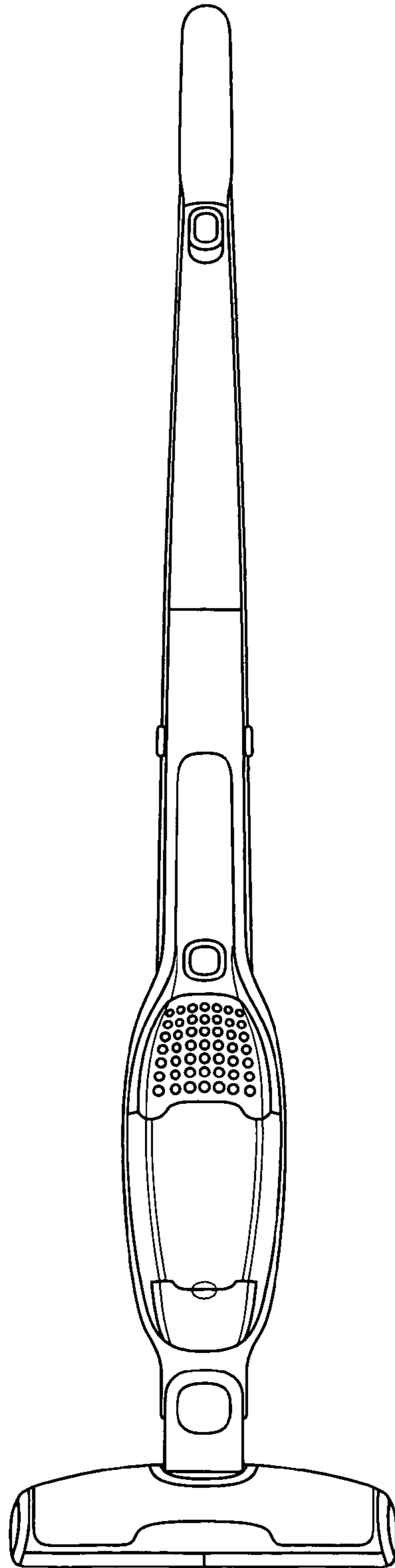

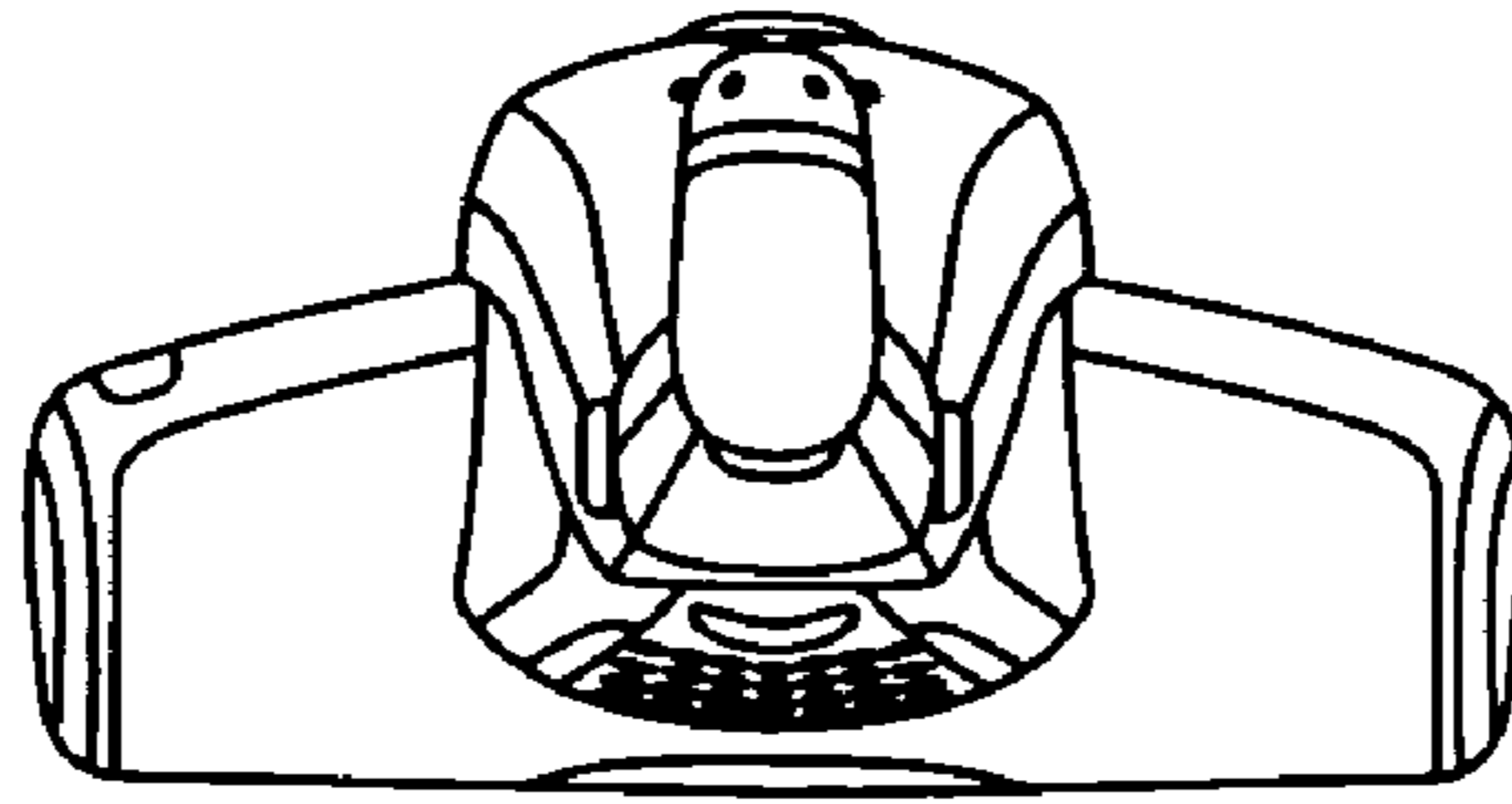

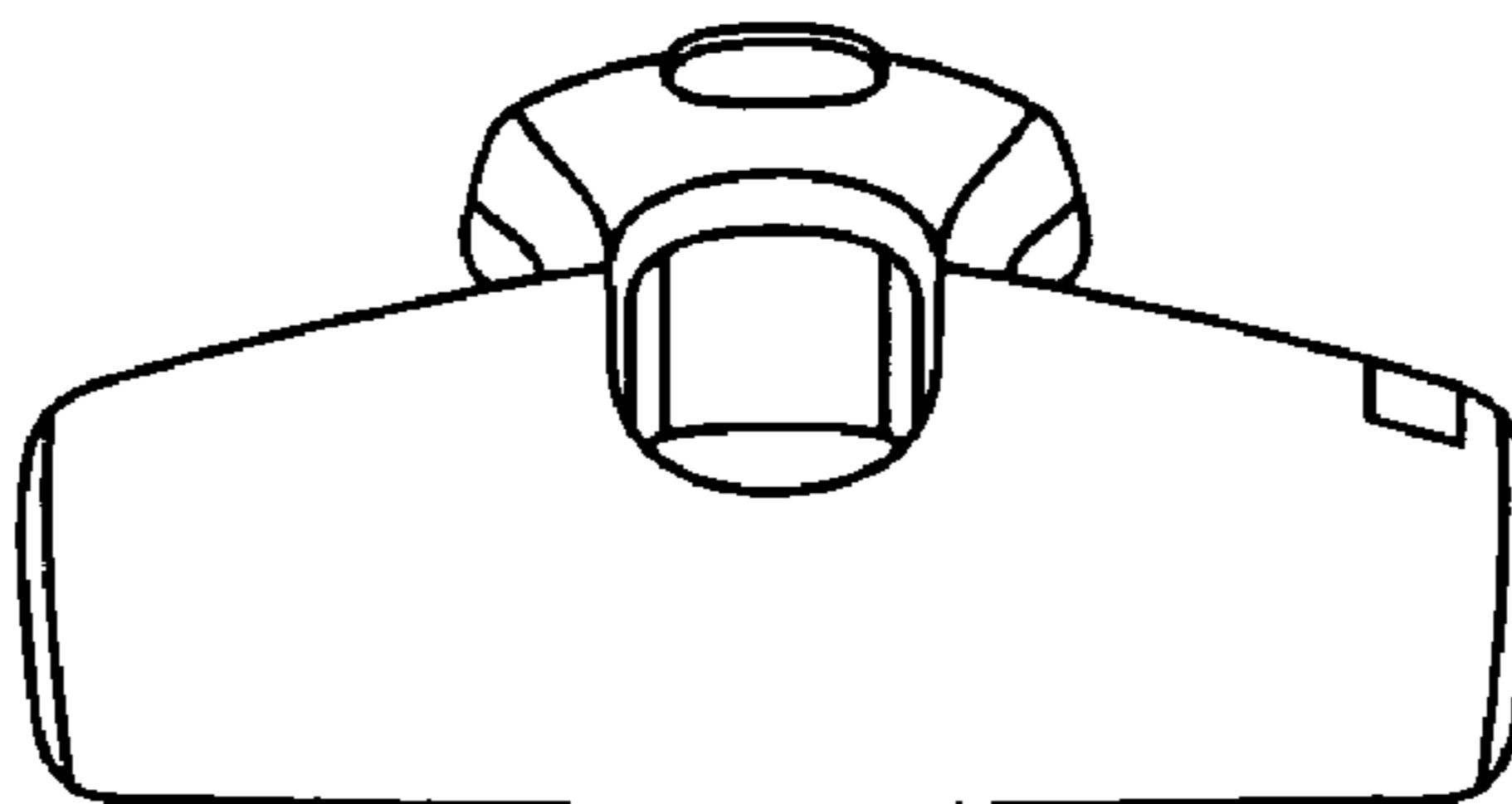
