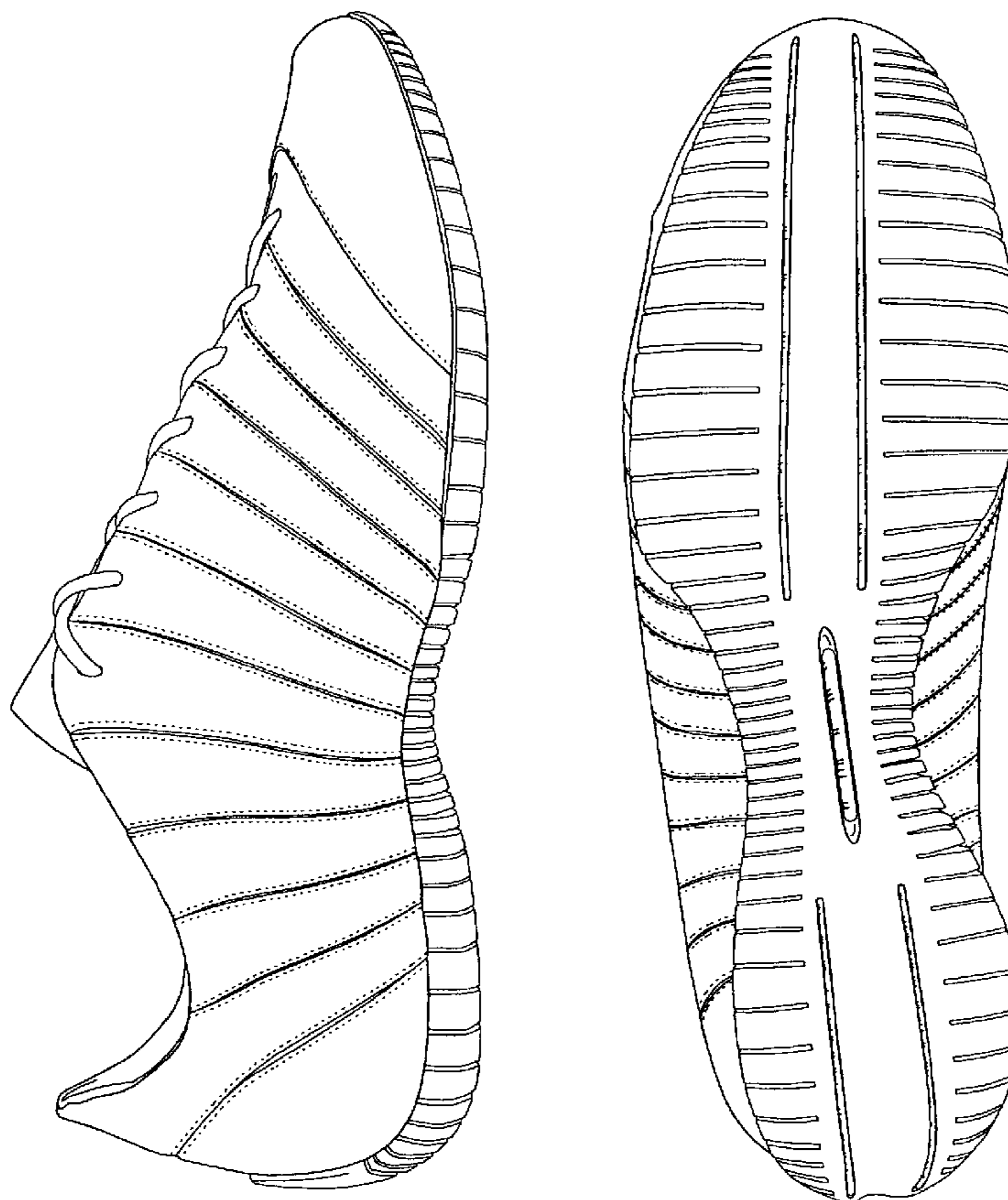

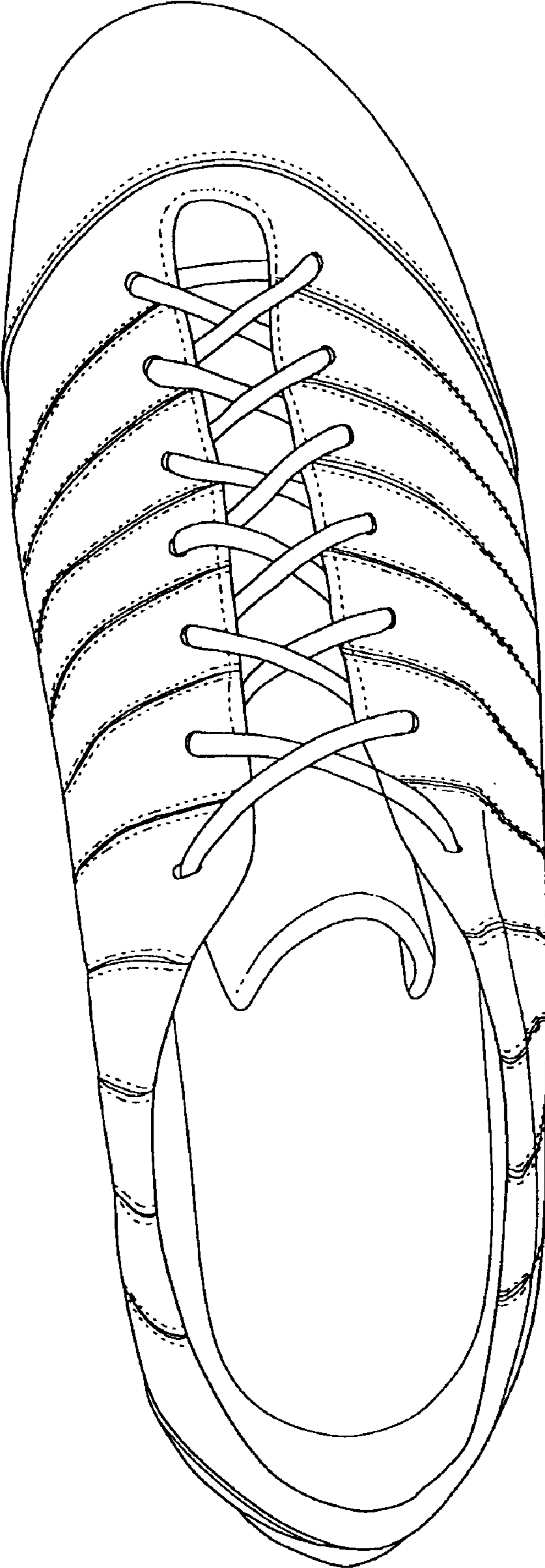
The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

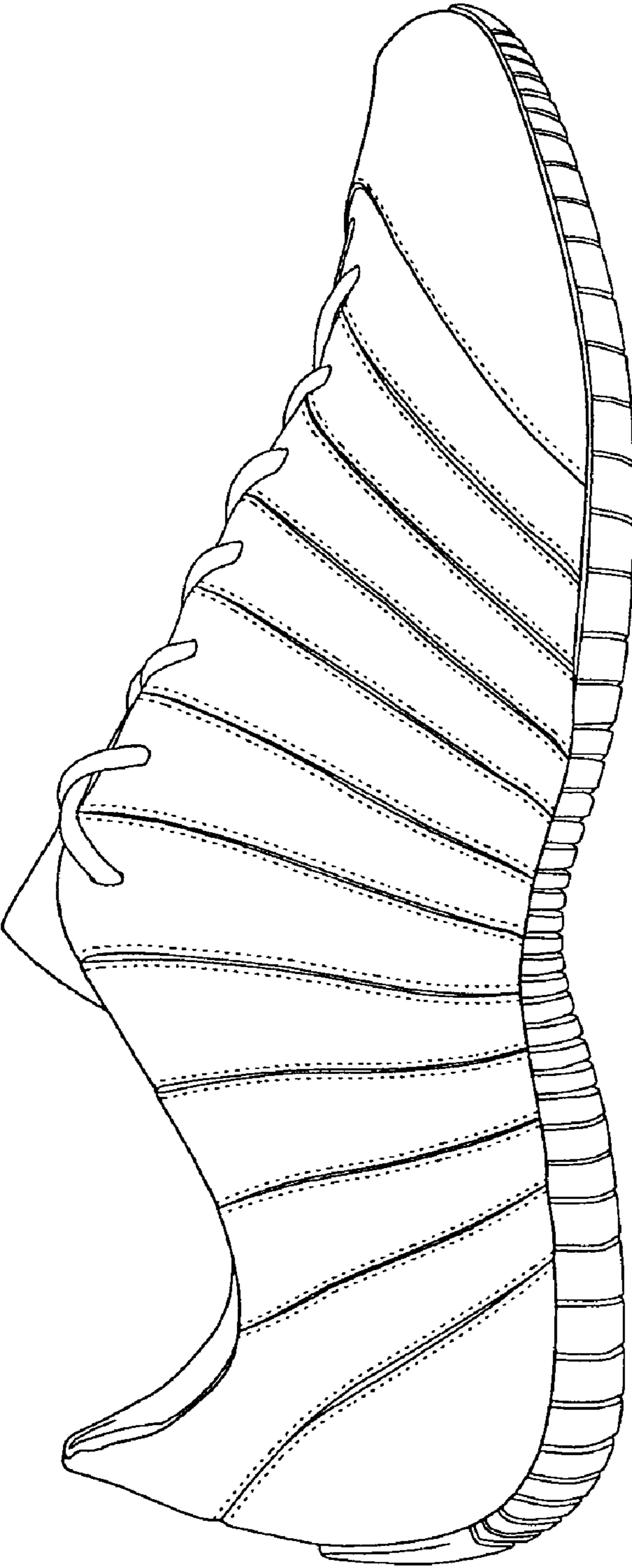
FIG. 1 is a top view of a shoe of my design;

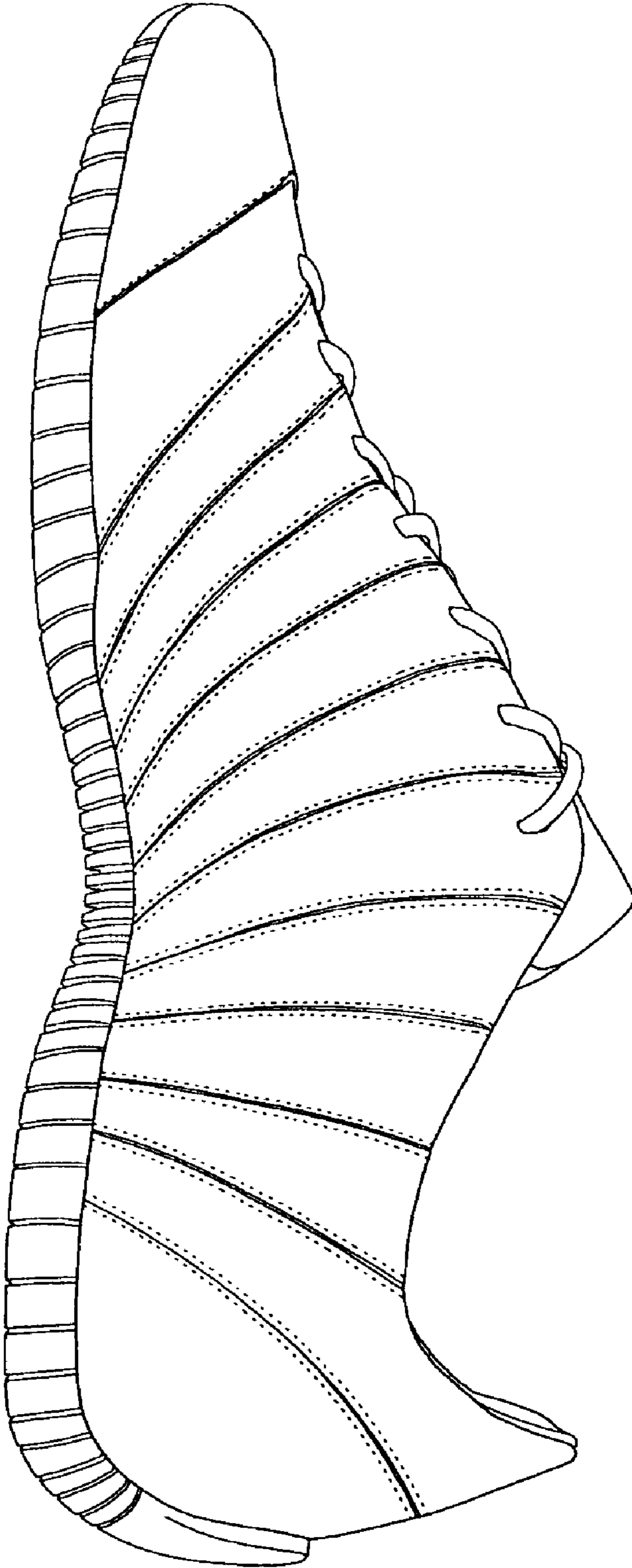




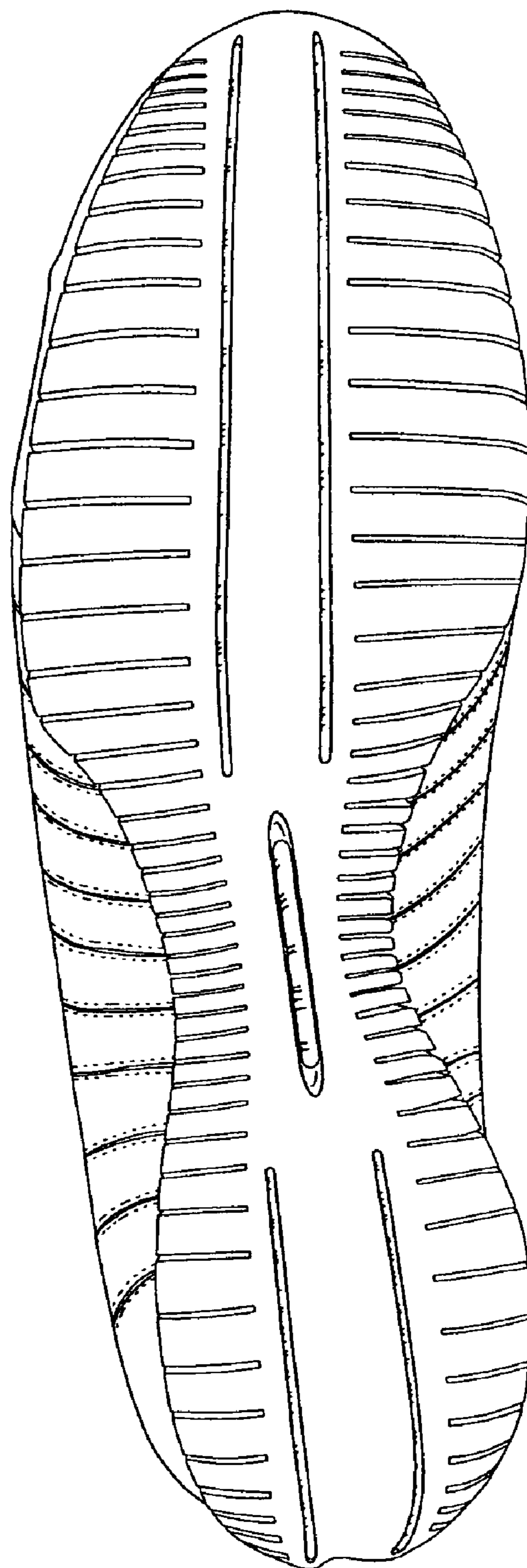

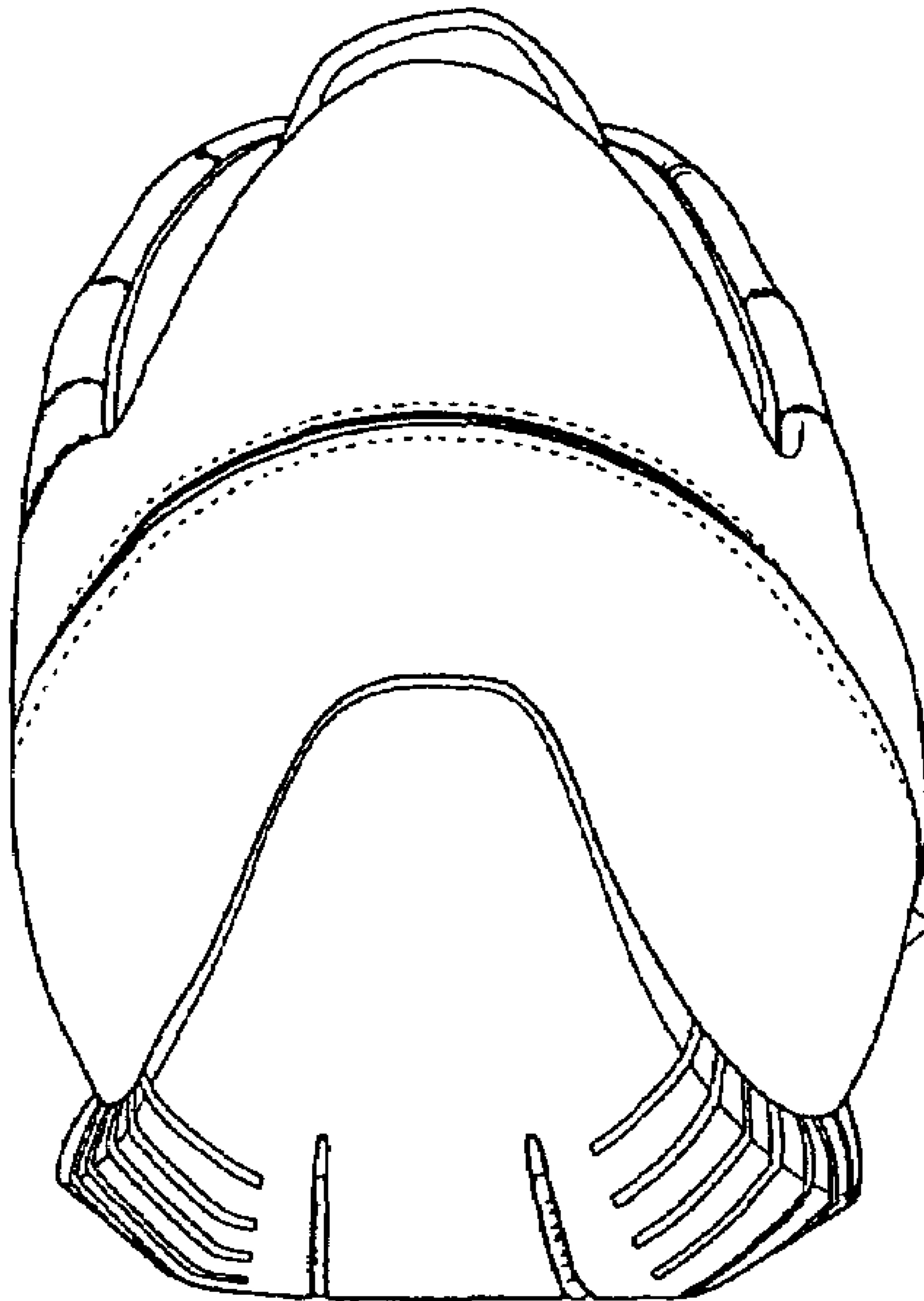
