DESCRIPTION

FIG. 1 is a front view of a head portion of a toothbrush
showing my design;

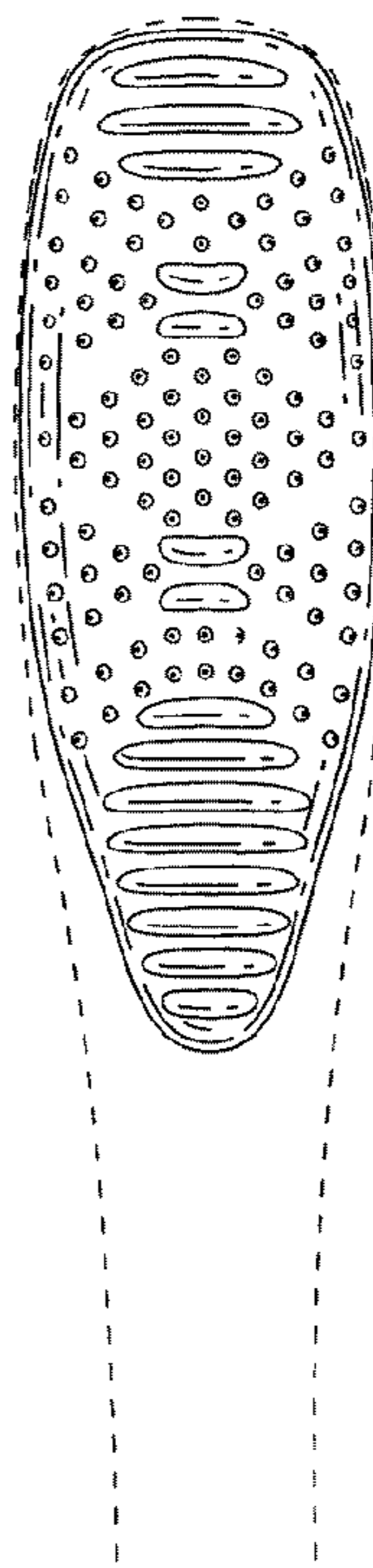
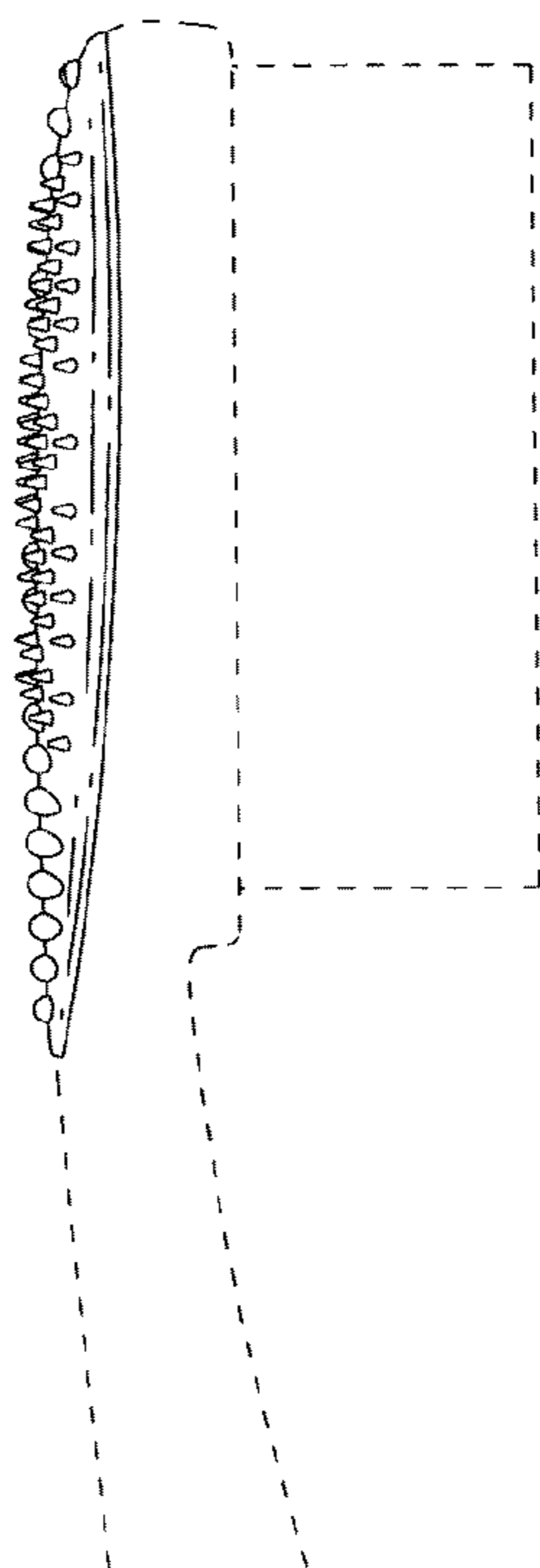

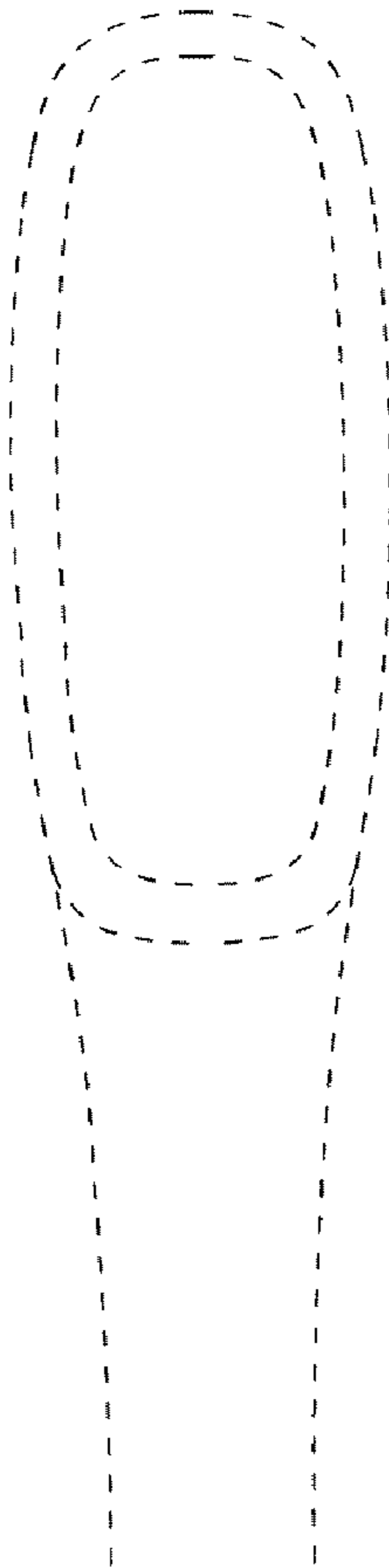

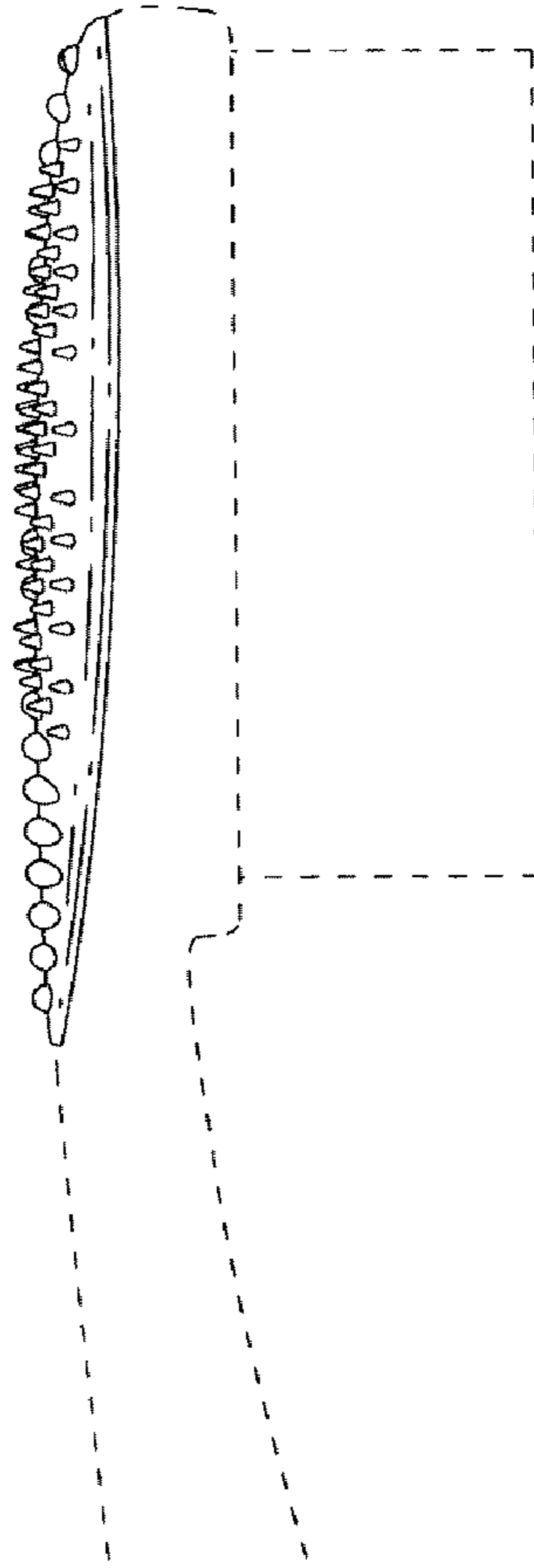

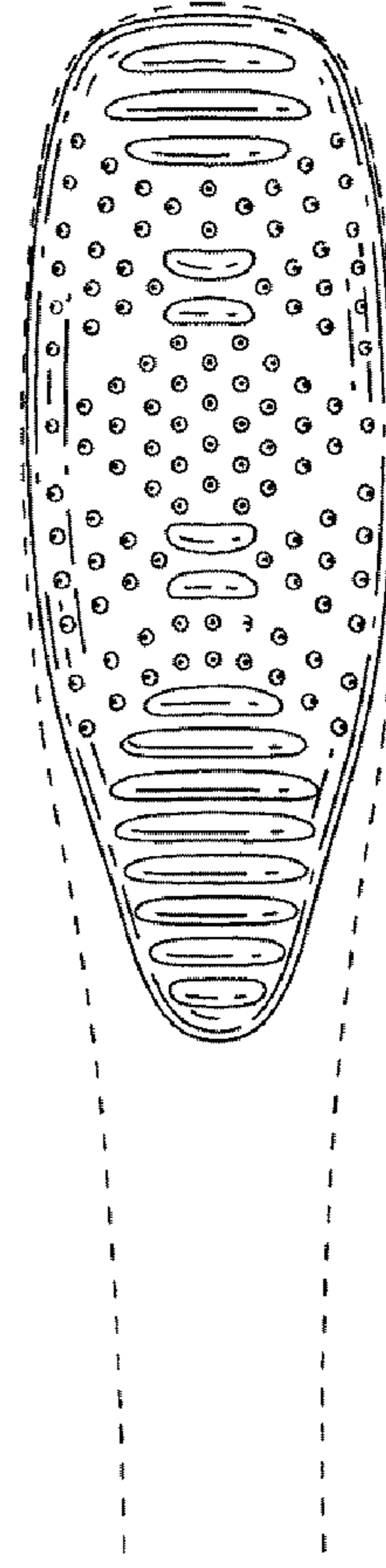

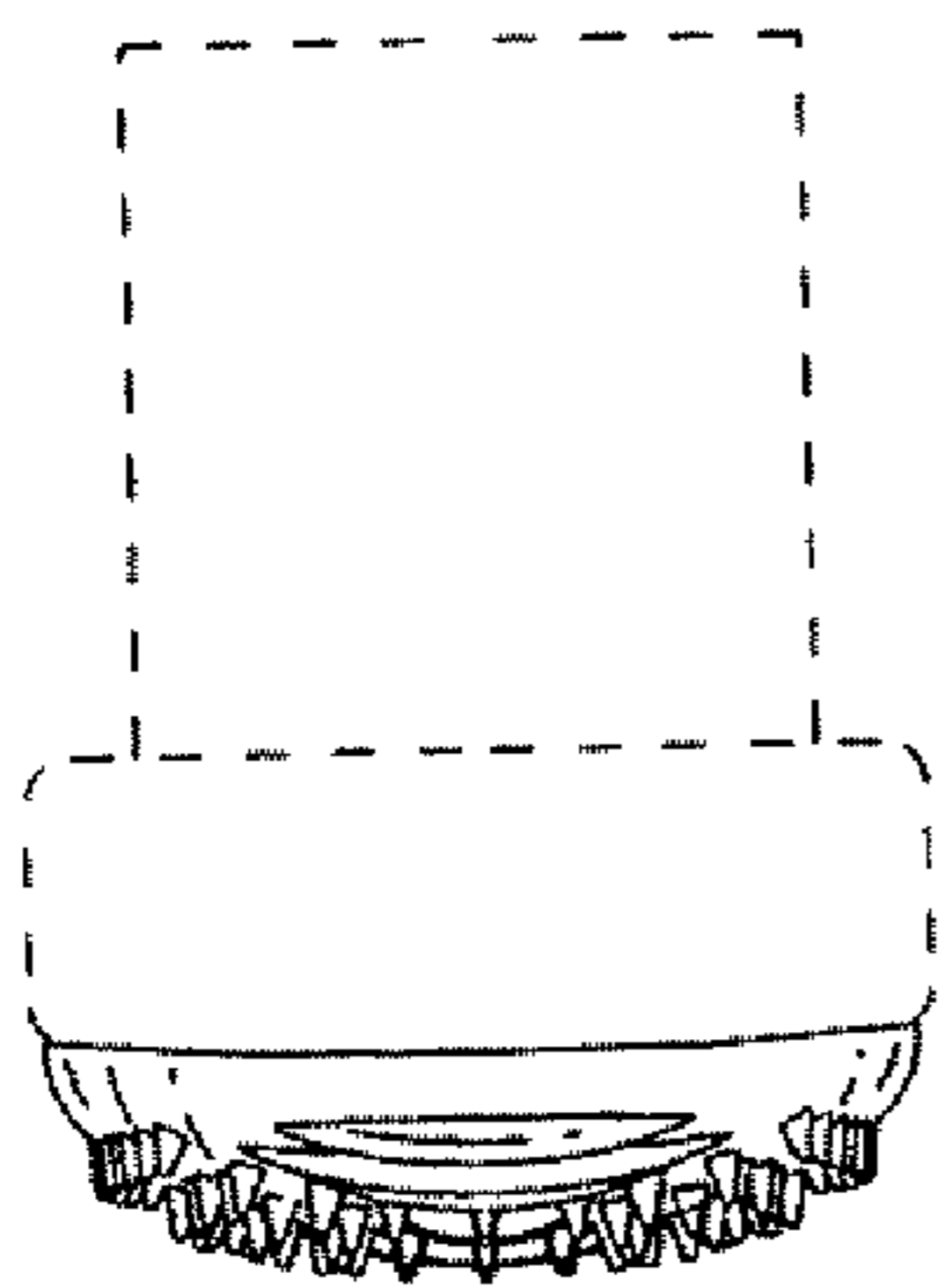
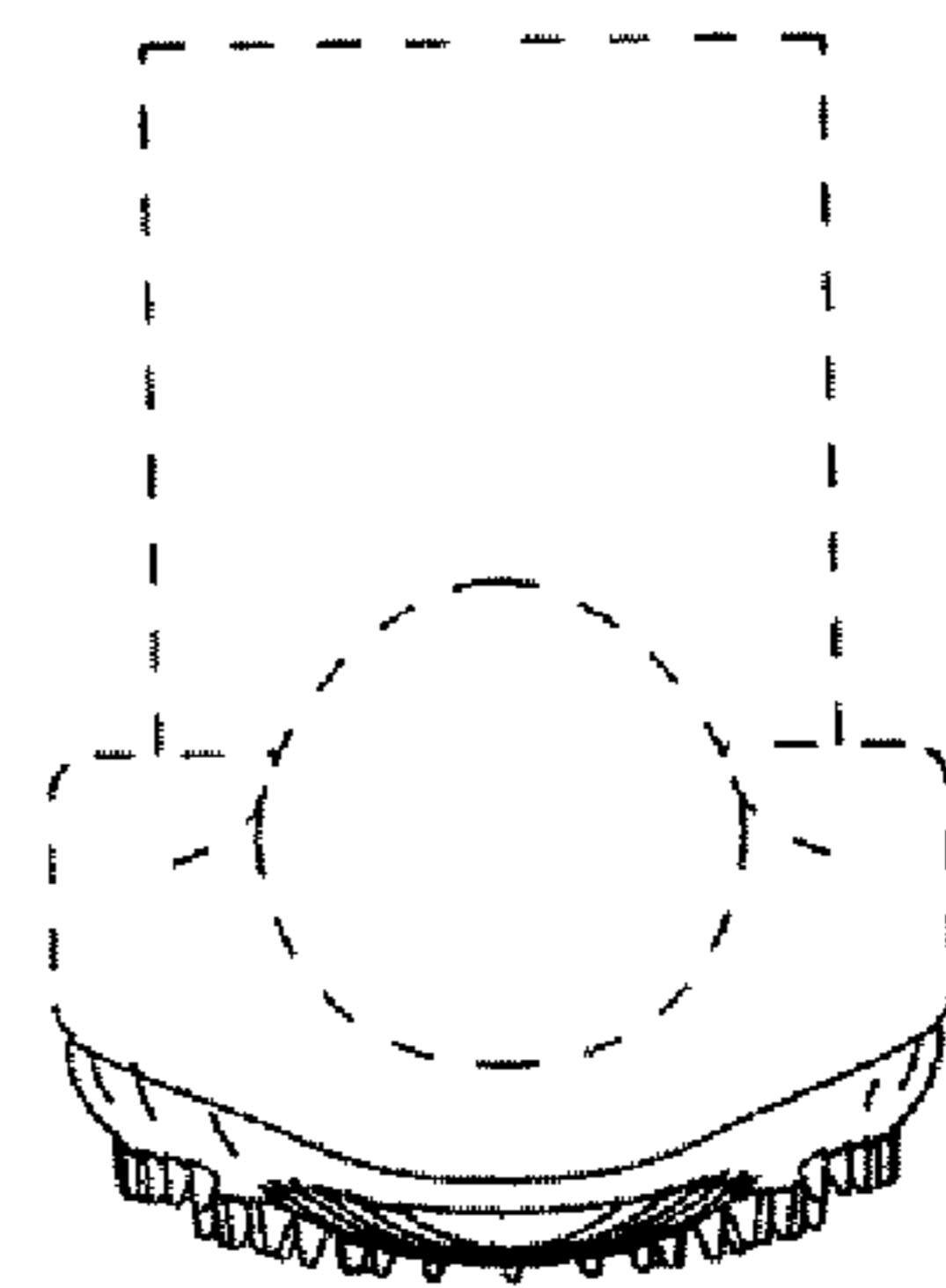

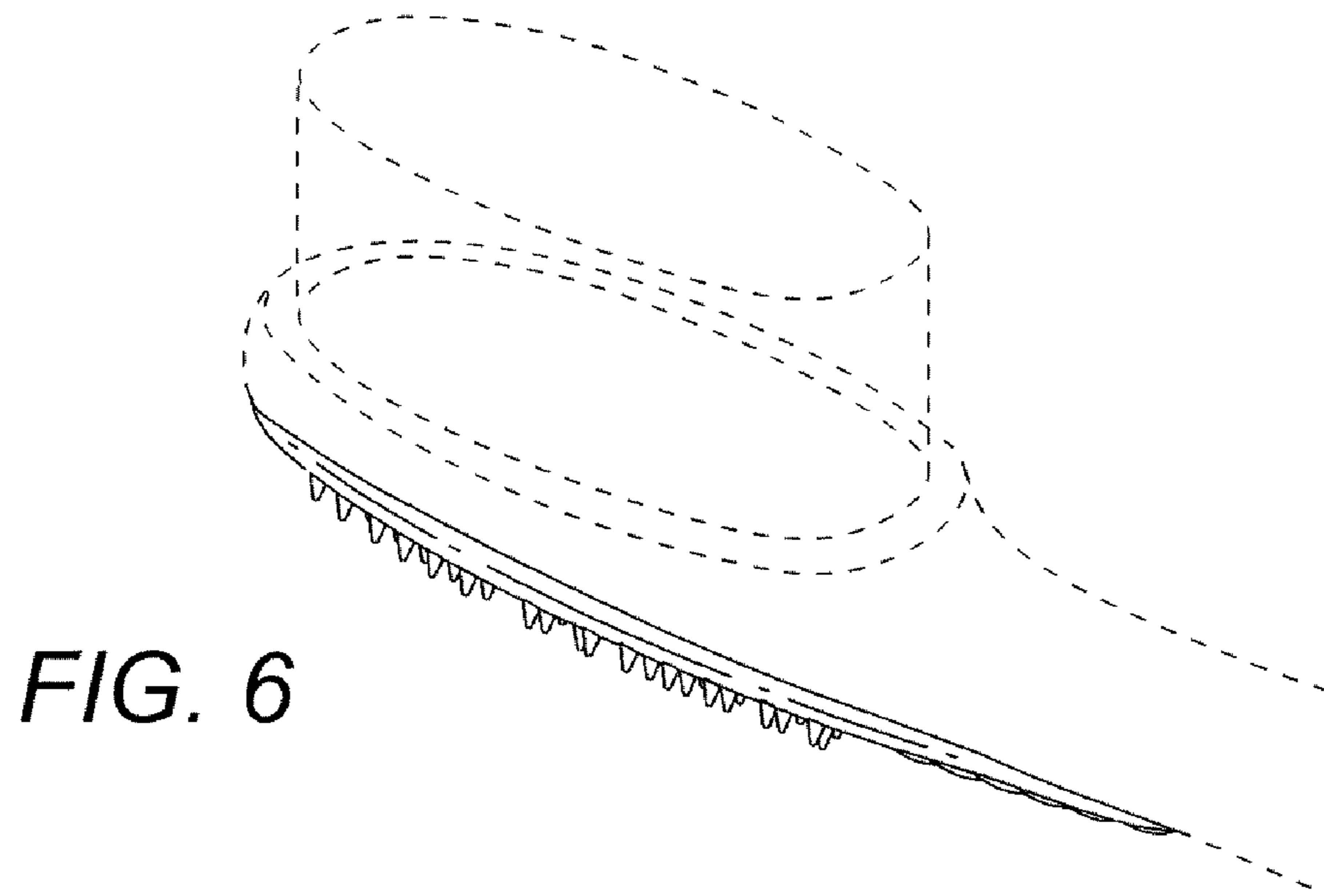

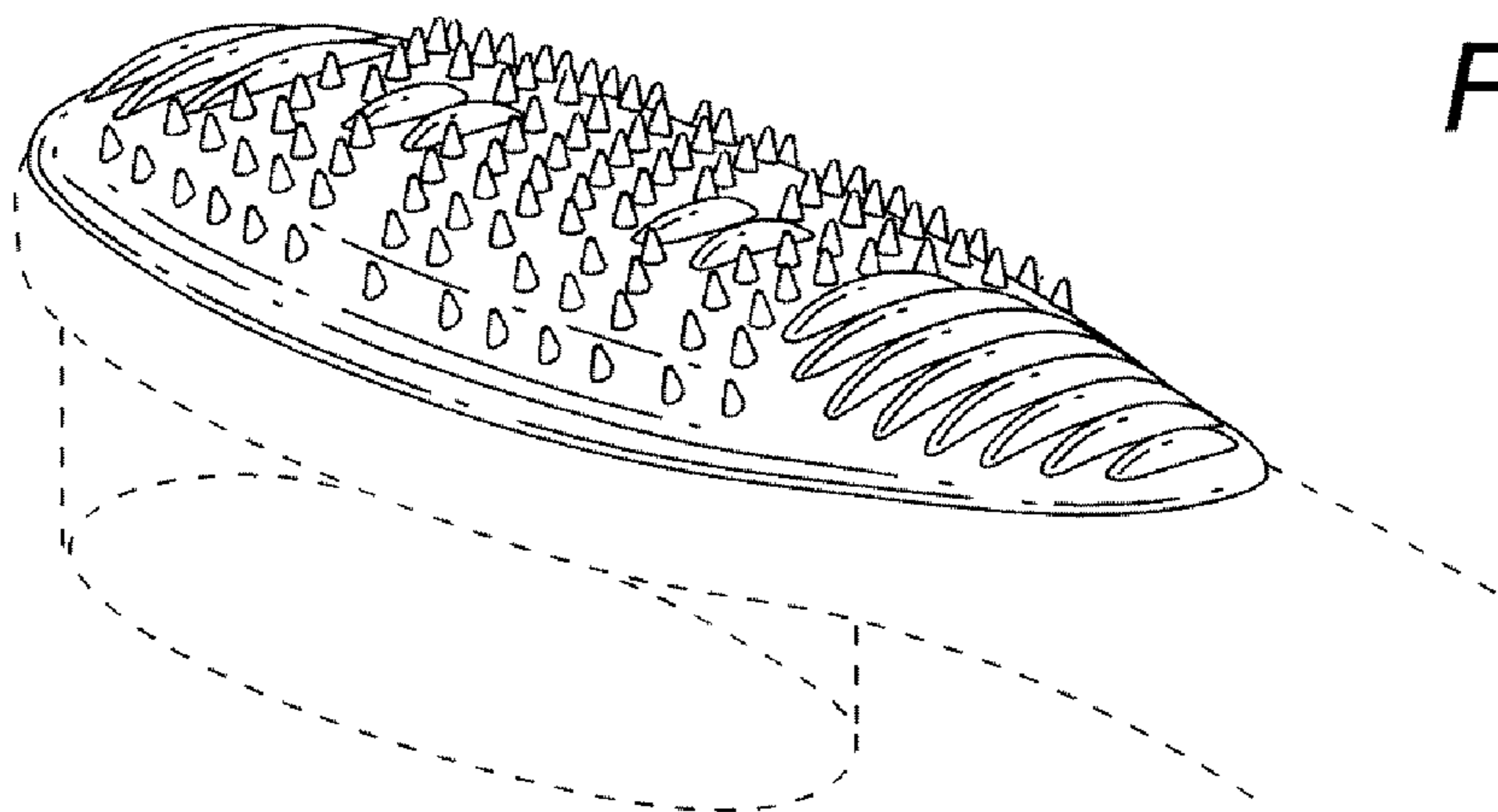
