FIG. 2 shows a front view of the show case in accordance with FIG. 1;

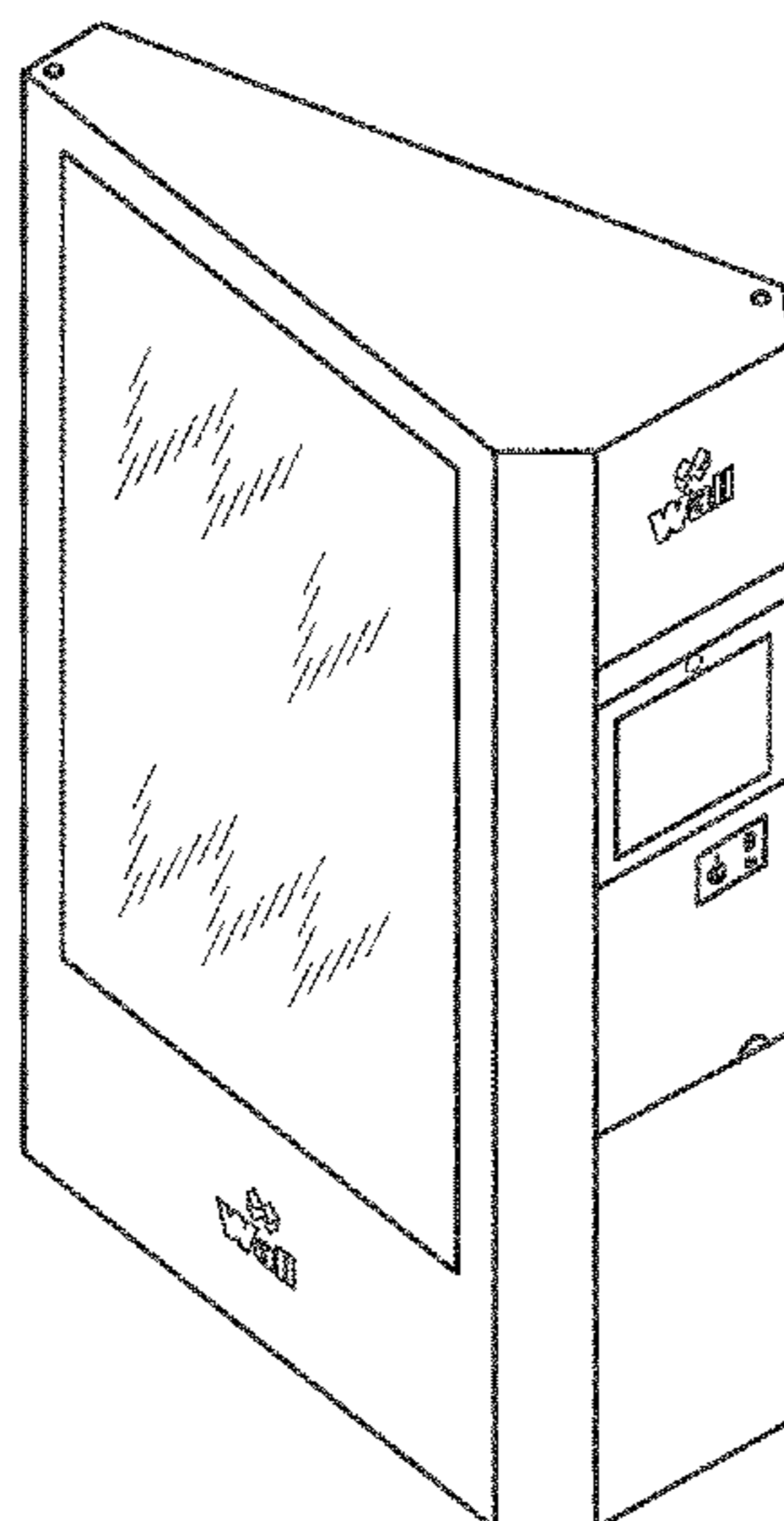
FIG. 3 shows a side view of the show case in accordance with FIGS. 1 and 2; and,

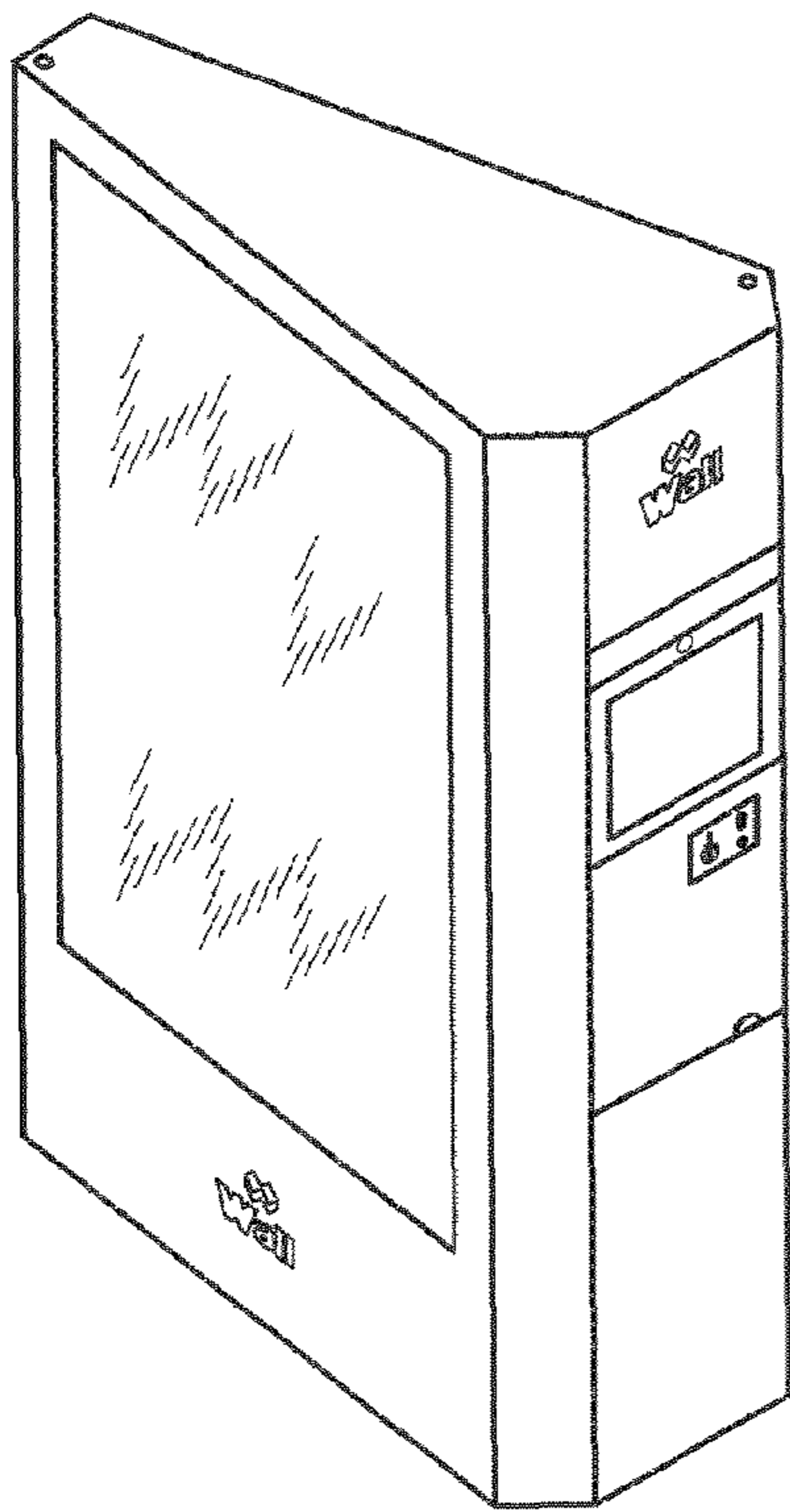

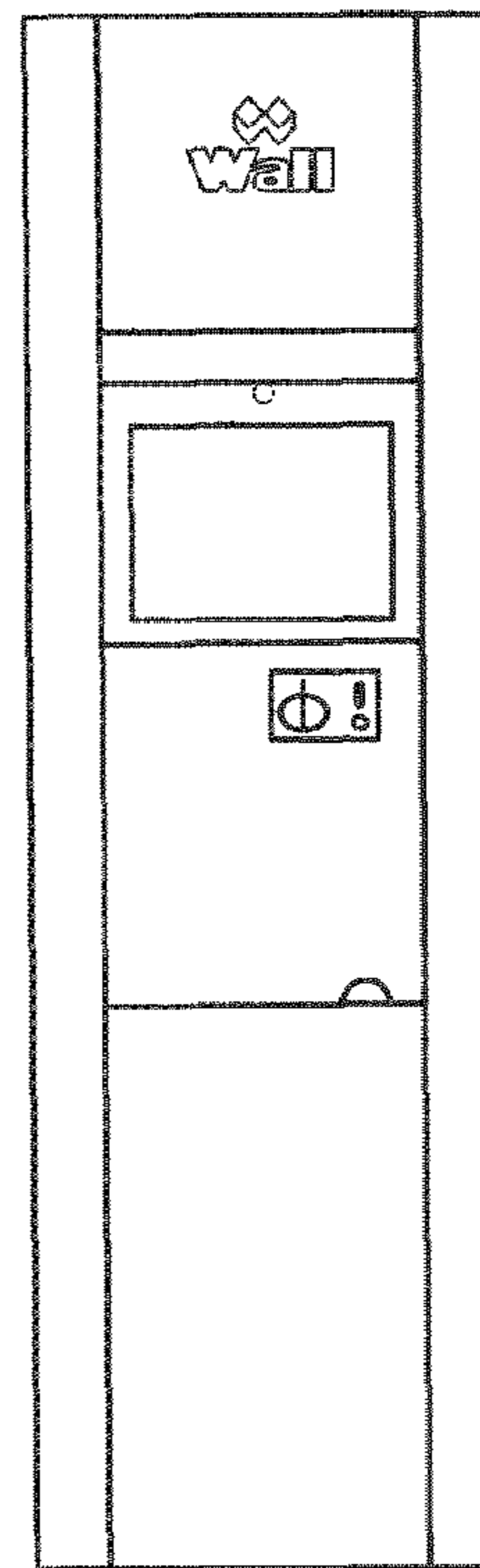

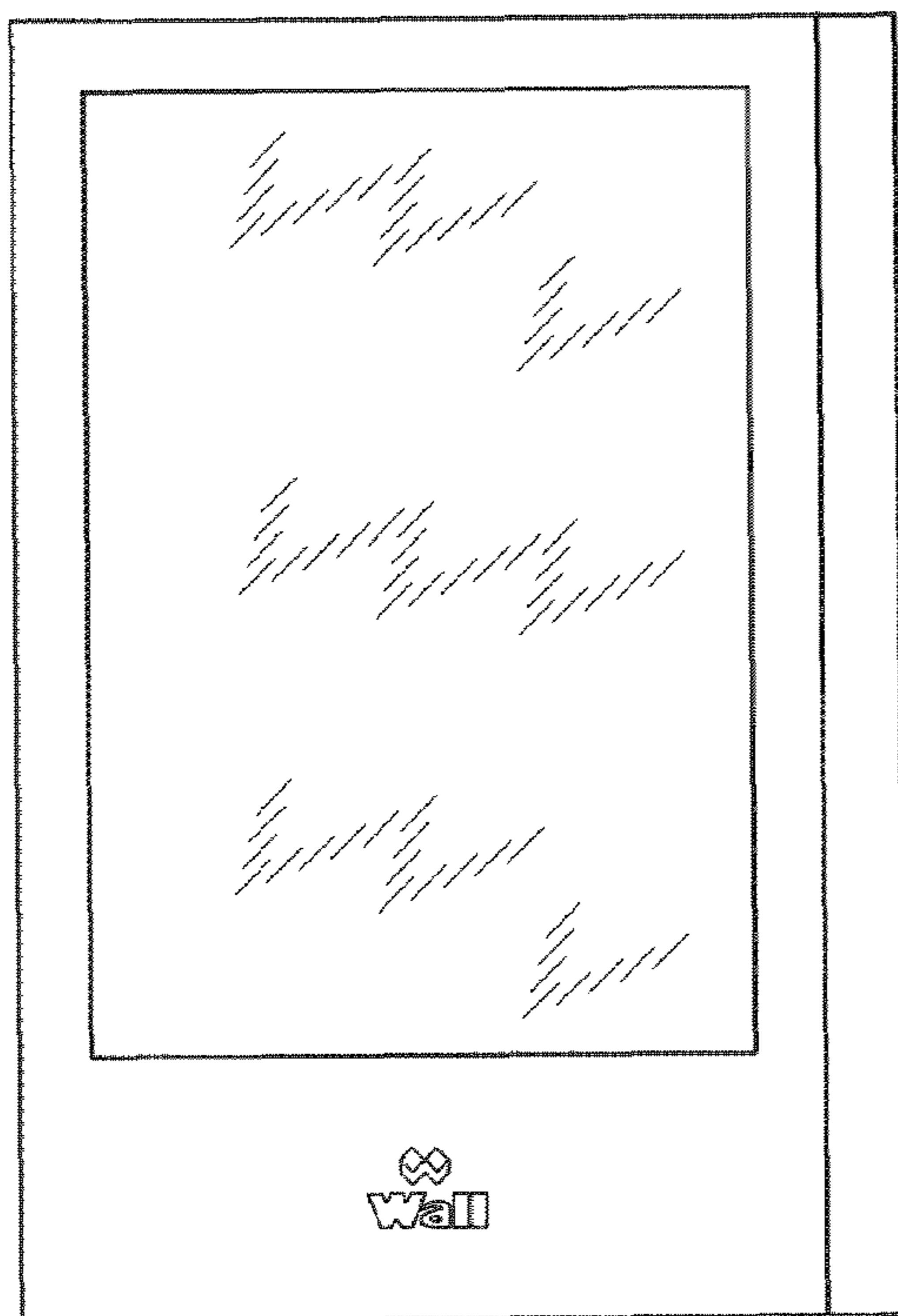

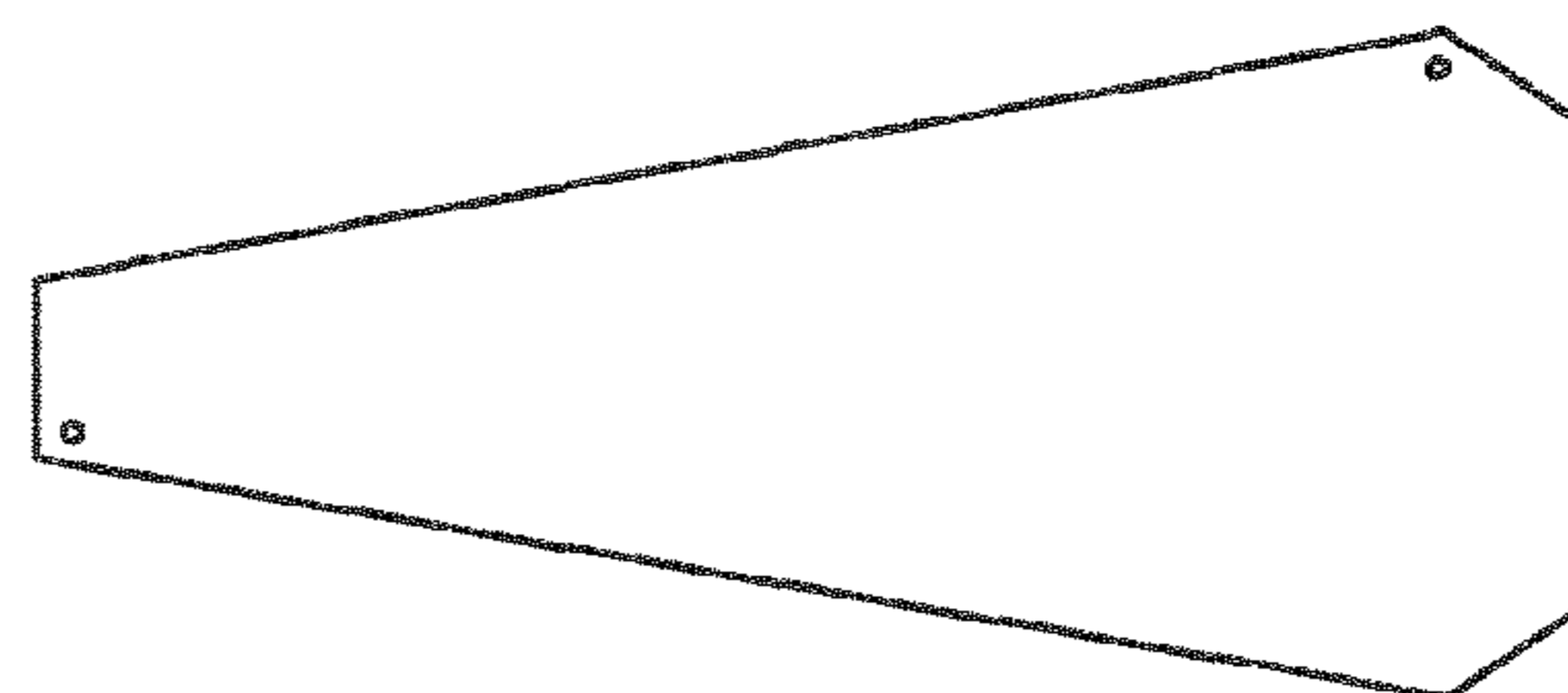
