**DESCRIPTION**

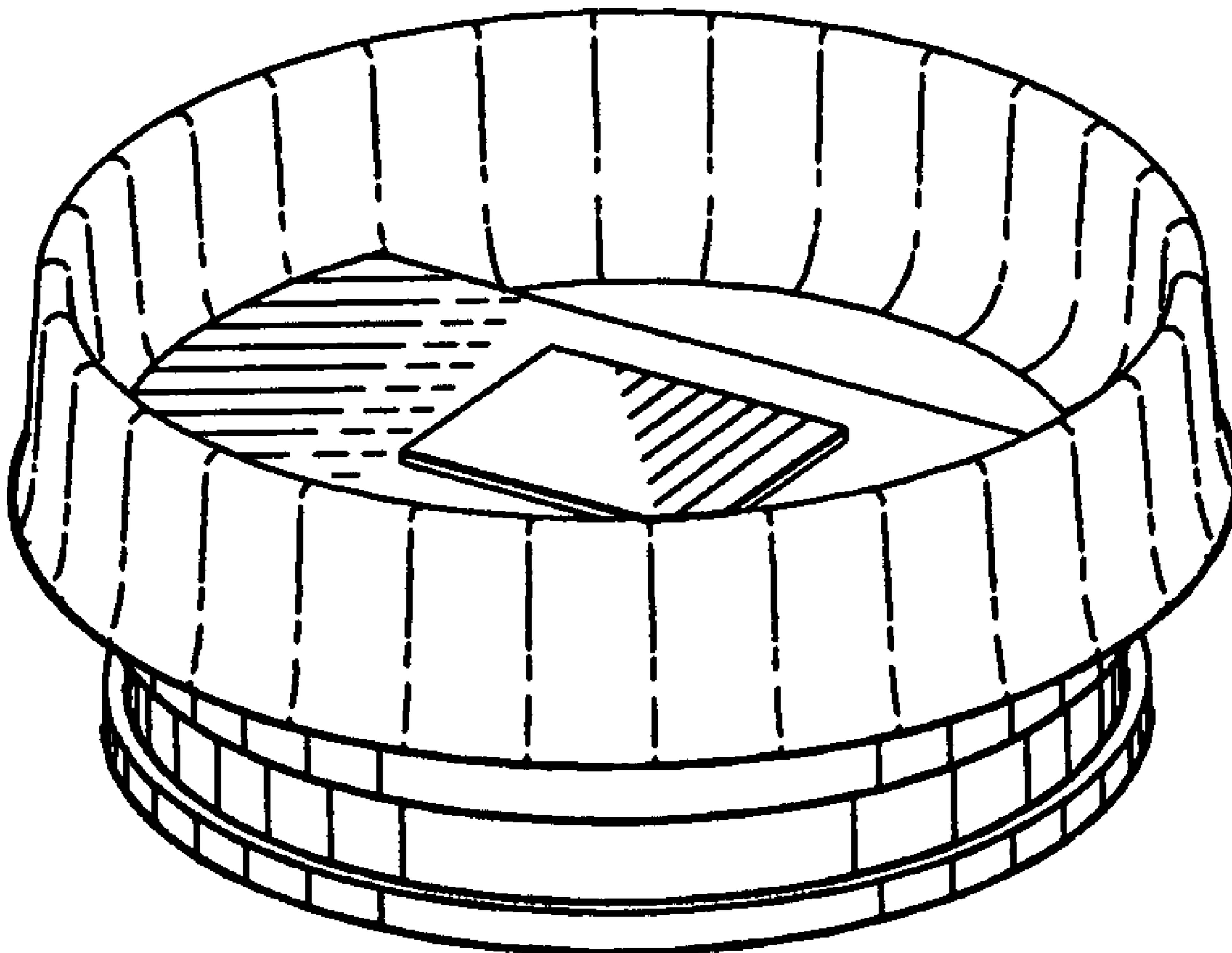
FIG. 1 is an isometric view of the top for beverage container showing my design;

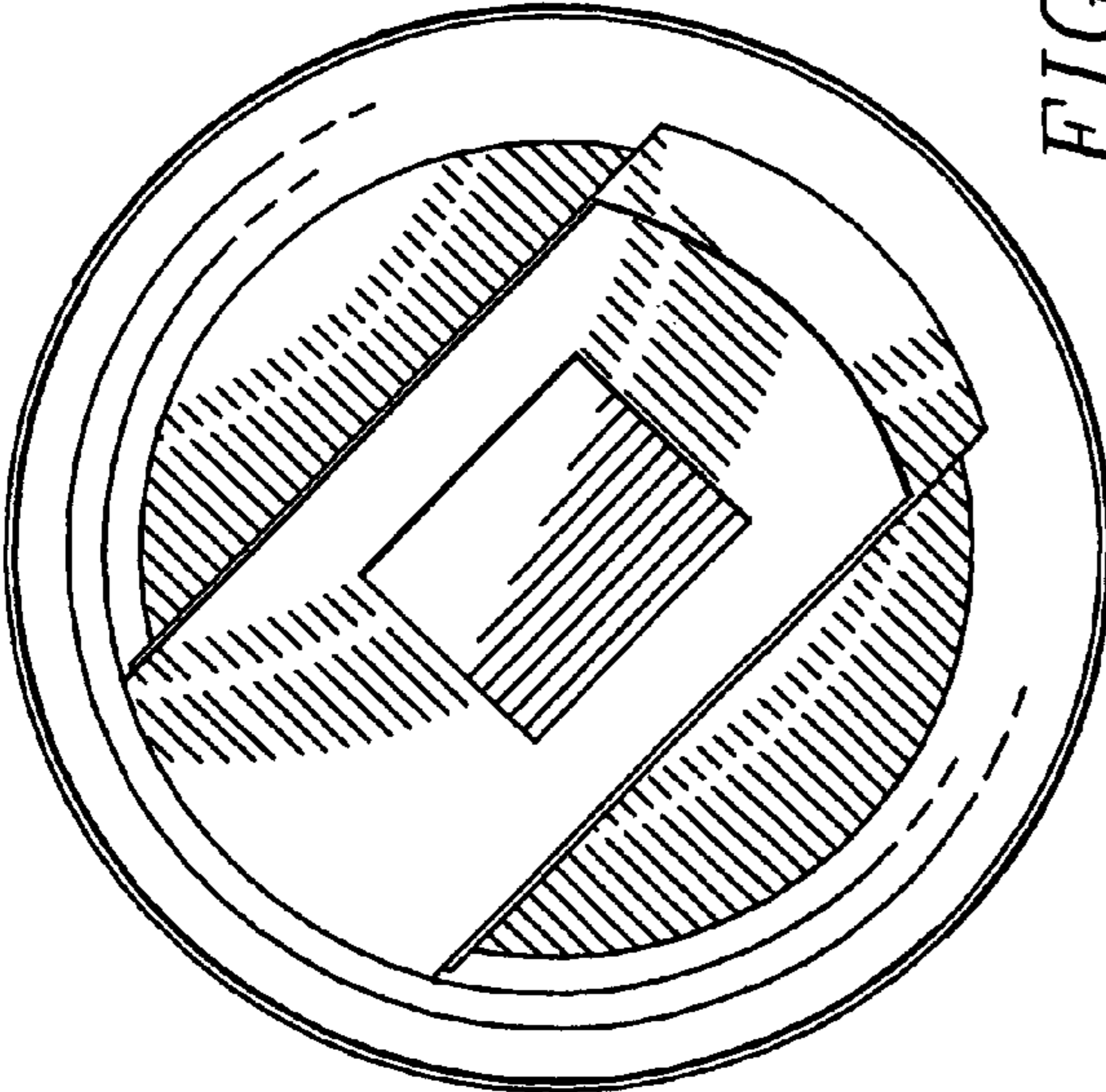

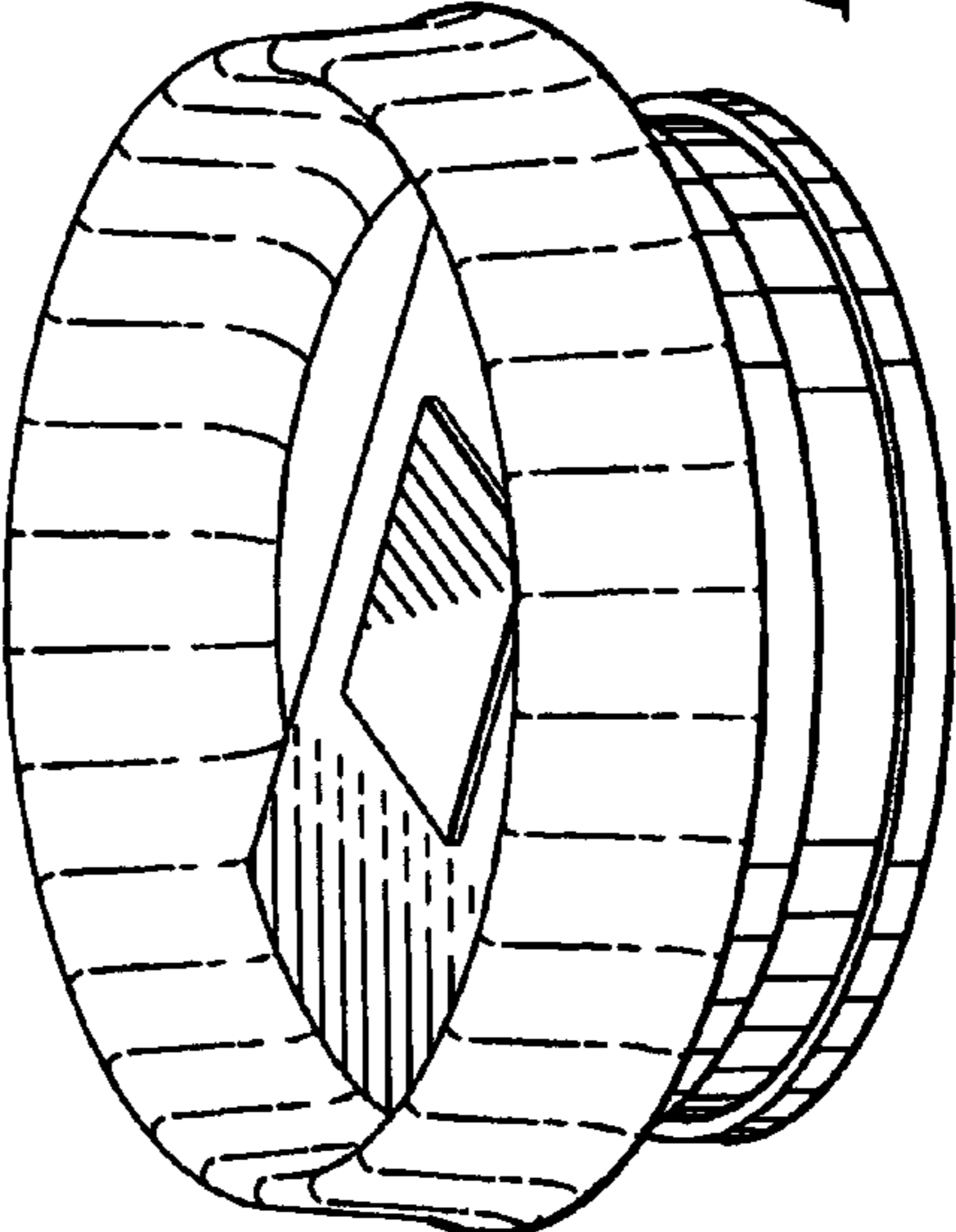

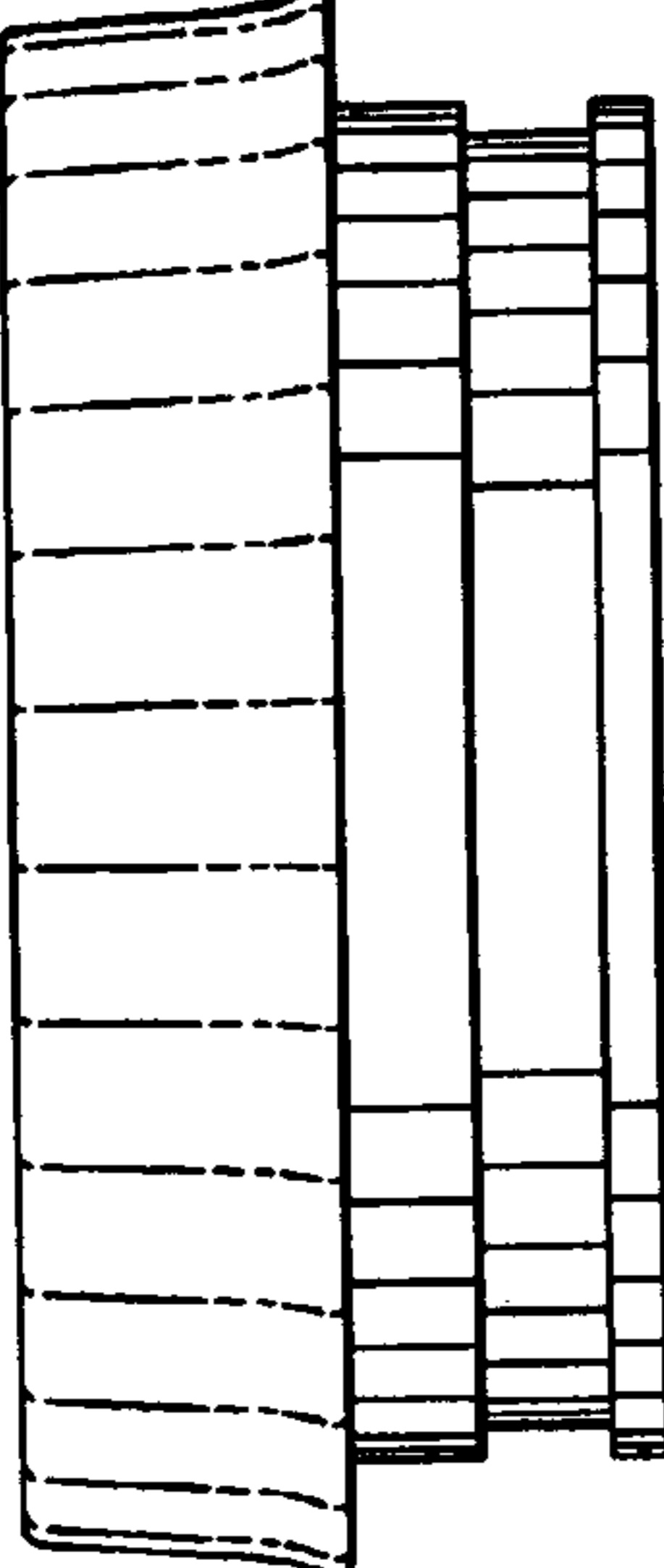

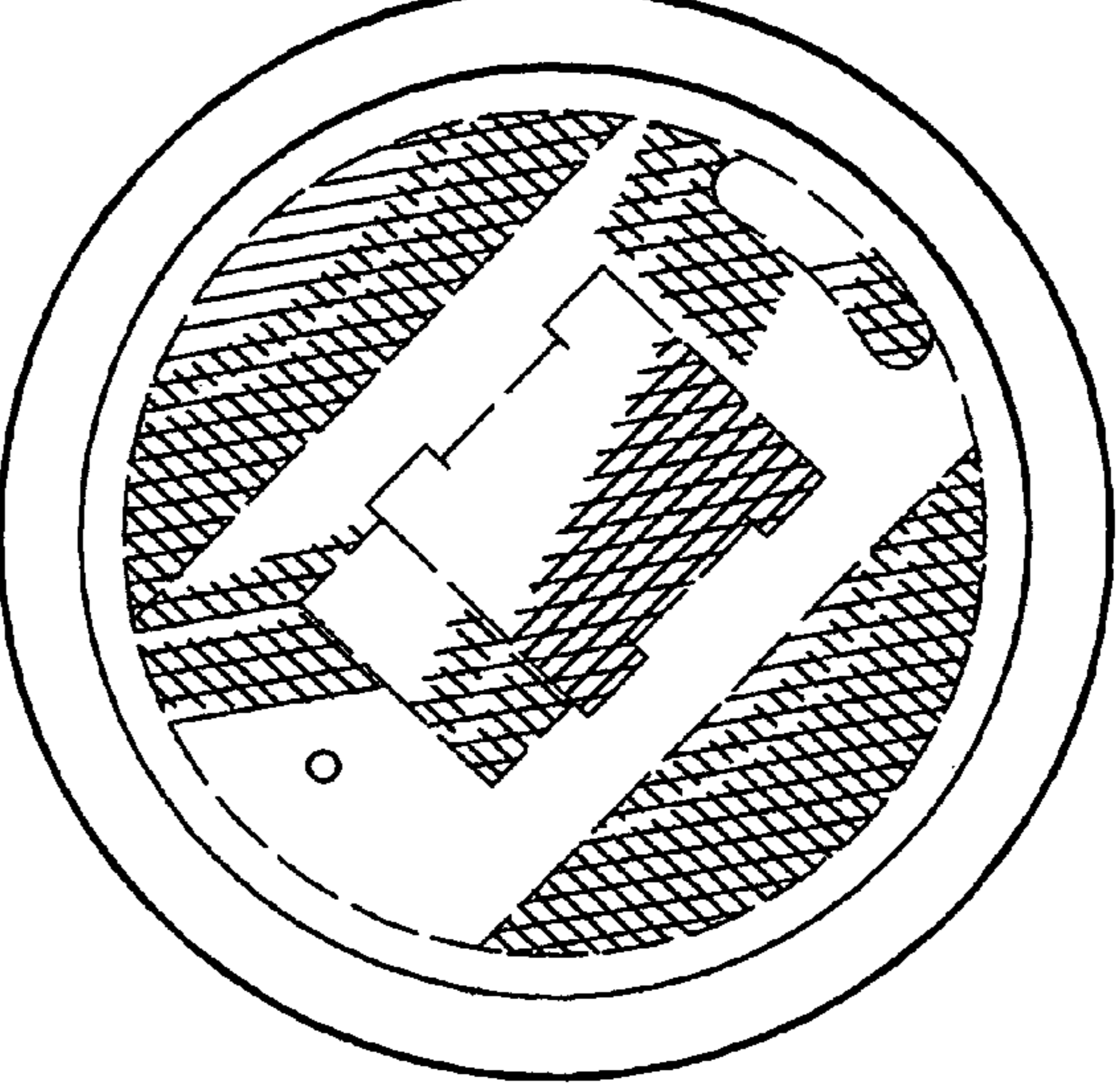
