DESCRIPTION

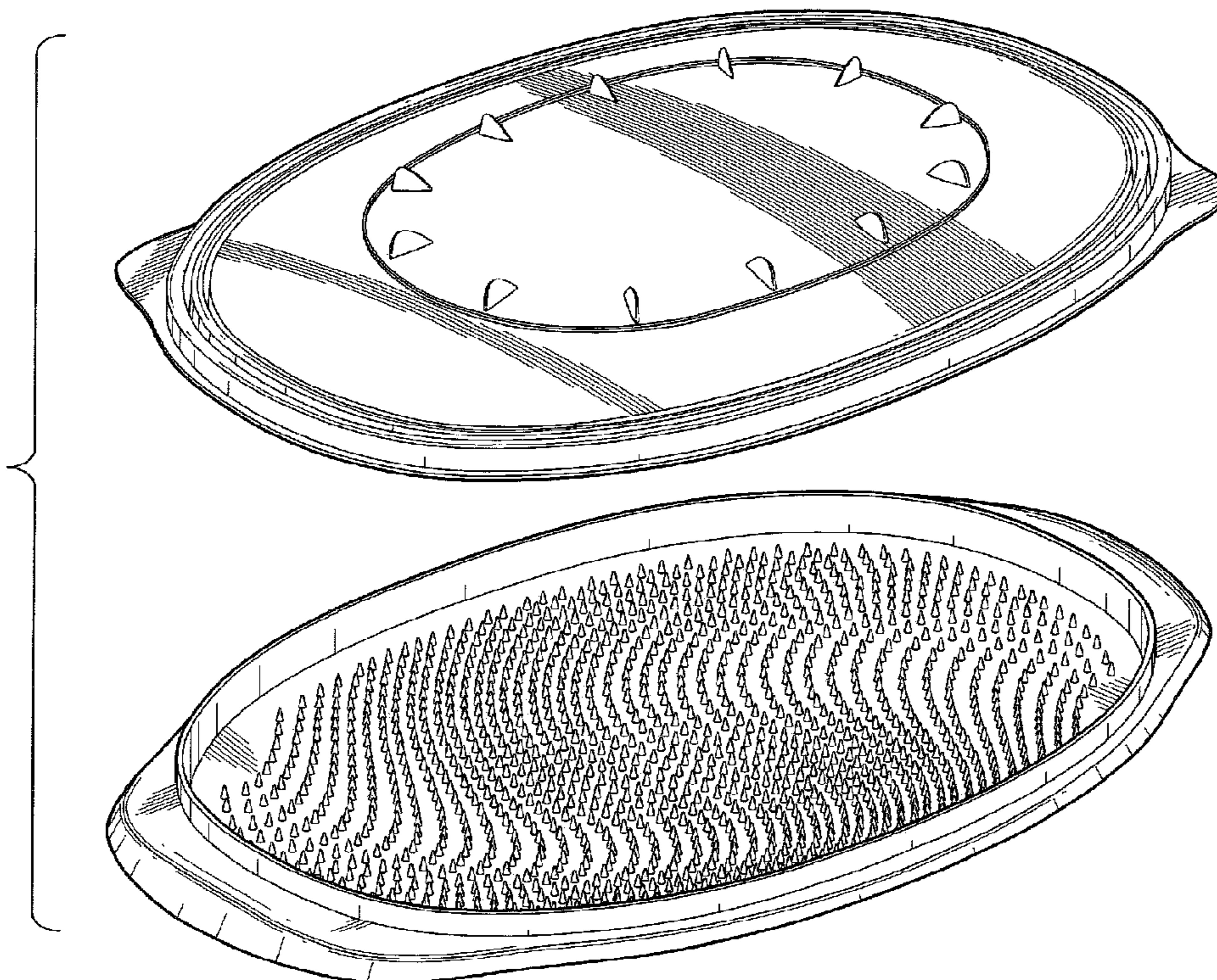
FIG. 1 is a perspective view of a marinade tray showing our new design;

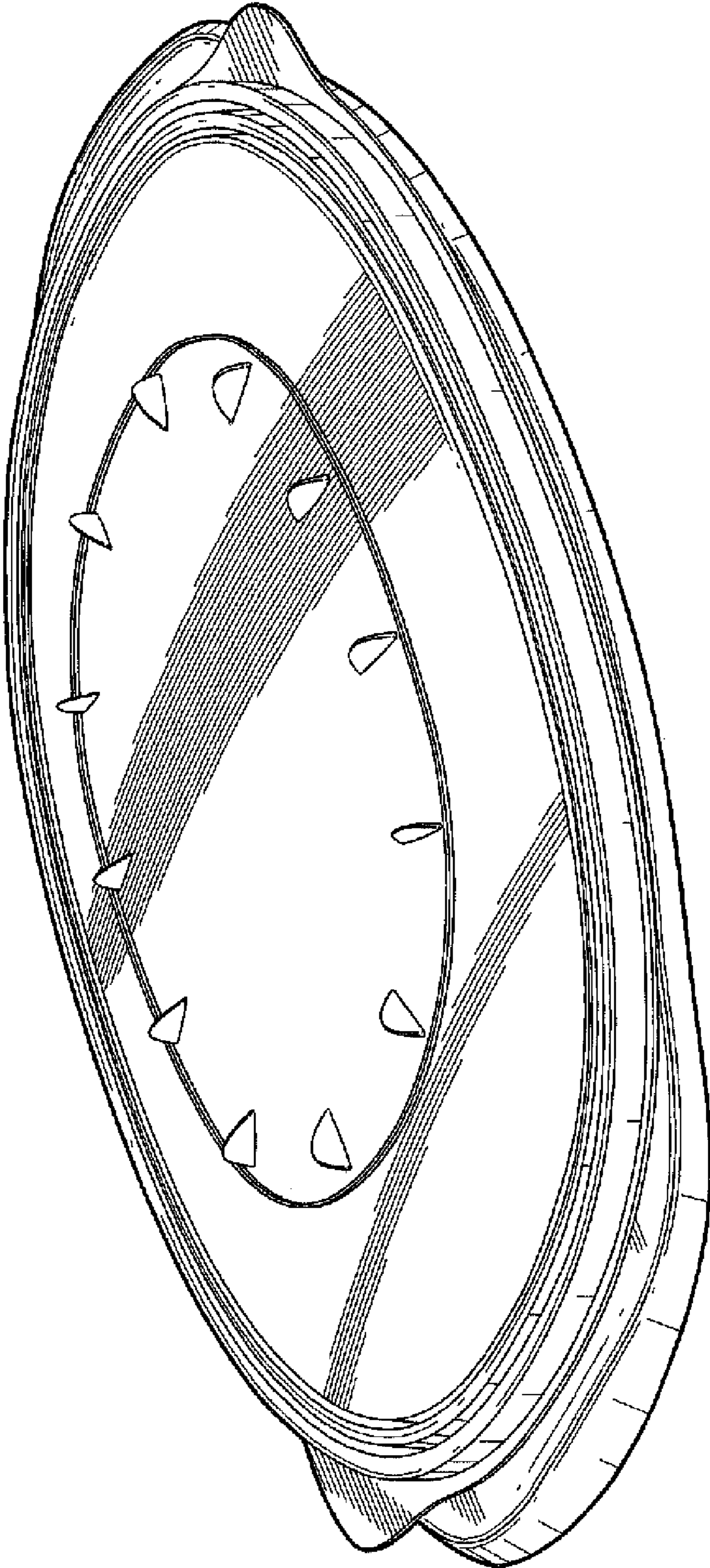
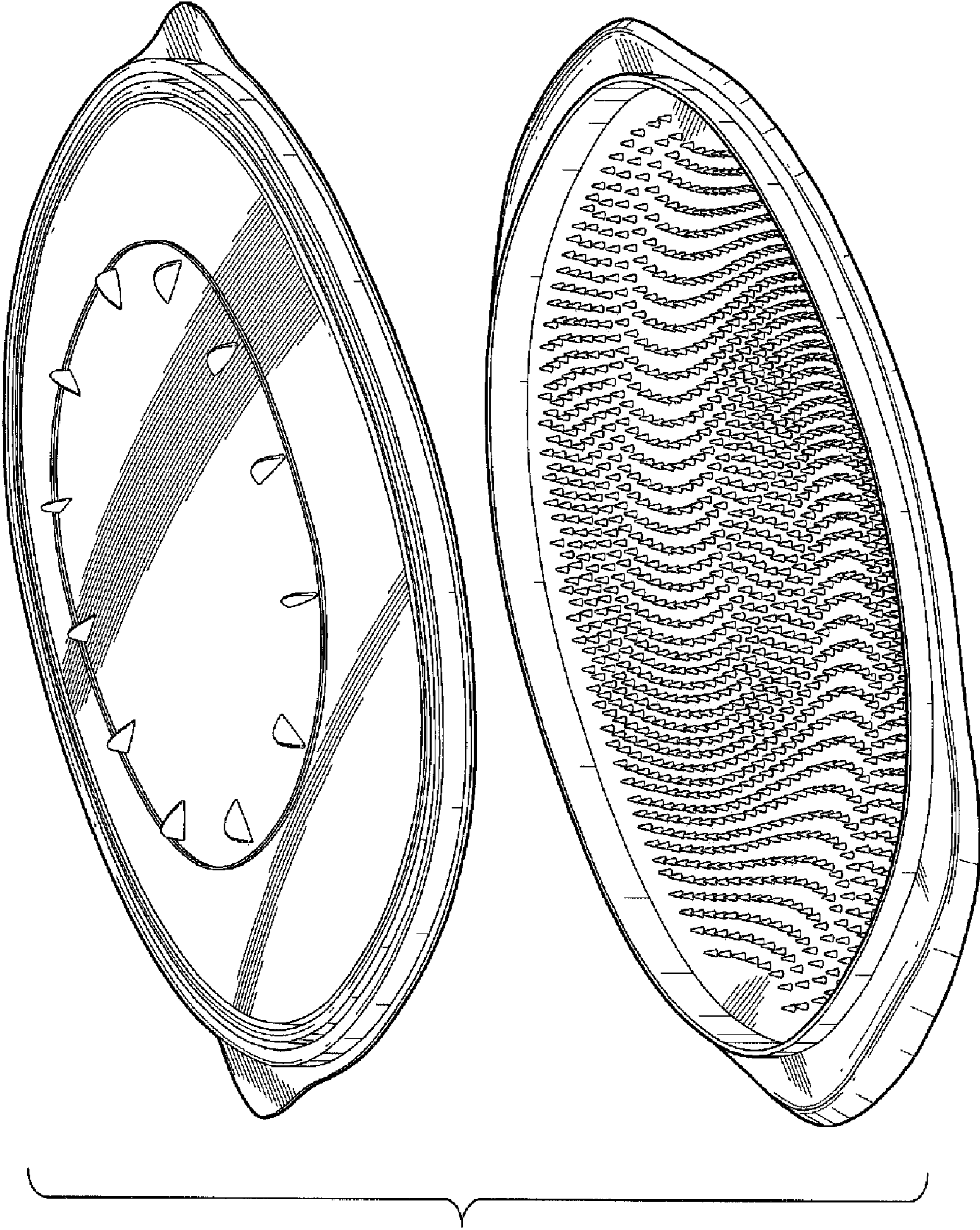

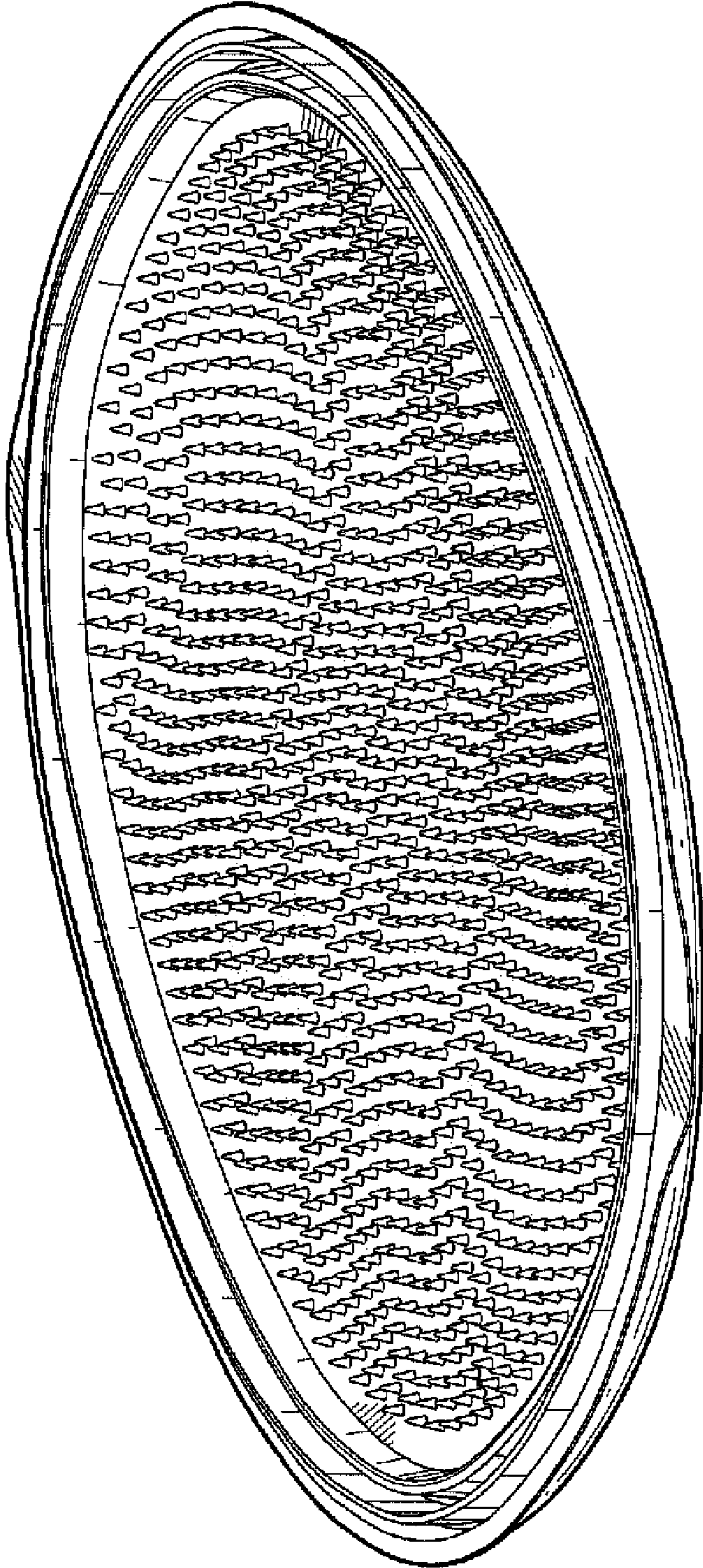

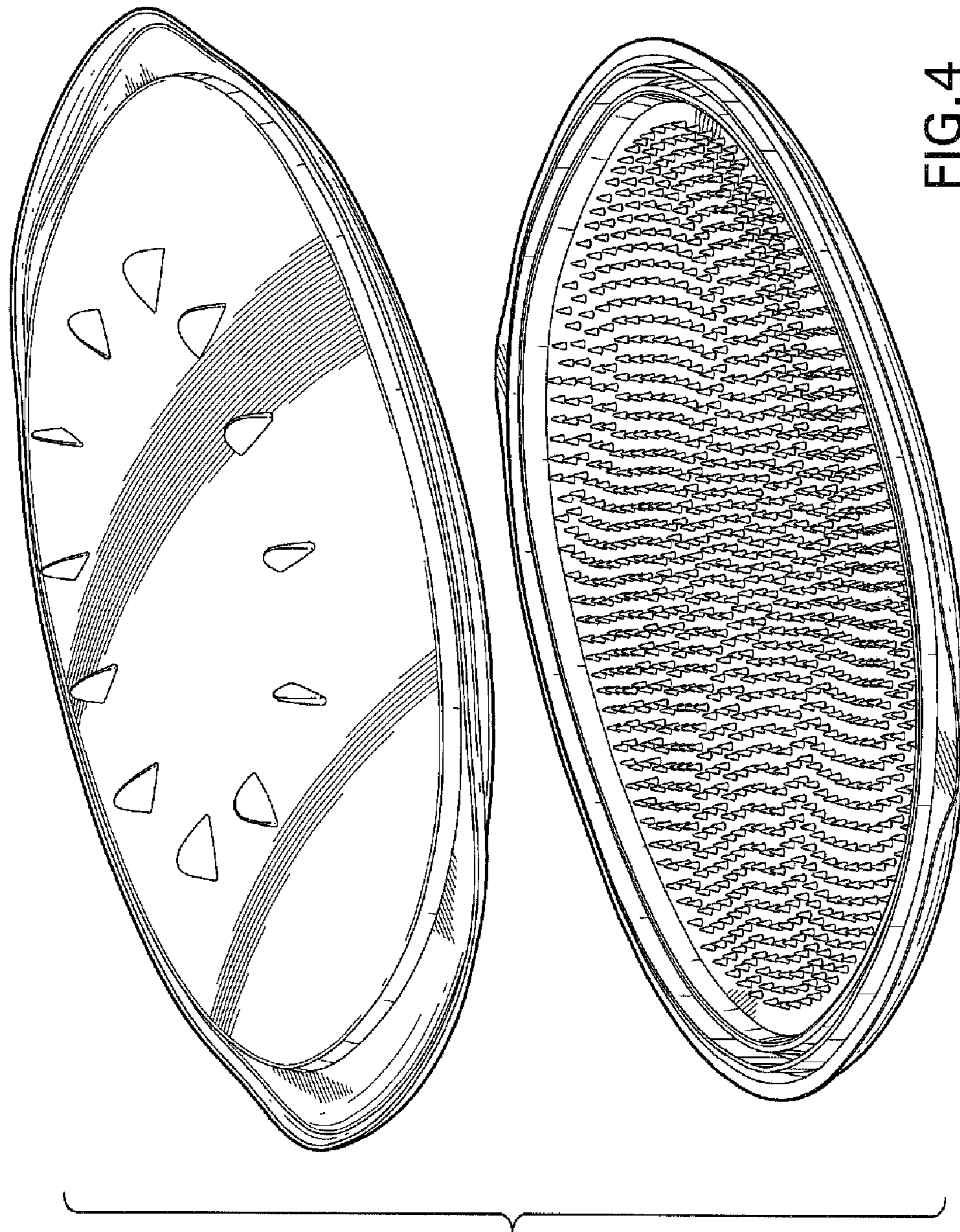
