(57) **CLAIM**

The ornamental design for a plastic container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a plastic container showing our new design;

FIG. 2 is a bottom, front, and right side perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

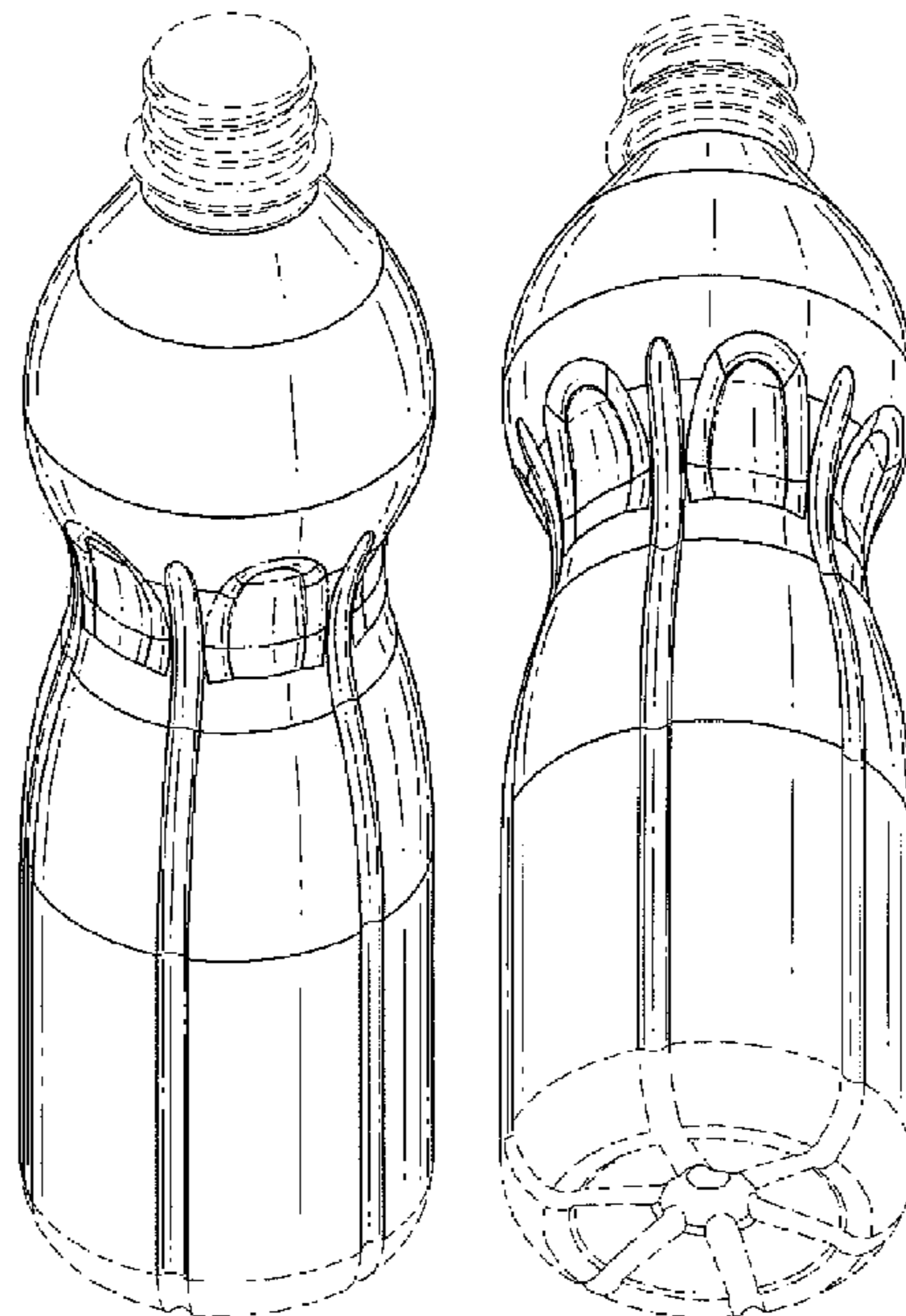
FIG. 6 is a rear elevational view thereof;

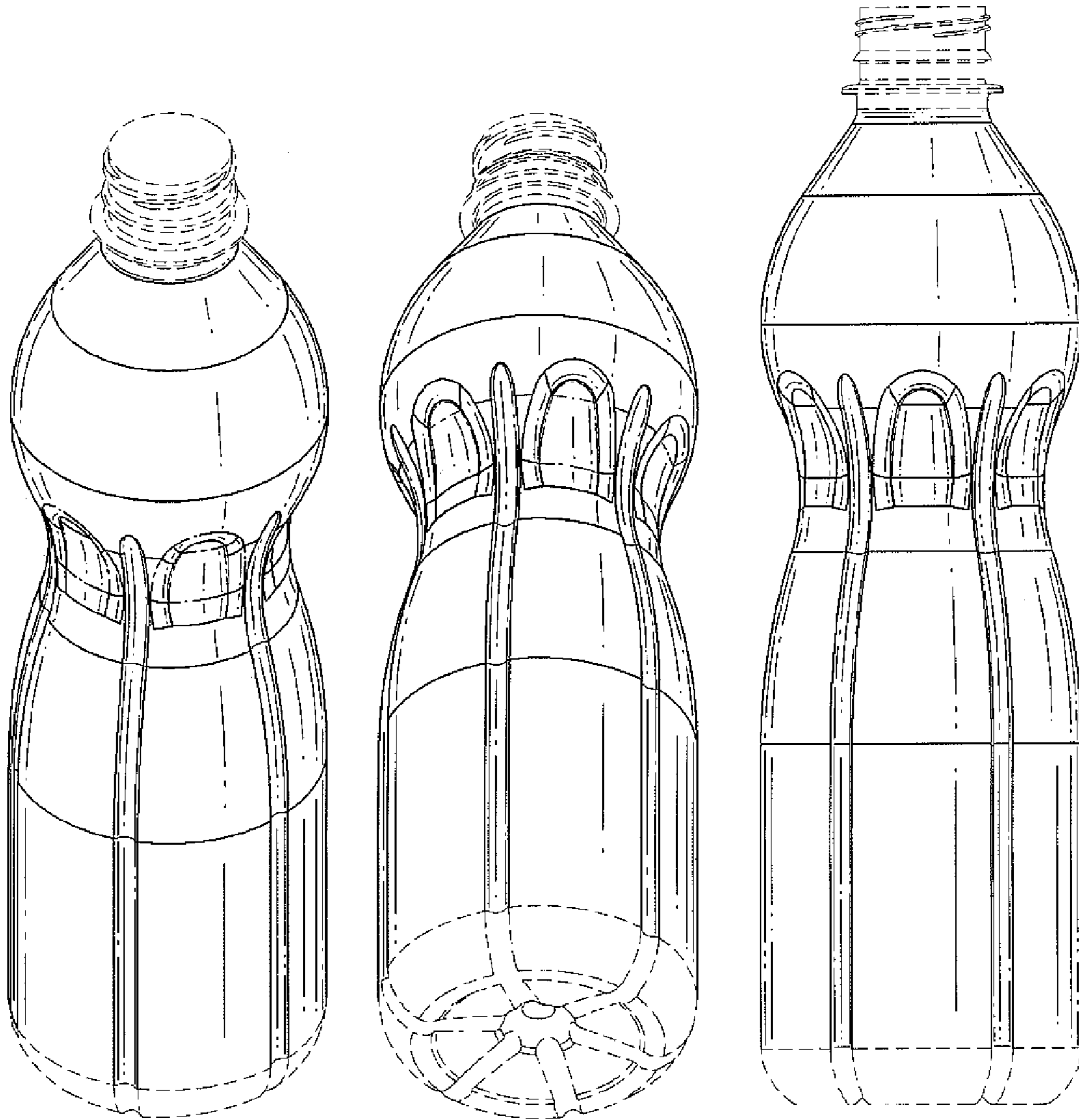

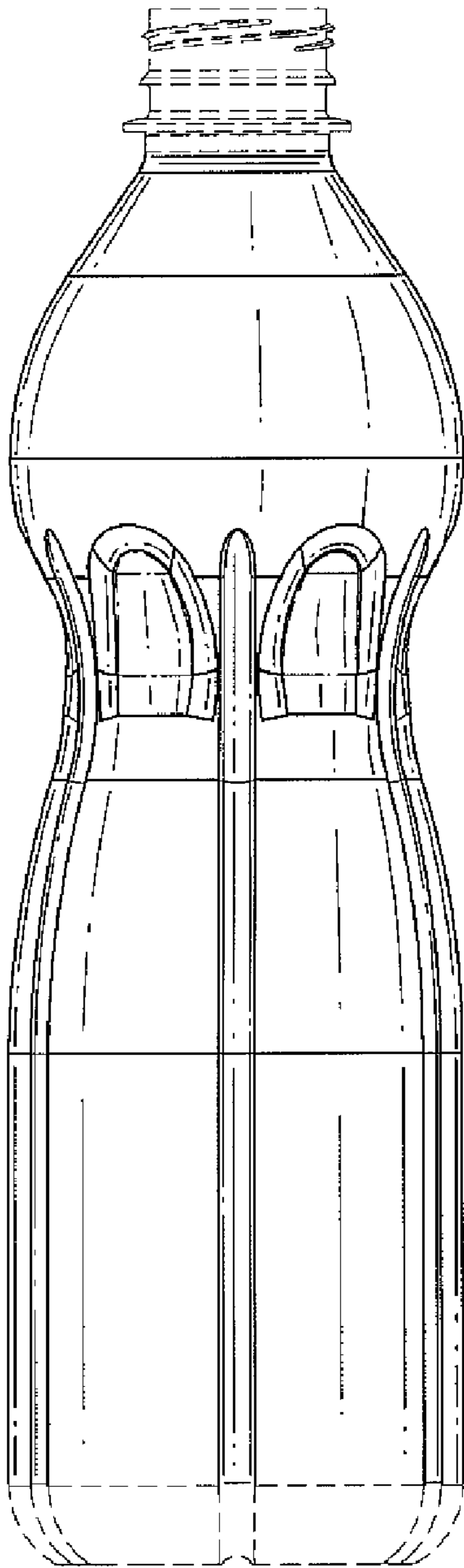

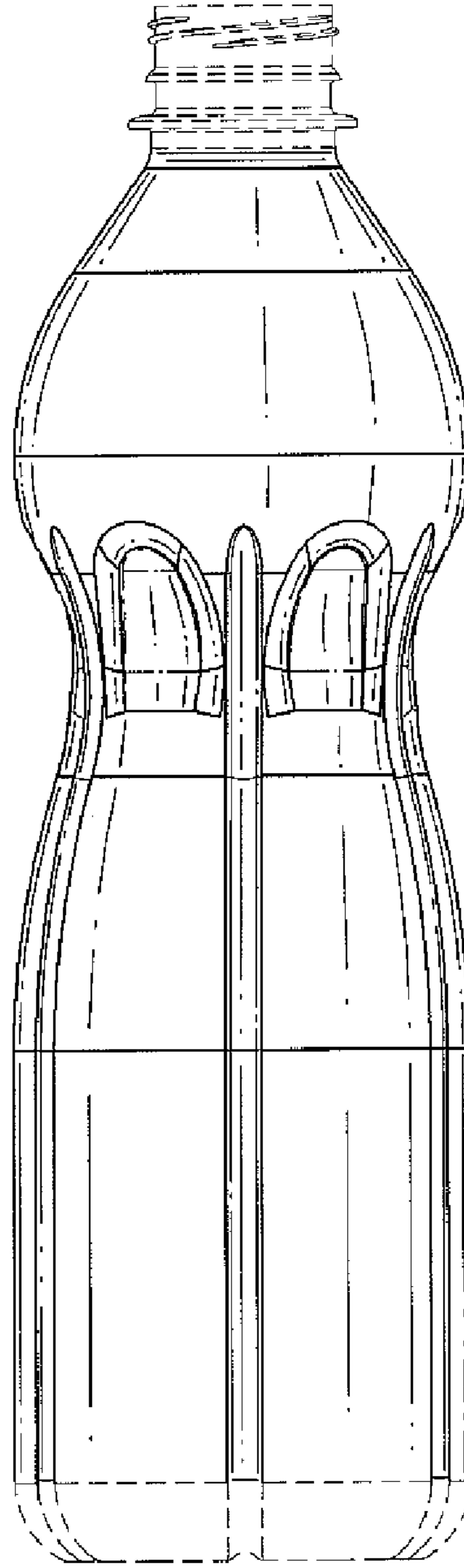

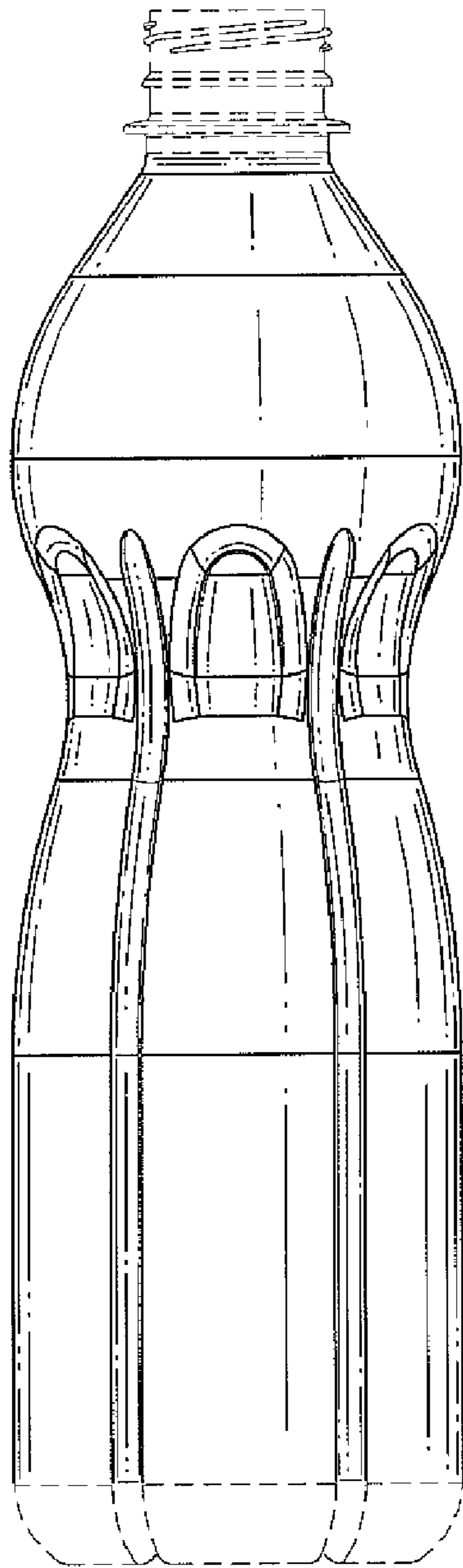

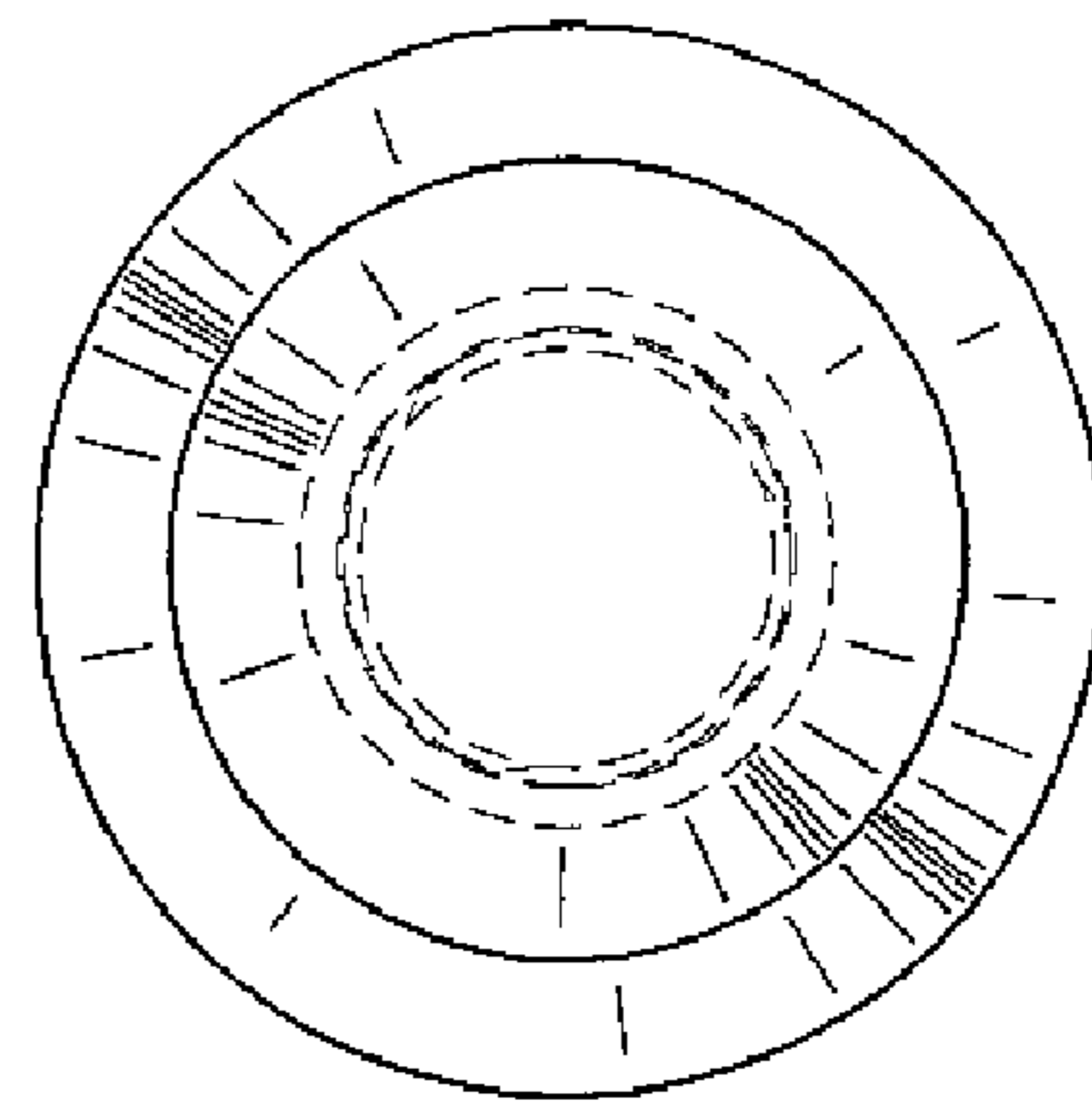

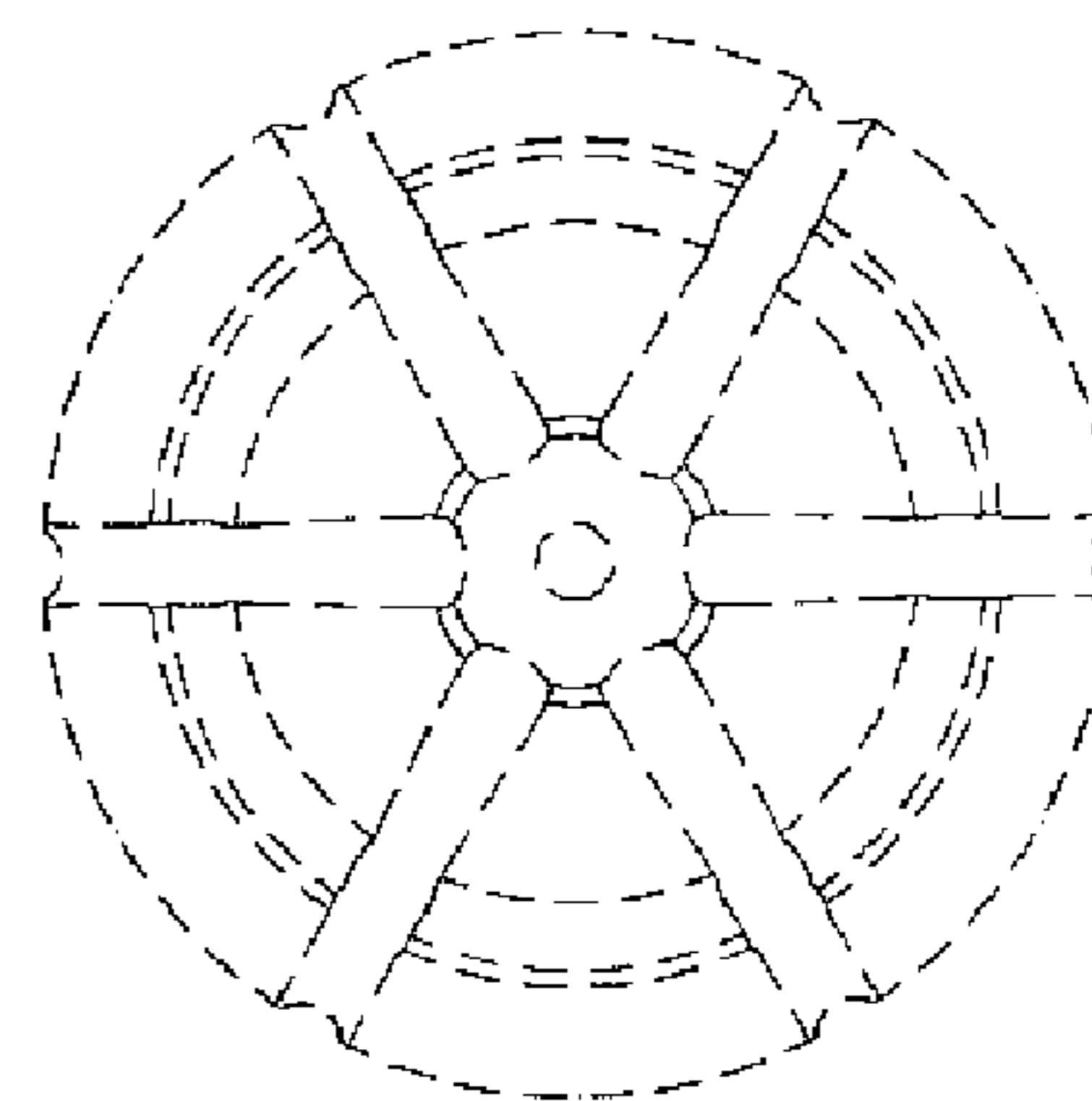
