The ornamental design for a headlights and front grill unit for automobile, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a headlights and front grill unit for automobile showing my new design;

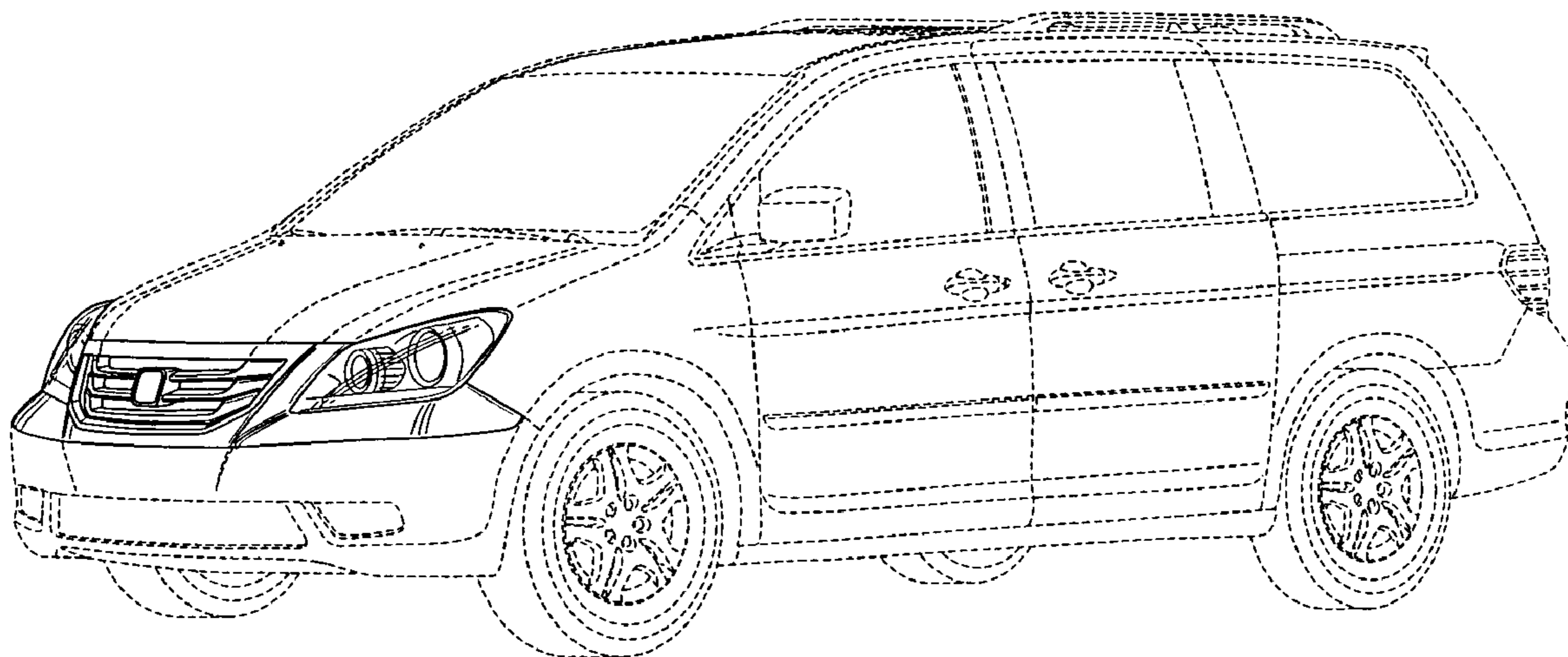

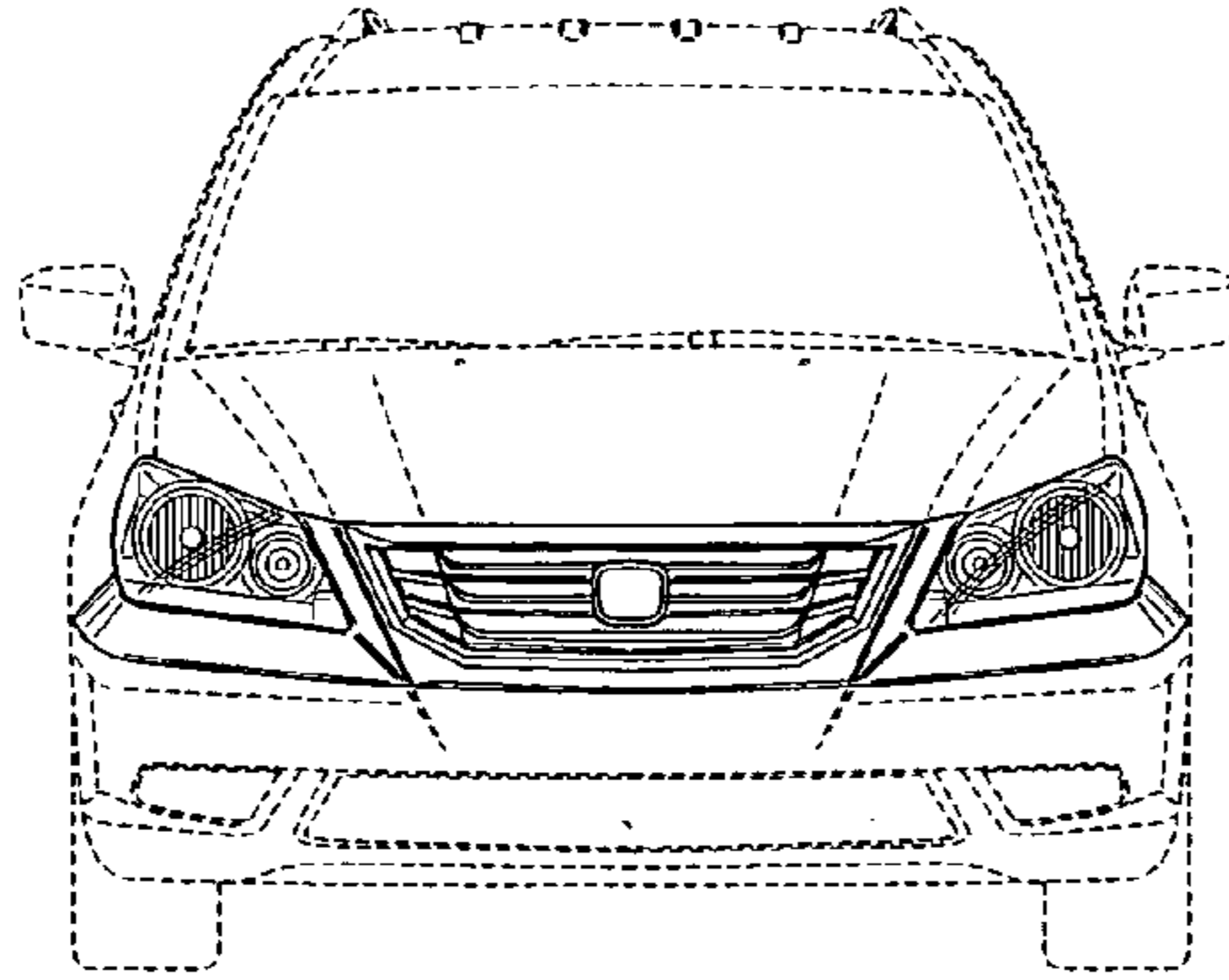

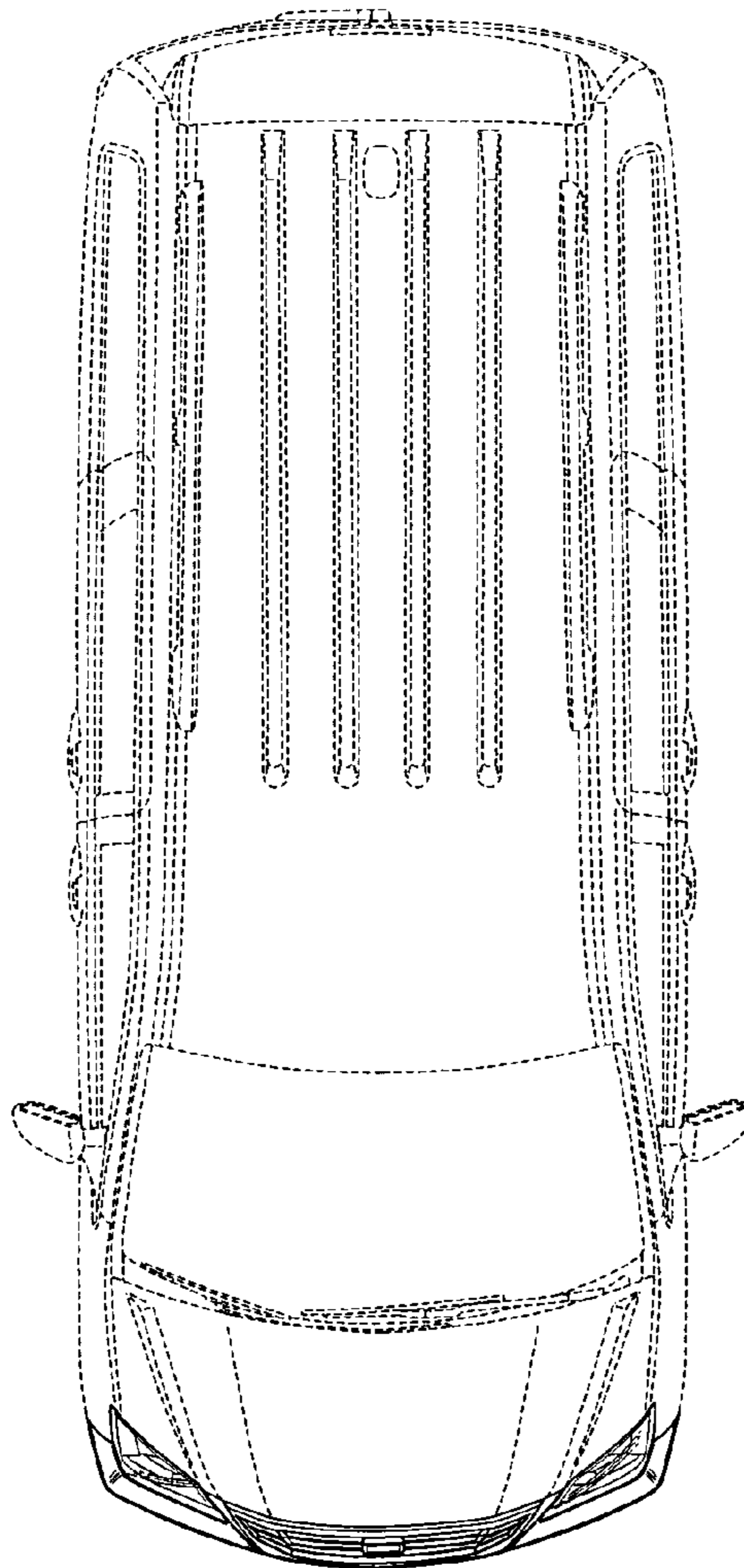

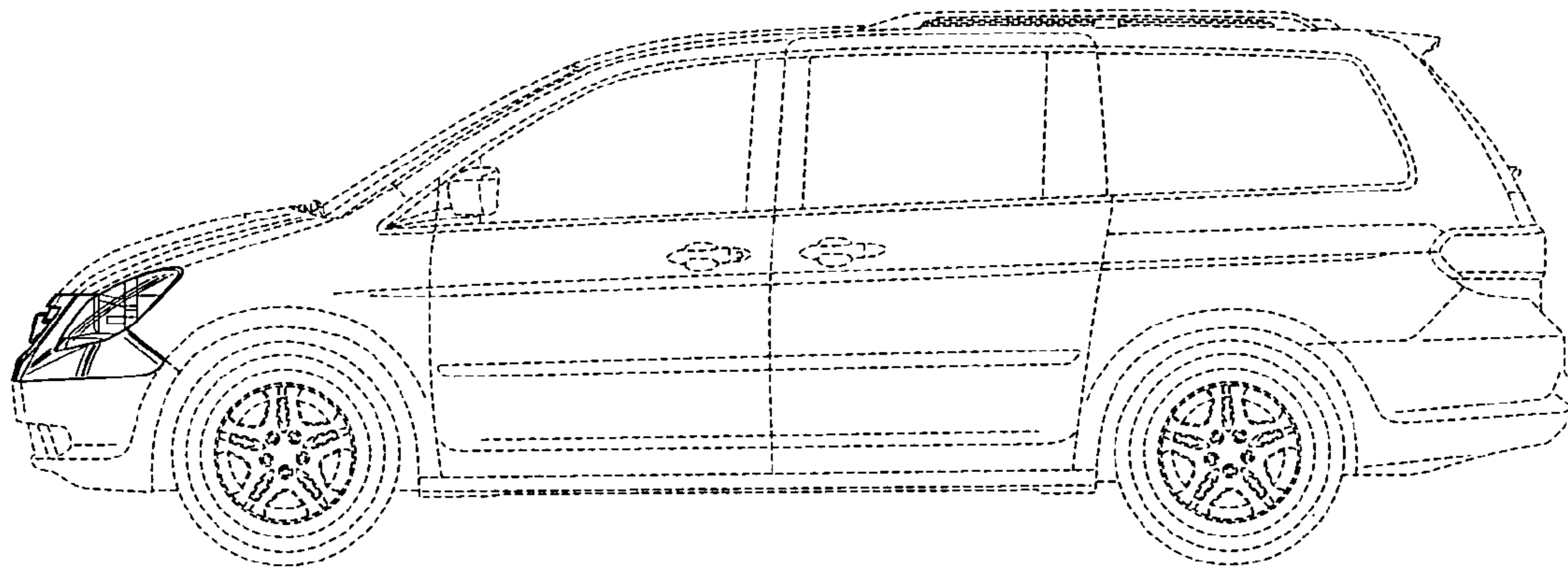
