FIG. 4 is a left side elevation view thereof;

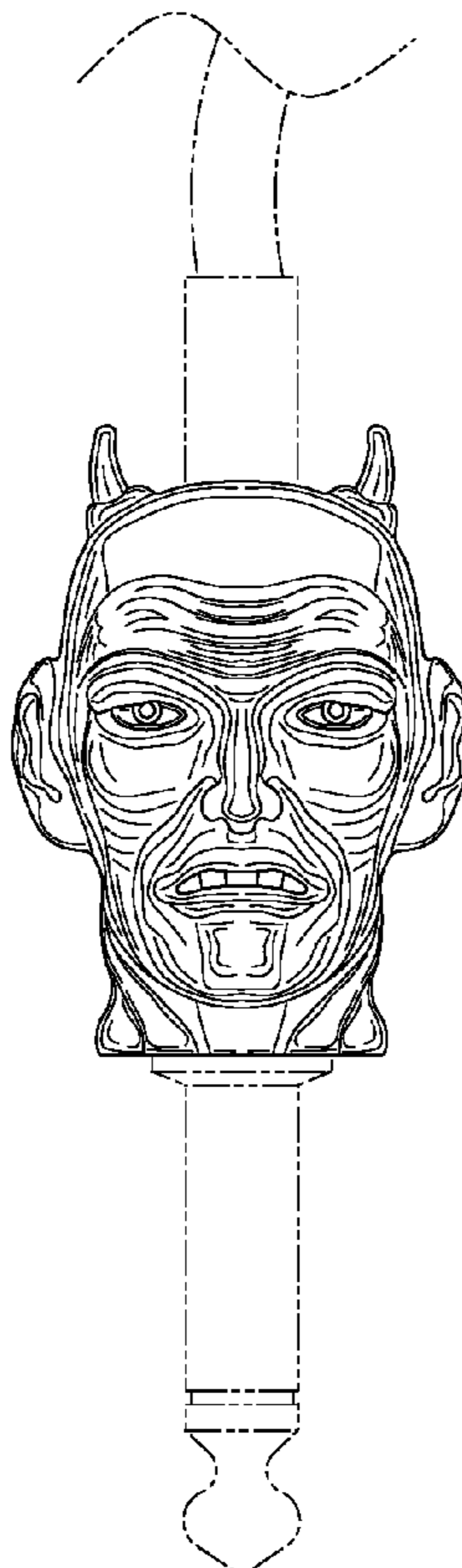
FIG. 5 is a top plan view thereof;

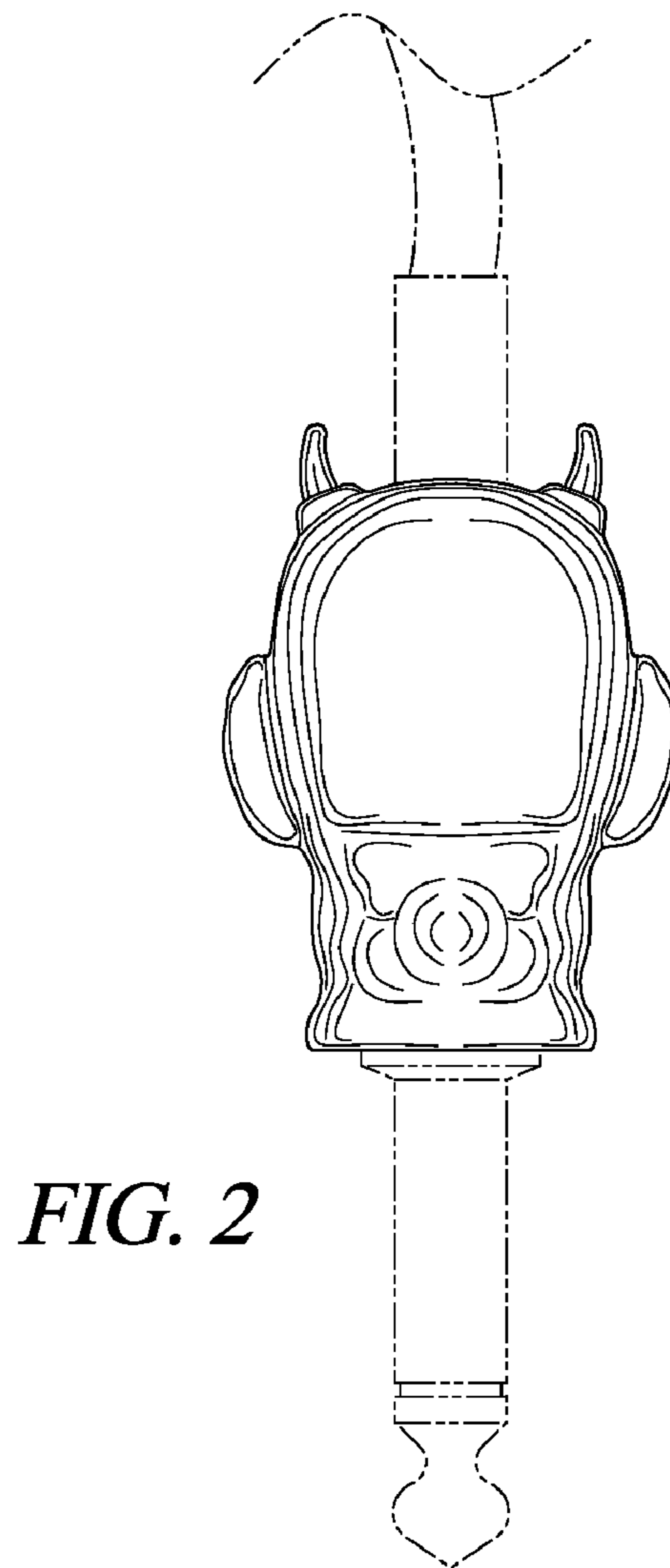
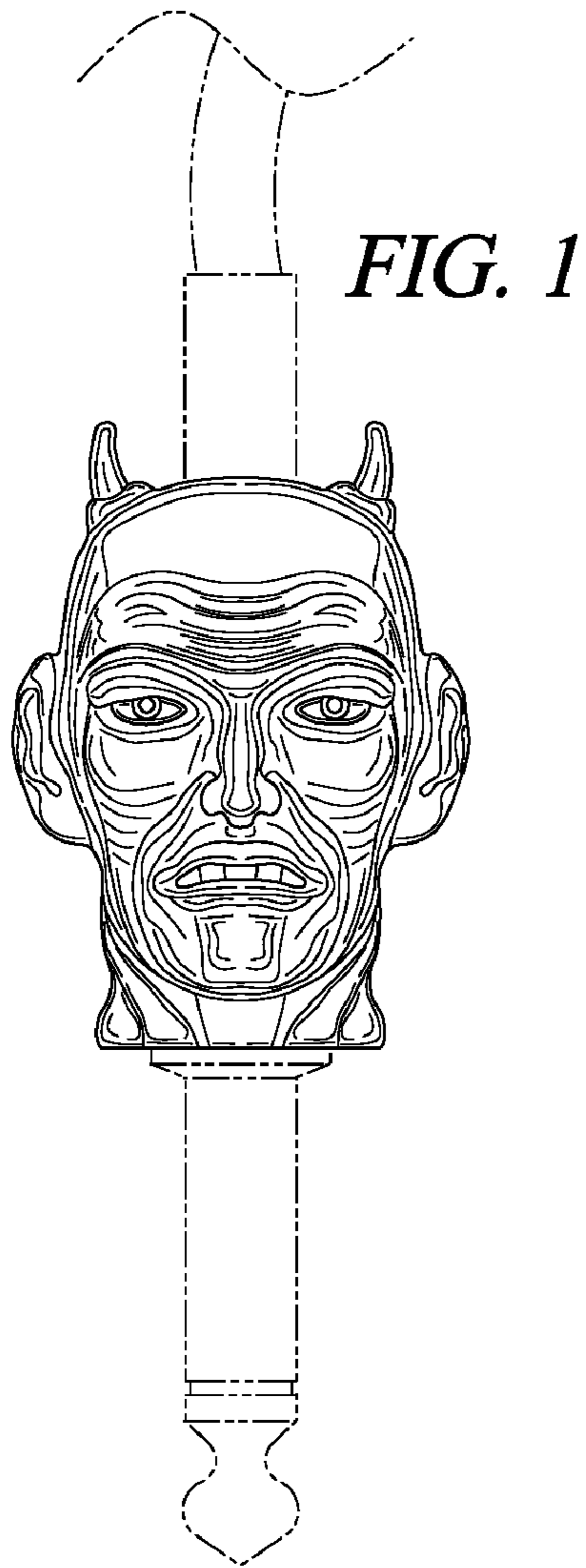
FIG. 6 is a bottom plan view thereof; and,

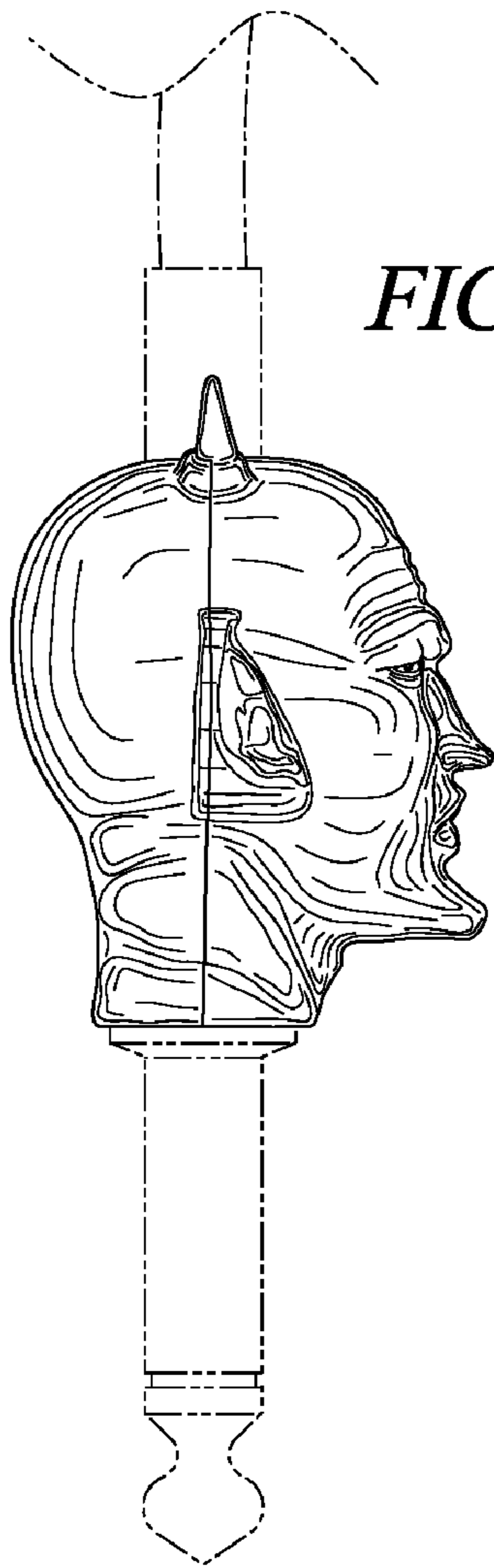
FIG. 7 is a perspective view of a cable devil of the present invention.

The broken line representations in FIGS. 1-7 are for illustrative purposes only and form no part of the claimed design.

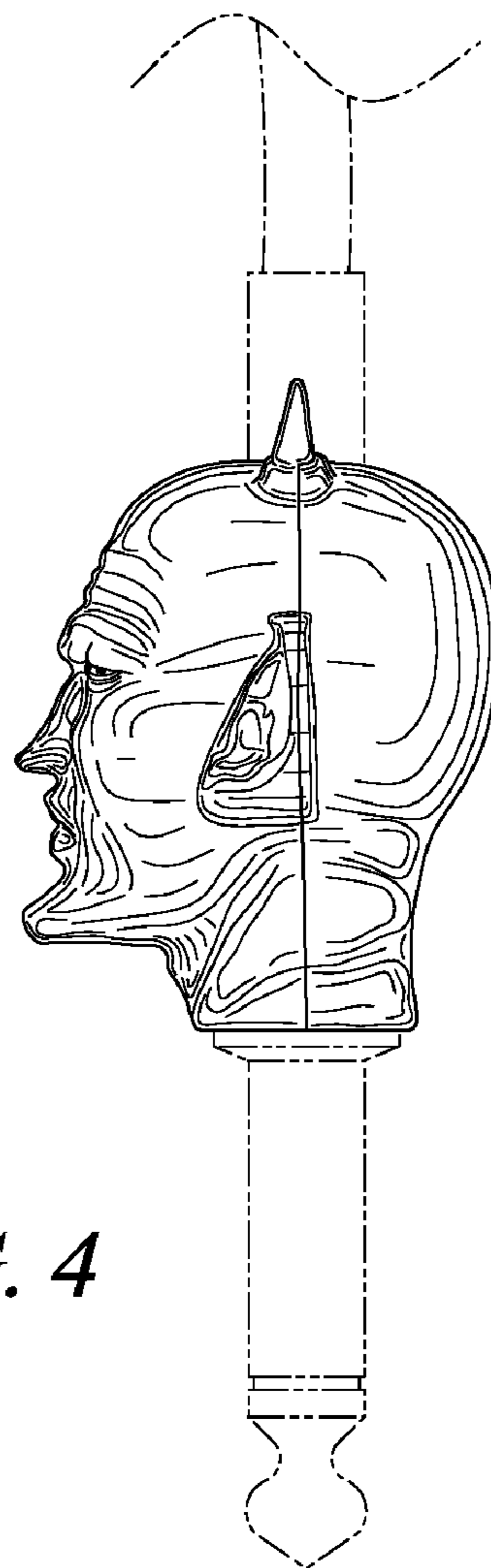

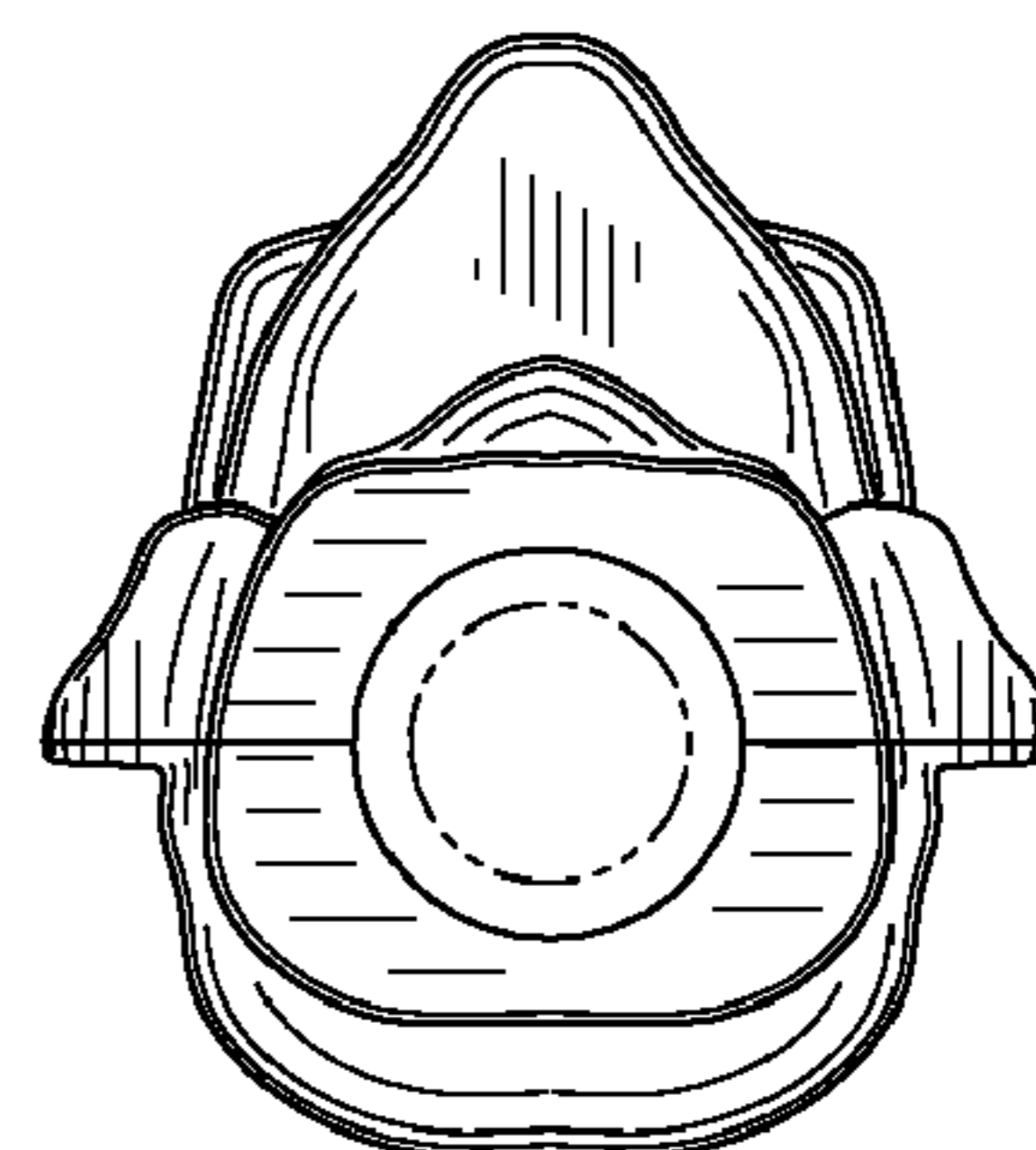
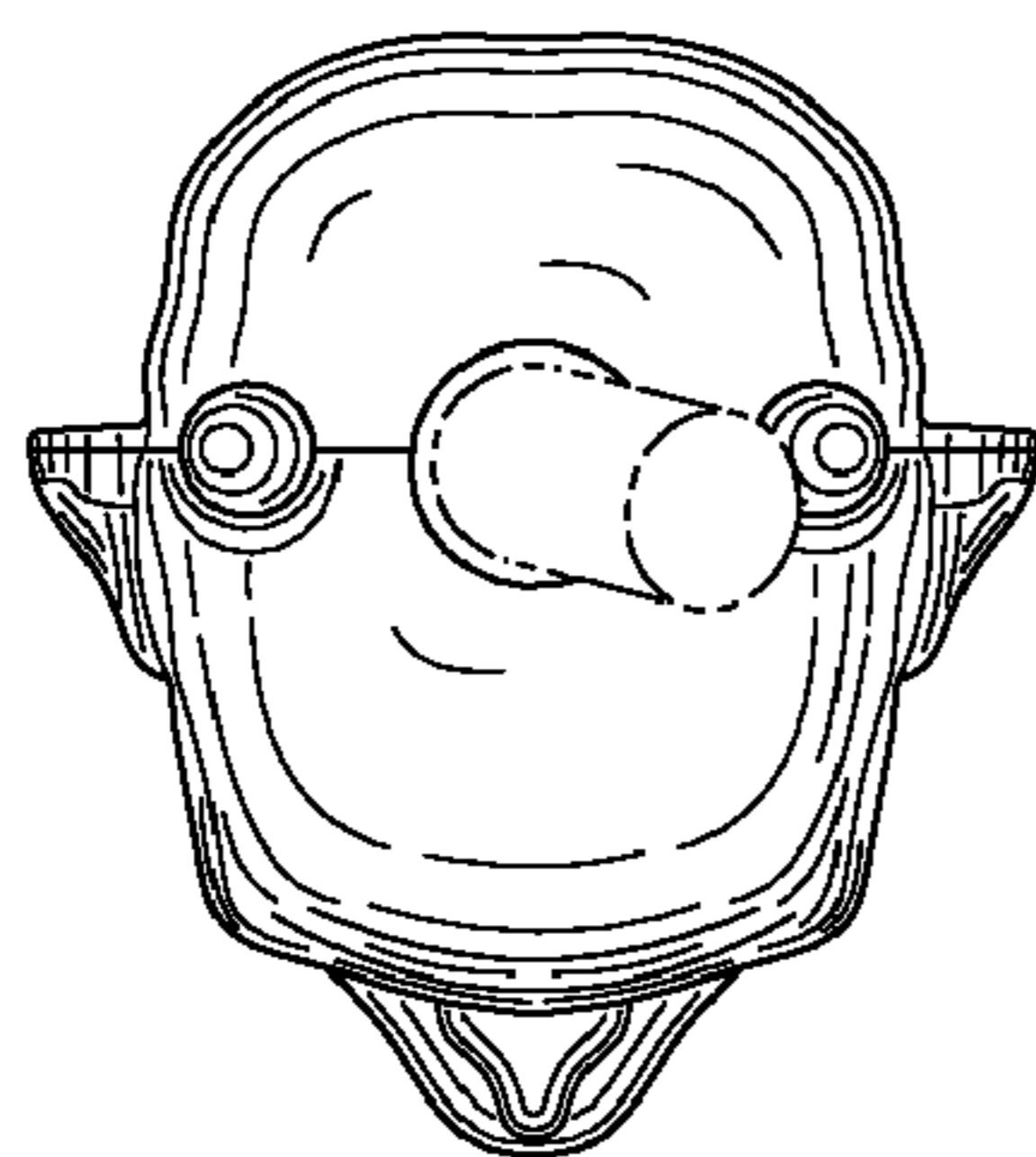

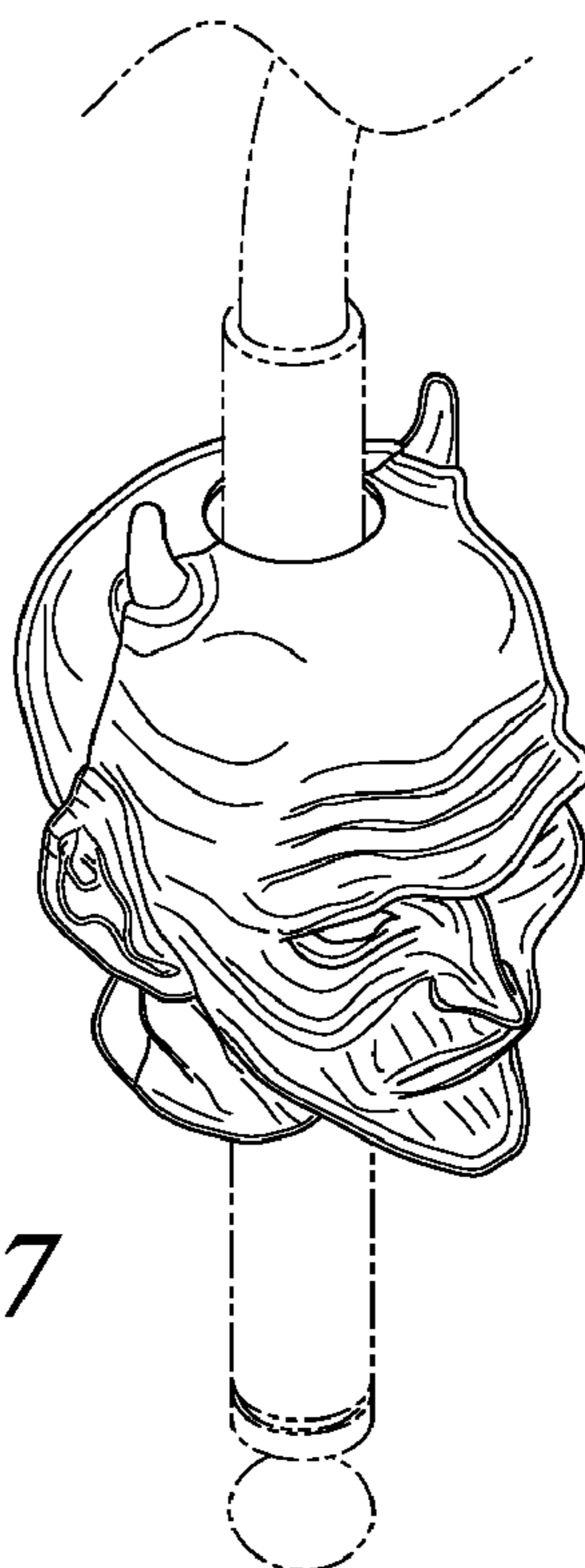
