FIG. 3 is a bottom view of FIG. 5;

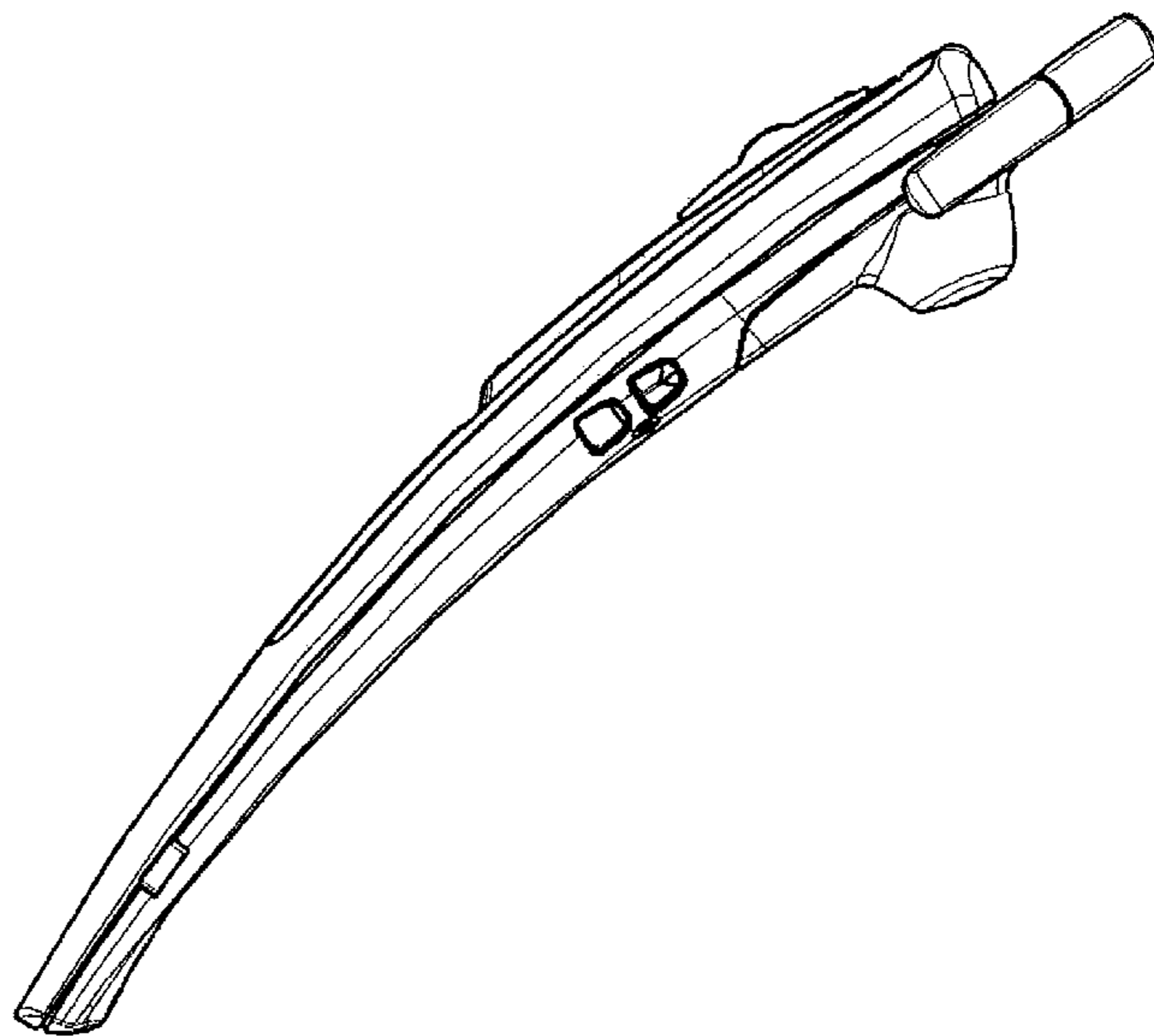
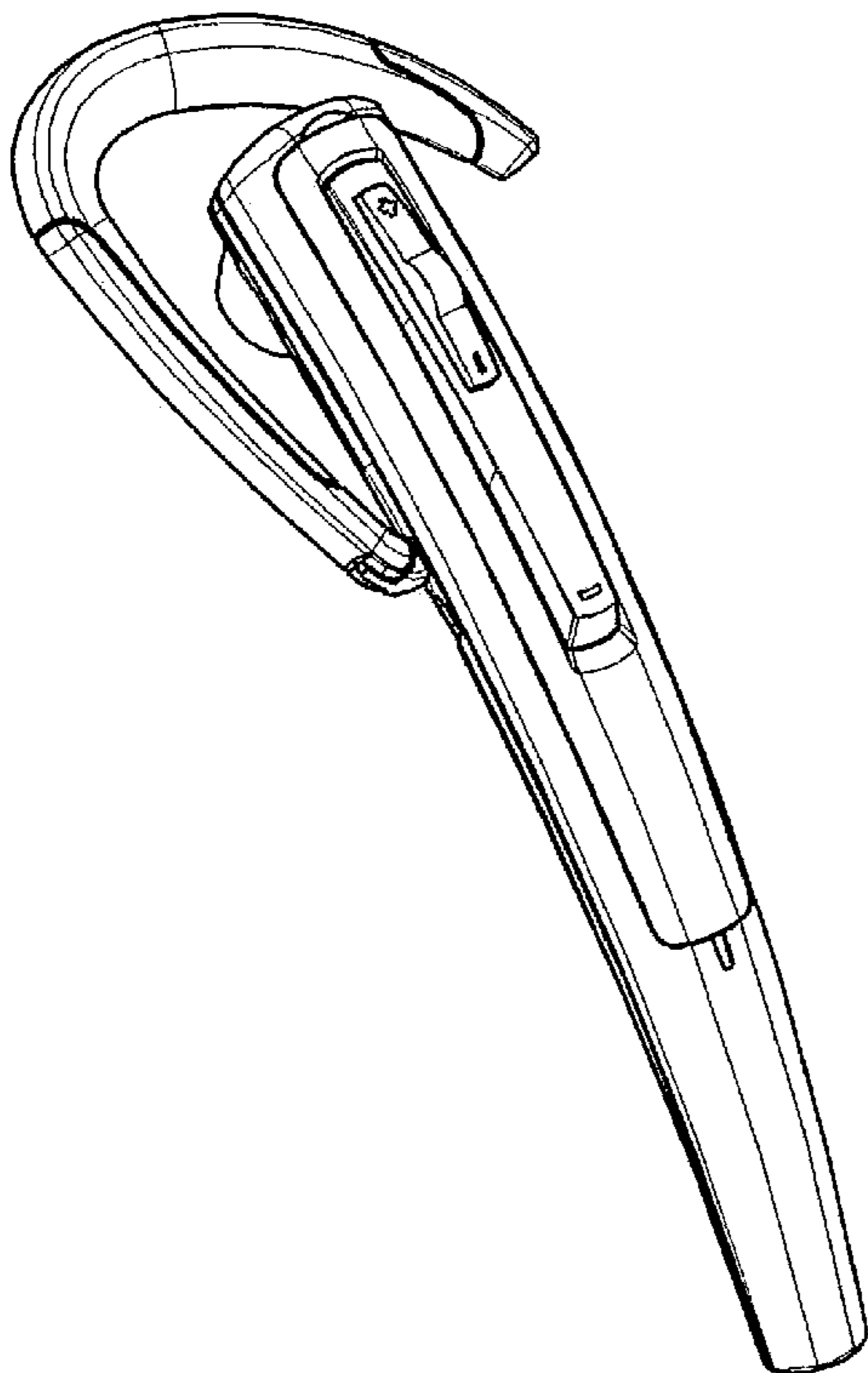
FIG. 4 is a side view of FIG. 1;

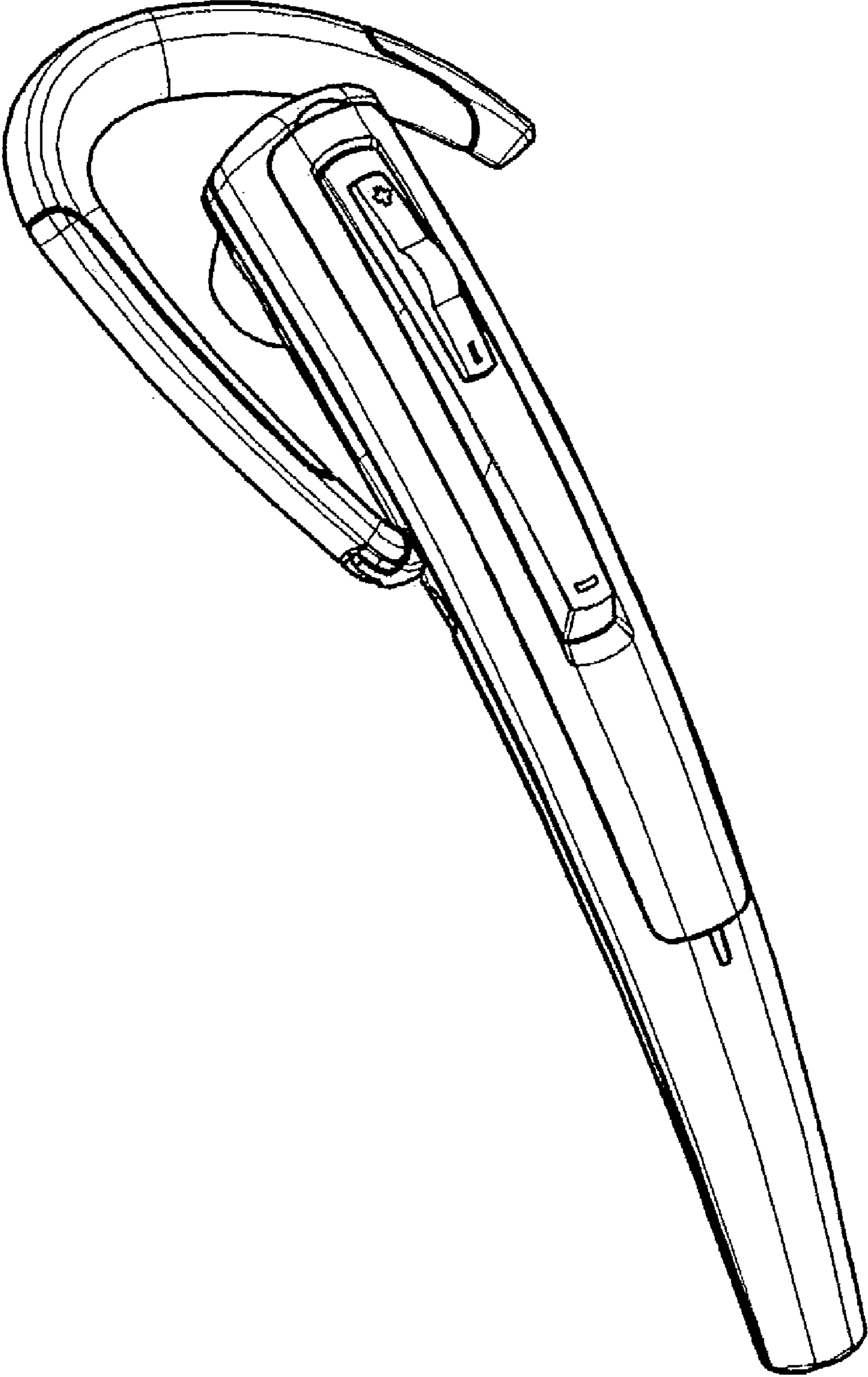

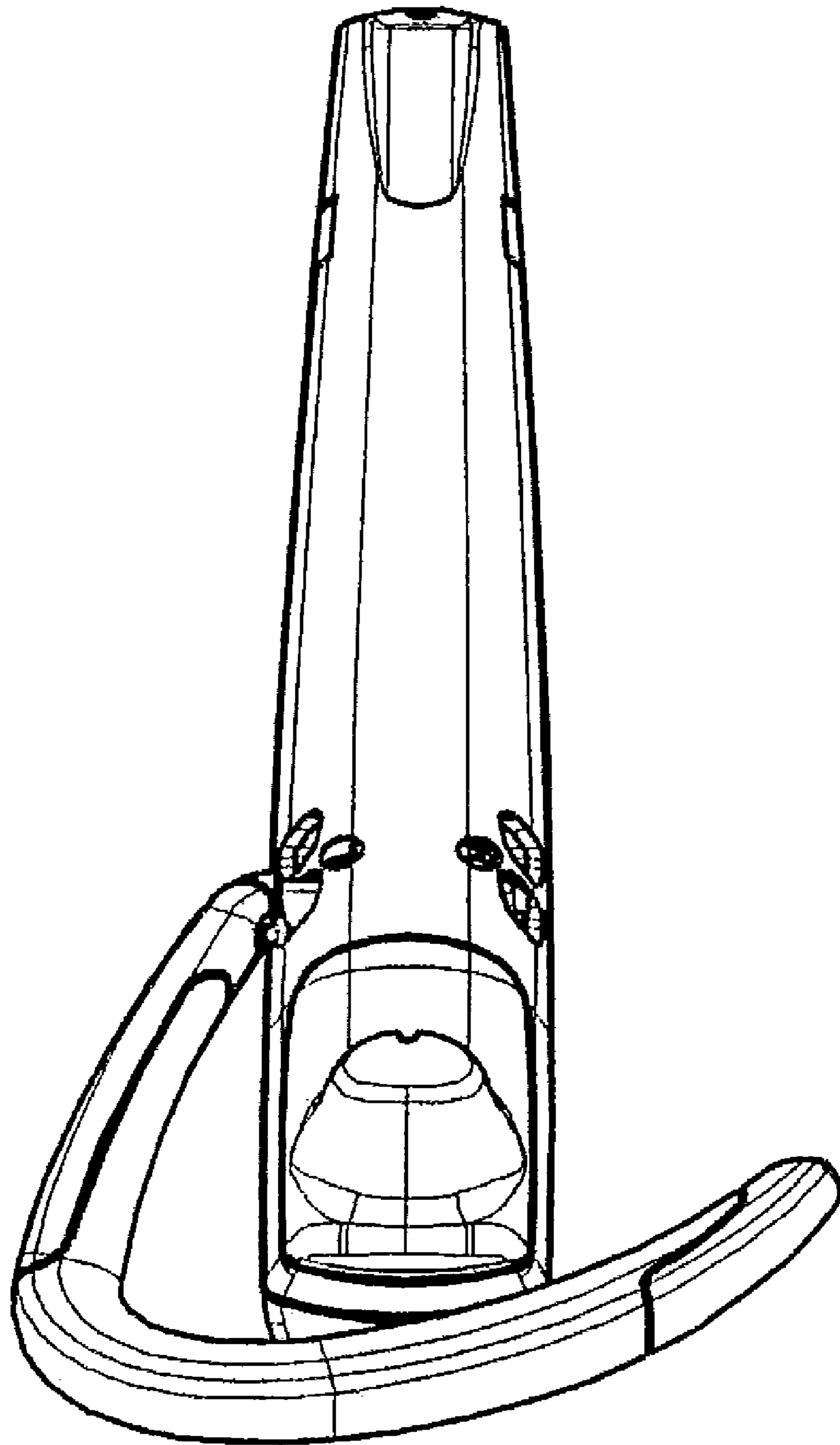

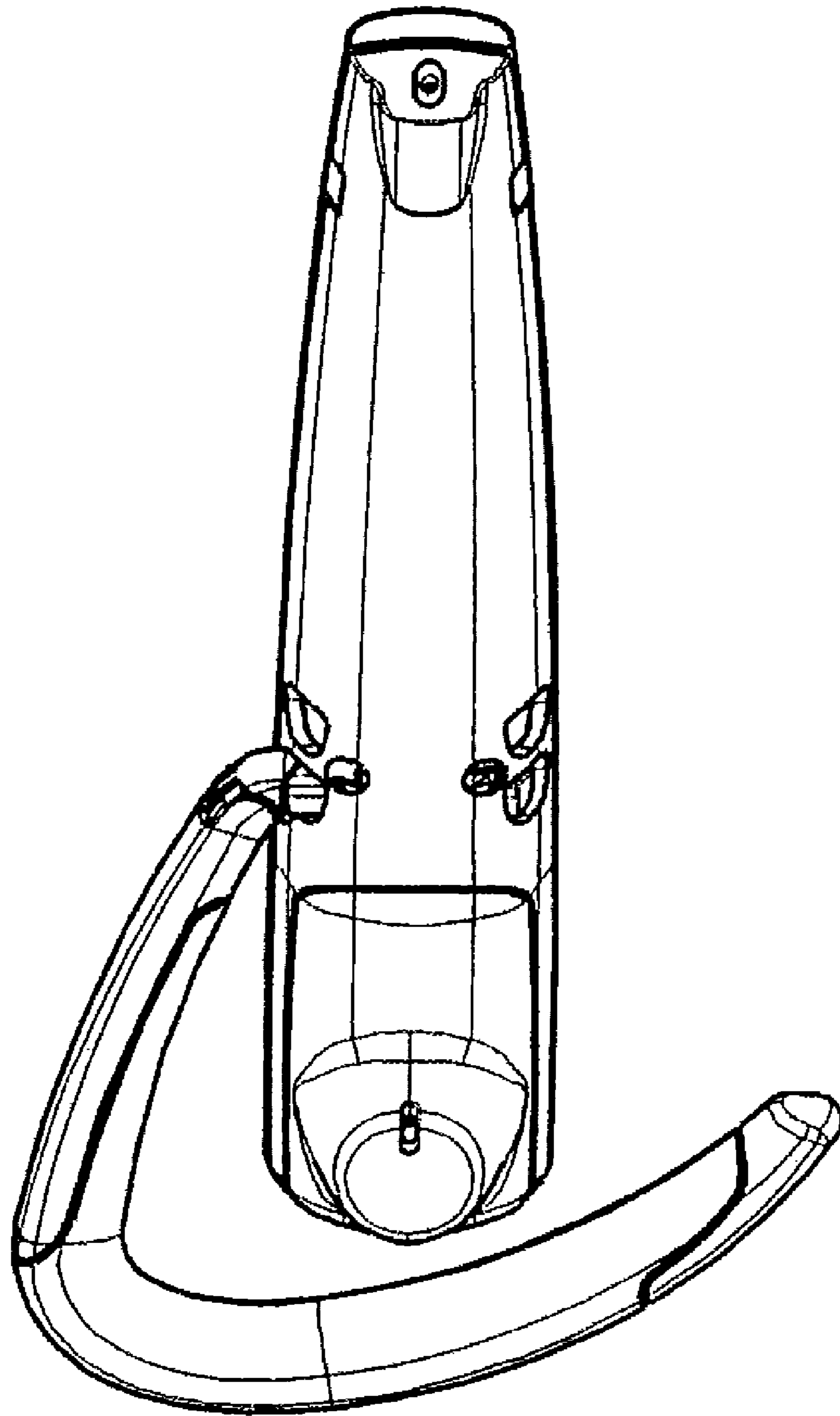

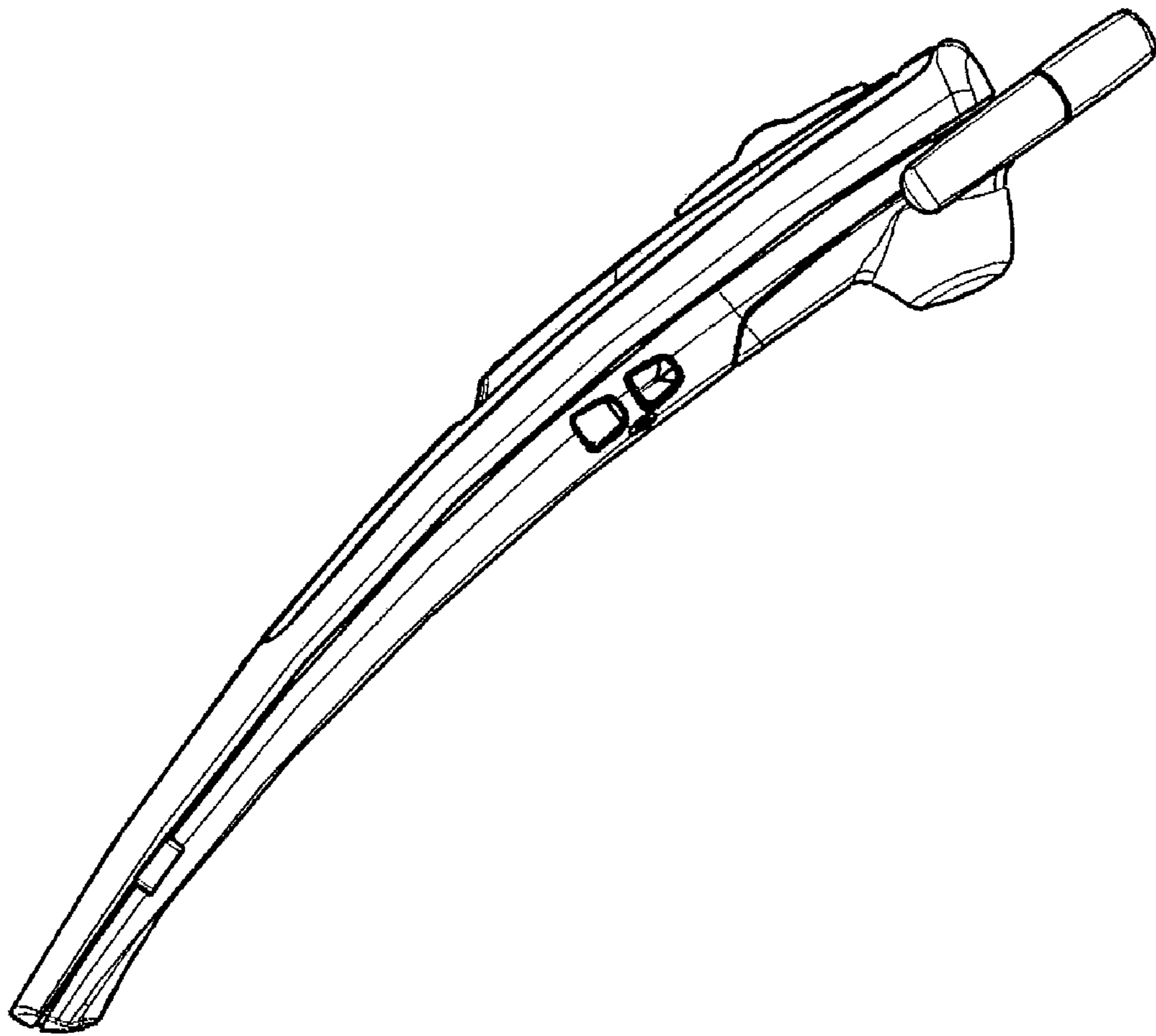

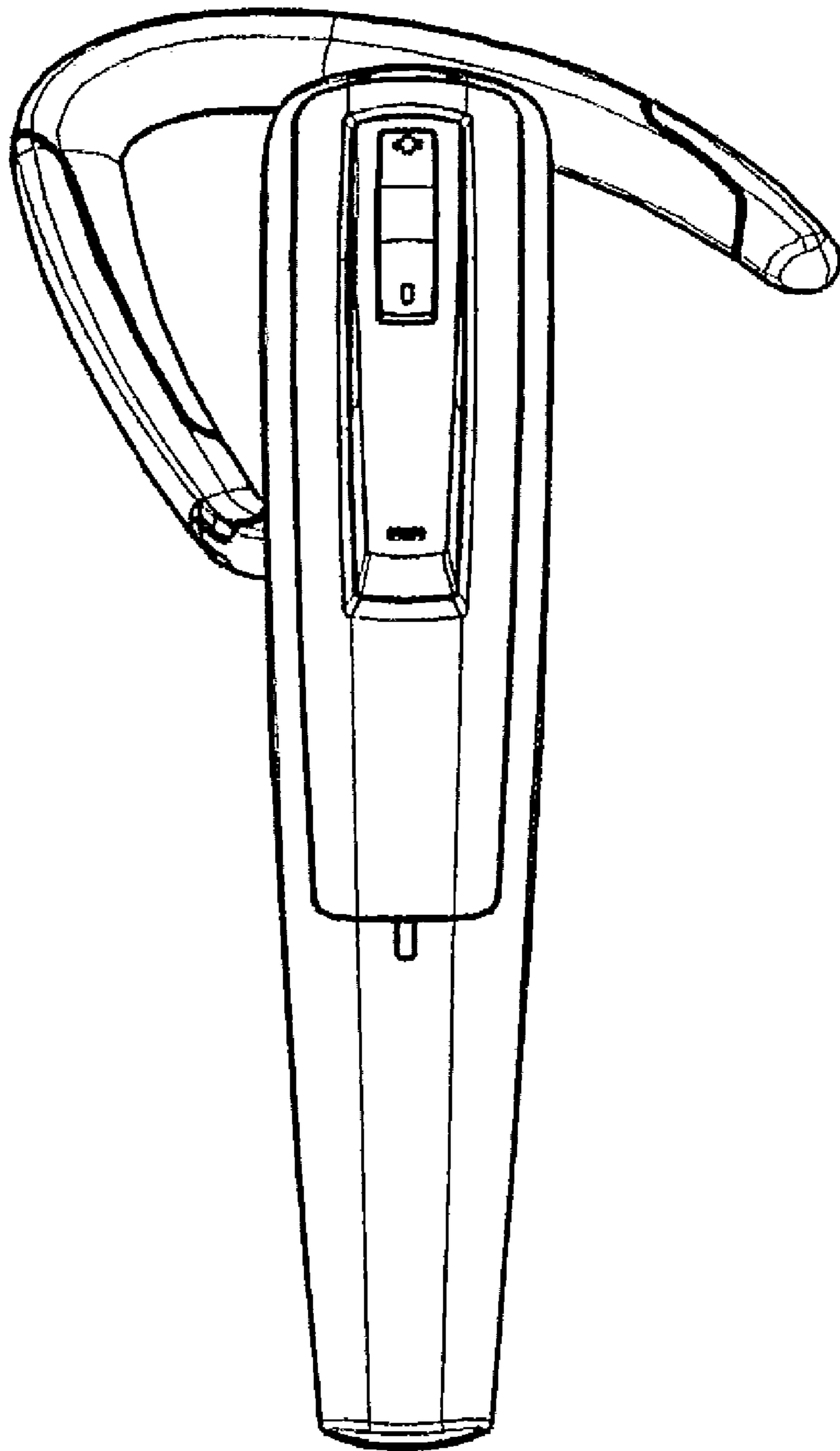

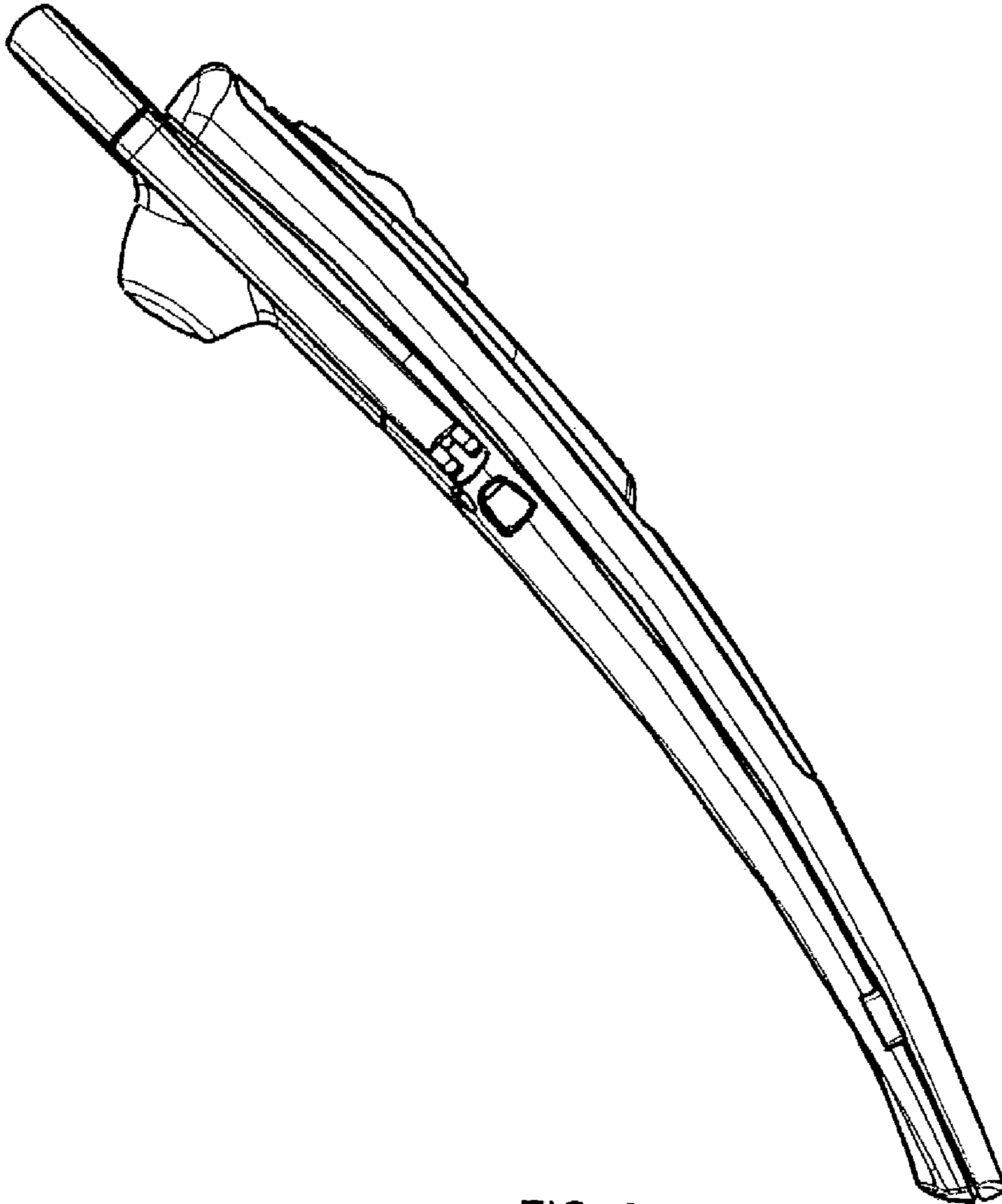

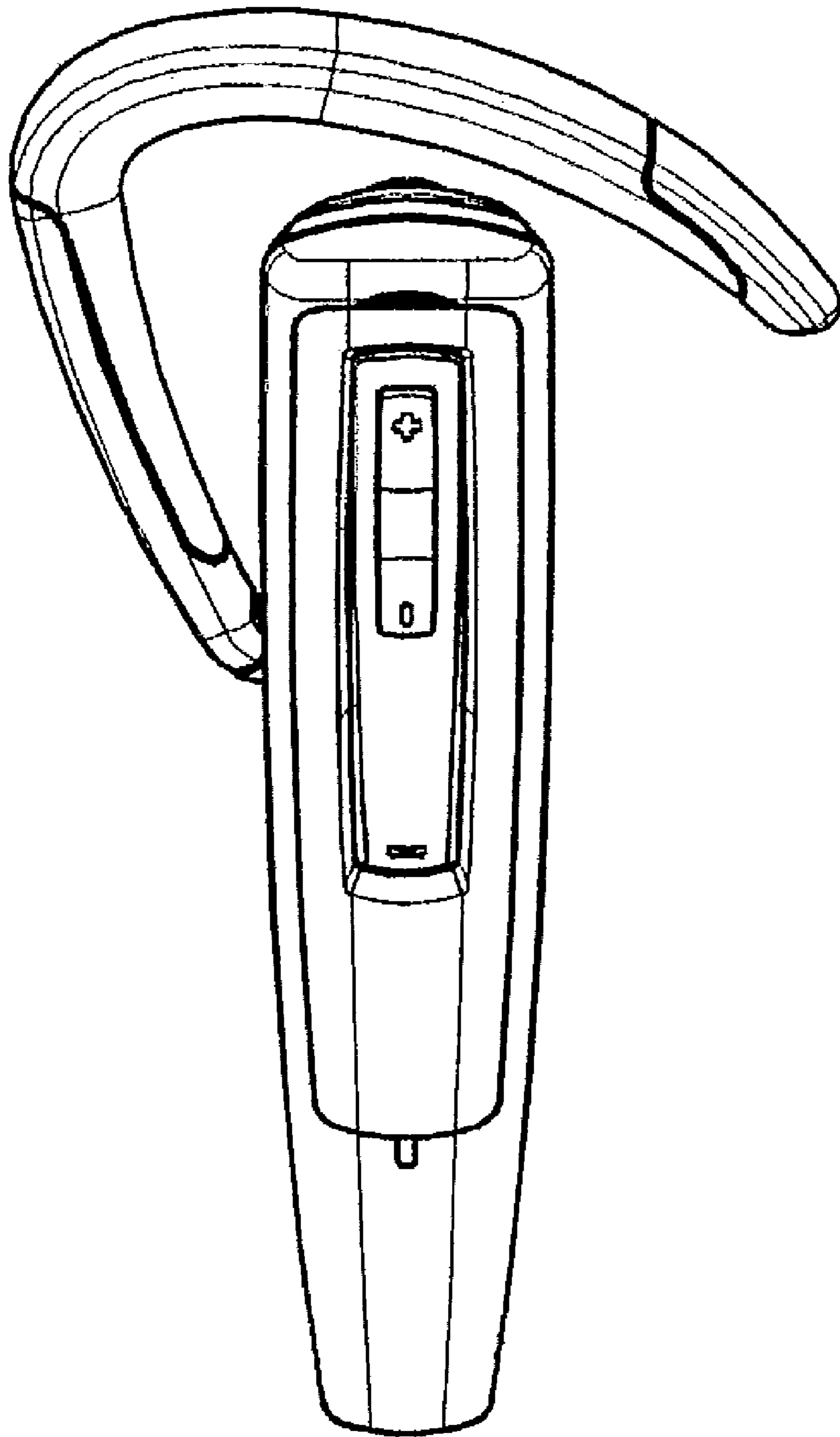
