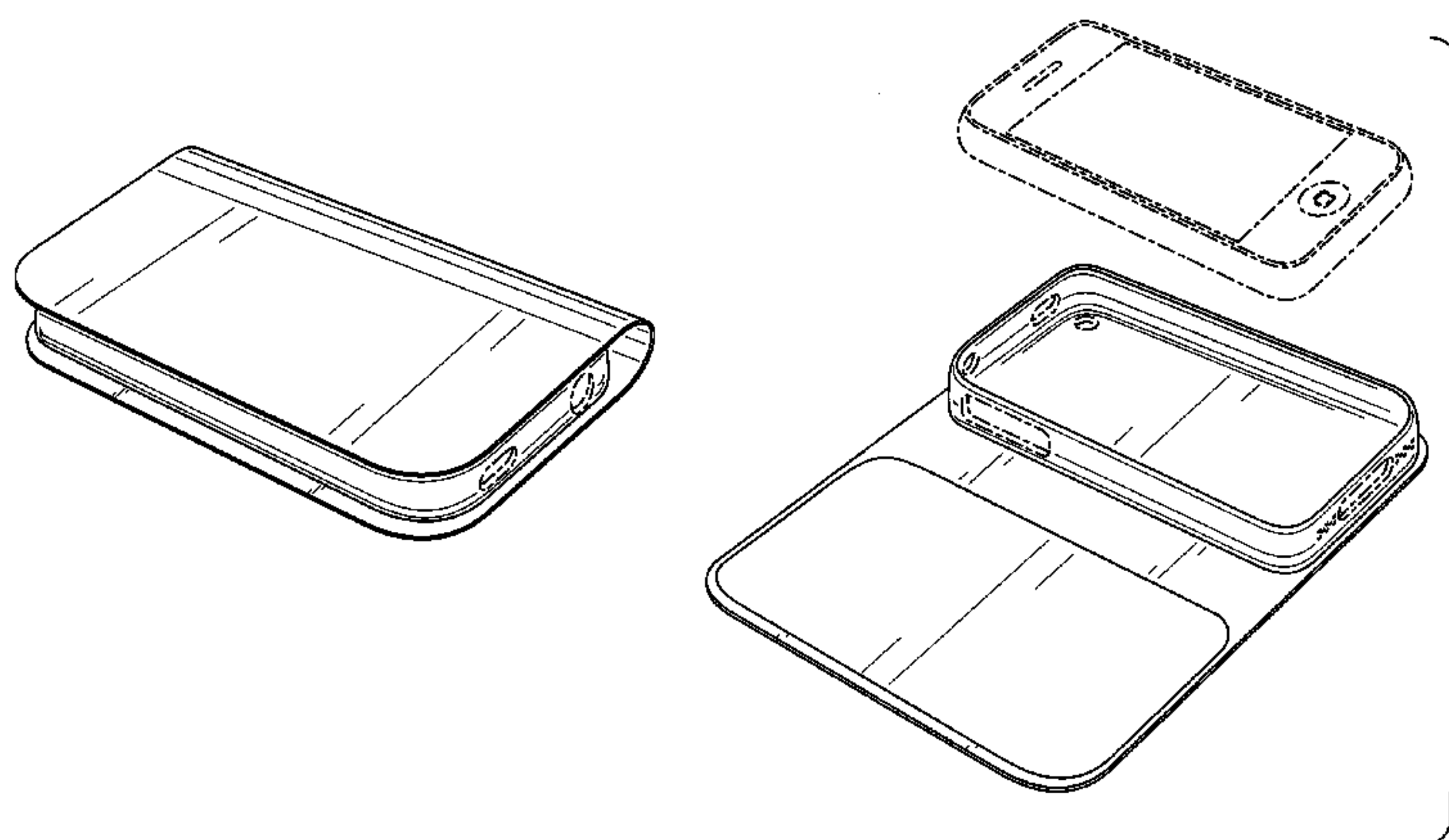
The ornamental design for a case, substantially as shown and described.

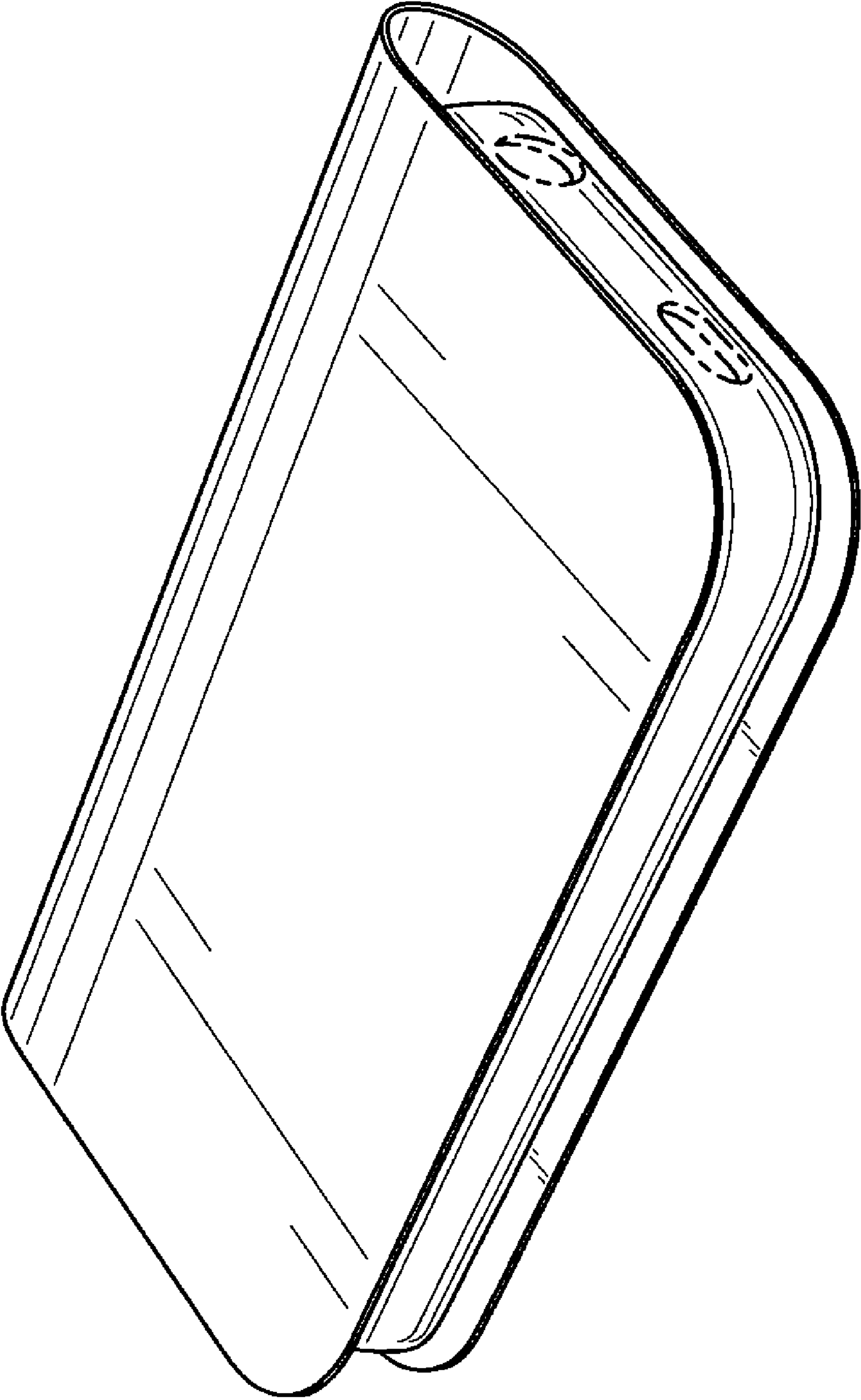

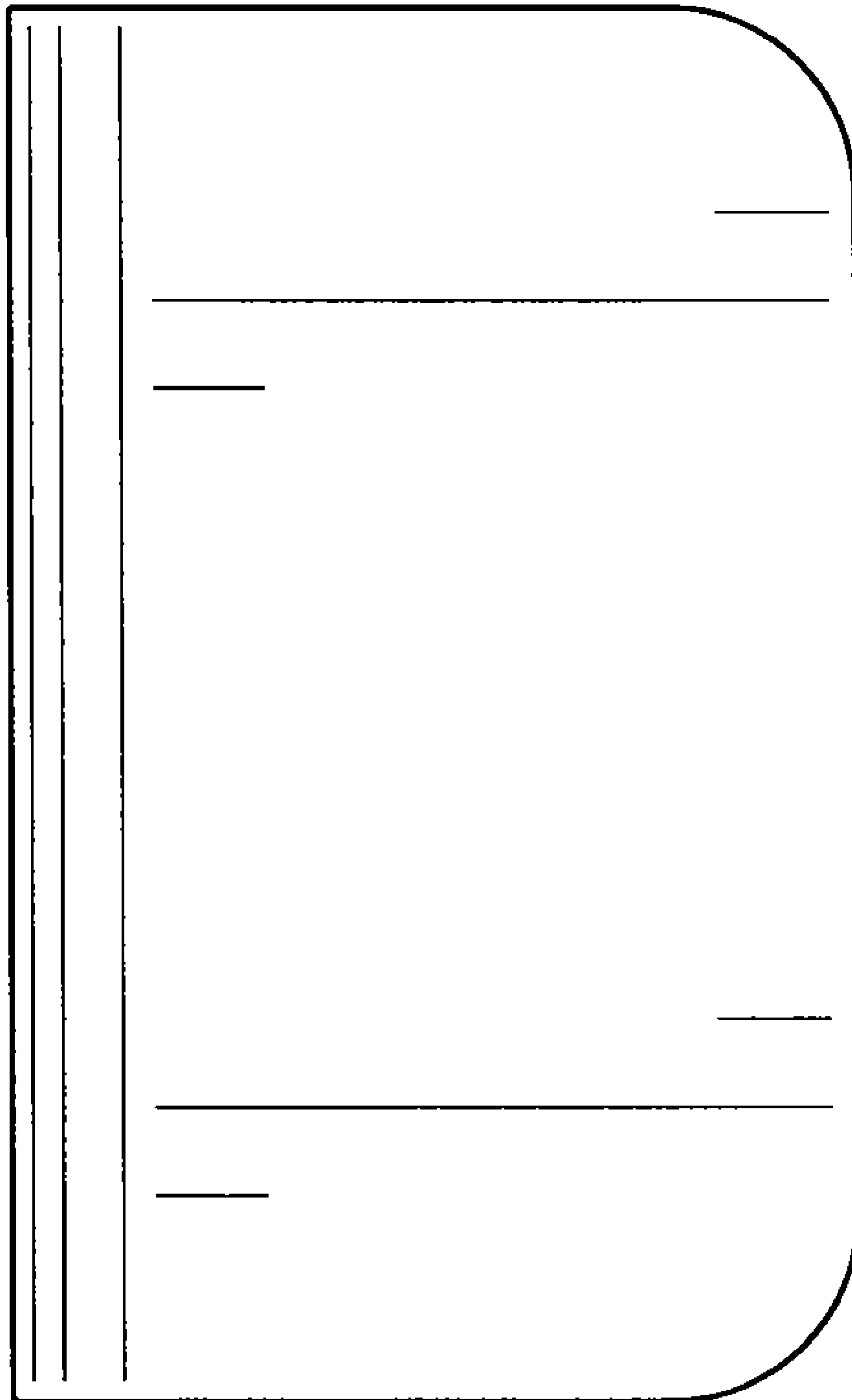

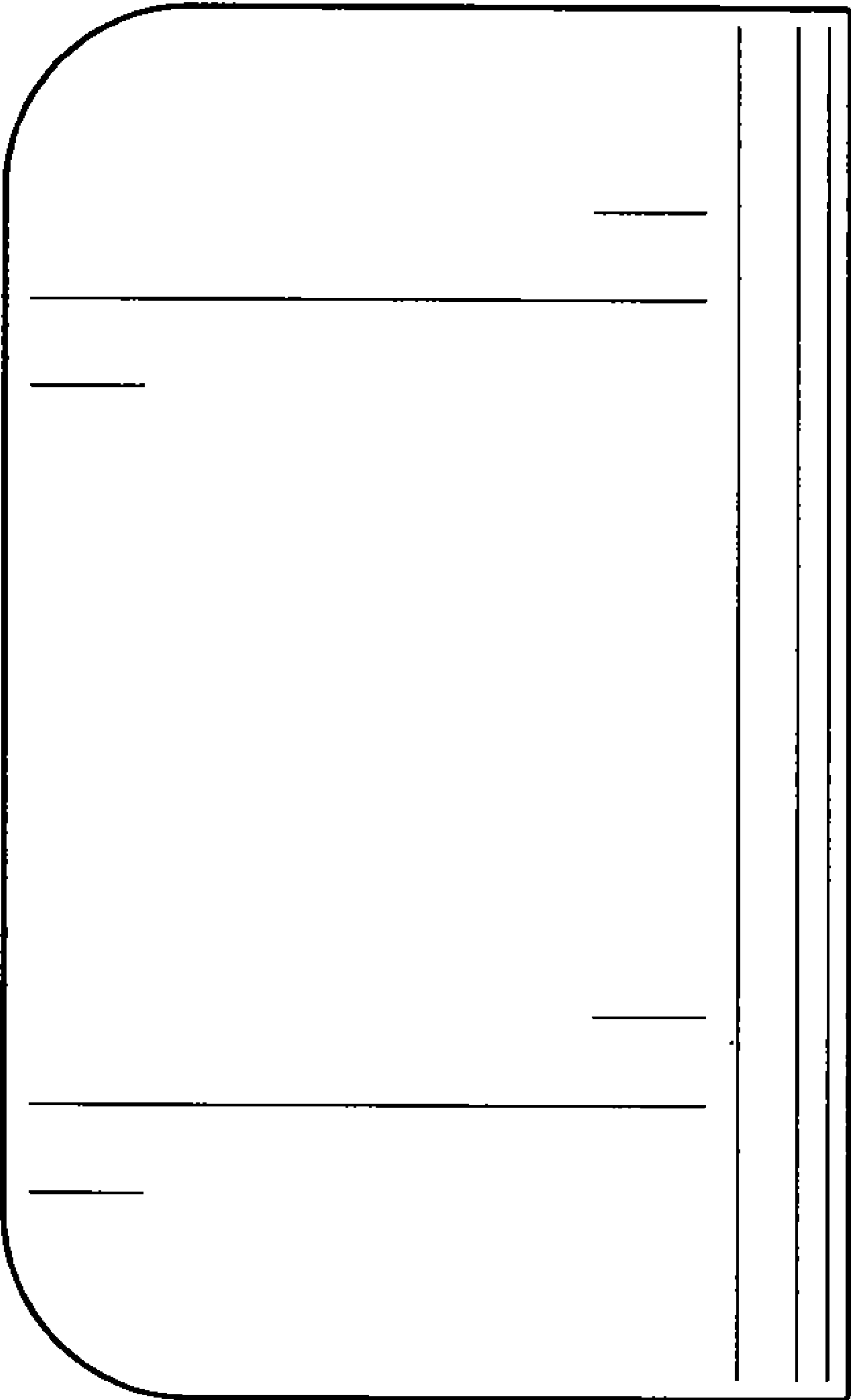

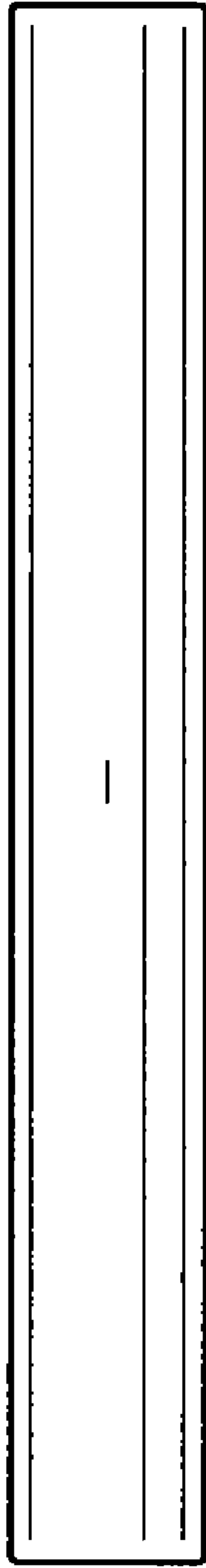

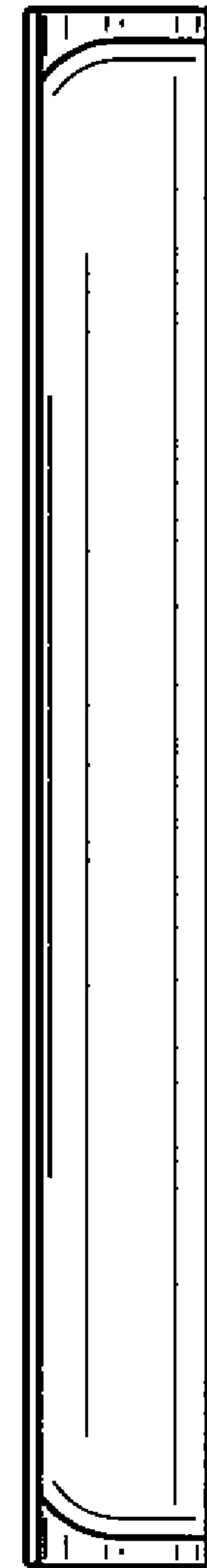

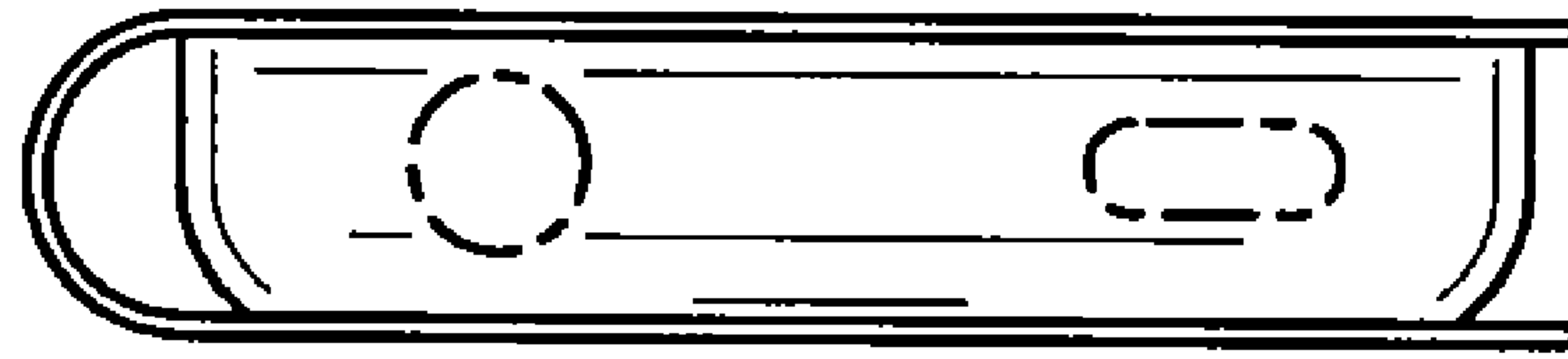

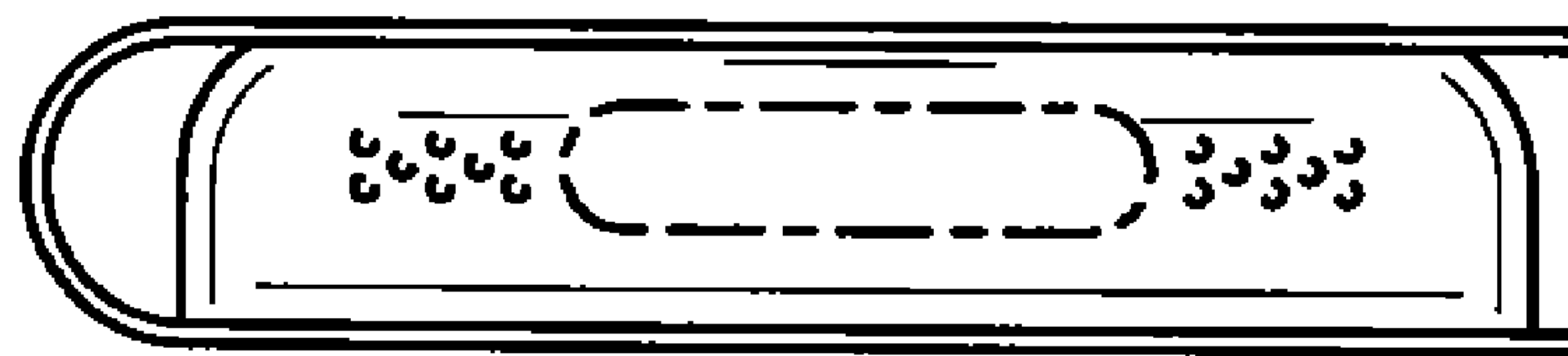

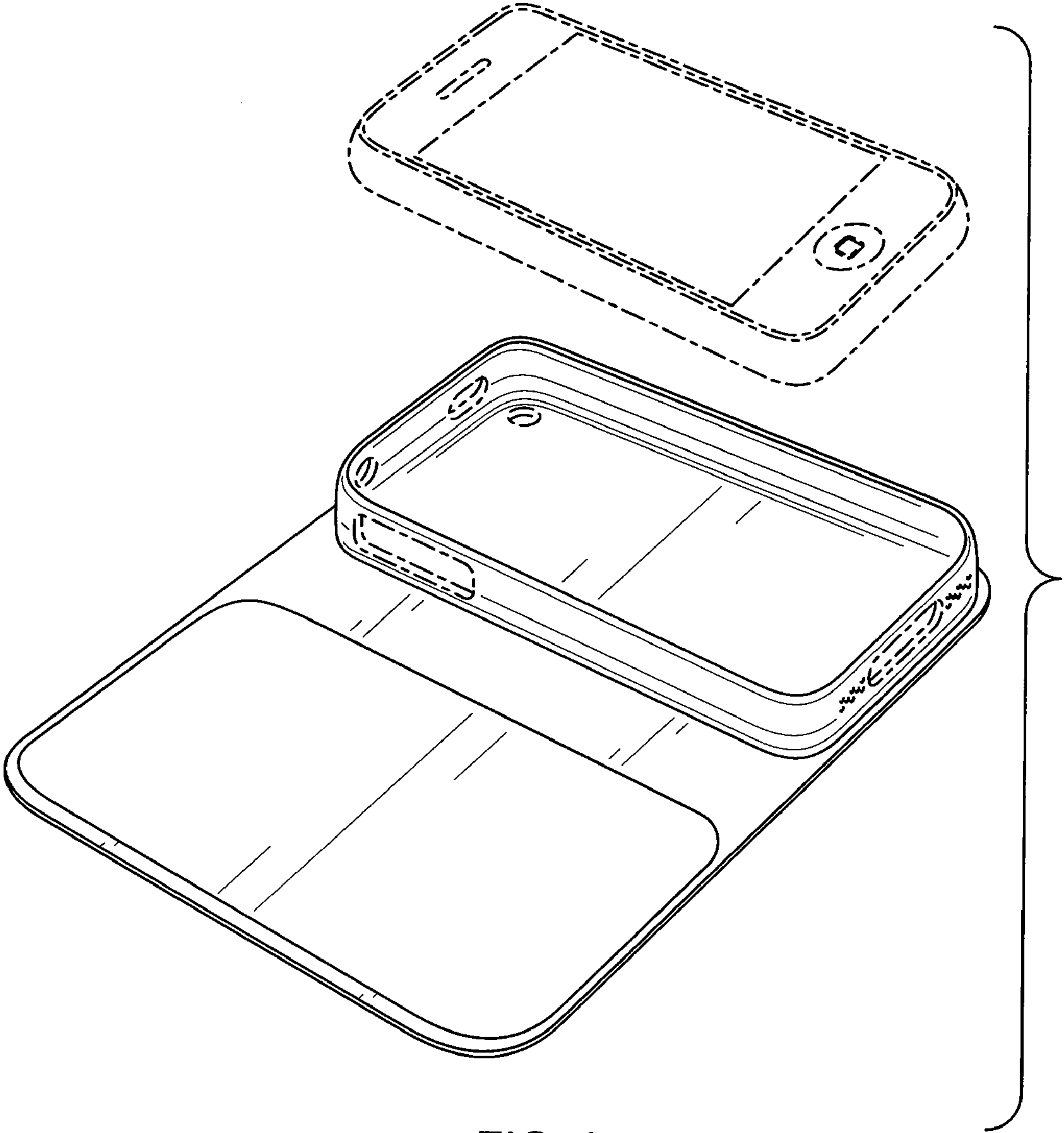

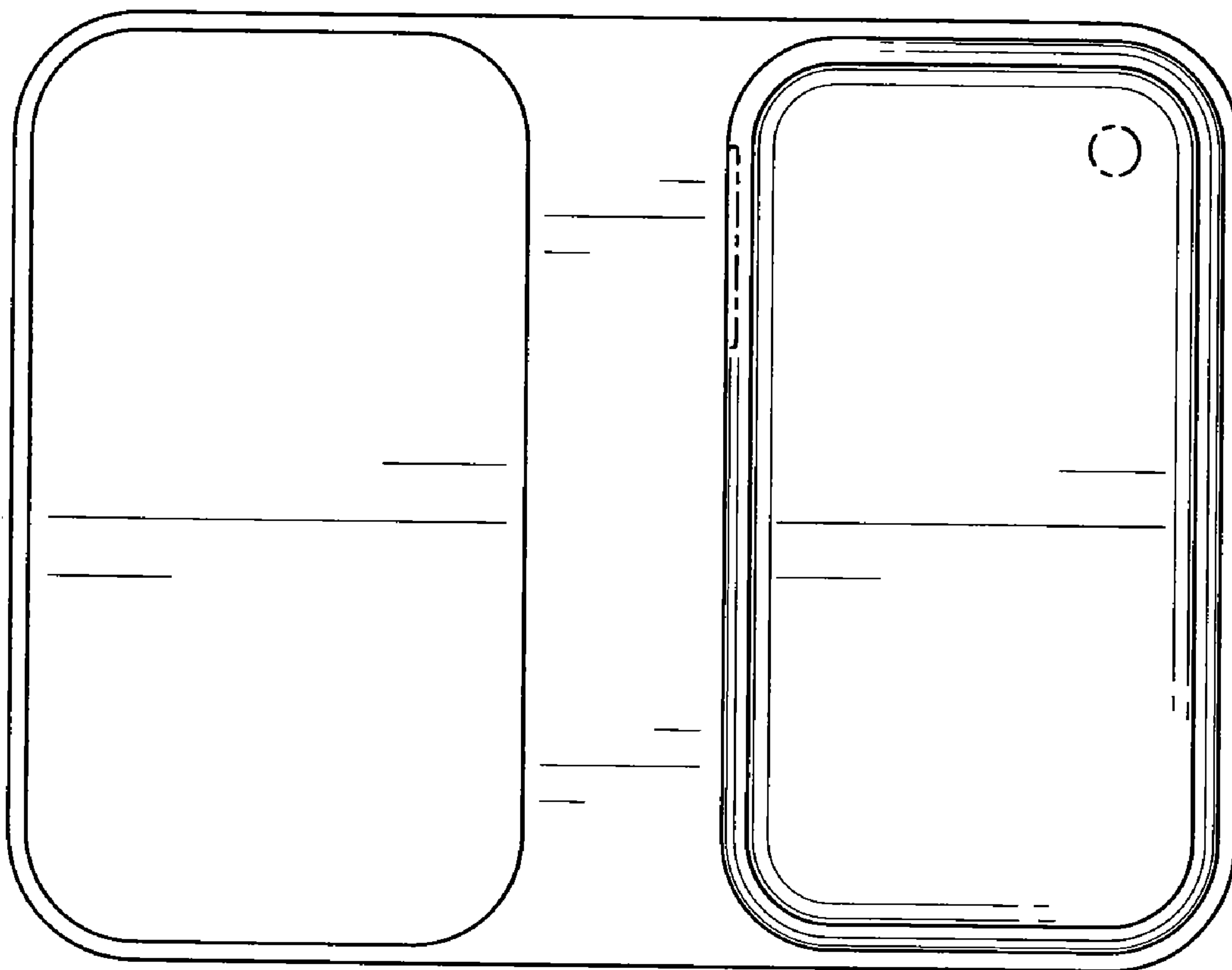

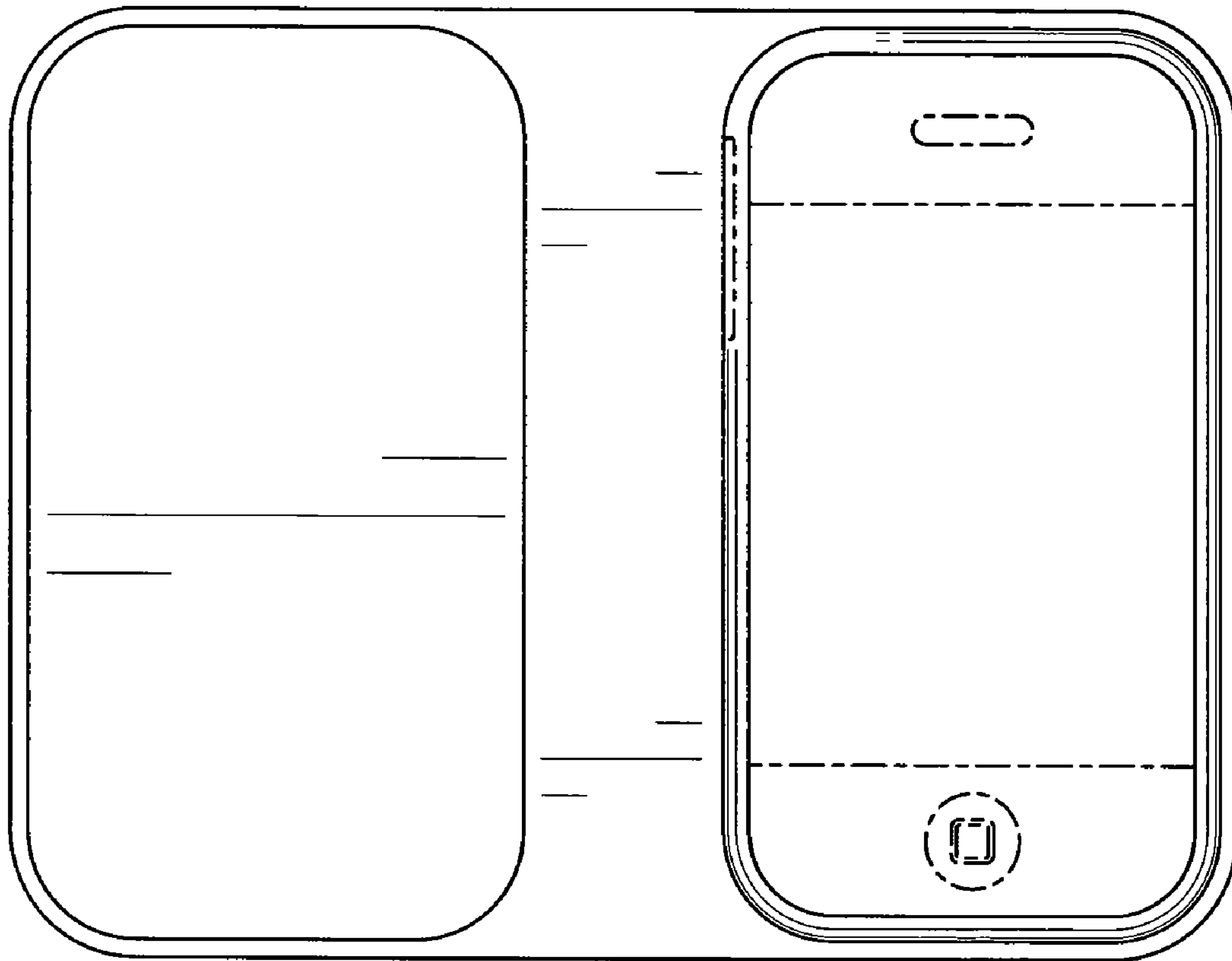

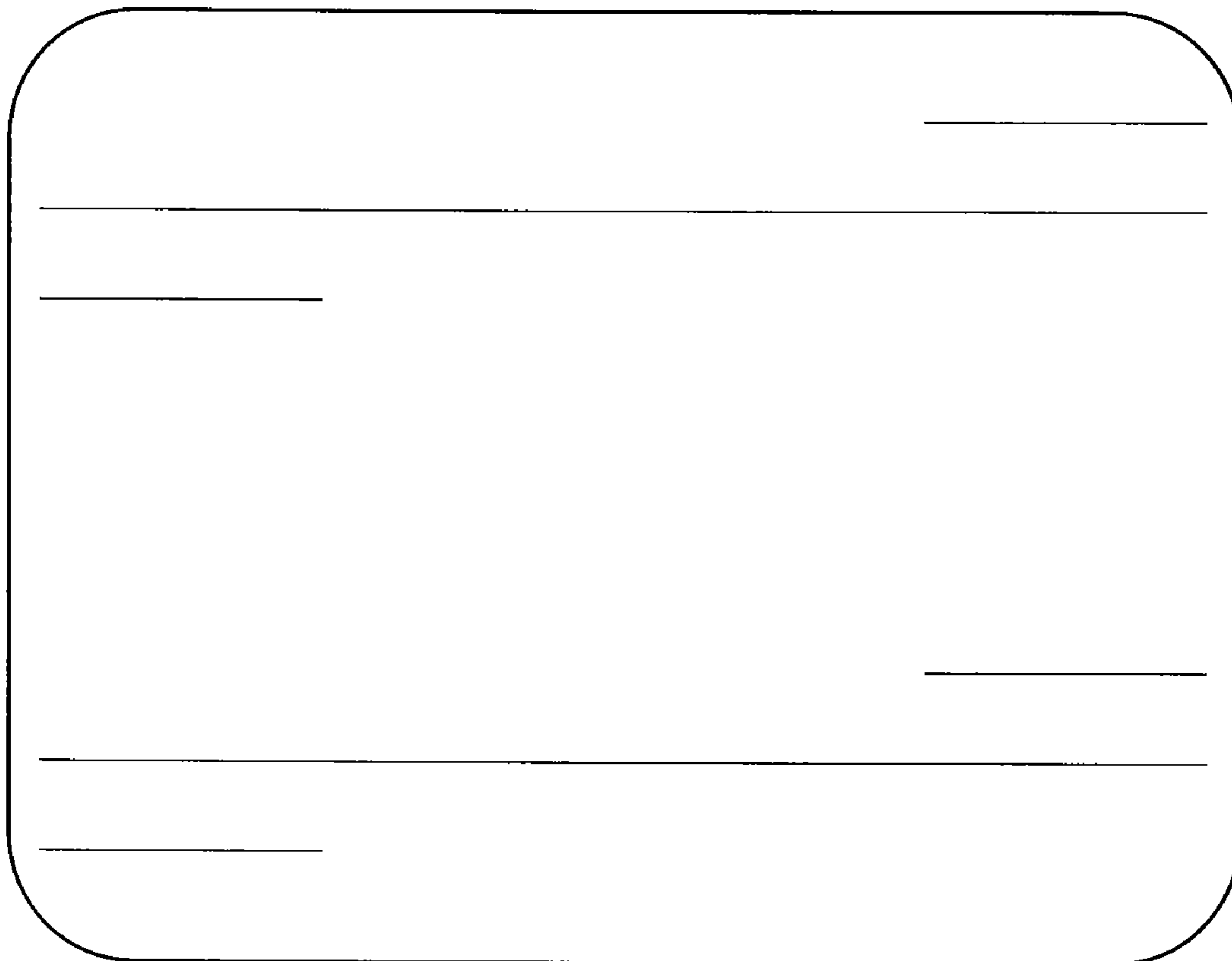

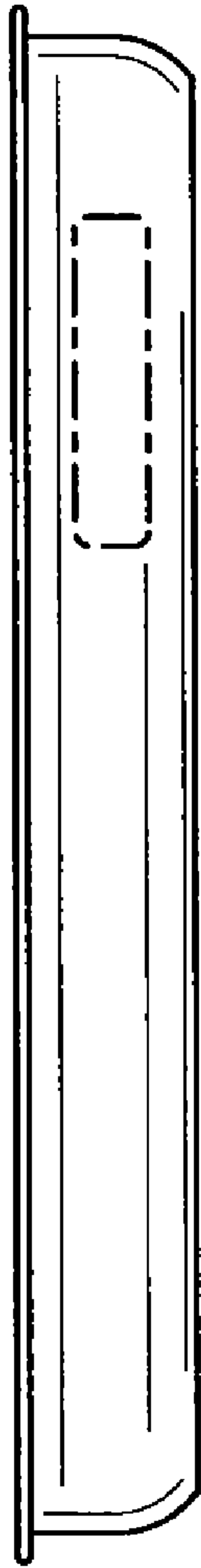

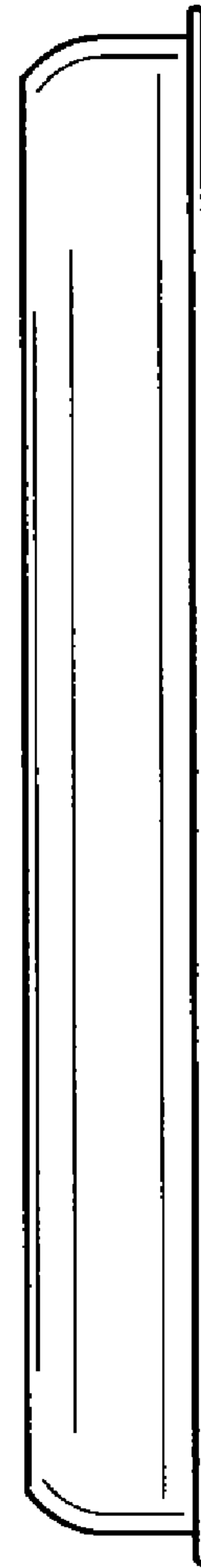

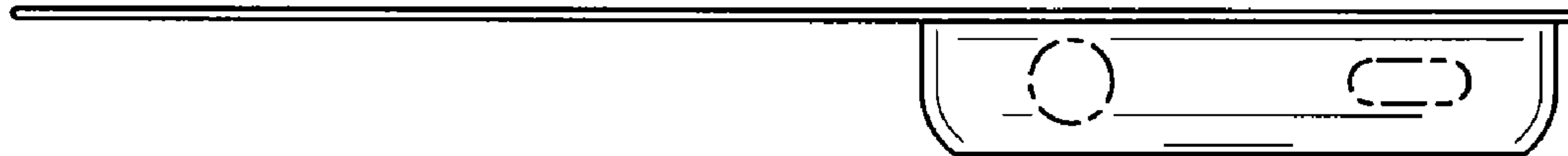
