FIG. 2 is a rear elevational view thereof;

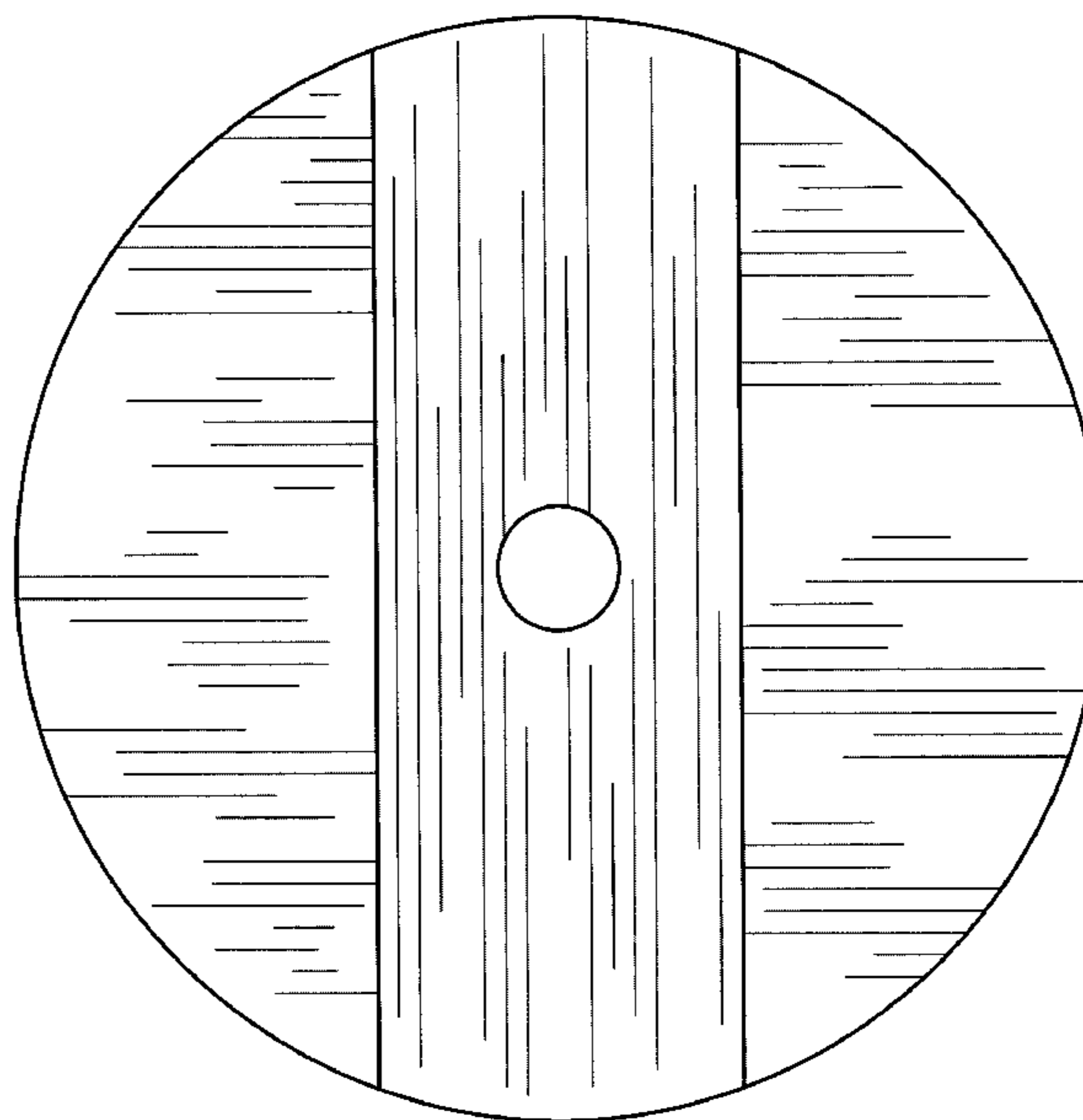
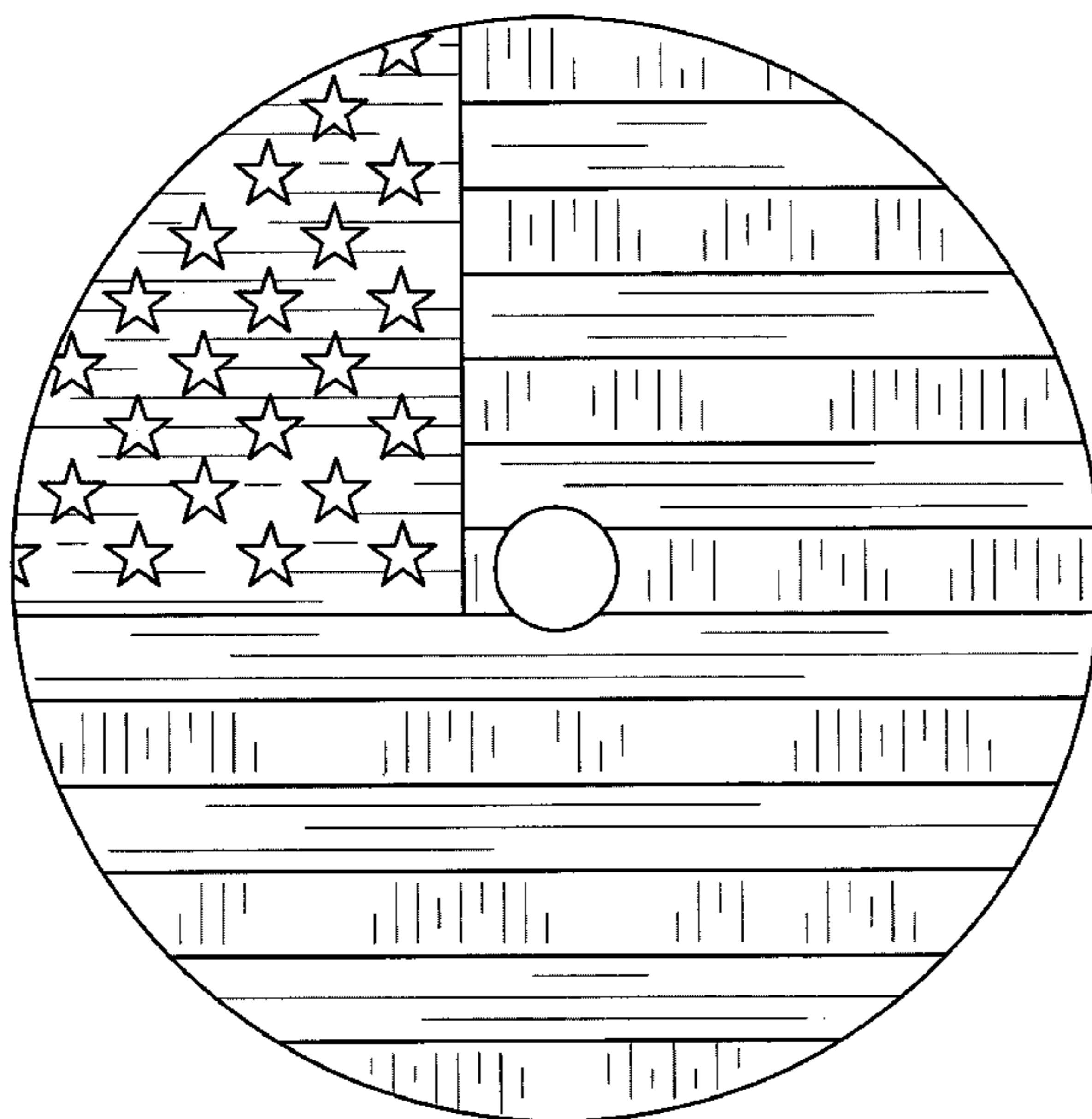
FIG. 3 is atop plan view thereof;

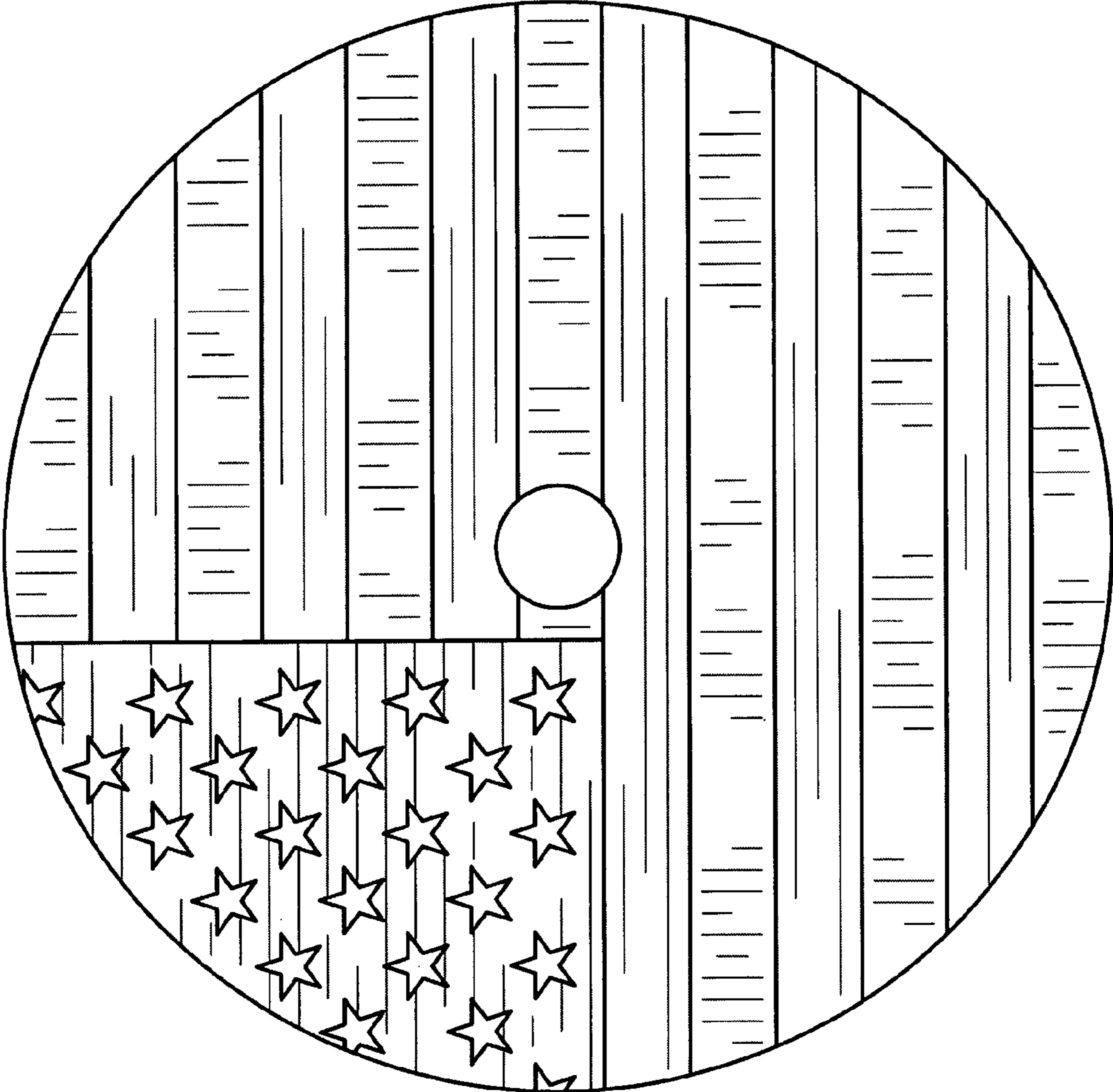

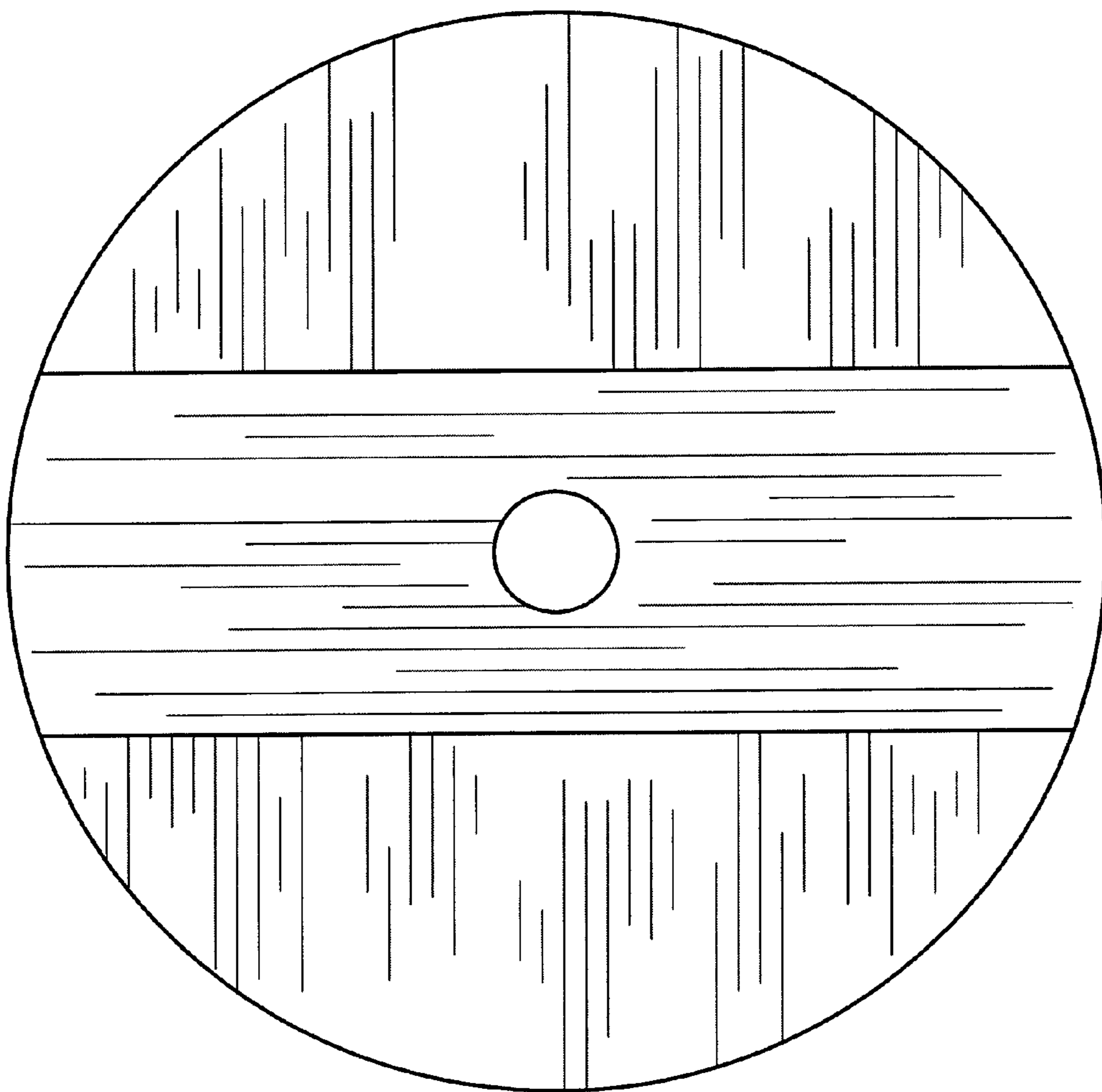
