The ornamental configuration for an earth moving machine, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of an earth moving machine showing our new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a frontal view thereof

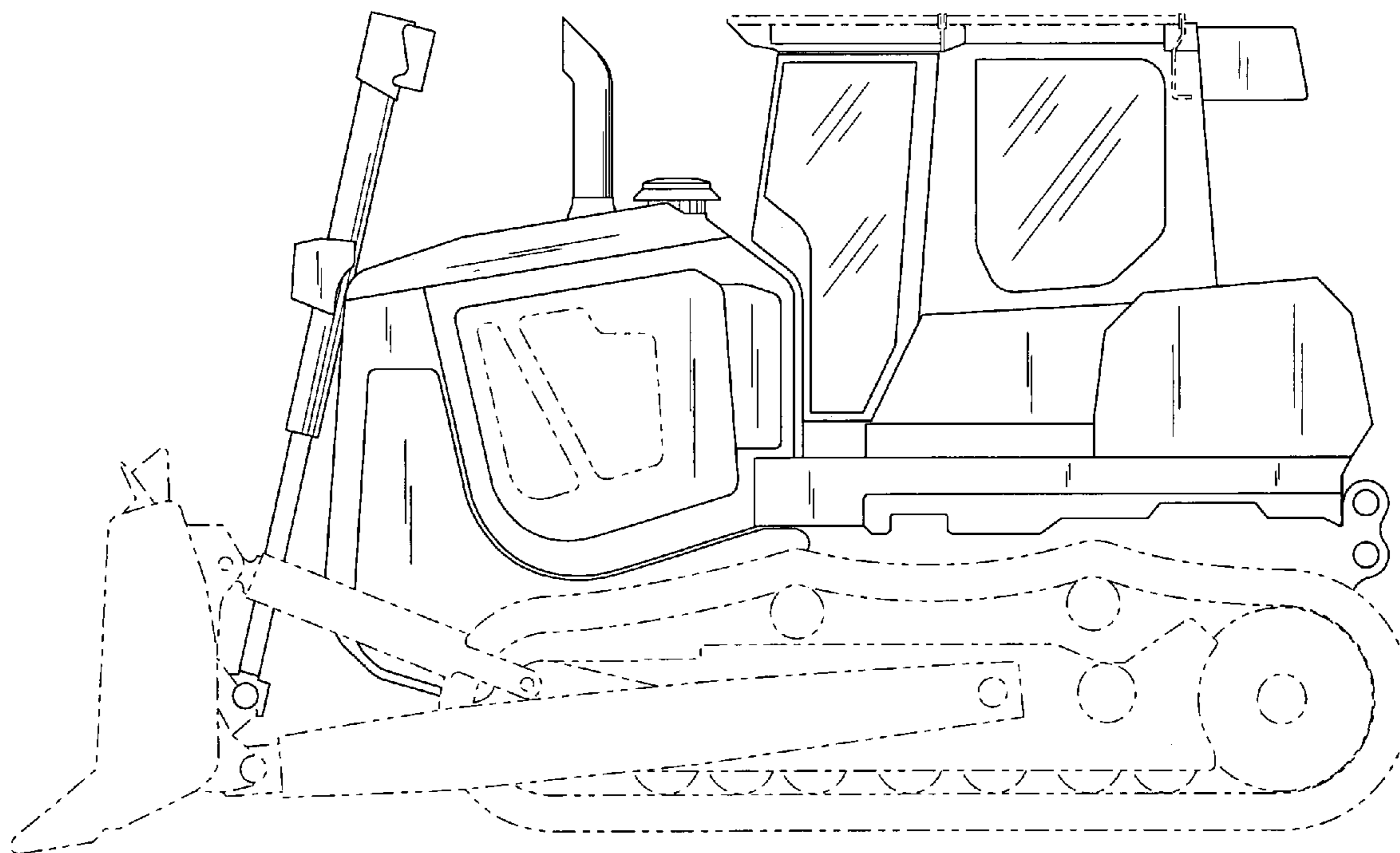
FIG. 4 is a top view thereof;

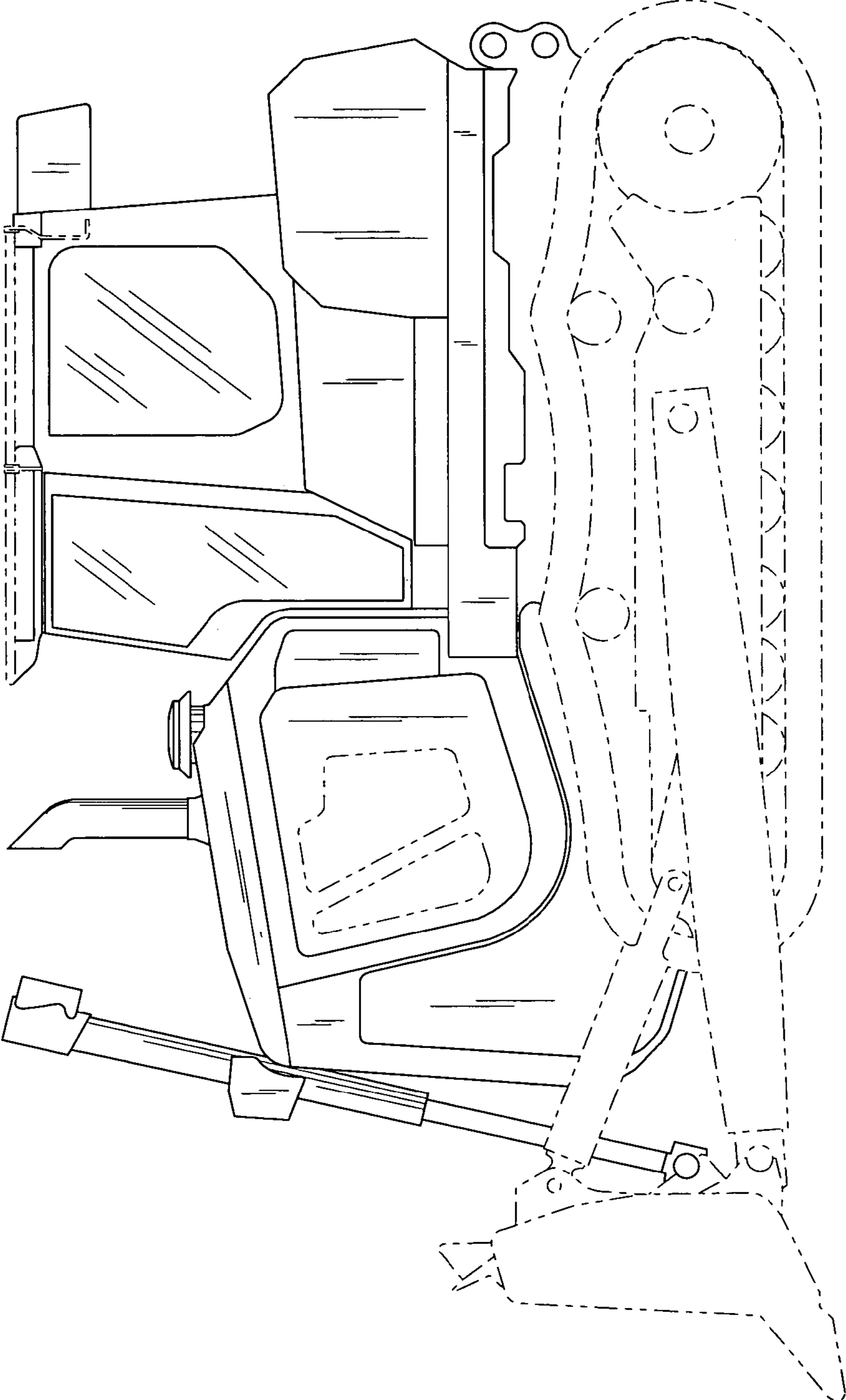

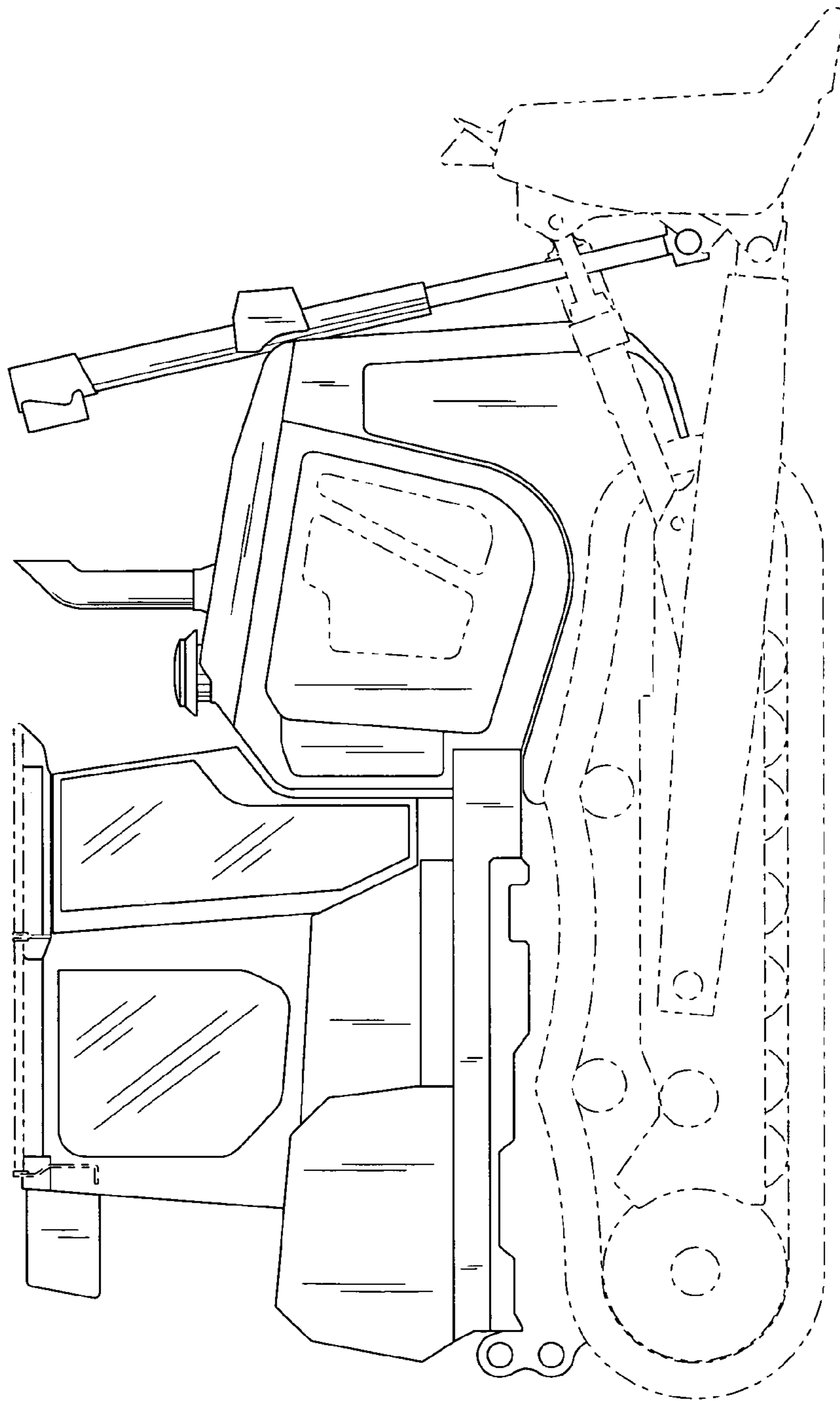
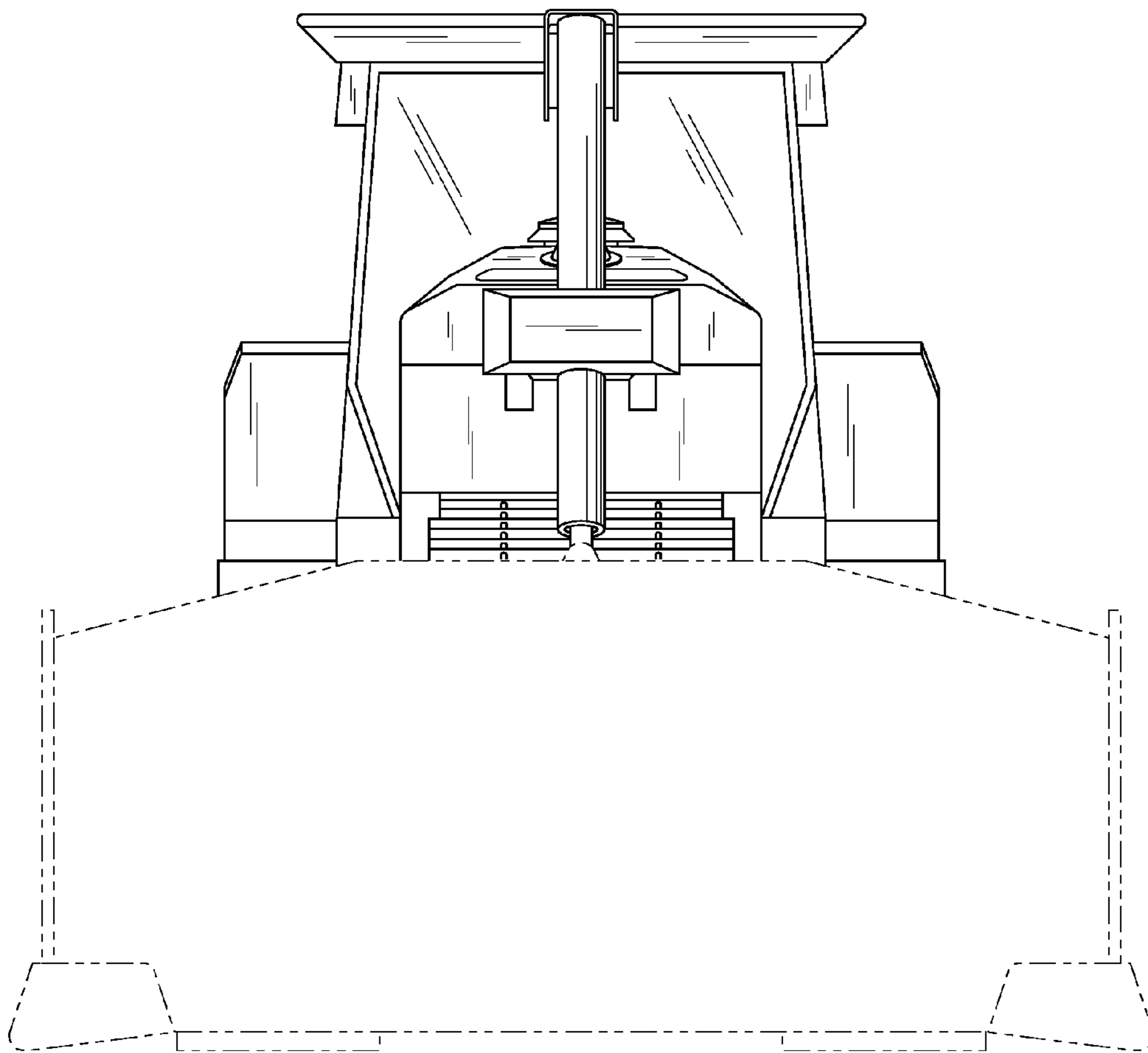

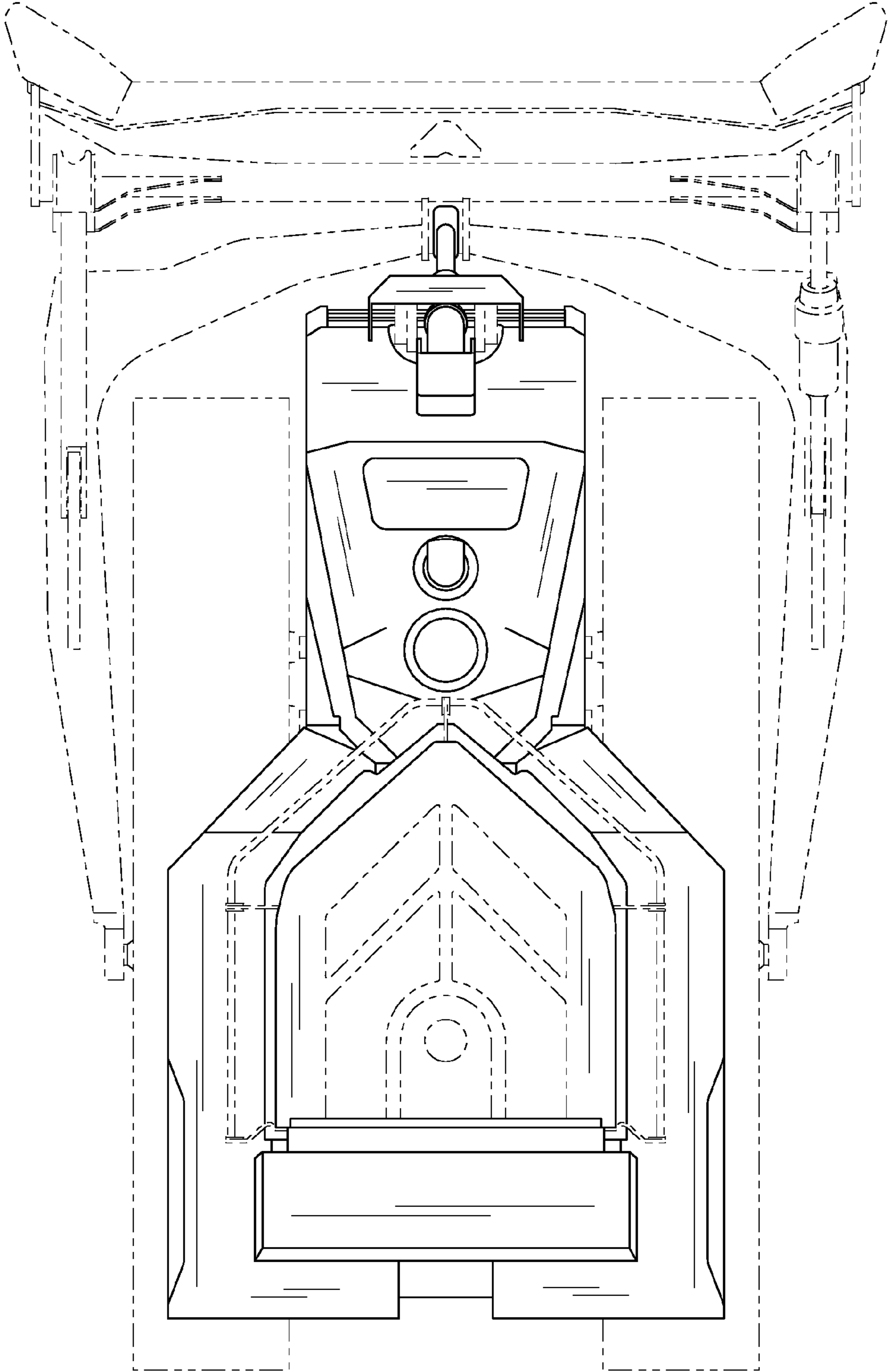
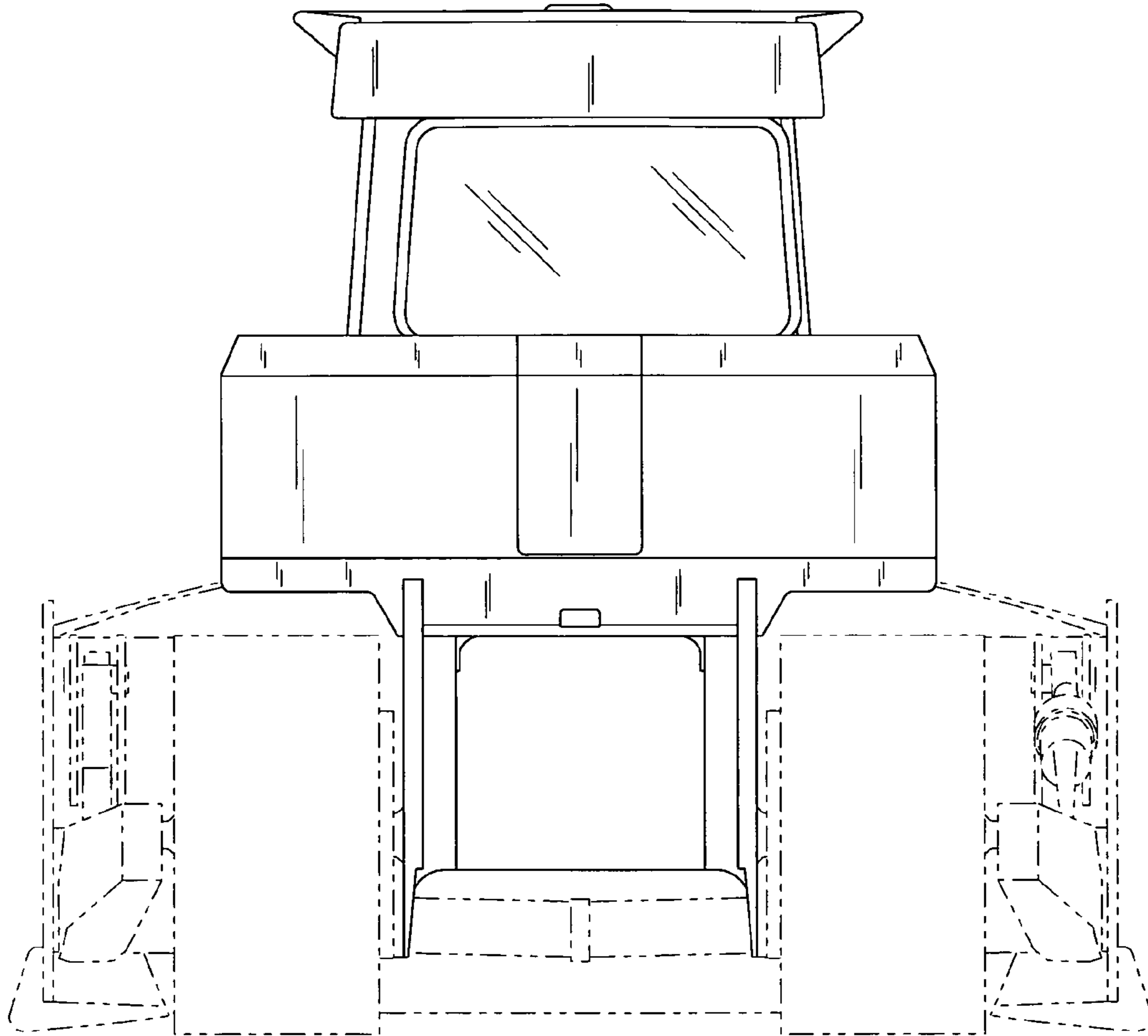

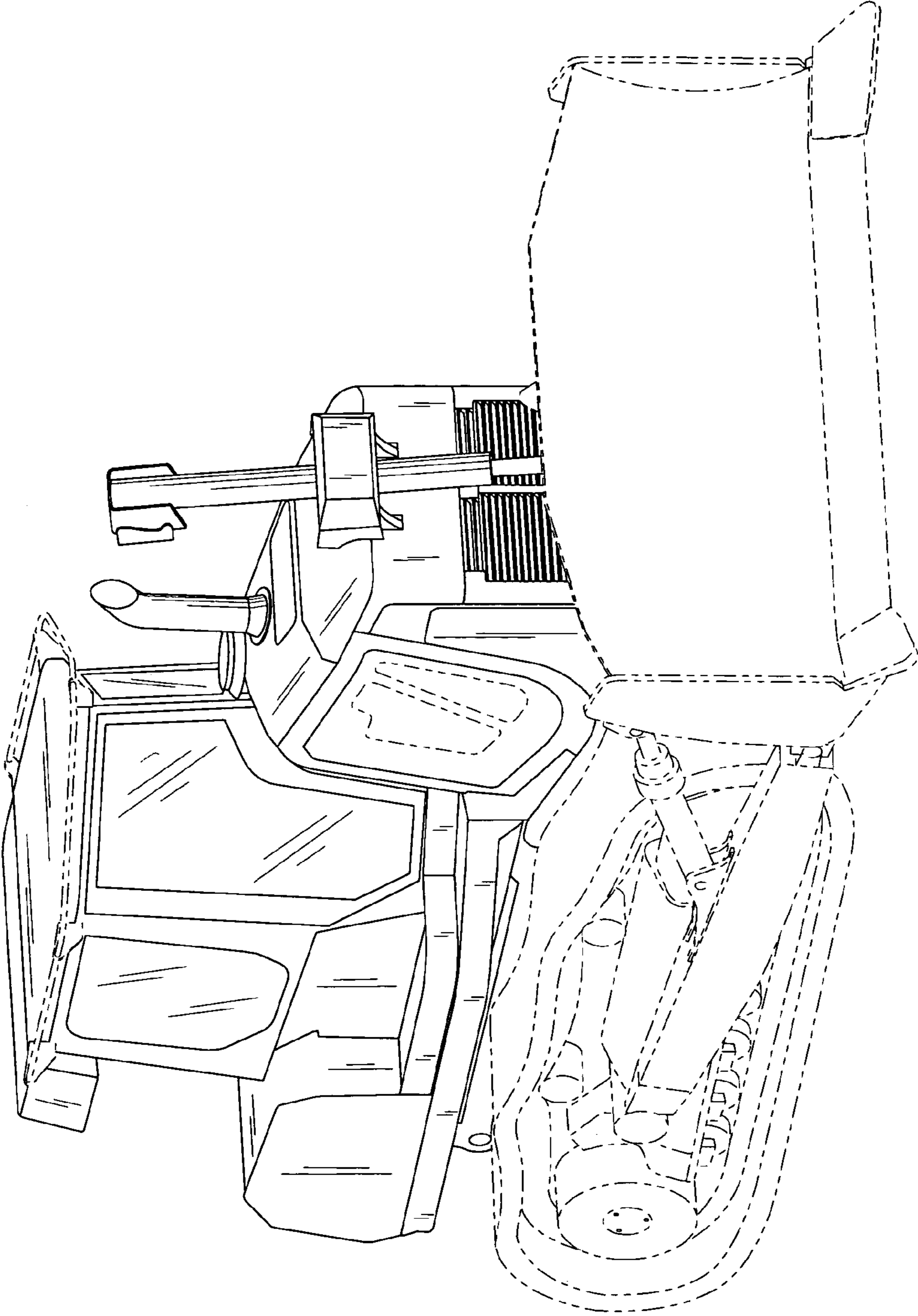
