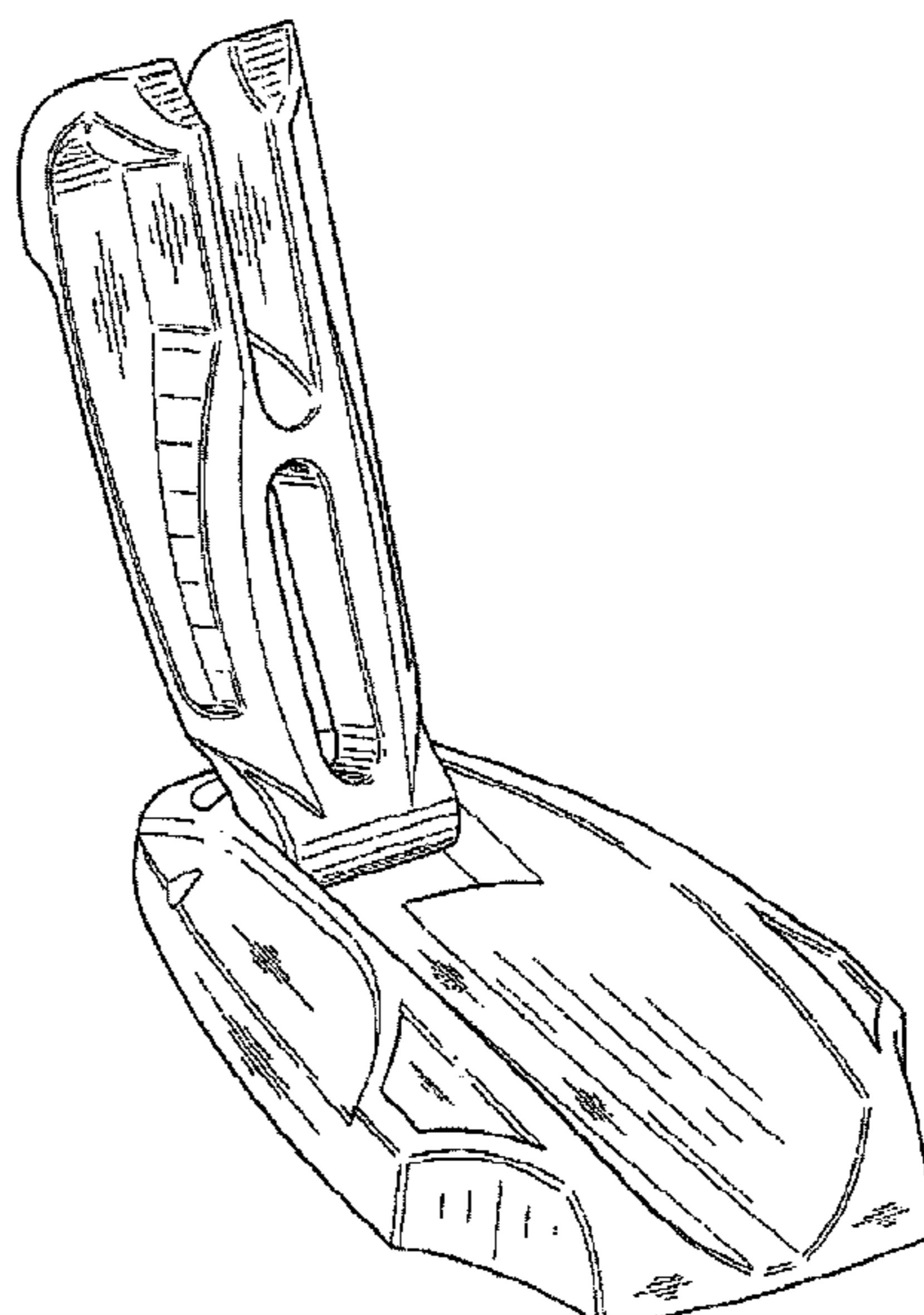
FIG. 10 is a view of a front end of the paintball marker stand

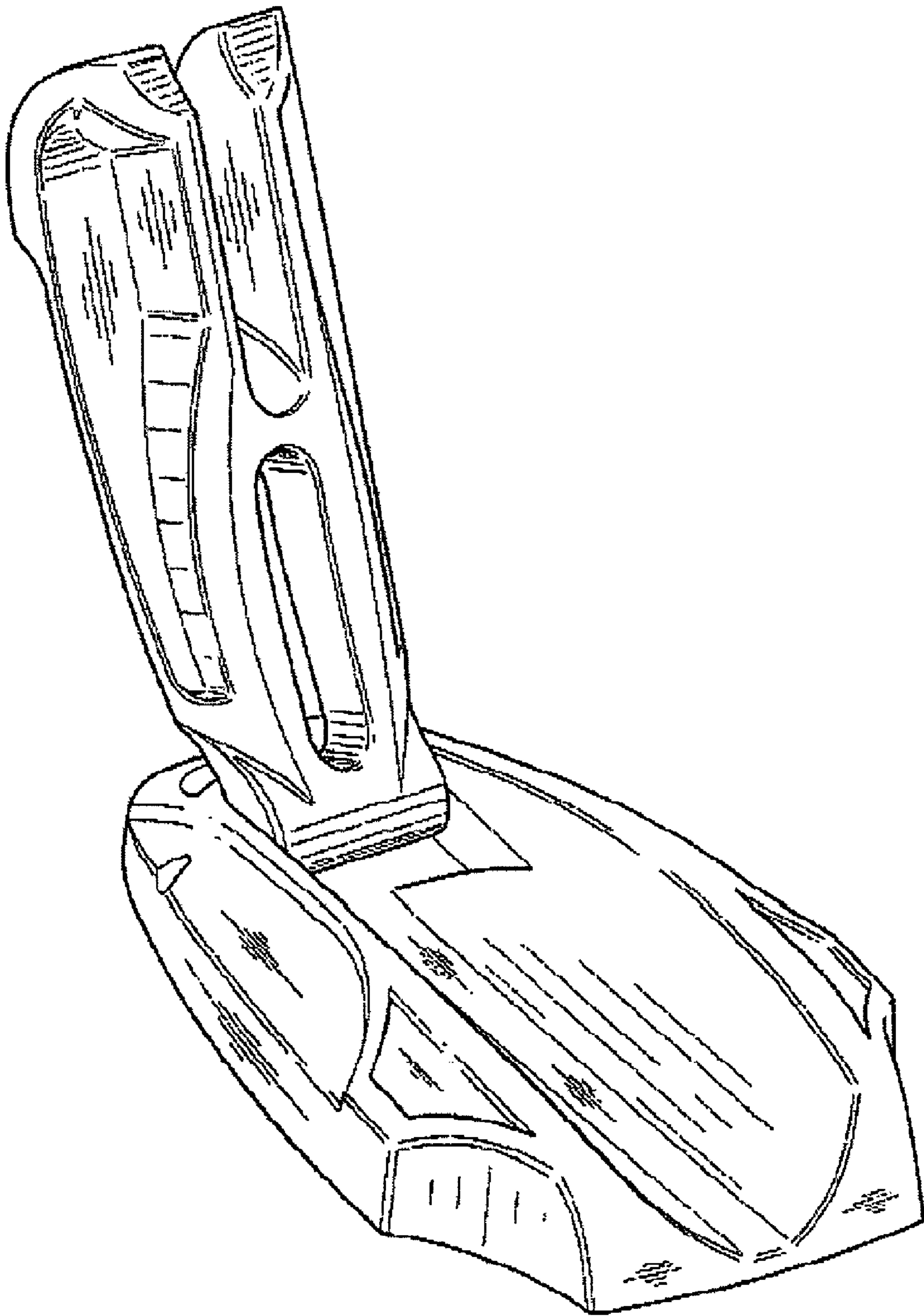

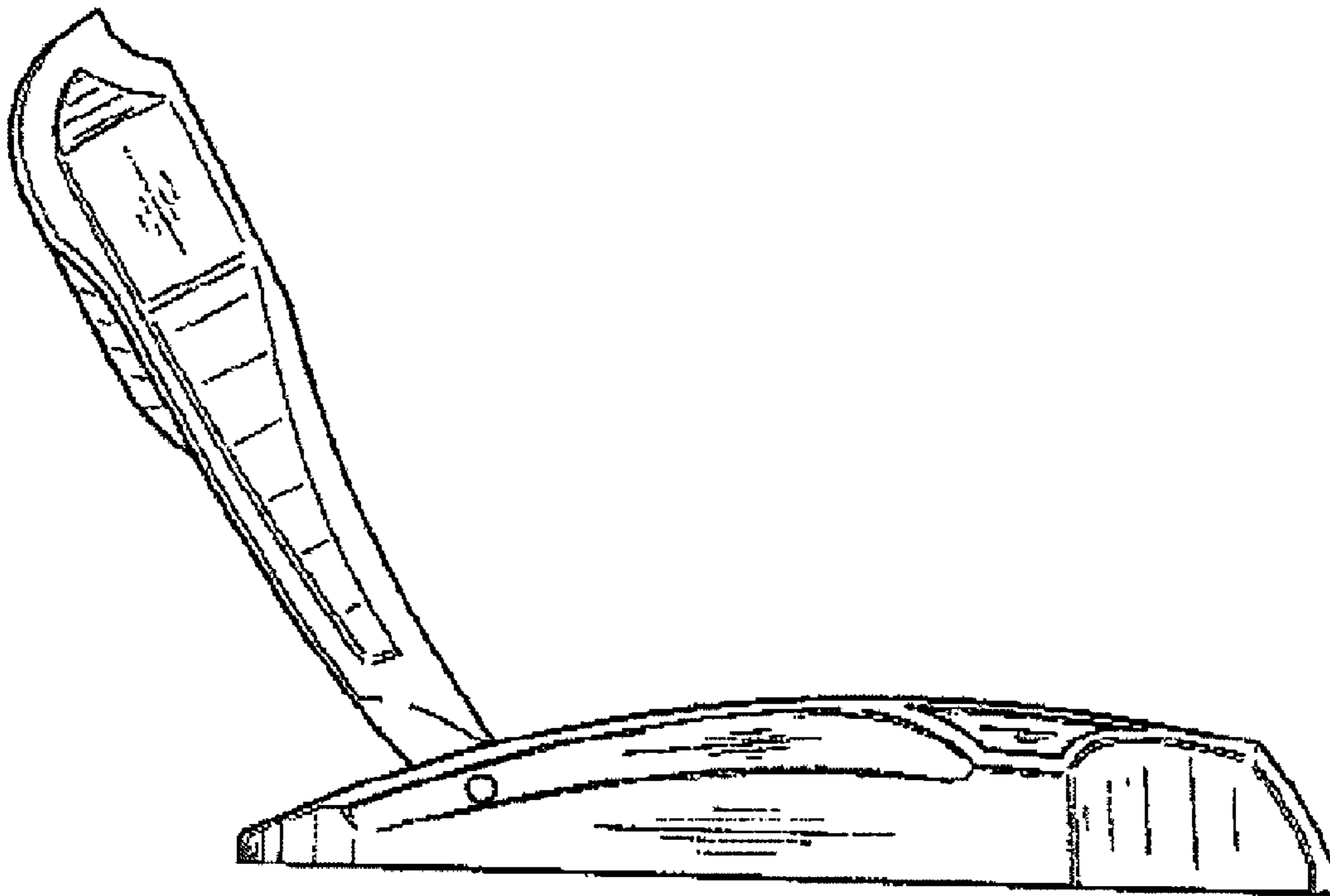

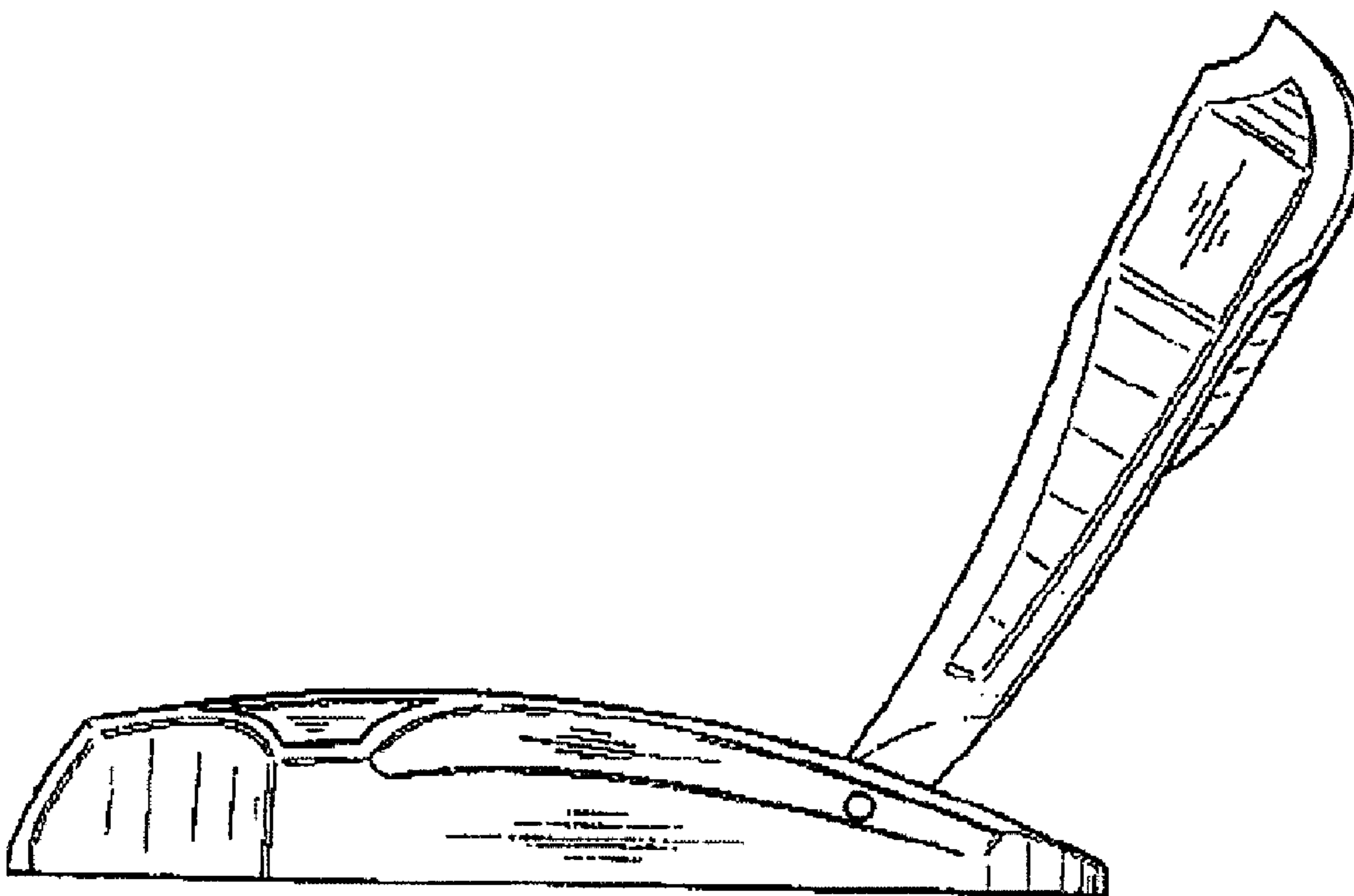

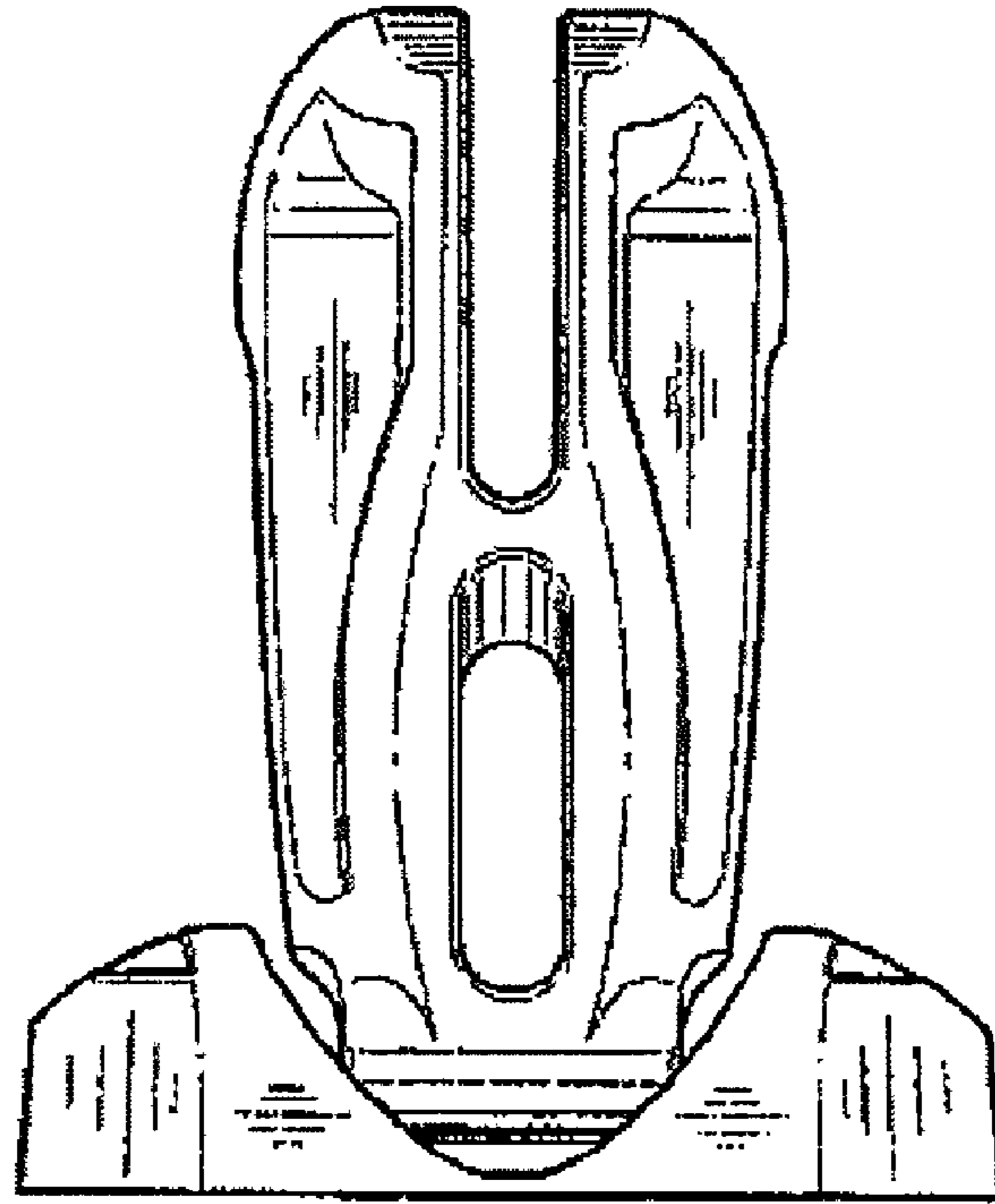

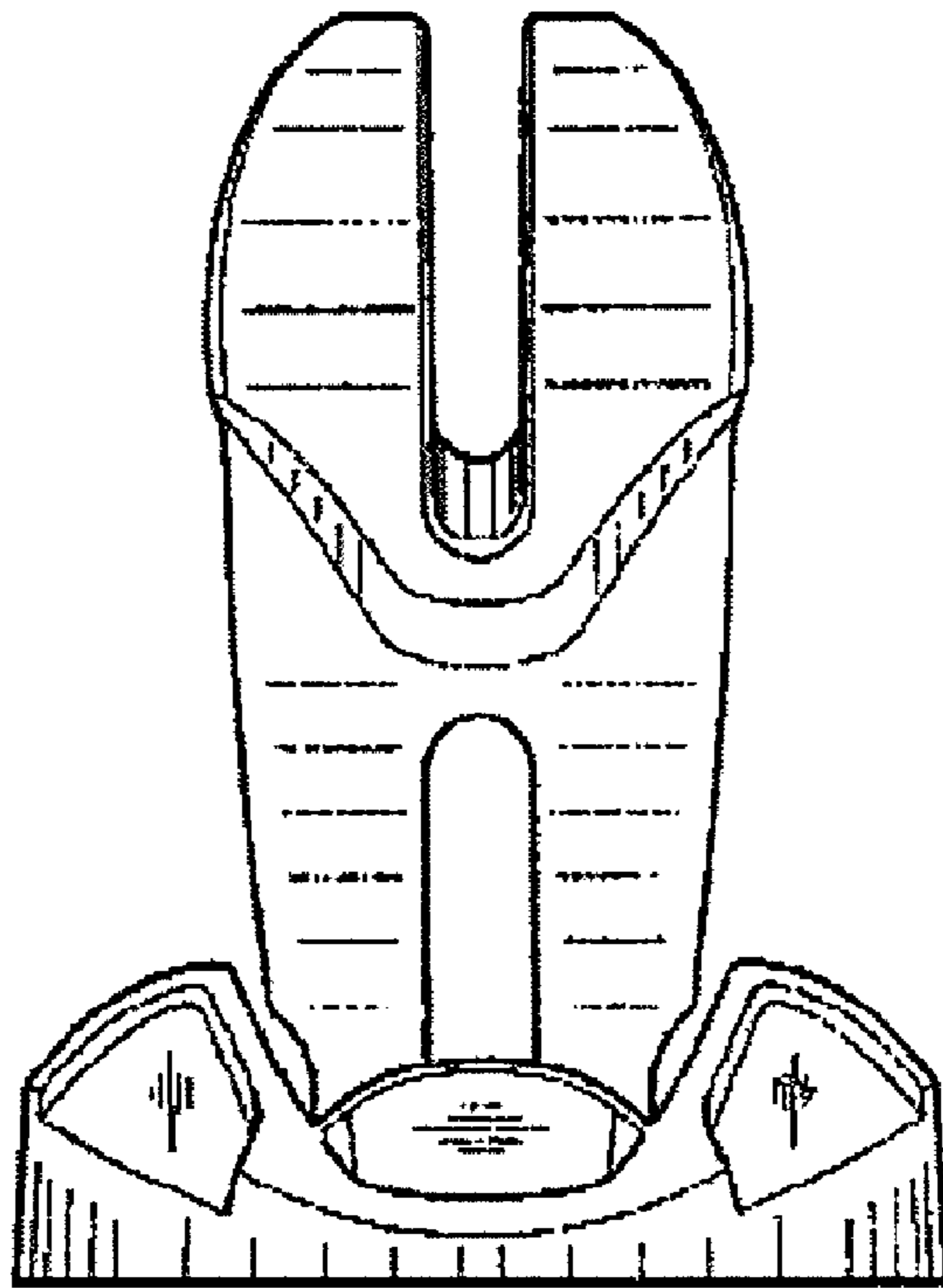

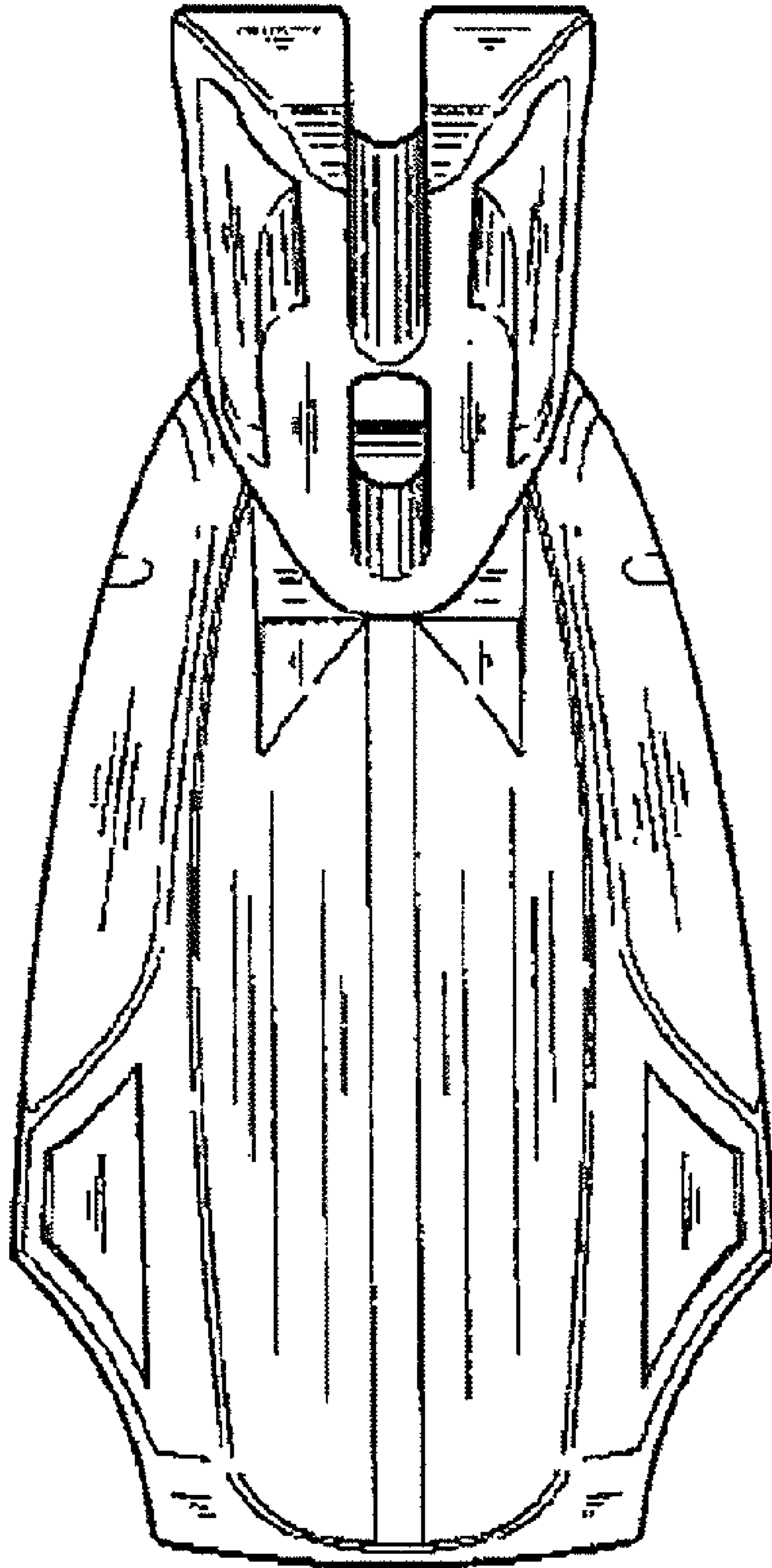

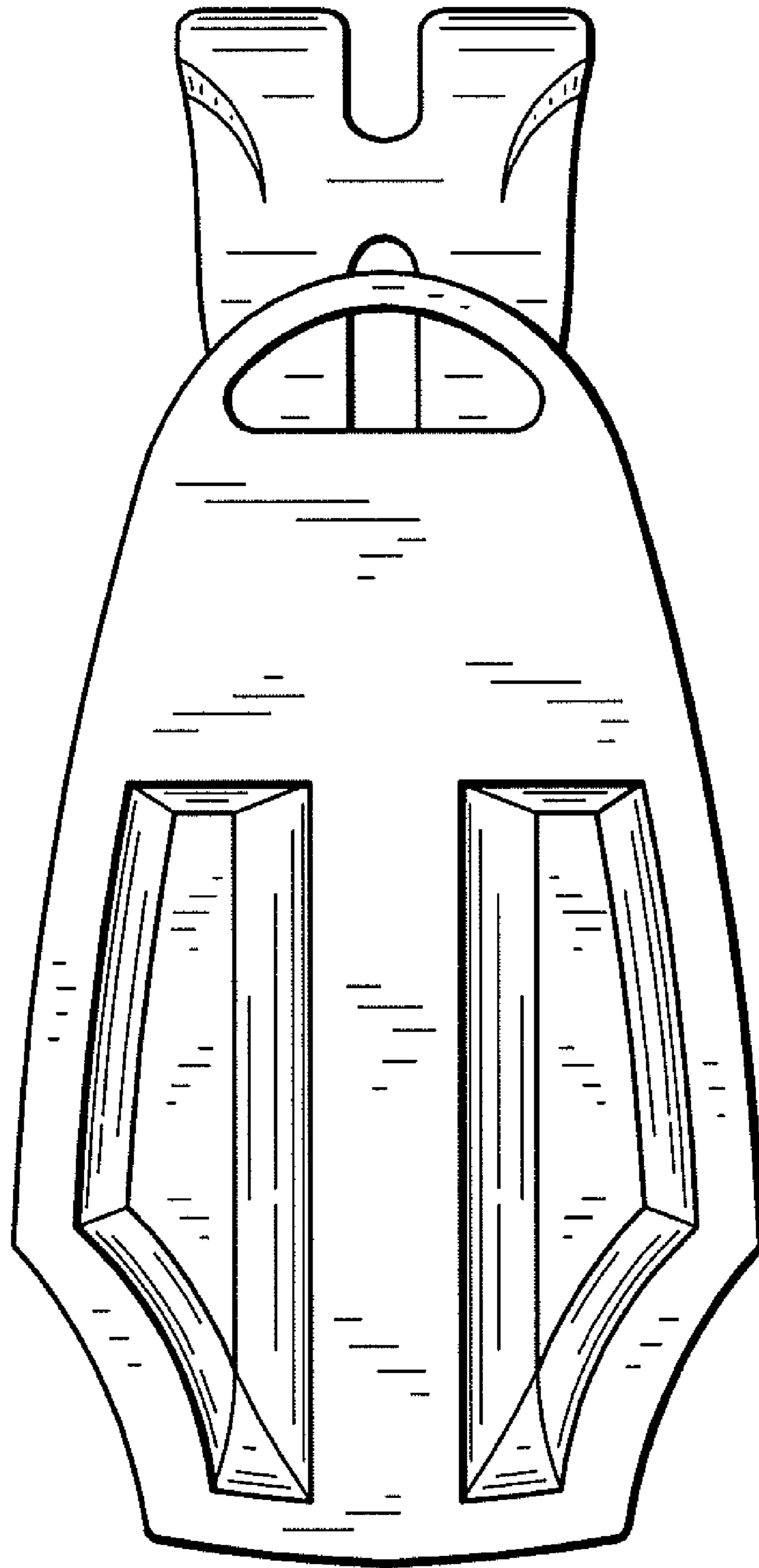

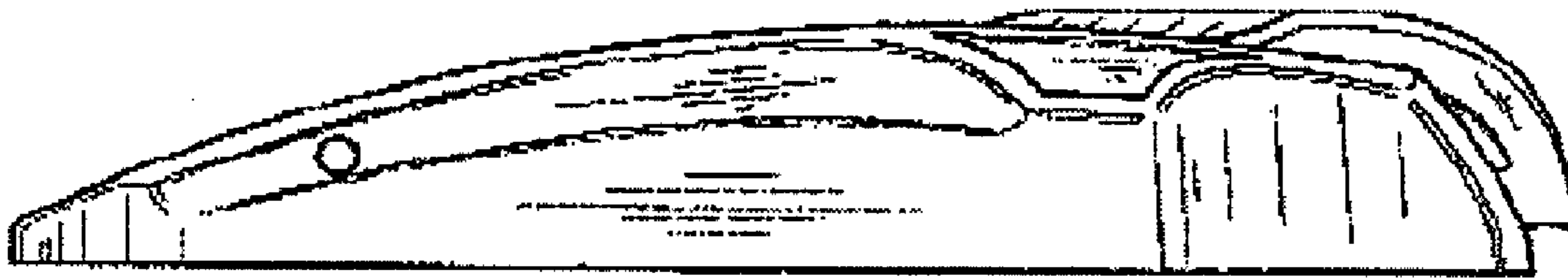

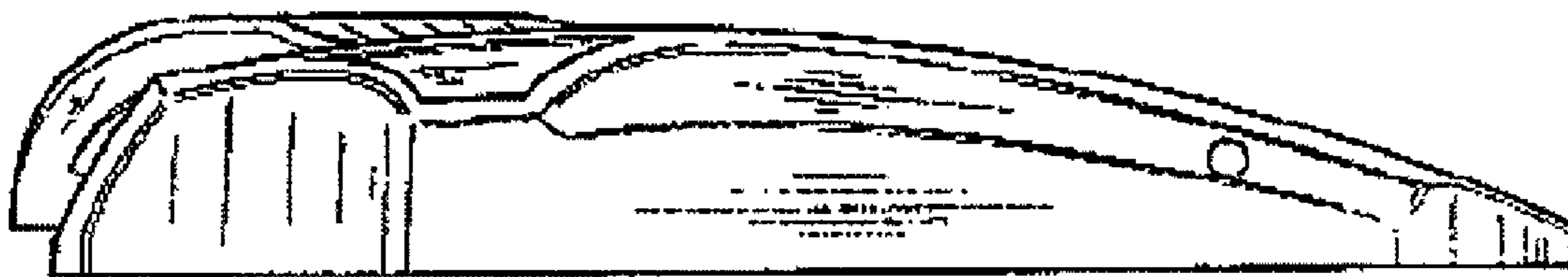

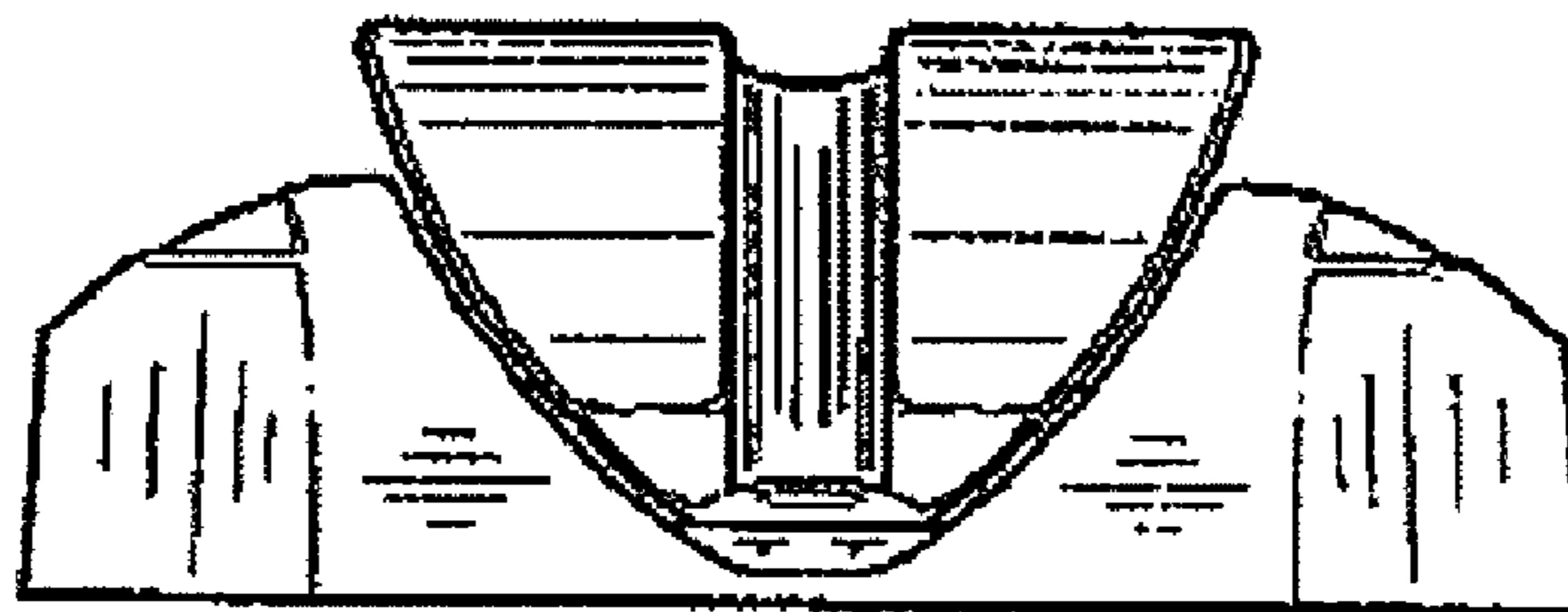

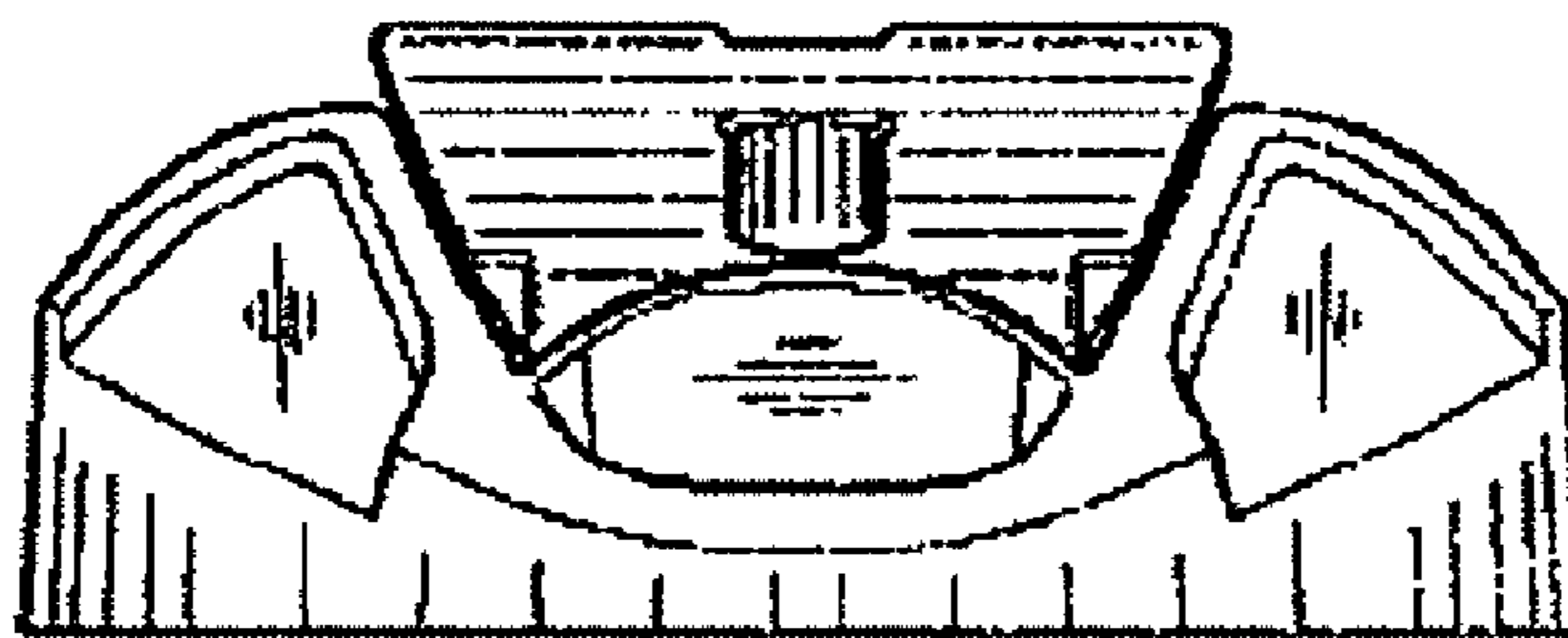

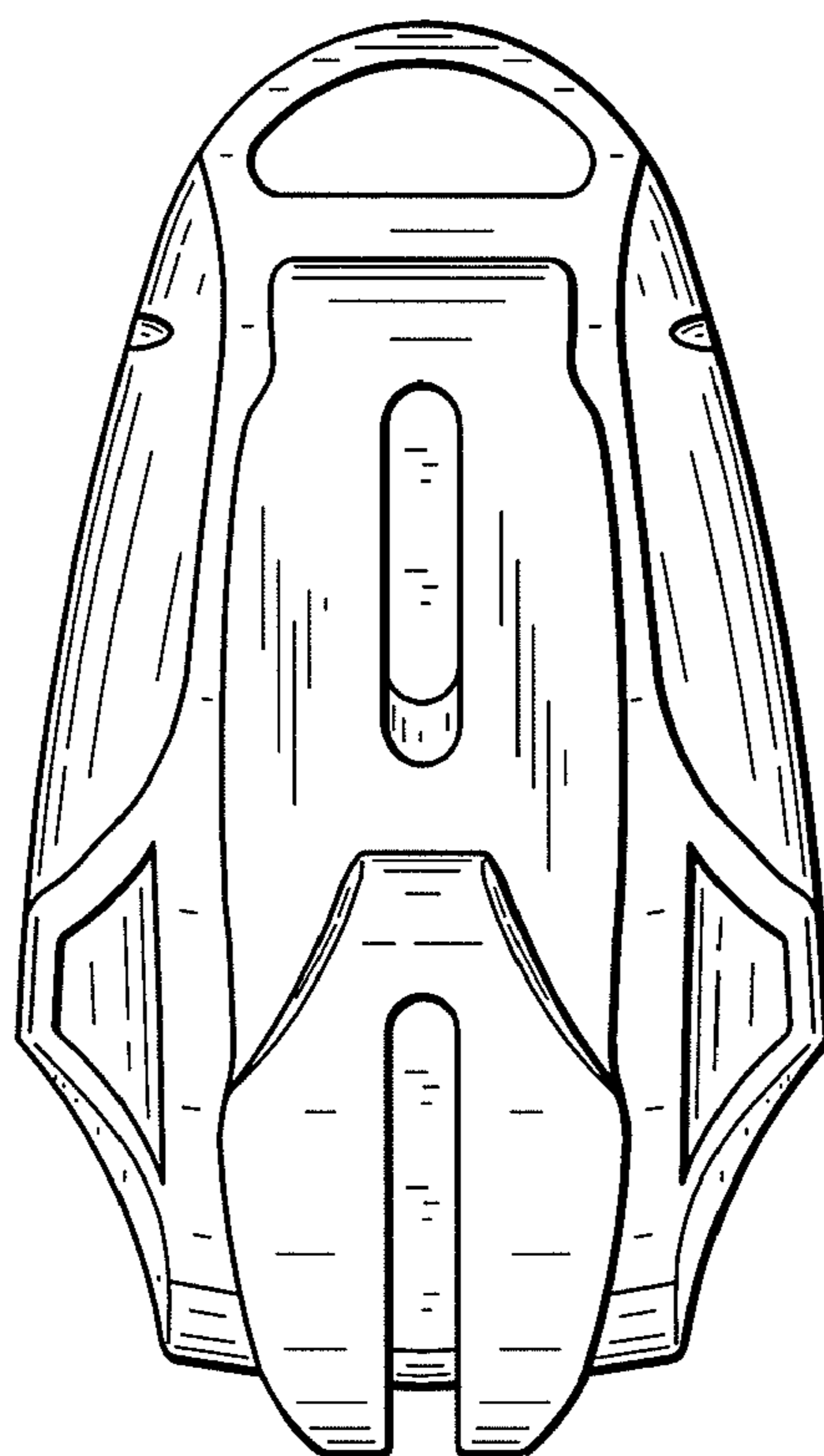

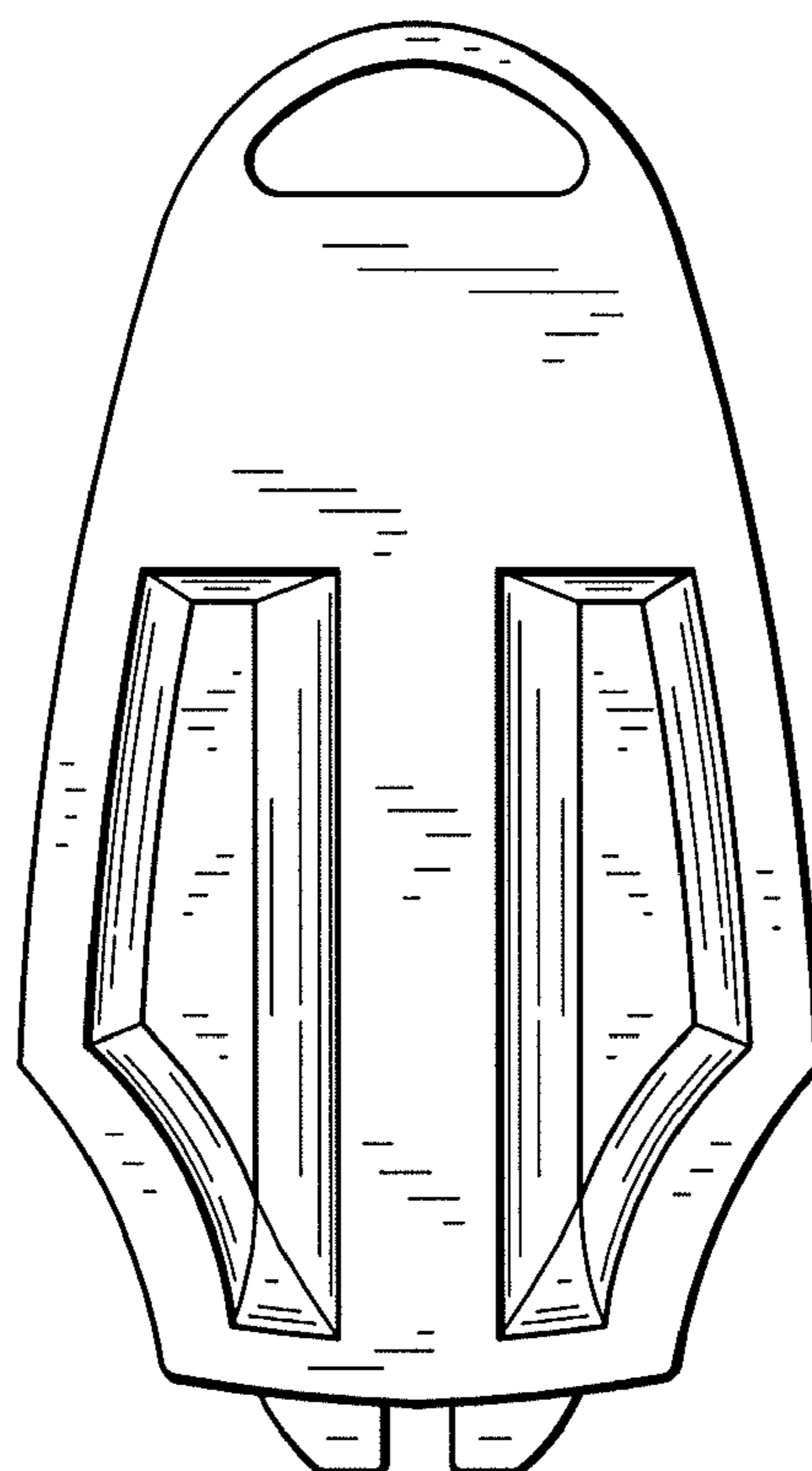
