(57) **CLAIM**

I claim the ornamental design of a candle jar and lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of candle jar and lid showing the lid attached to the jar;

FIG. 2 is a front view of the candle jar and lid of FIG. 1;

FIG. 3 is a left side view of the candle jar and lid of FIG. 1;

FIG. 4 is a right side view of the candle jar and lid of FIG. 1;

FIG. 5 is a rear view of the candle jar and lid of FIG. 1;

FIG. 6 is a top view of the candle jar and lid of FIG. 1;

FIG. 7 is a perspective view of candle jar and lid showing the lid raised above the jar;

FIG. 8 is a front view of the candle jar and lid of FIG. 7;

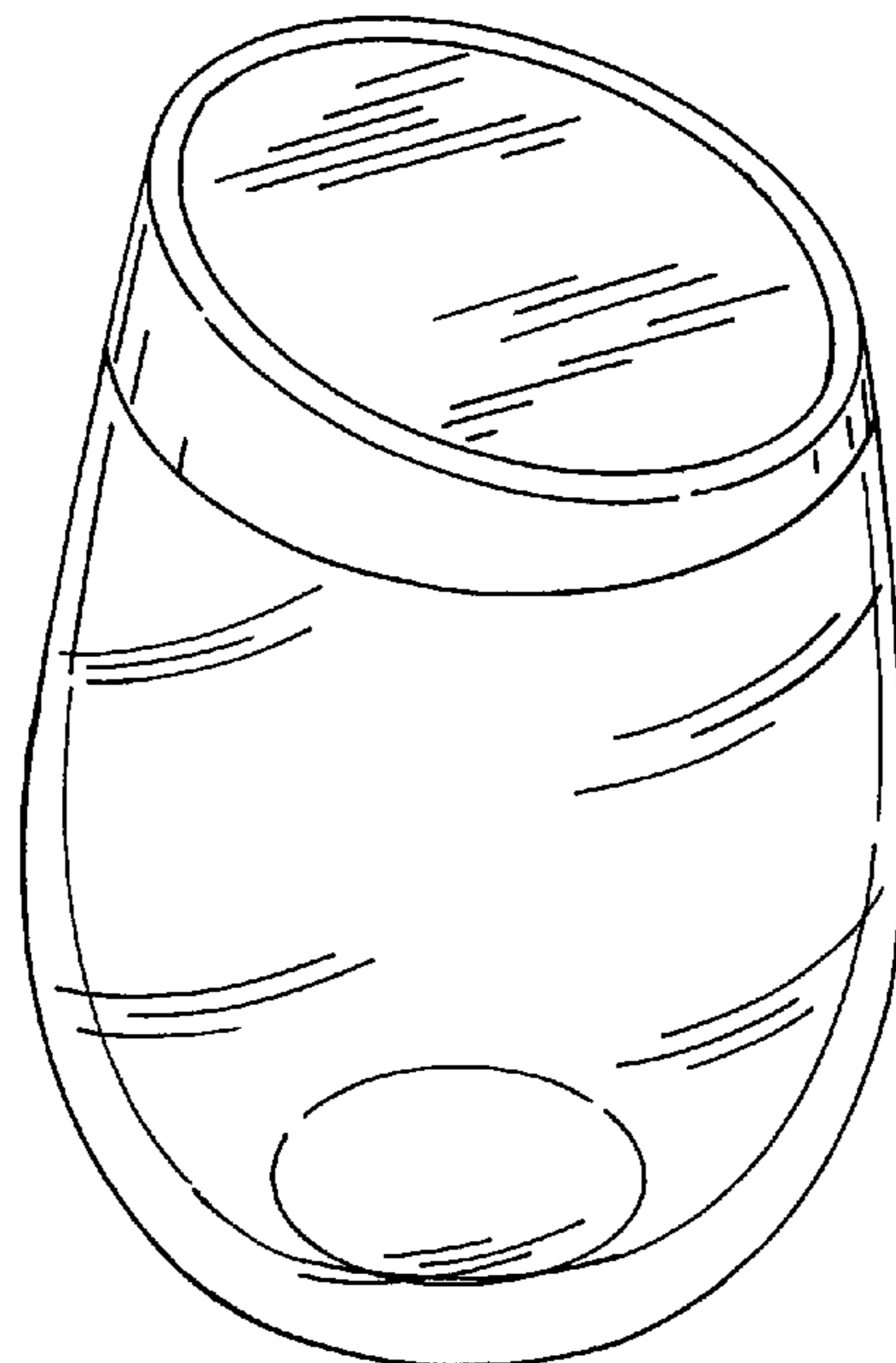
FIG. 9 is a left side view of the candle jar and lid of FIG. 7;

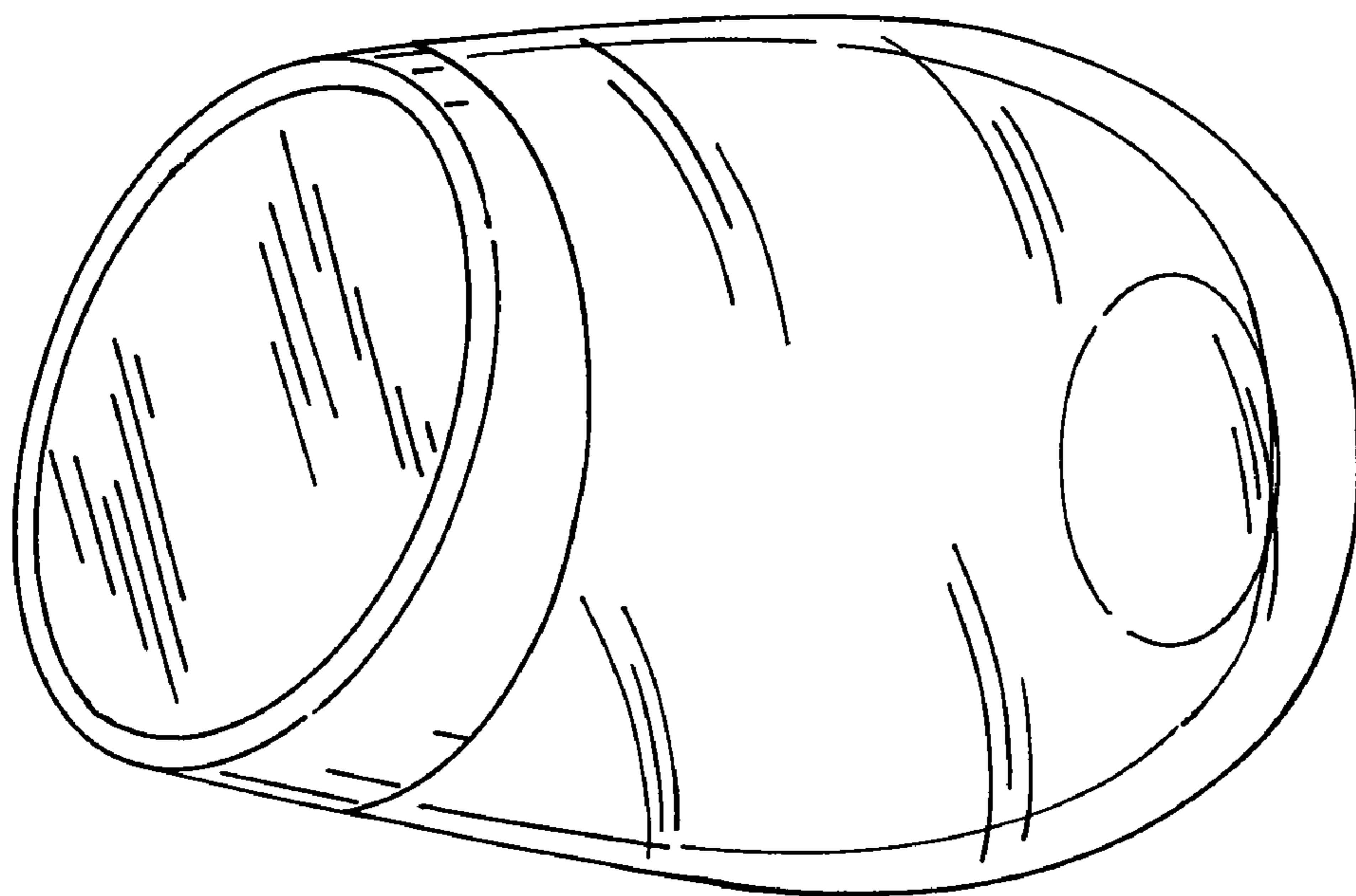

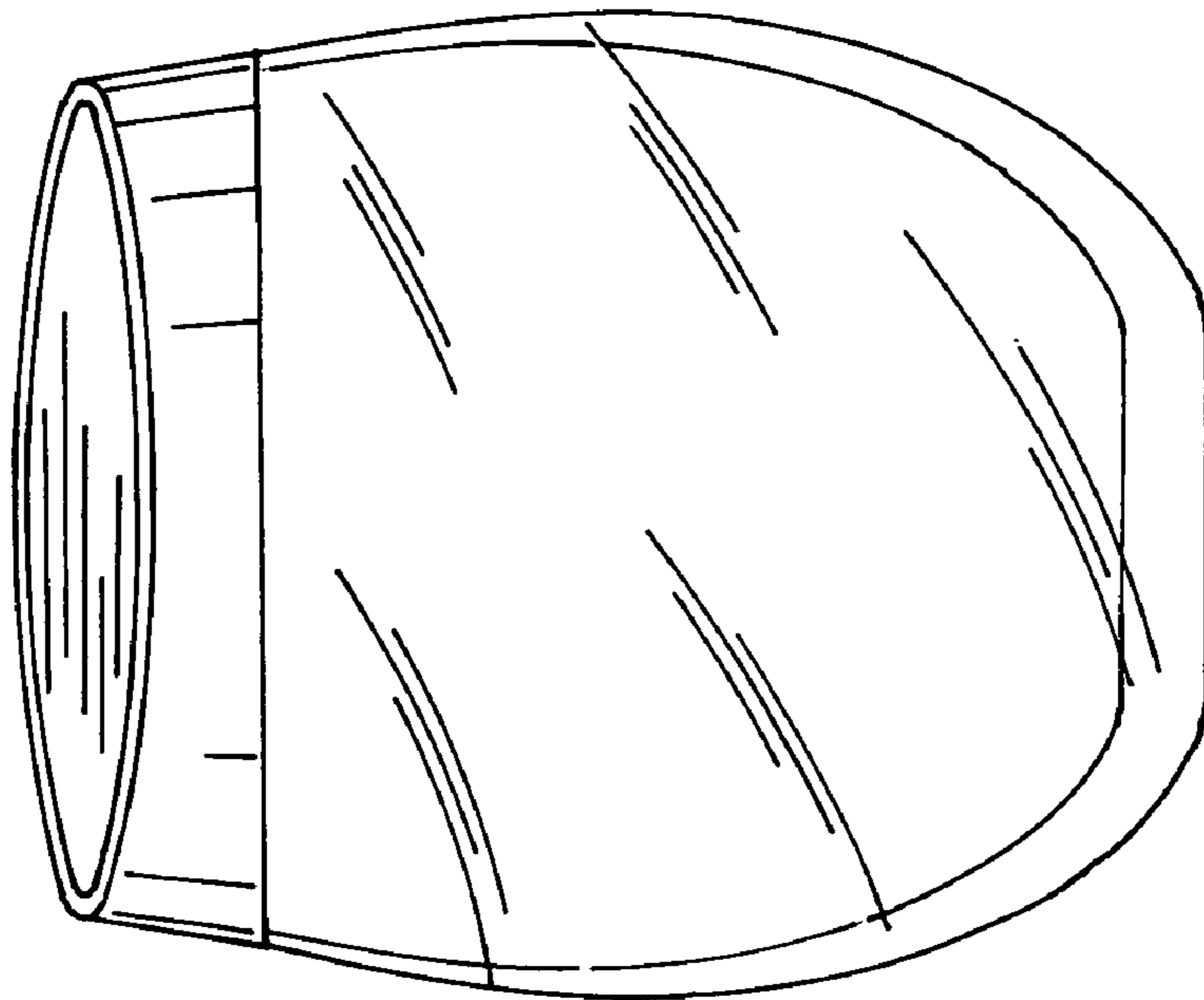

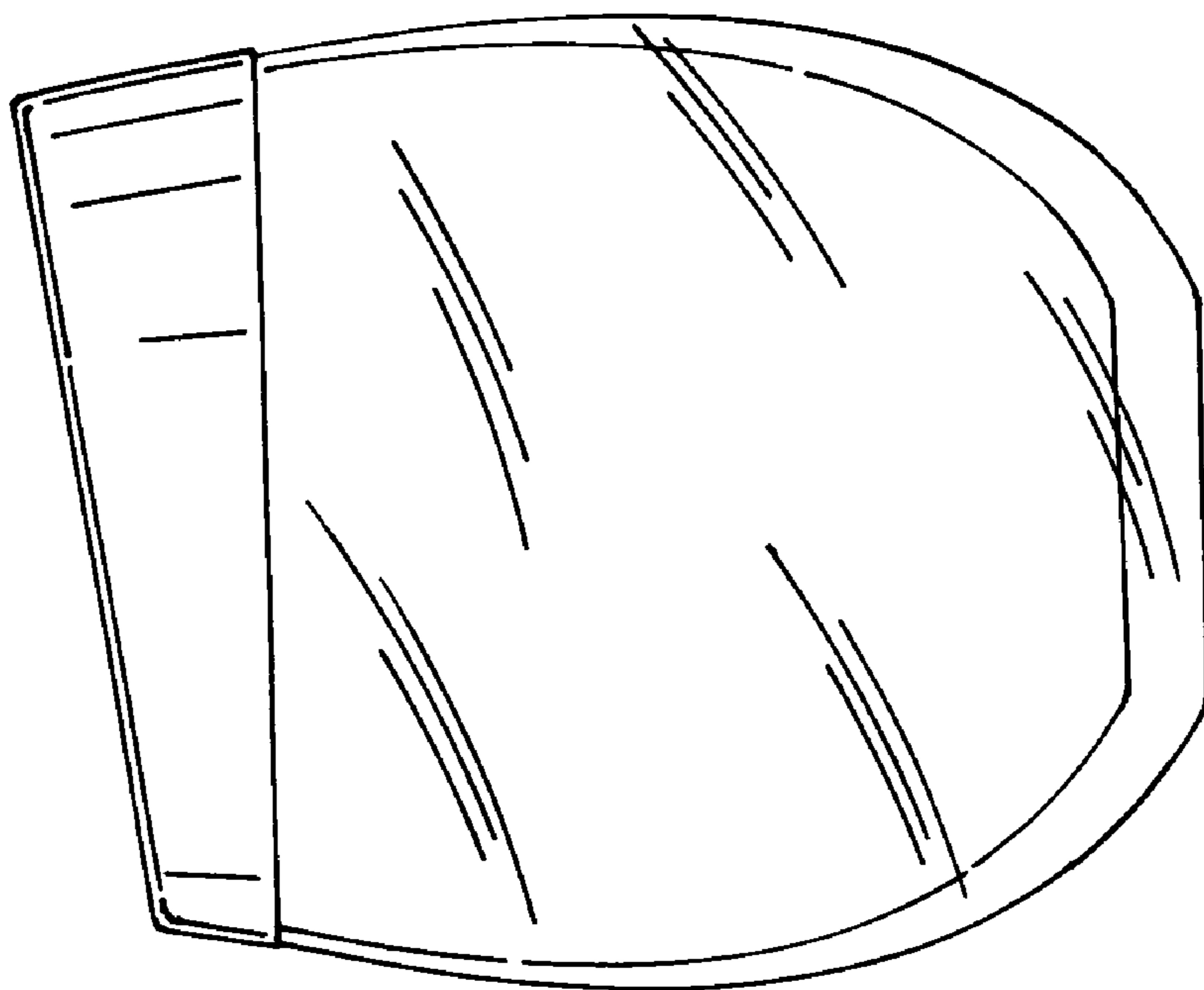

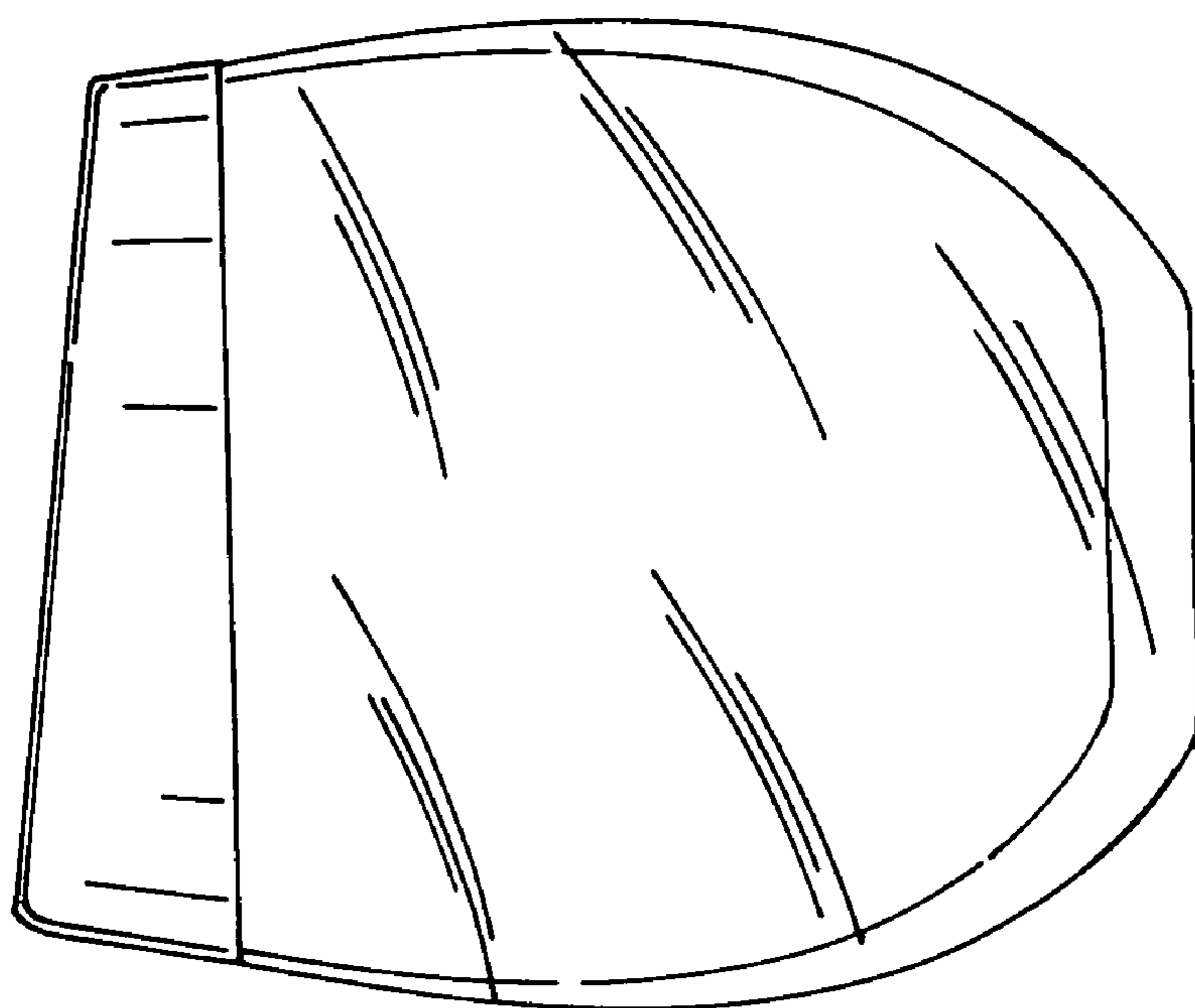

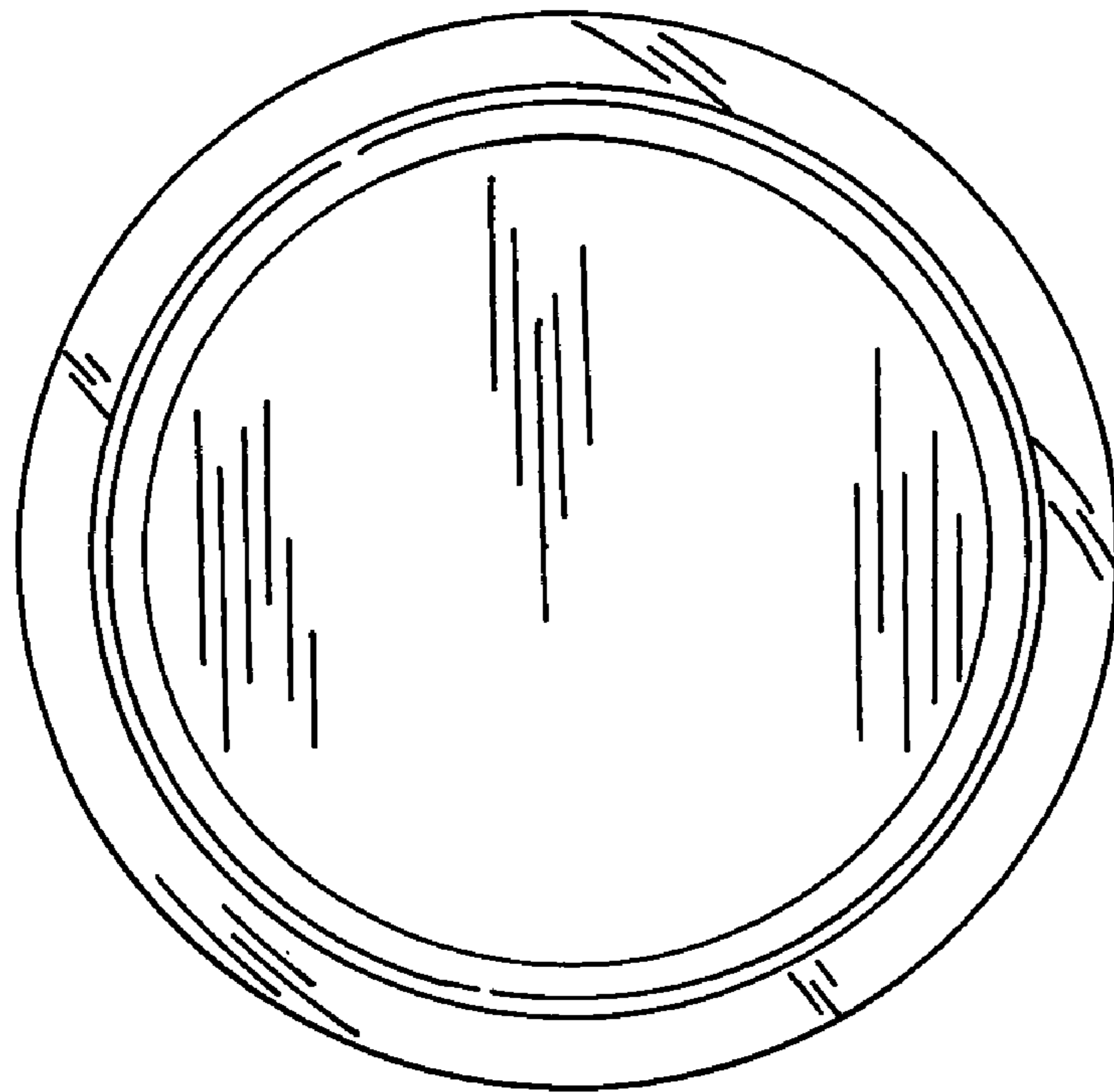

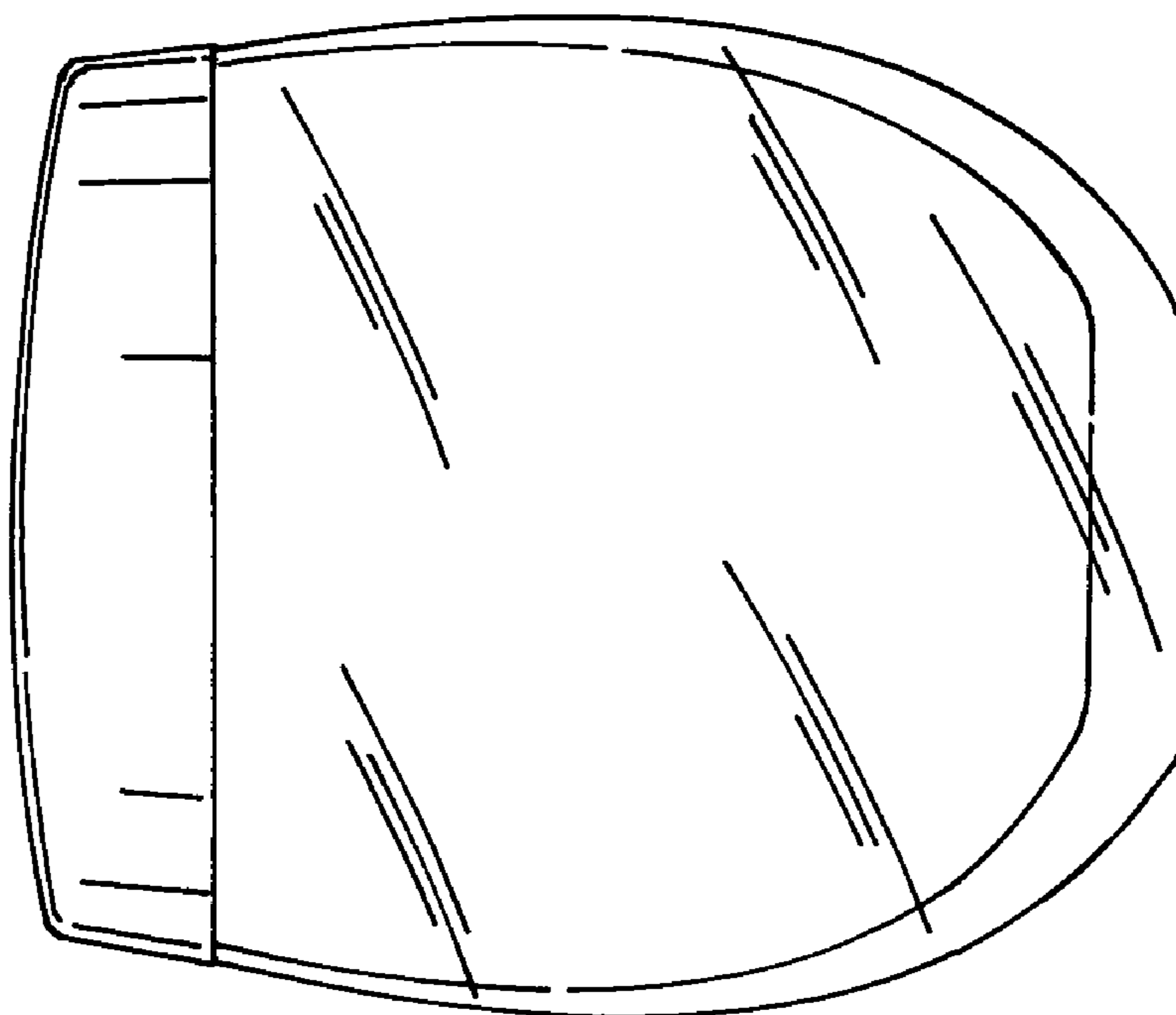

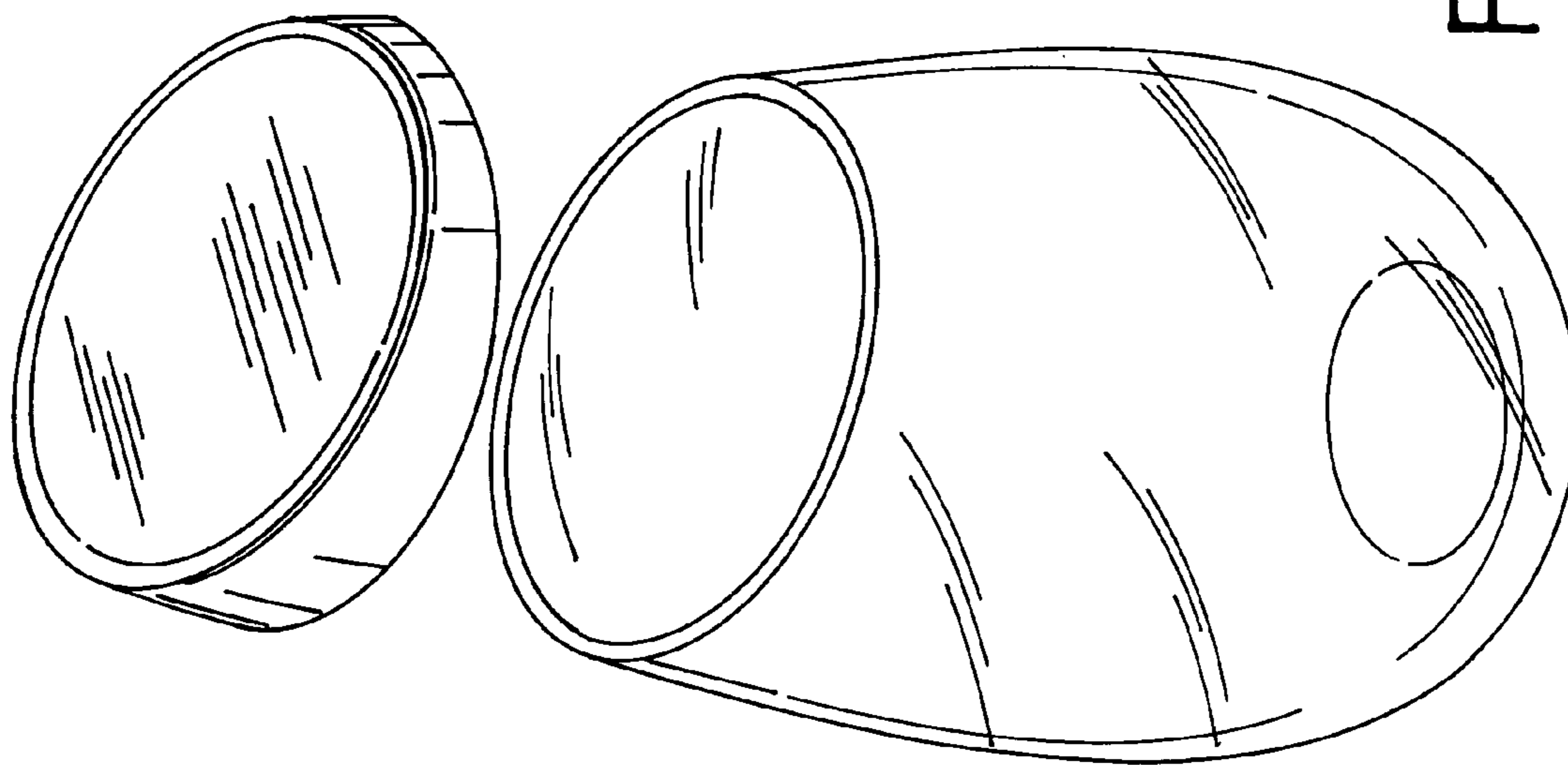

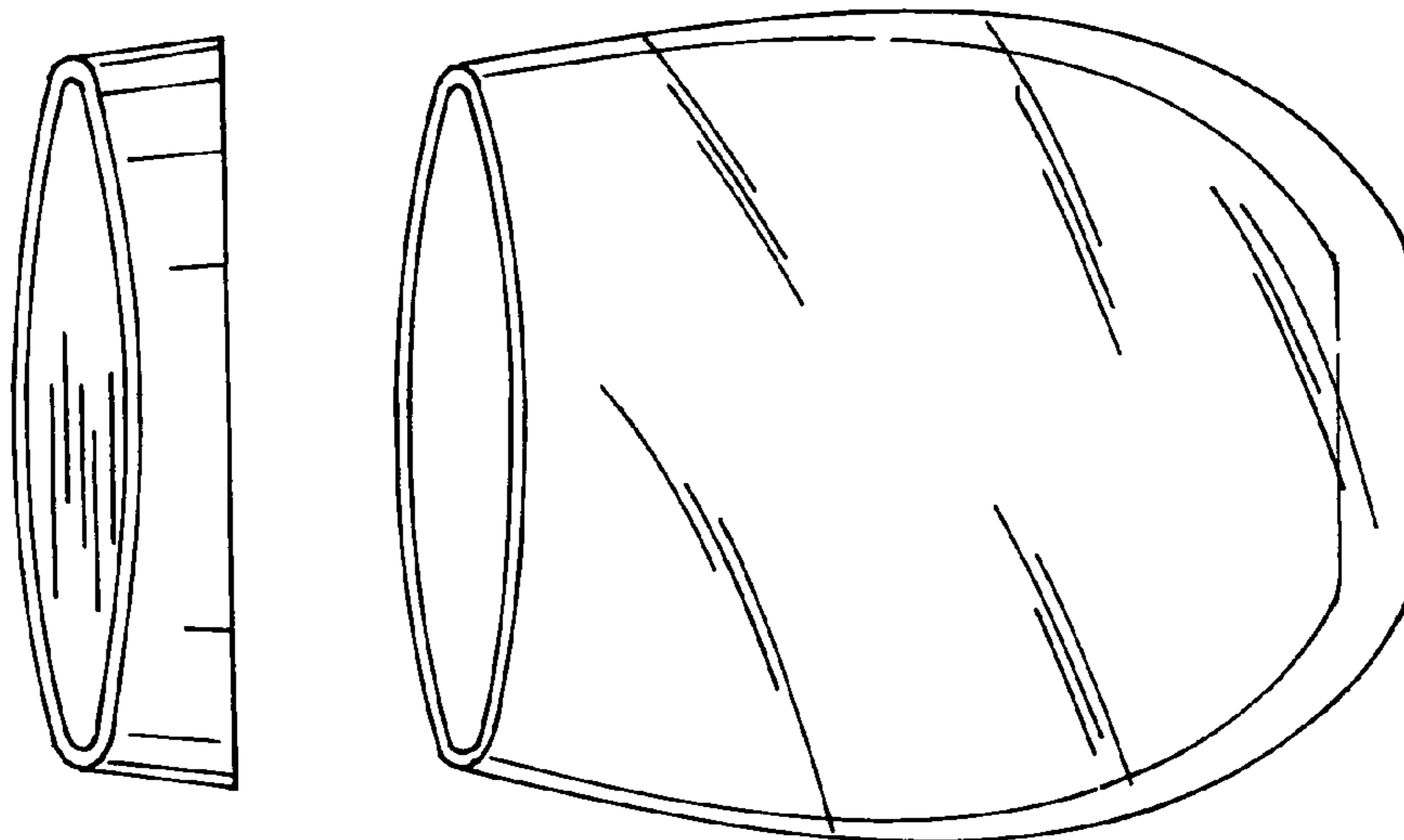

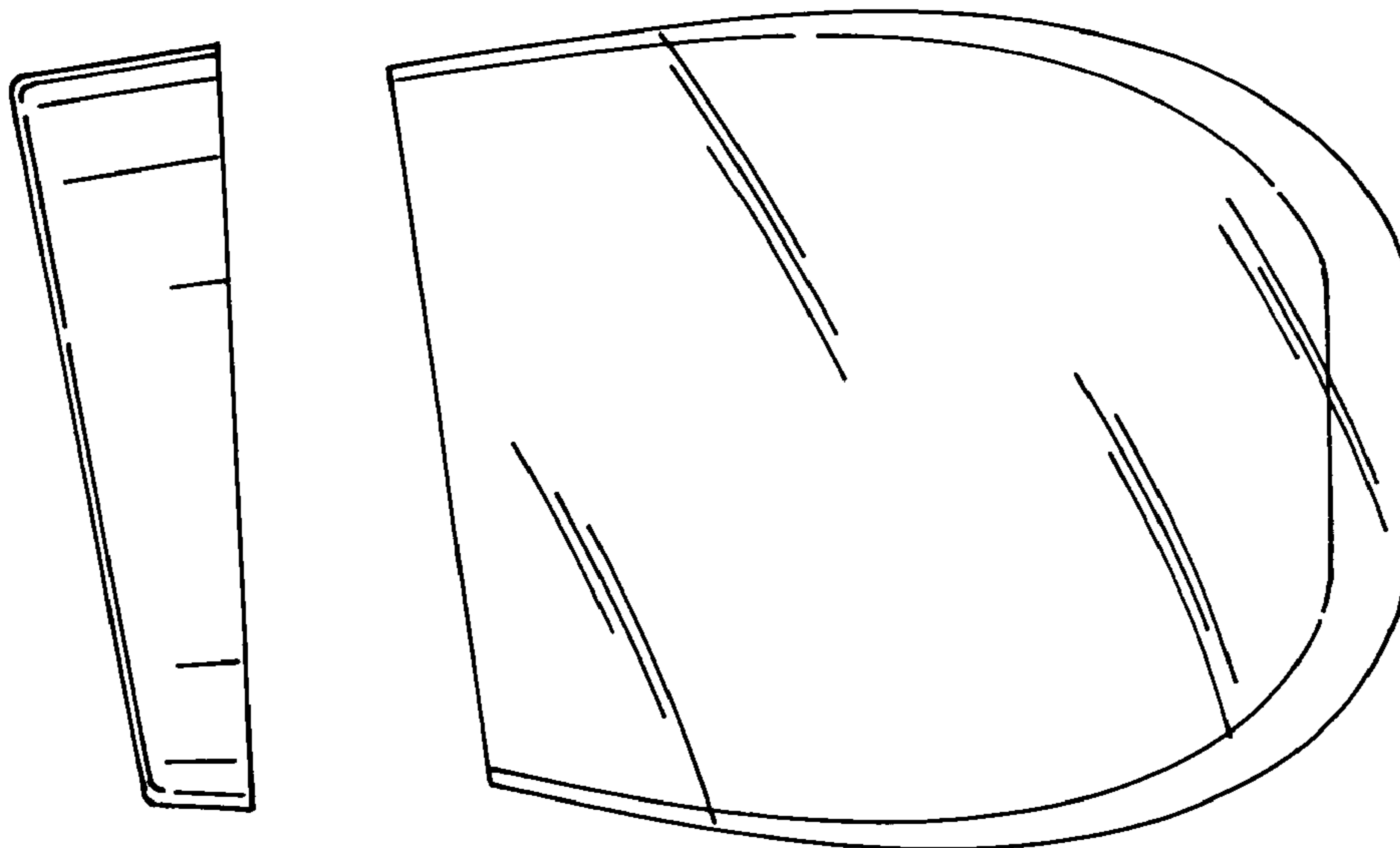

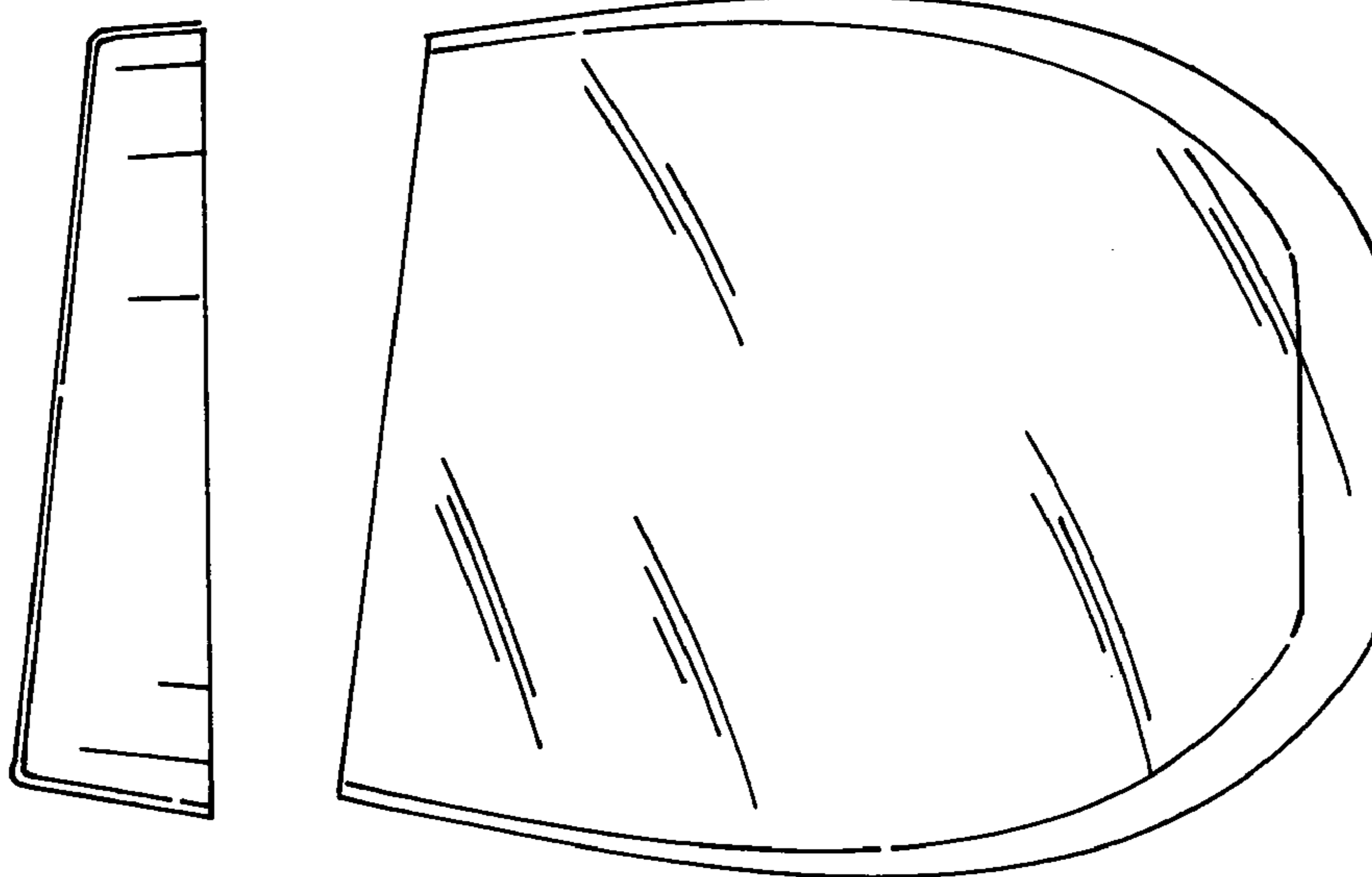

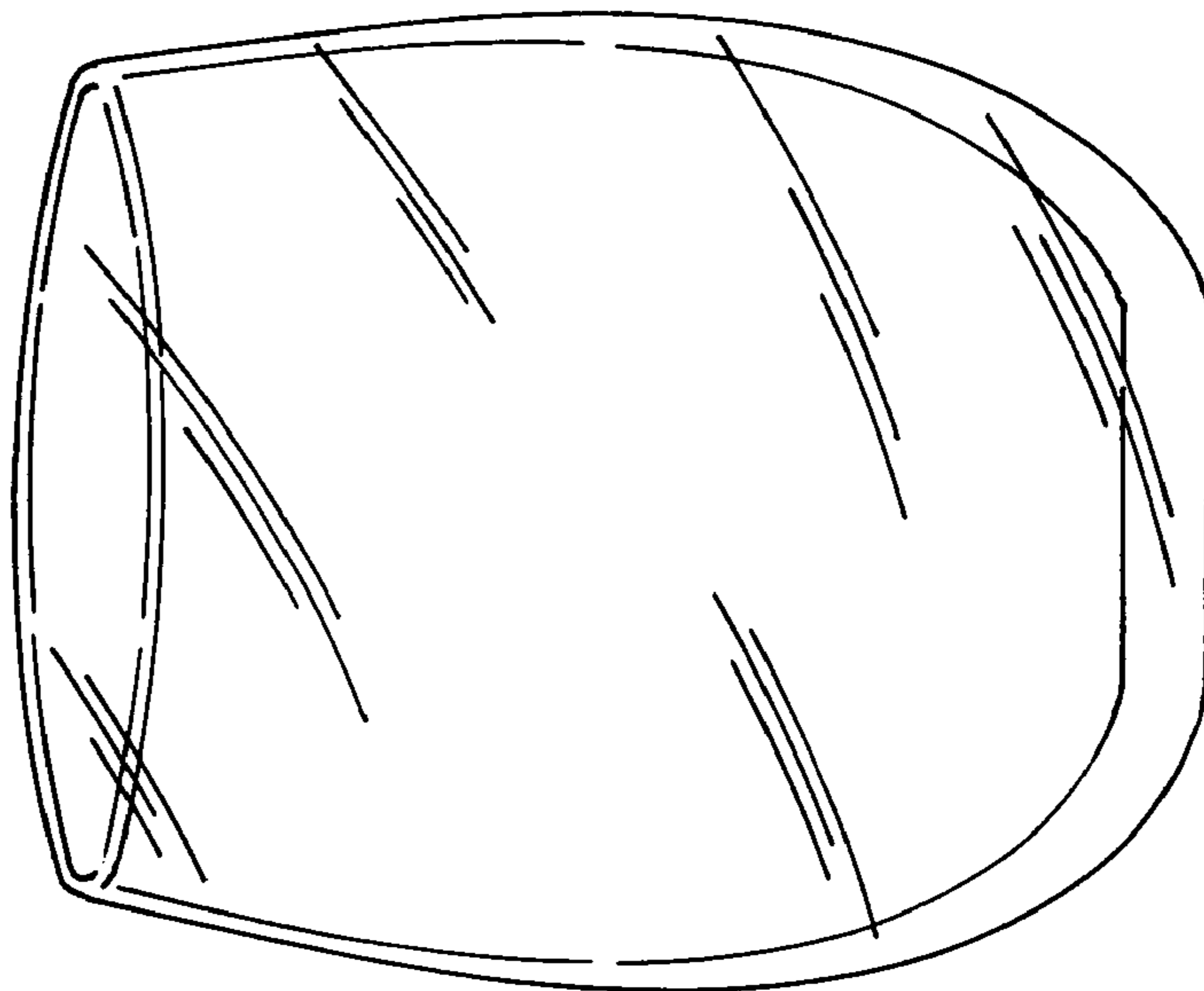
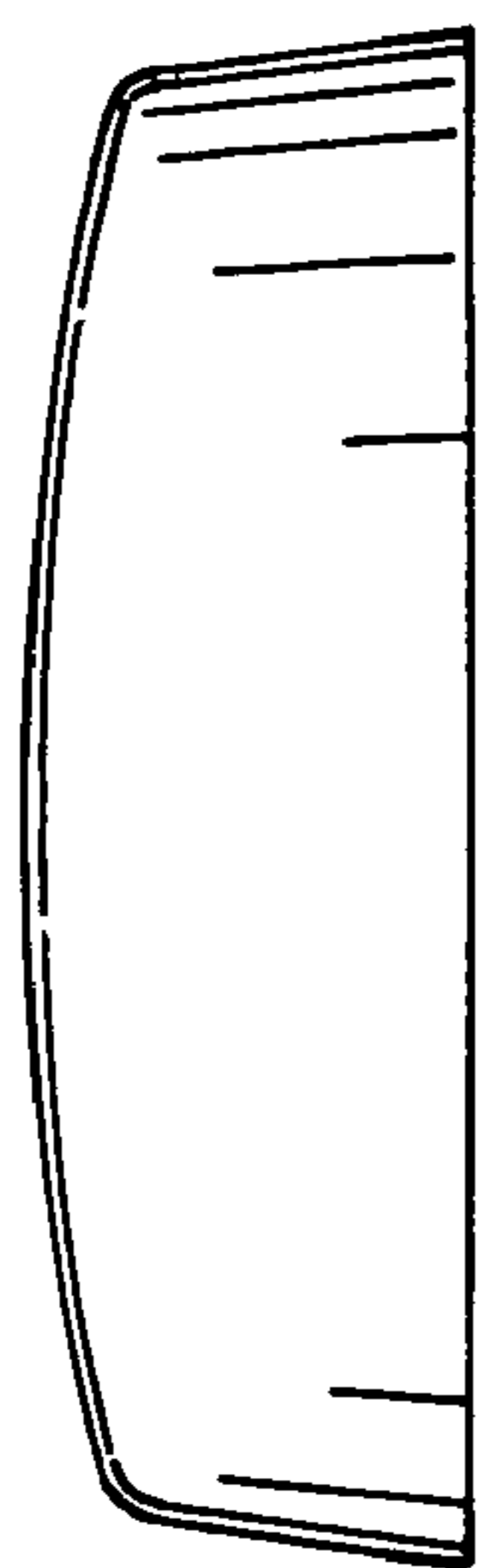

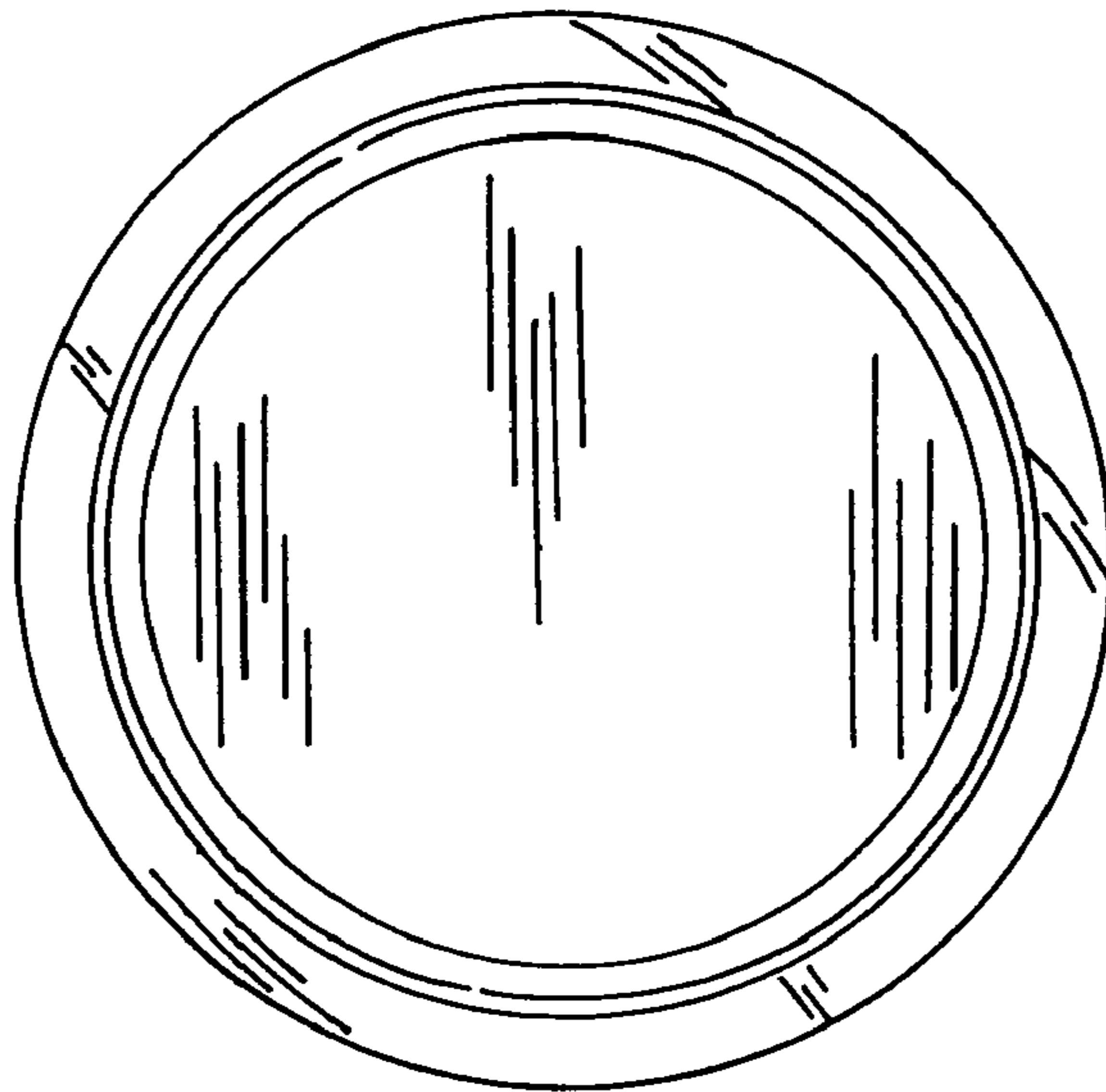
