(57) **CLAIM**

The ornamental design for protective pad for sportswear, as shown as described.

DESCRIPTION

FIG. 1 is a perspective view of a protective pad for sportswear;

FIG. 2 is a front elevation view of the protective pad for sportswear of FIG. 1;

FIG. 3 is a right side view of the protective pad for sportswear of FIG. 1;

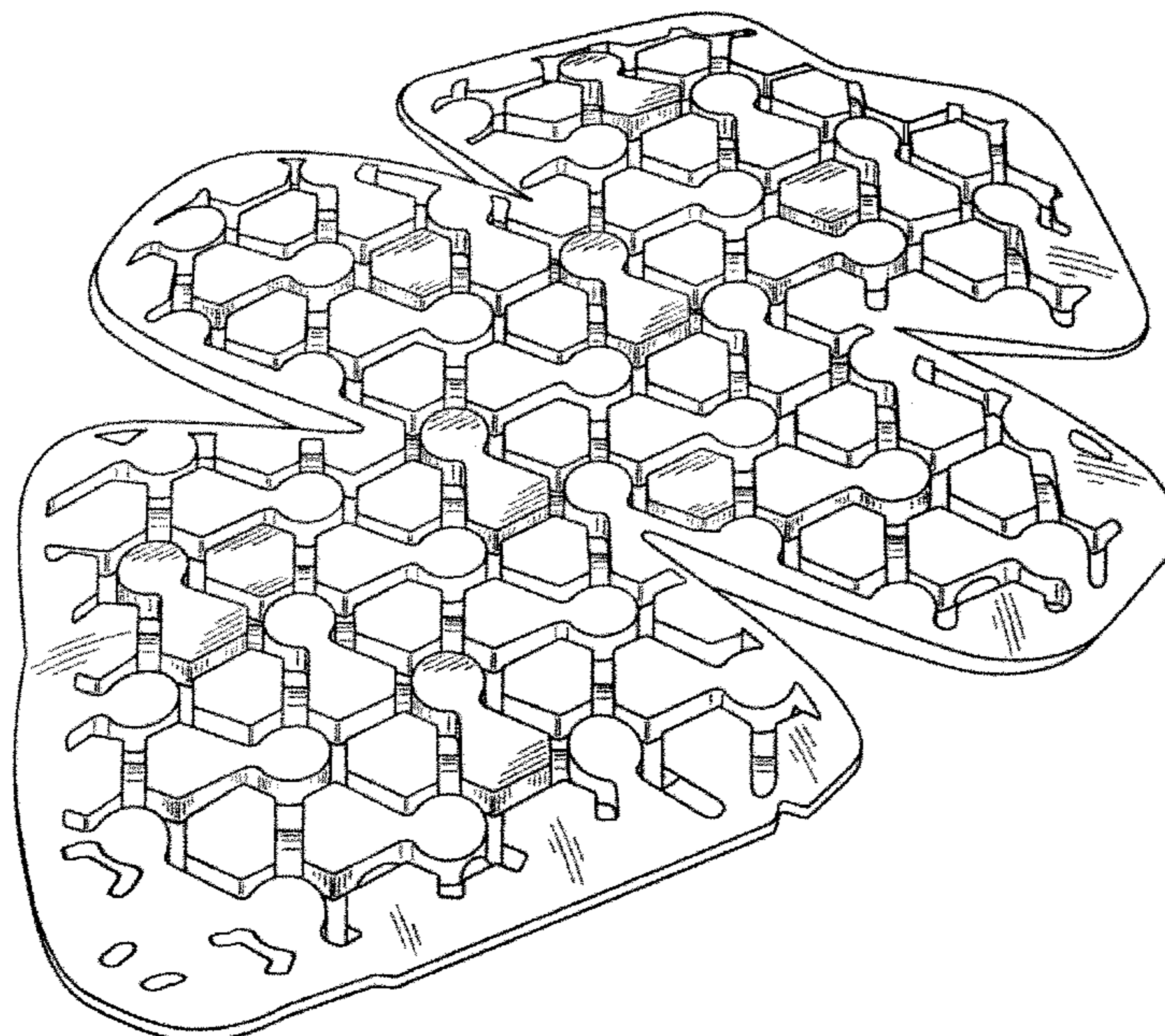
FIG. 4 is a top view of the protective pad for sportswear of FIG. 1;

FIG. 5 is a bottom view of the protective pad for sportswear of FIG. 1; and,

FIG. 6 is another perspective view of the protective pad for sportswear of FIG. 1, shown in a condition of use.

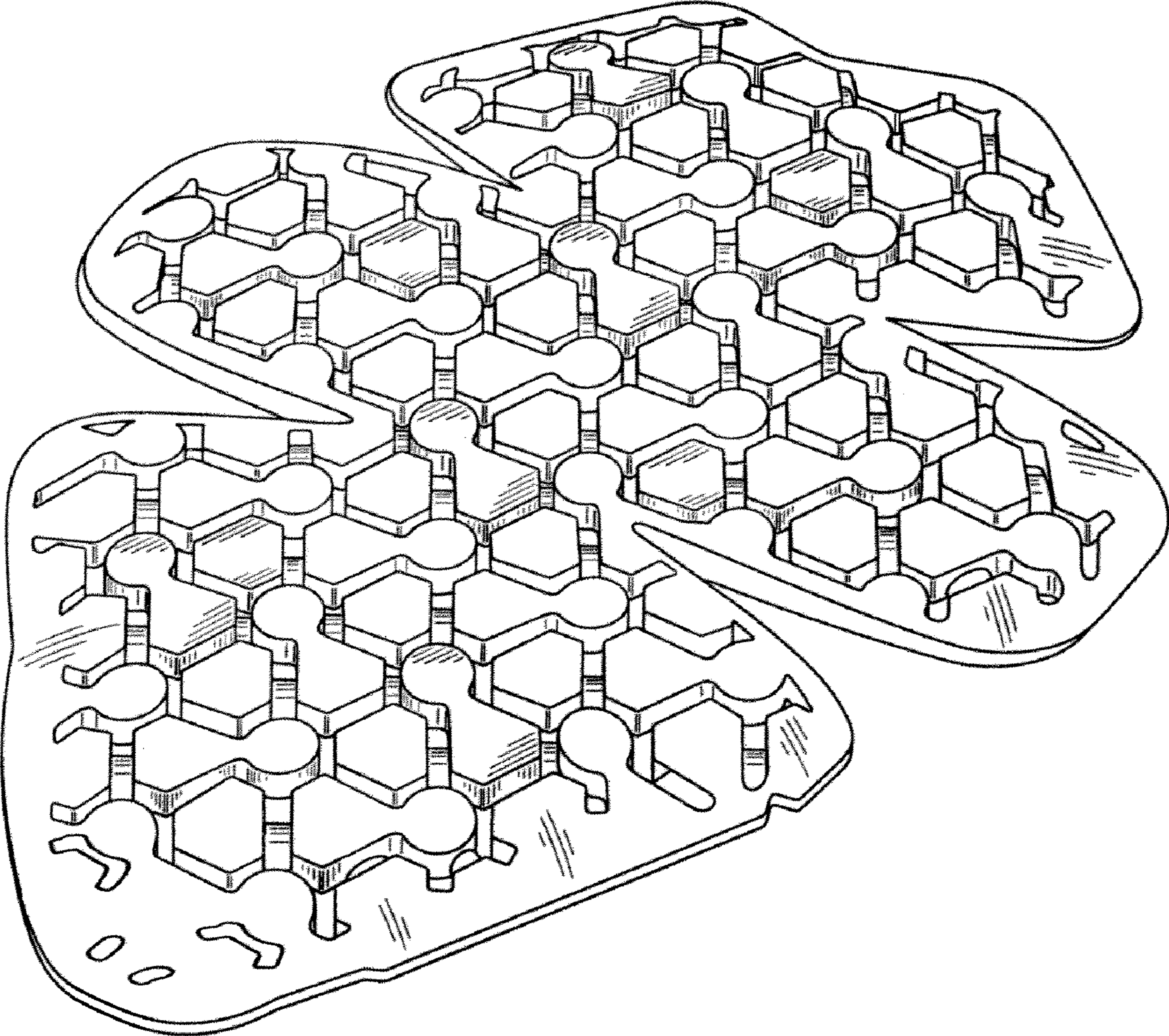

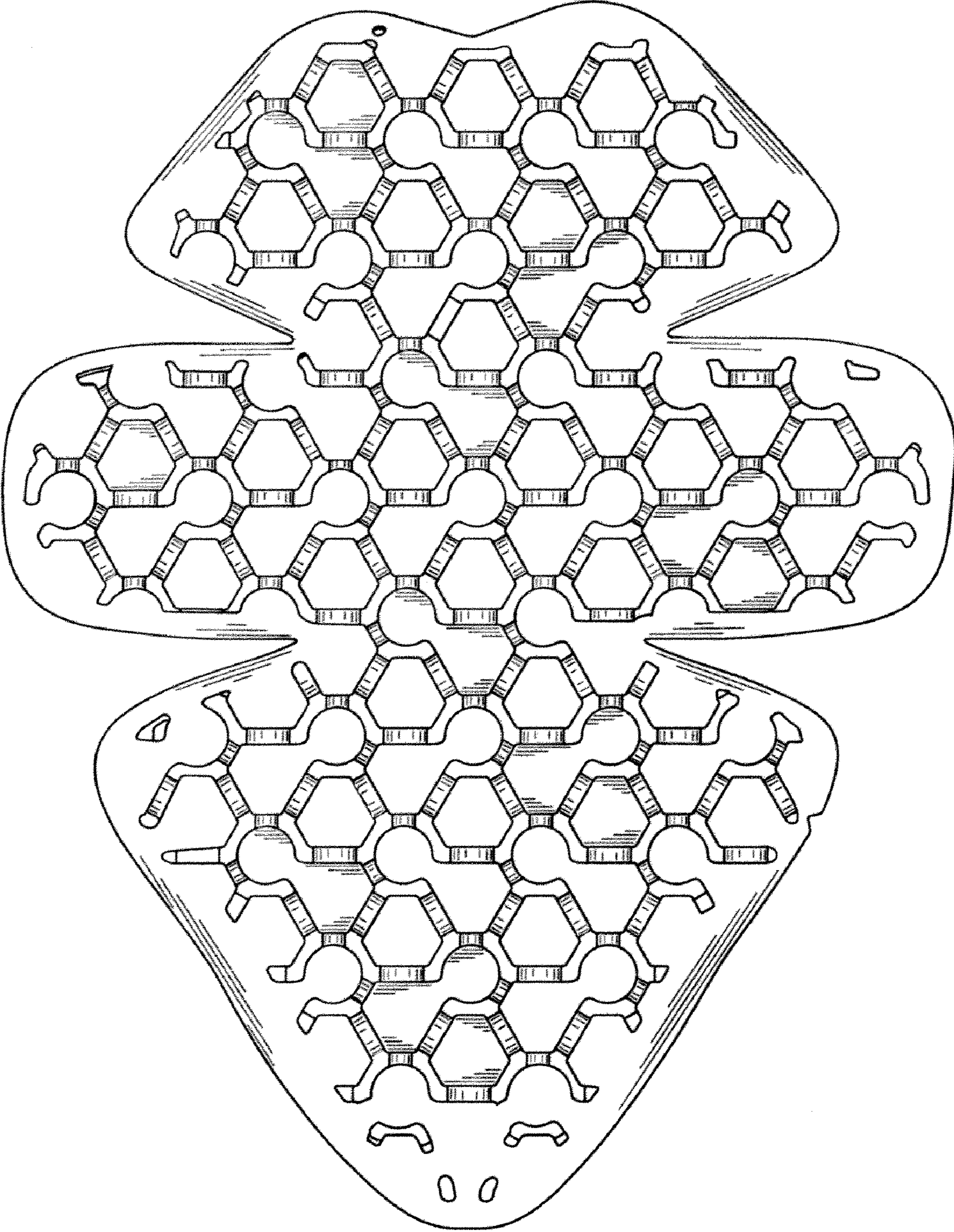

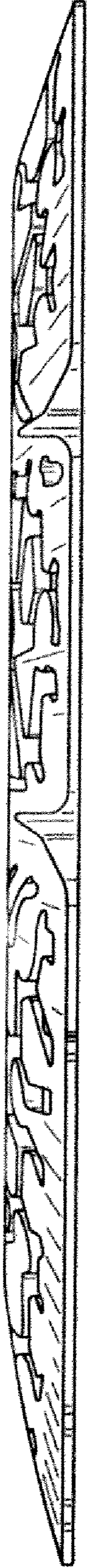

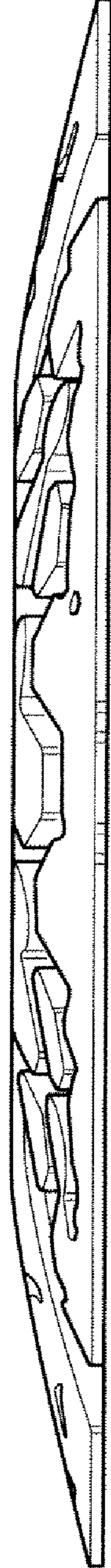

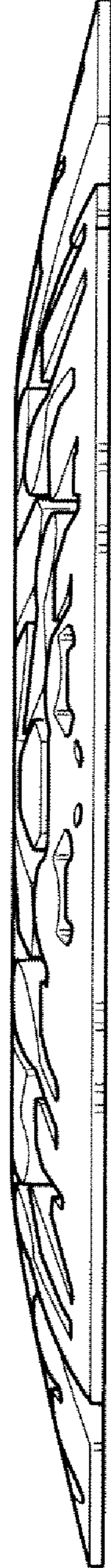

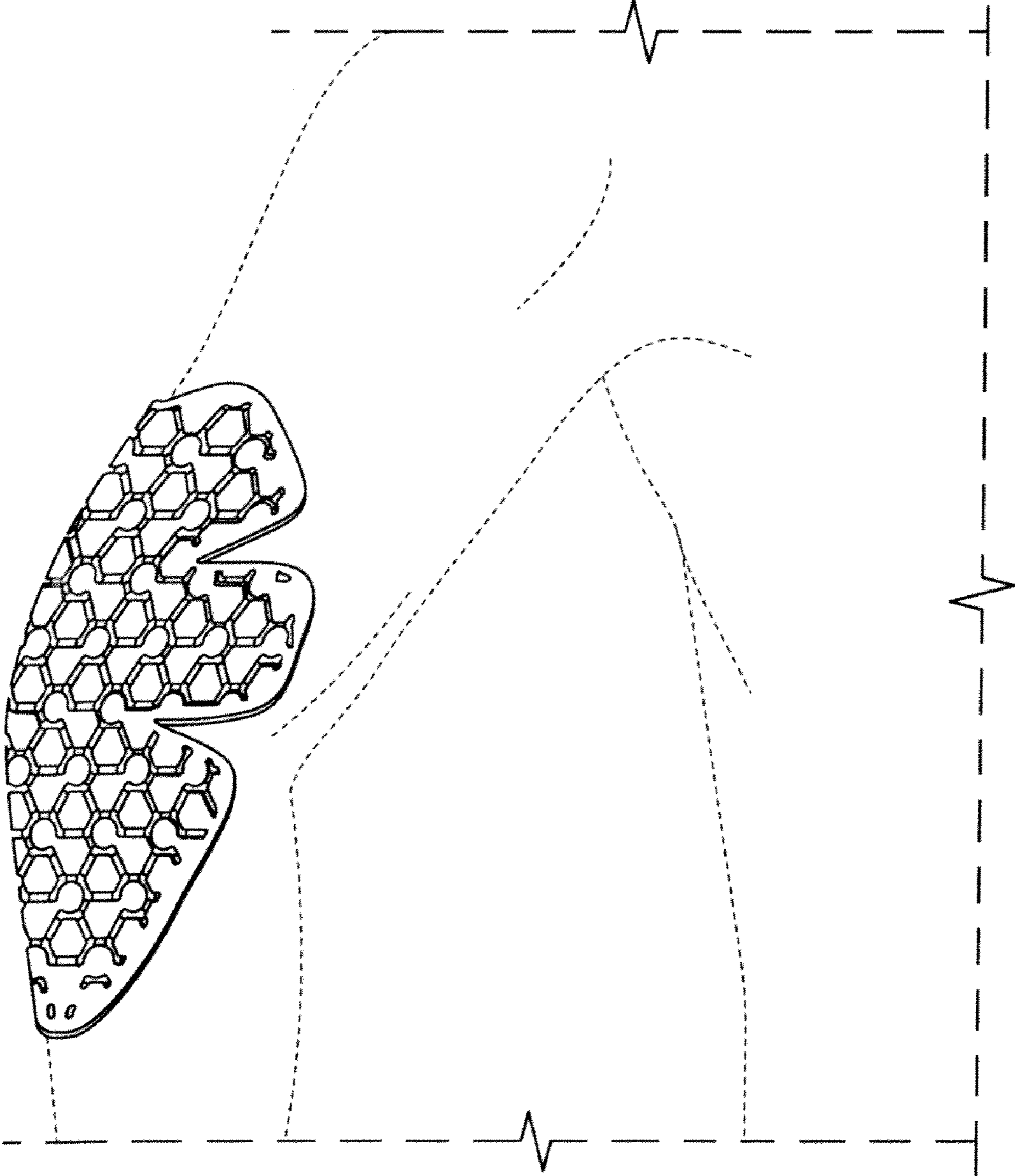
