FIG. 3 is a front view of the pet kennel cupboard;

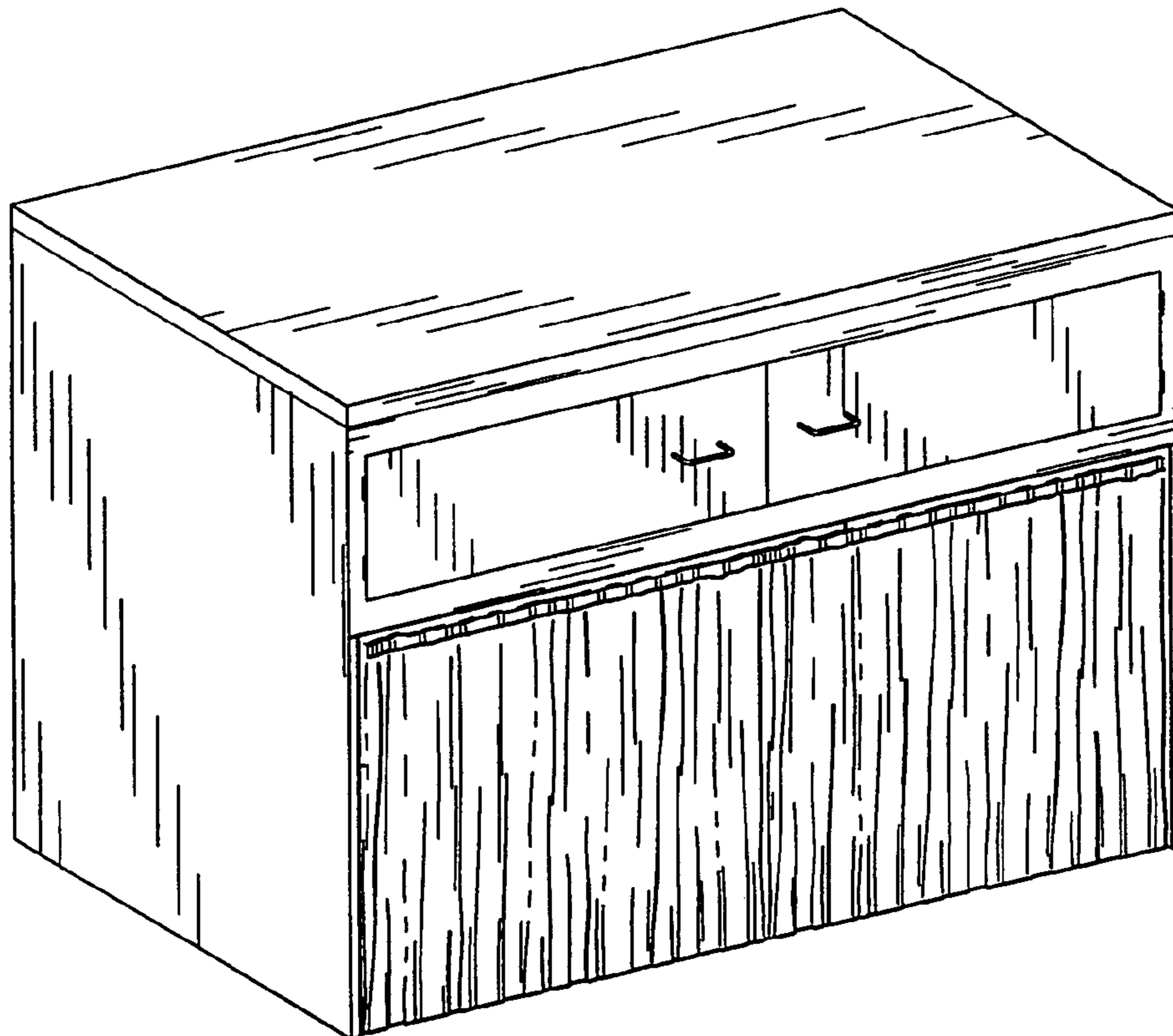
FIG. 4 is a view of the right side of the pet kennel cupboard.

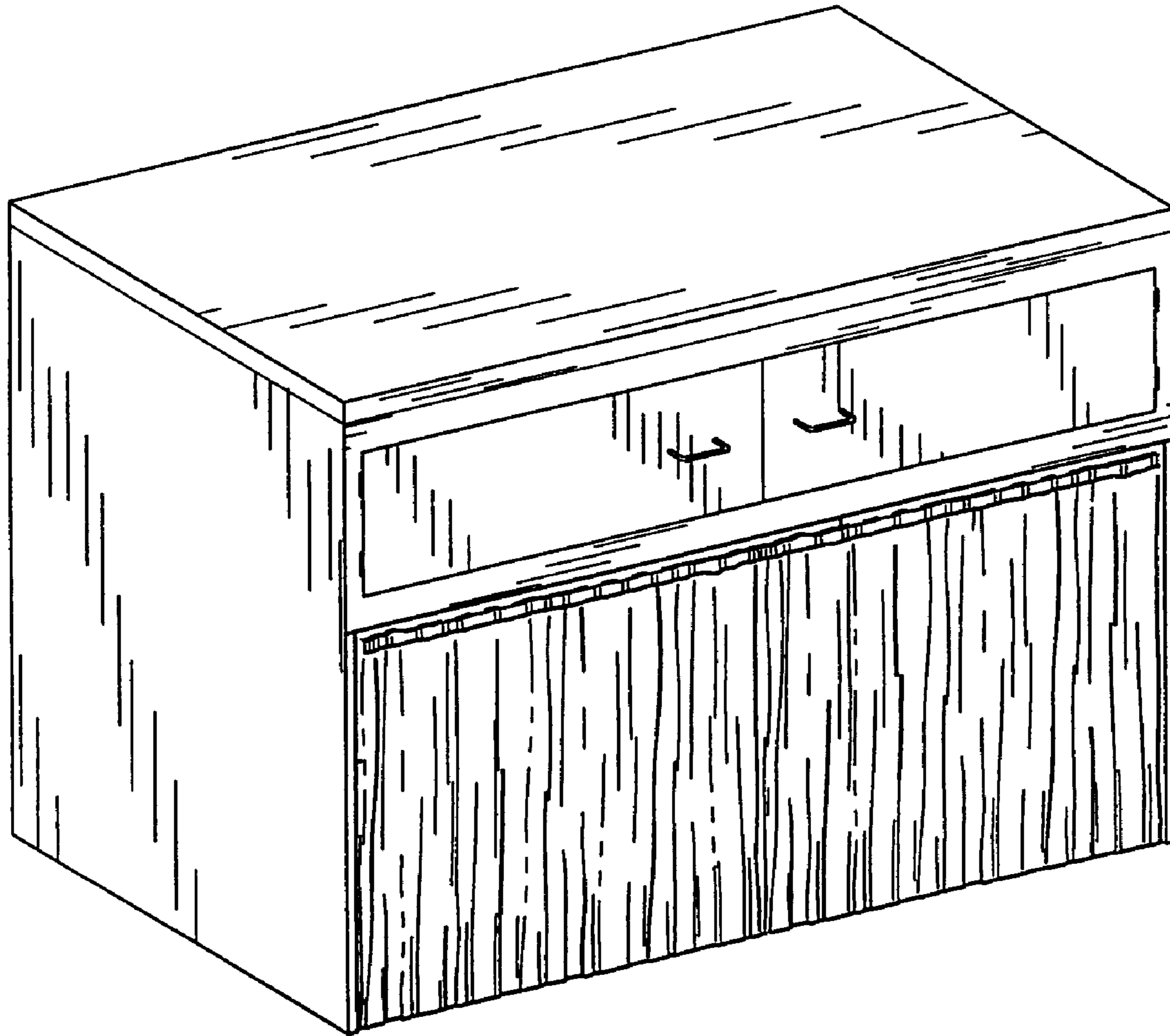

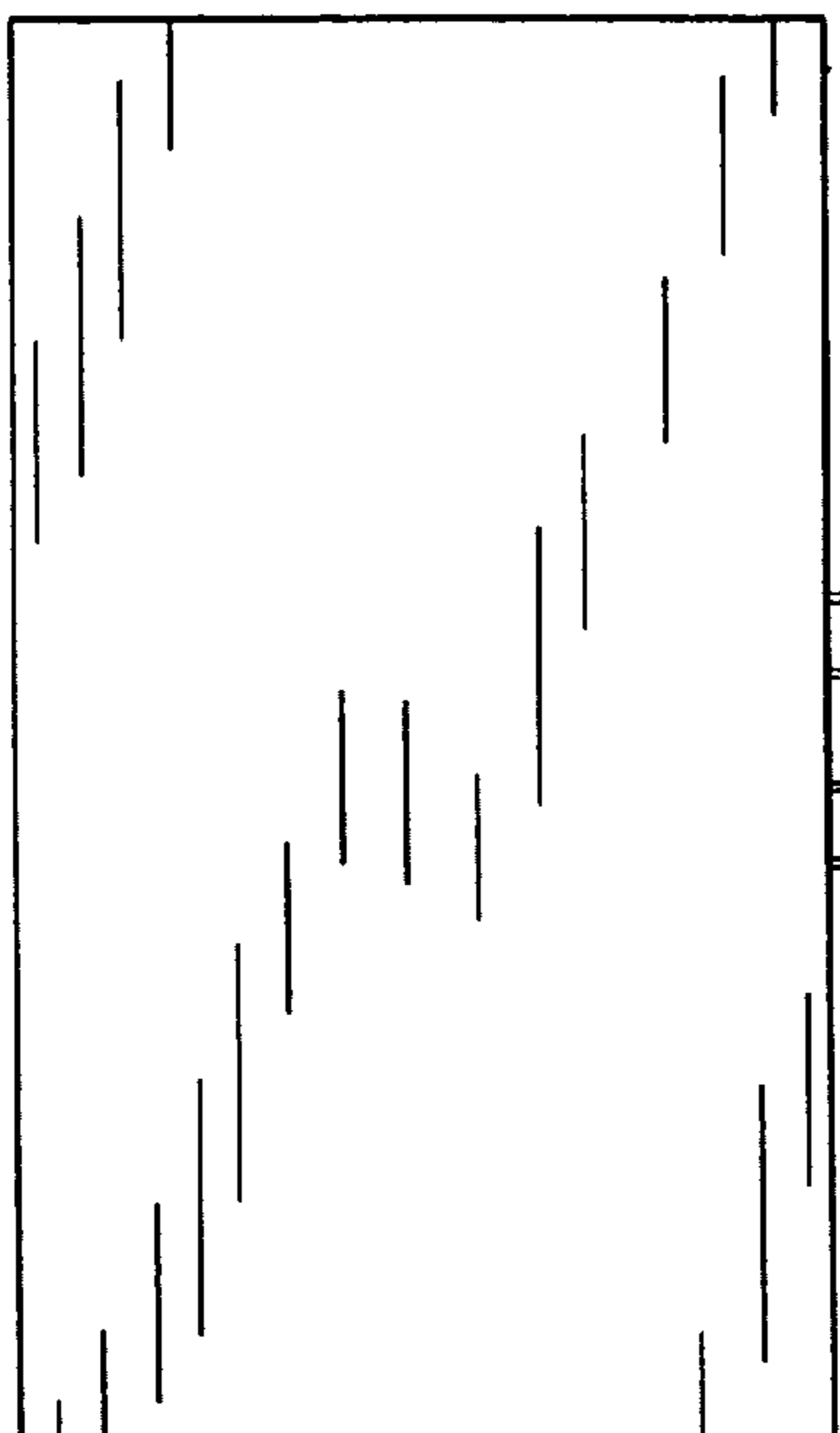

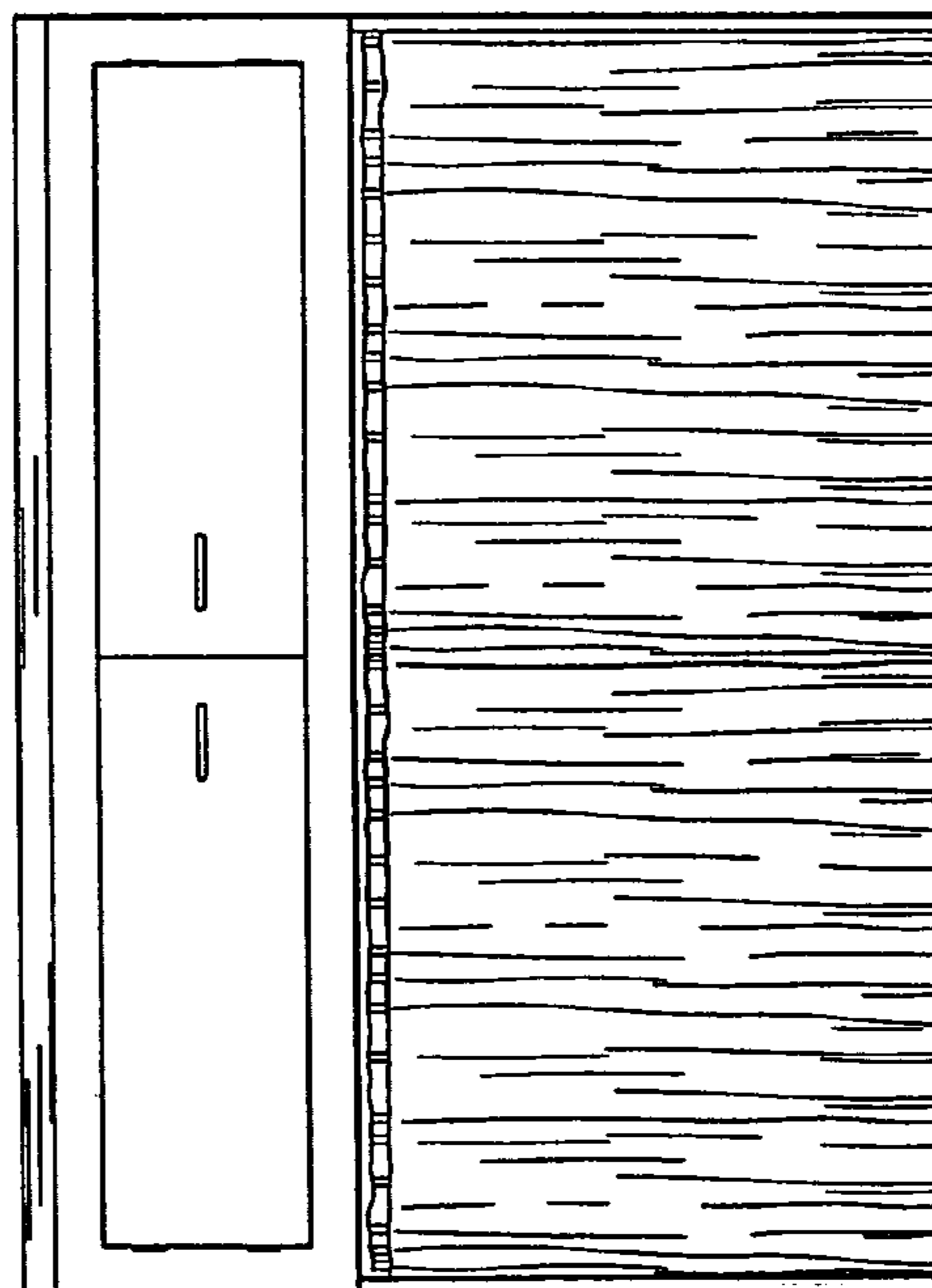

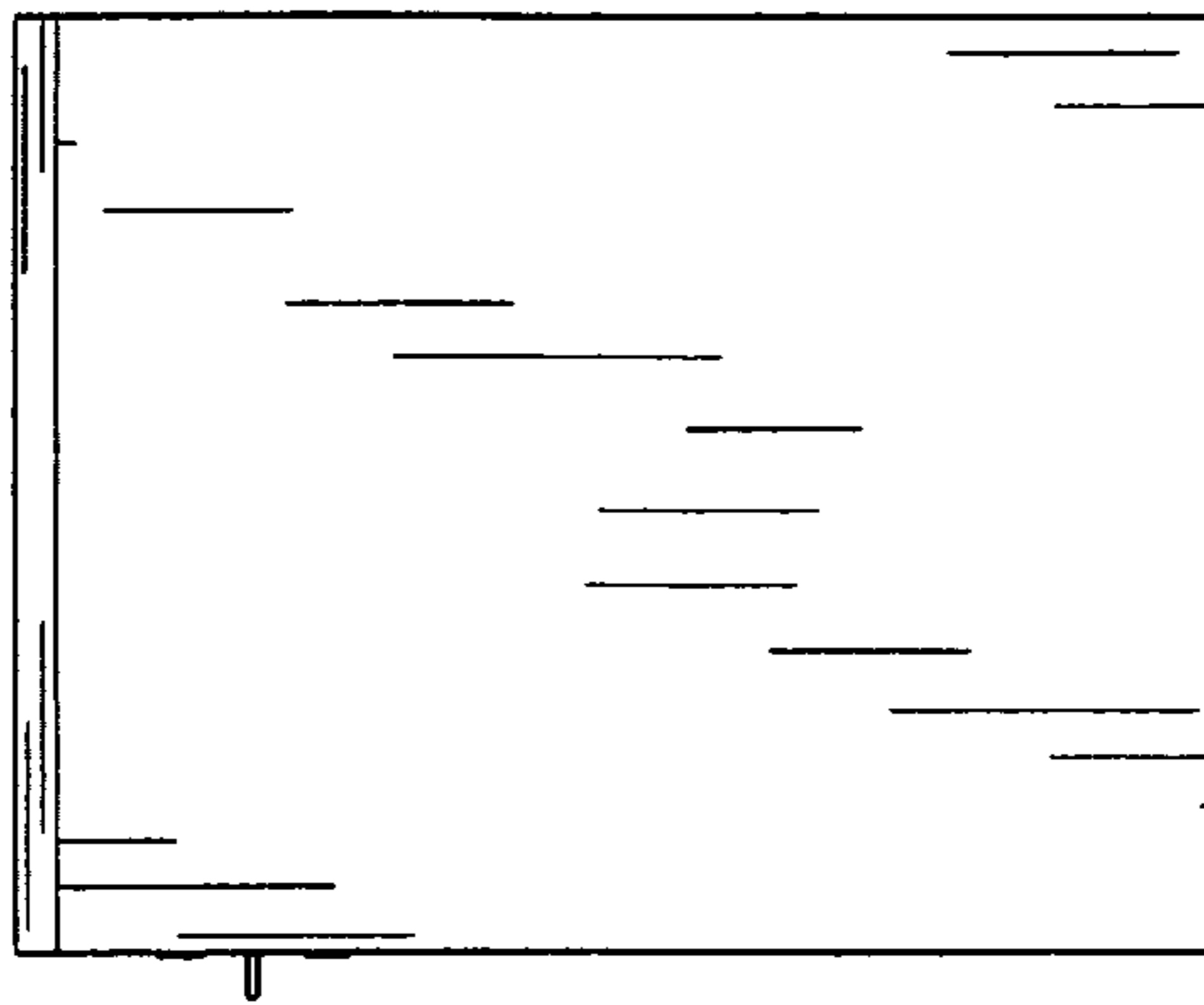

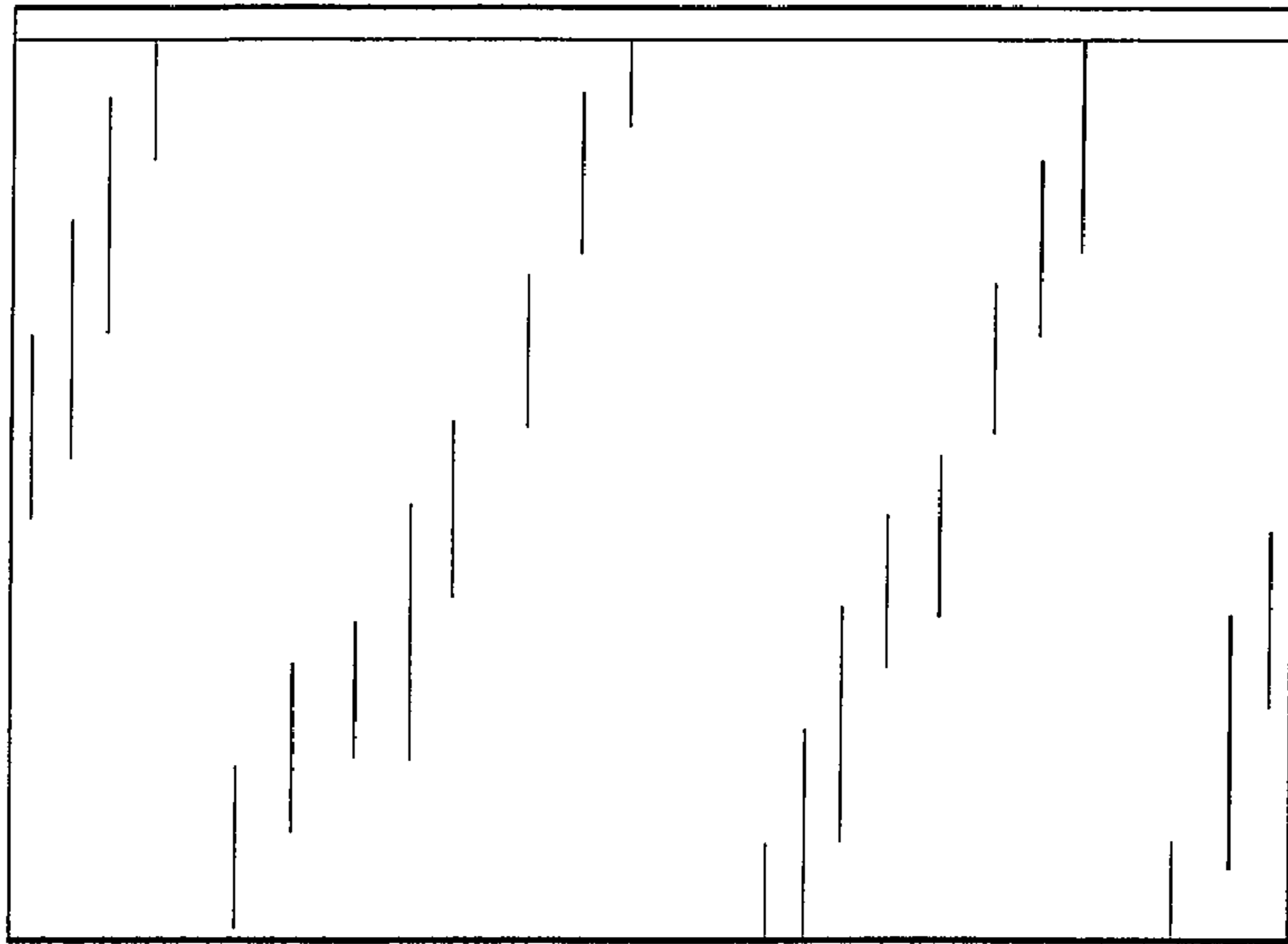

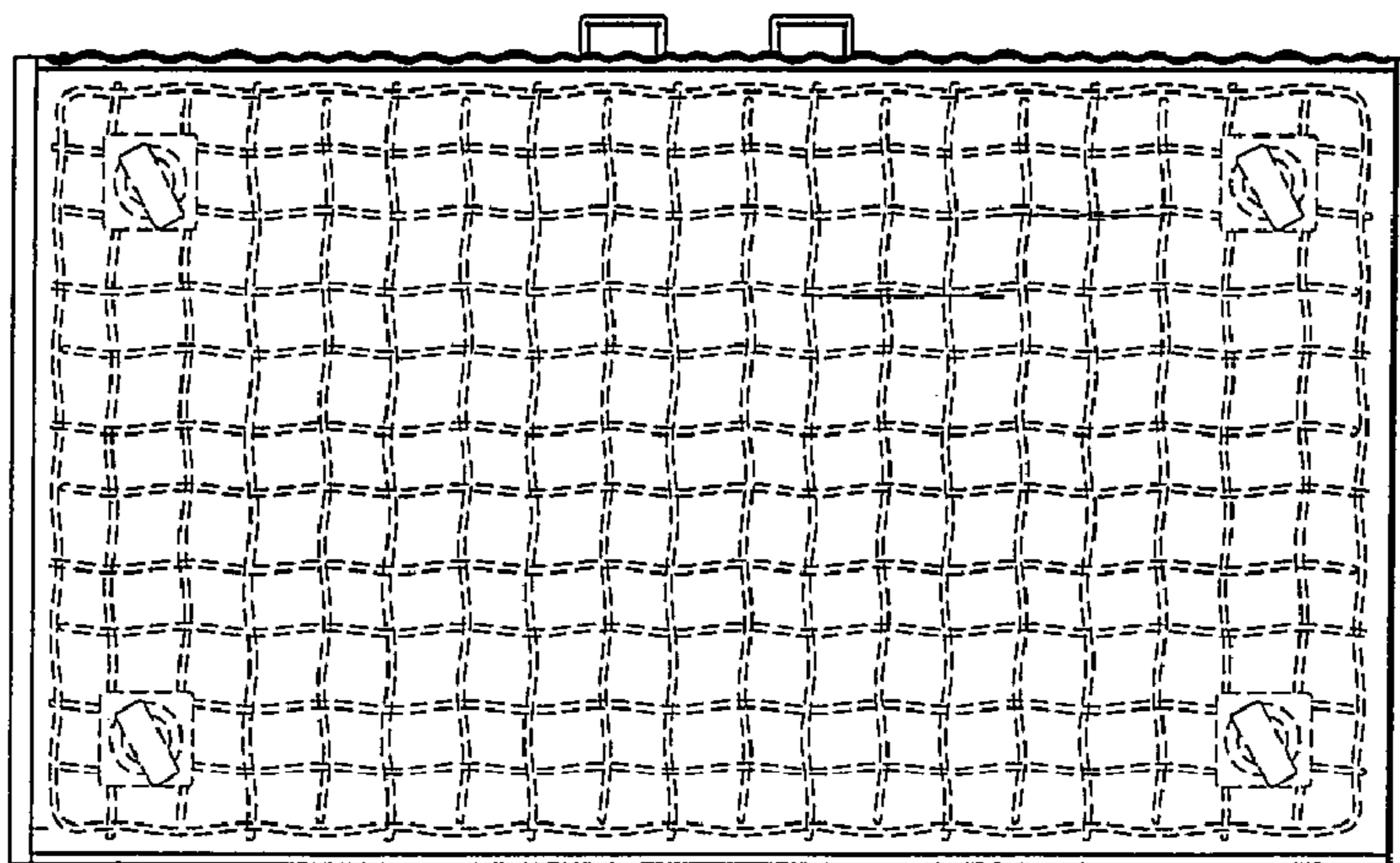
