I claim the ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the shoe outsole;

FIG. 2 is a left side view of the shoe outsole;

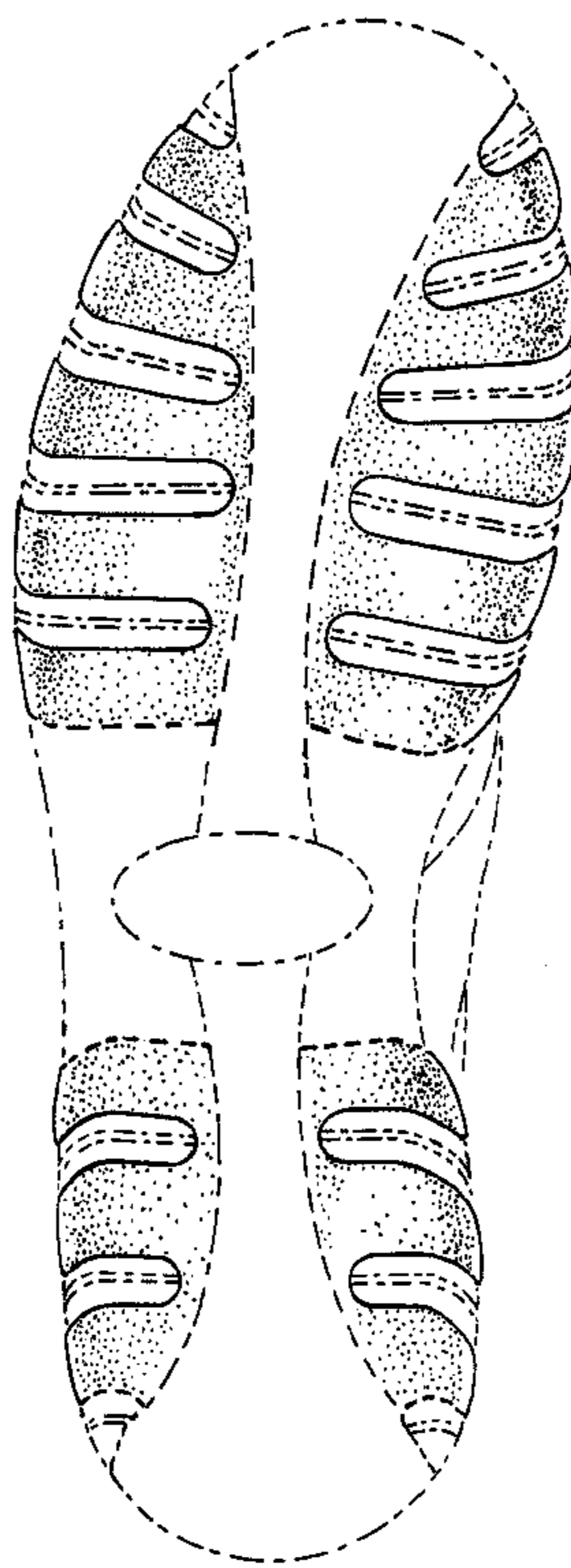
FIG. 3 is a right side view of the shoe outsole;

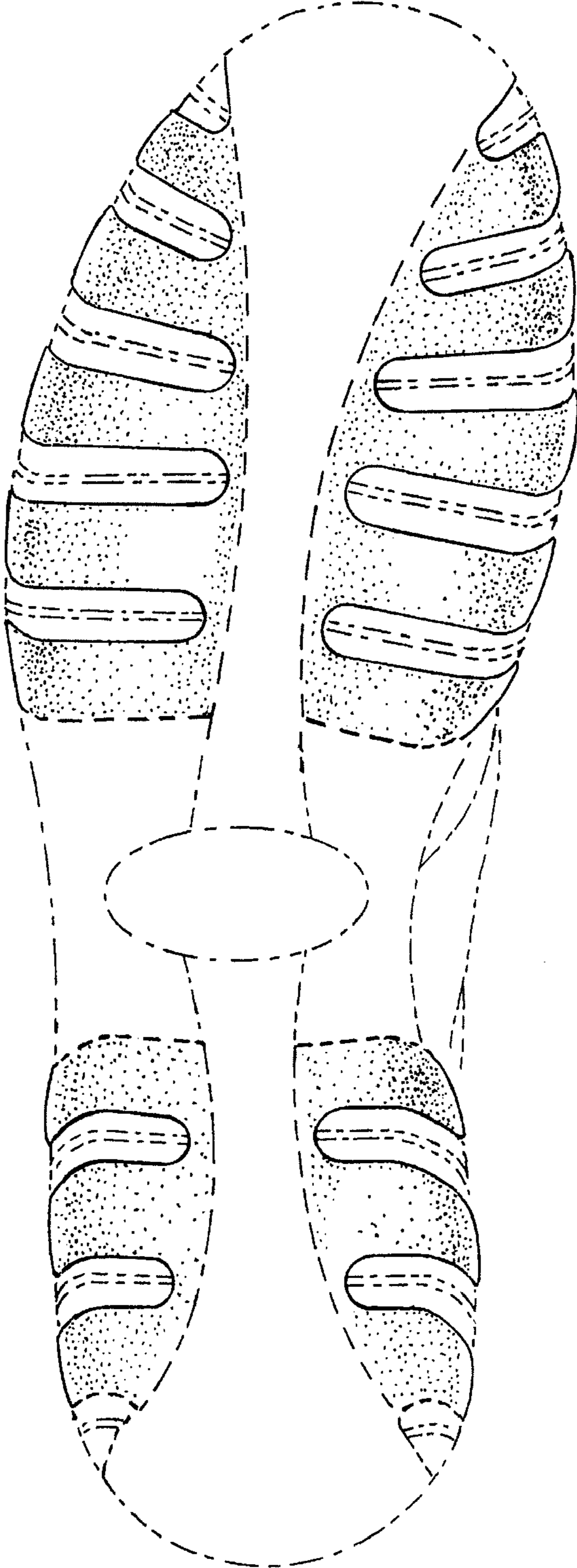

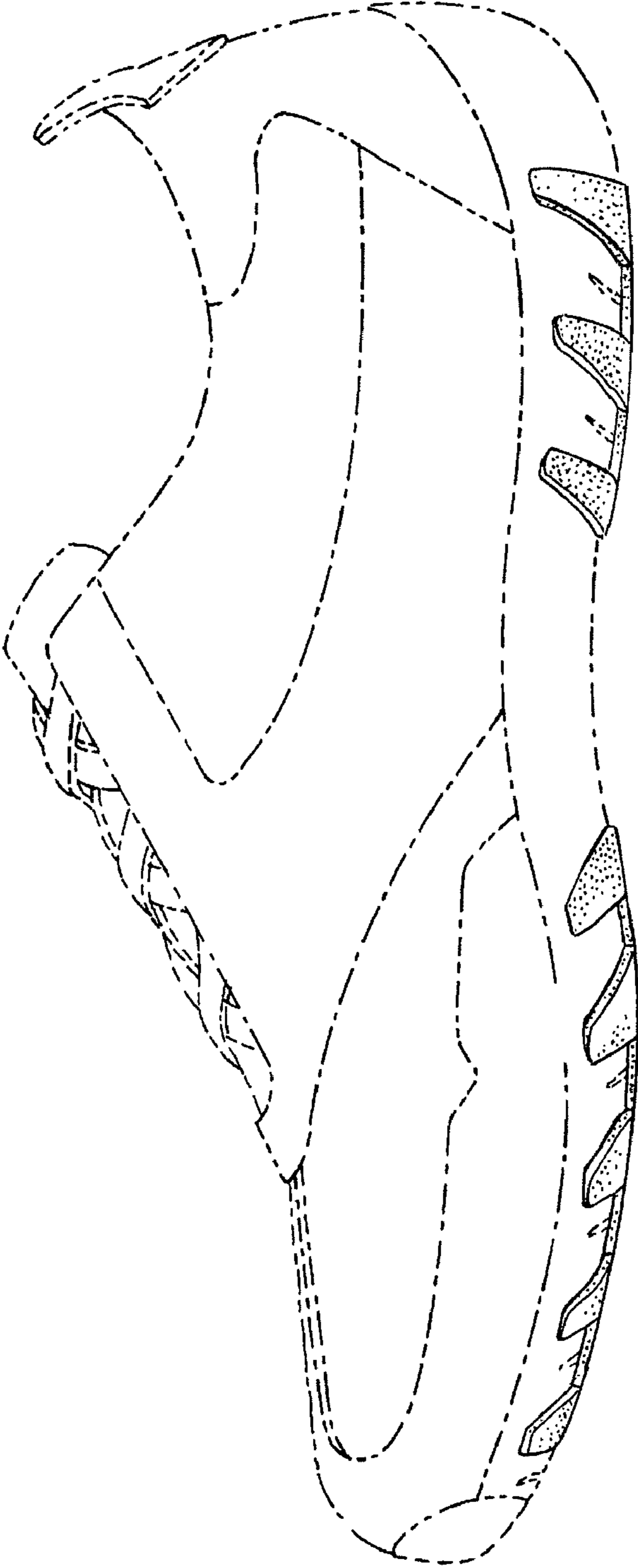

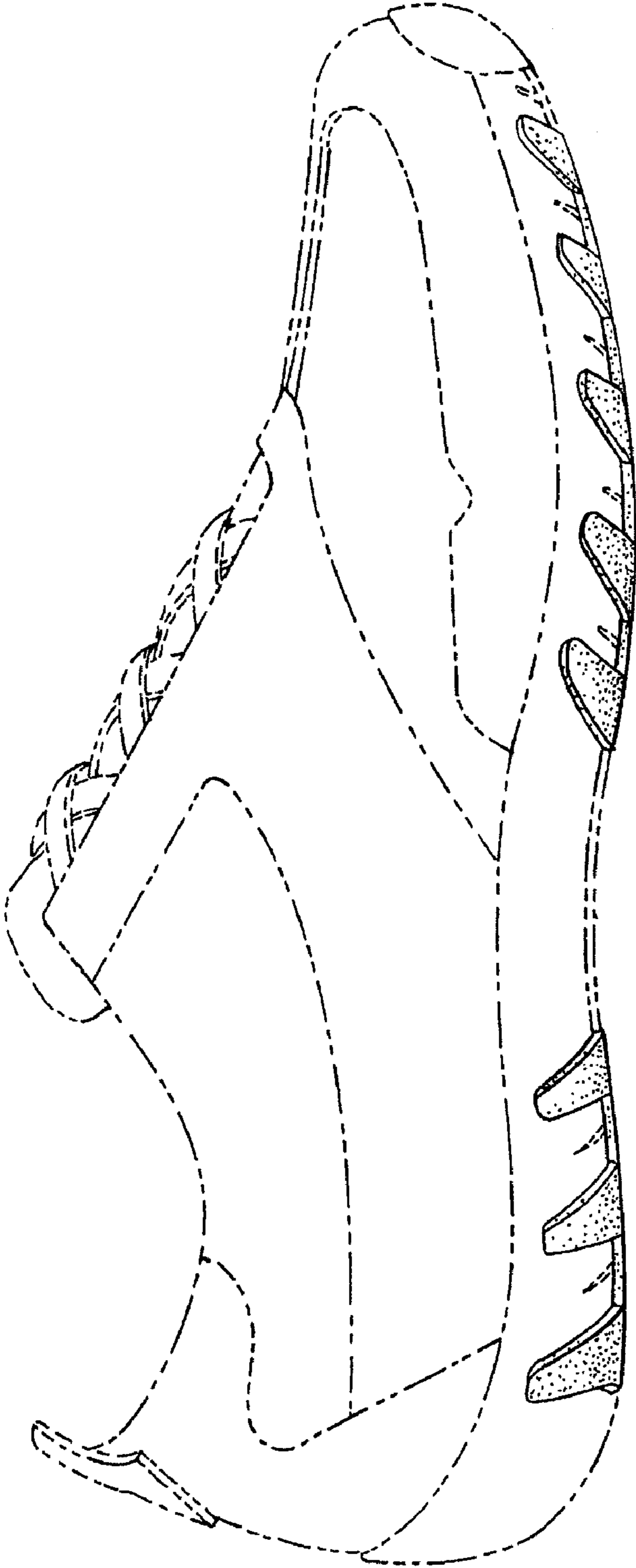

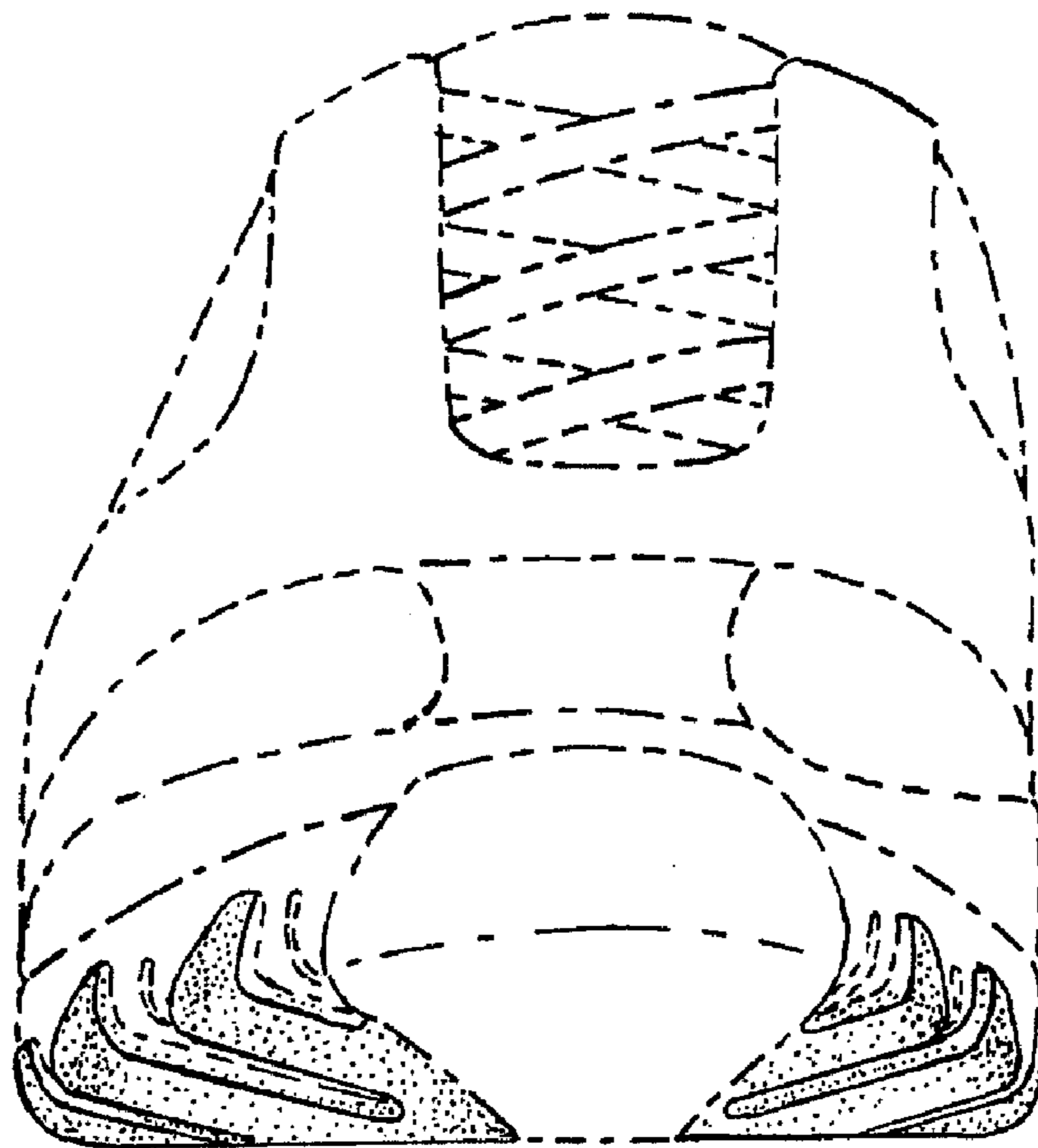

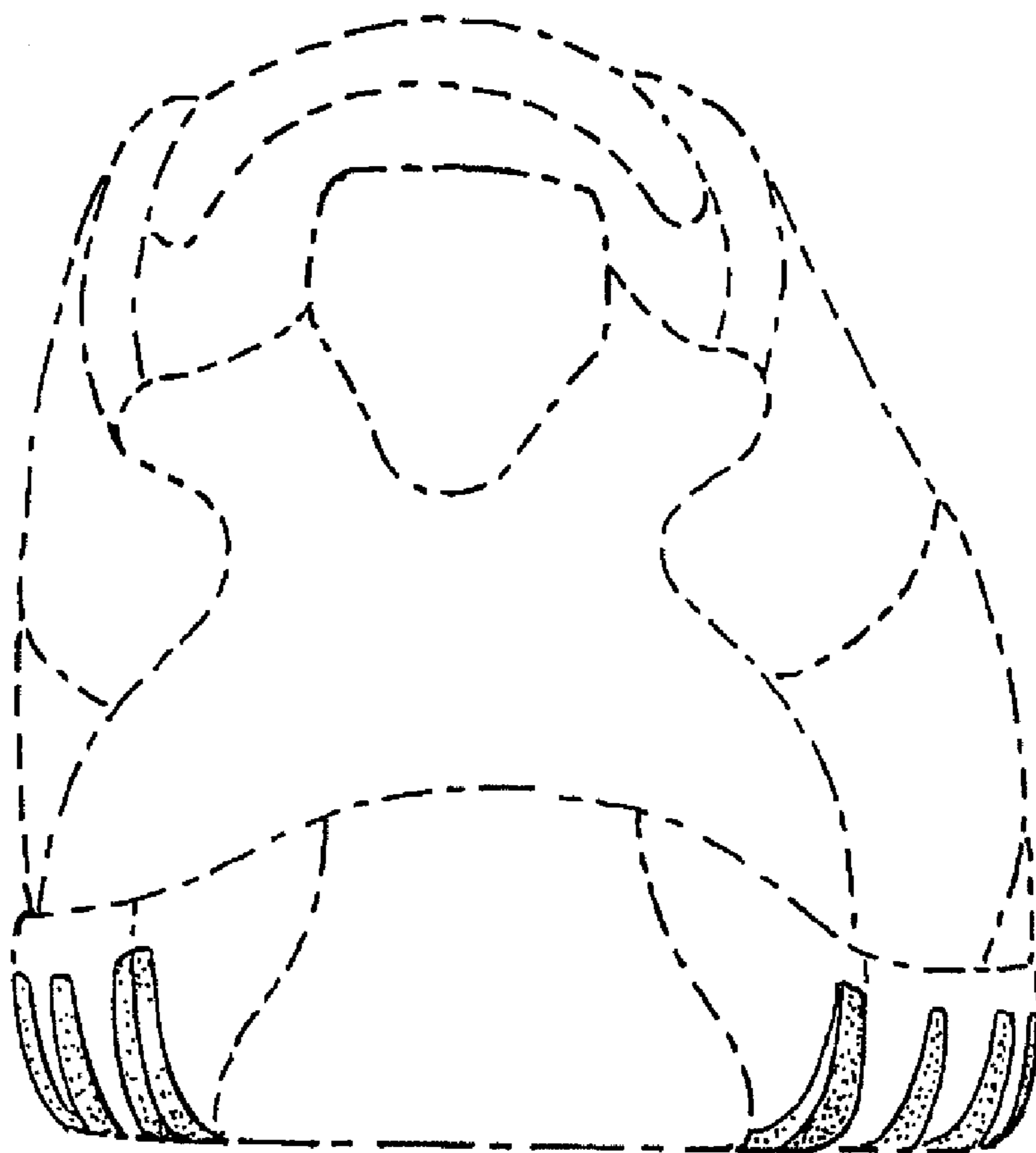
