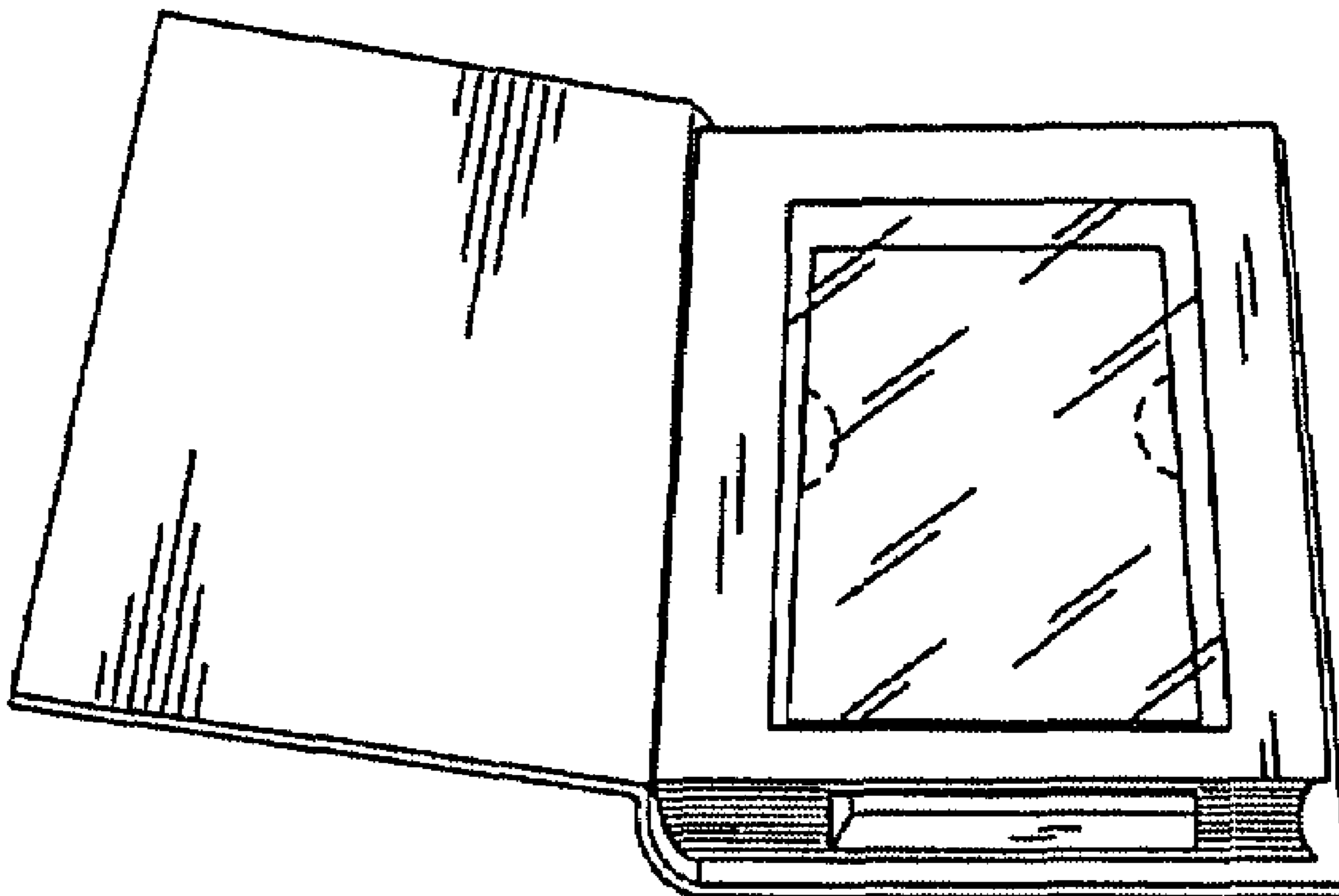
FIG. 8 is a rear side view thereof, with the cover closed; and,

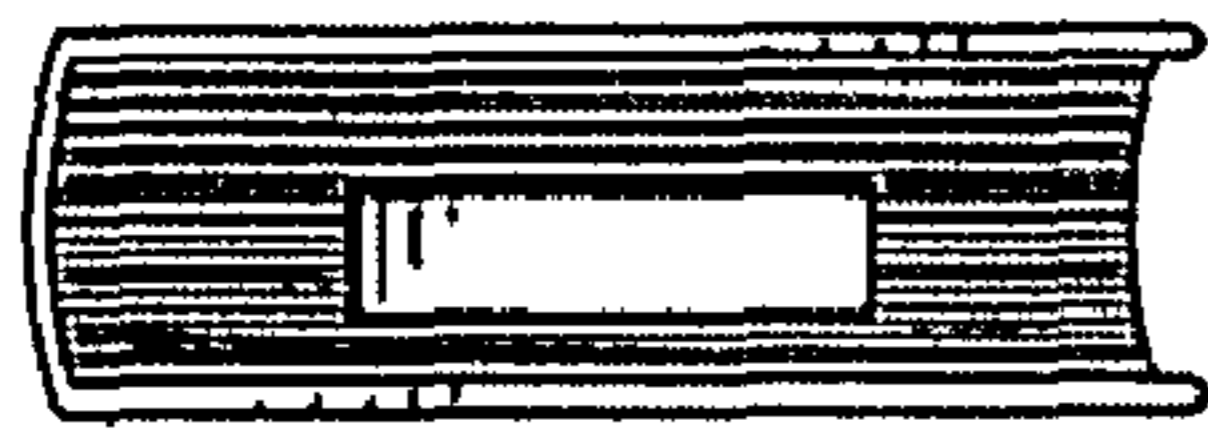

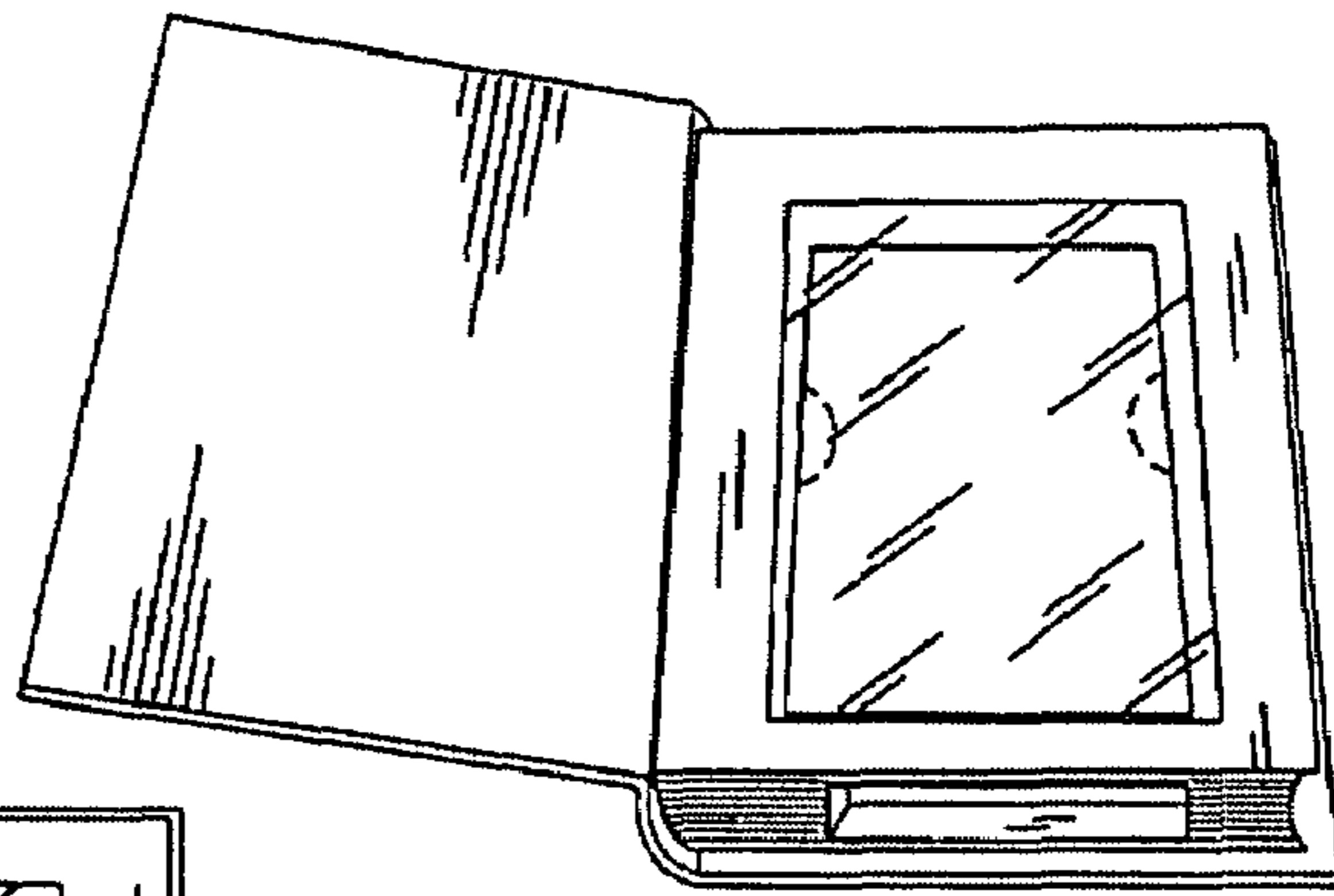

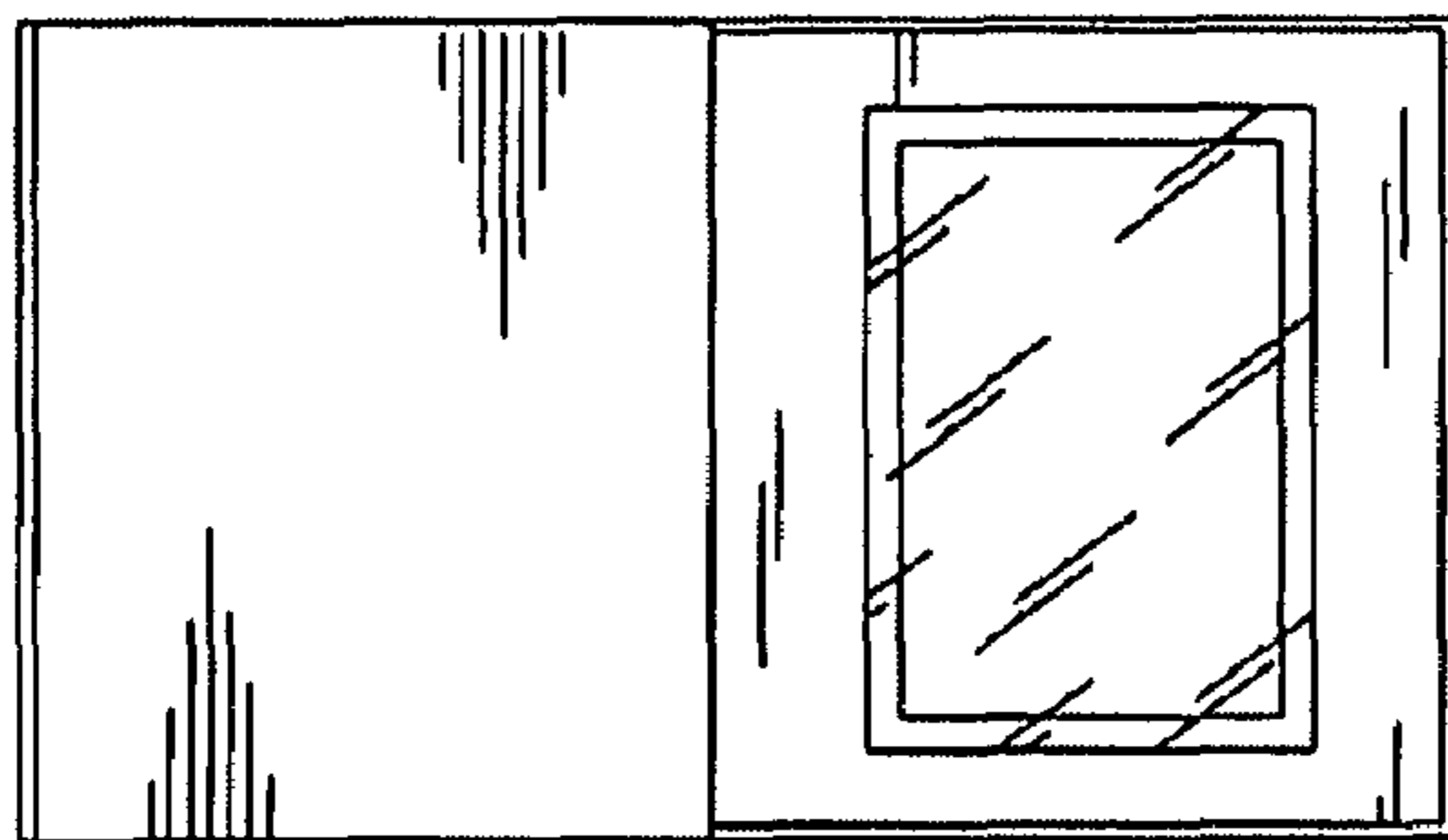

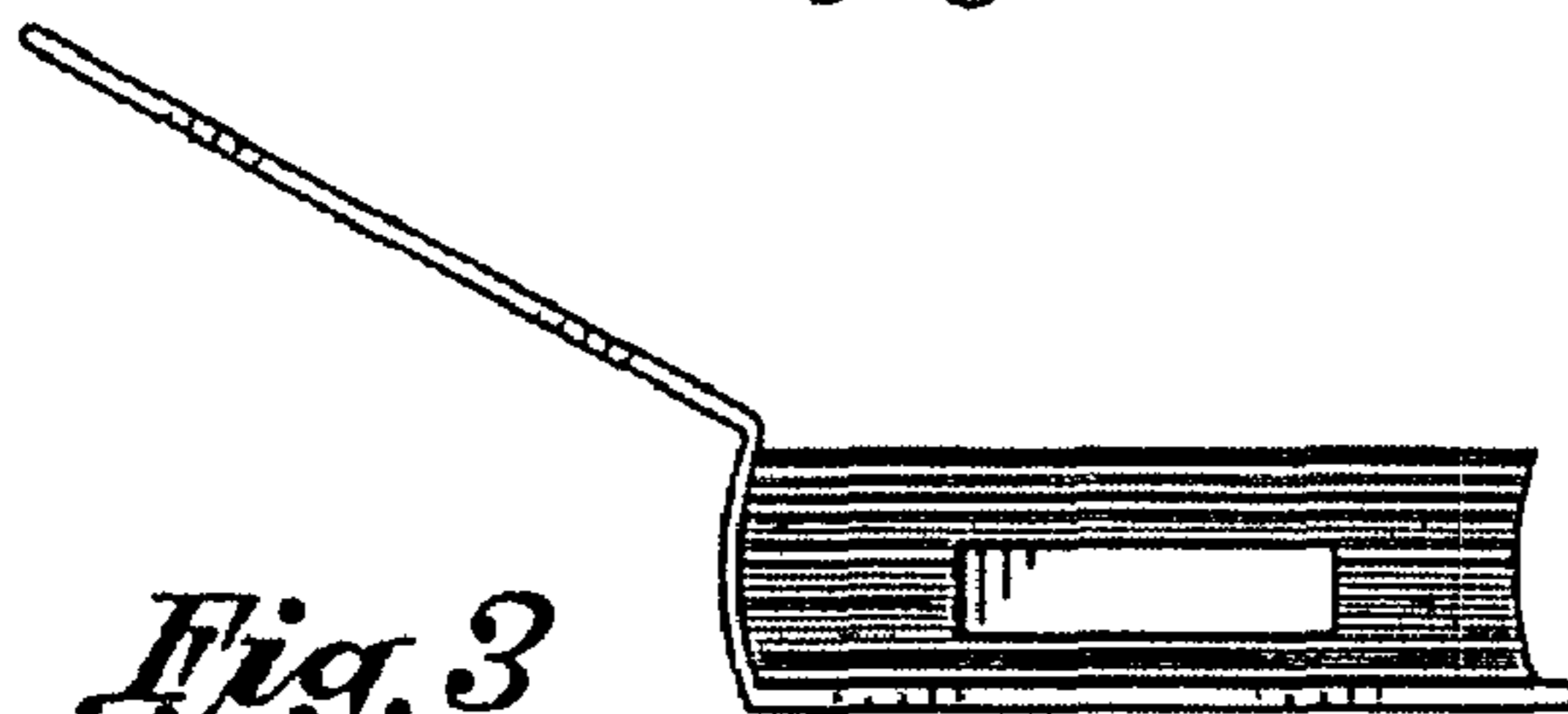

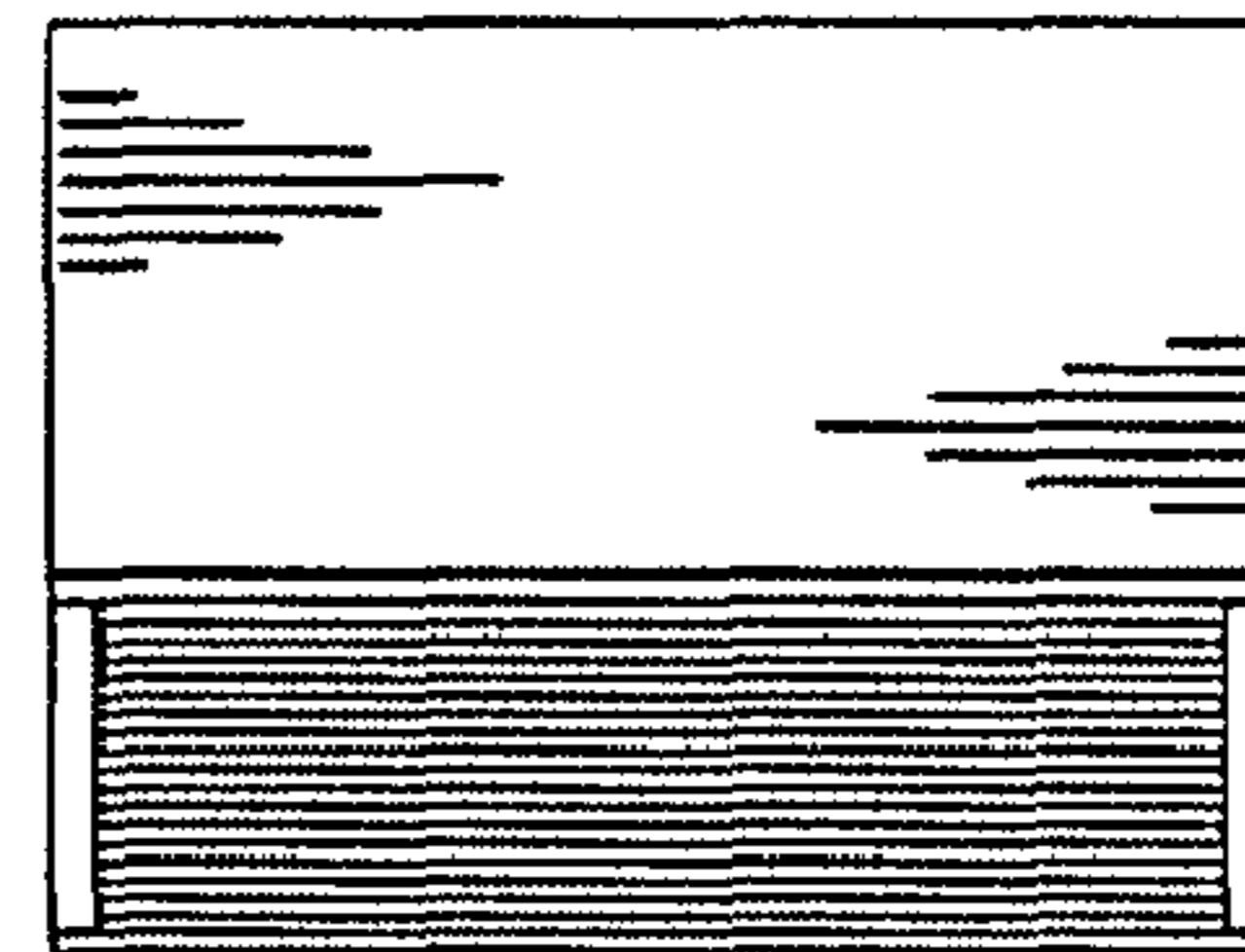

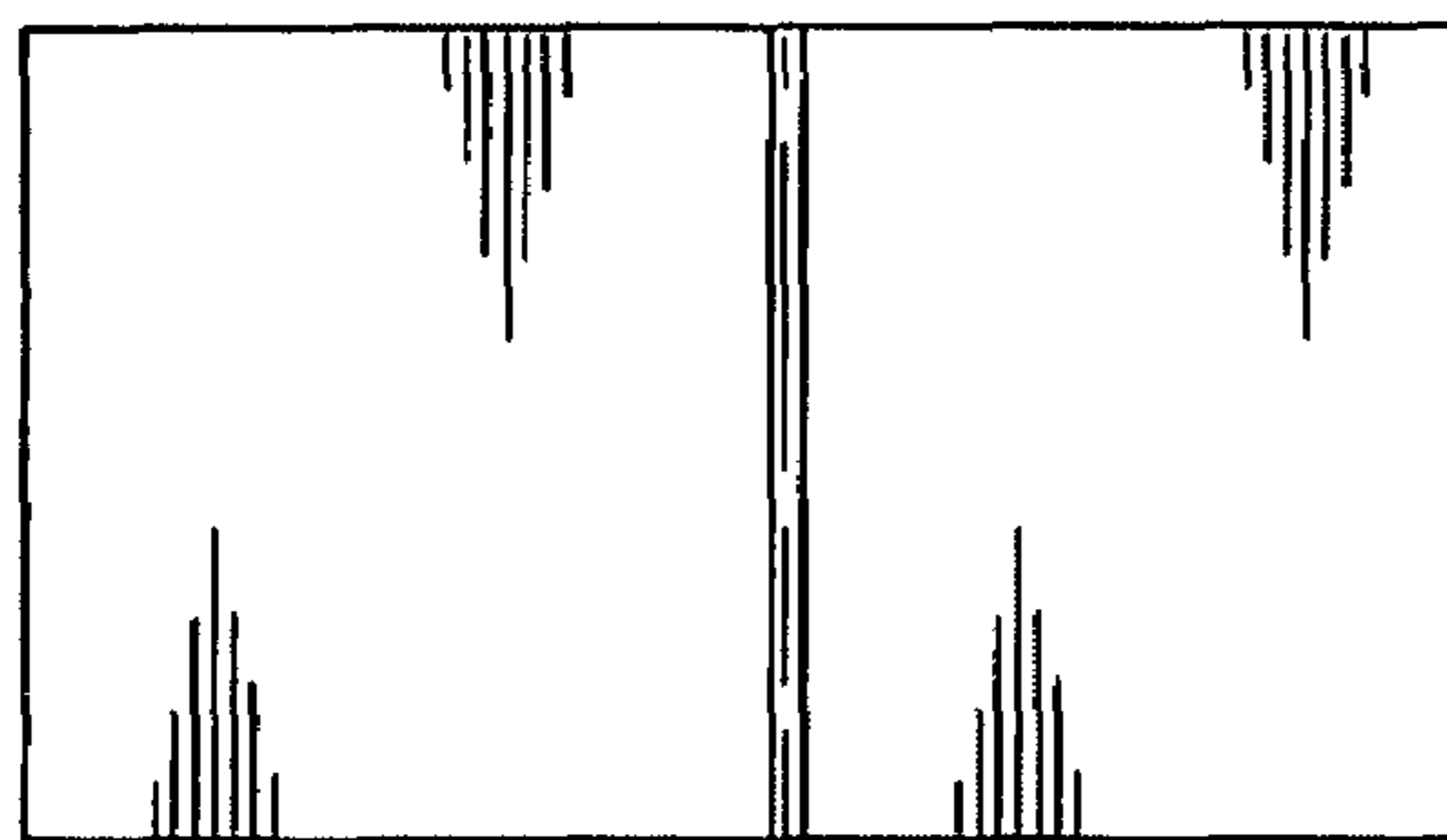

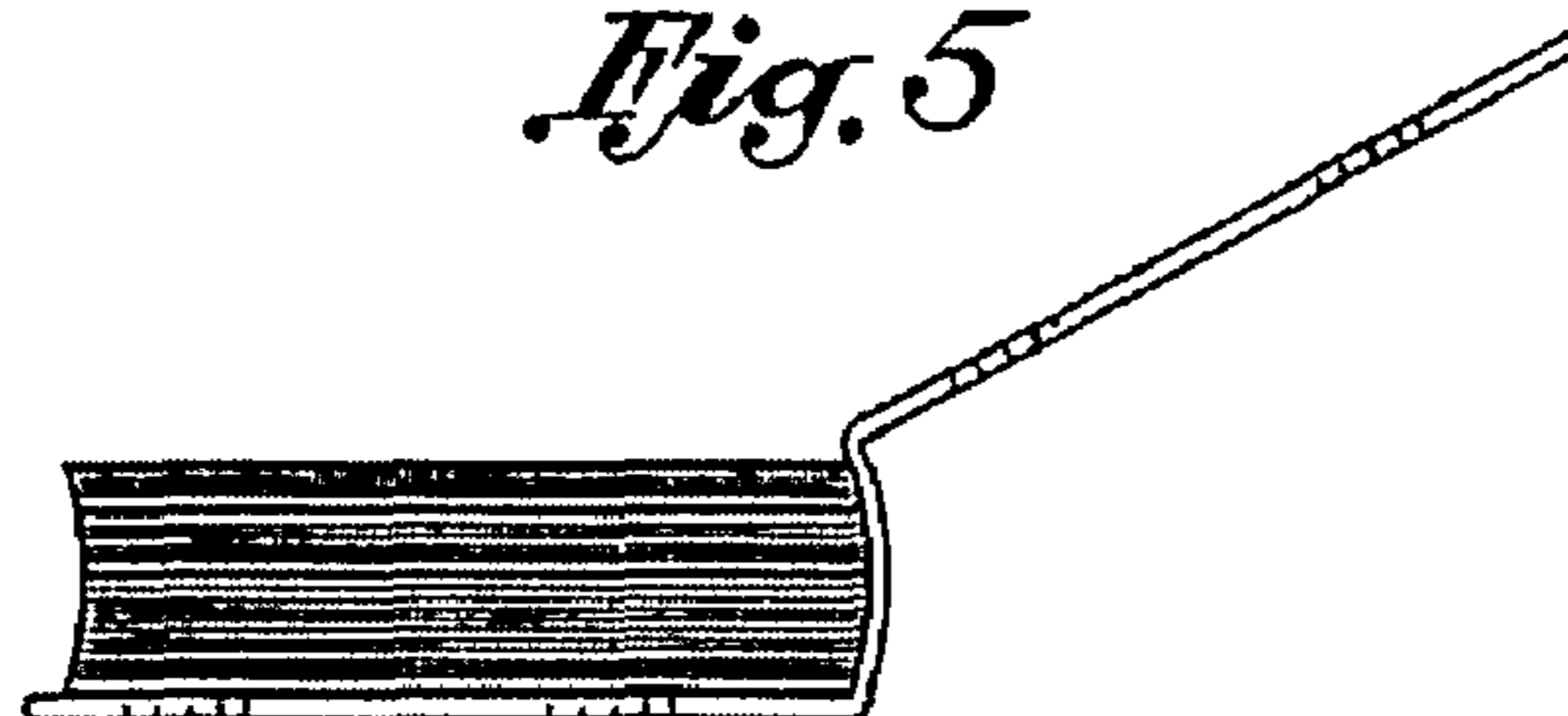

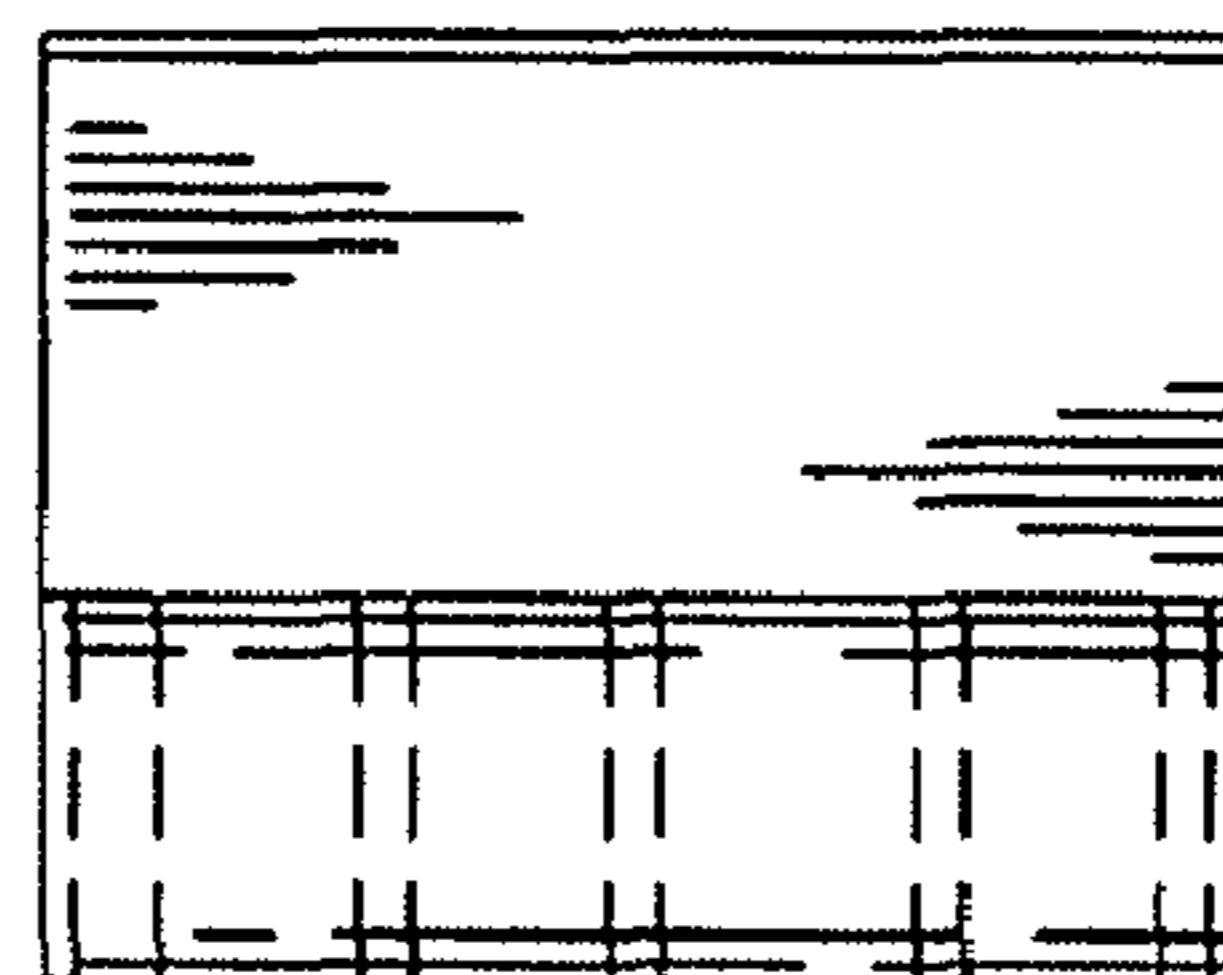

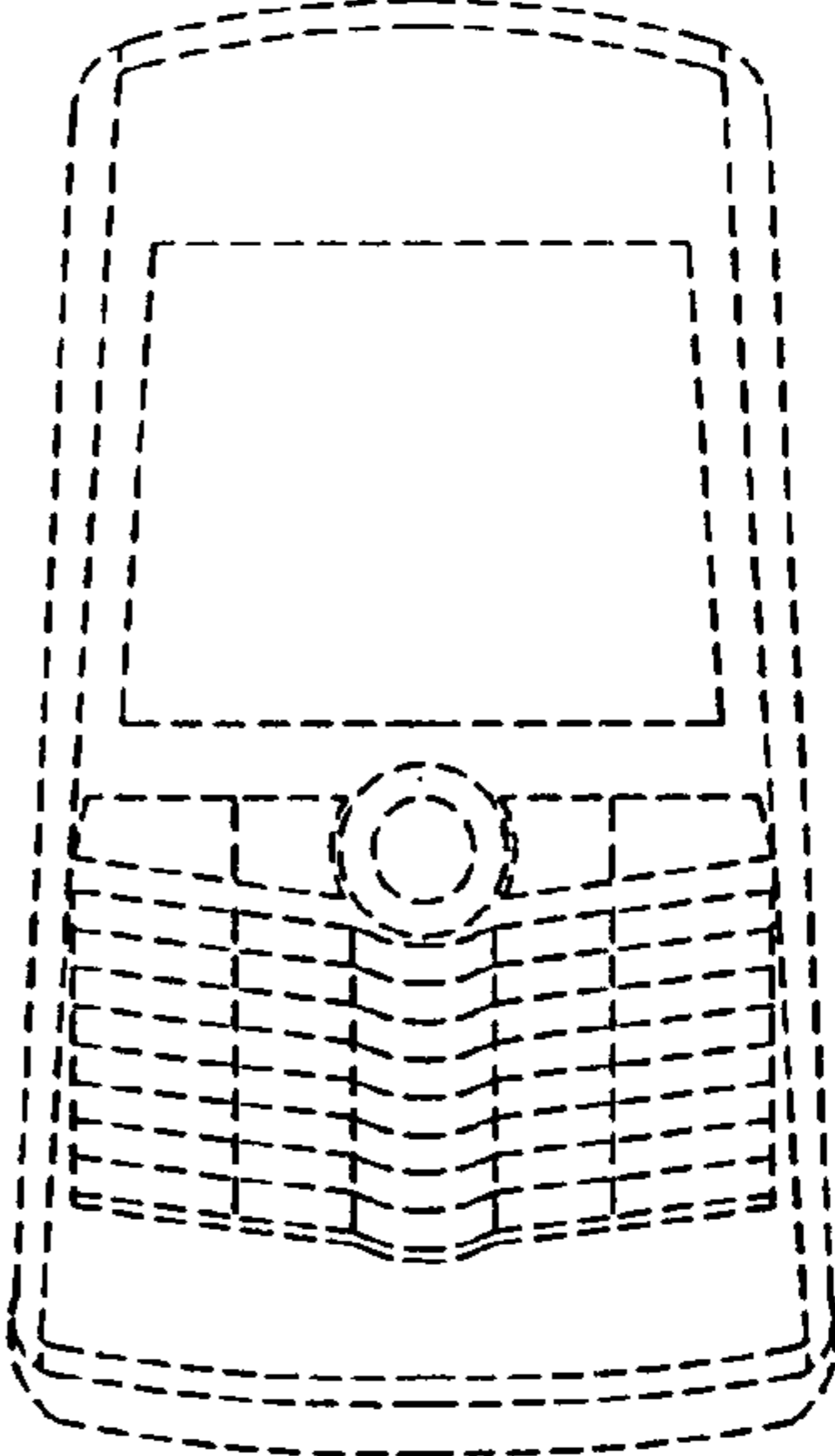
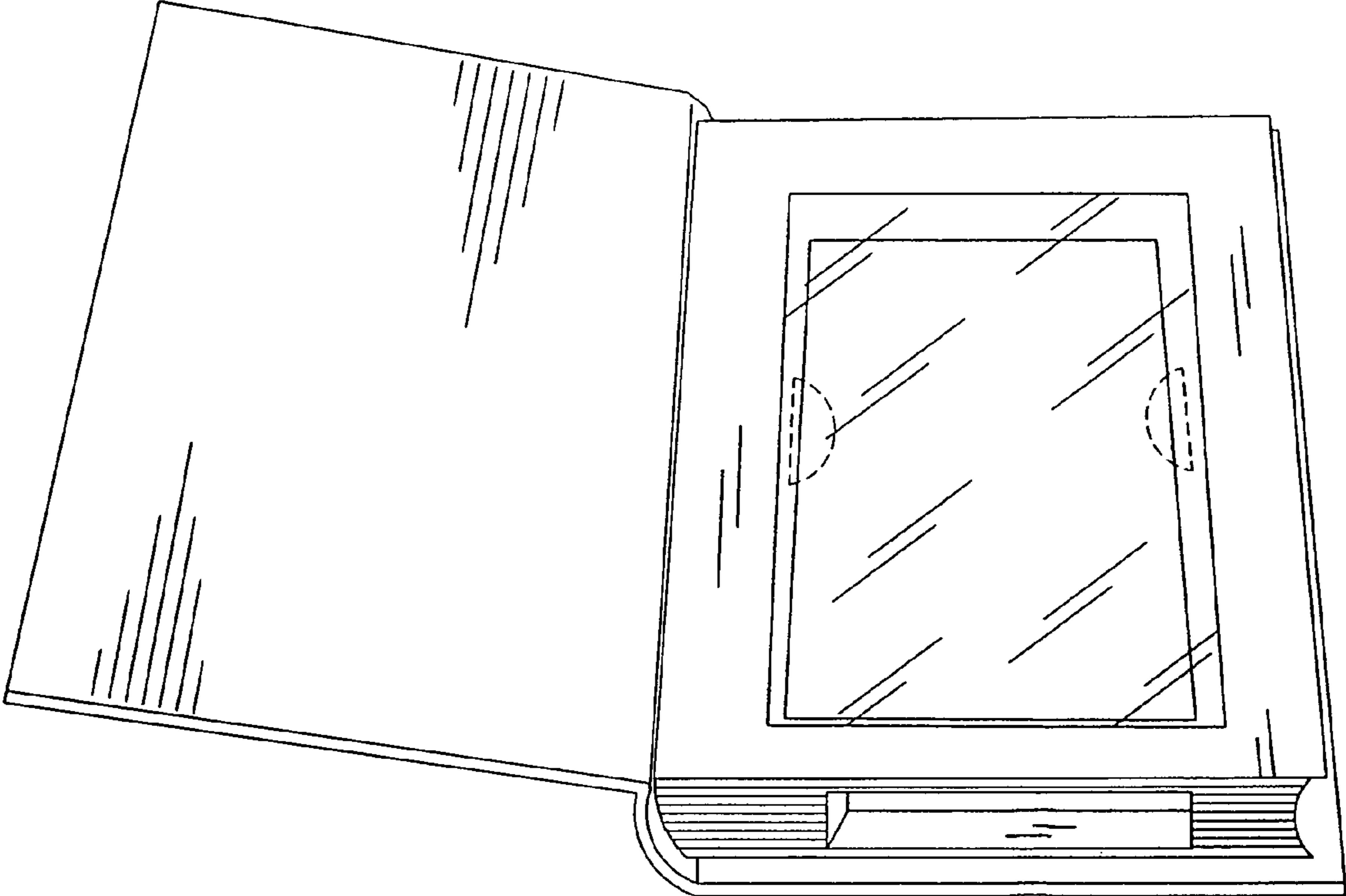
