FIG. 5 is a front view of the versatile and reconfigurable luggage in a closed configuration;

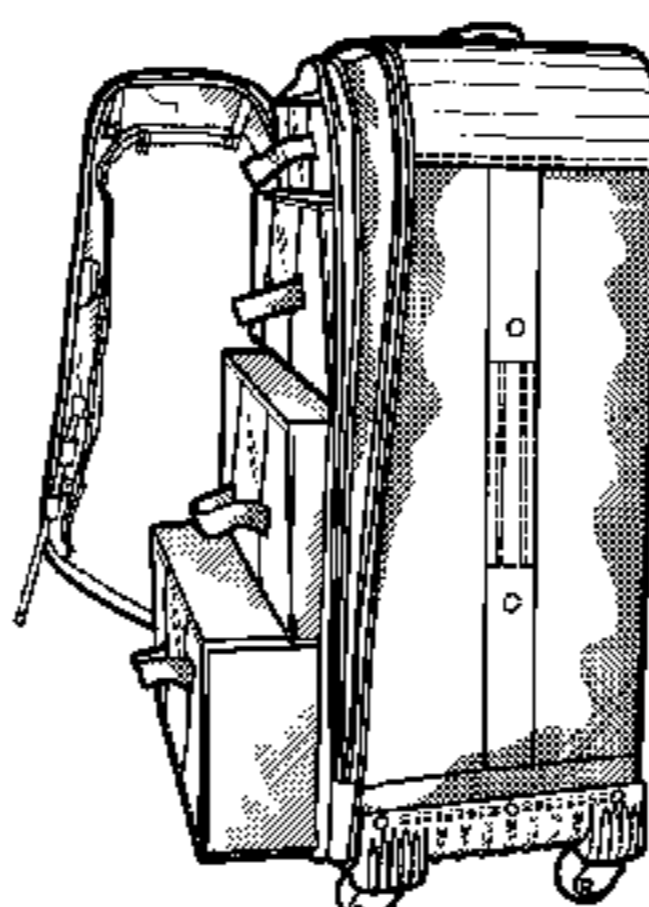
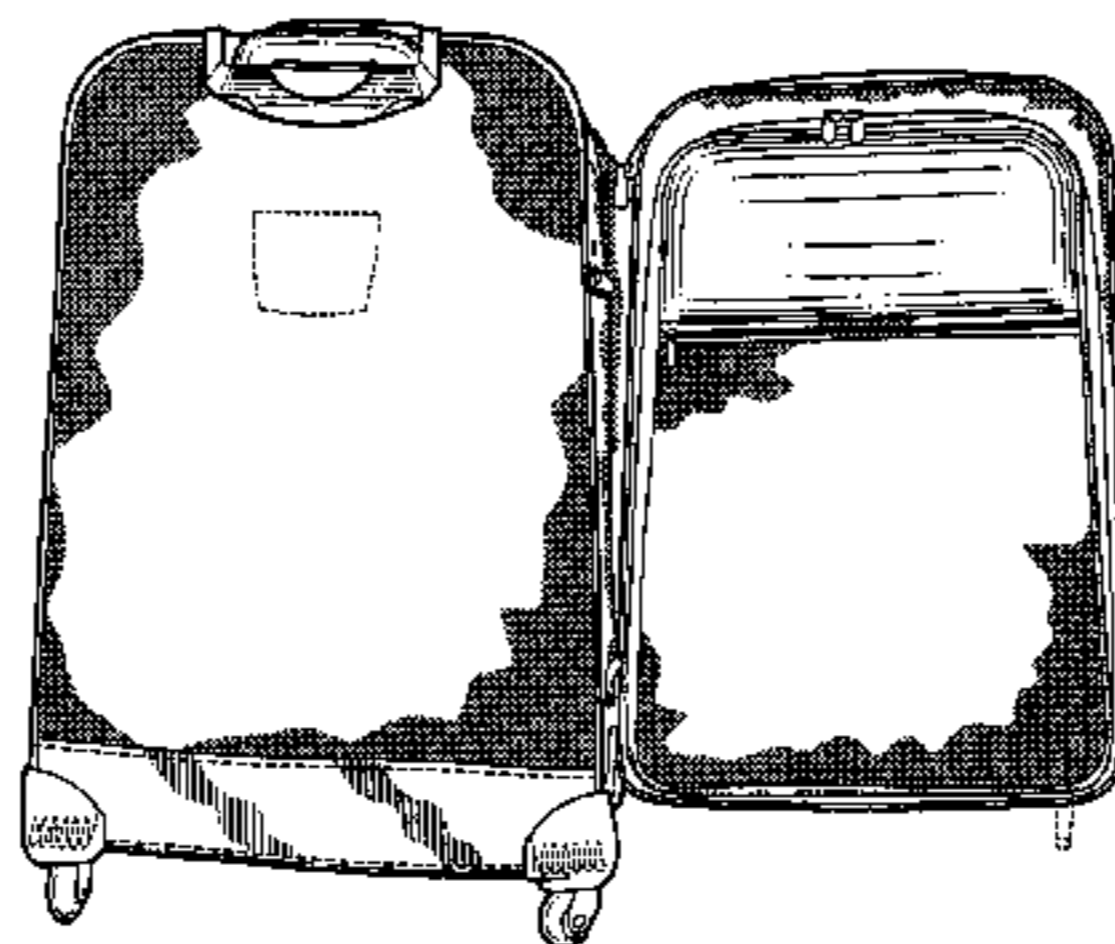
FIG. 6 is a right side view of the versatile and reconfigurable luggage in a closed configuration;

Referring to FIG. 1, the dashed lines located on the left-hand side of the versatile and reconfigurable luggage denote unclaimed subject matter, while the dashed lines on the right-hand side thereof represent stitching. Referring to FIGS. 2–4 and 6–8, the smaller dashed lines represent unclaimed subject matter, while the larger dashed lines represent stitching. The dashed lines denoting unclaimed subject matter are directed to environment.

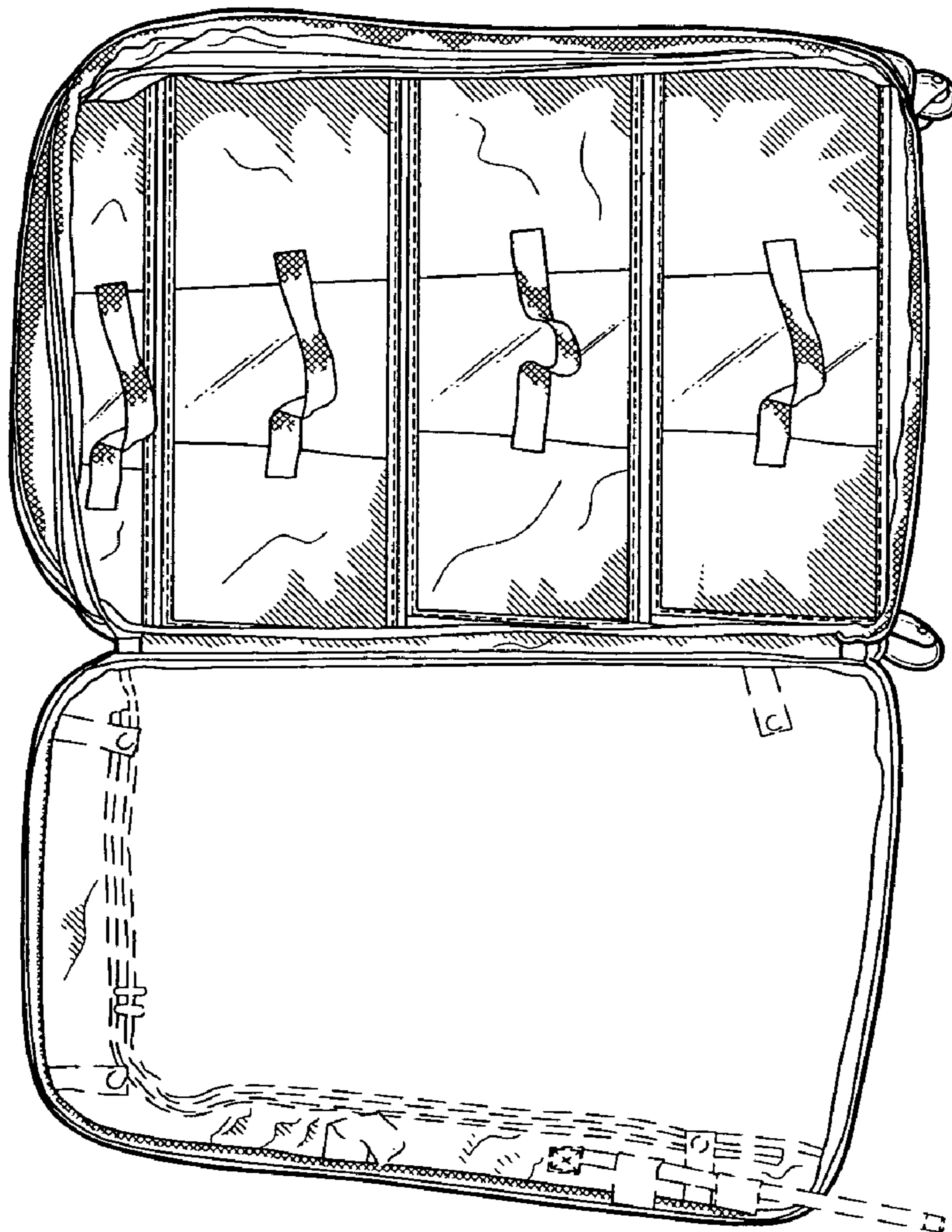

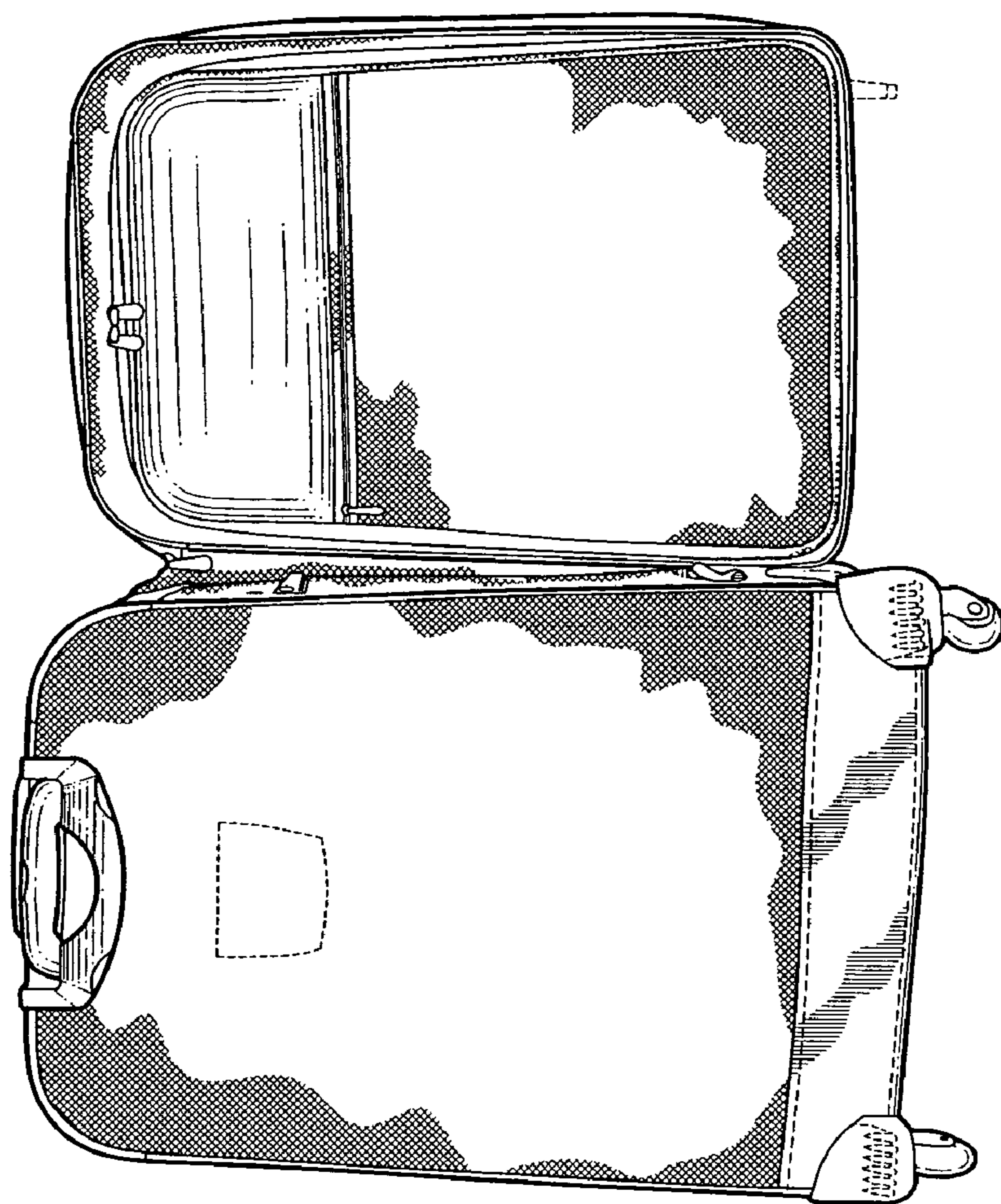

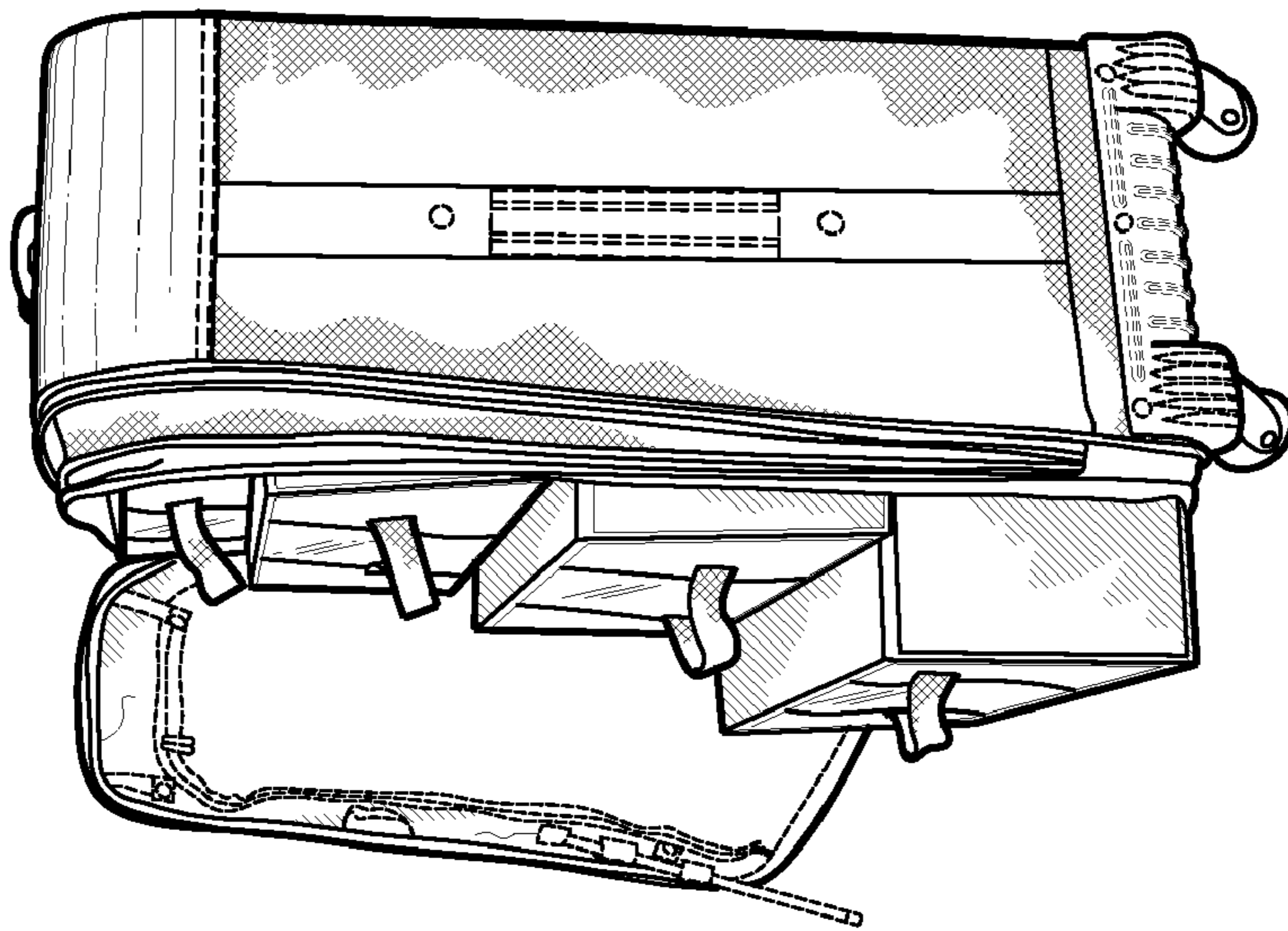

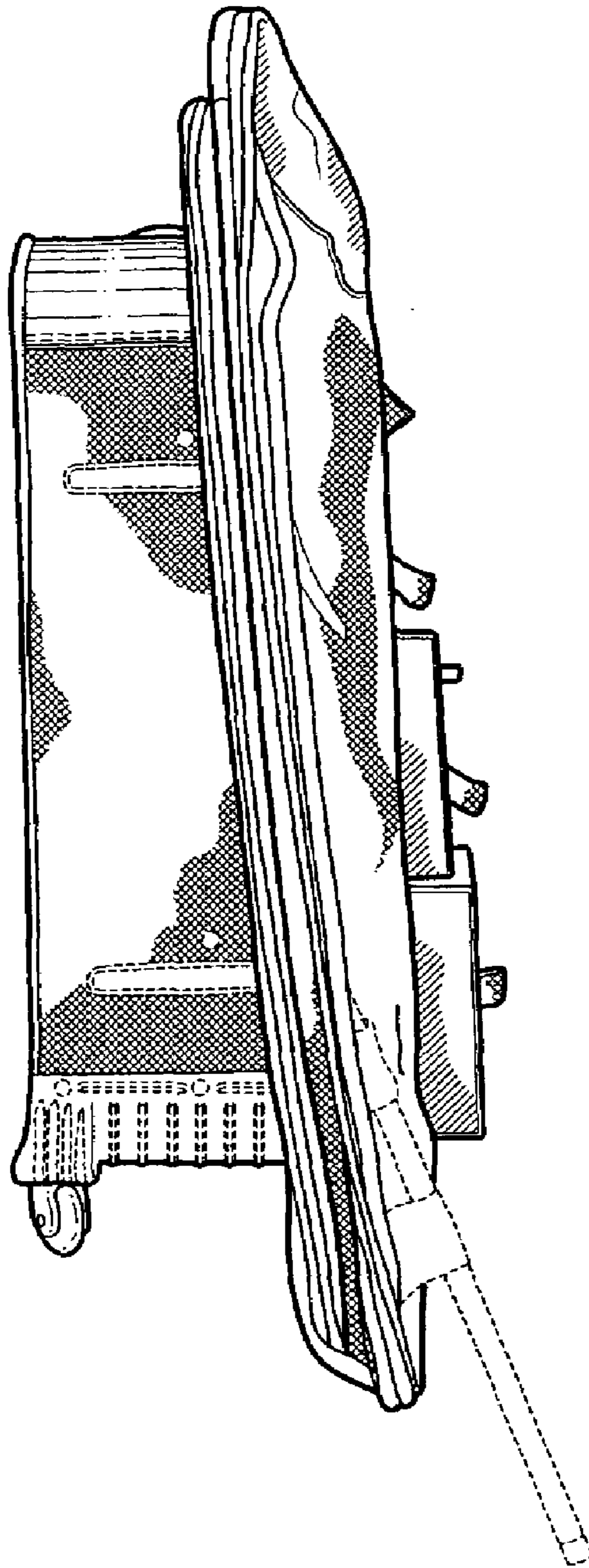

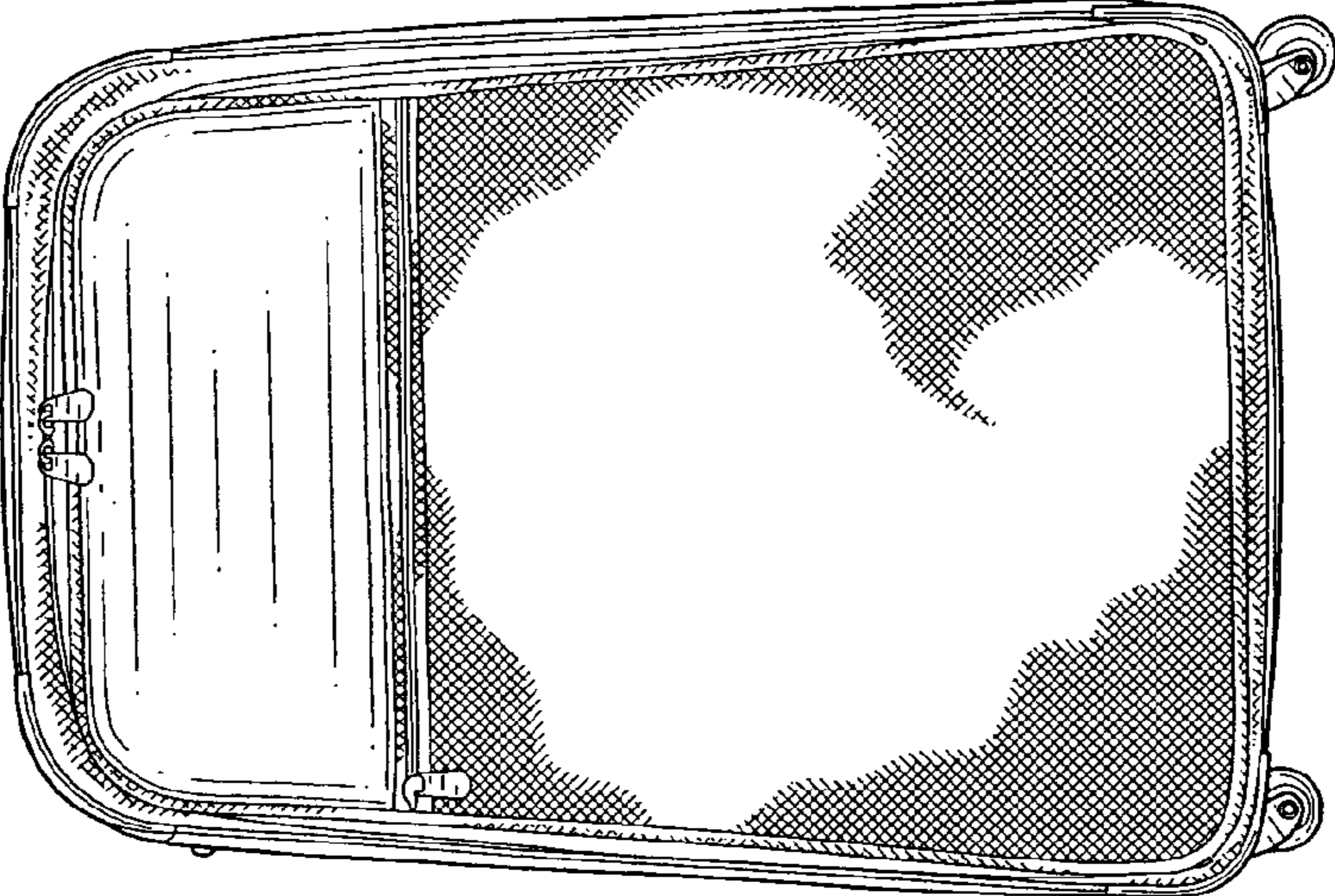

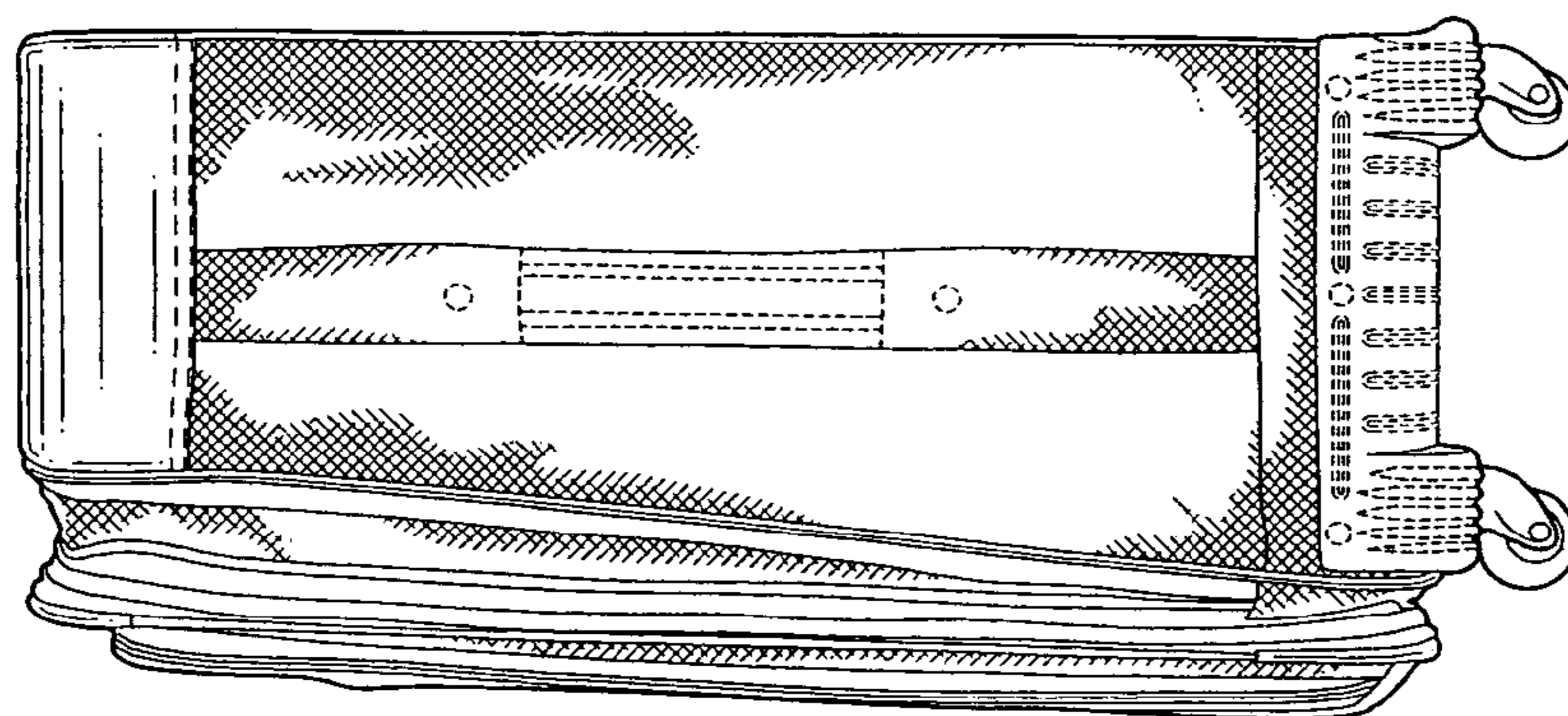

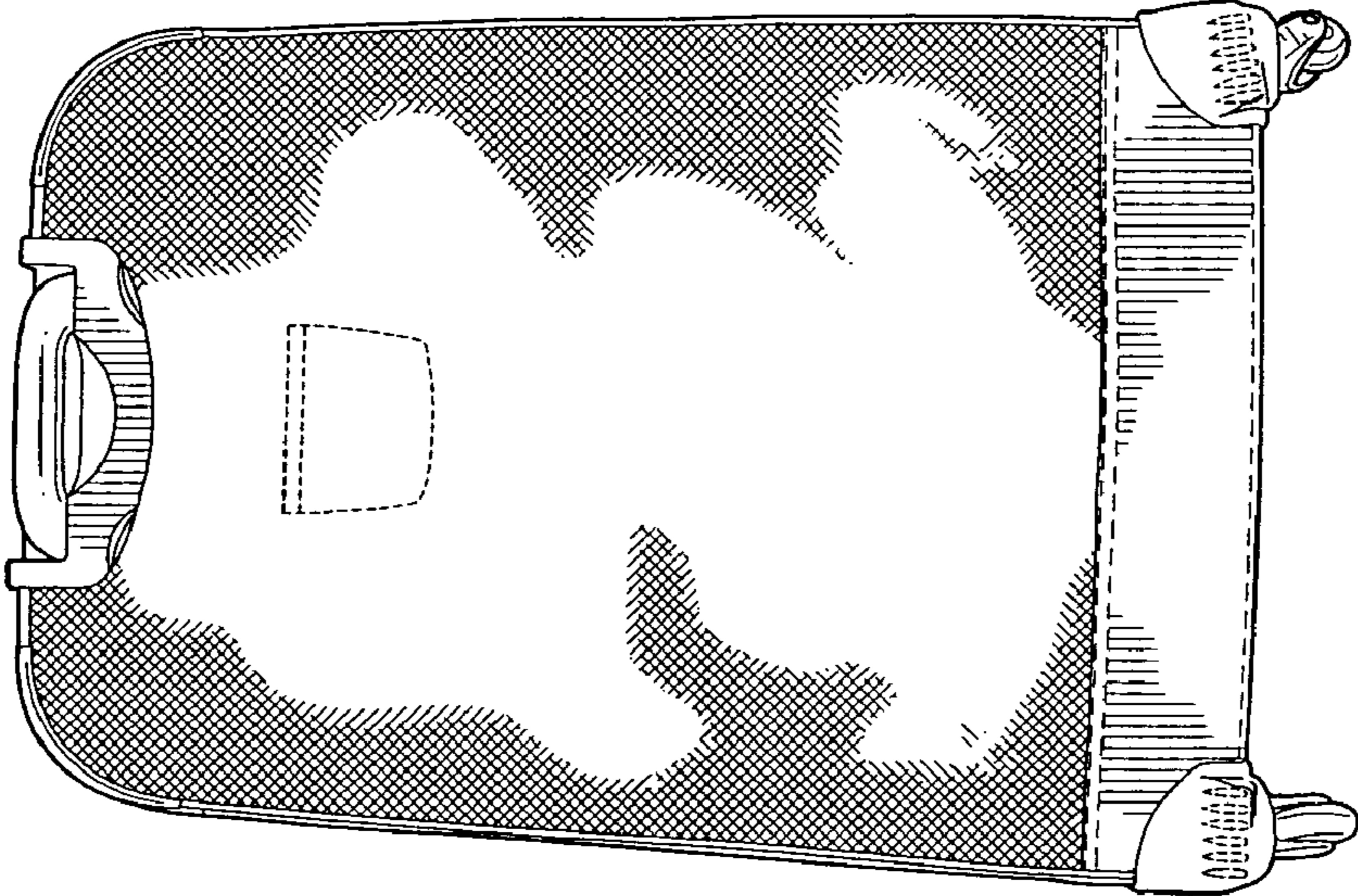

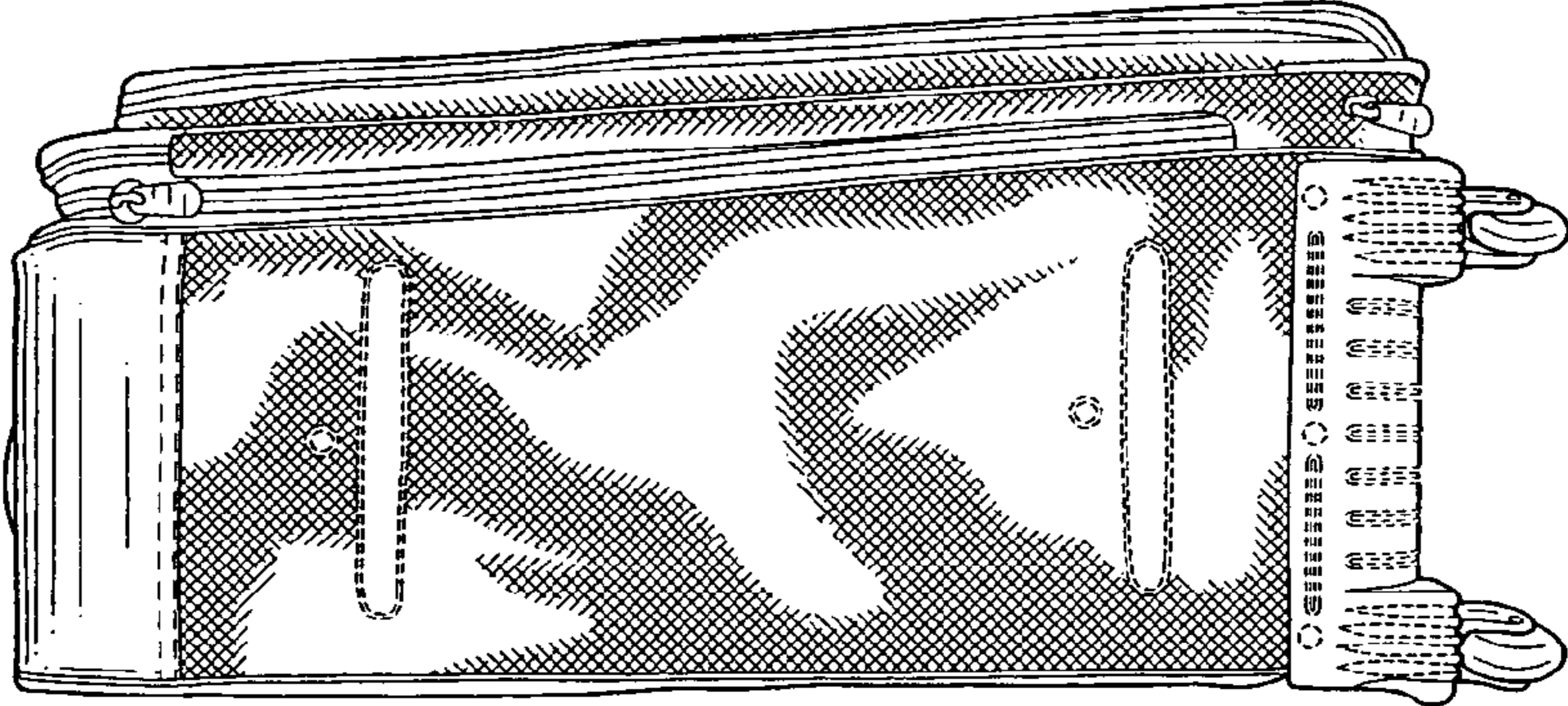
