handbag shown in FIG. 1;

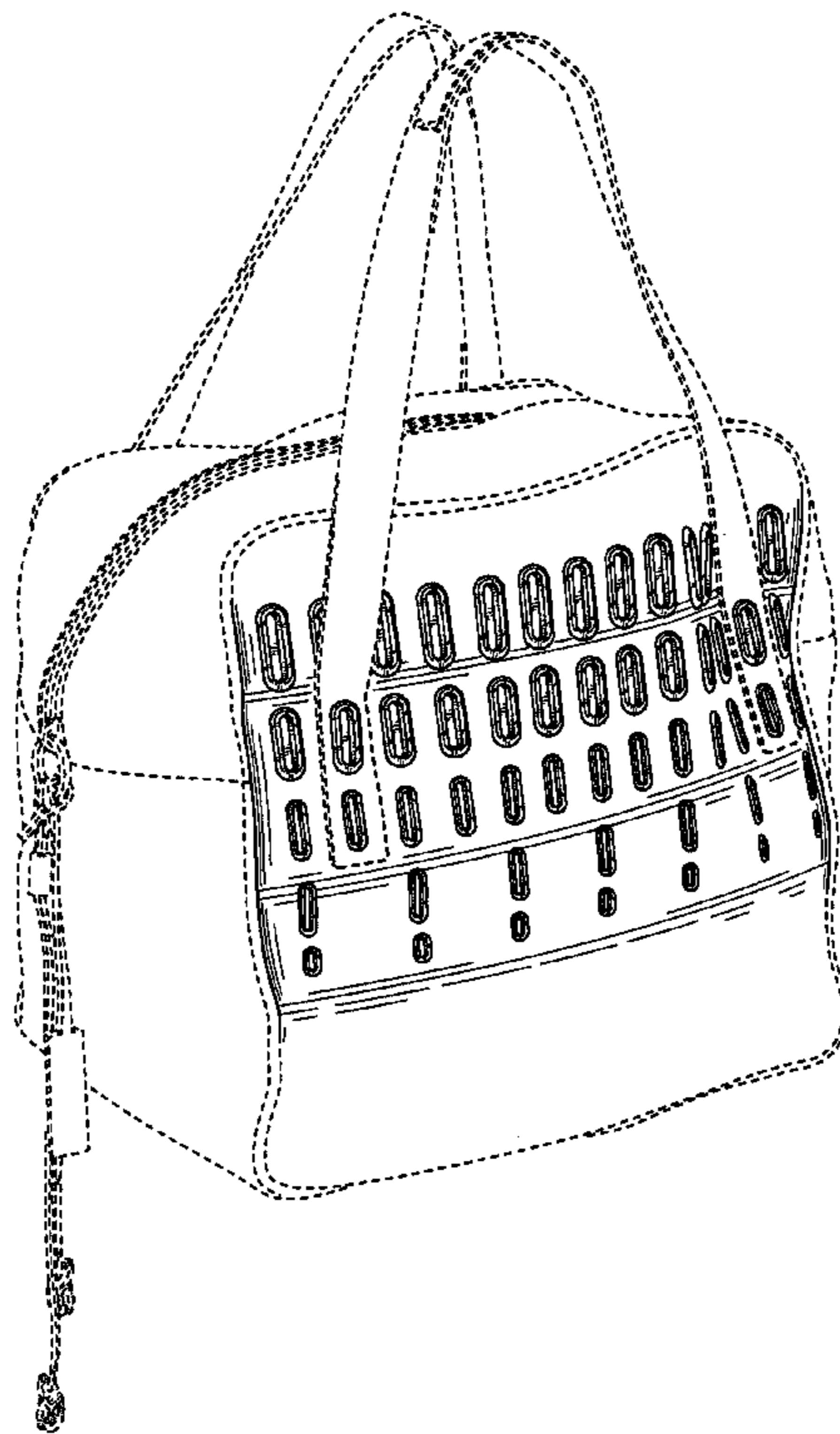
FIG. 4 is a right side view of the alternative embodiment of the  
handbag shown in FIG. 1;

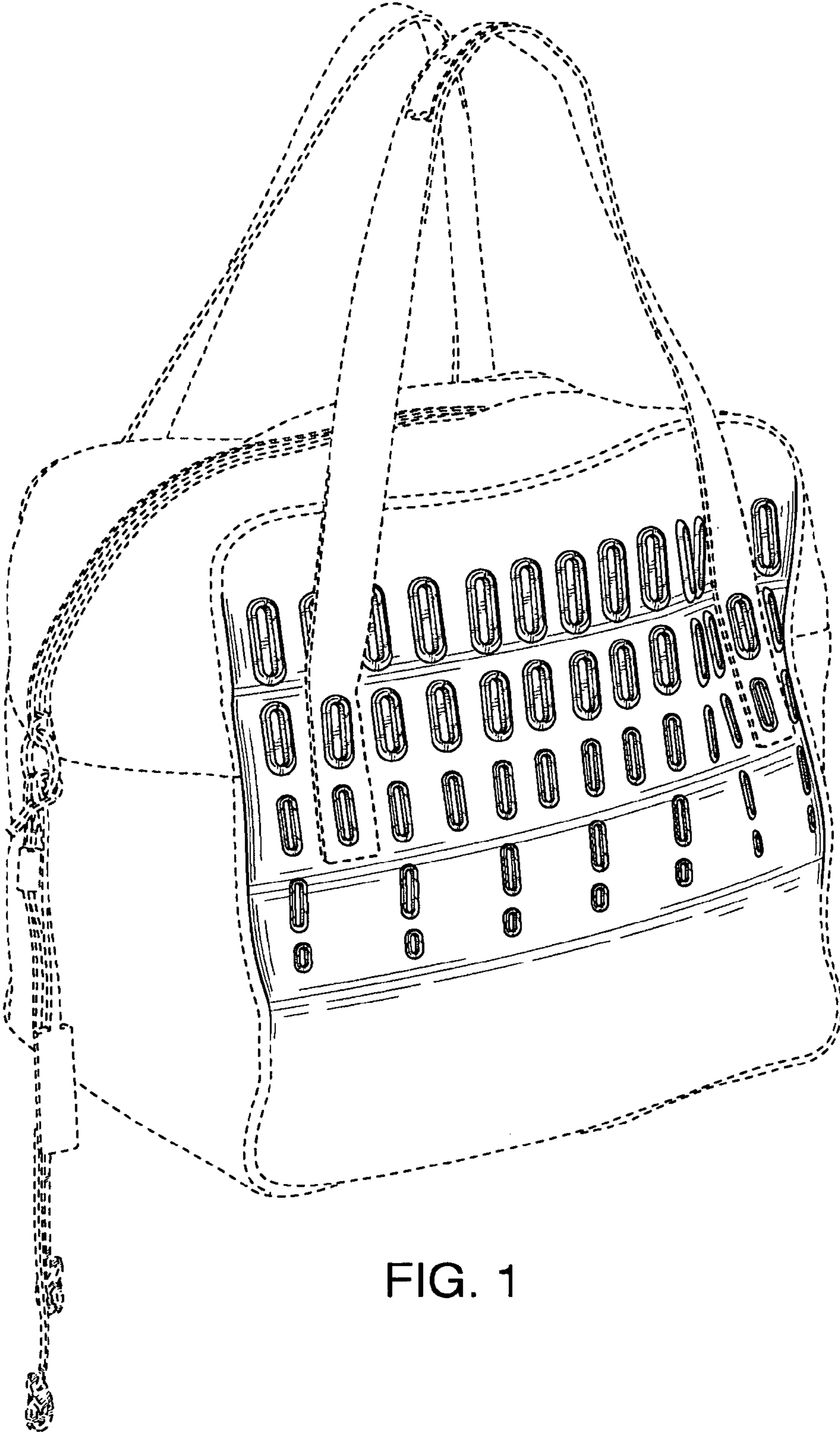
FIG. 5 is a top view of the alternative embodiment of the

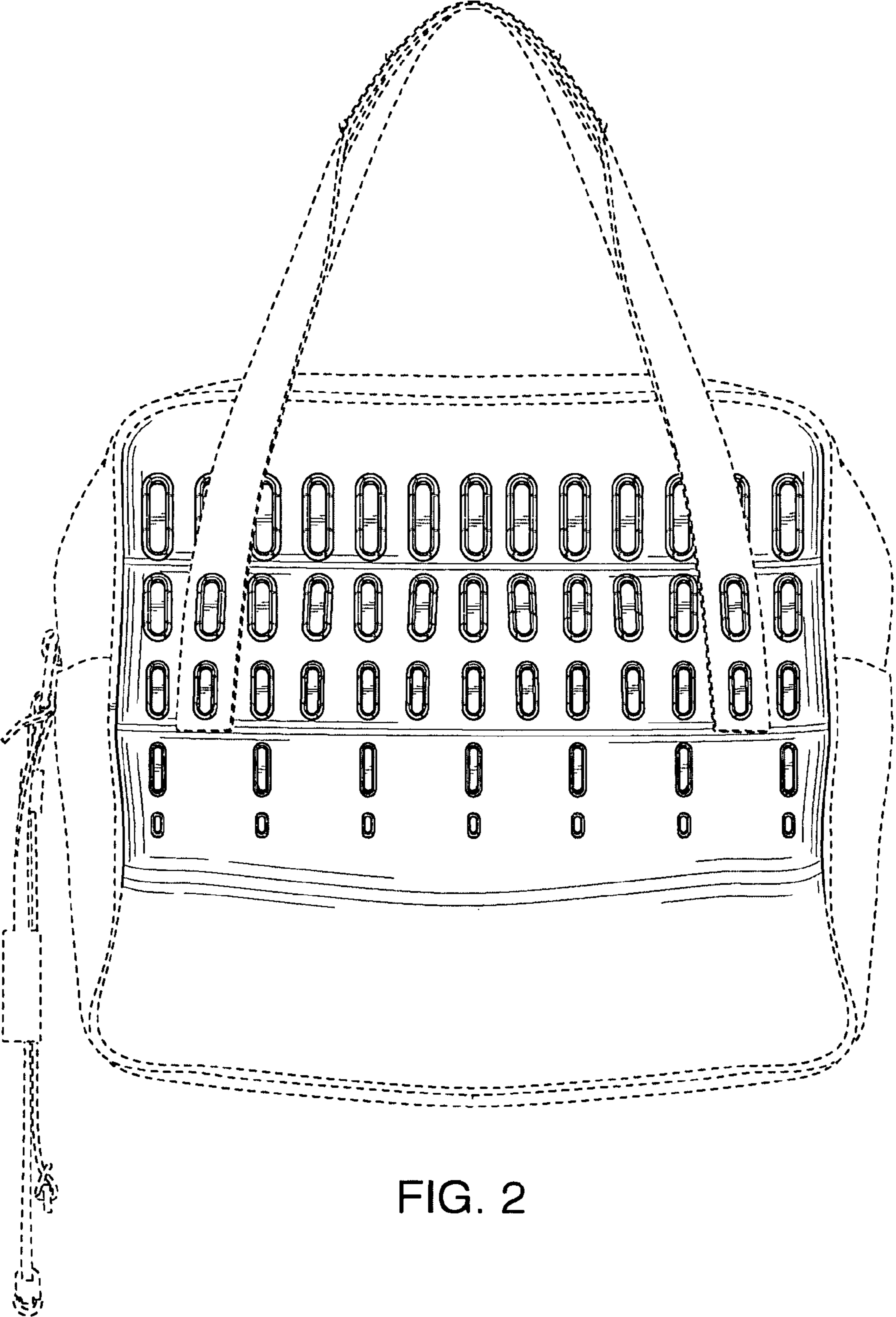

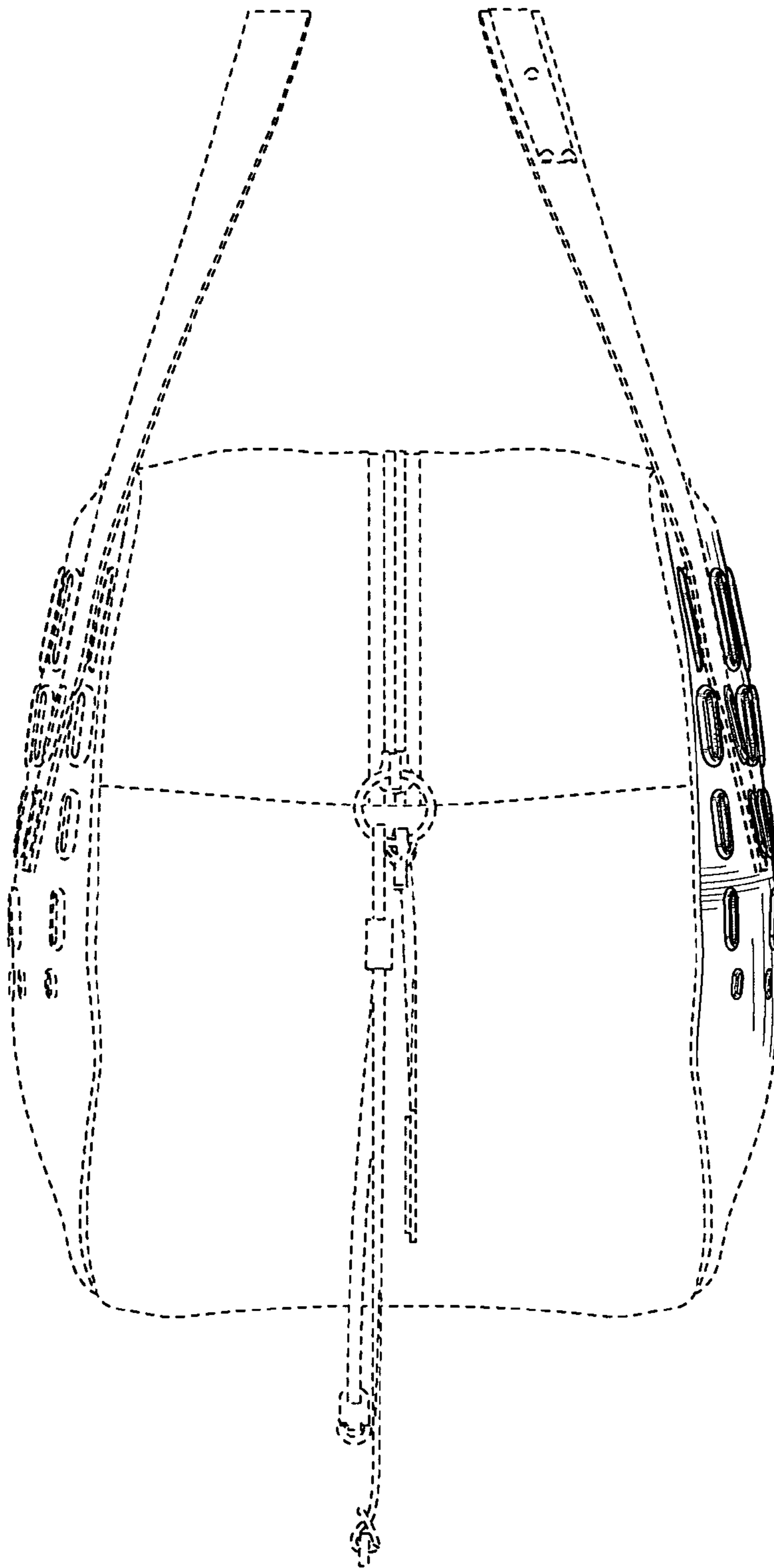

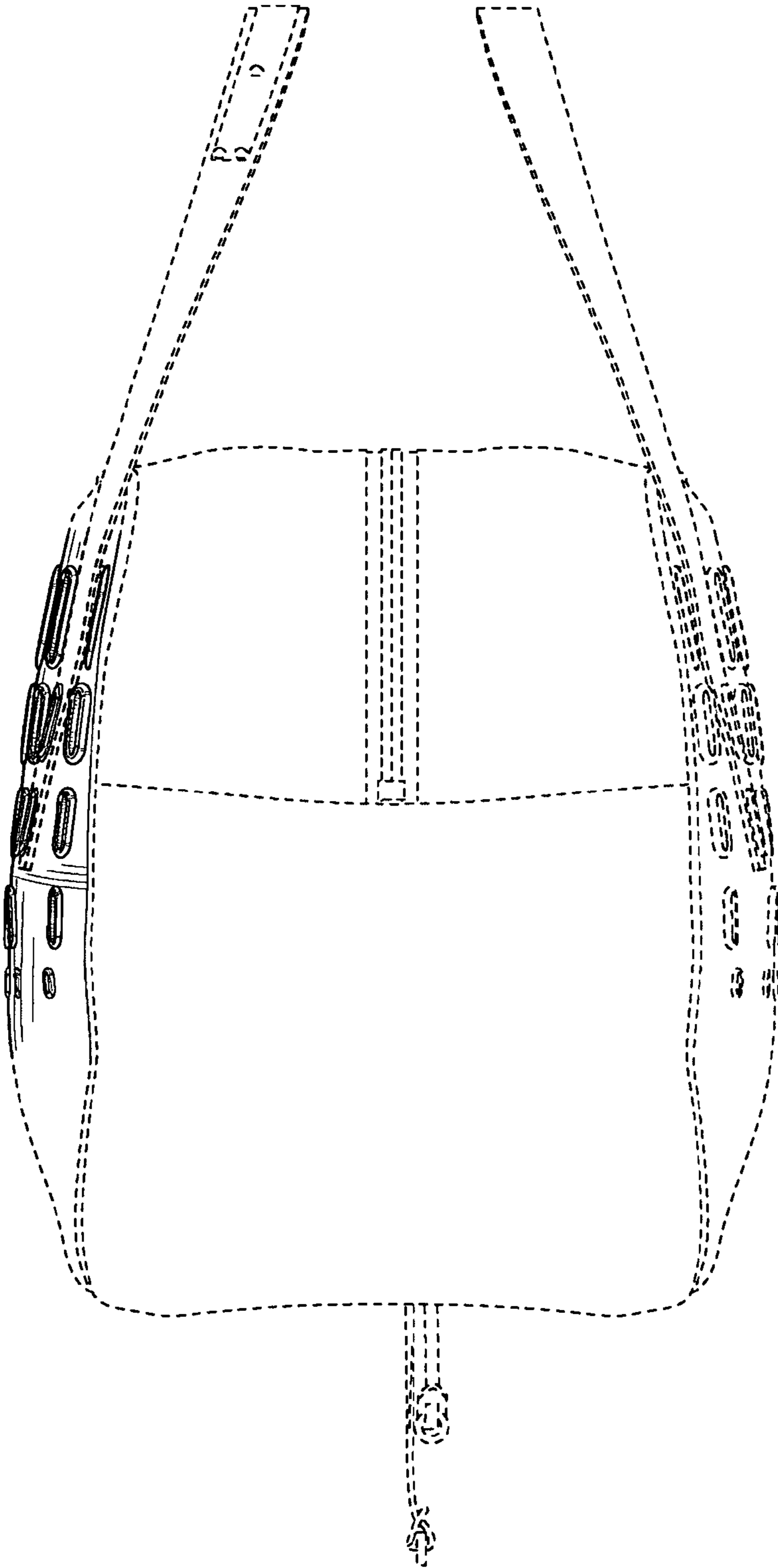

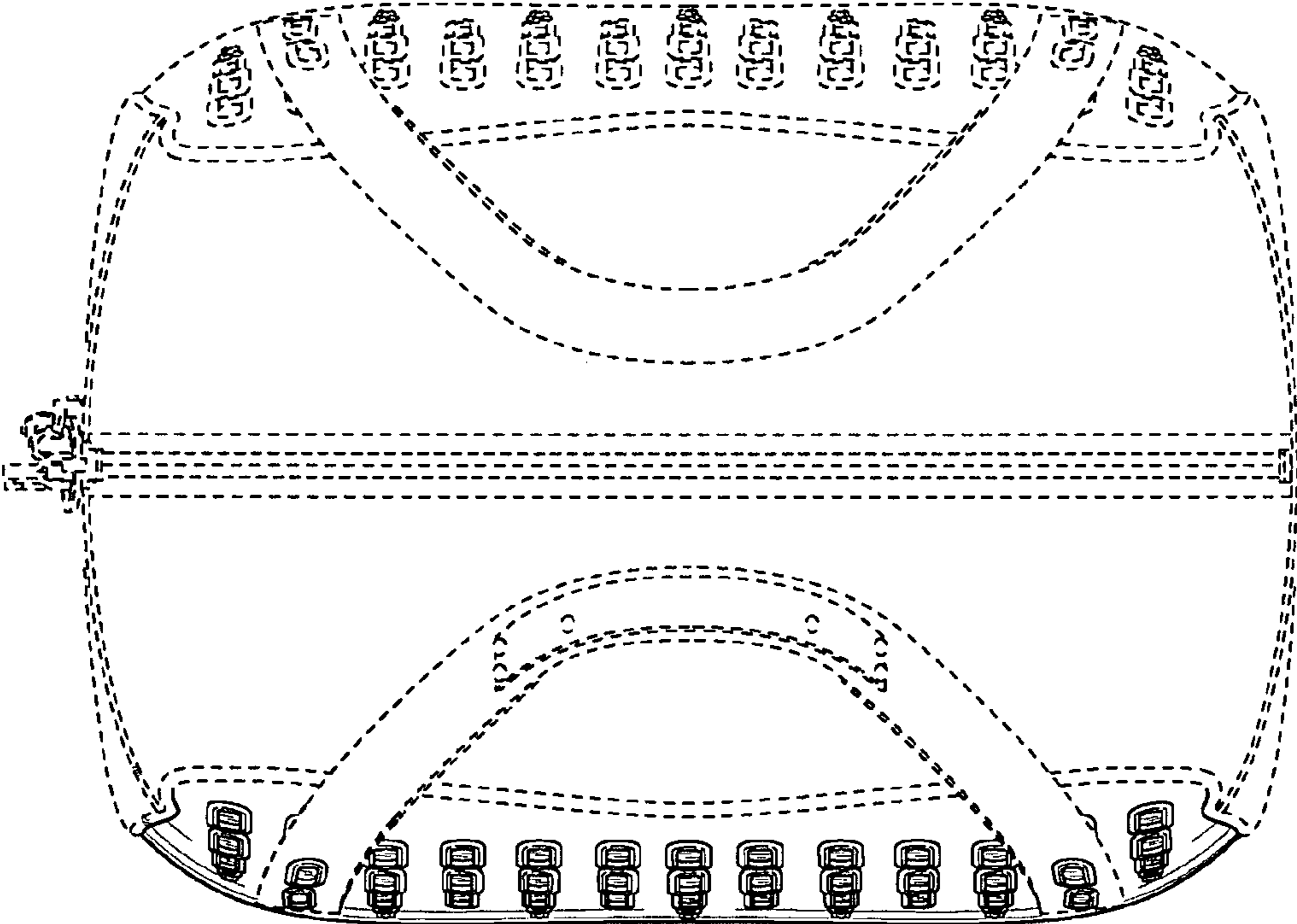

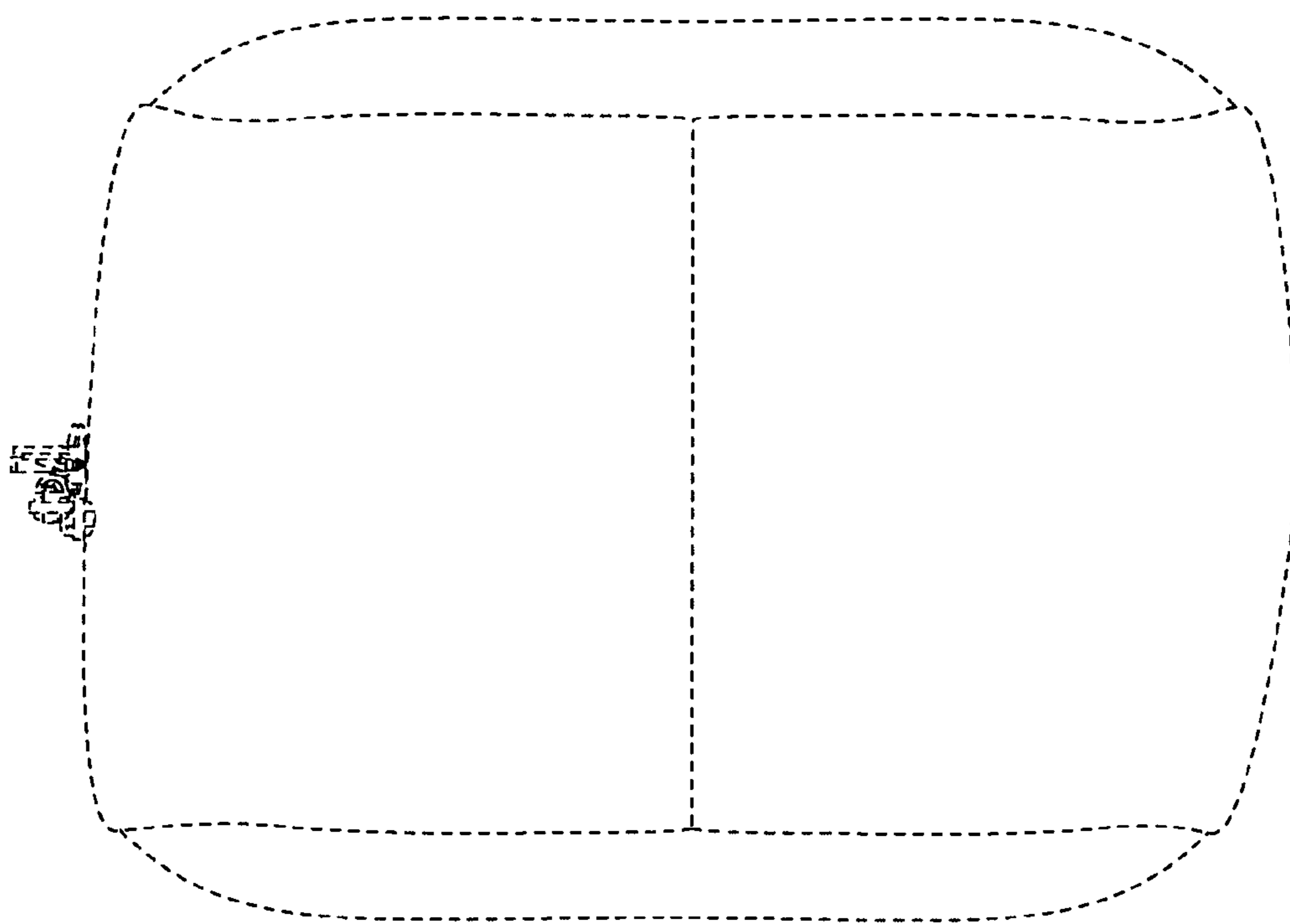
