# (57) CLAIM

The ornamental design for a modular lounge, as shown and described.

#### **DESCRIPTION**

FIG. 1 is a side, right upper perspective view of a section of a modular lounge embodying my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a side, right upper perspective of another section of a modular lounge embodying my new design, the top view being identical to the view shown in FIG. 2;

FIG. 7 is a front elevational view thereof;


FIG. 8 is a rear elevational view thereof; and,


FIG. 9 is a right side elevational view thereof.


The broken line representations of support legs in FIGS. 1 and 3–5 form no part of the claimed design.












