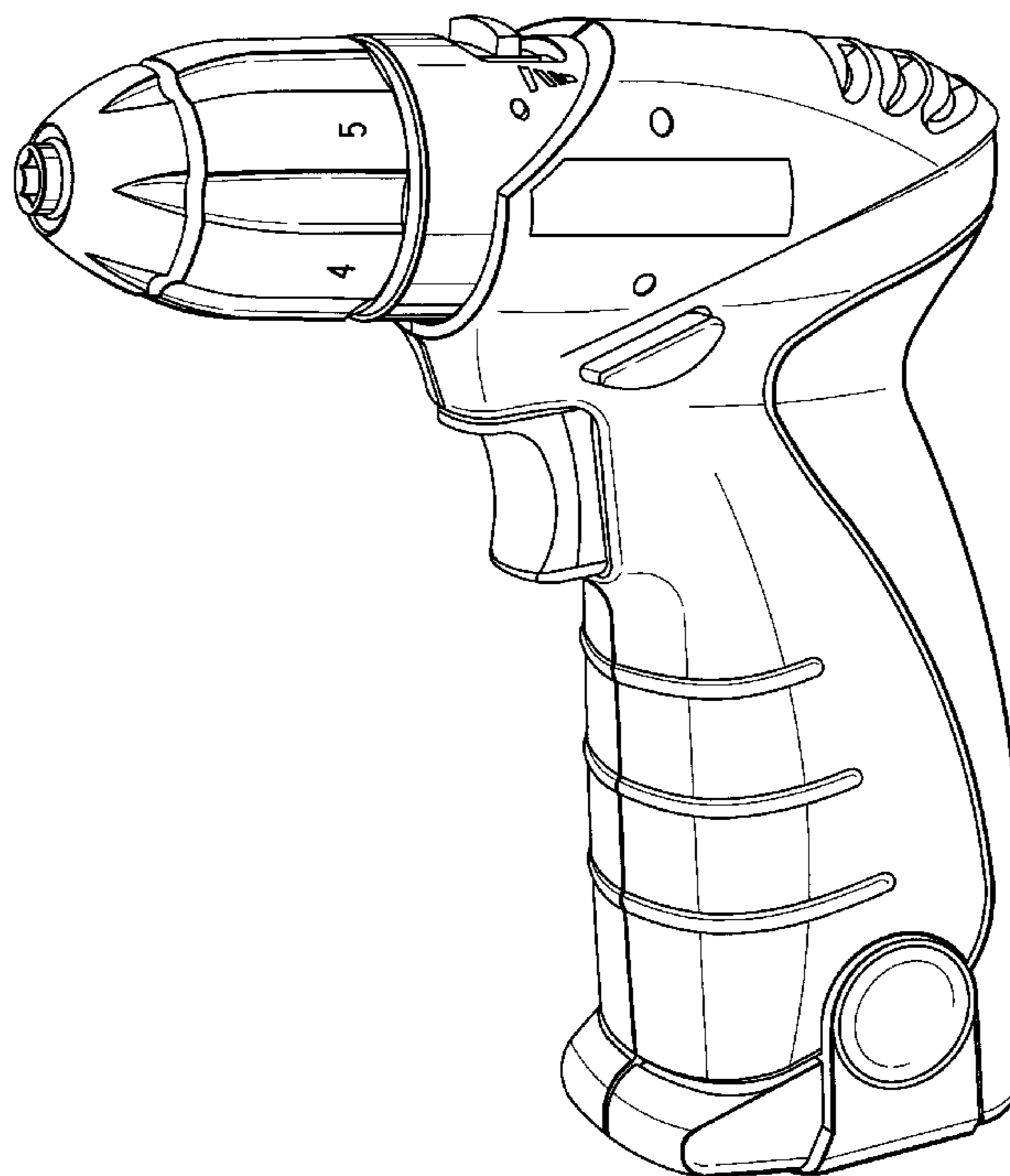
(57) **CLAIM**

DESCRIPTION

FIG. 1 shows a front and left side perspective view of the cordless screwdriver in accordance with the invention;
FIG. 2 shows a left side perspective view of the cordless screwdriver in accordance with the invention;

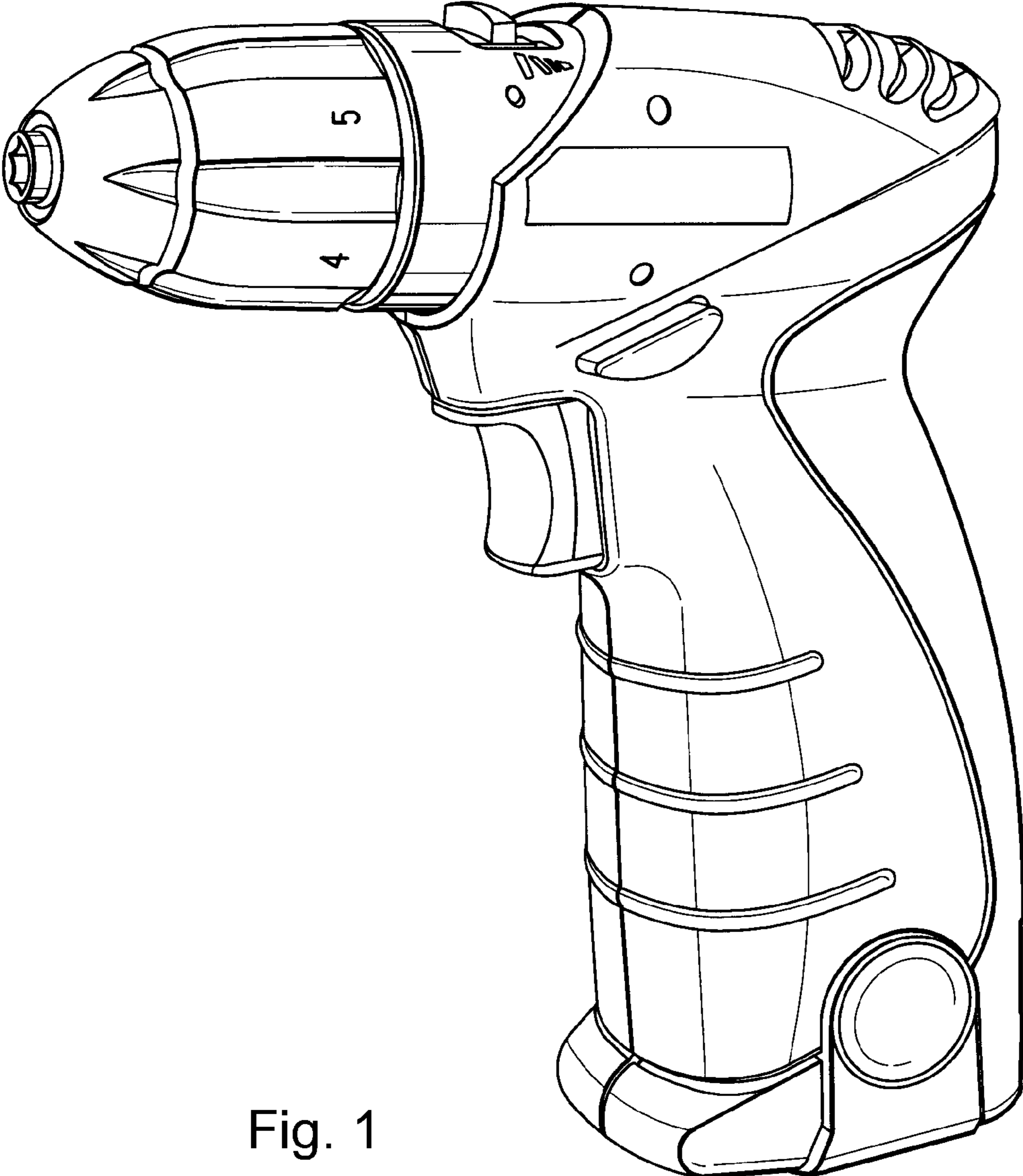

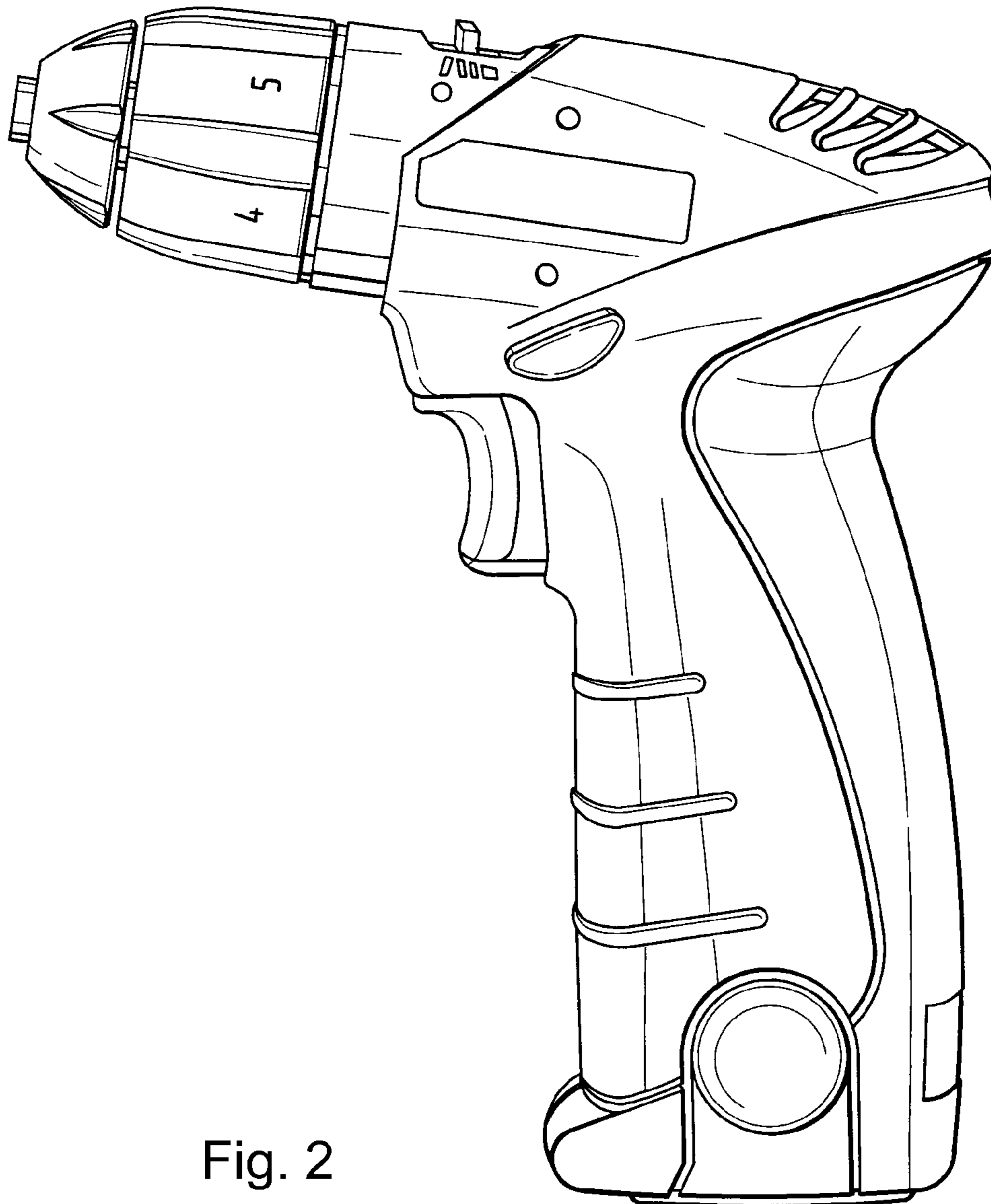

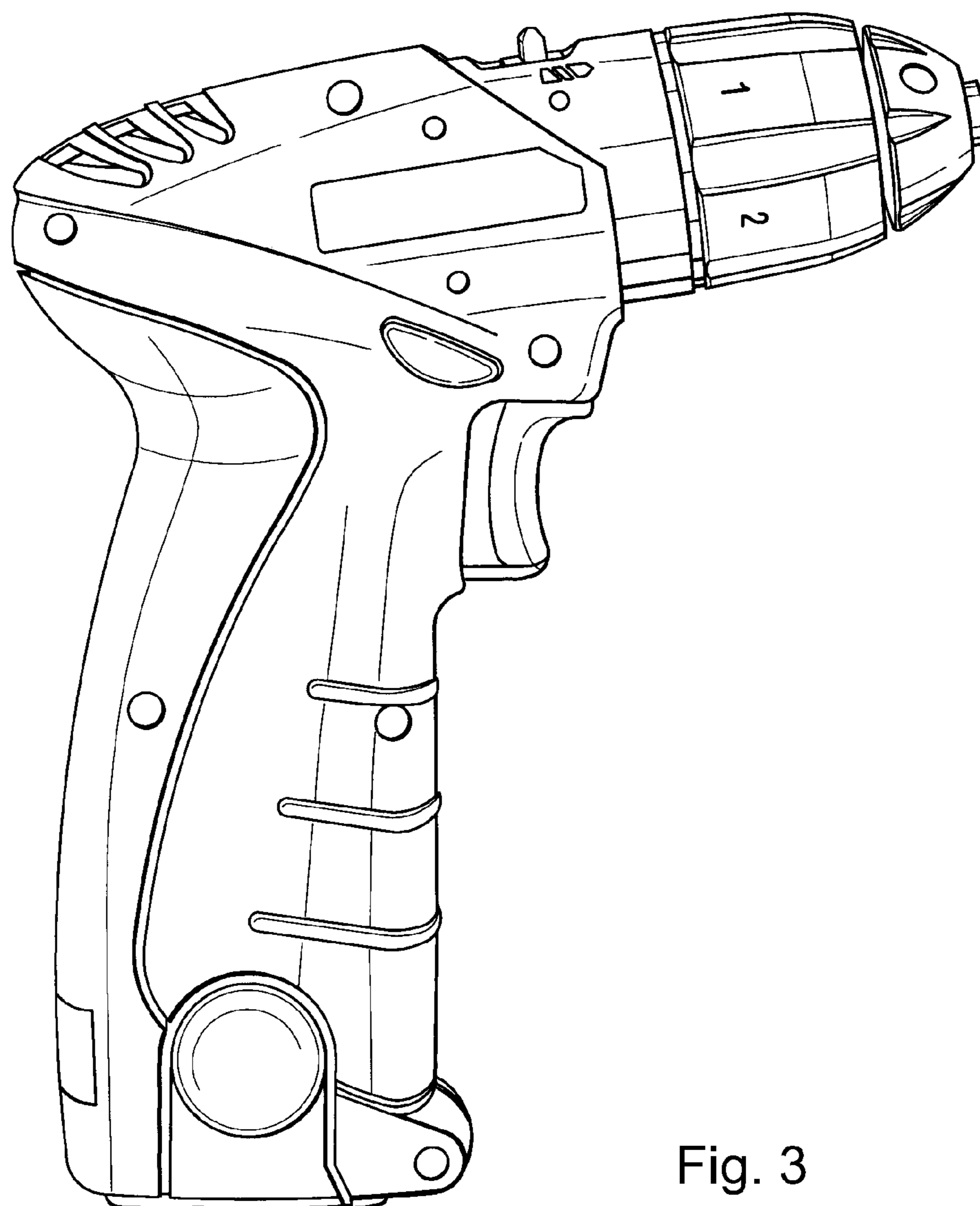

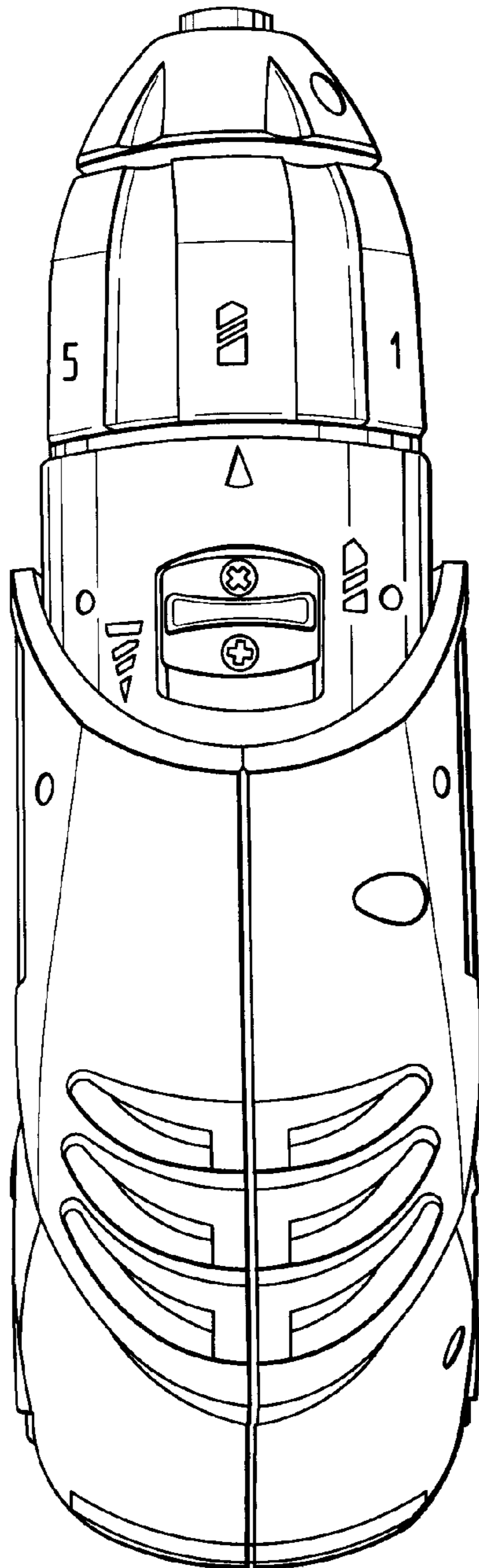

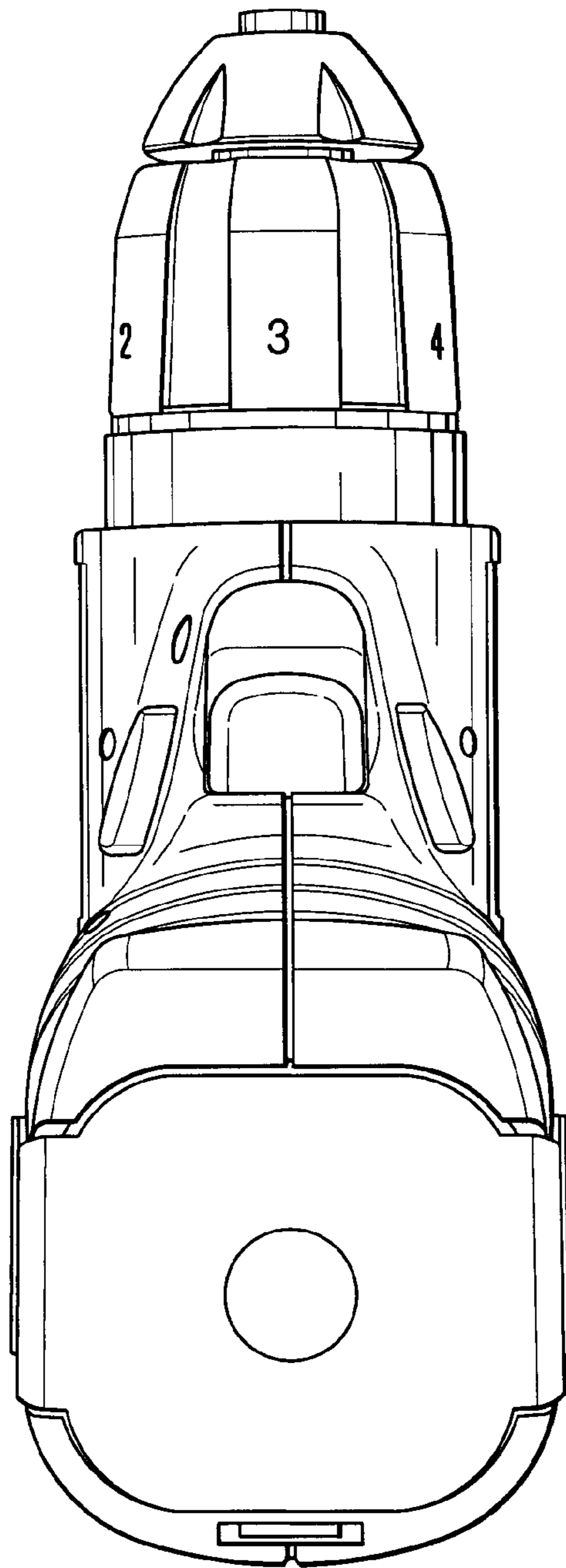

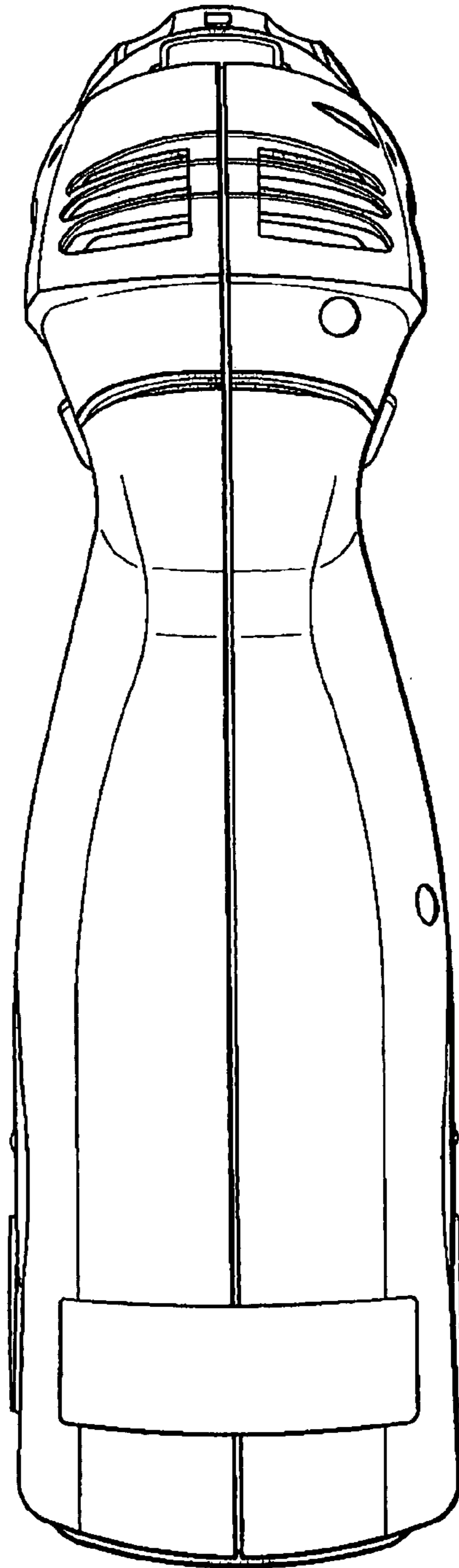

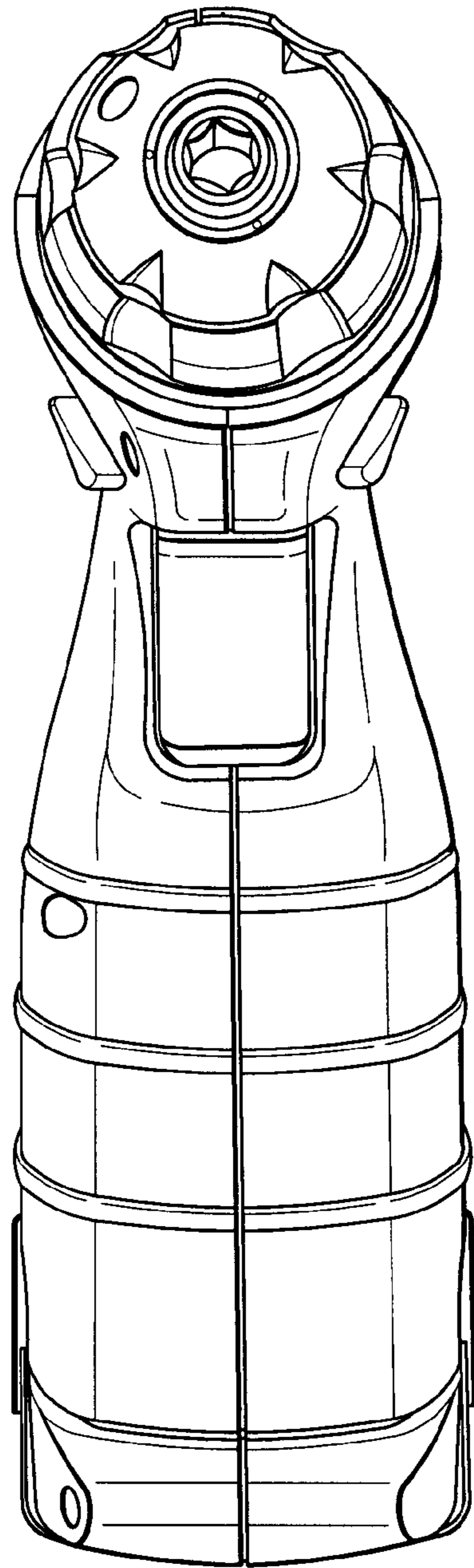
