(57) **CLAIM**

We claim the ornamental design for a door handle back plate, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the front side of the door handle back plate.

FIG. 2 is a perspective view taken from the rear thereof.

FIG. 3 is an end elevational view taken from the right of FIG. 1.

FIG. 4 is an end elevational view taken from the left of FIG. 1.

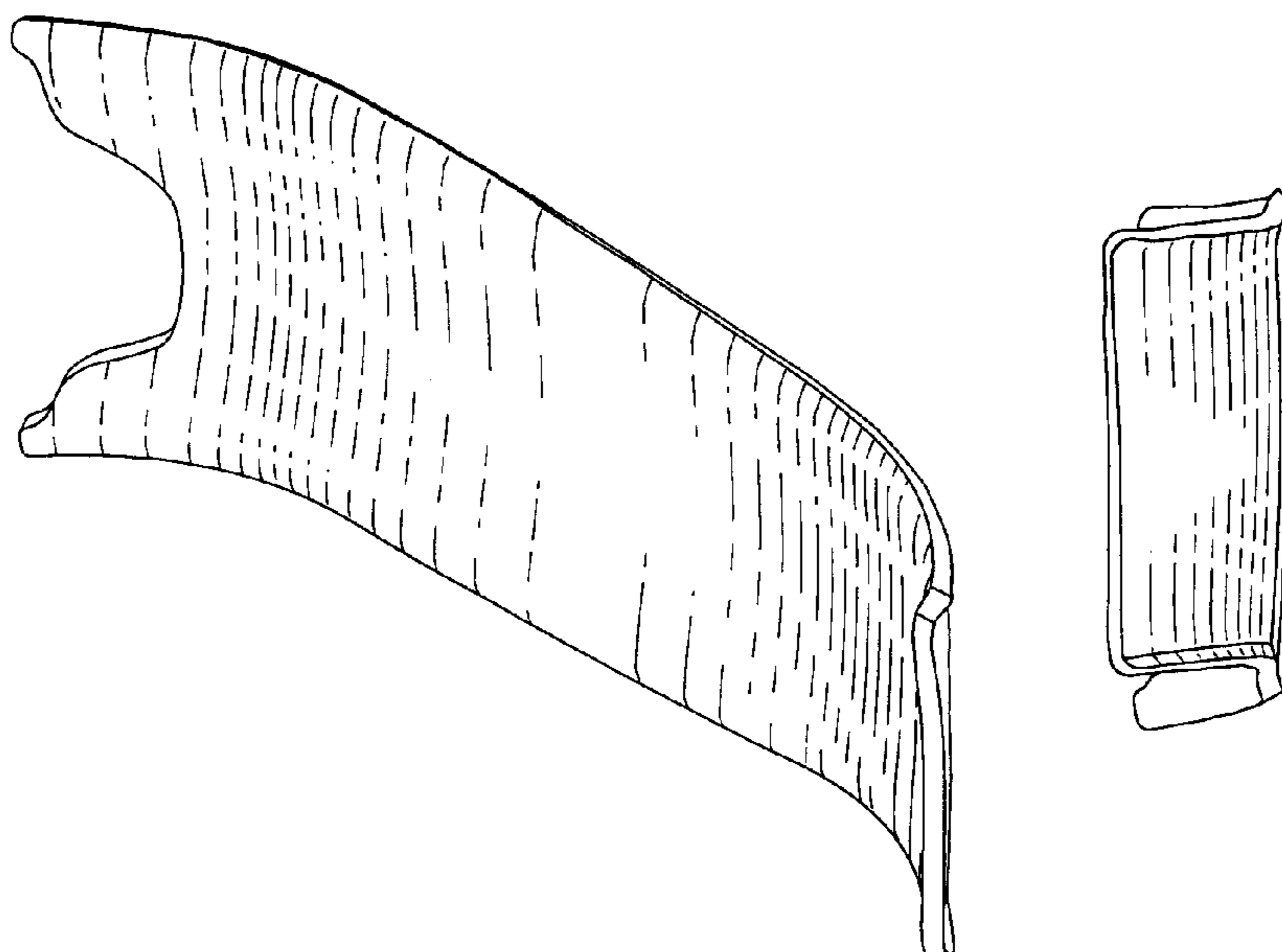
FIG. 5 is a front elevational view thereof.

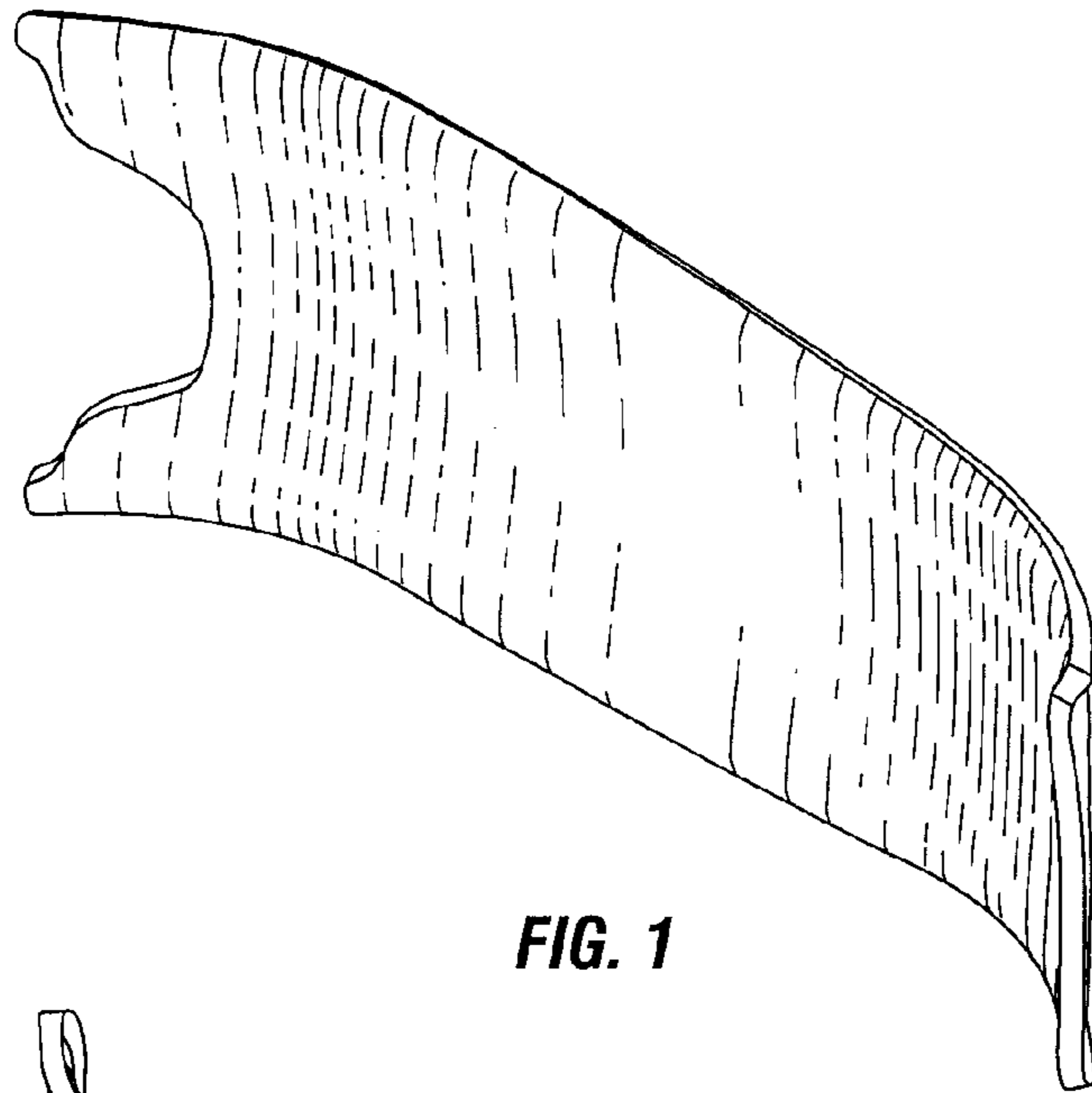
FIG. 6 is a rear elevational view thereof.

FIG. 7 is a top plan view of the device shown in FIG. 1; and,

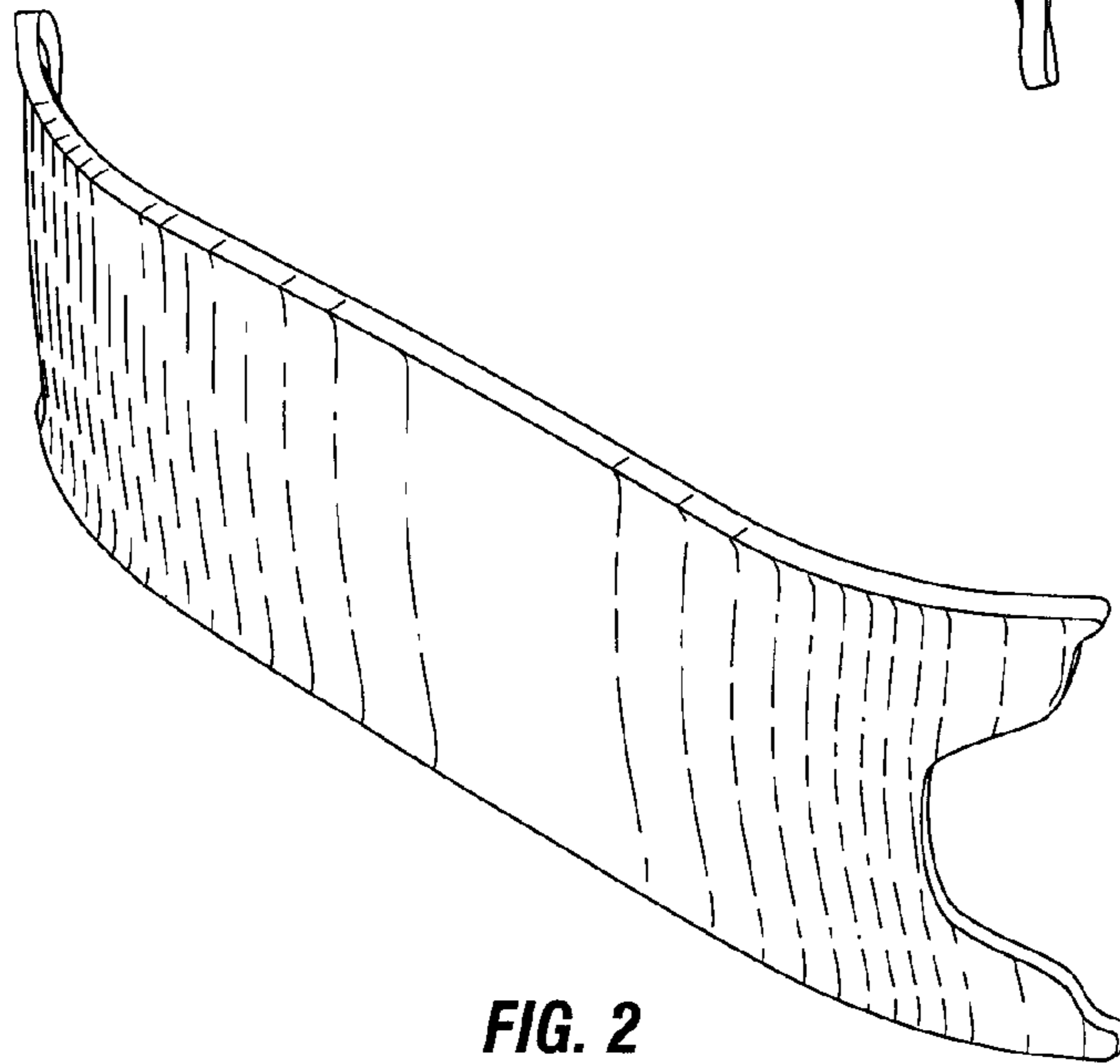
FIG. 8 is a bottom plan view of the device shown in FIG. 2.

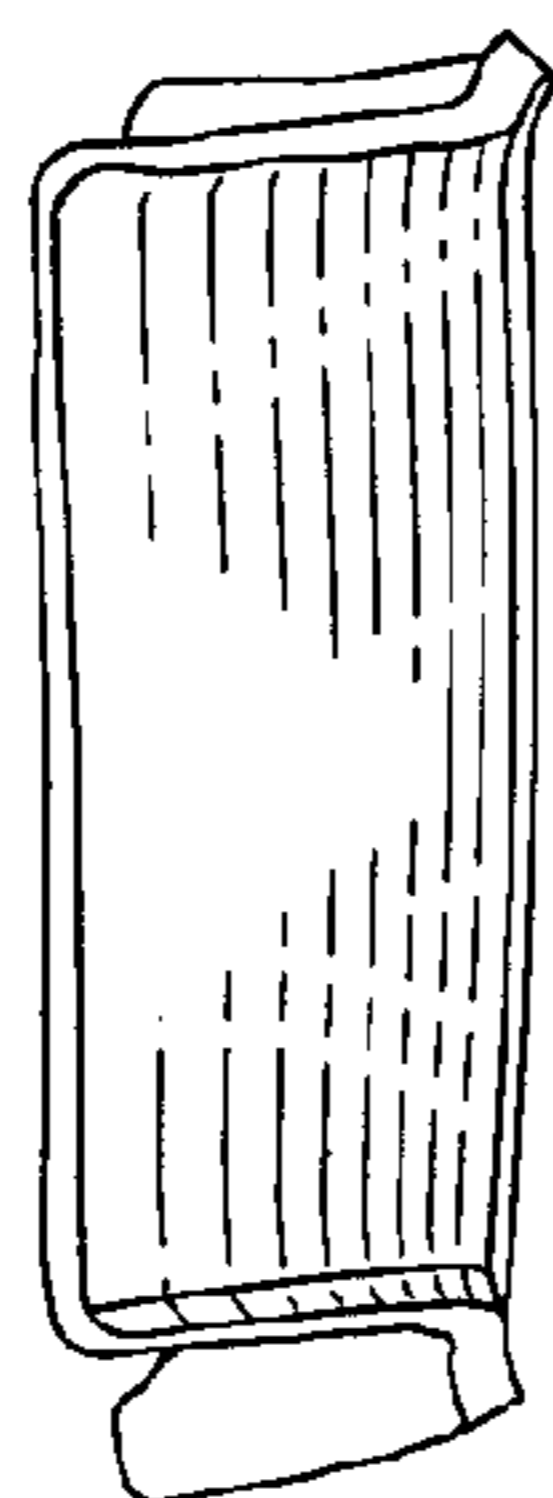




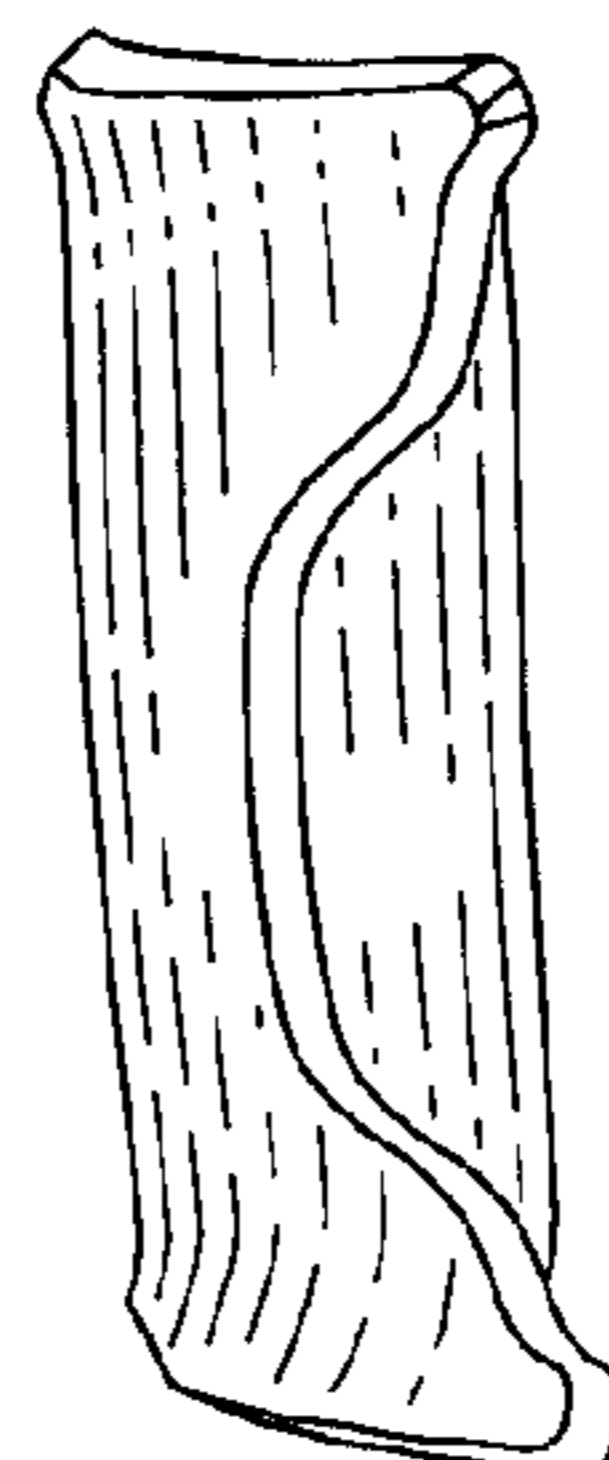

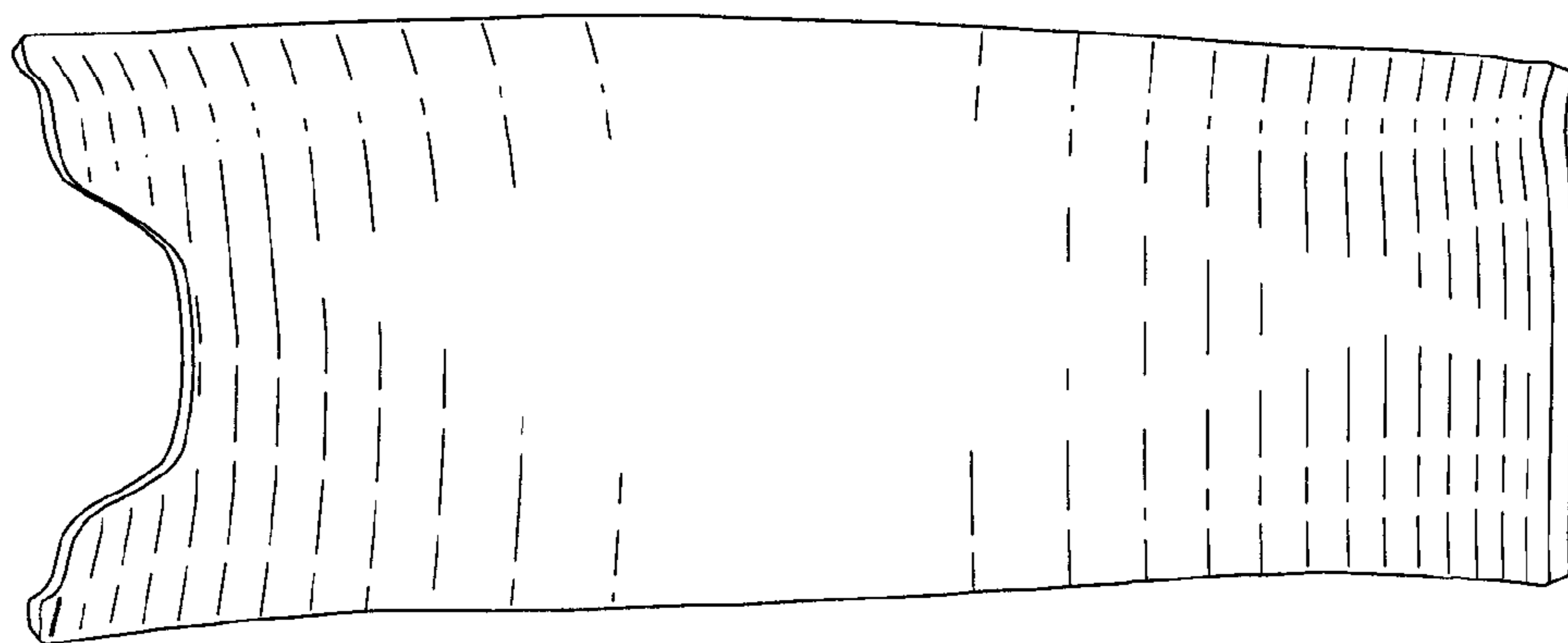

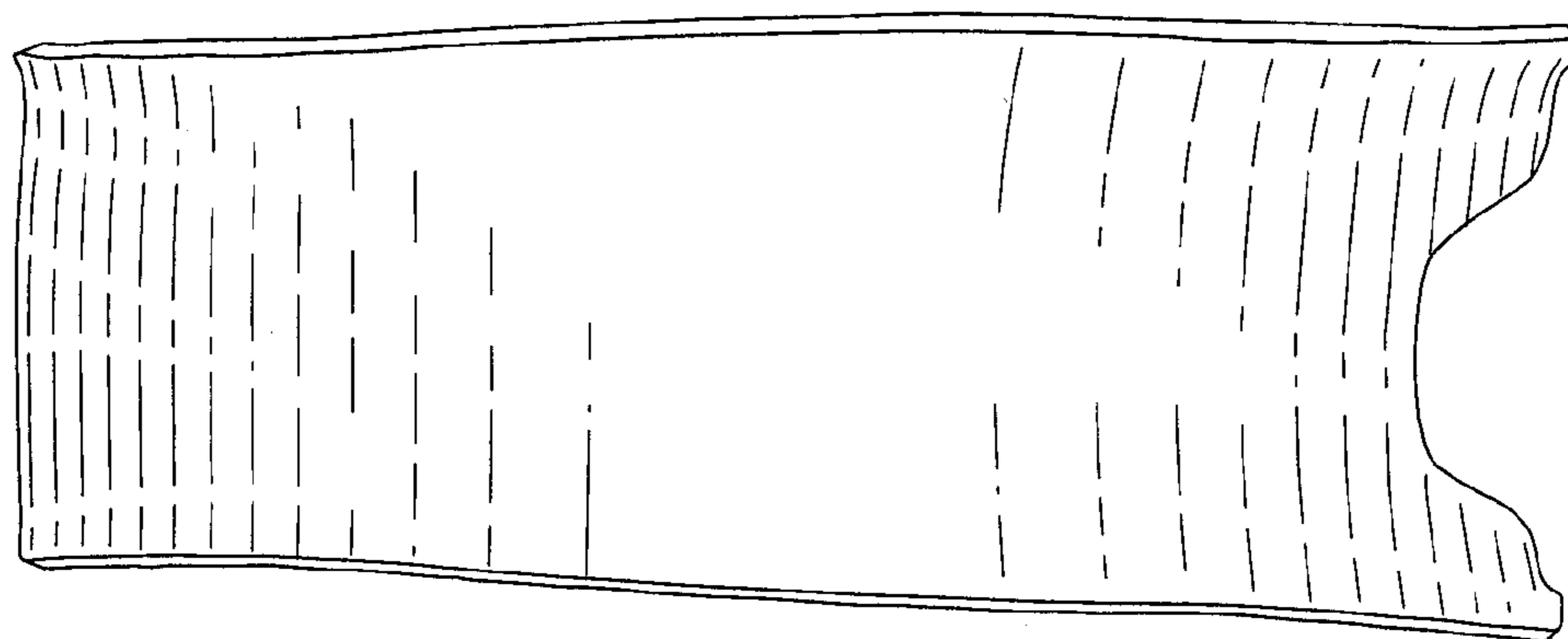

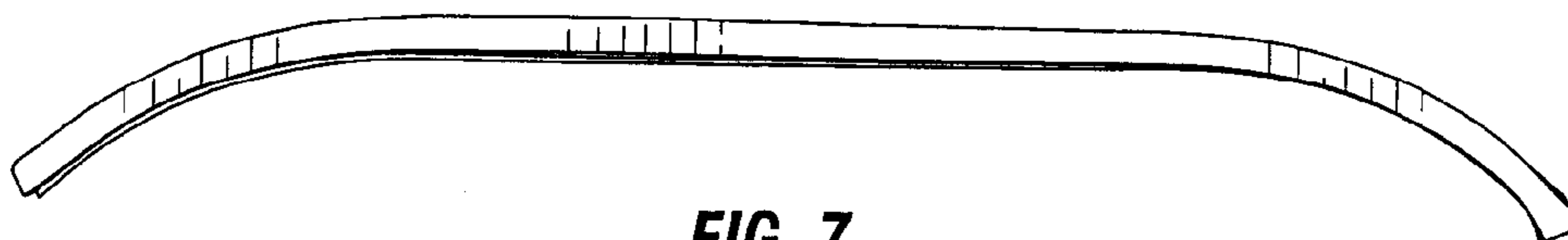

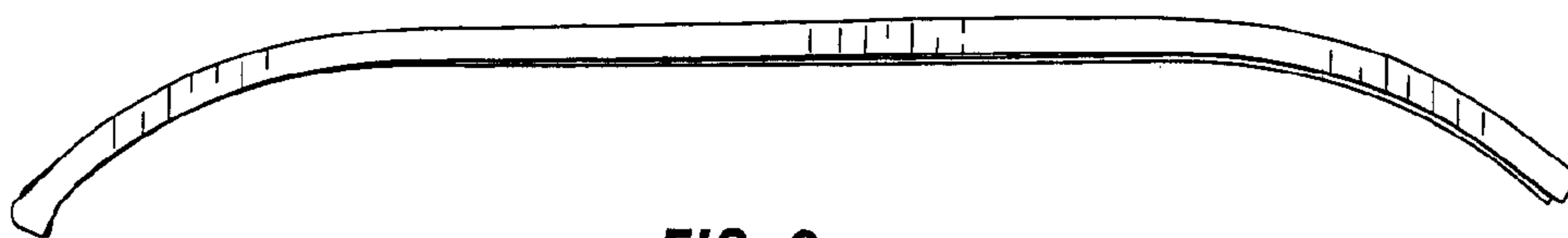
