(57) **CLAIM**

The ornamental design for a toothbrush package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view as seen from the front and left side of a toothbrush package showing our new design;

FIG. 2 is a front side view of a toothbrush package of FIG. 1;

FIG. 3 is a back side view of a toothbrush package of FIG. 1;

FIG. 4 is a right side view of a toothbrush package of FIG. 1;

FIG. 5 is a left side view of a toothbrush package of FIG. 1;

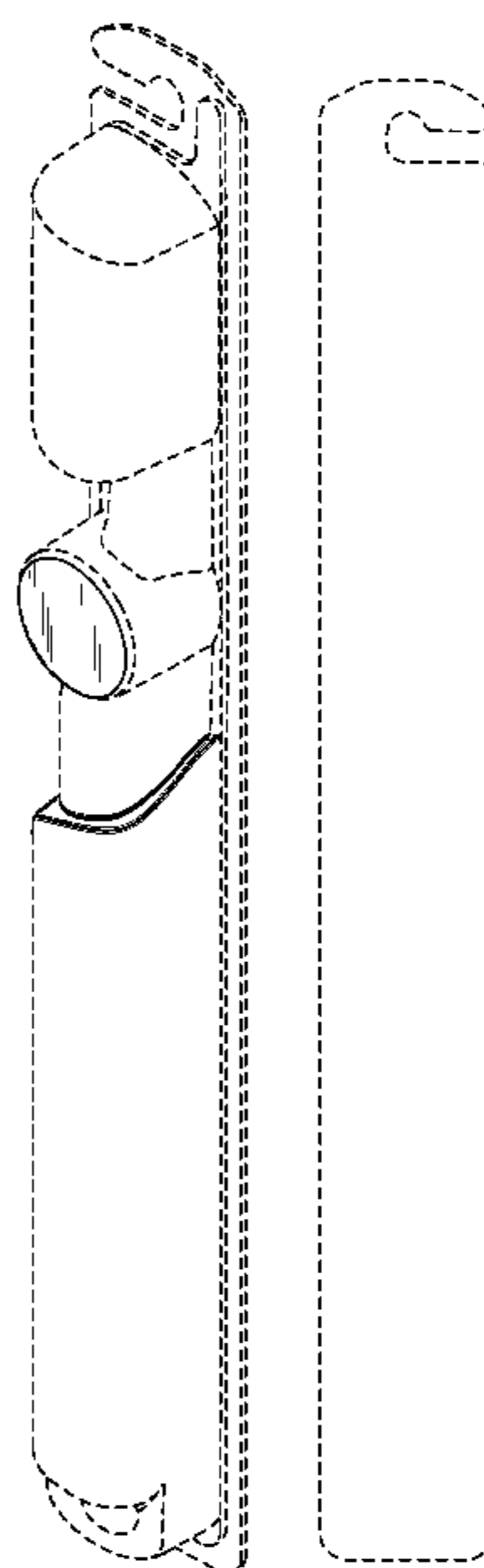
FIG. 6 is a top view of a toothbrush package of FIG. 1; and,

FIG. 7 is a bottom view of a toothbrush package of FIG. 1.

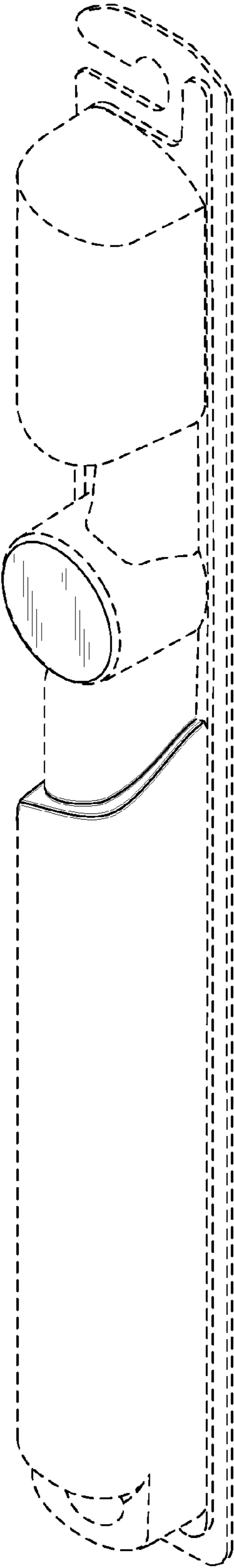

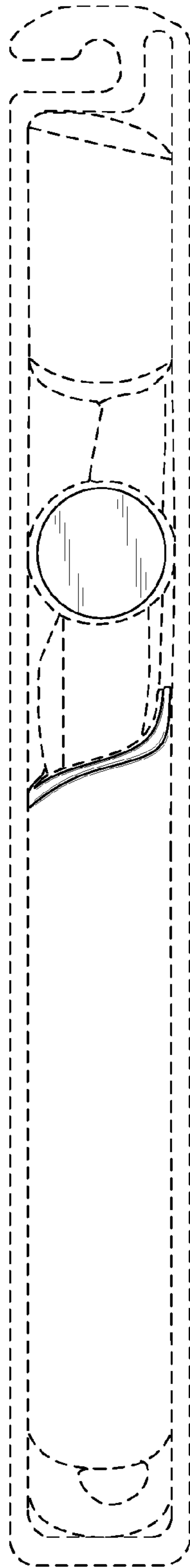

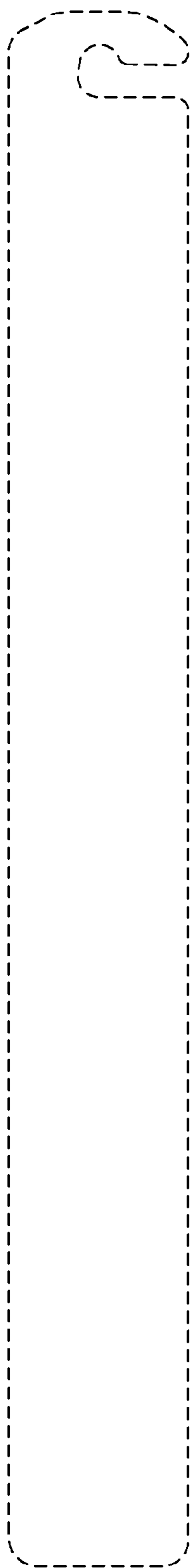

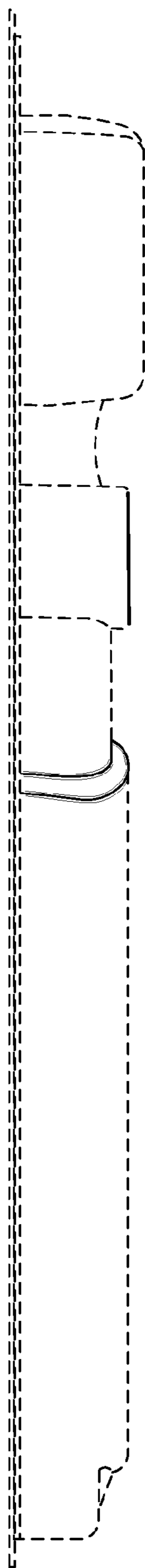

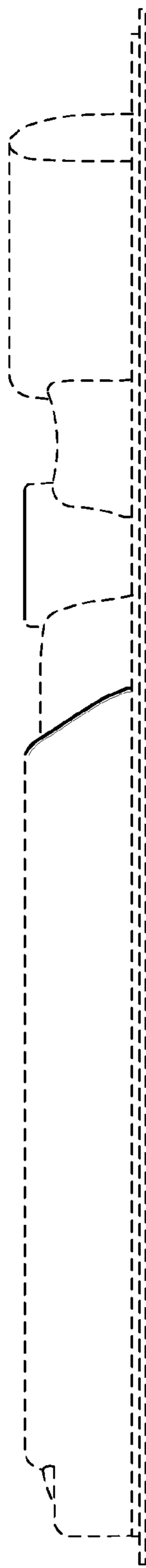

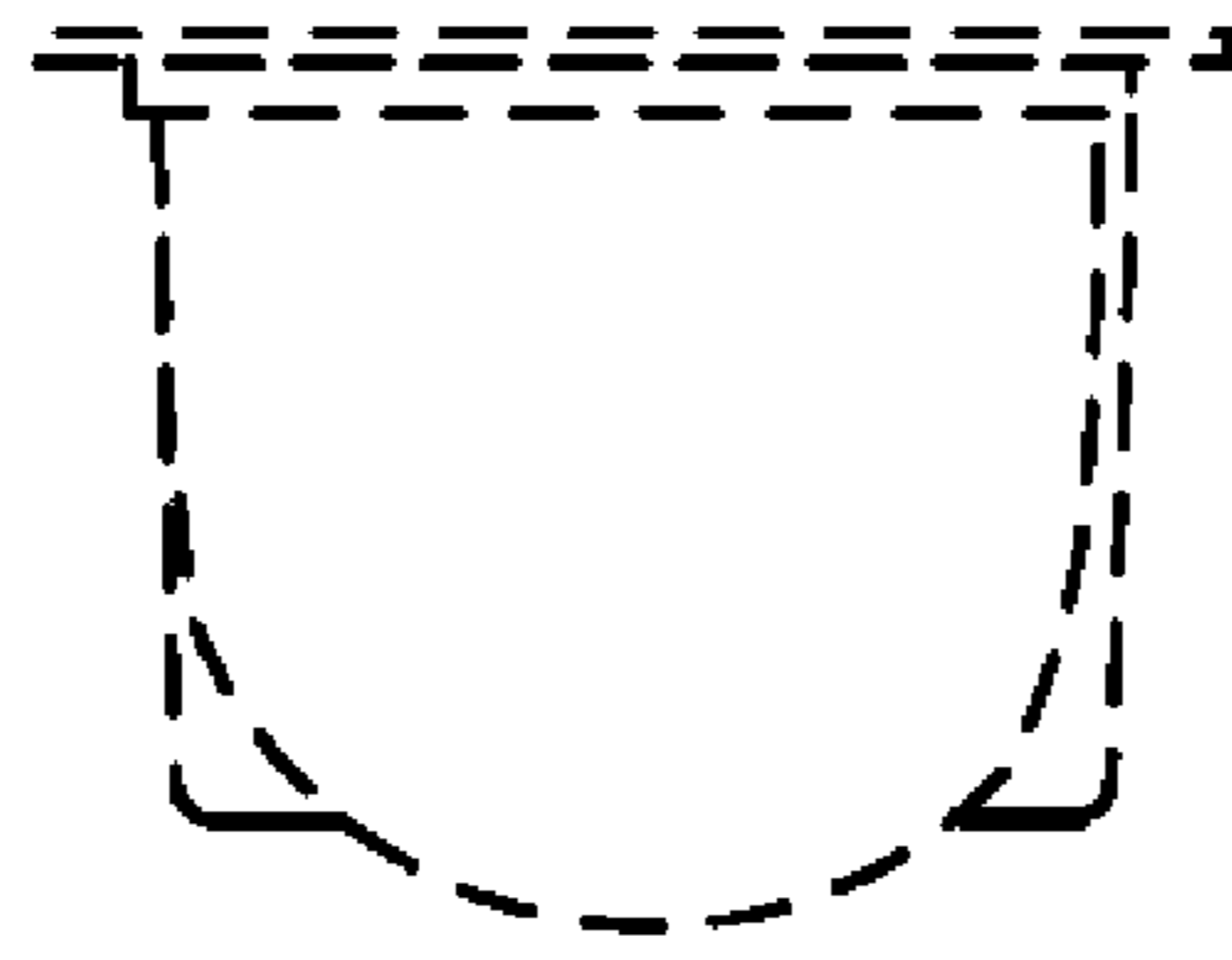
