**DESCRIPTION**

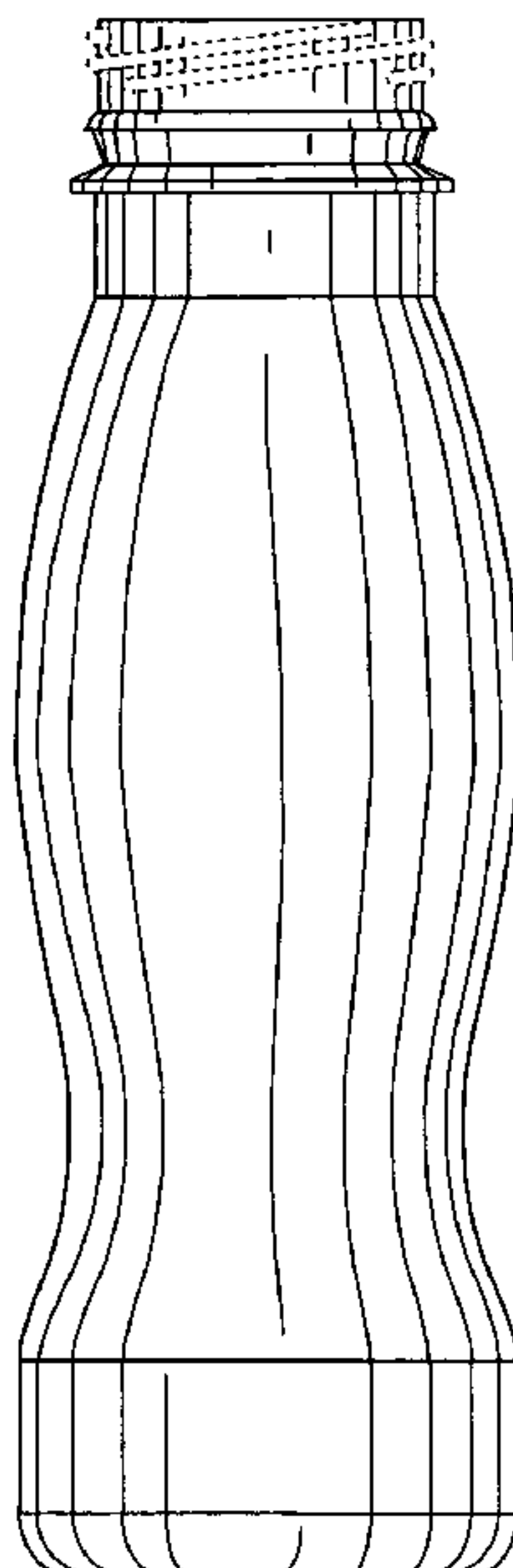
FIG. 1 is a top, front, perspective view of a beverage bottle showing our new design;

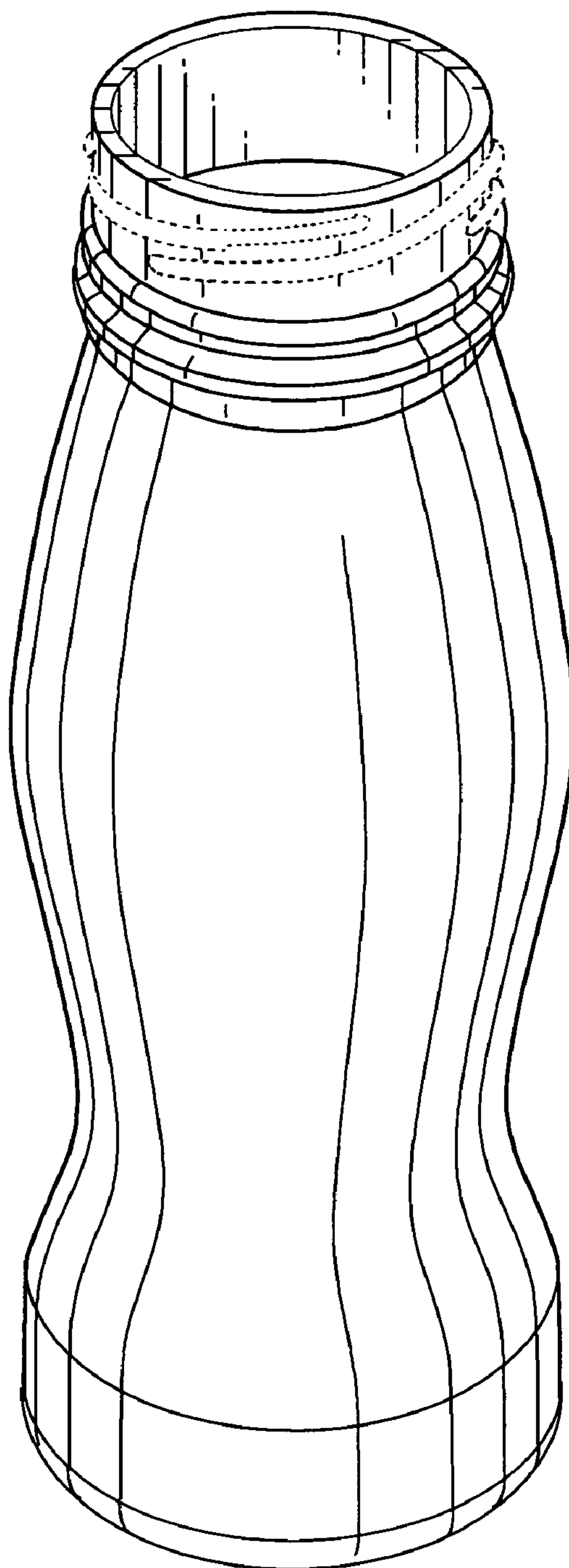
FIG. 2 is a front elevation view thereof; and,

FIG. 3 is a top plan view thereof.

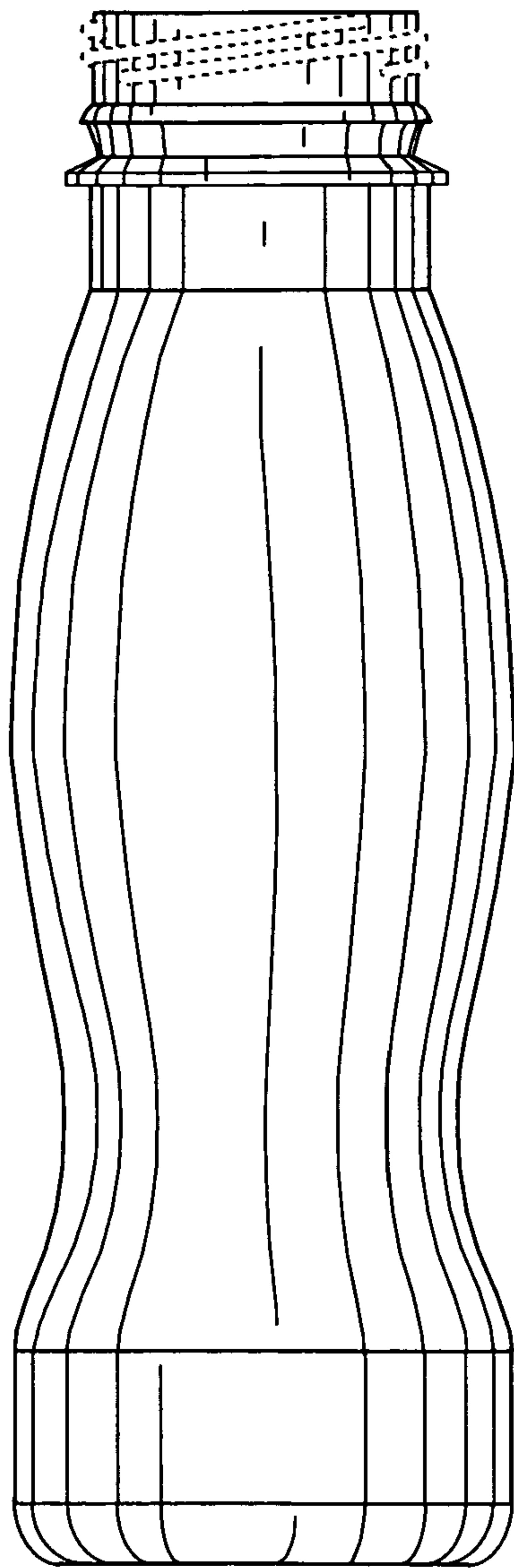
The broken lines in the drawings showing the thread and the inside details of the bottom surface illustrate the portions of the design that form no part of the claim.

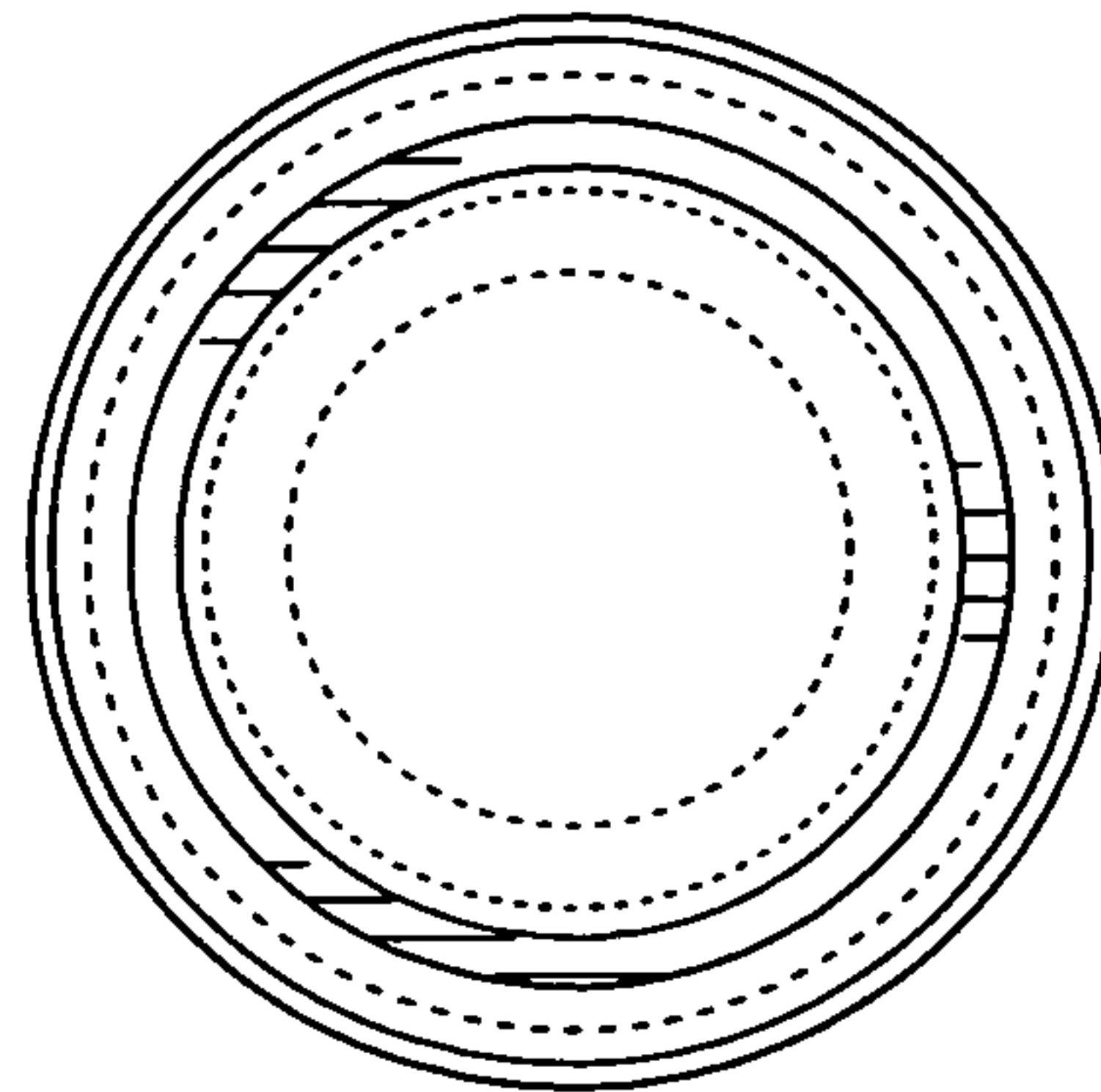
