(57) **CLAIM**

I claim the ornamental design for a vehicle fender flare, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a vehicle fender flare showing the new design.

FIG. 2 is a side view of the new design.

FIG. 3 is a top view of the new design.

FIG. 4 is an isometric front view of the new design; and,

FIG. 5 is an isometric rear view of the new design.

The broken lines shown in the drawings represent unclaimed portions of the structure and form no part of the claimed design. Furthermore, the interior surfaces that are shown without surface shading form no part of the claimed design.

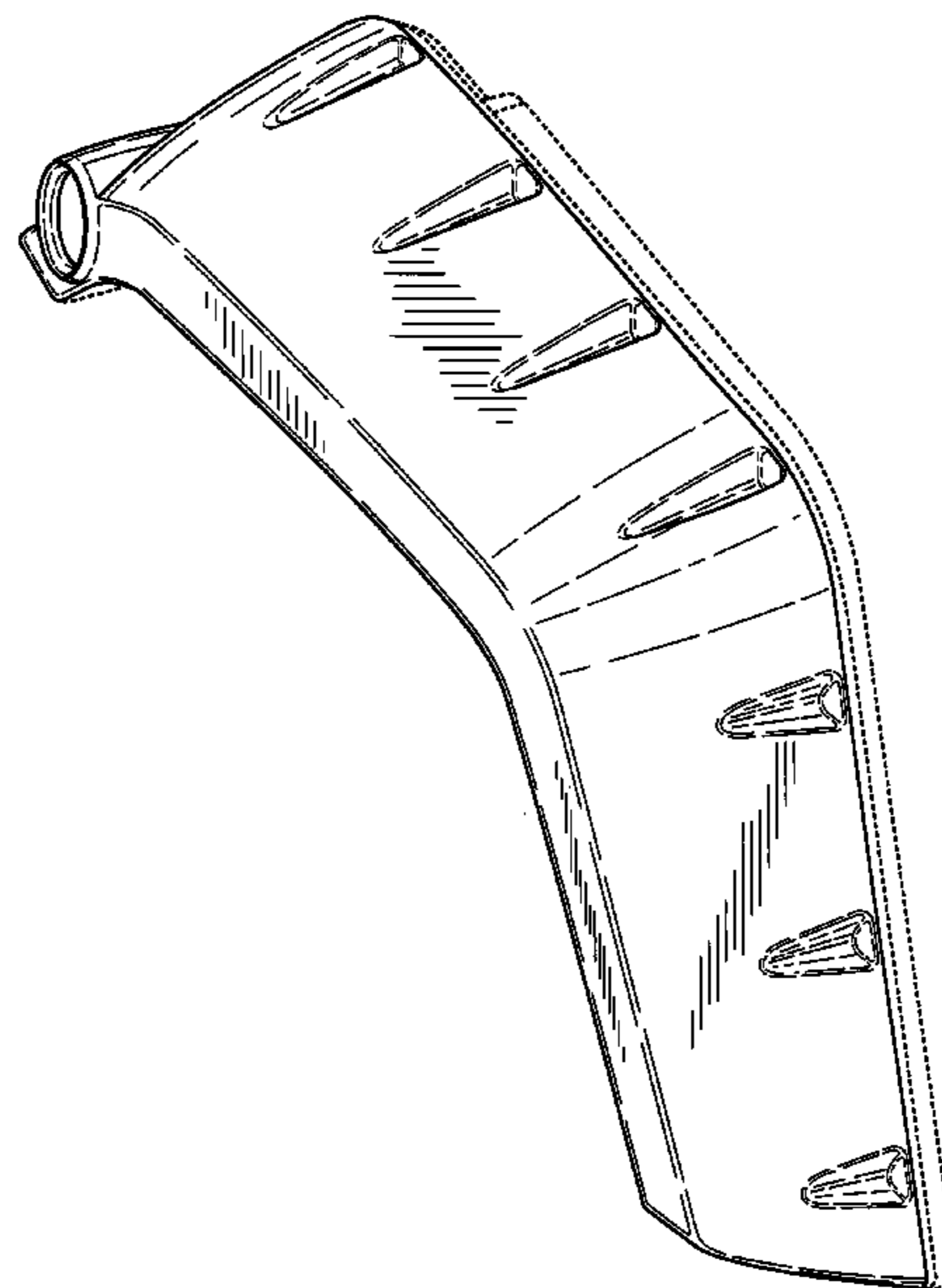
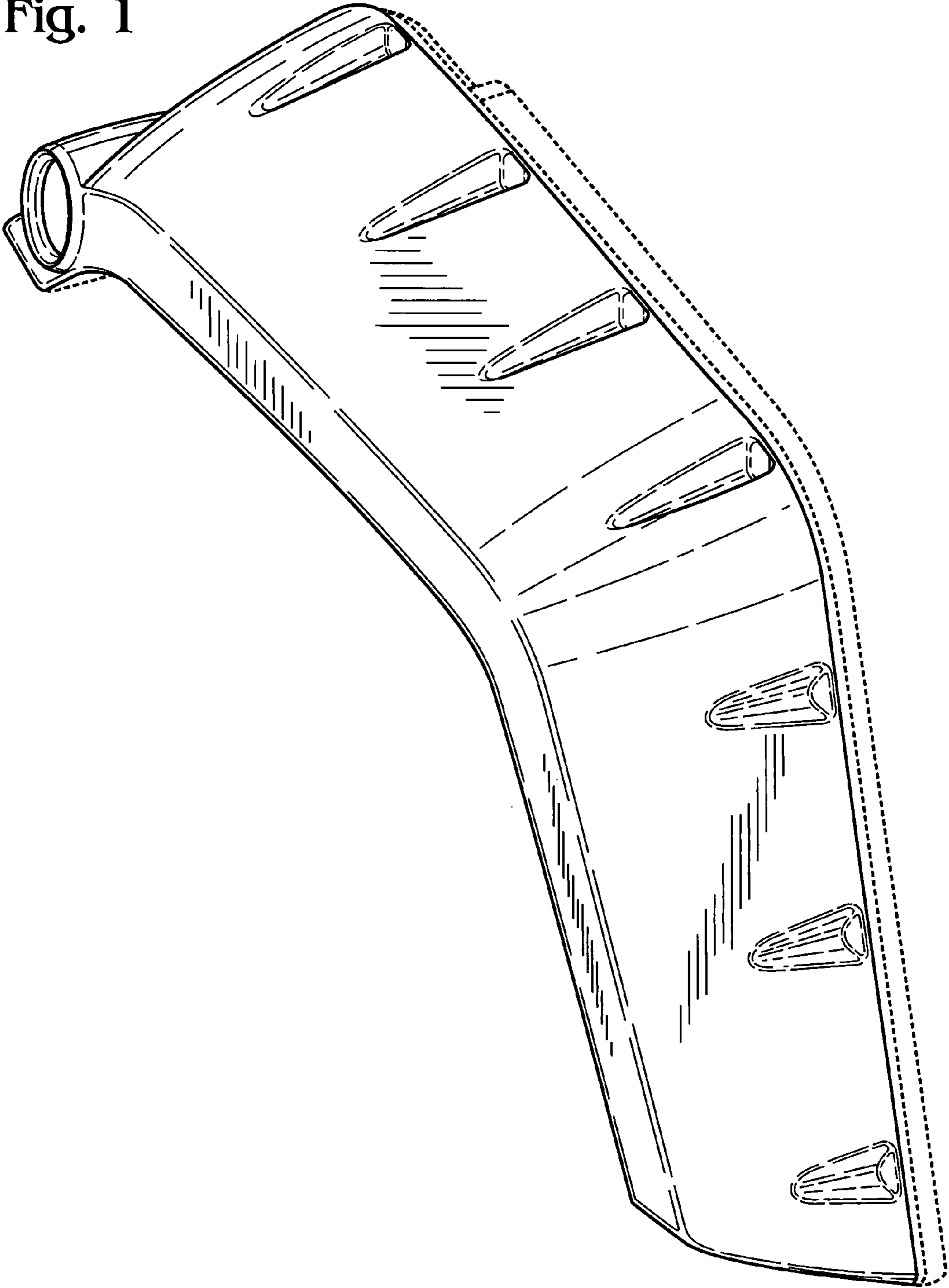

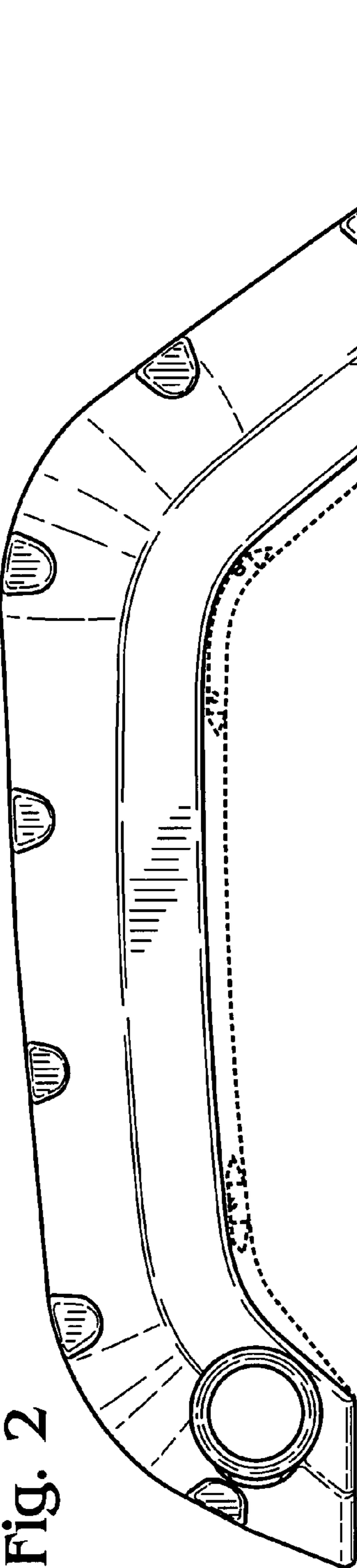

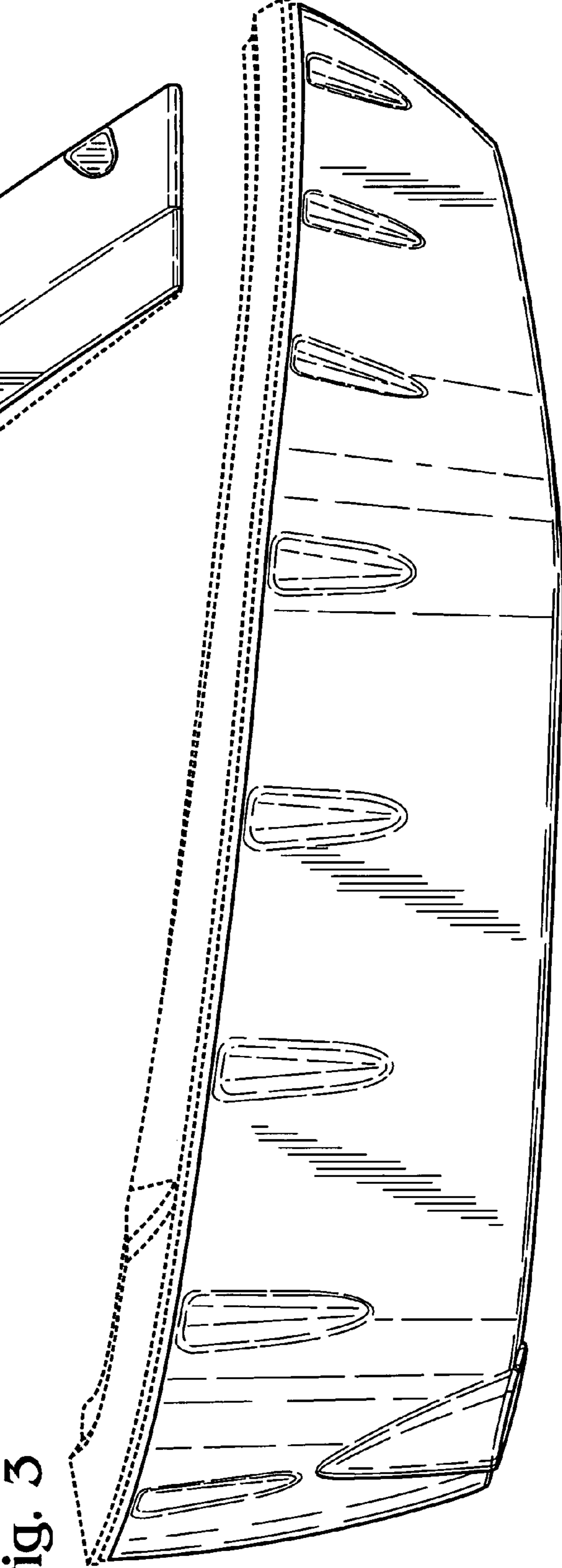

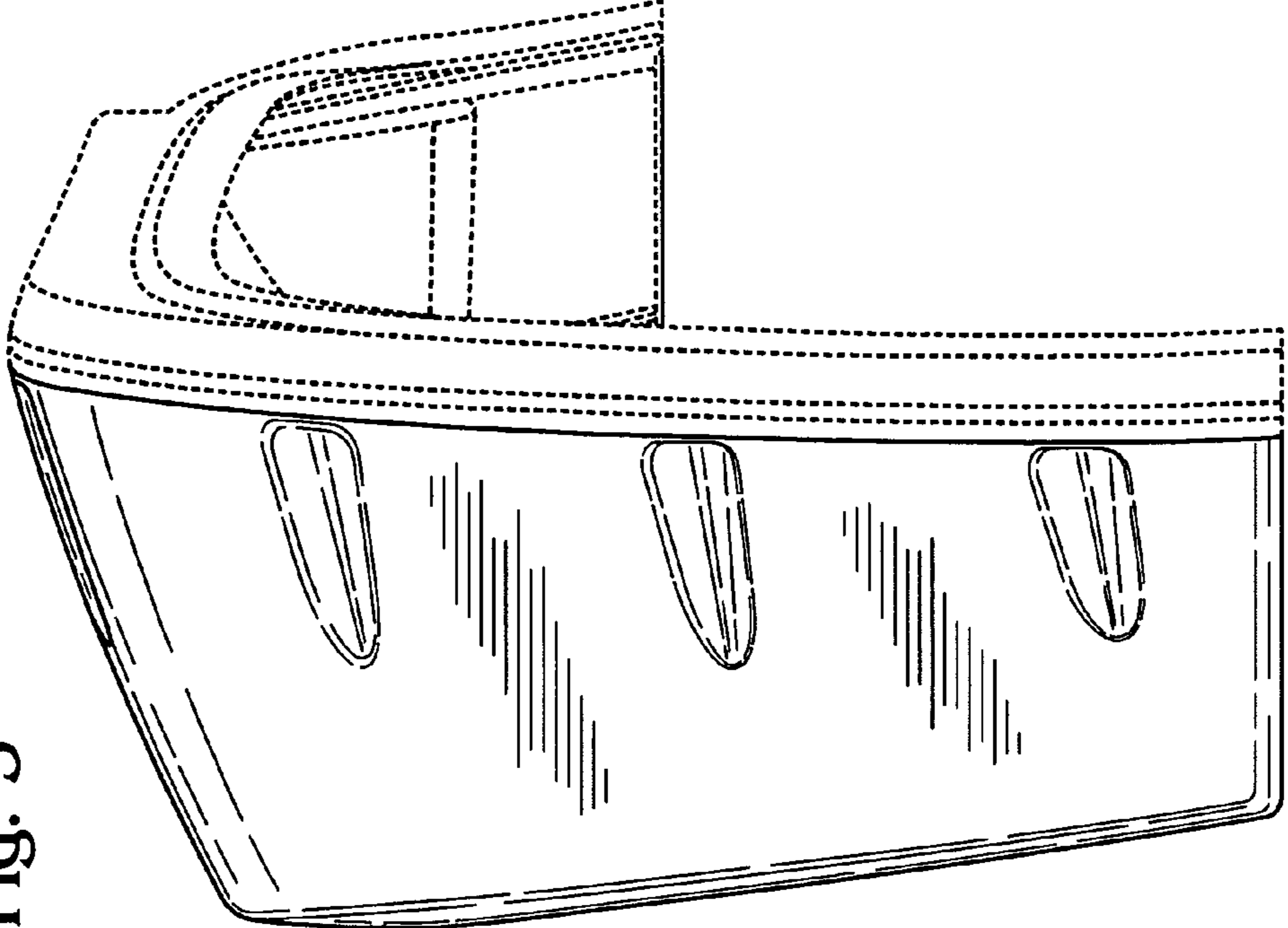
