FIG. 11 is a front elevational view thereof; and,

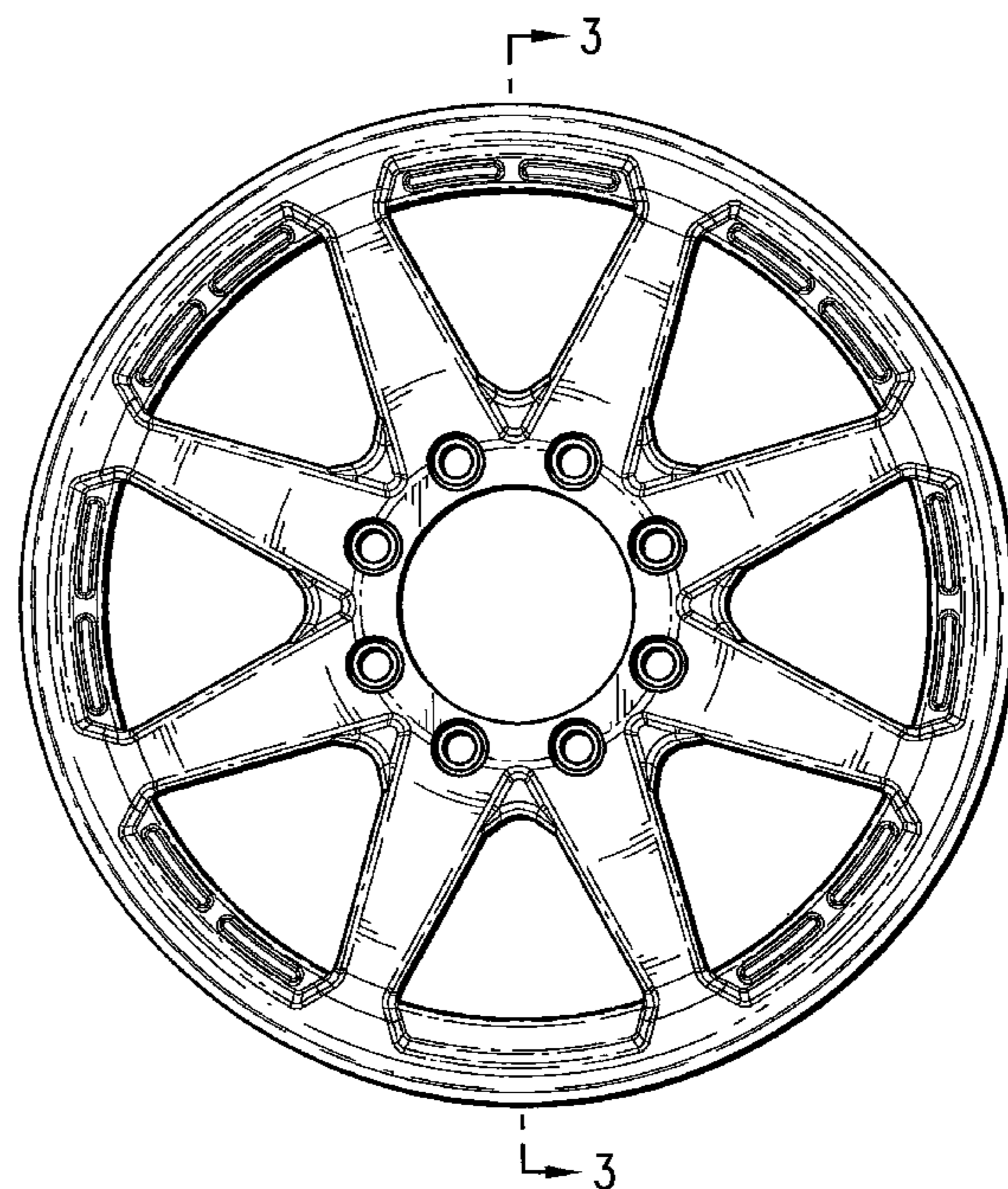
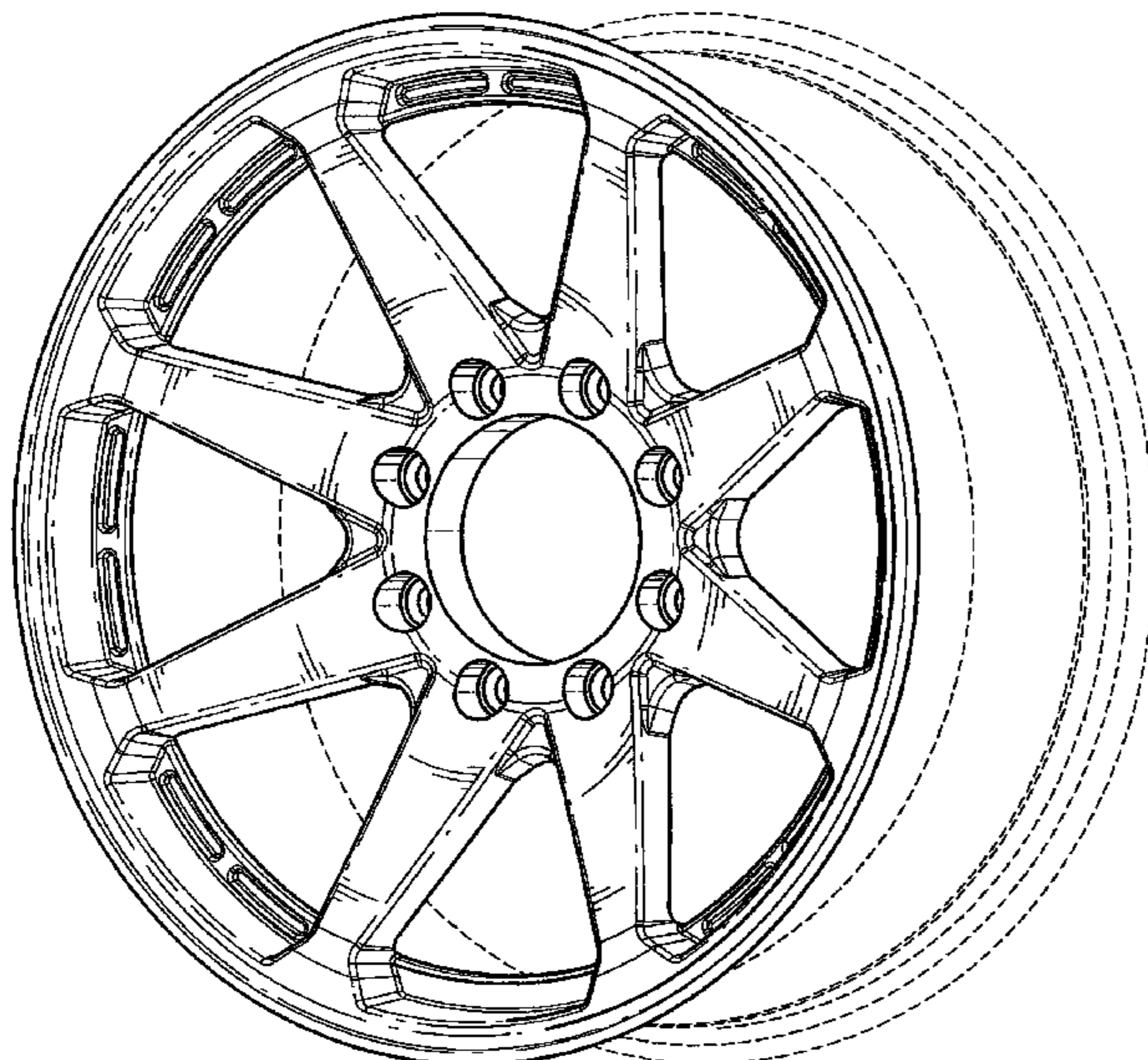
FIG. 12 is a cross-sectional view taken along the lines of 12—12 of FIG. 11.

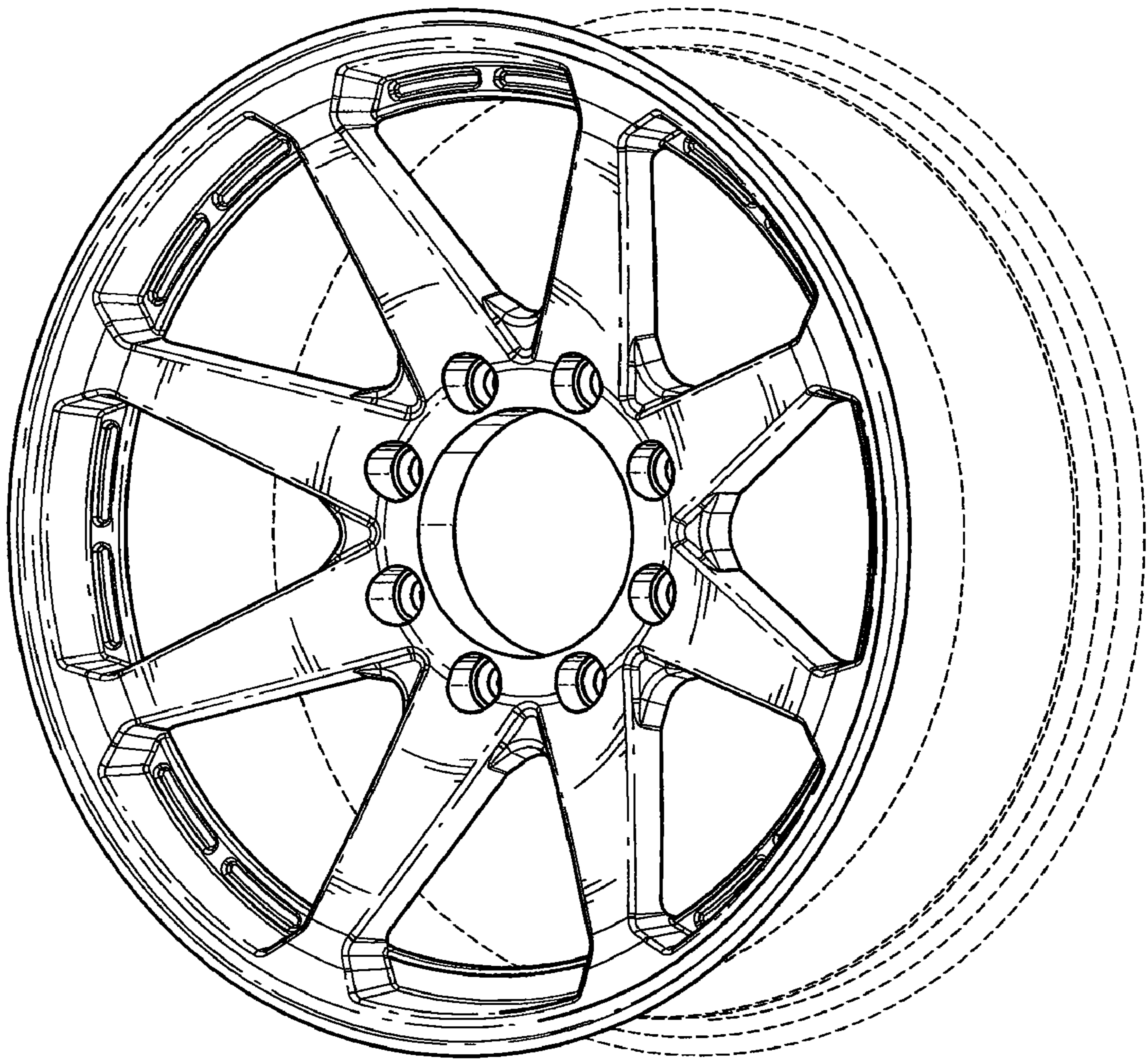

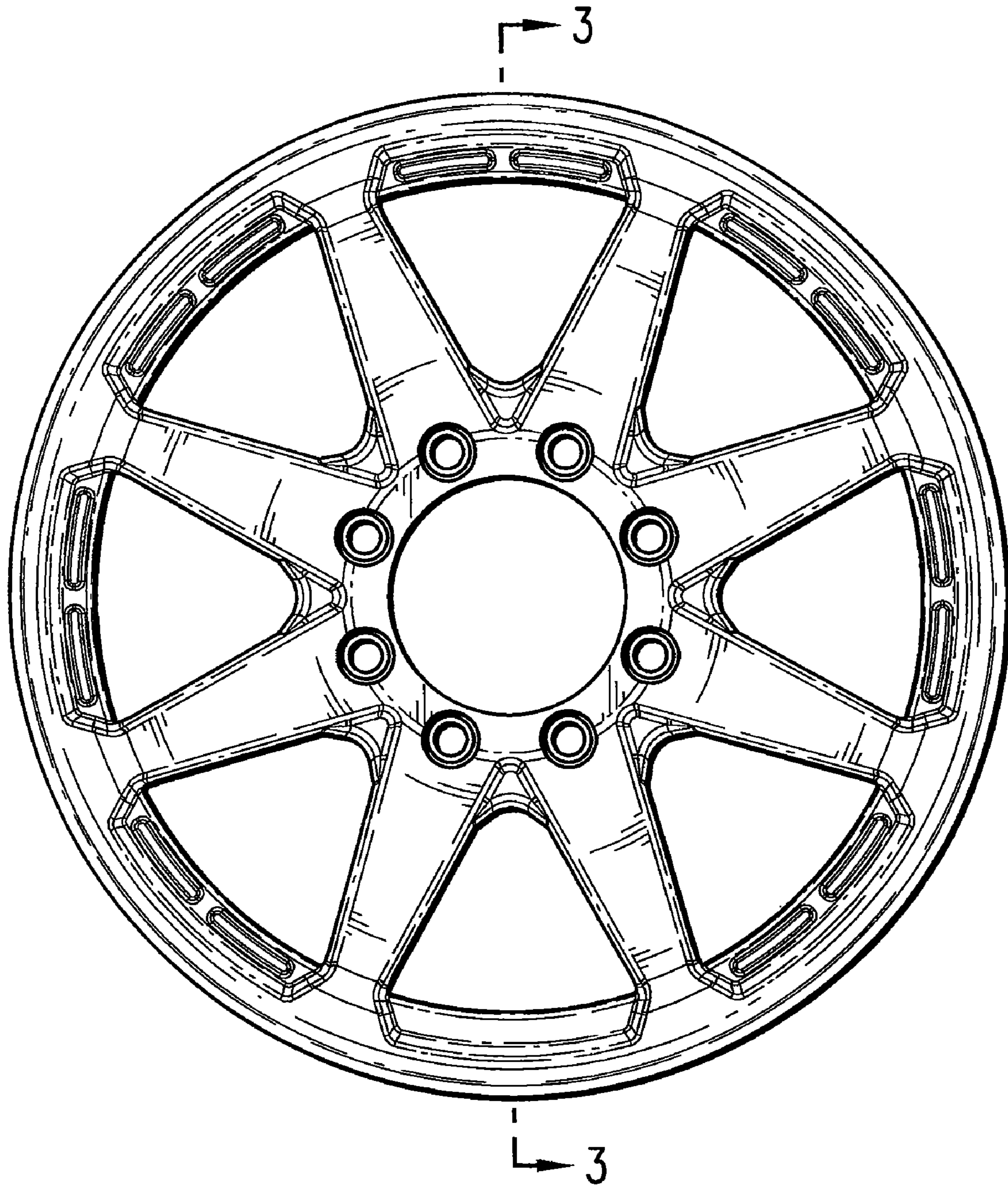

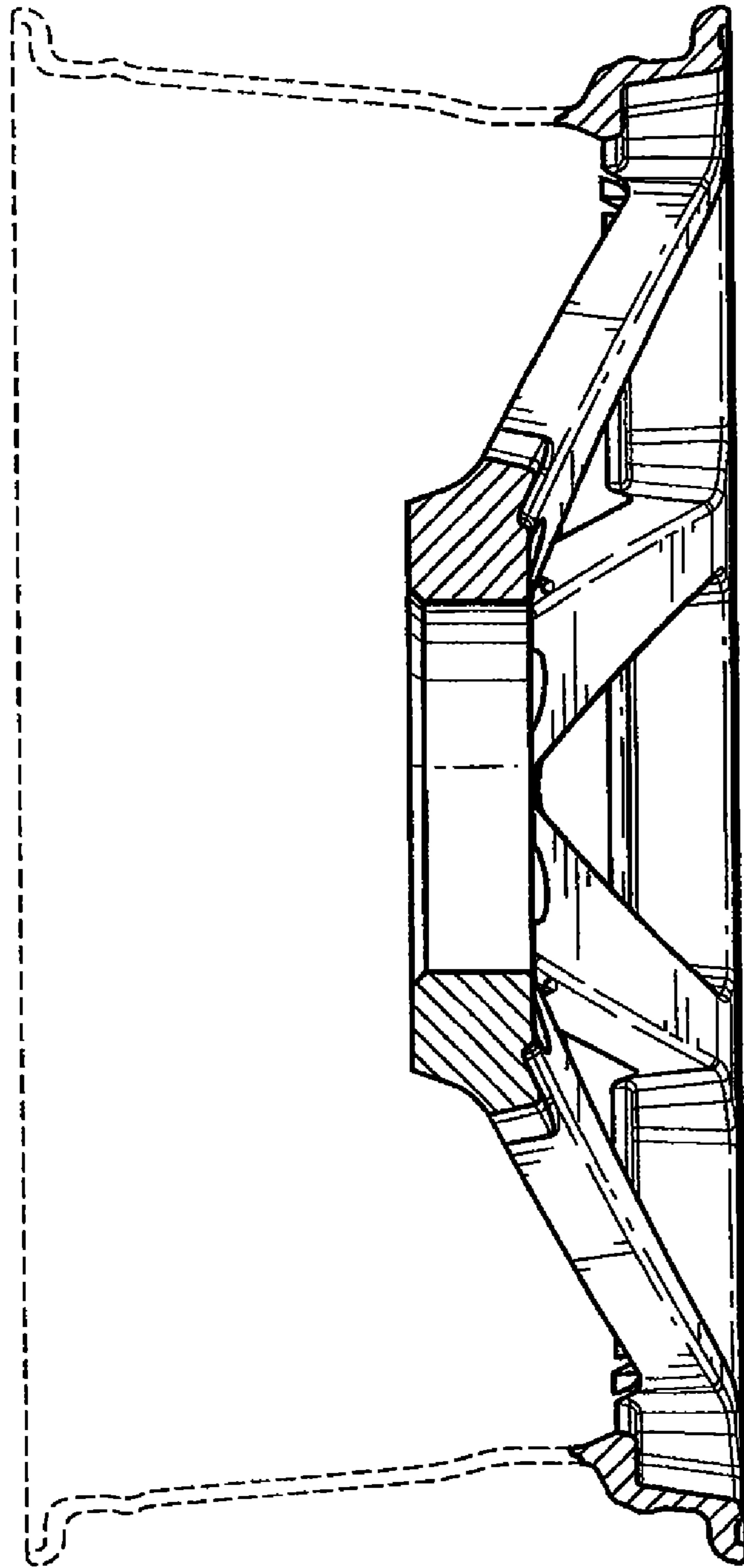

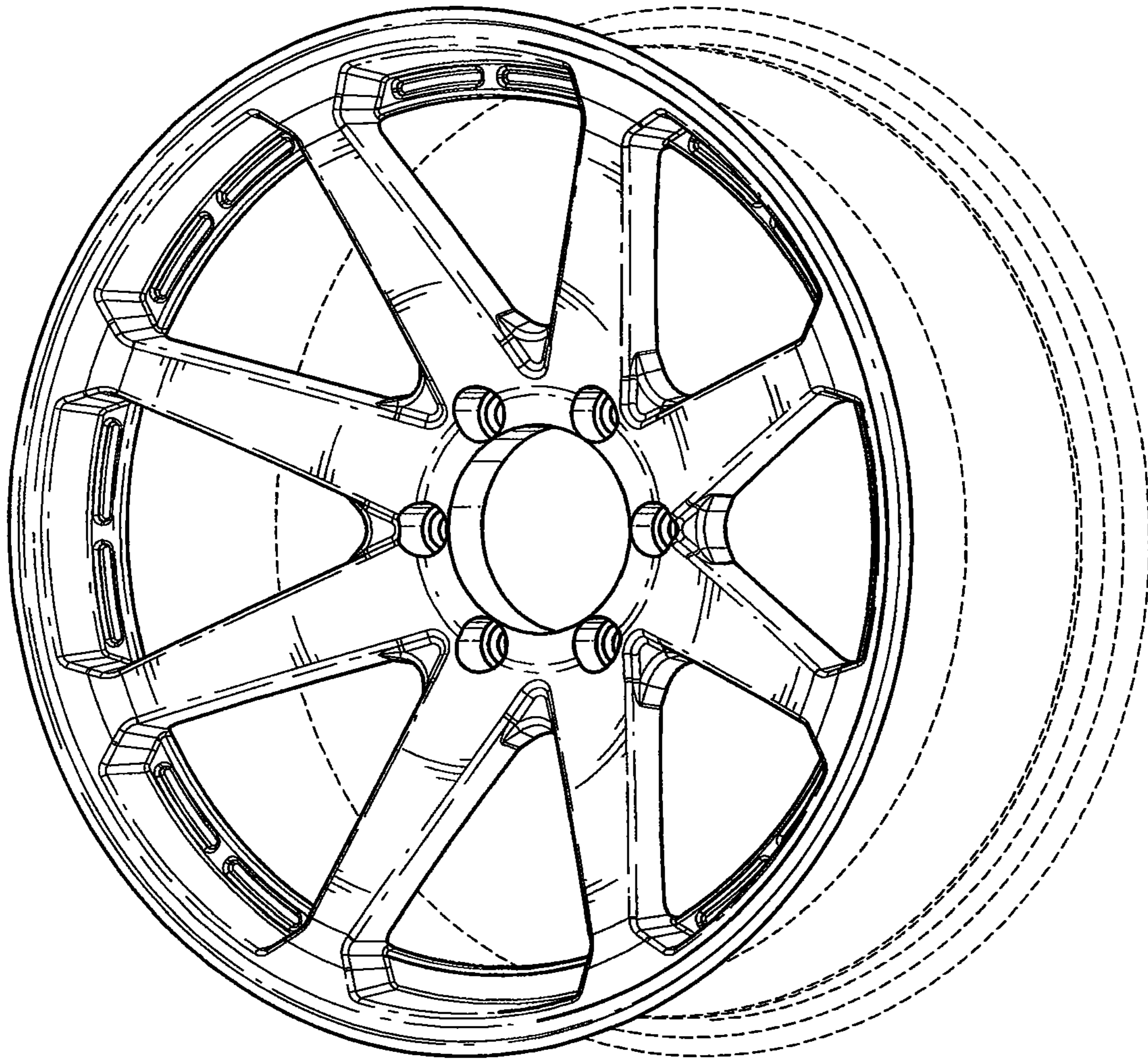

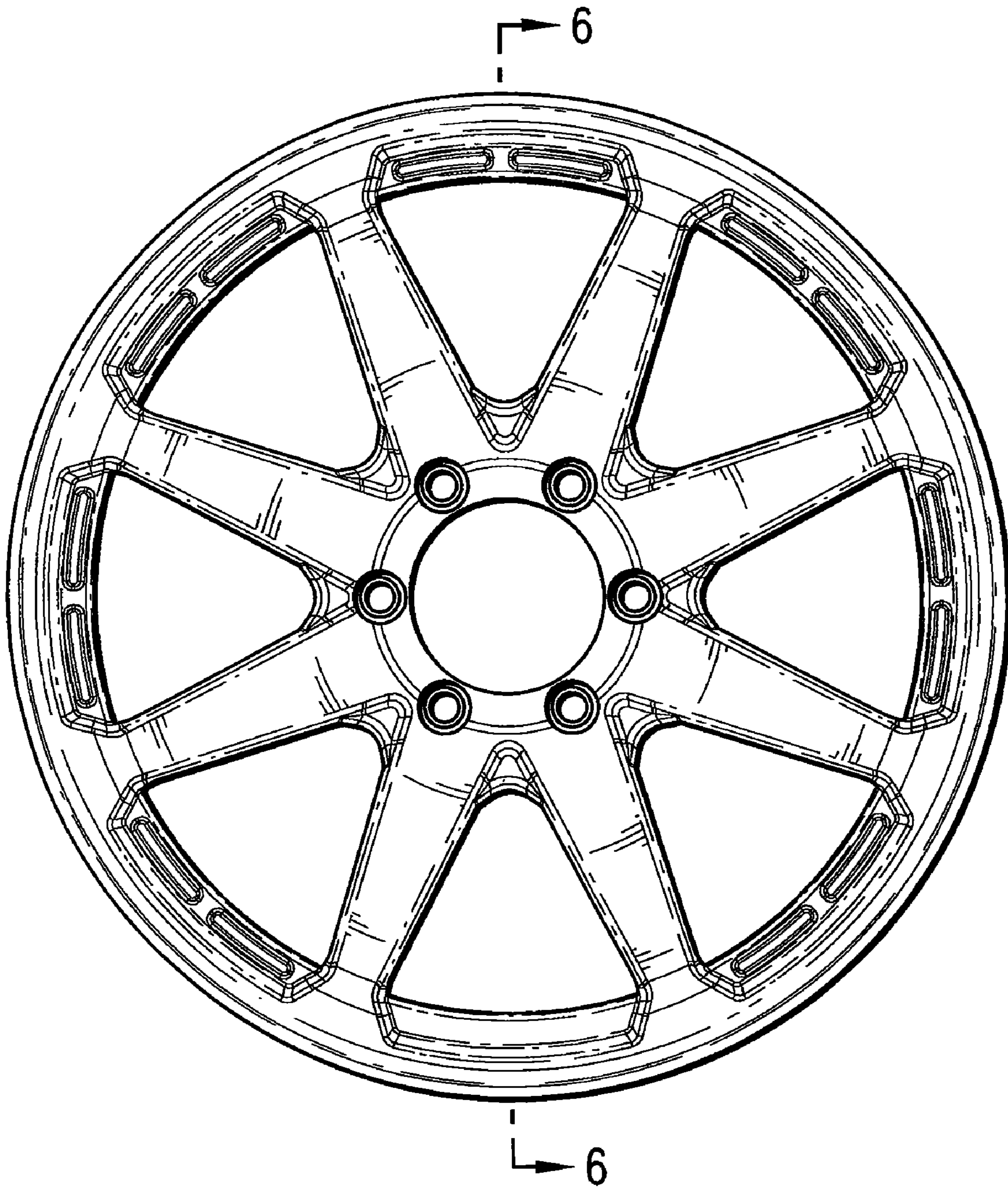

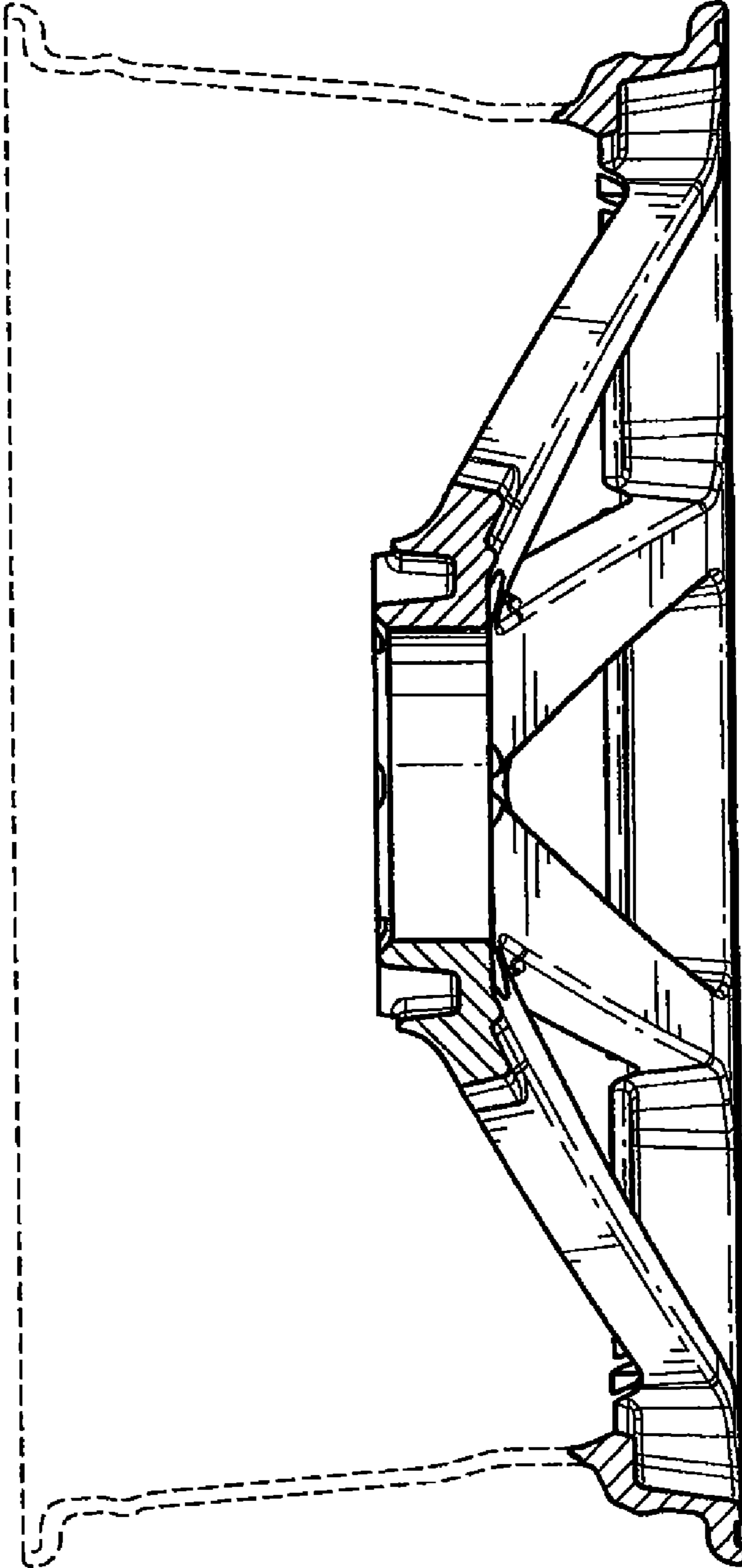

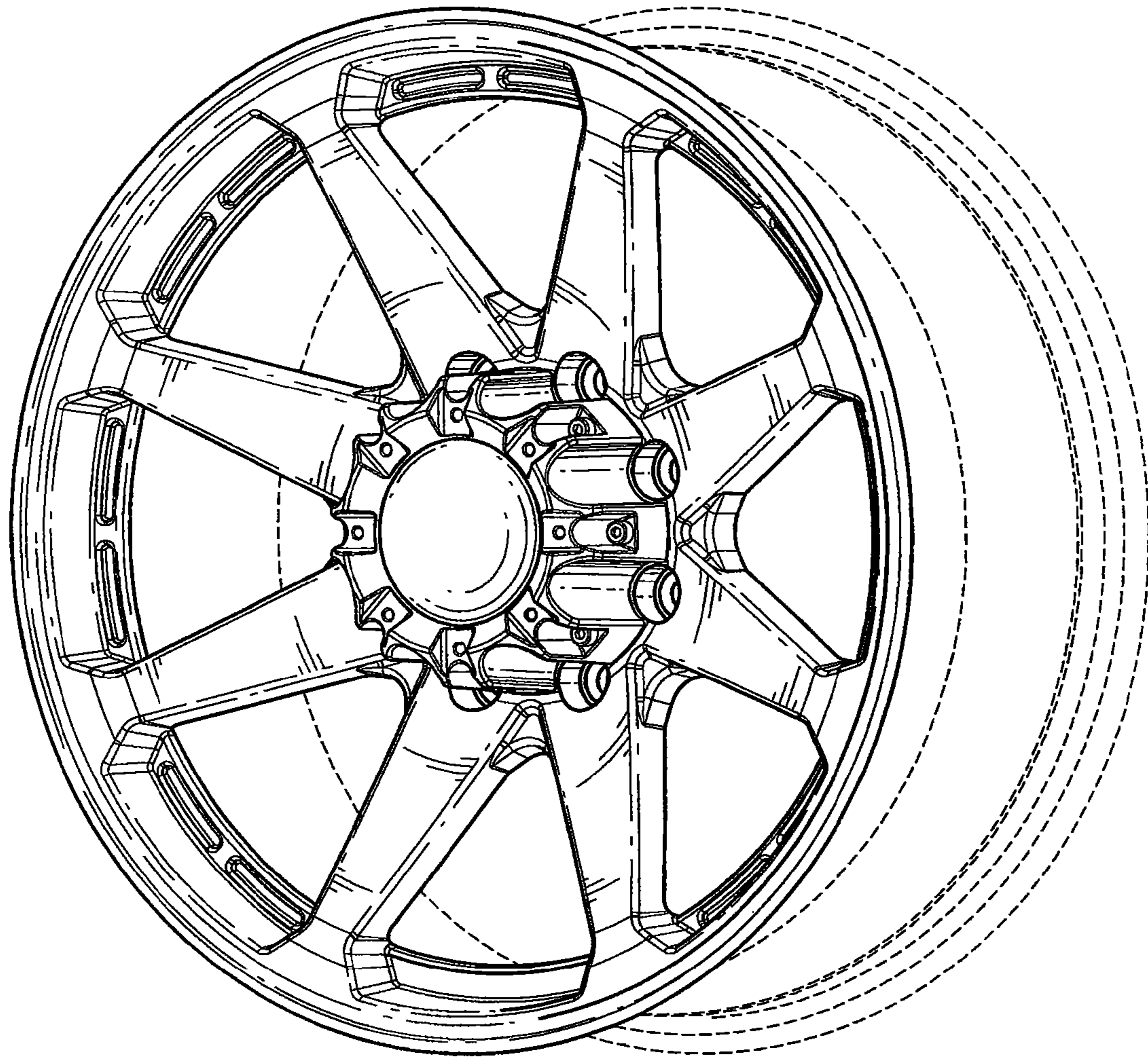

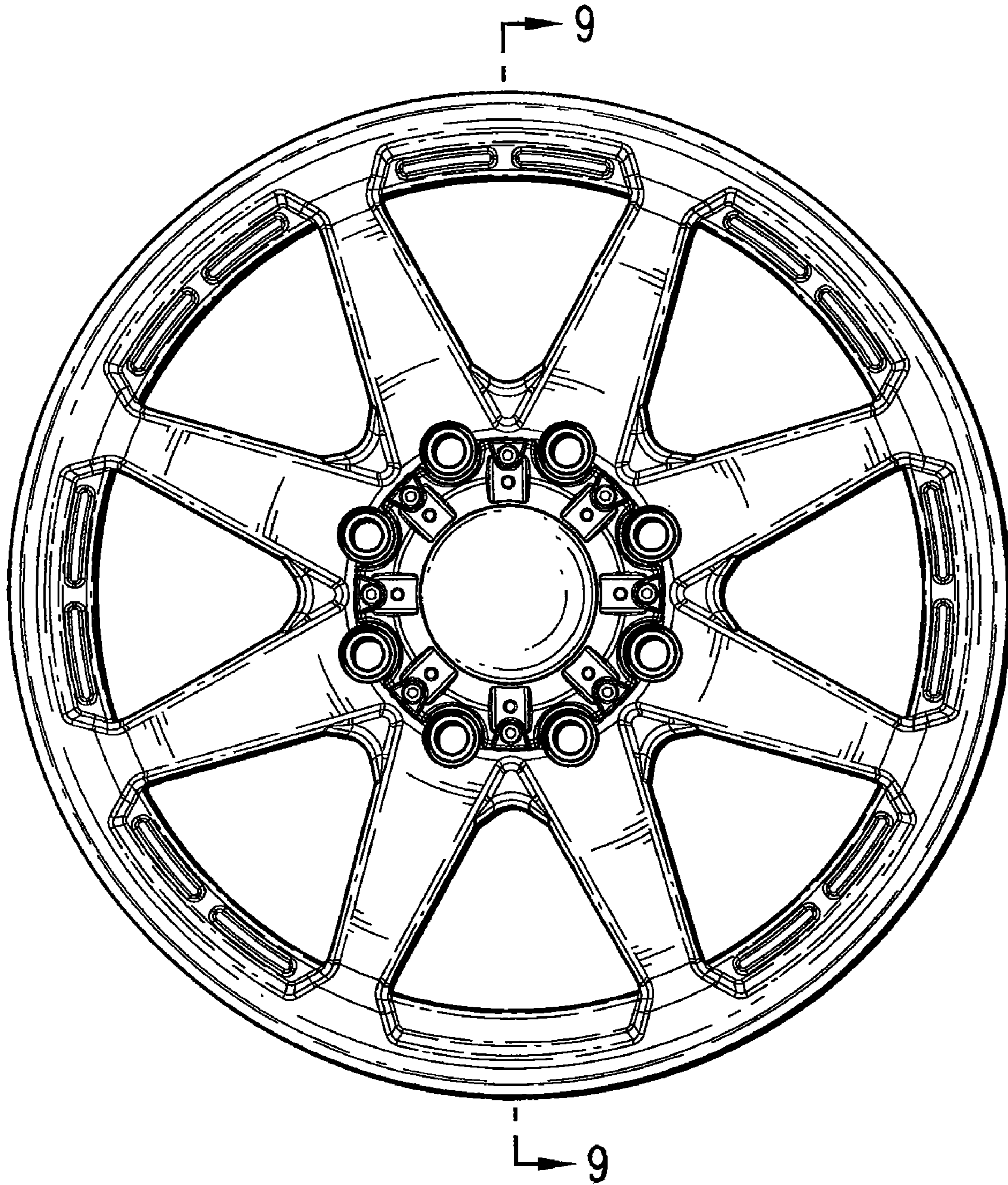

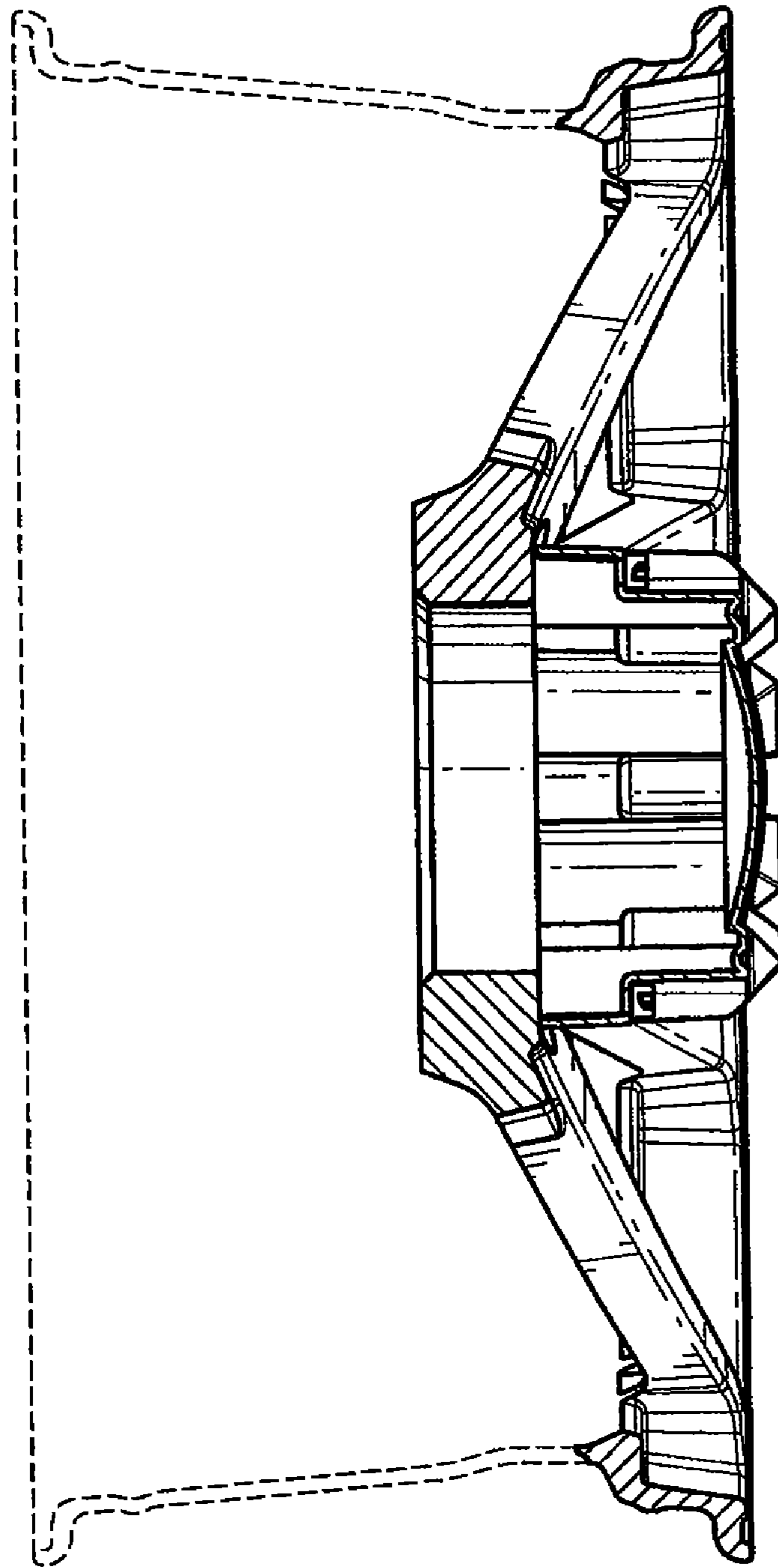

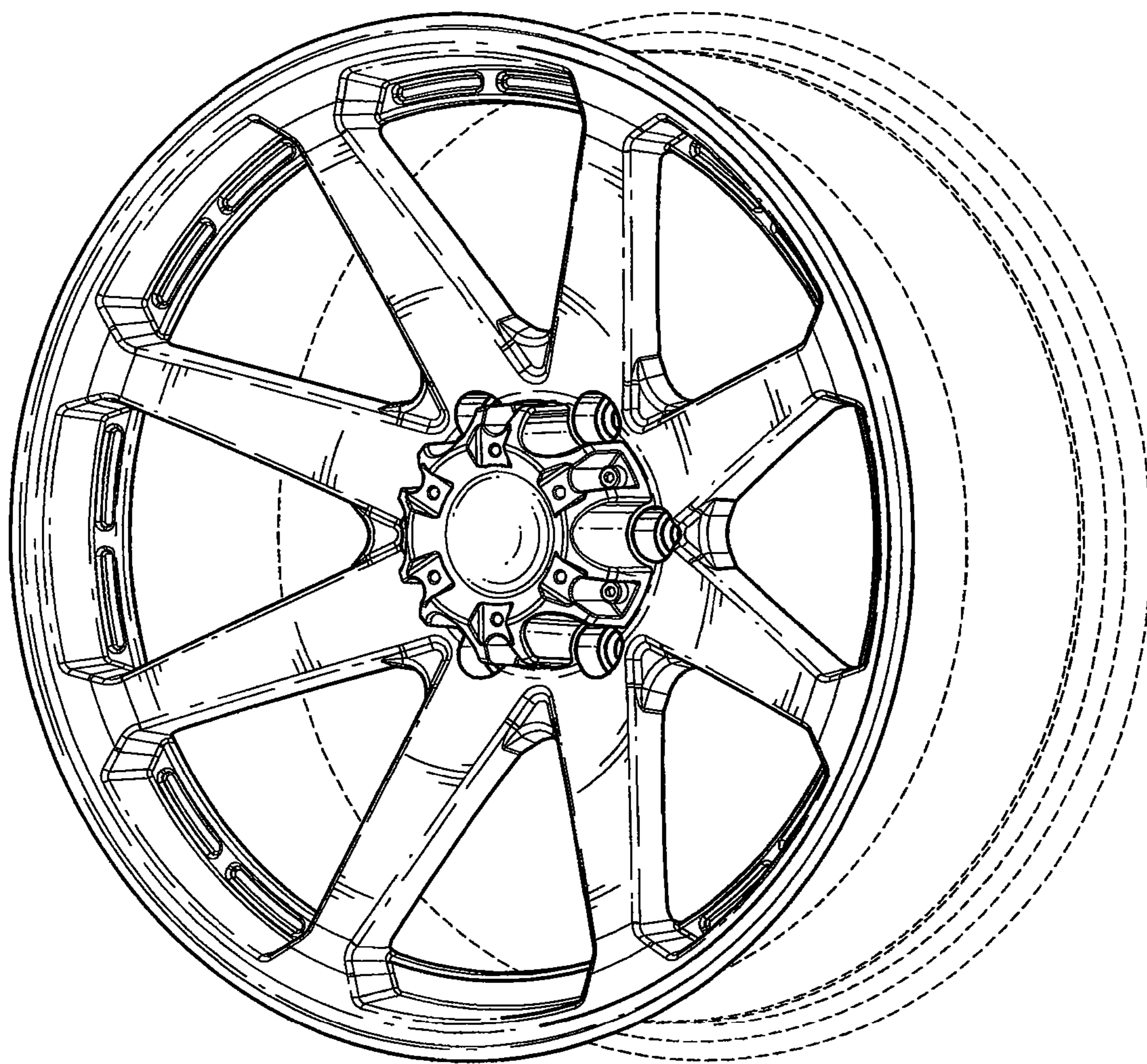

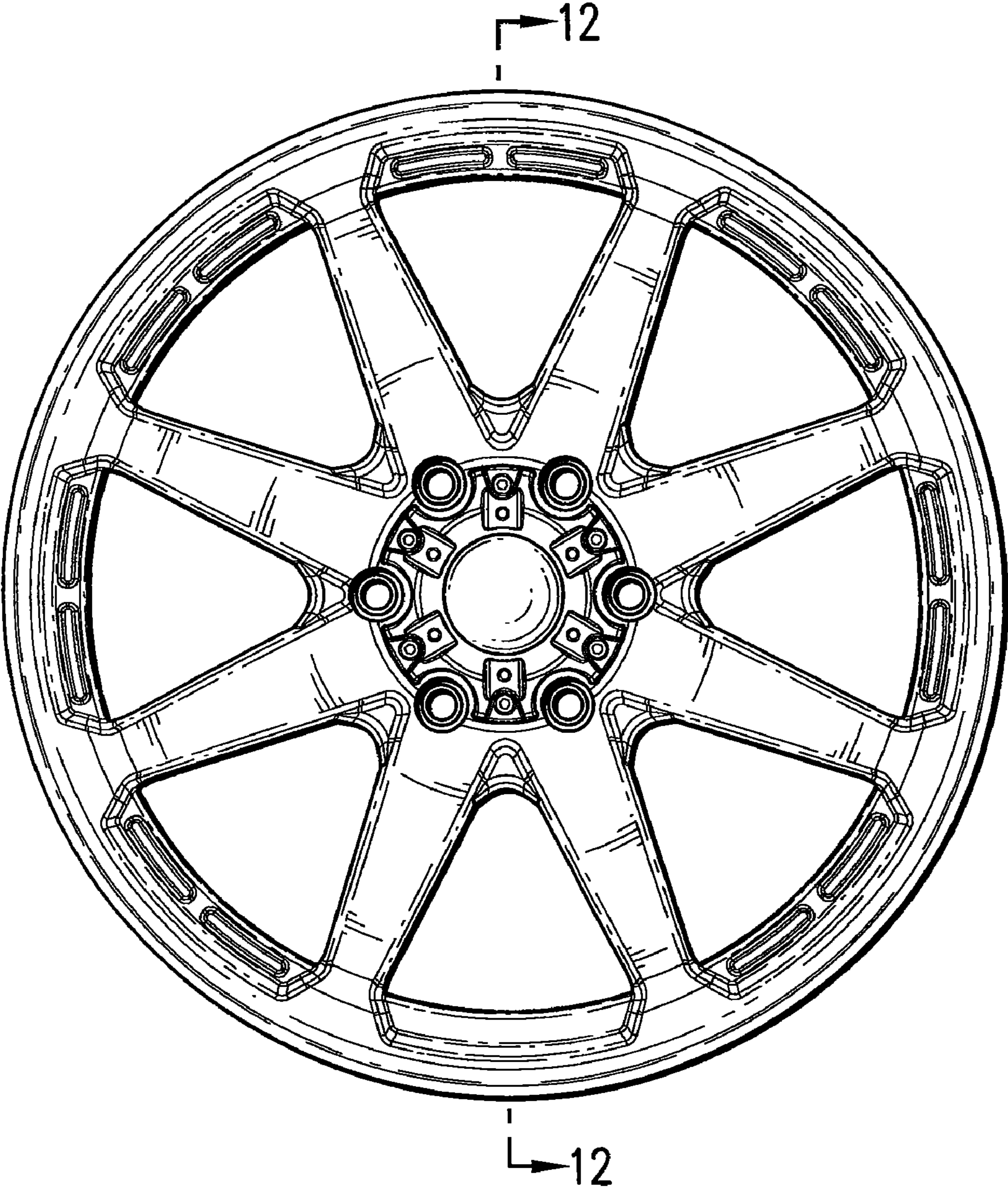

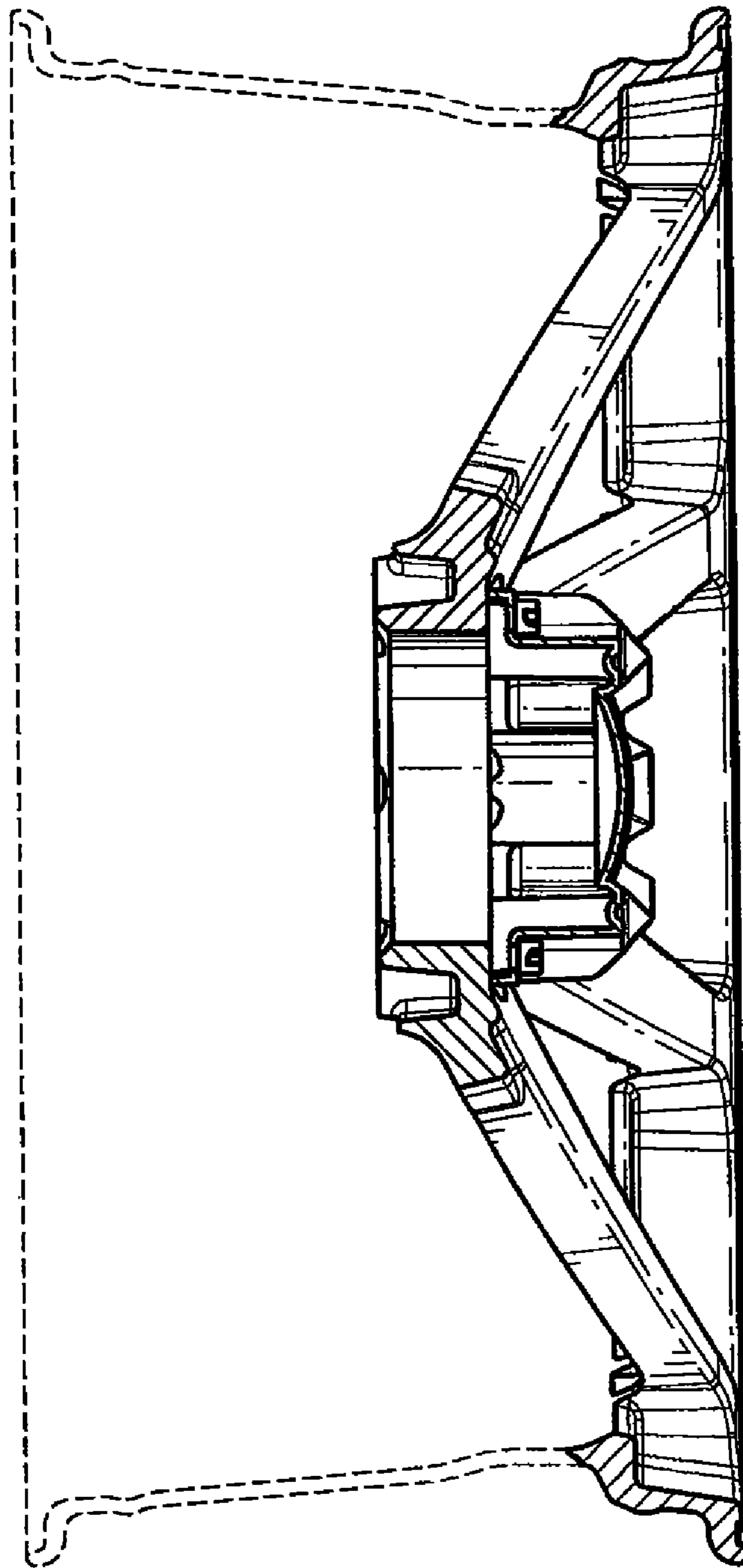
