FIG. 6 is a side perspective view, the portions shown in broken lines forming no part of the design sought to be patented; and,

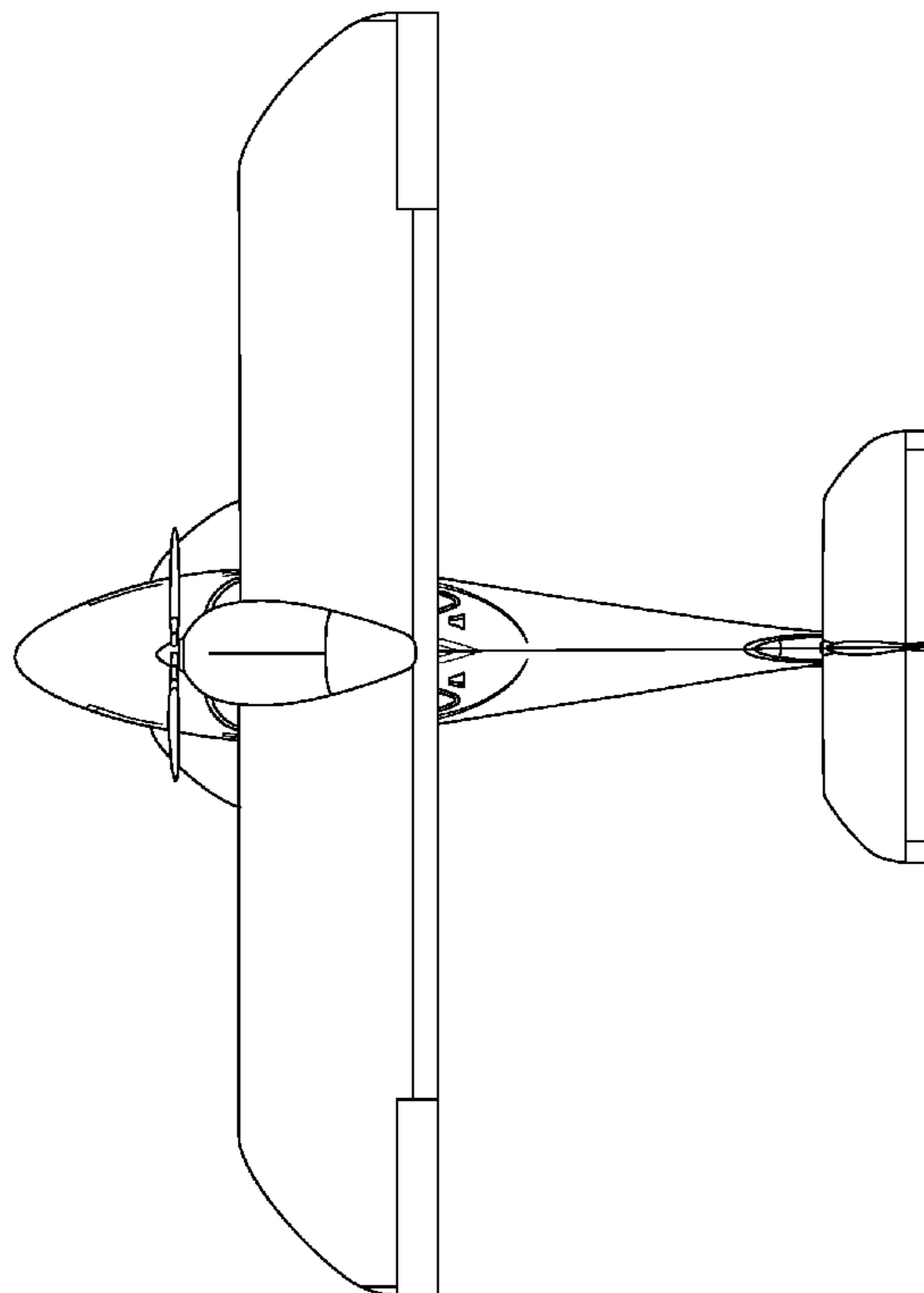
FIG. 7 is a bottom plan view thereof, the portions shown in broken lines forming no part of the design sought to be patented.

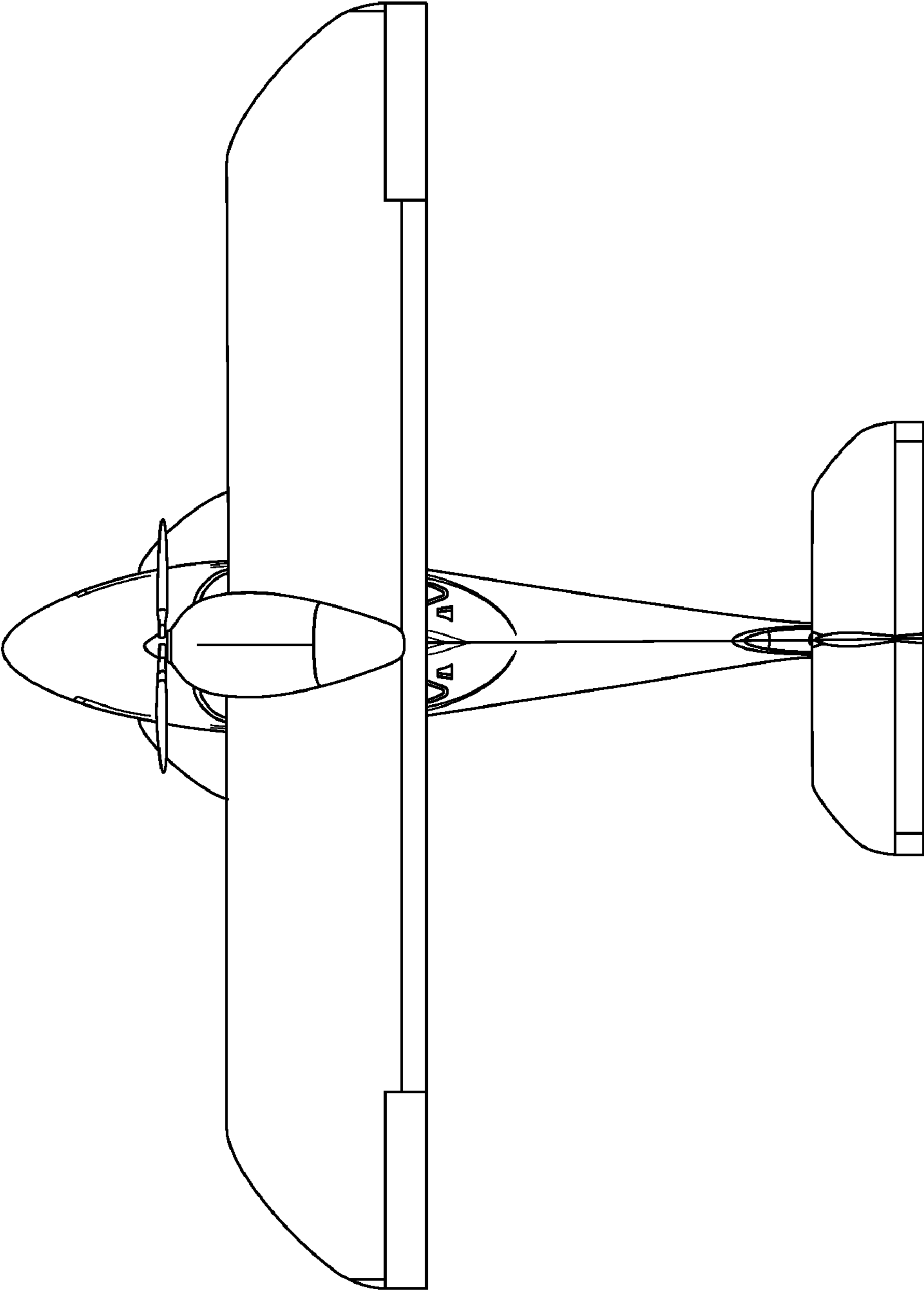

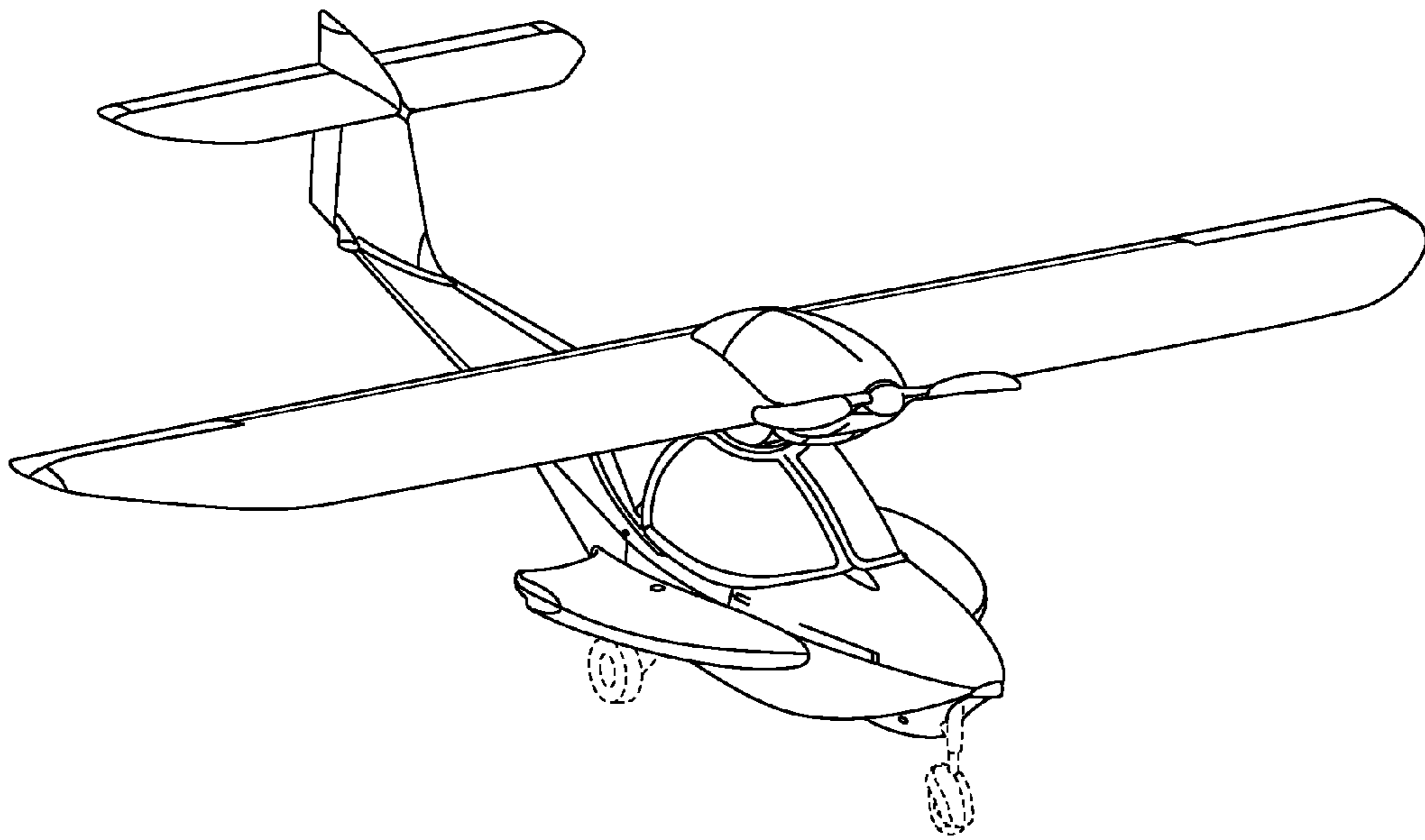

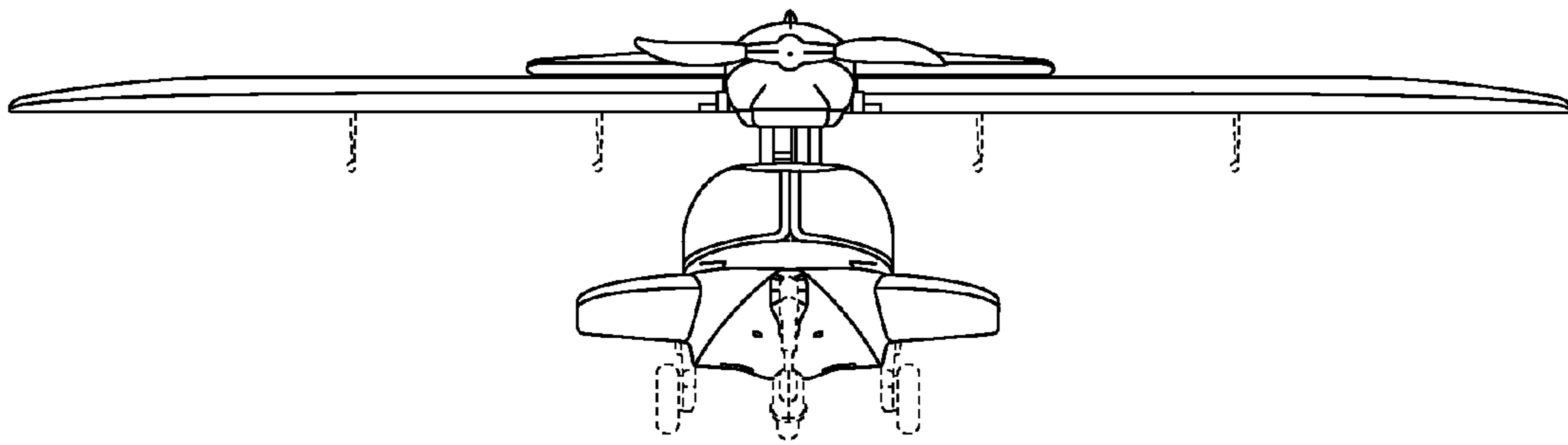

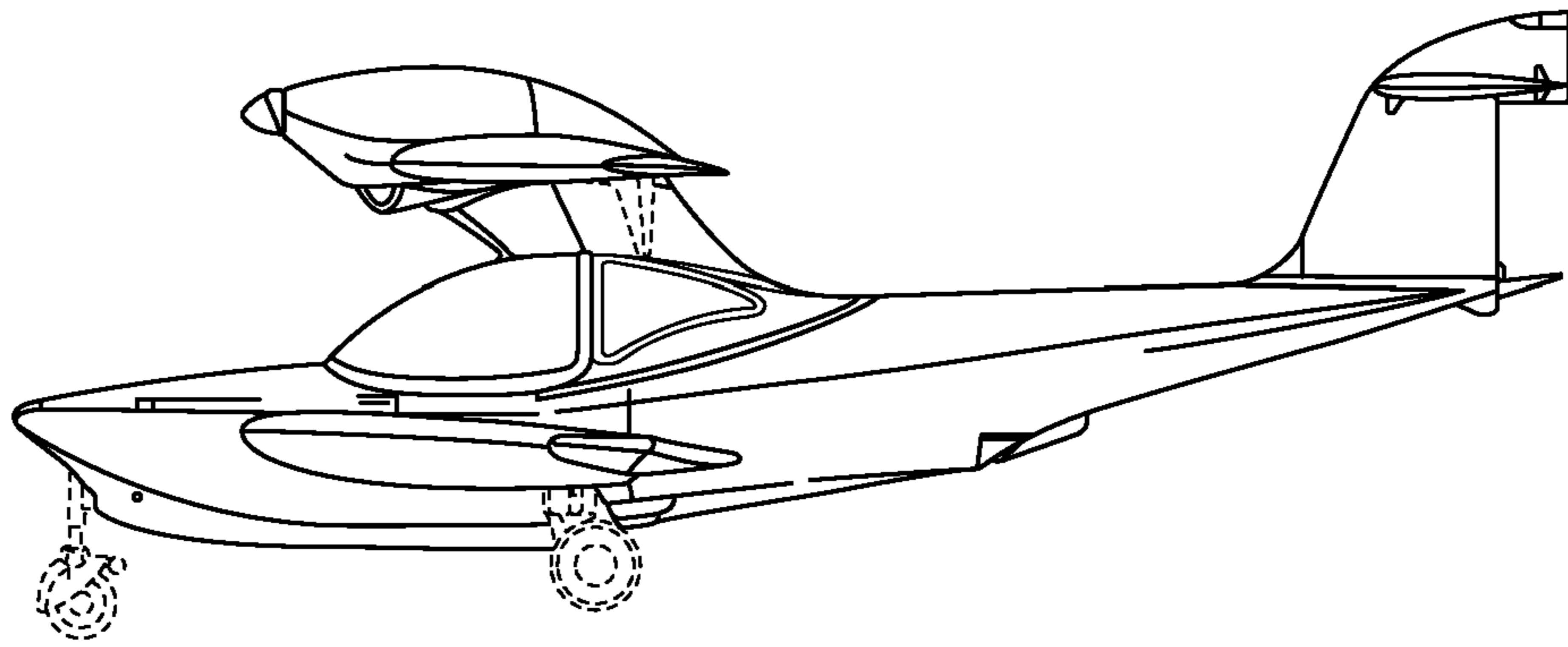

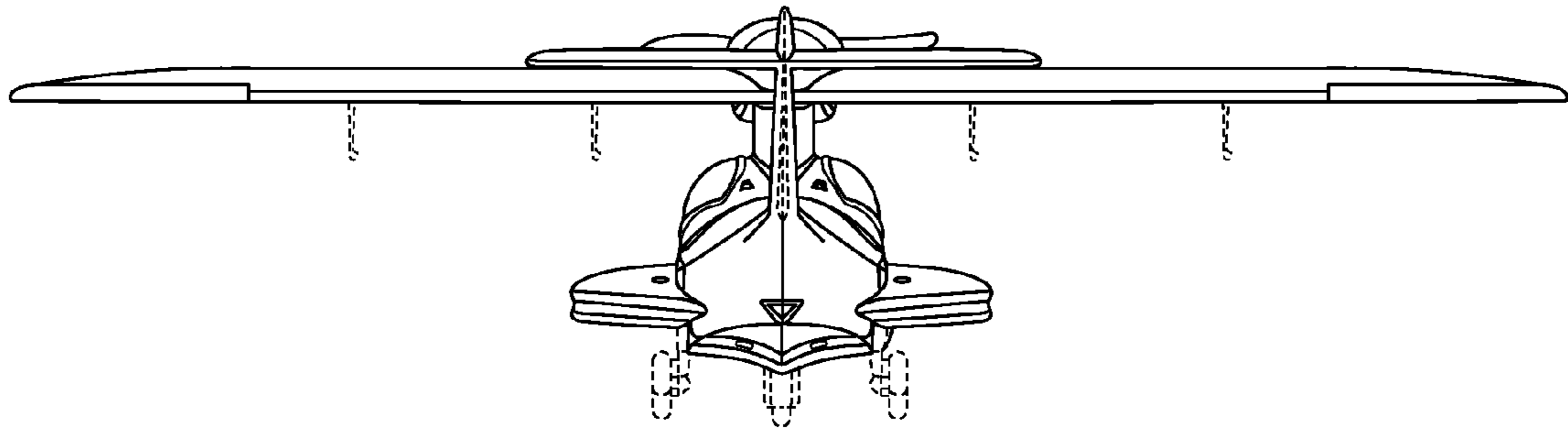

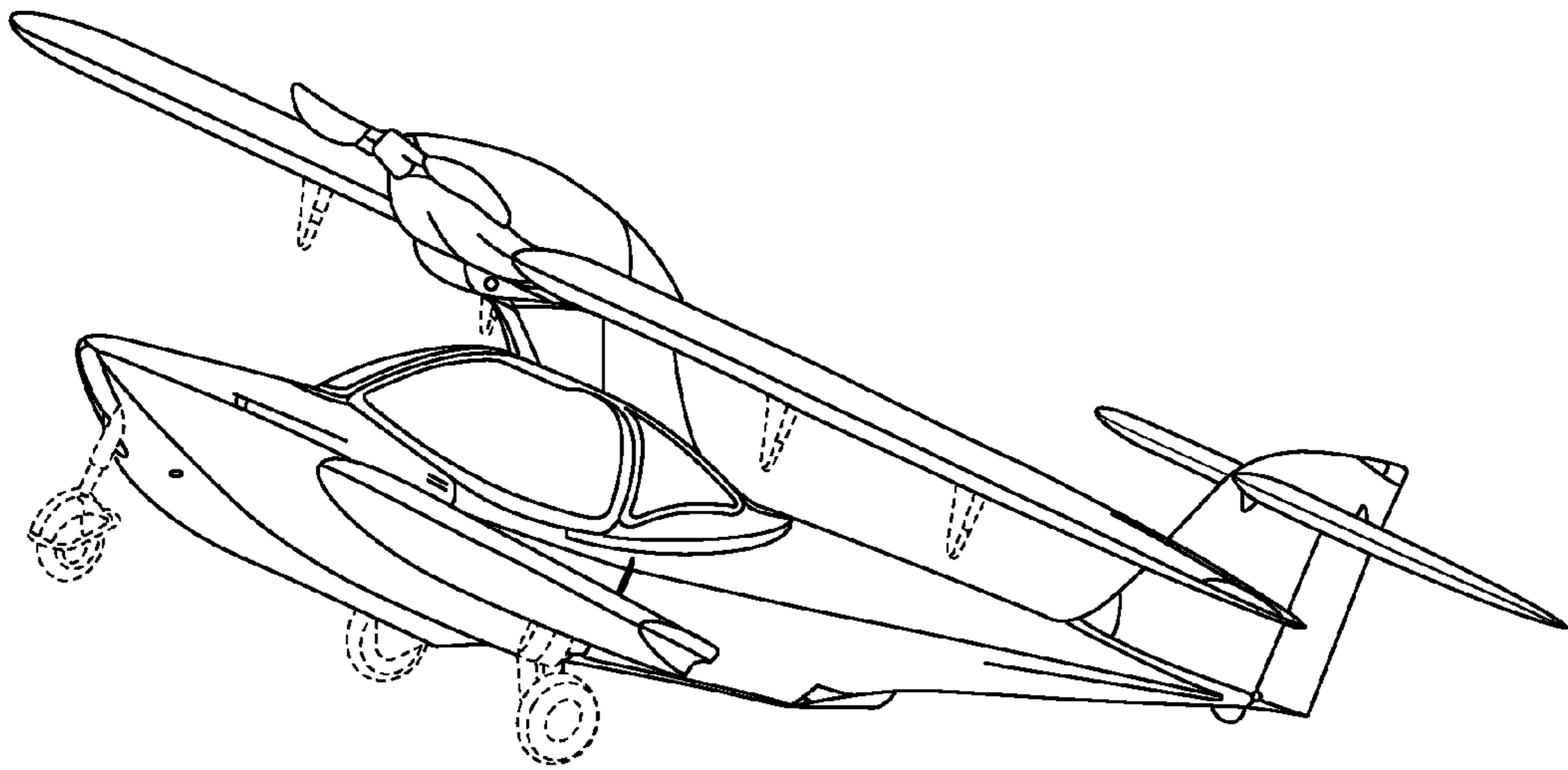

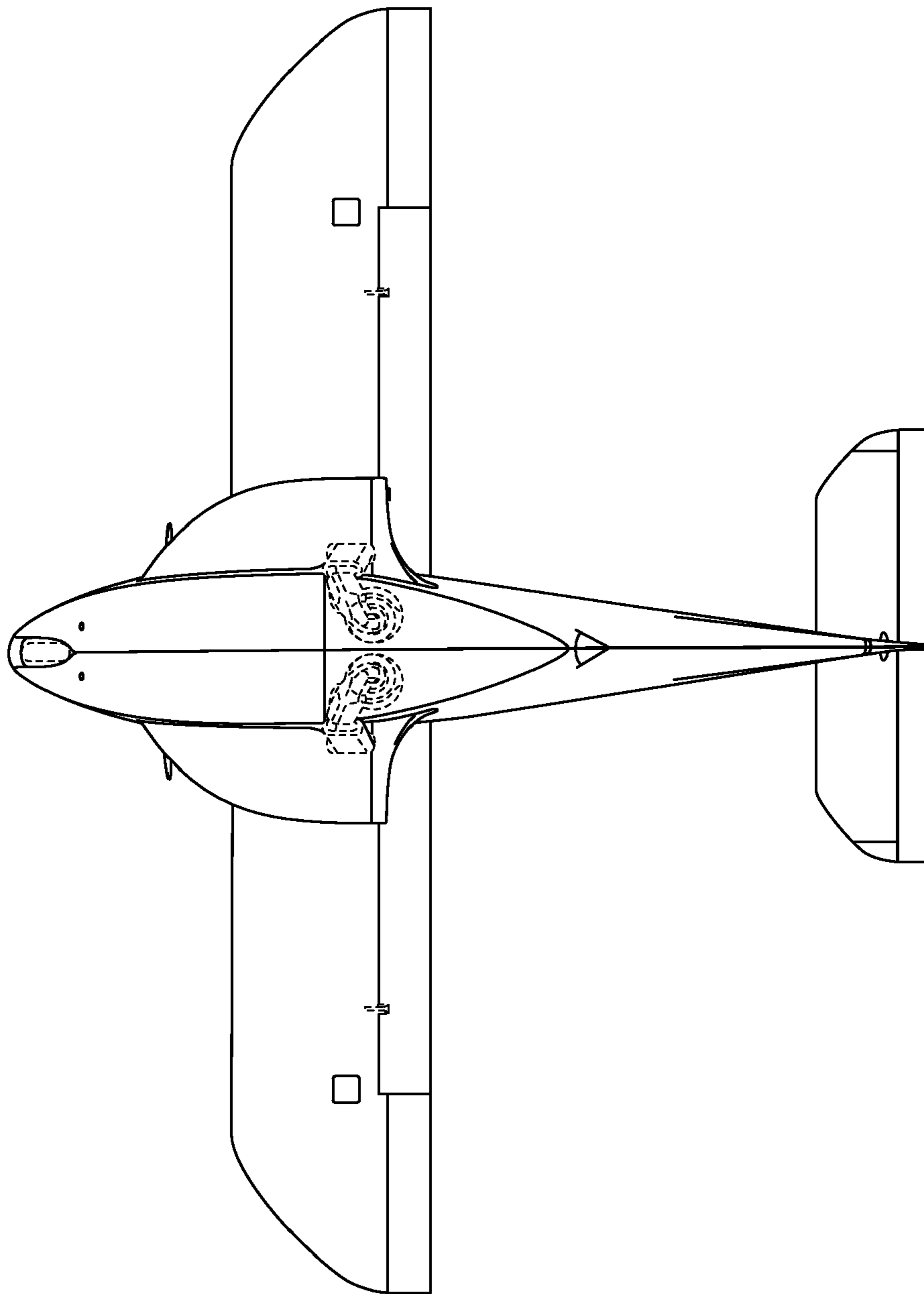
