DESCRIPTION

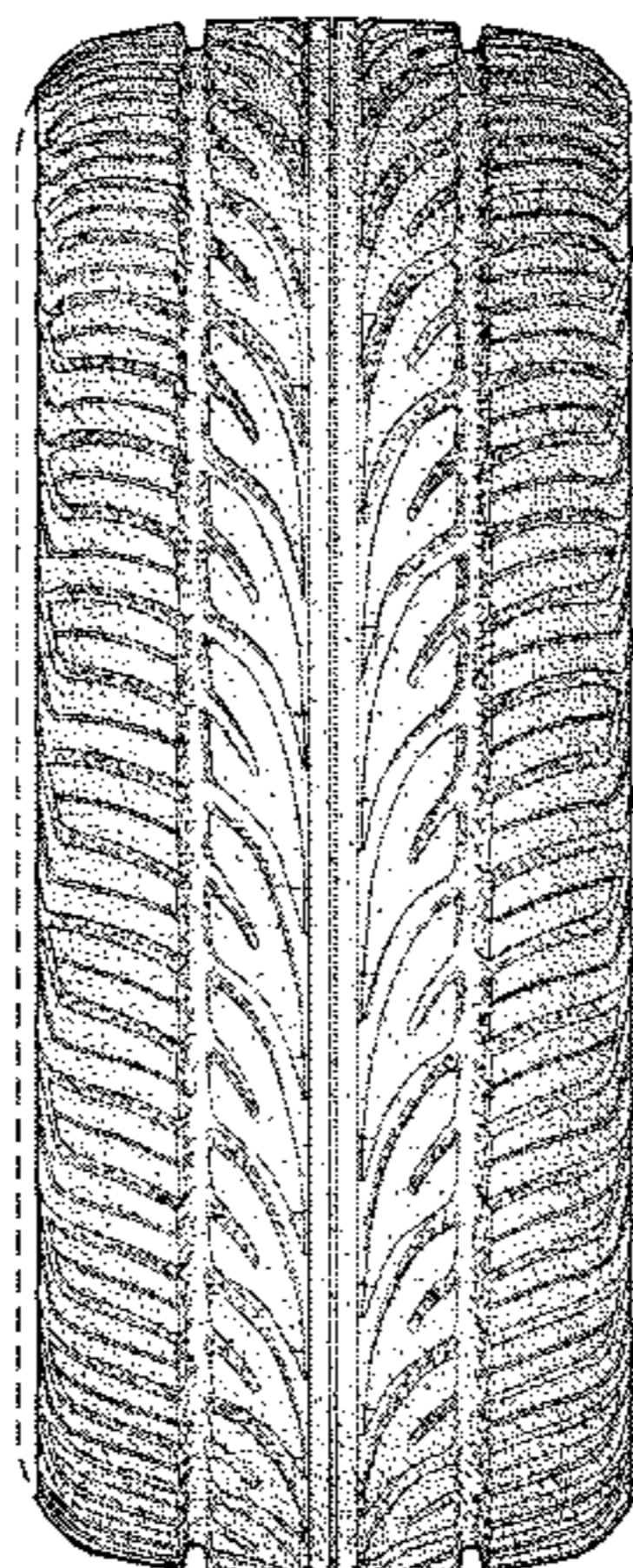

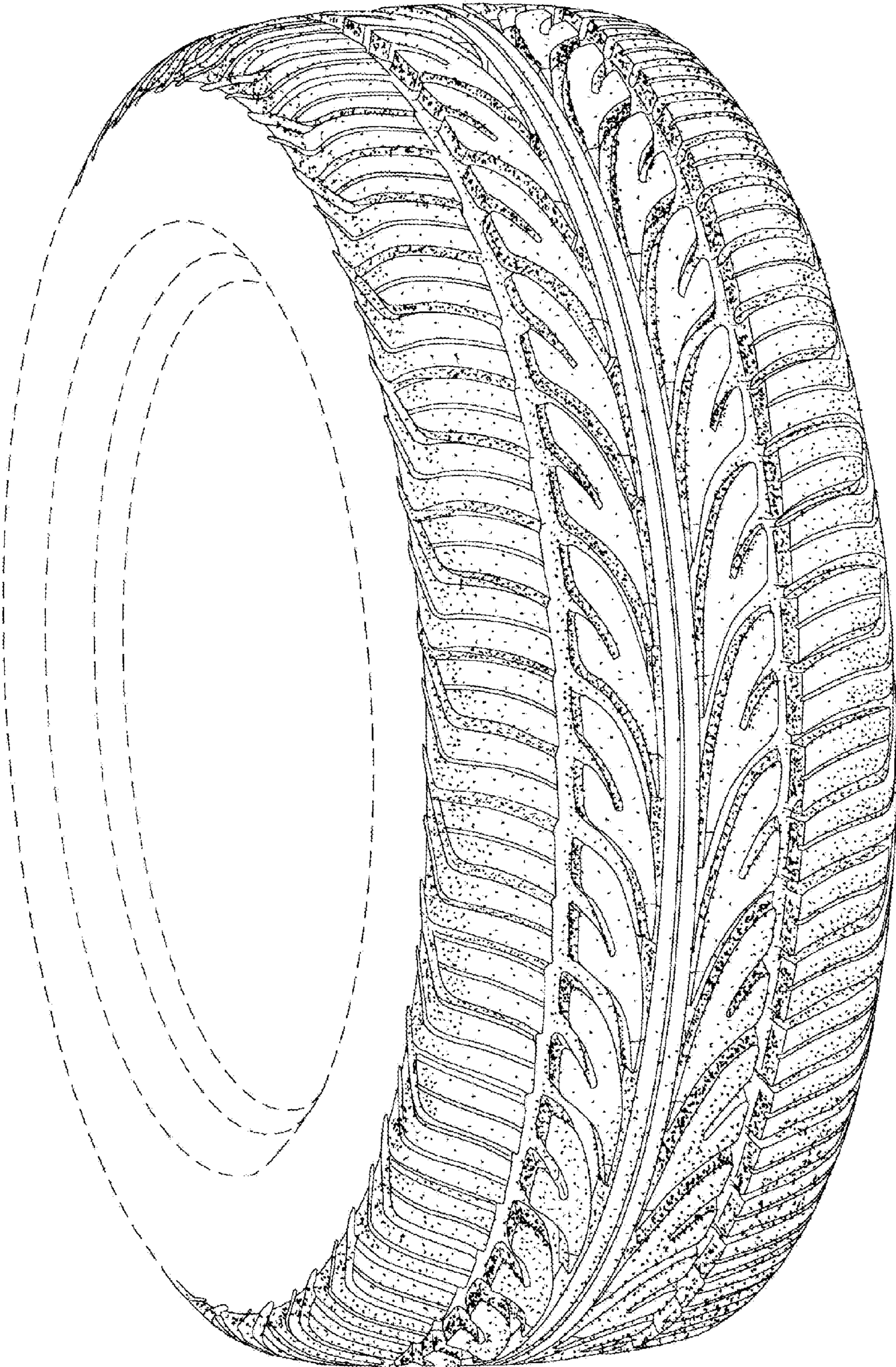

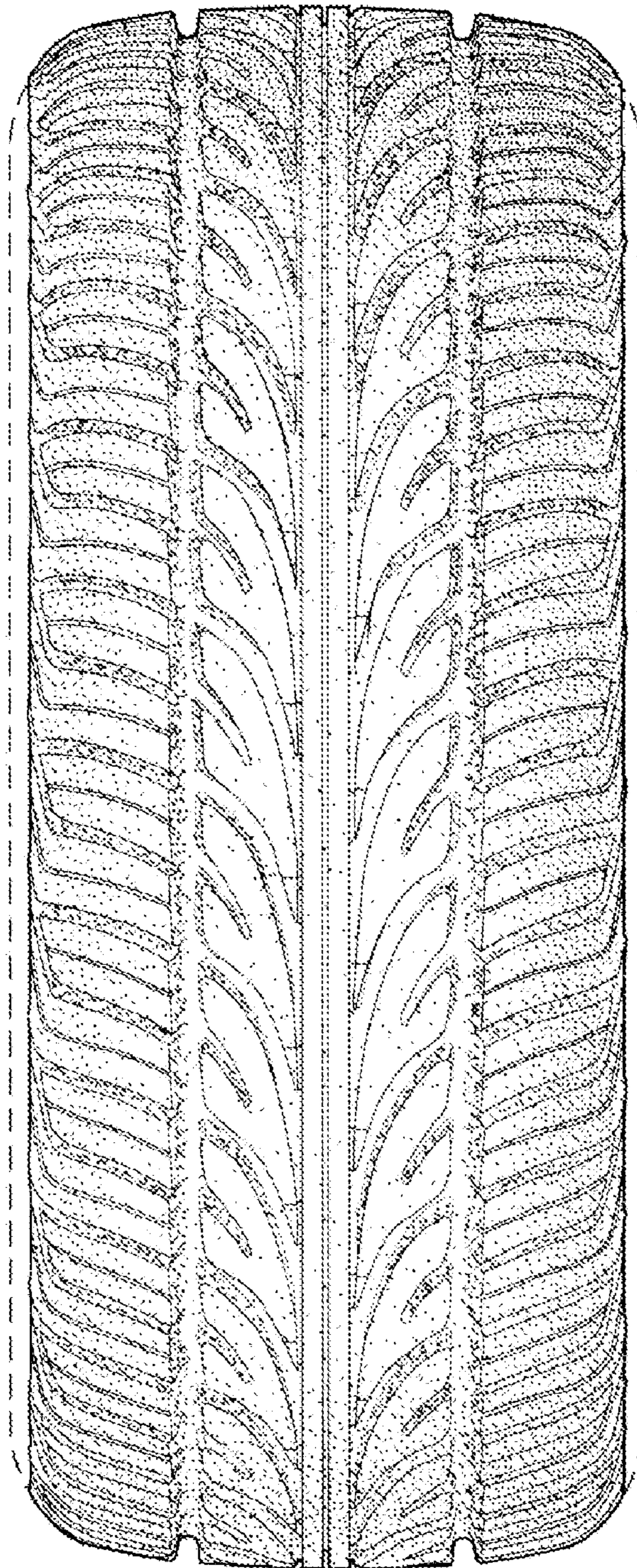

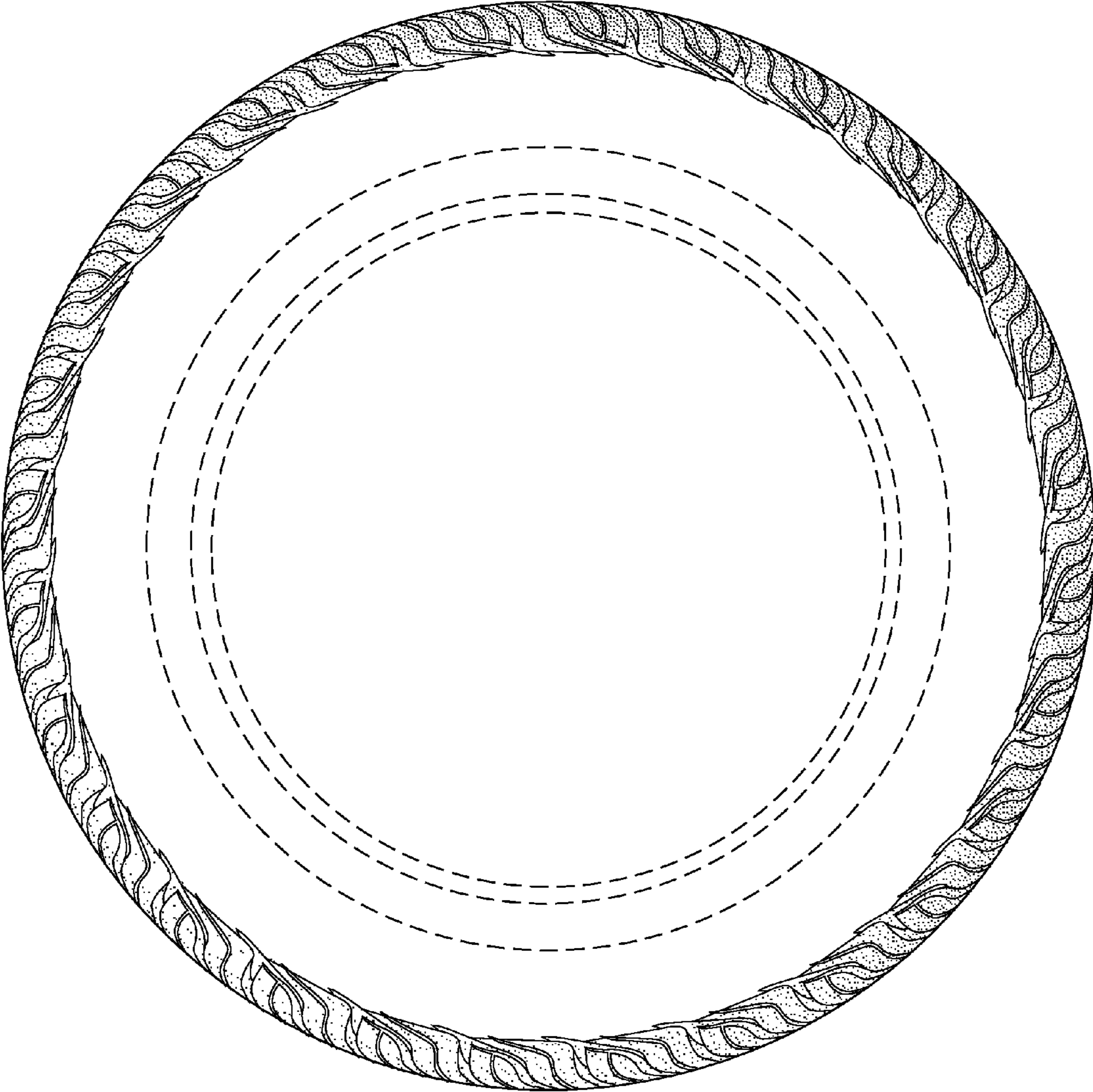

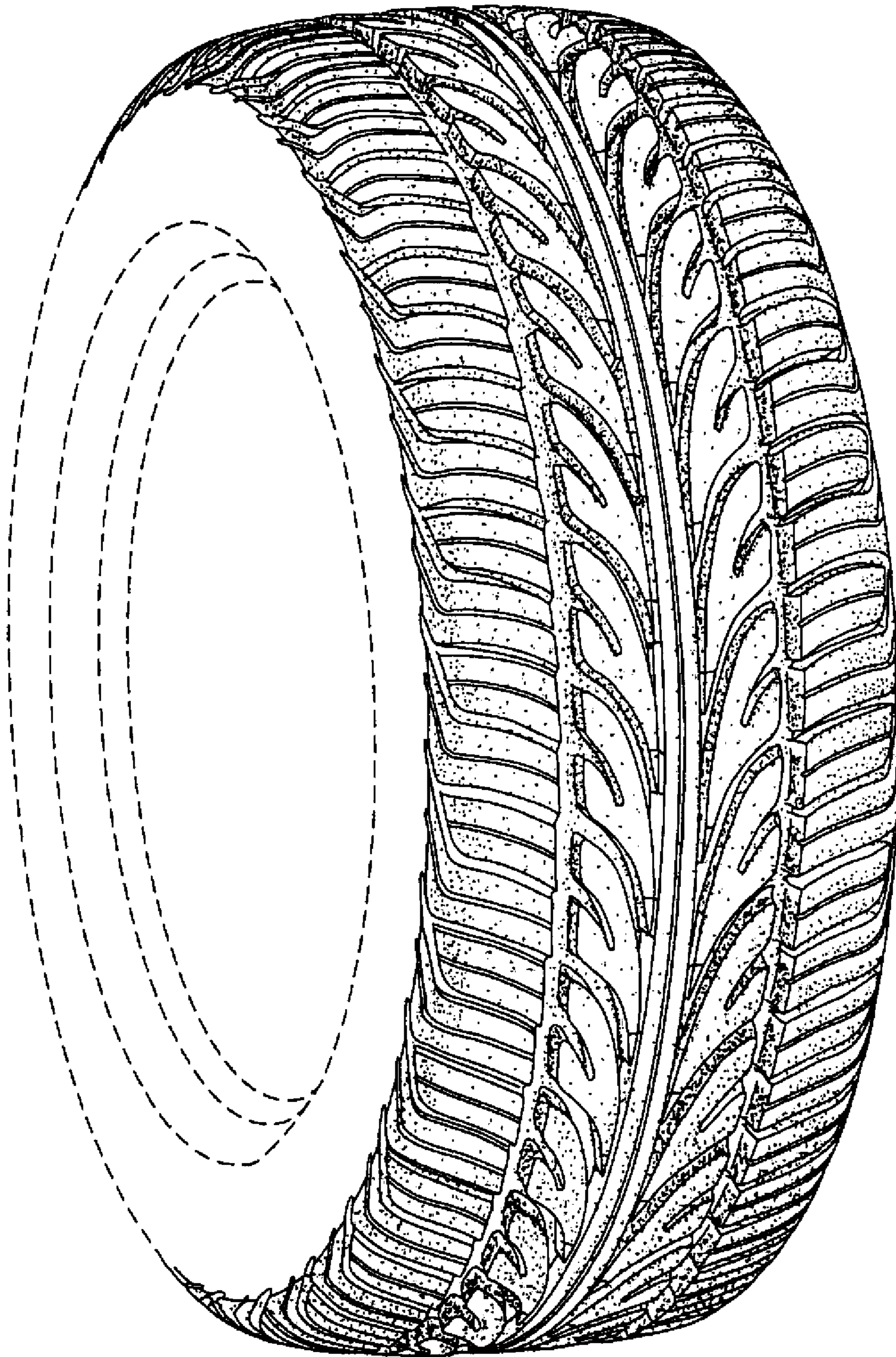

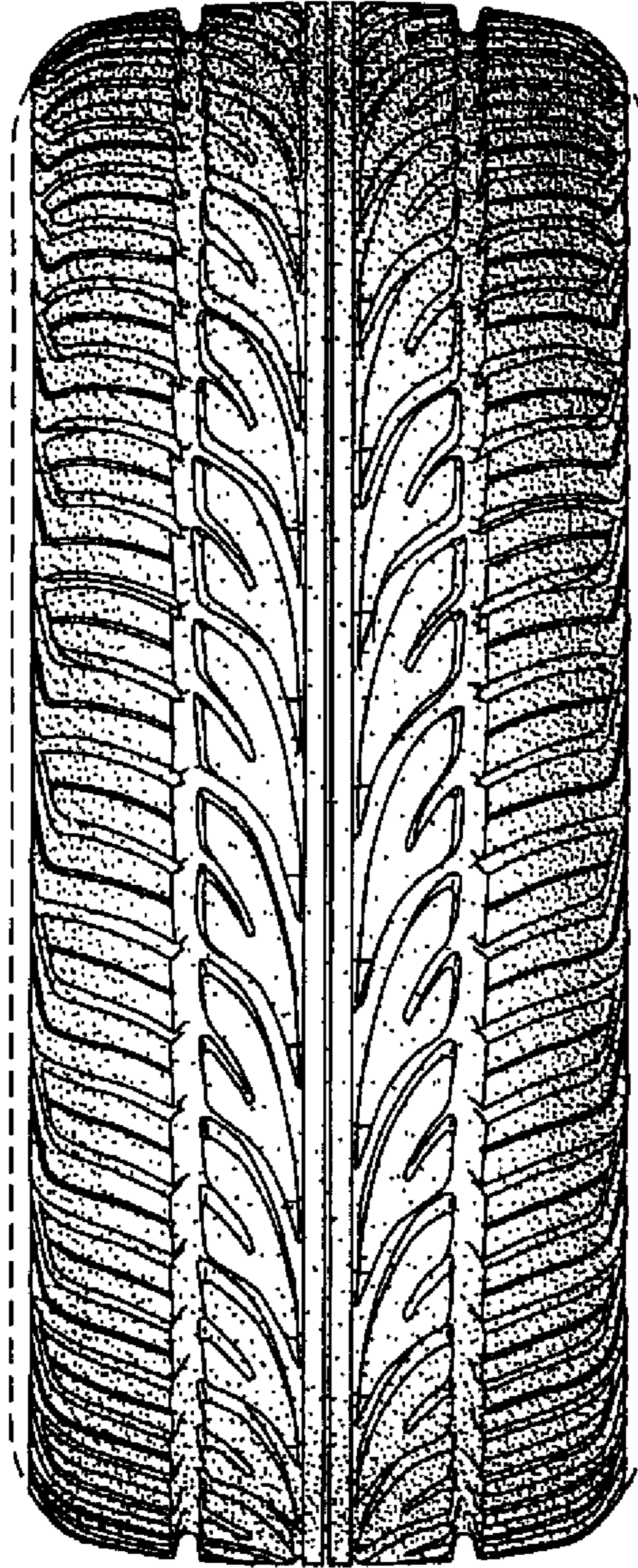

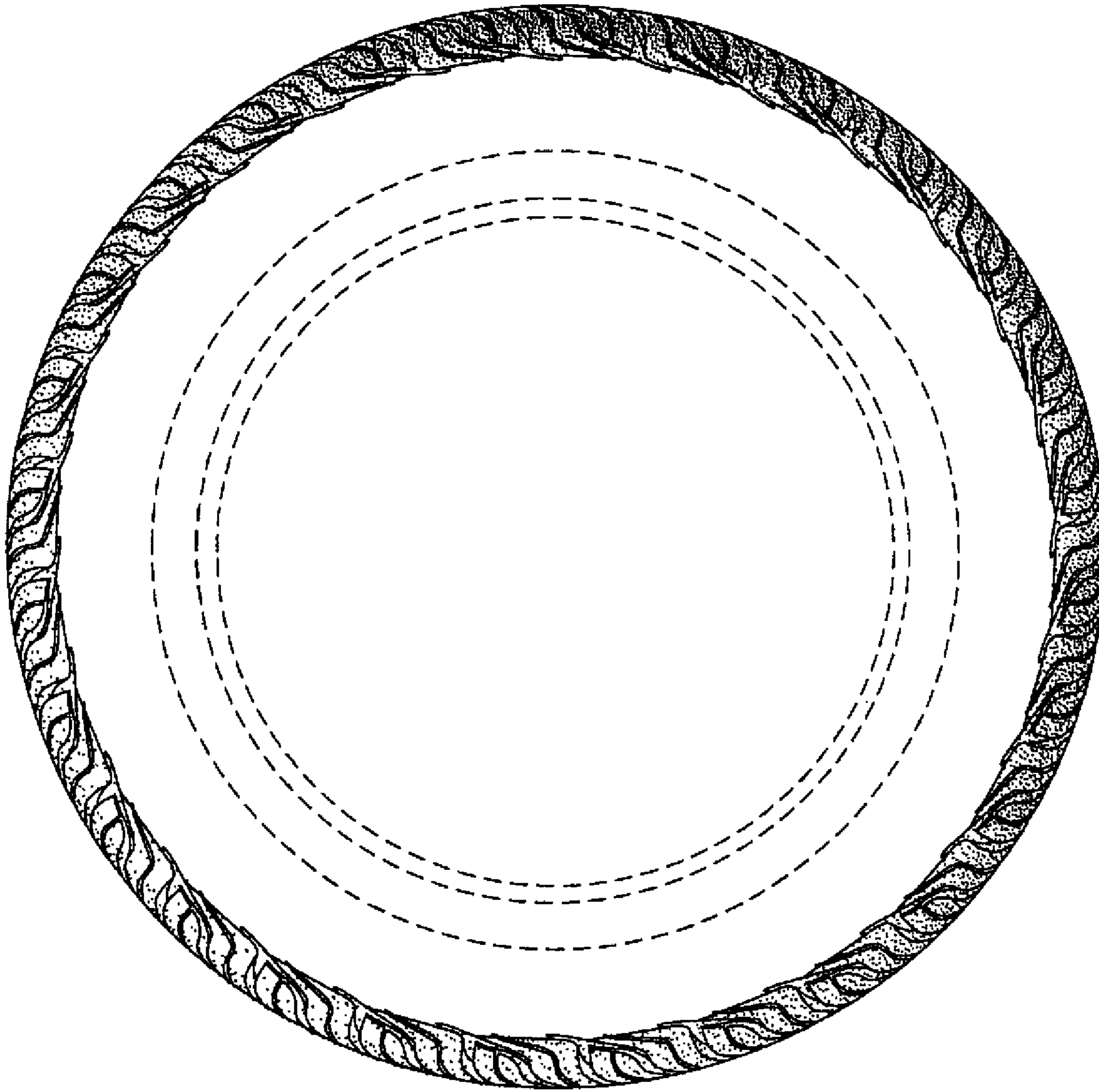

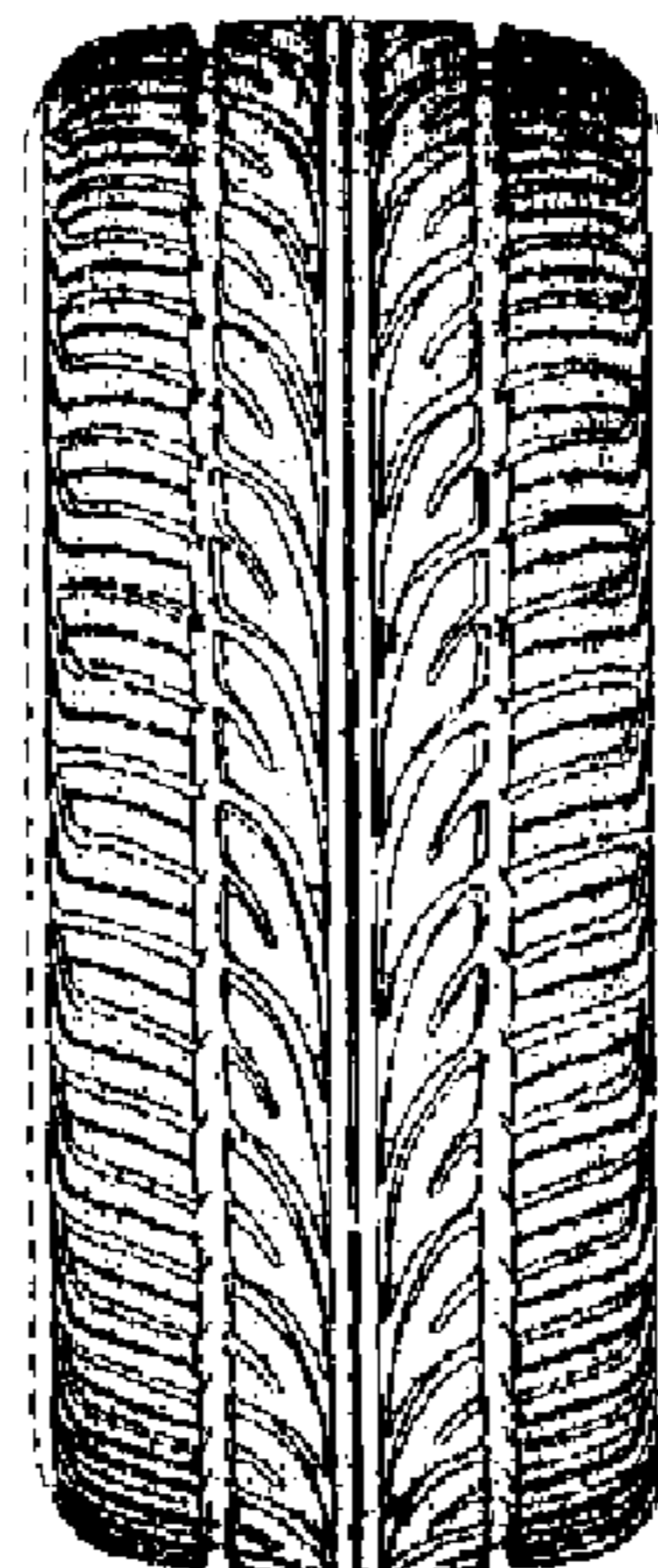

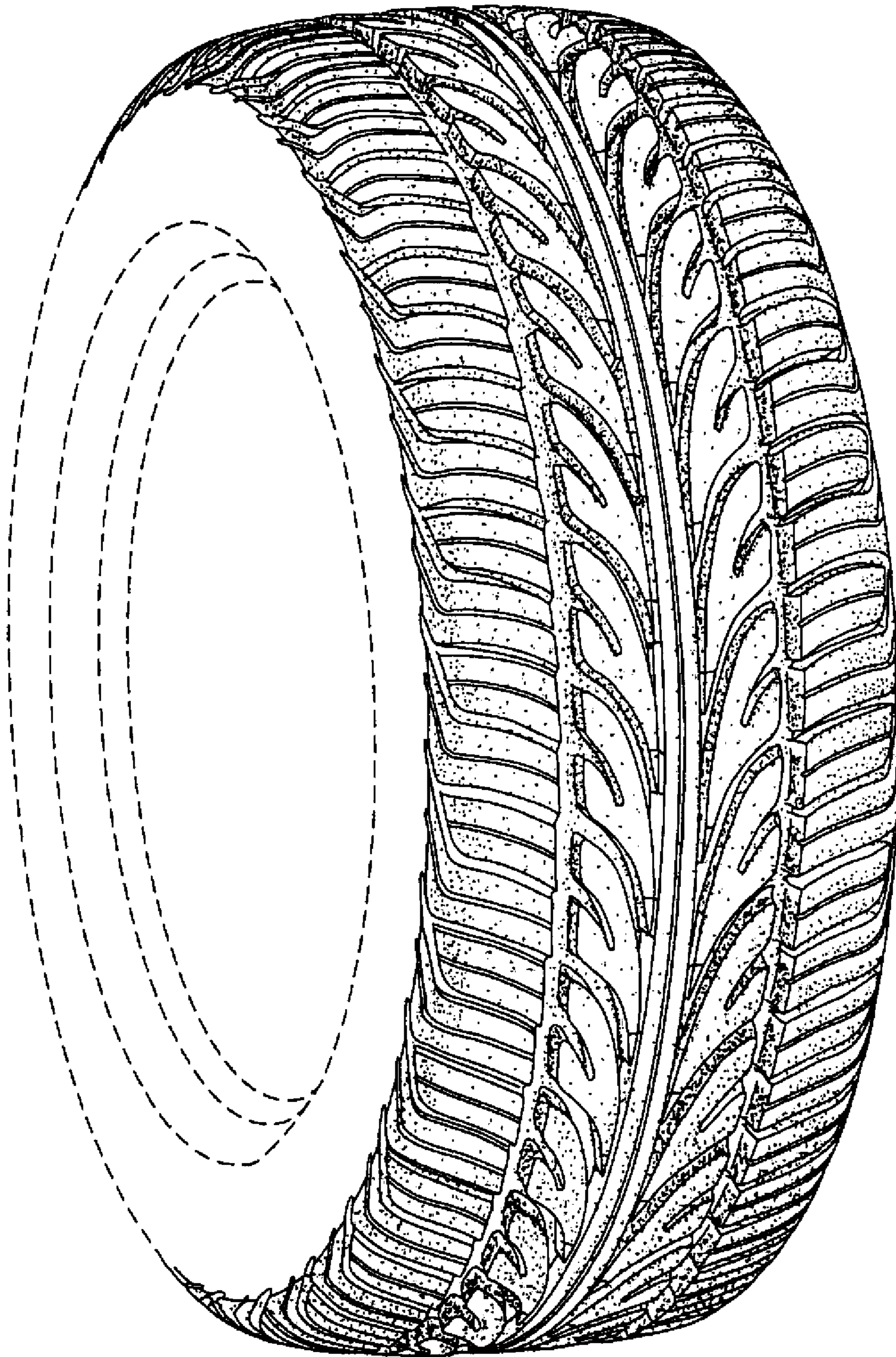

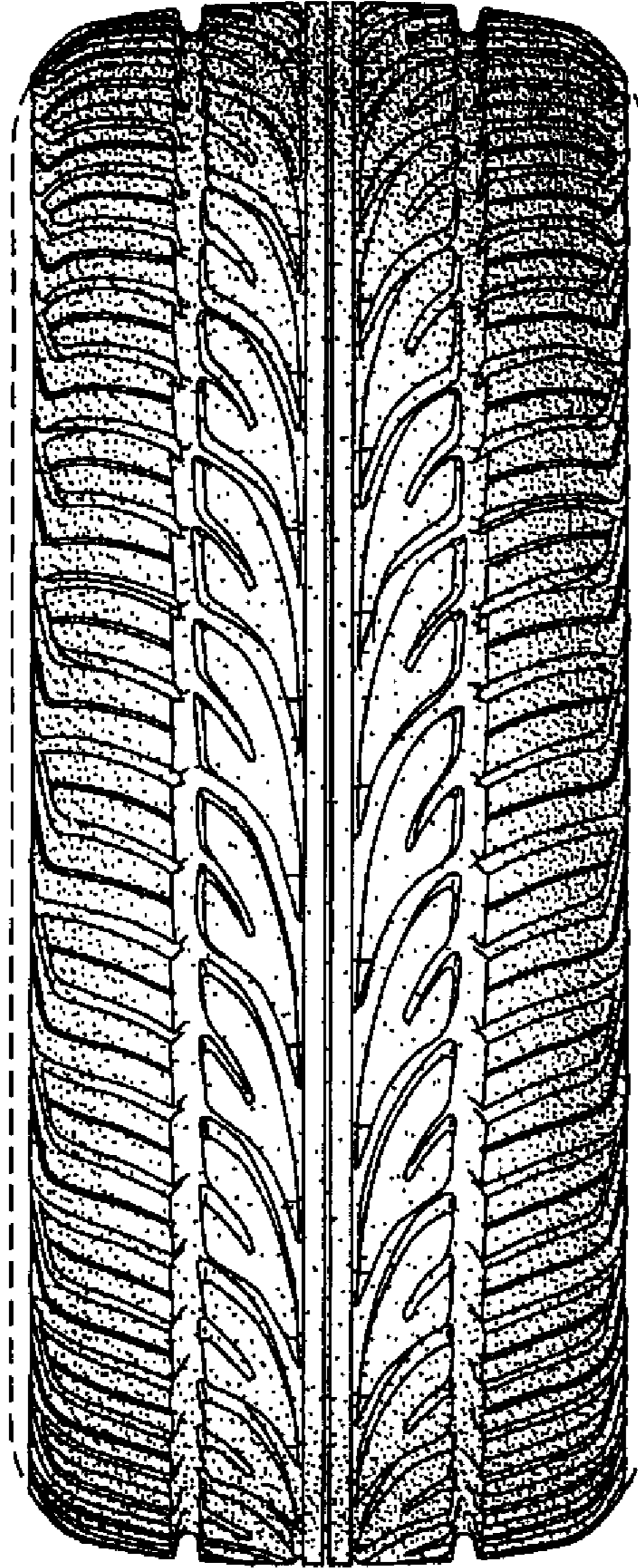

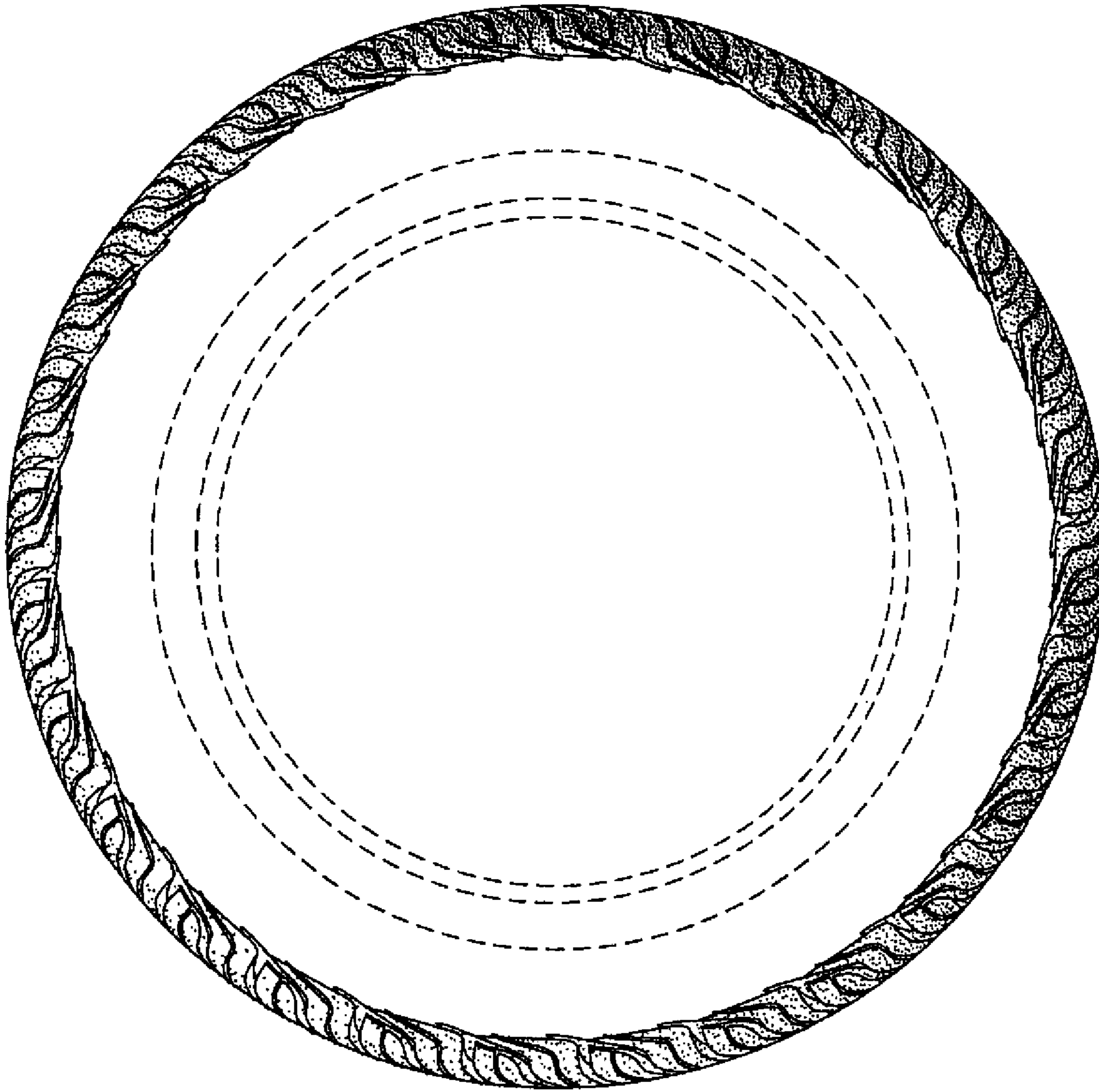
