**DESCRIPTION**

FIG. 1 is a front perspective view of an inverter showing my new design;

FIG. 2 is an elevated front view thereof;

FIG. 4 is a top plan view thereof;

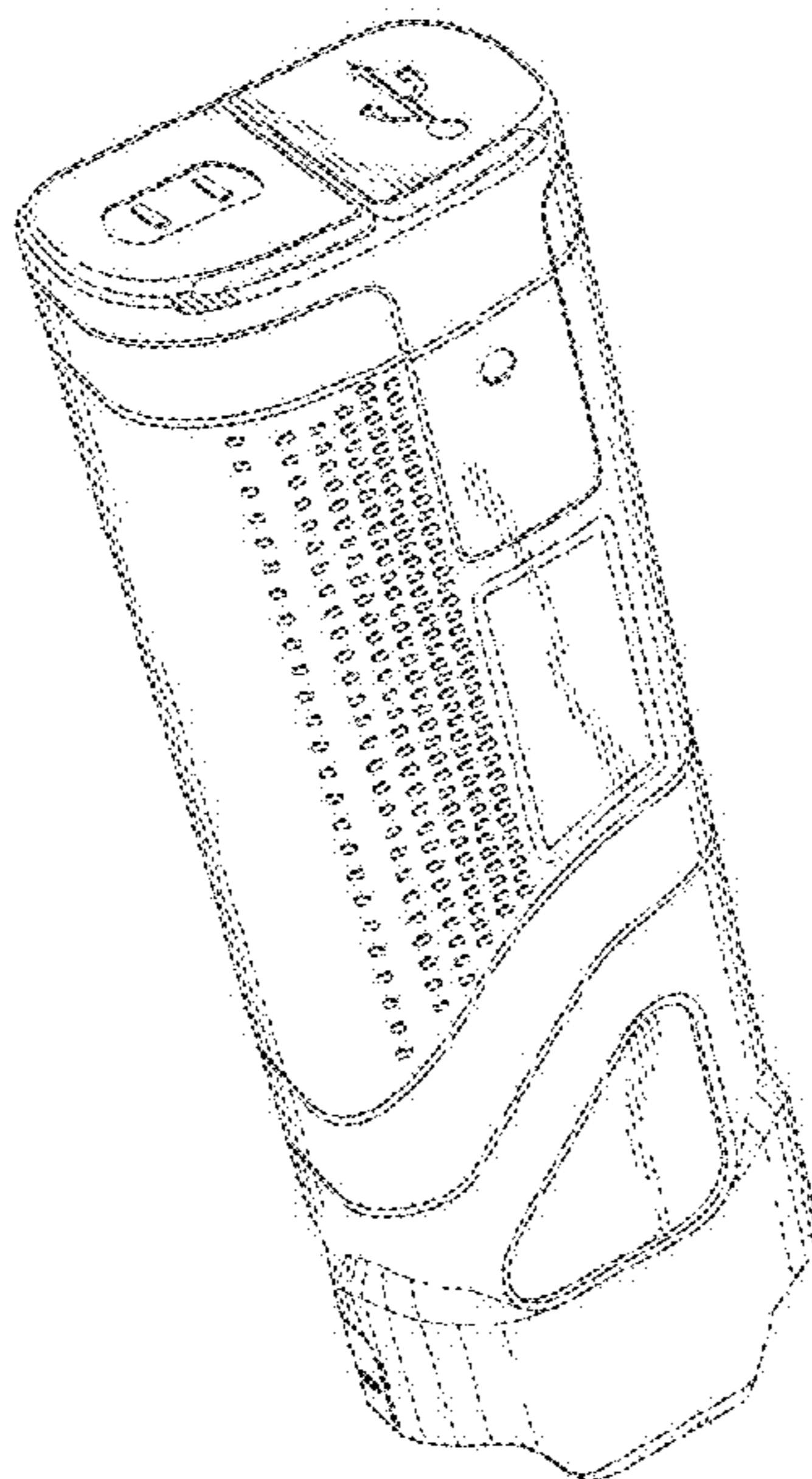
FIG. 5 is a bottom plan view thereof;

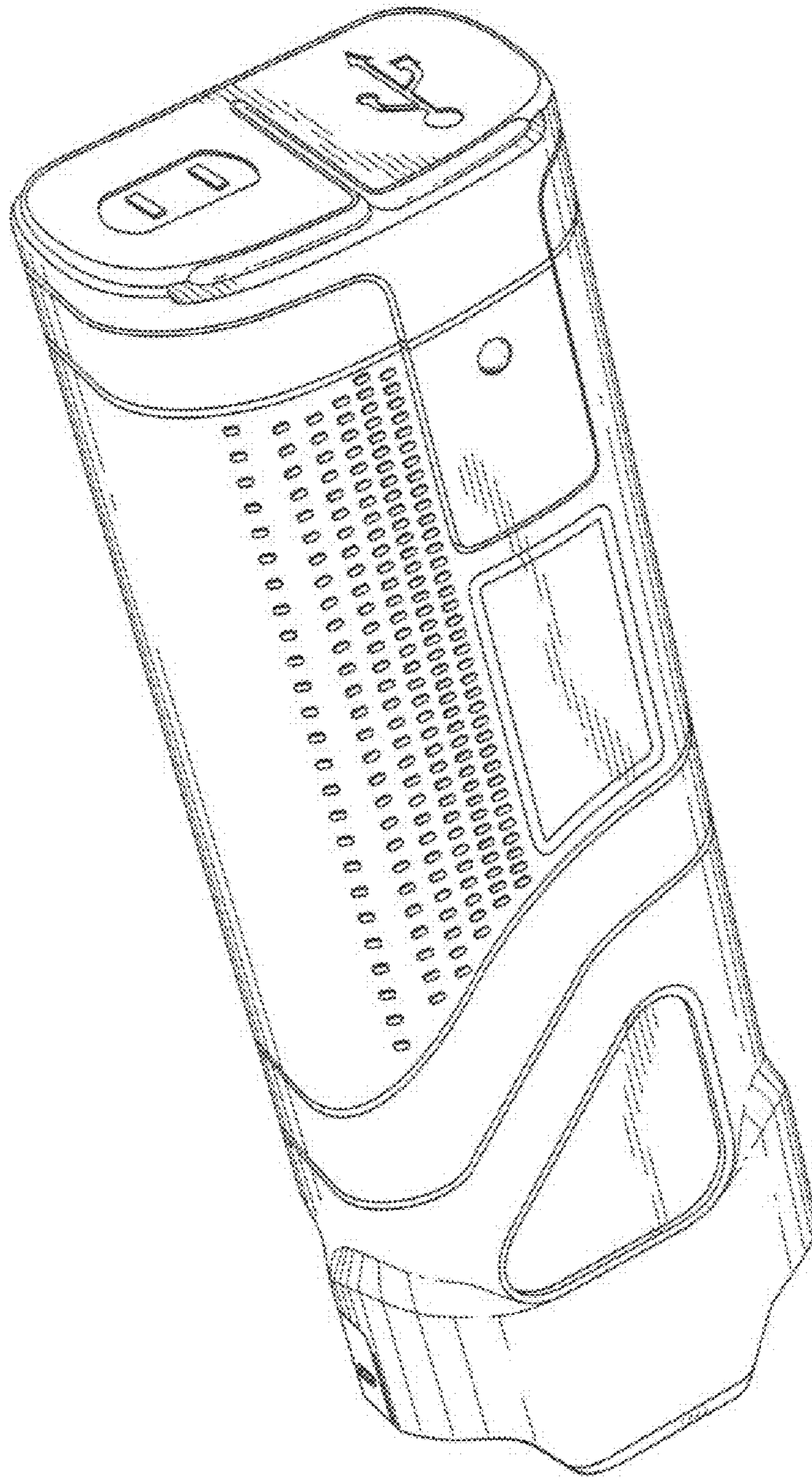

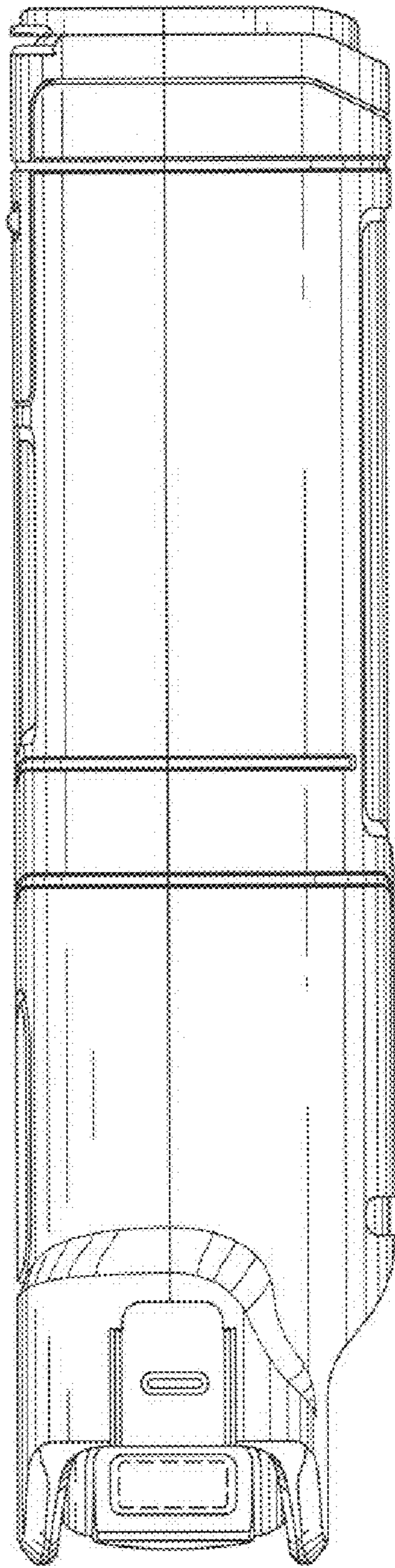

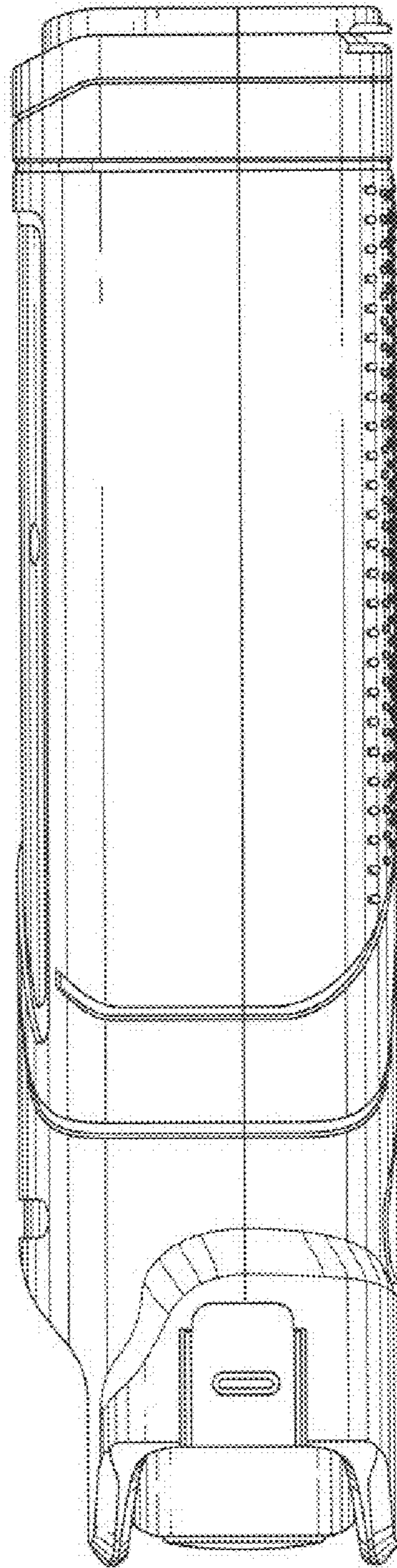

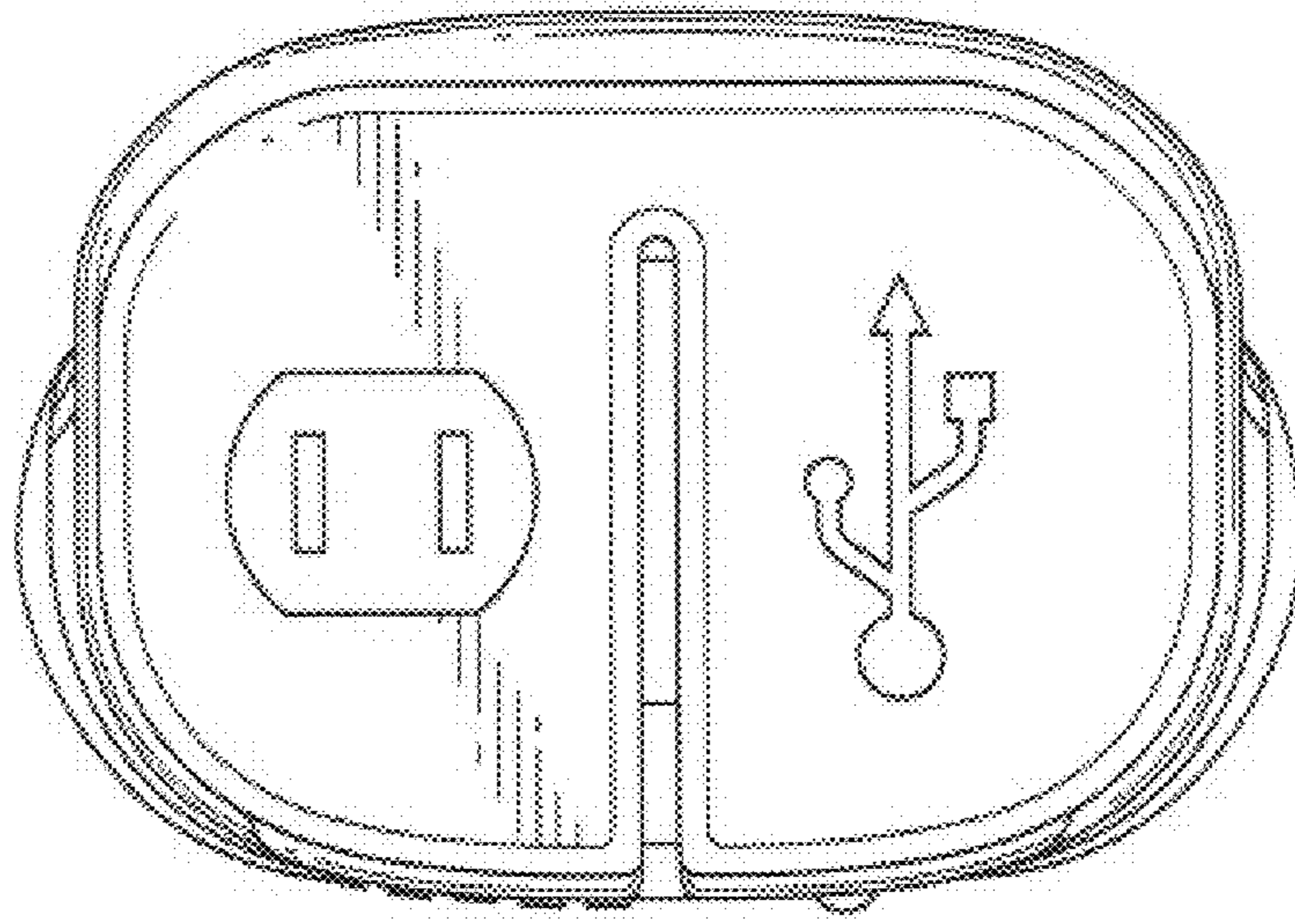

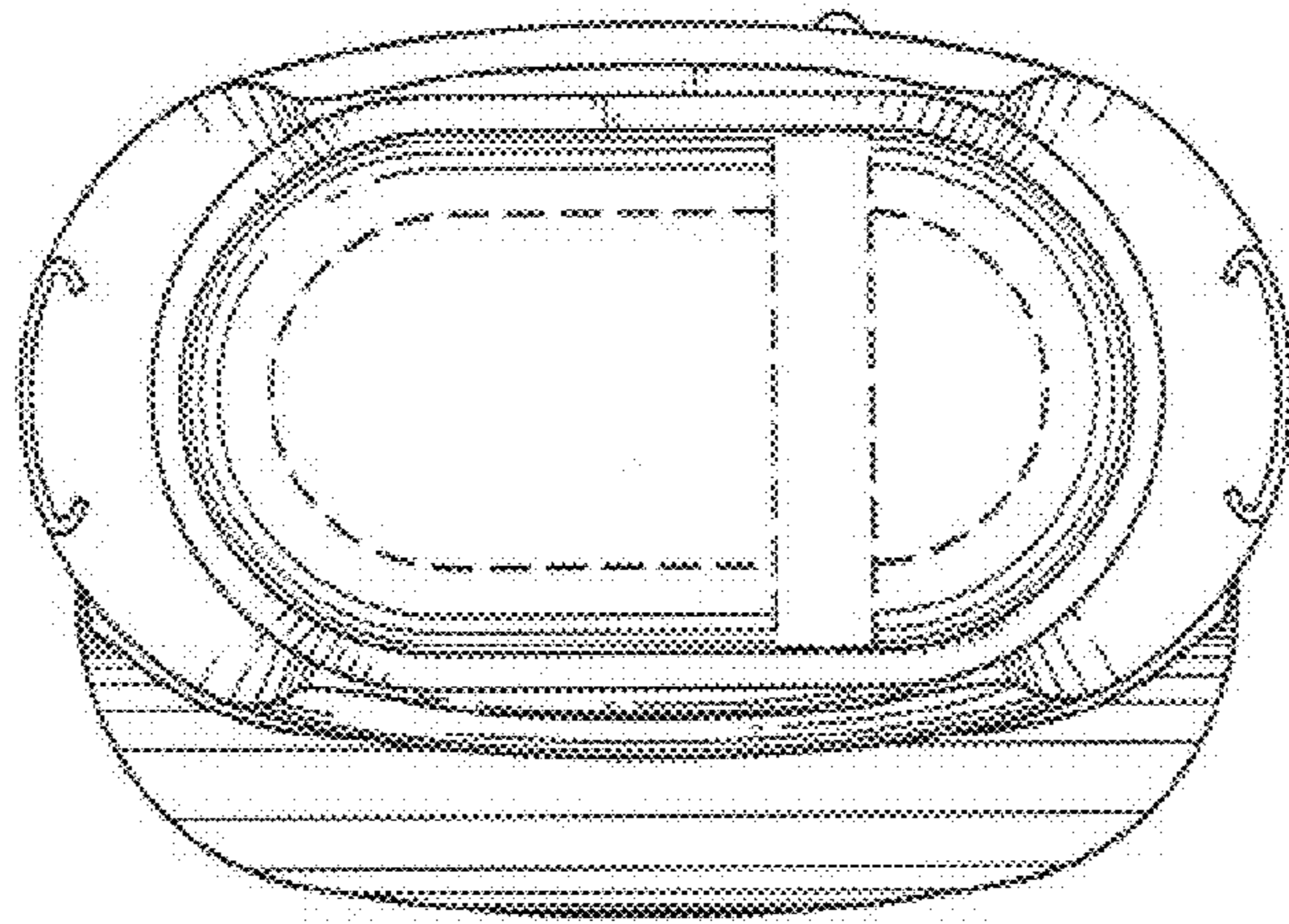

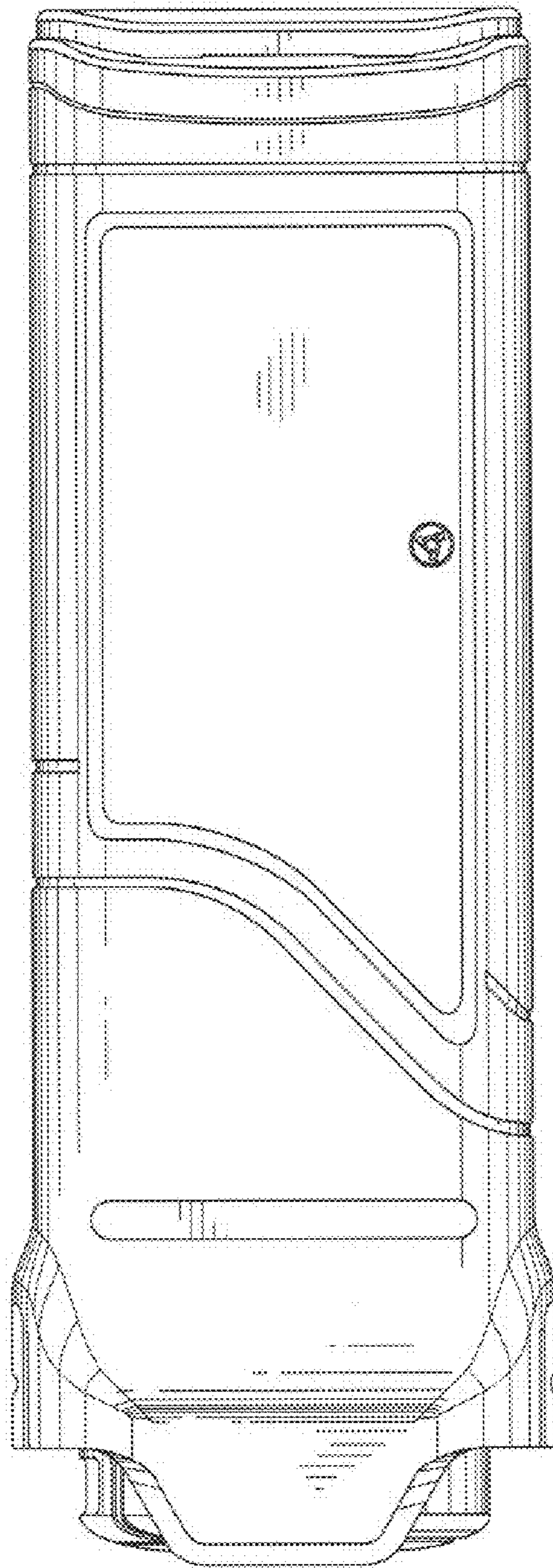

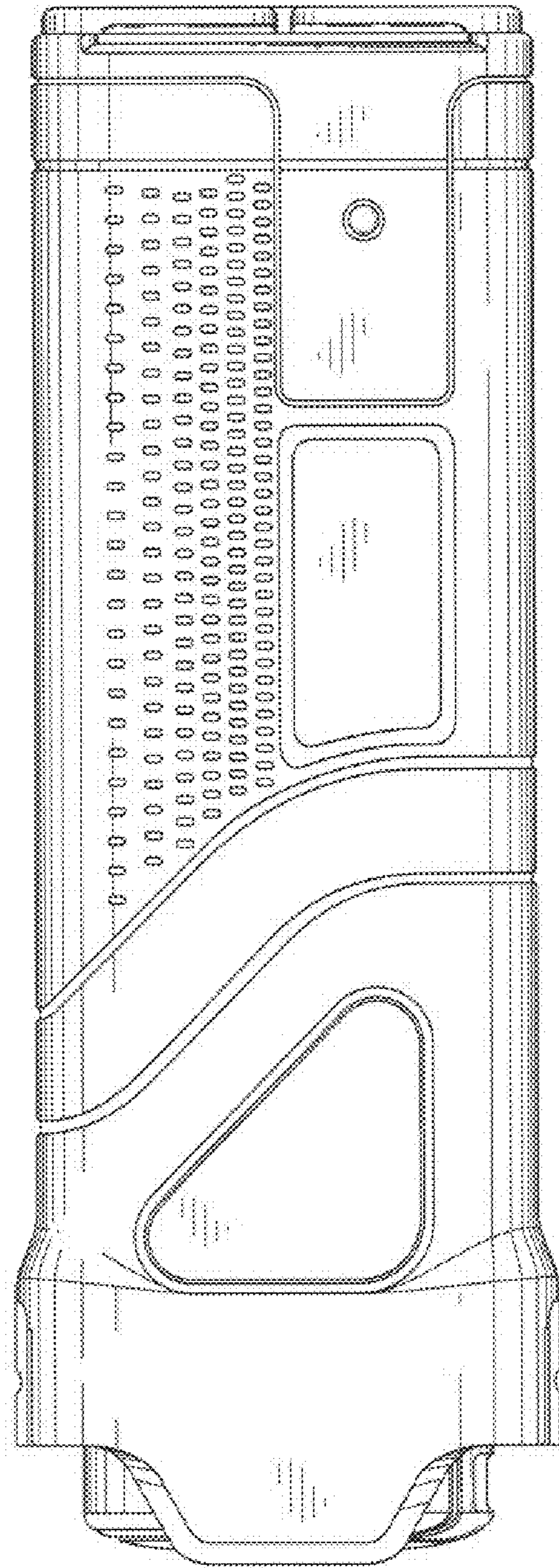
