DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a plug showing our new design;

FIG. 2 is a bottom, front and right side perspective view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

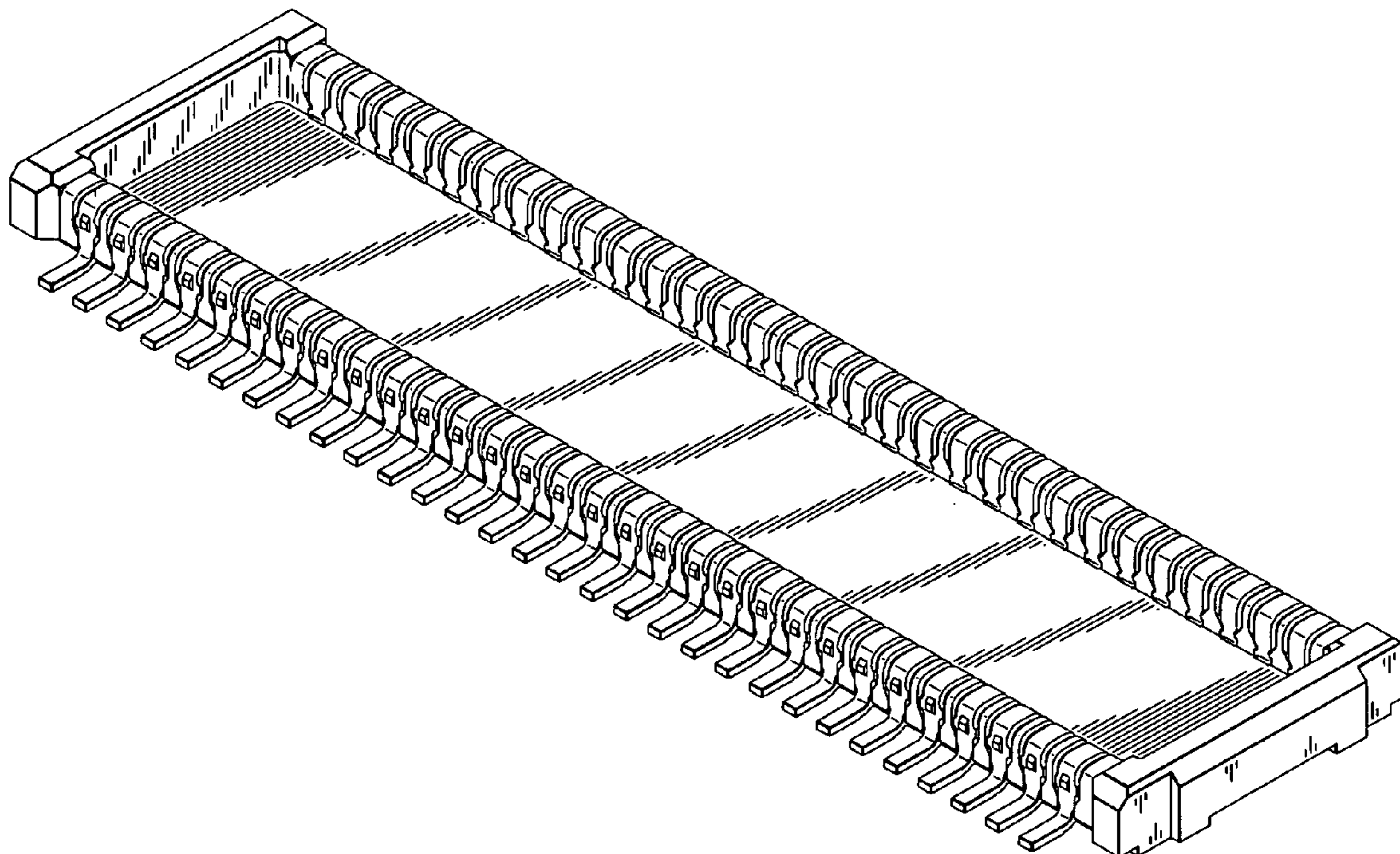
FIG. 6 is a right side elevational view thereof.

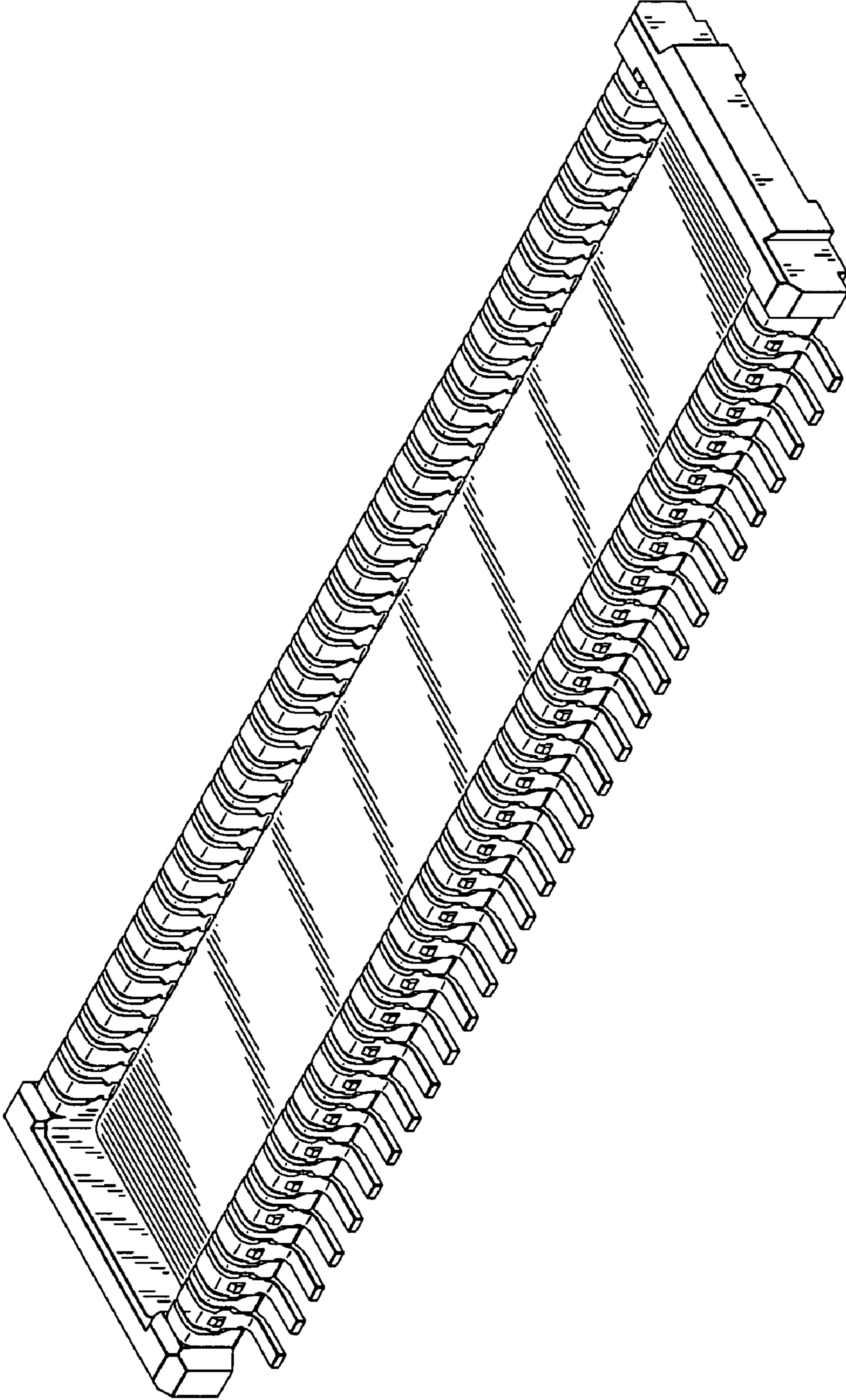

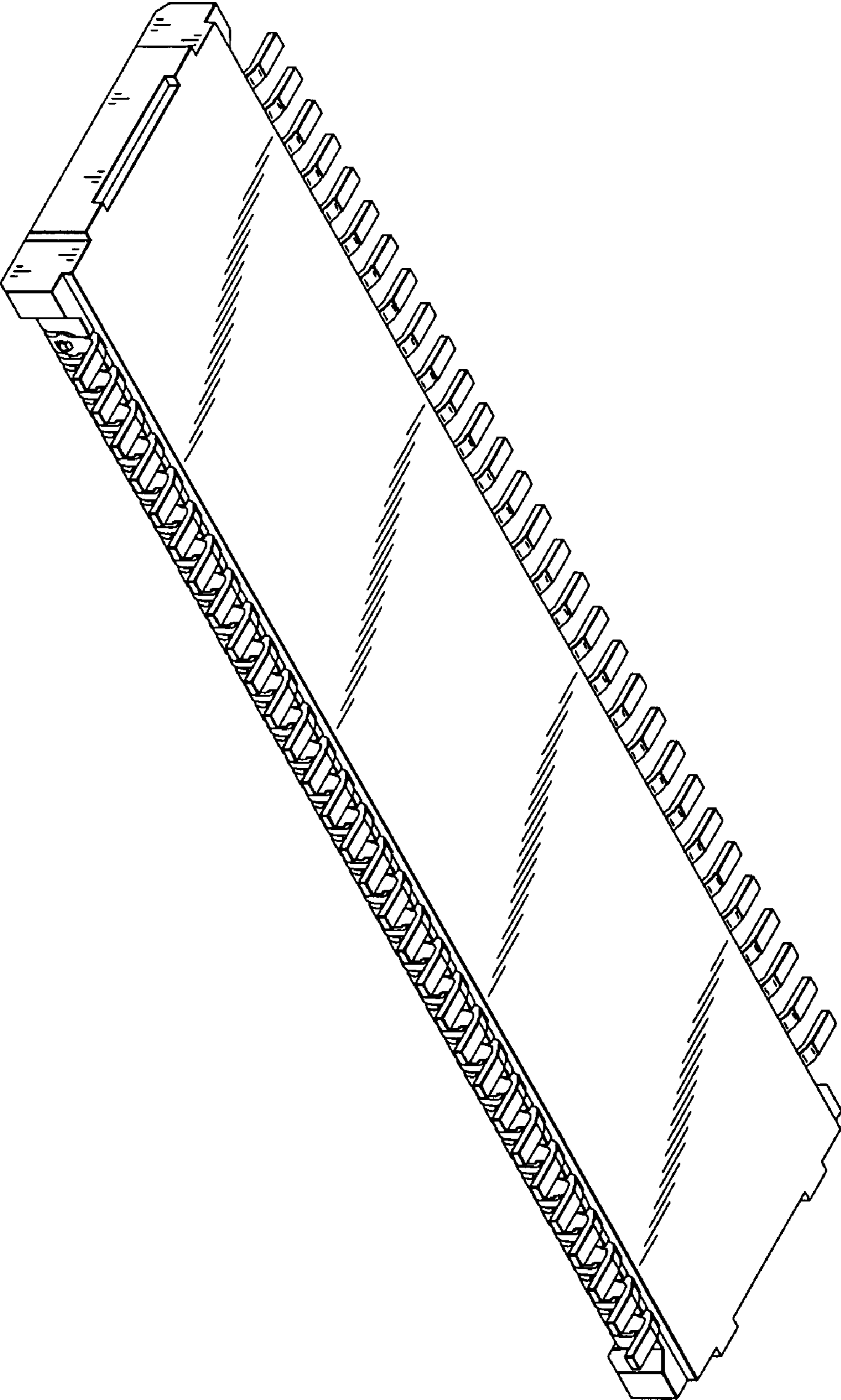

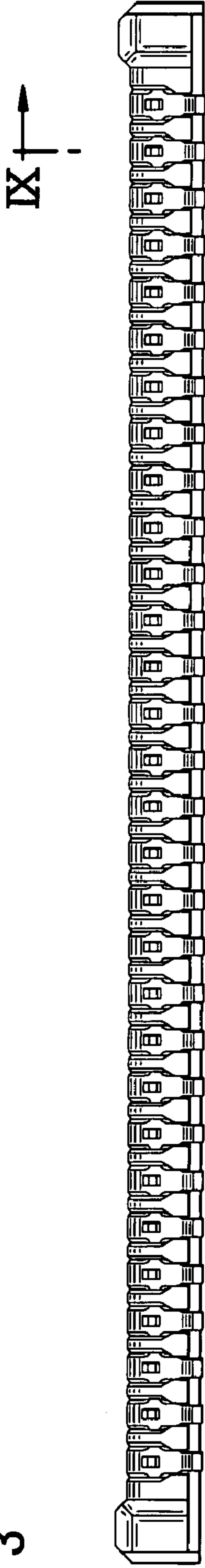

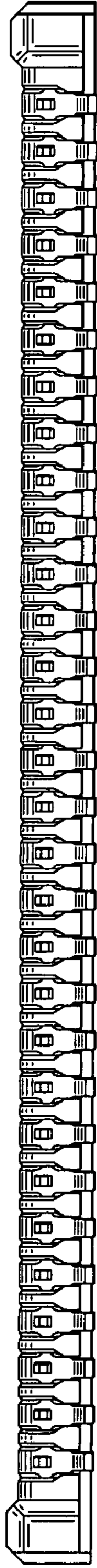

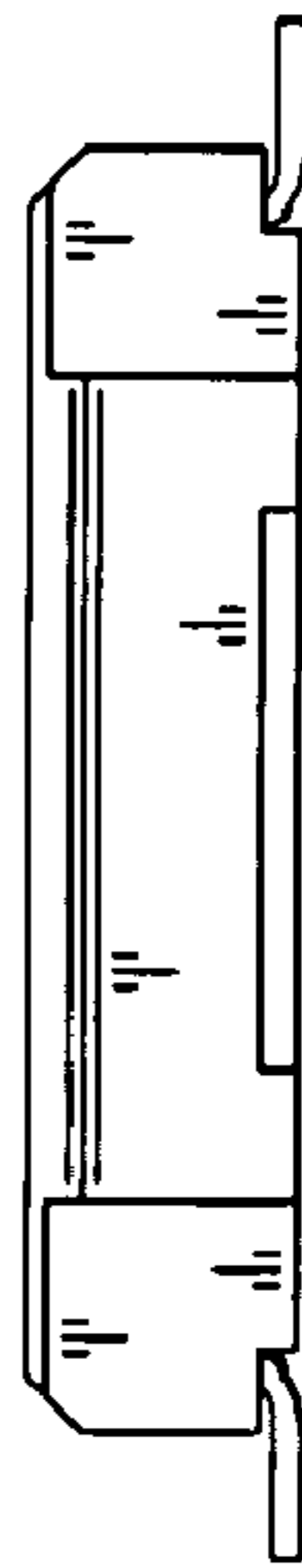
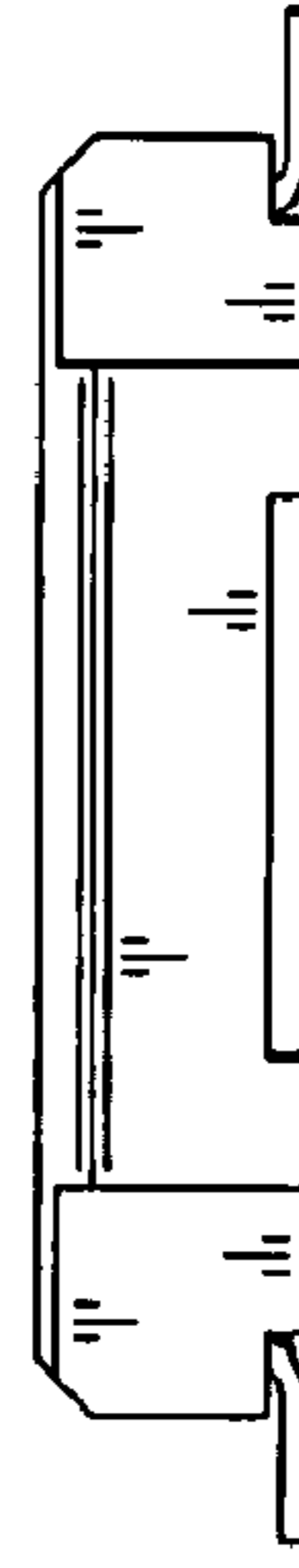

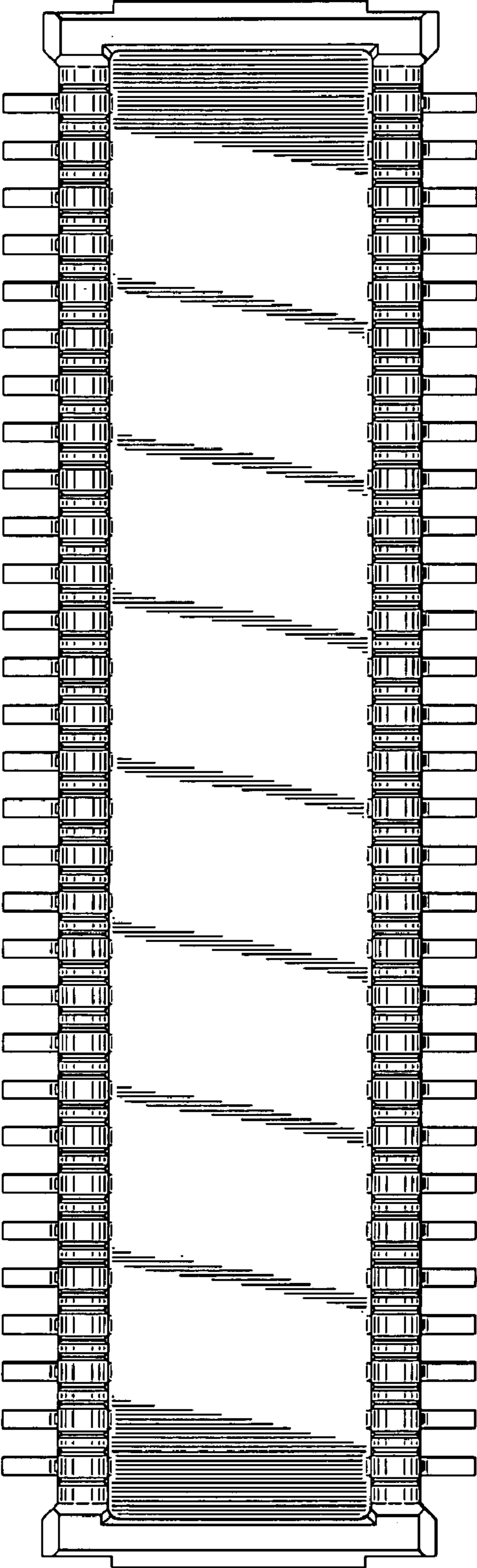

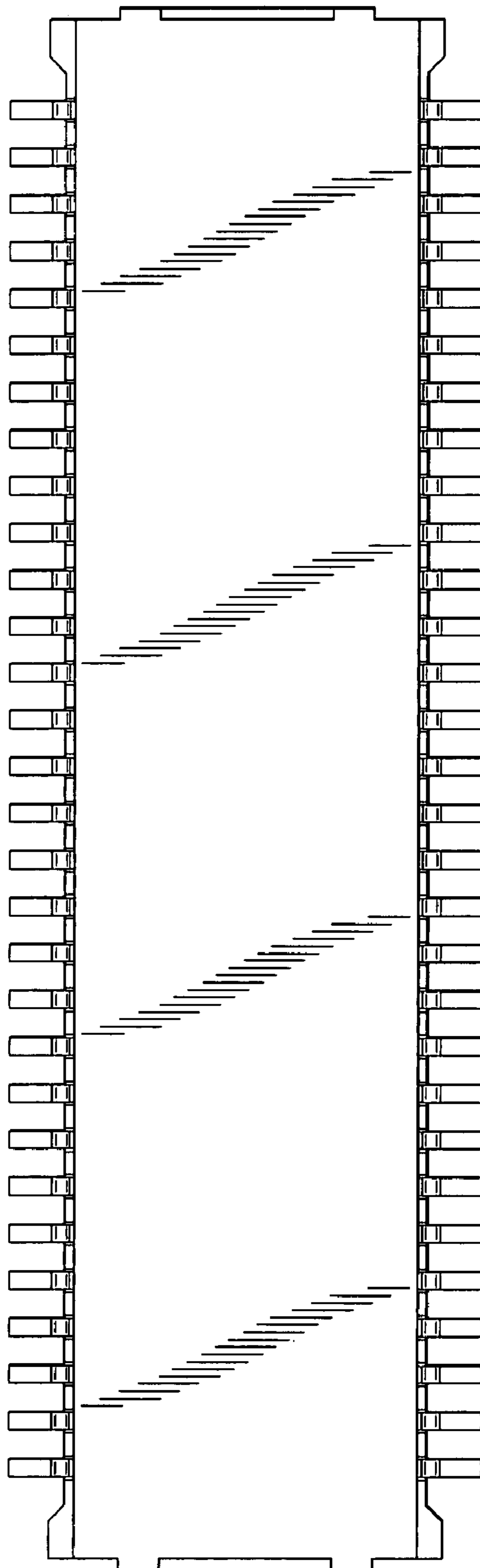

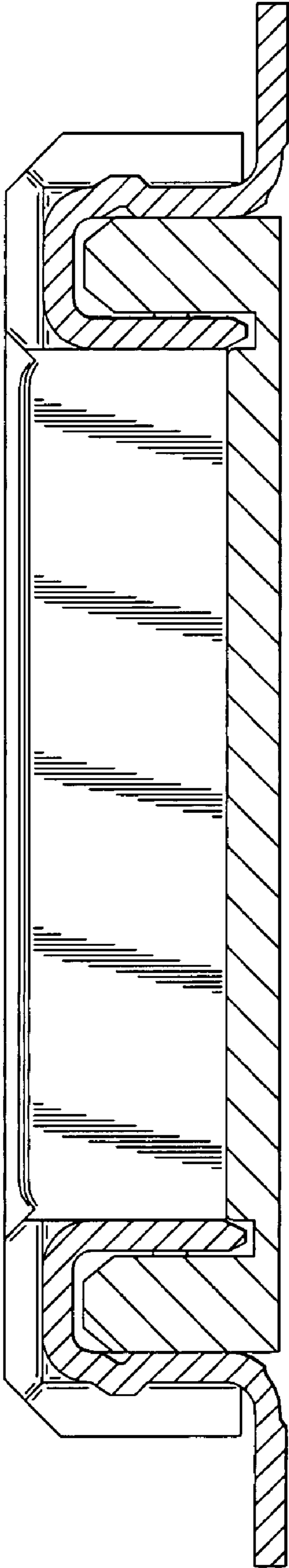
