**DESCRIPTION**

FIG. 1 is a front, right-side, top perspective view with the lid open of my new design for mobile phone;

FIG. 2 is a front, right-side, top perspective view with the lid closed thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

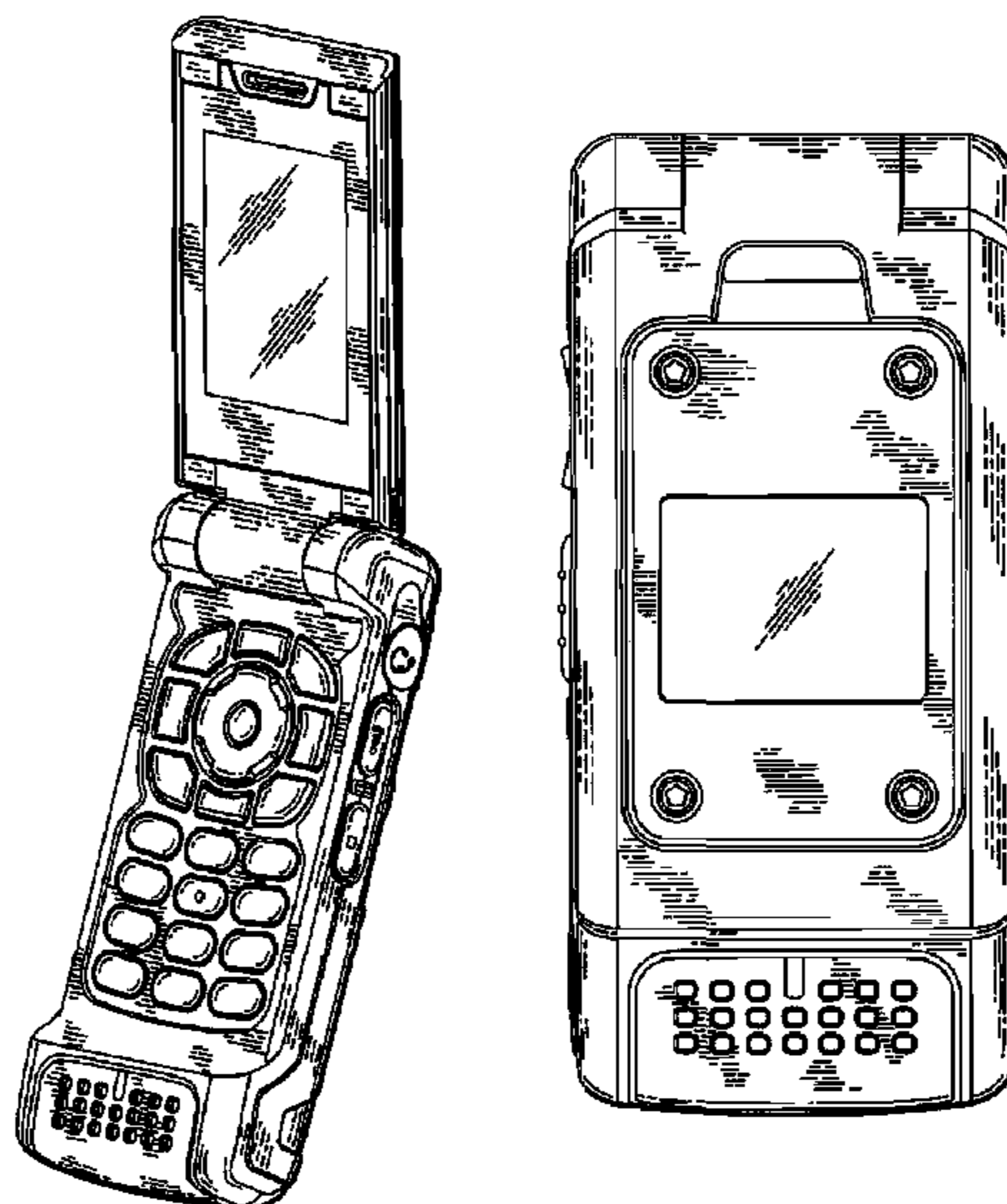

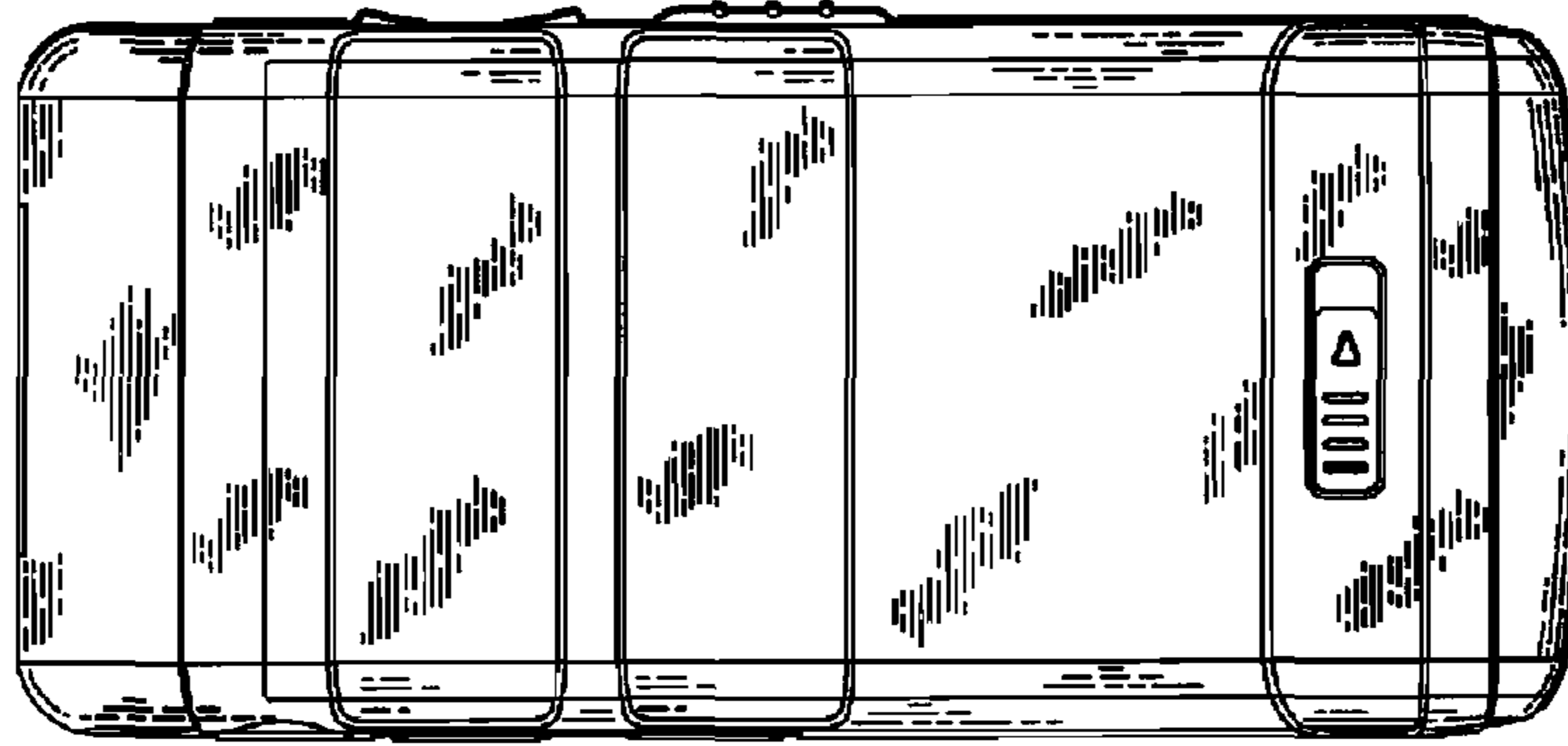

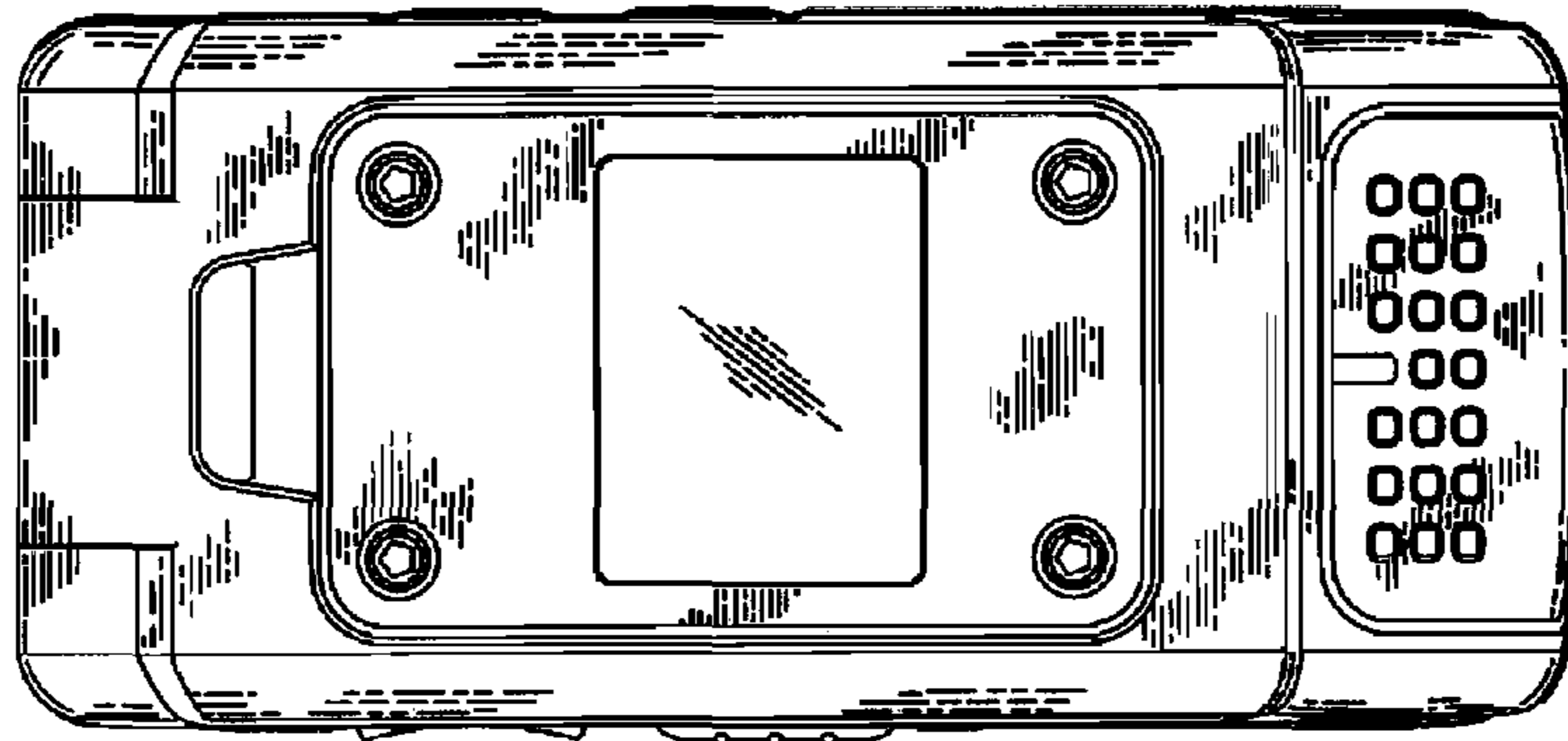

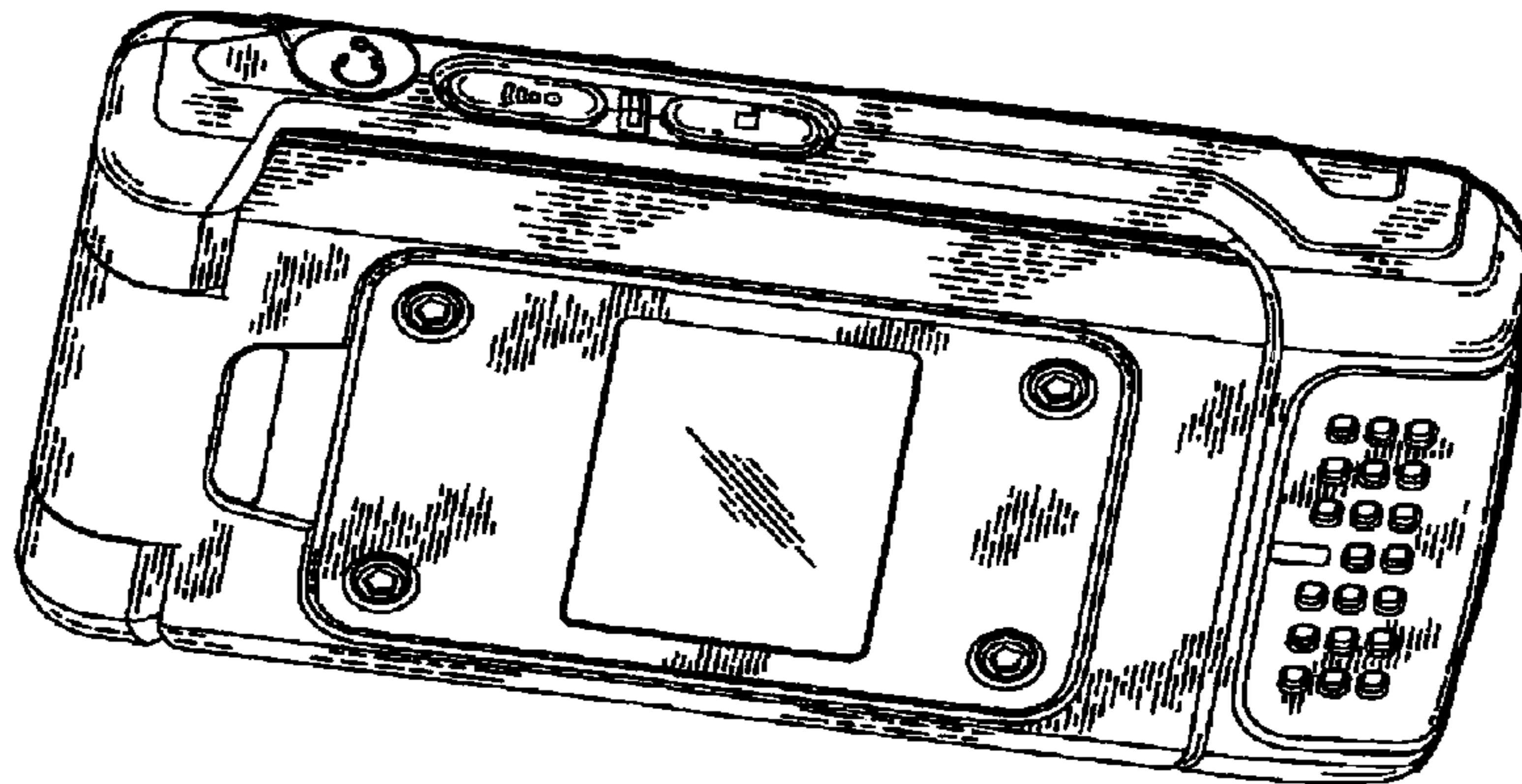

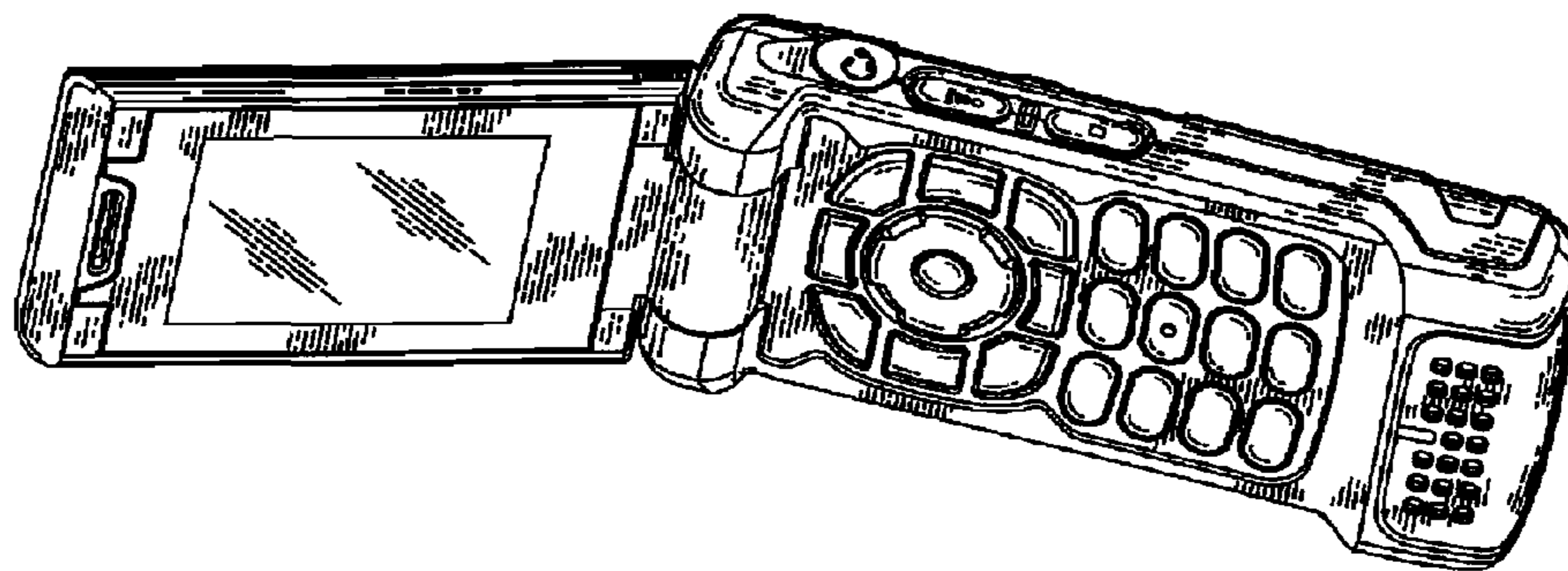

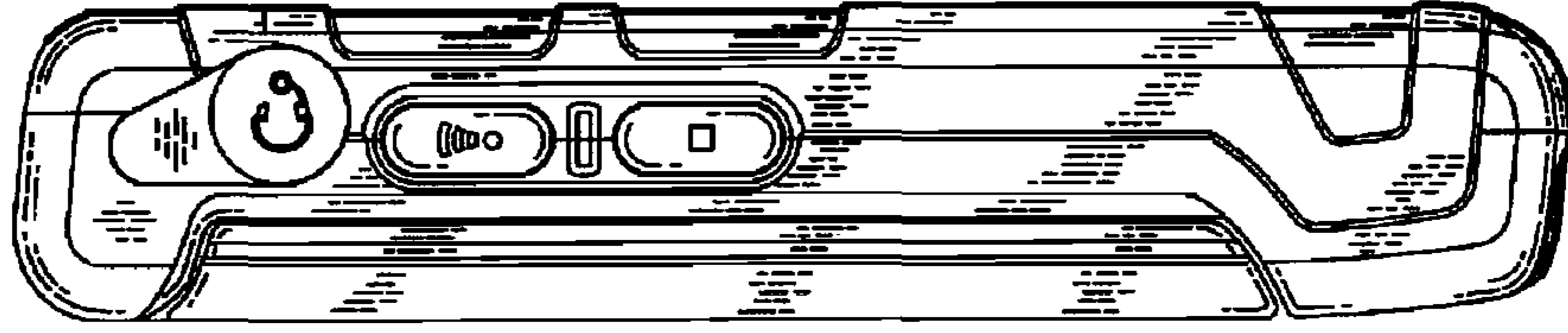

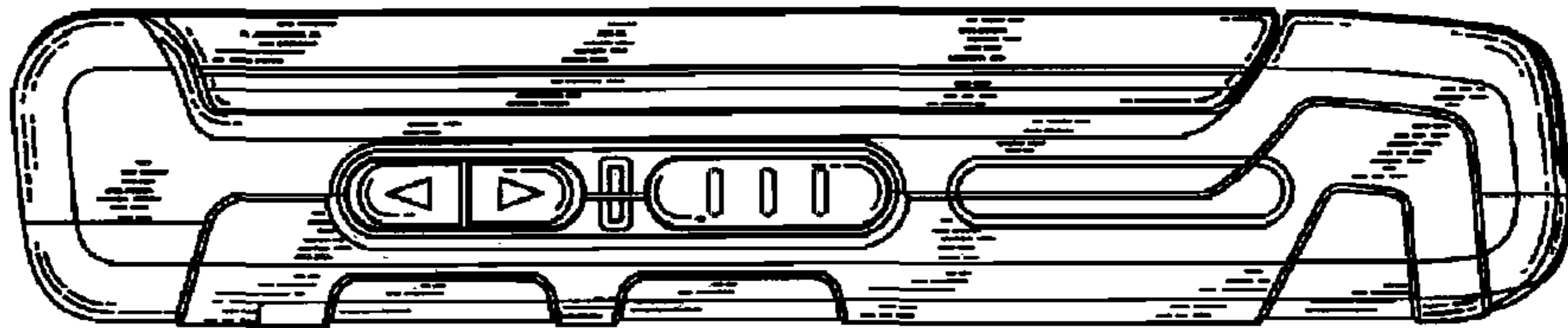

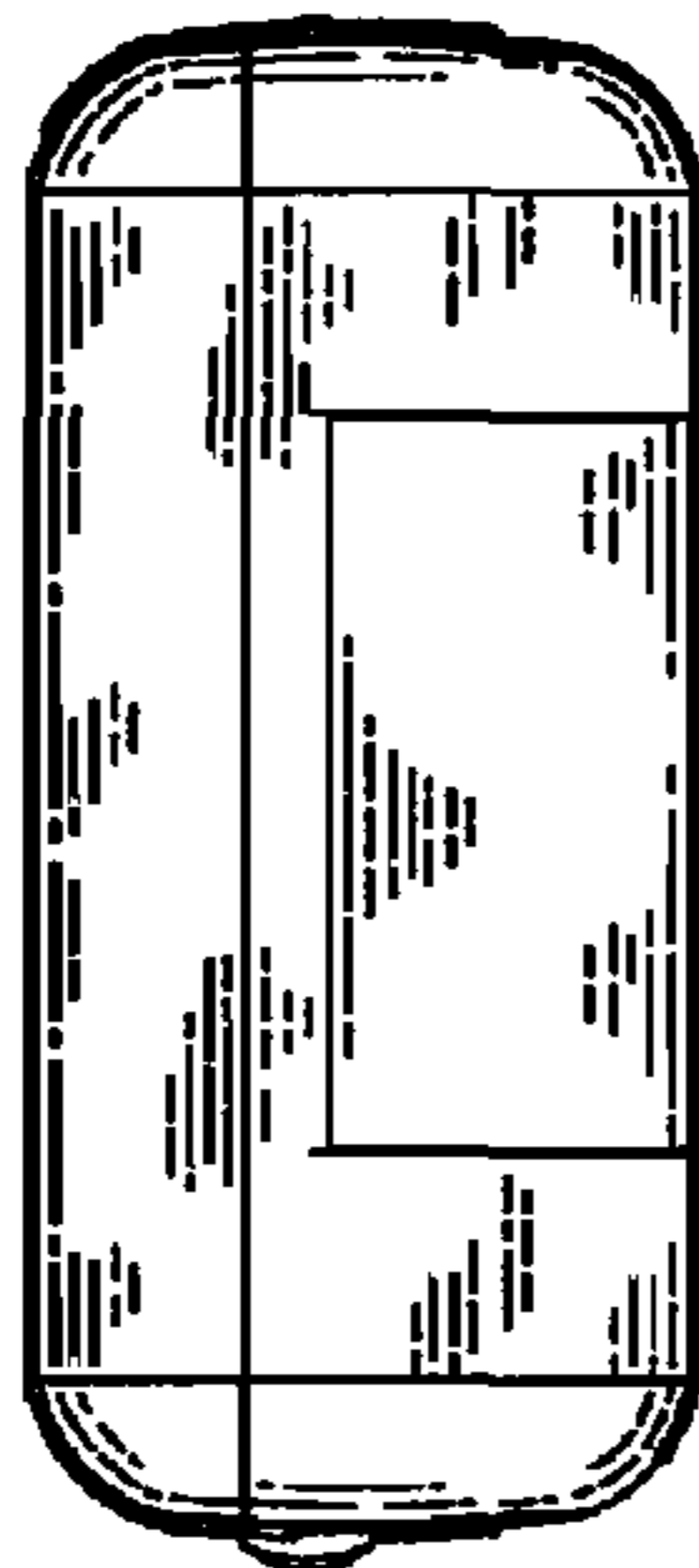
