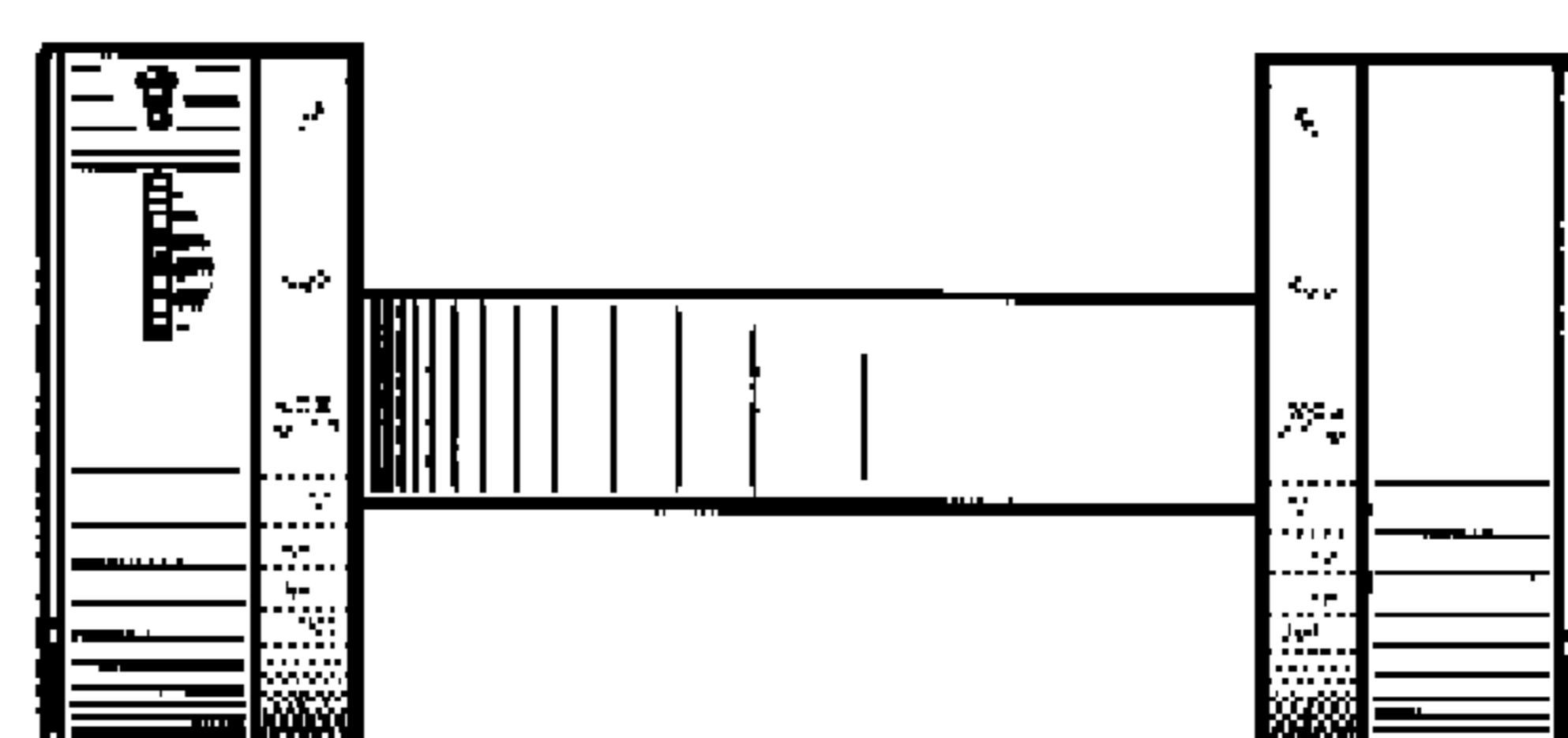
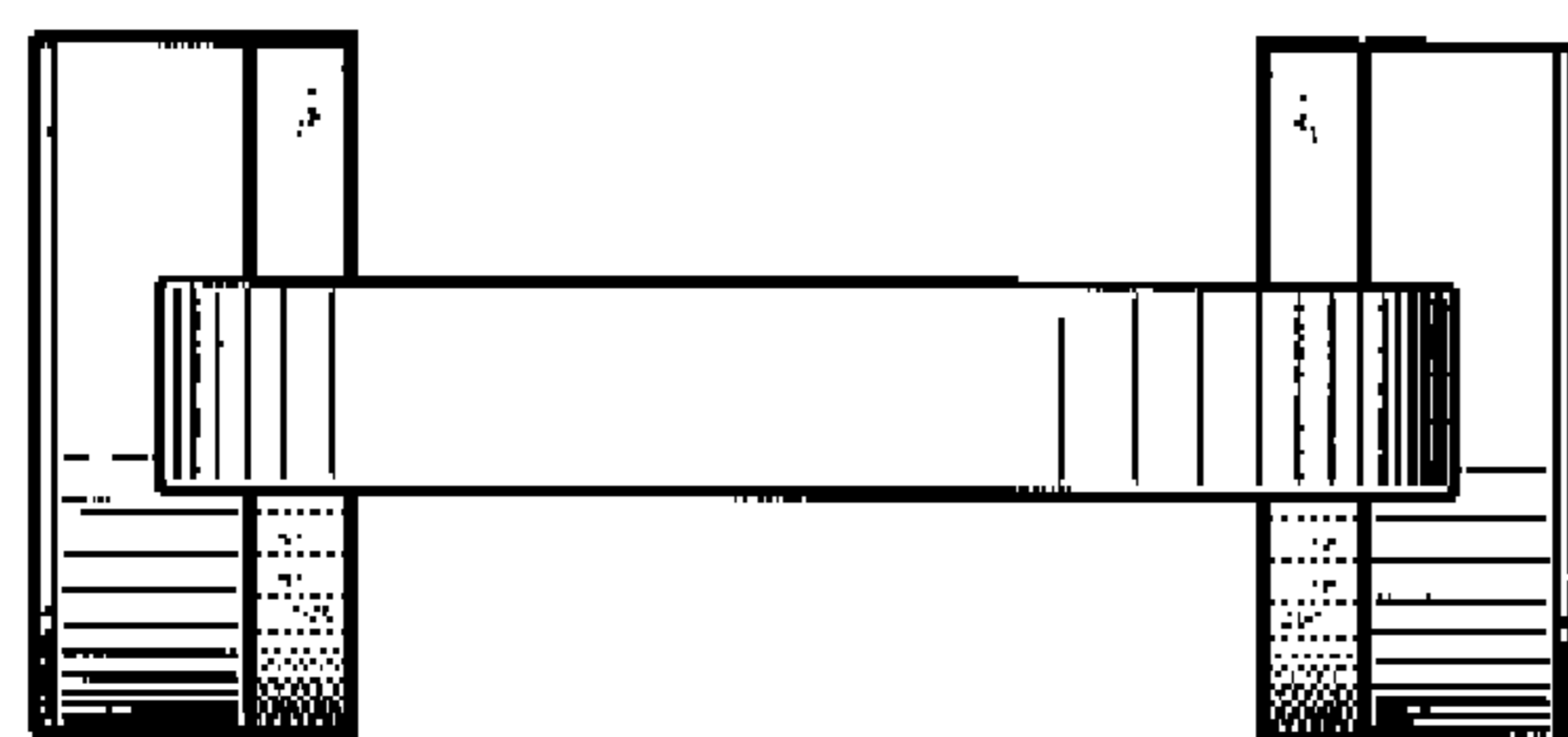
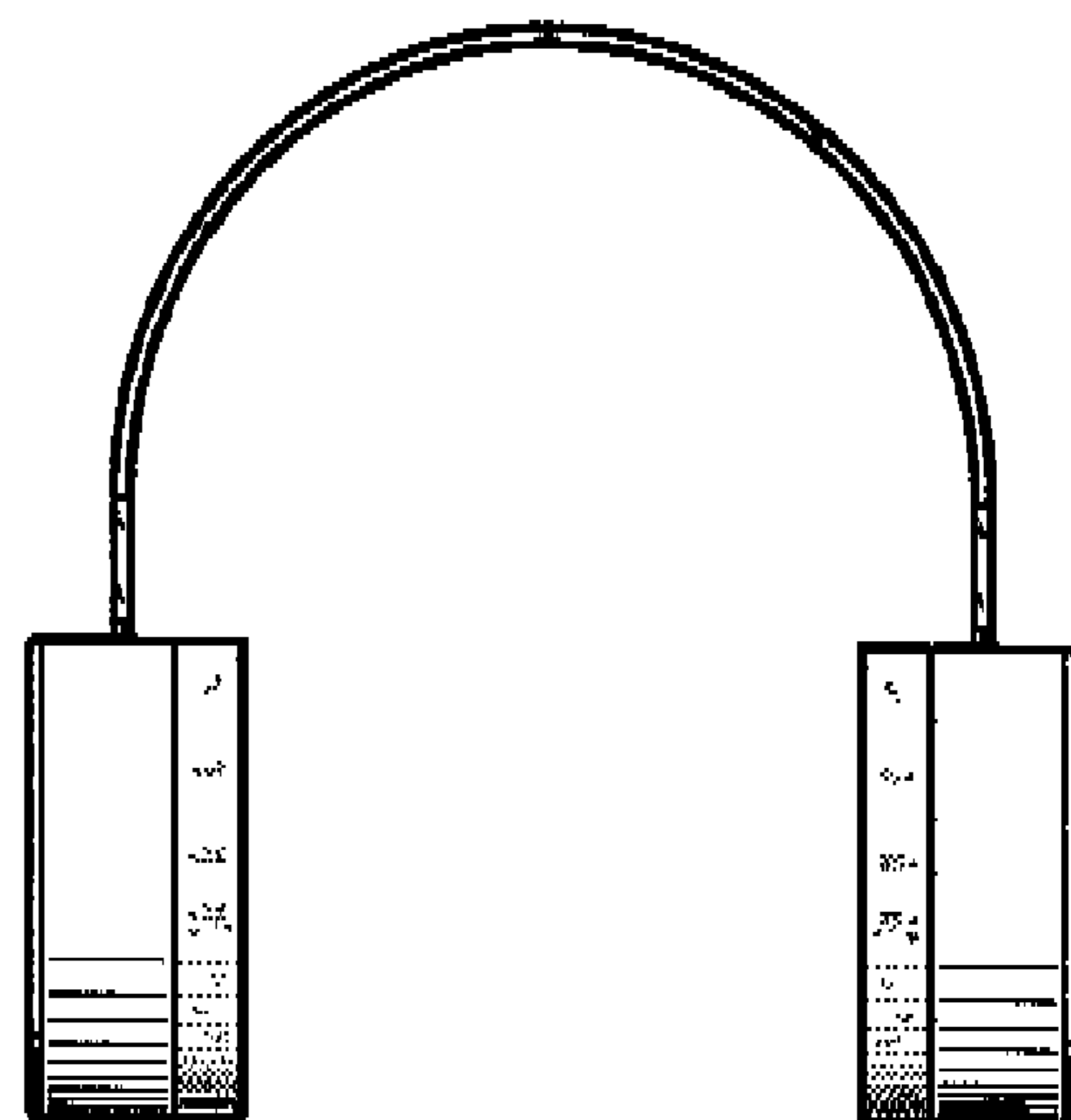
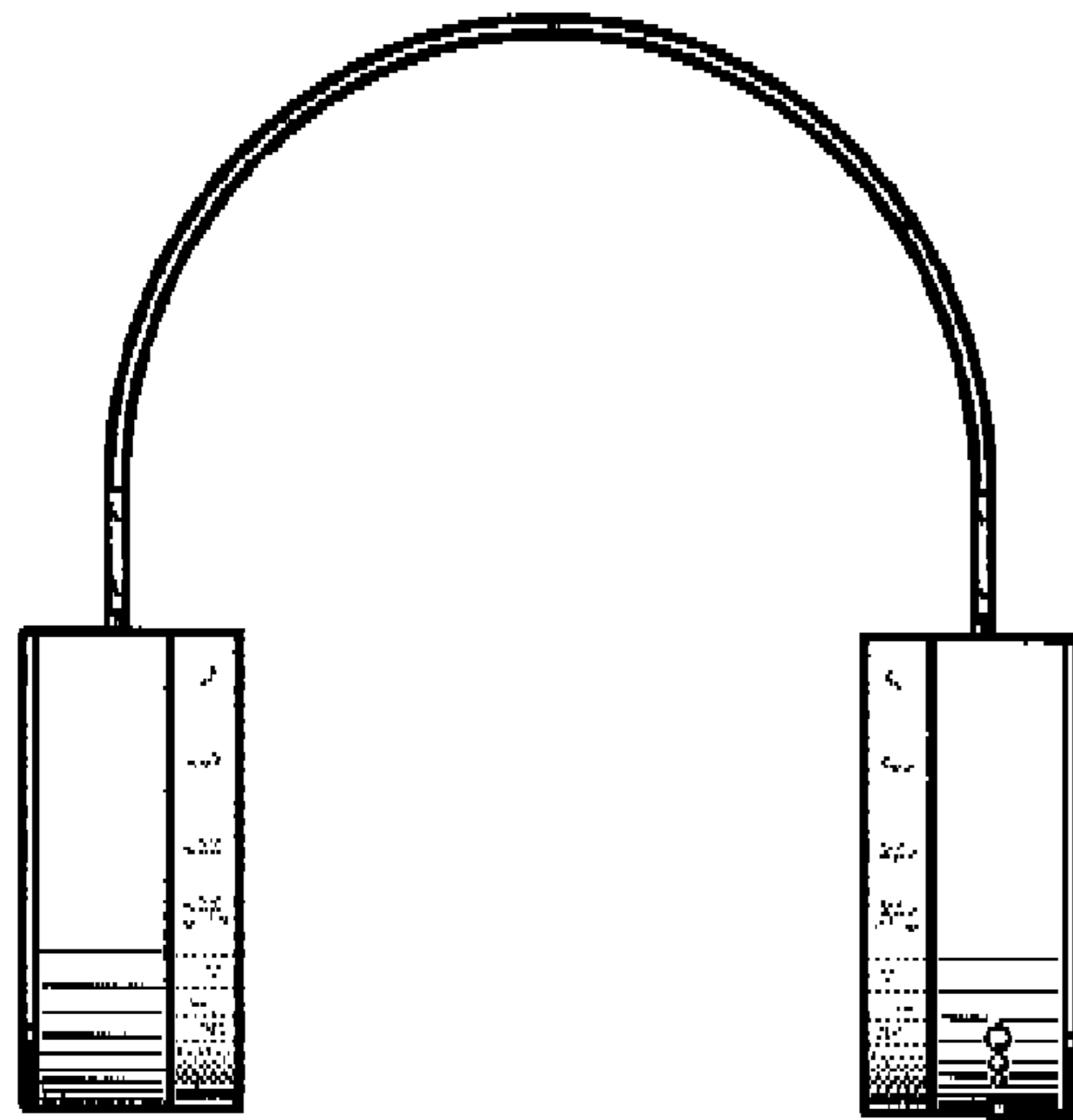
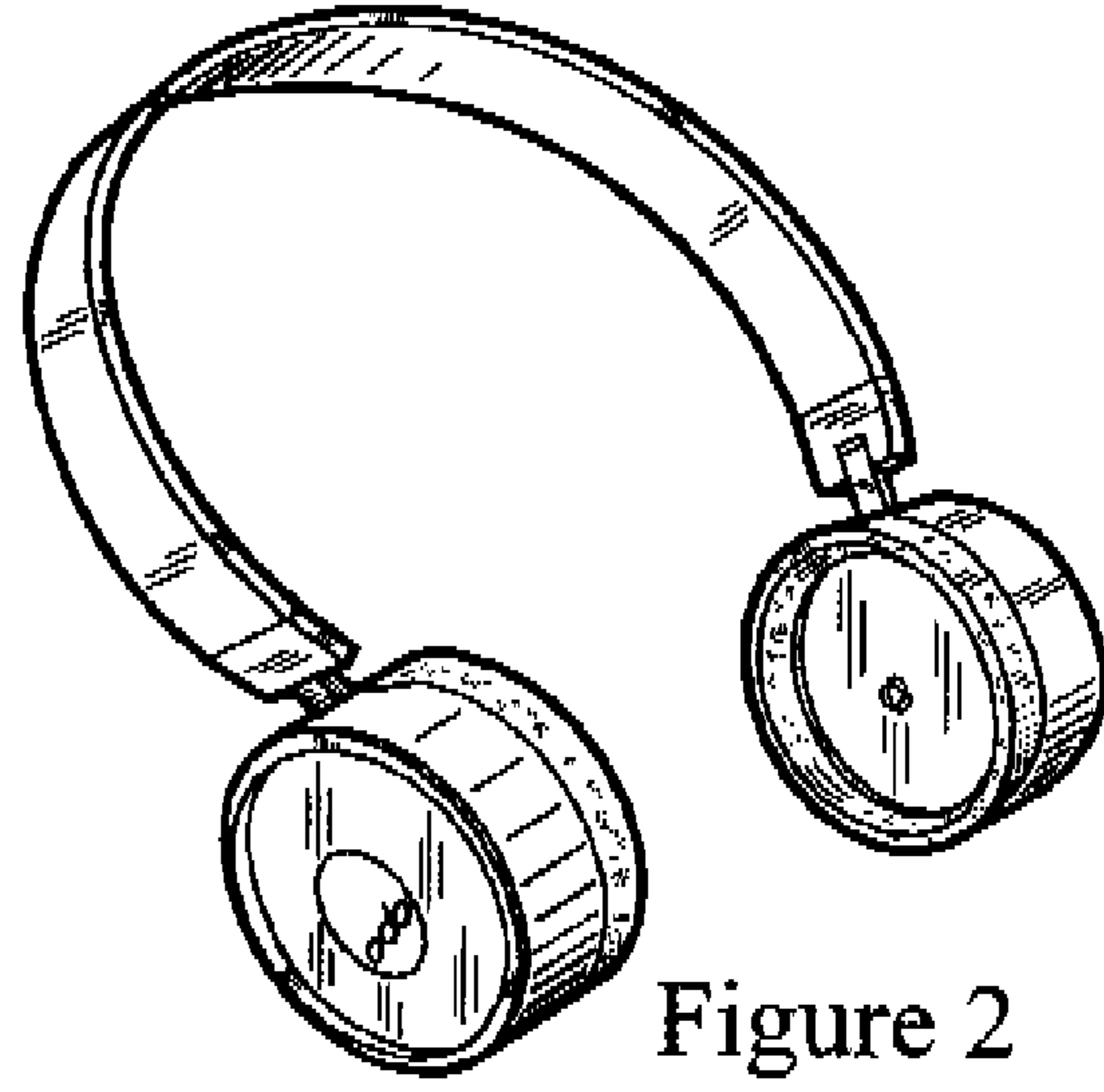
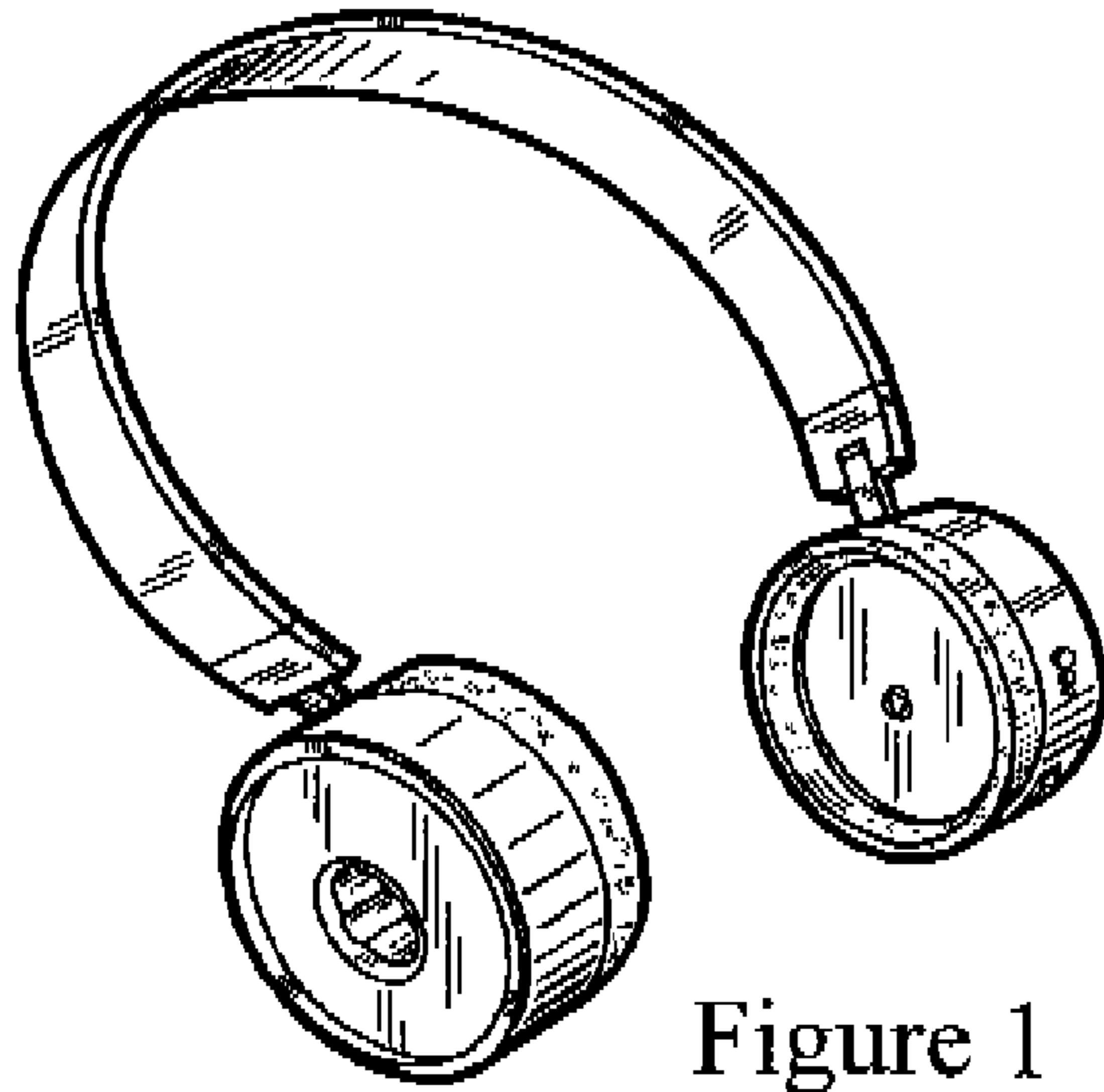
The ornamental design for the headphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the headphones from the front;

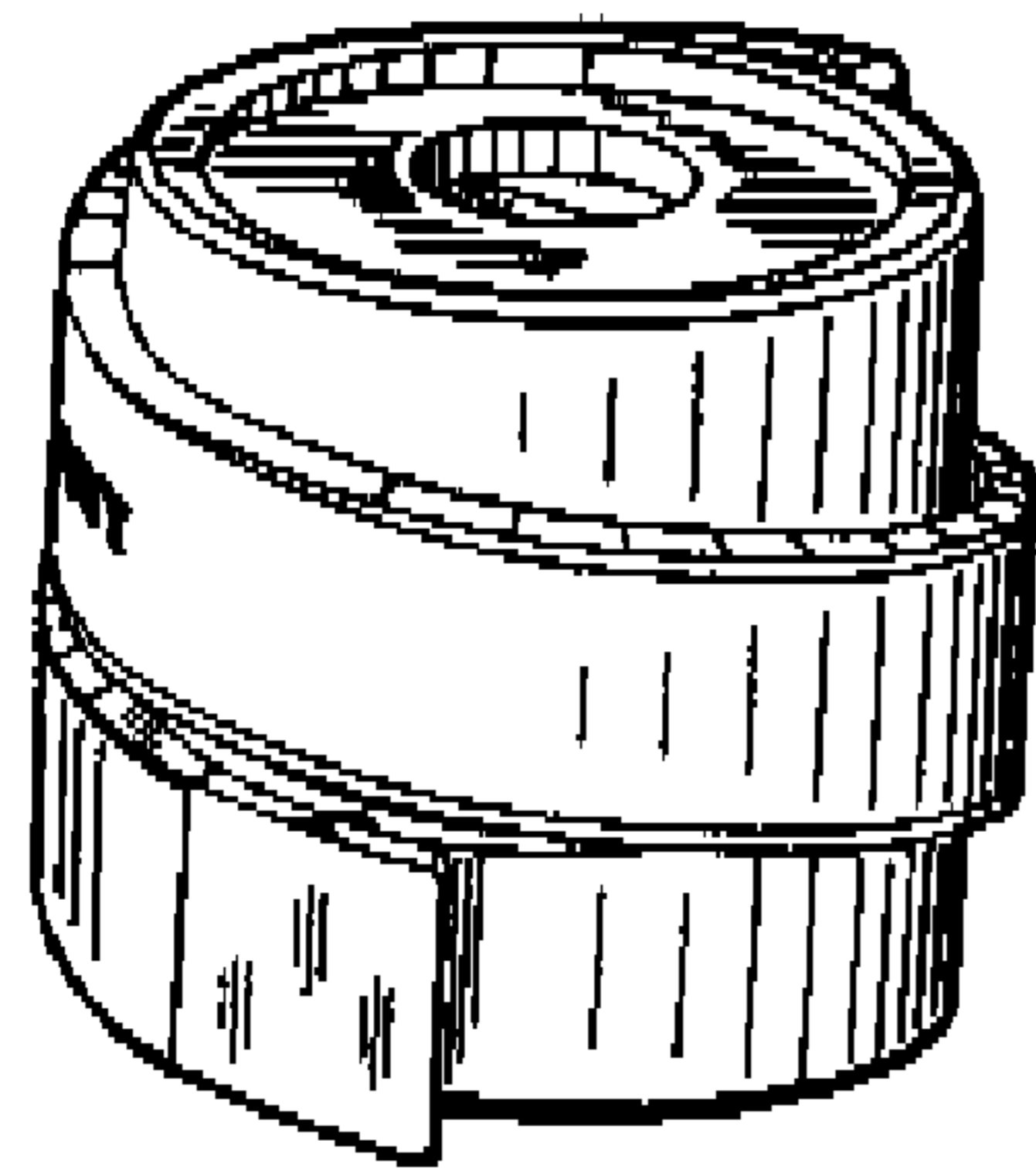

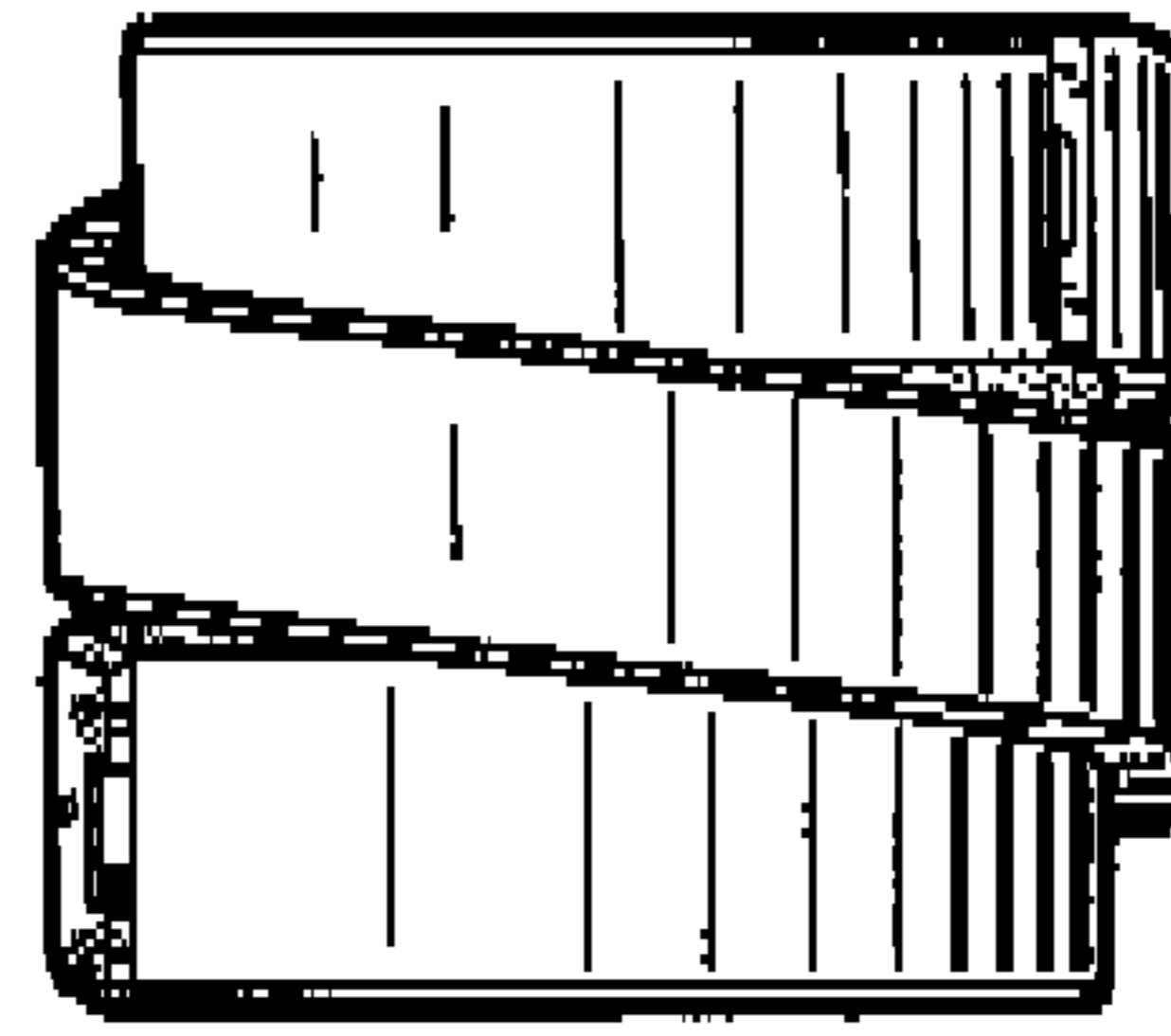

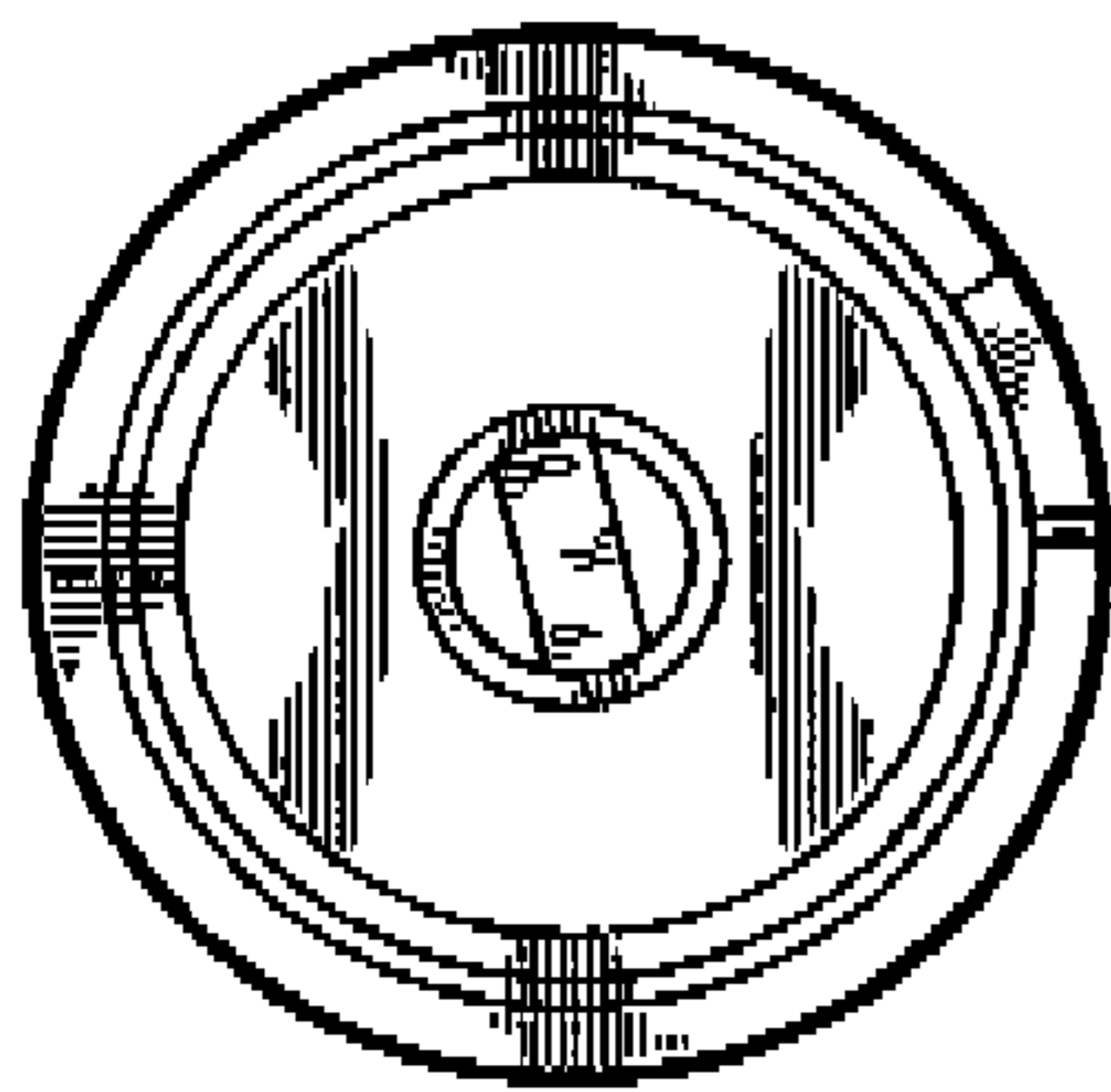

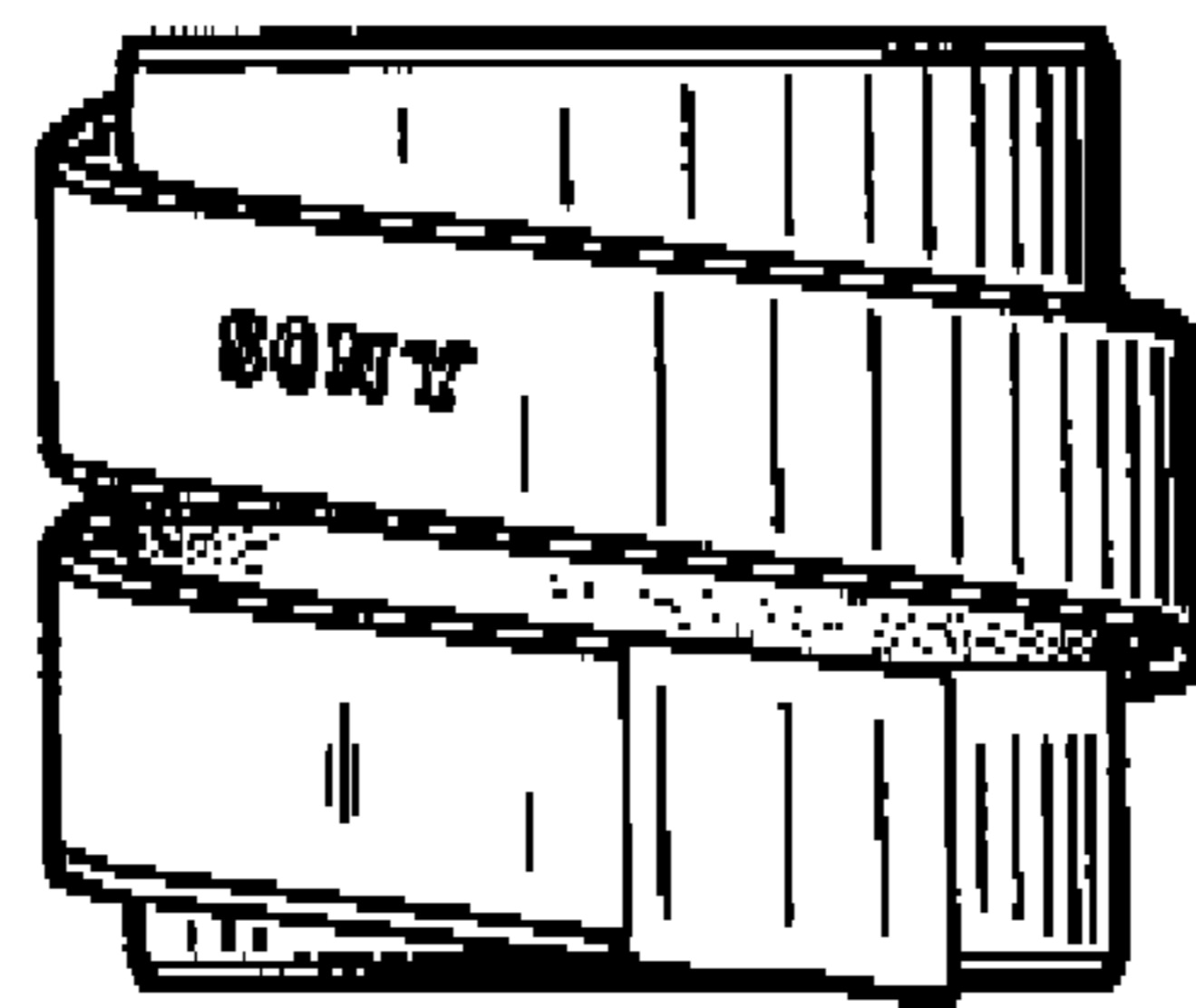

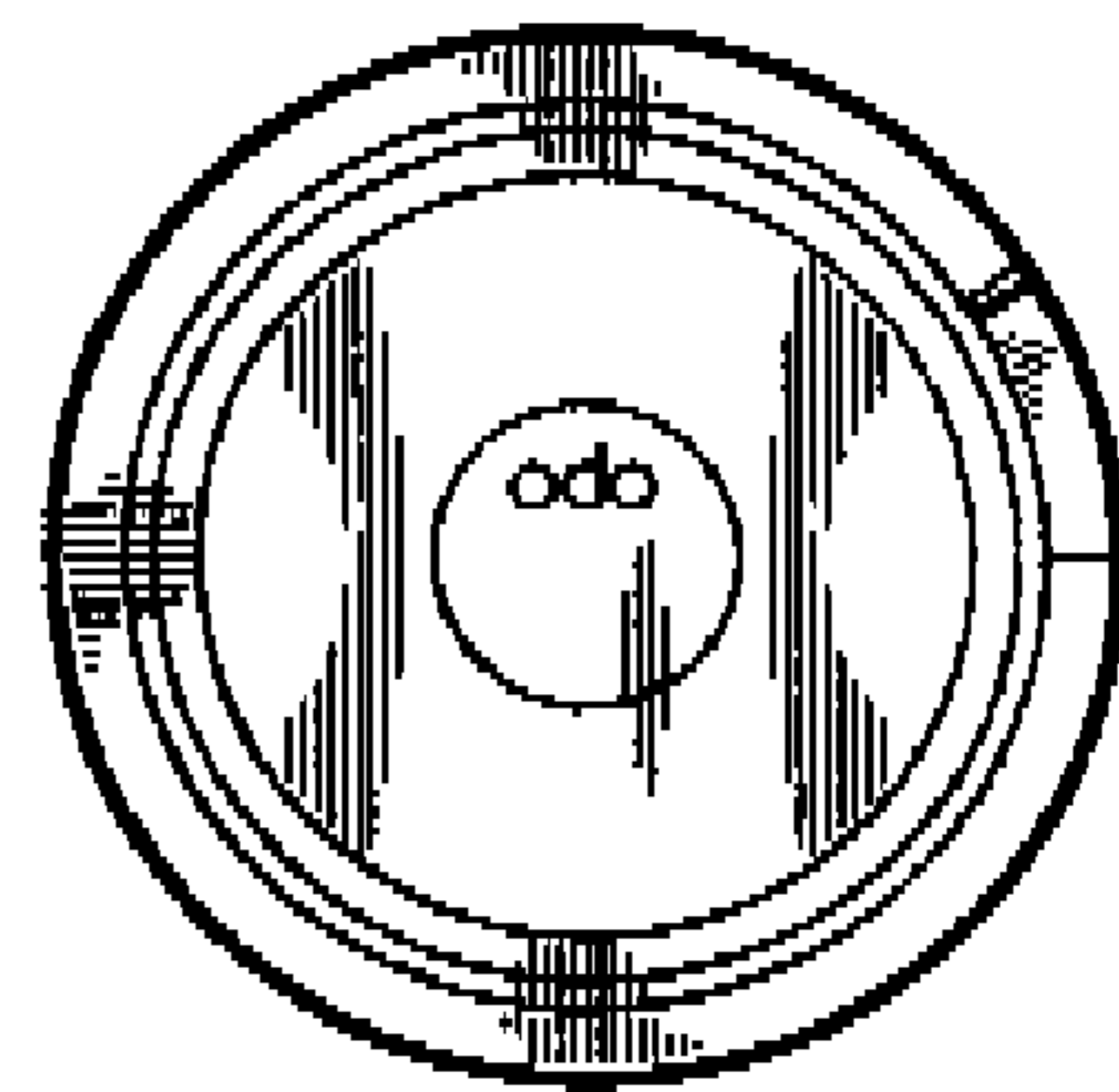

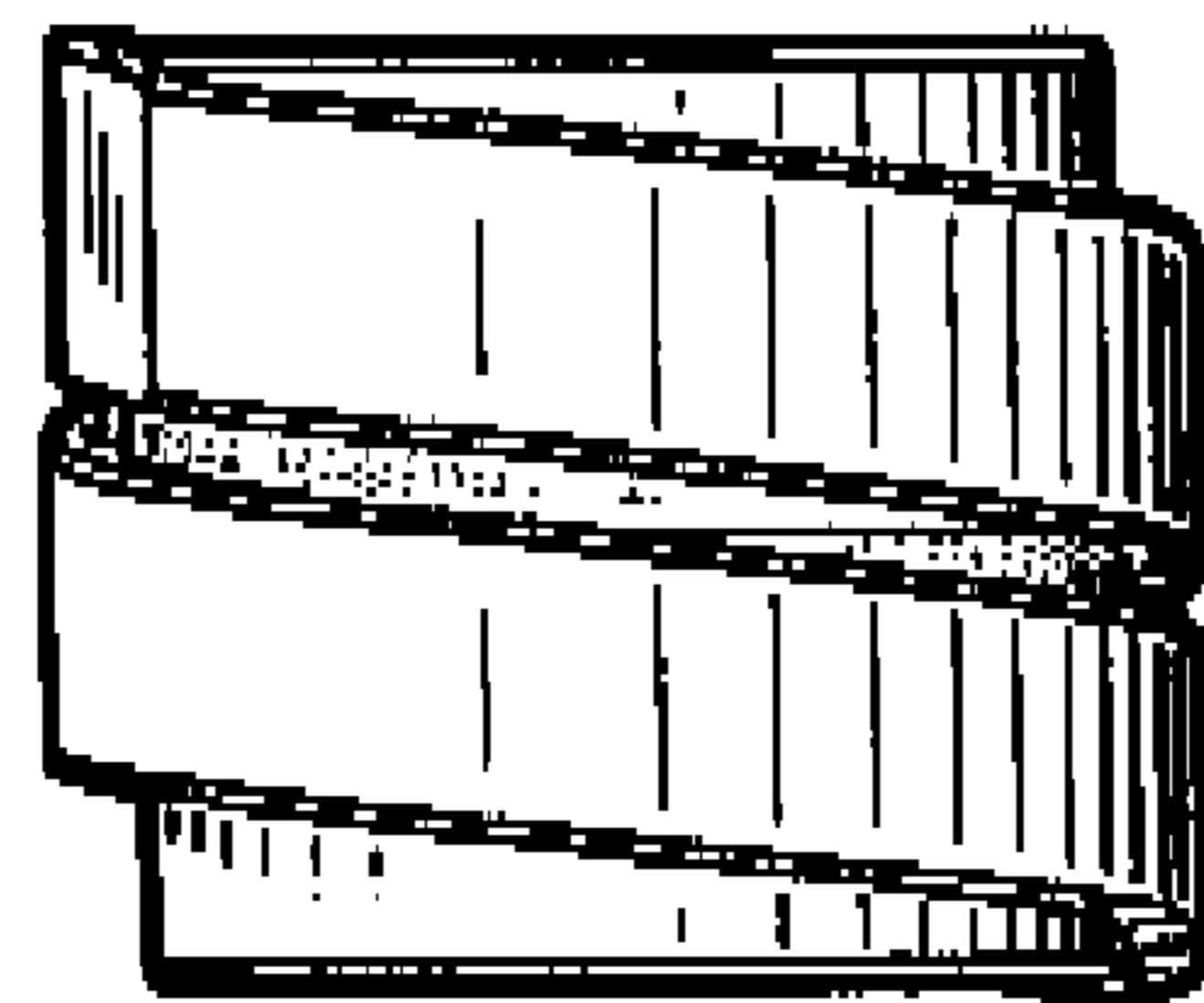
