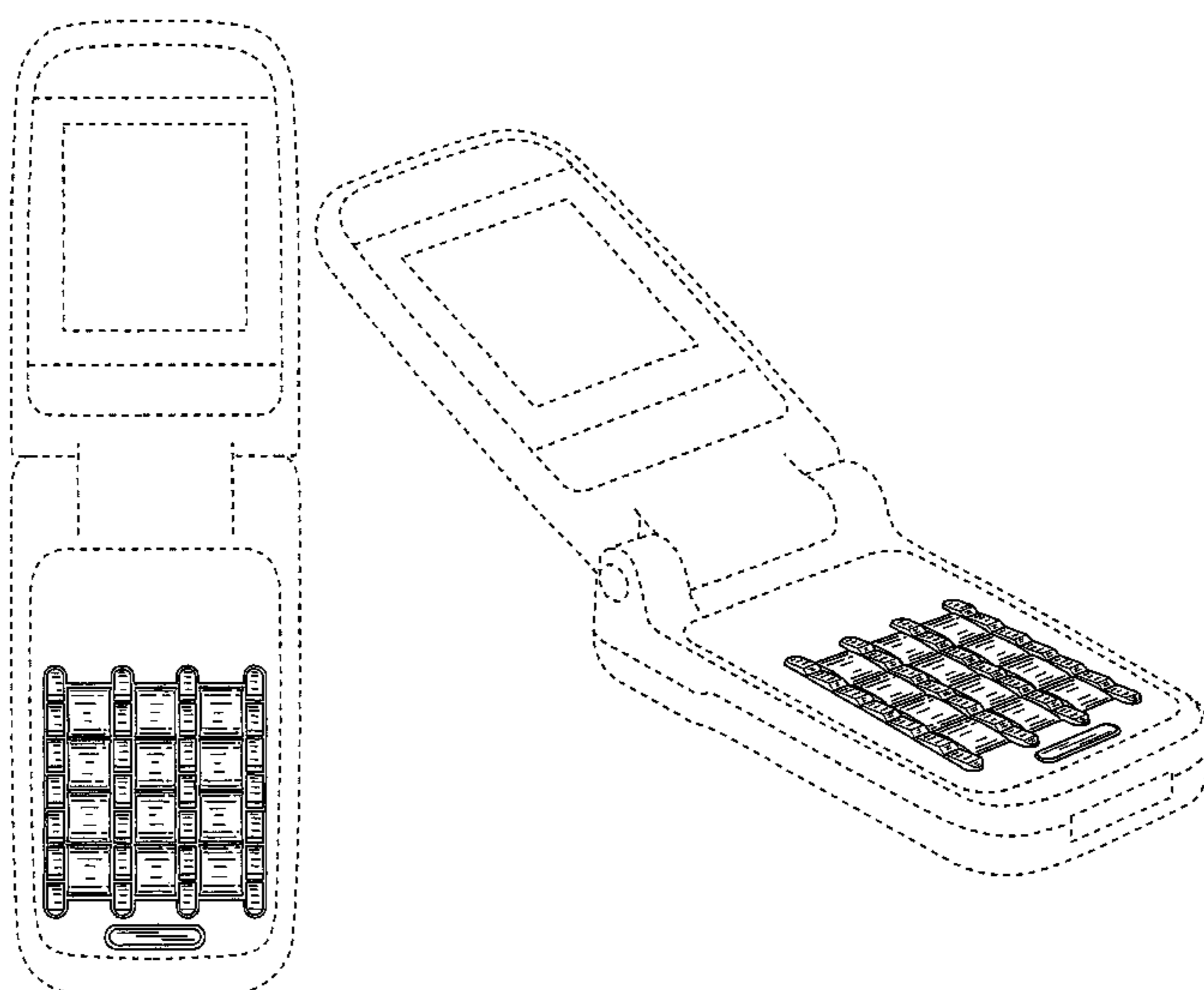
The ornamental design for a keypad, as shown and described.

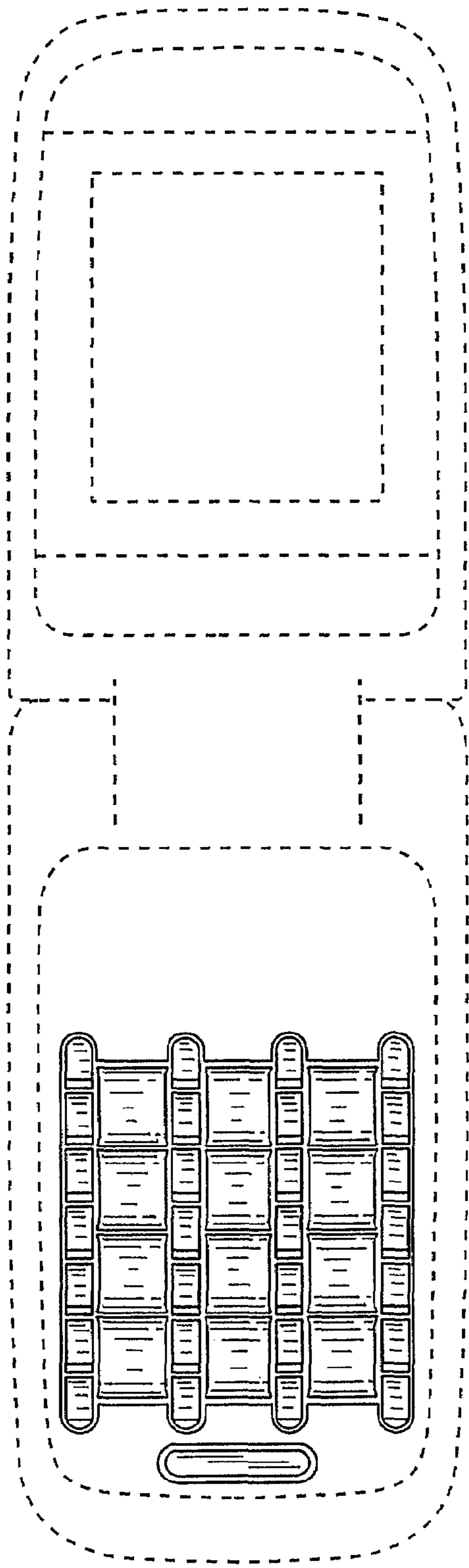

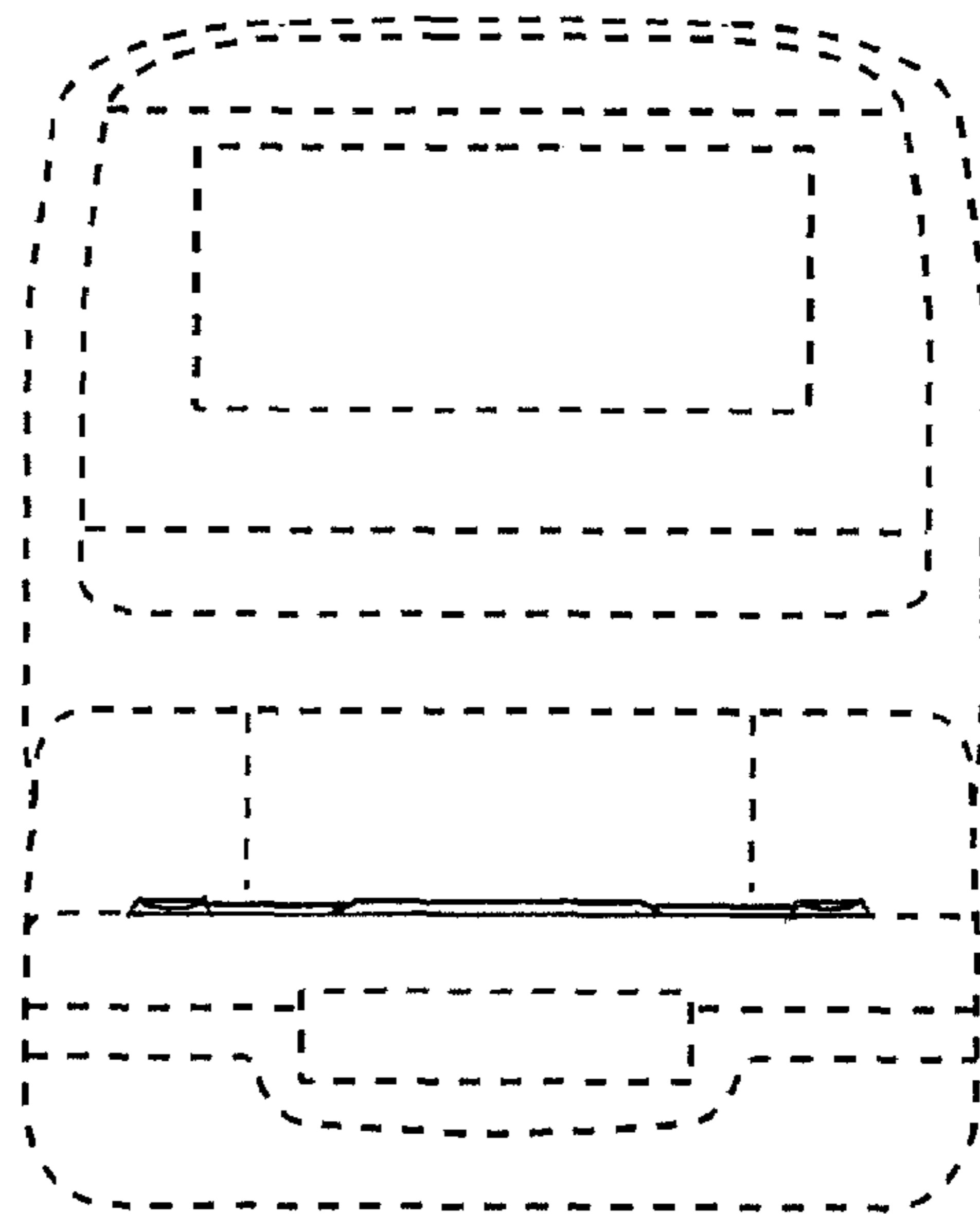

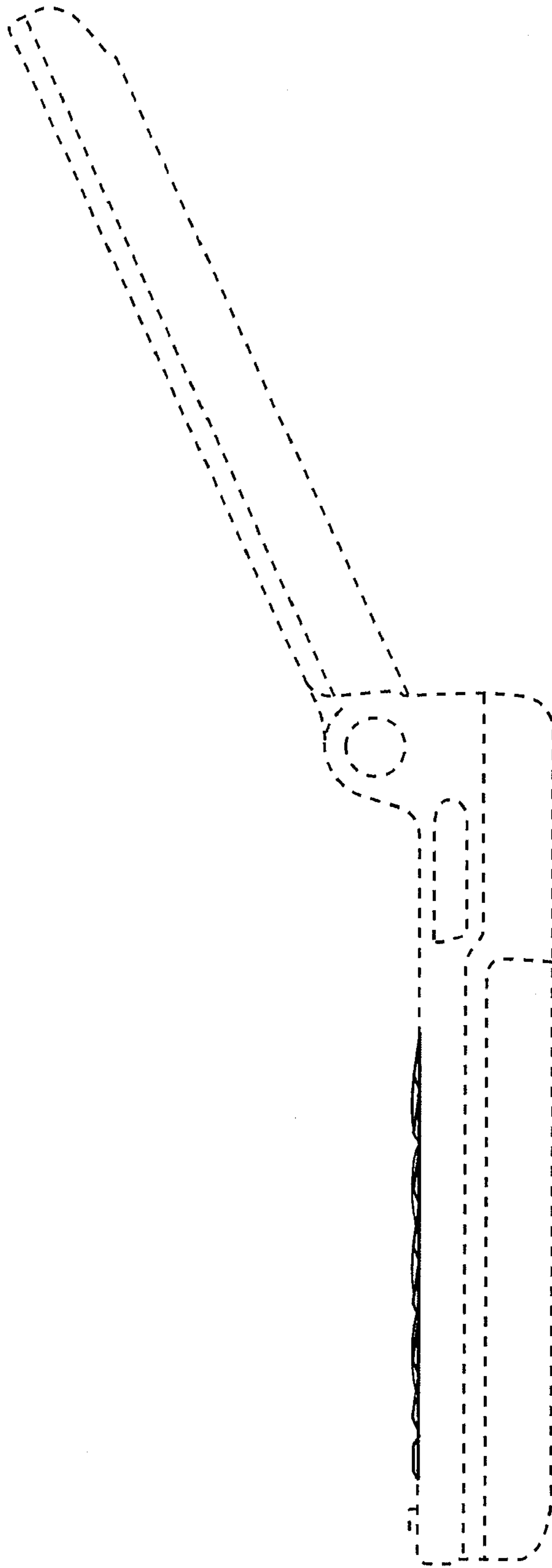

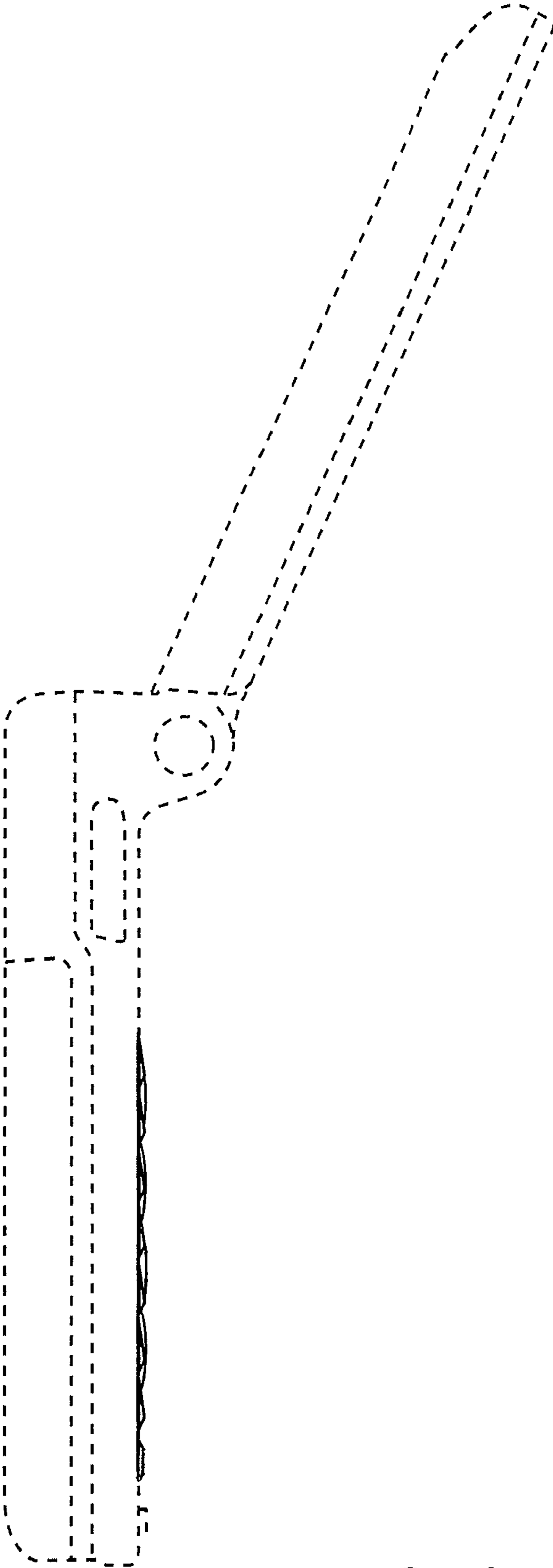

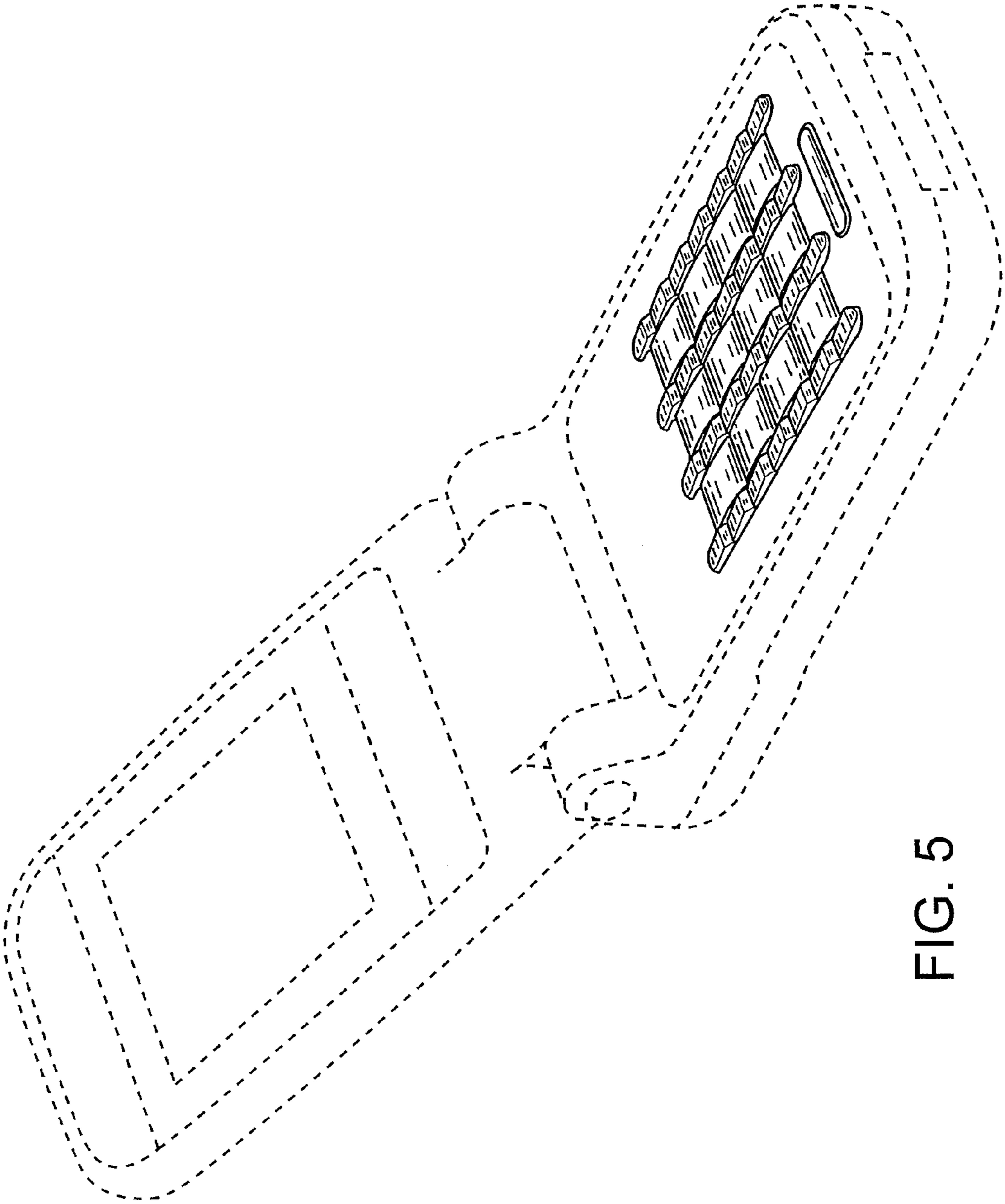

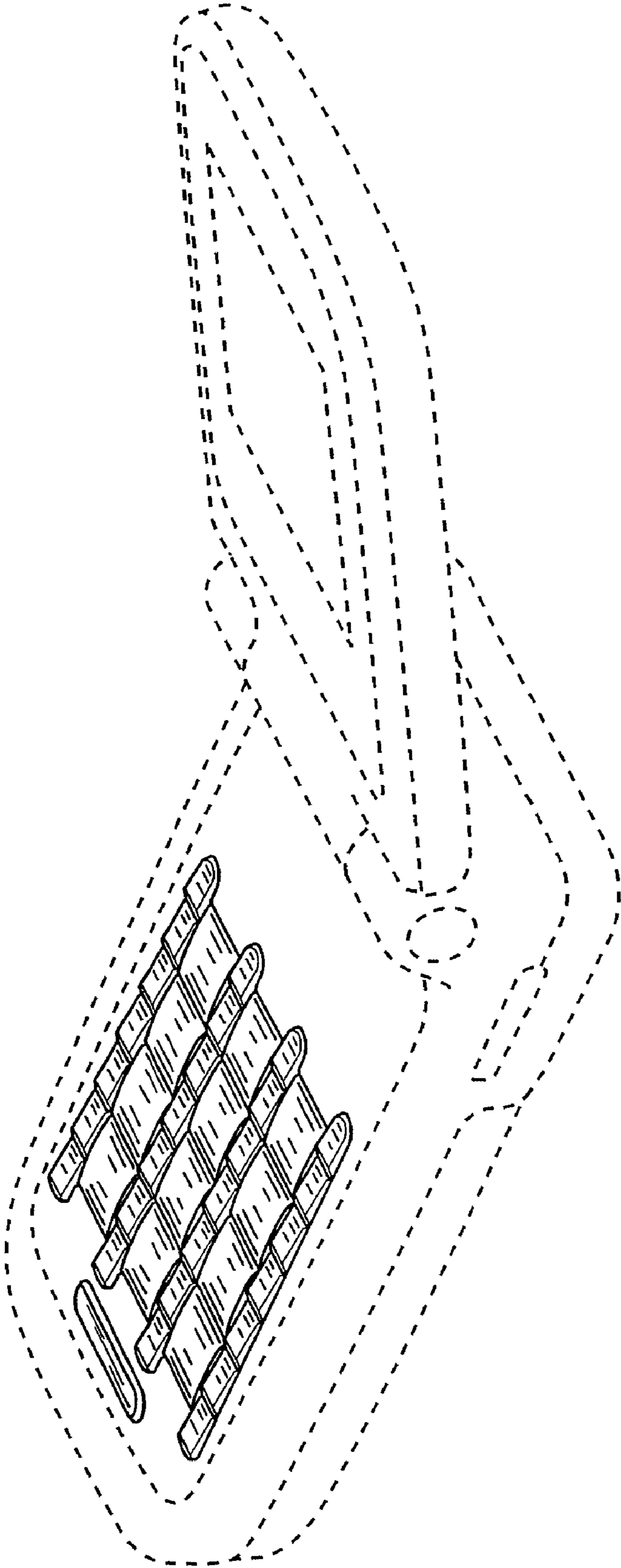
