(57) **CLAIM**

The ornamental design for an image display for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an image display for a mobile phone; and,

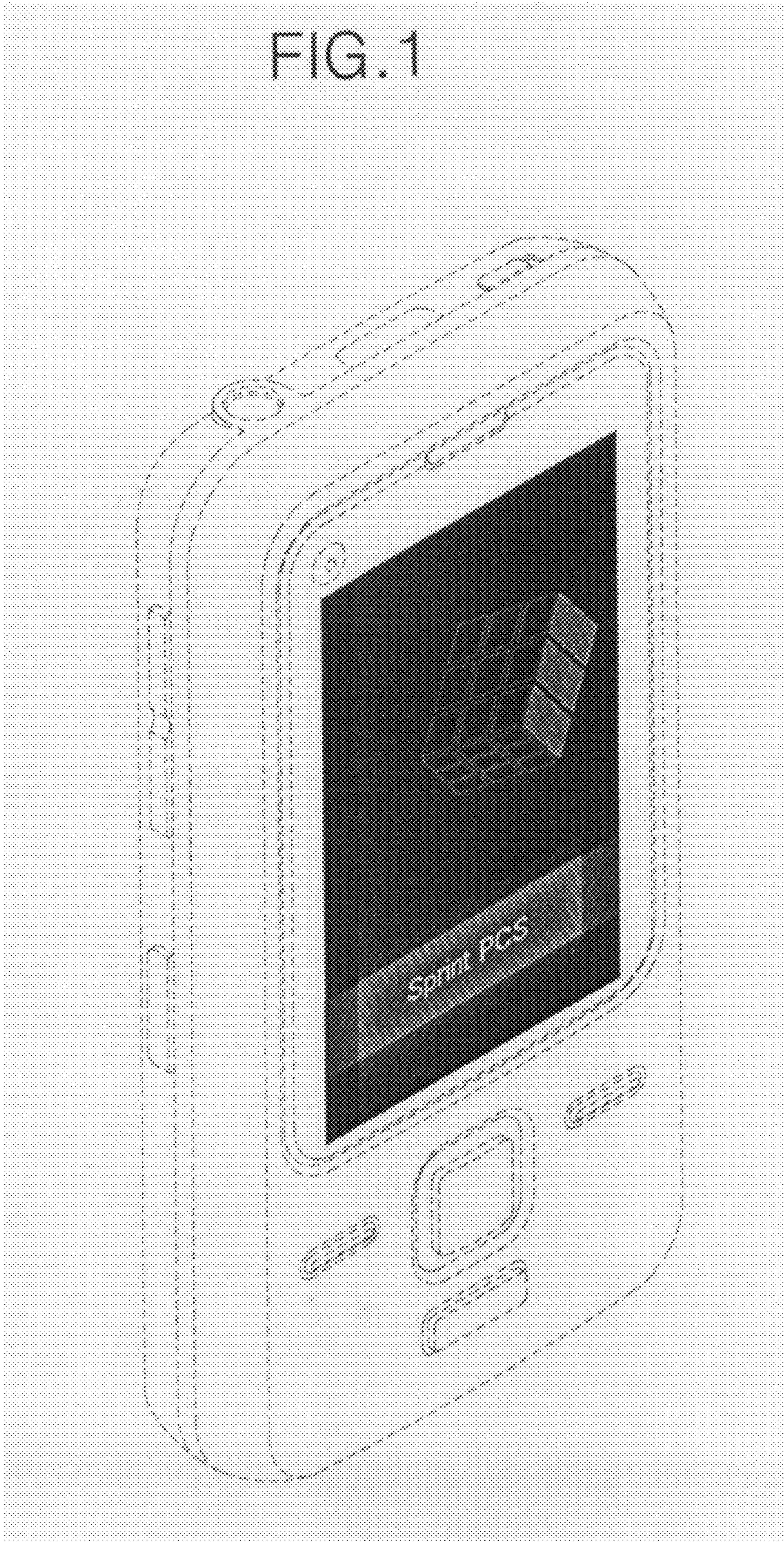
