(57) **CLAIM**

The ornamental design for an image display for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an image display for a mobile phone; and,

FIG. 2 is an enlarged front view of the image display for a mobile phone of FIG. 1.

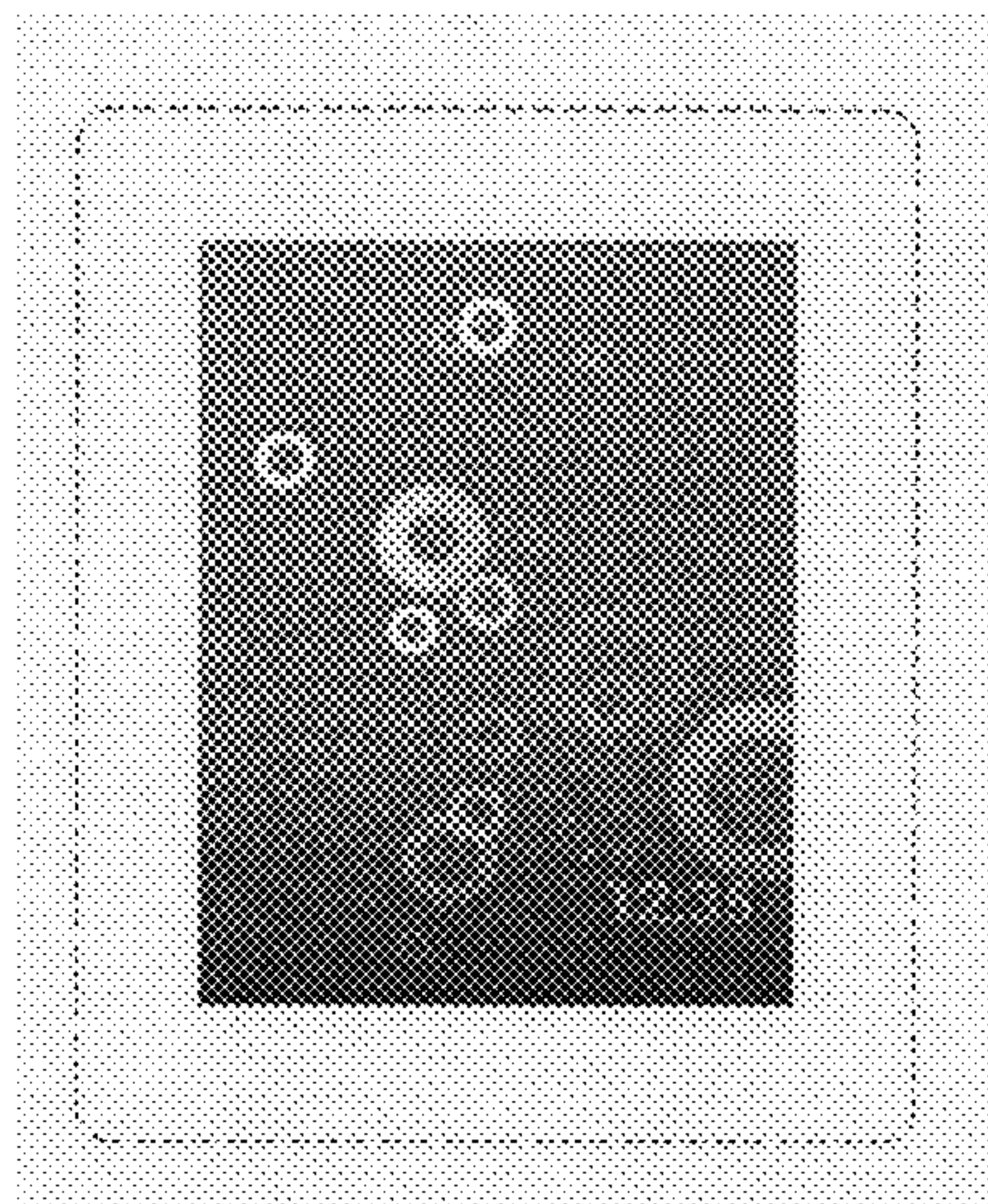

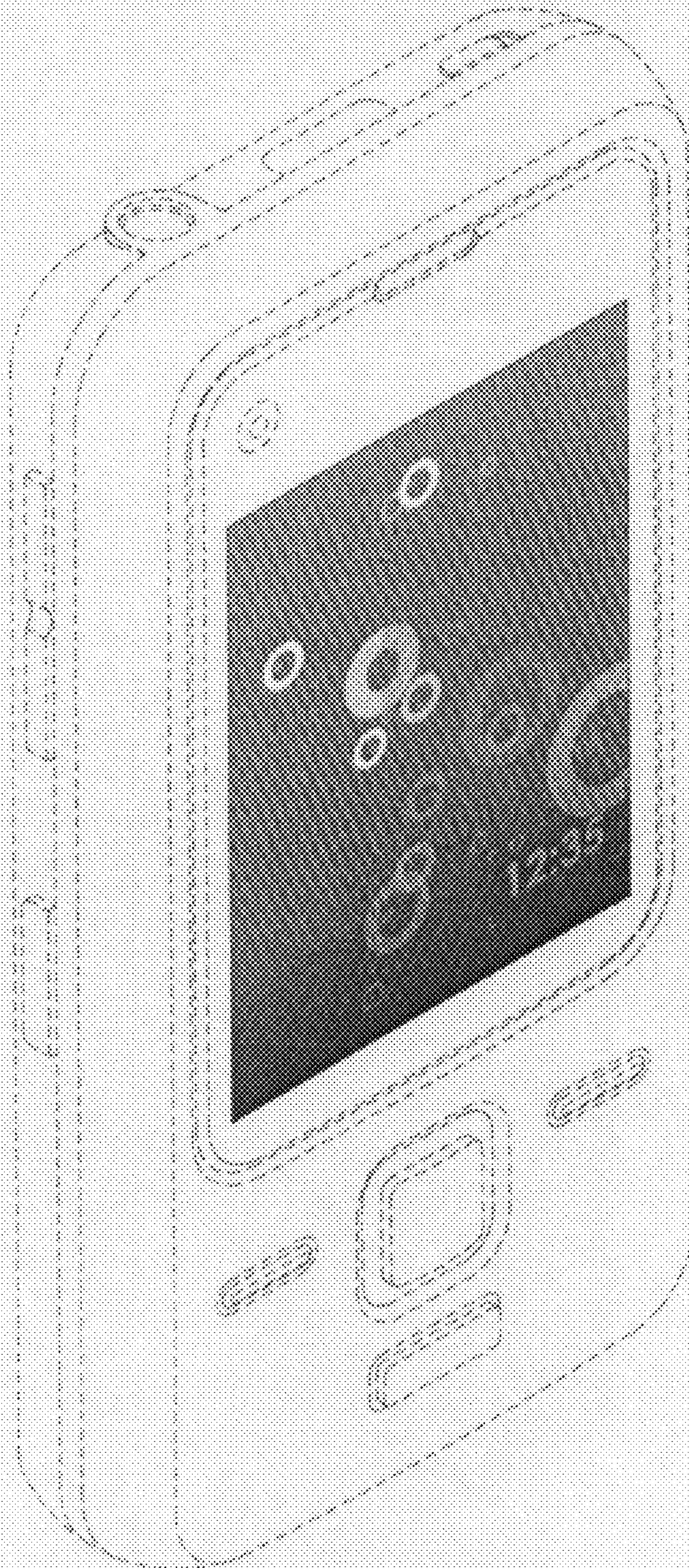
