(57) **CLAIM**

The ornamental design for an tip end of a golf club shaft, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective of a tip end of a golf club shaft, the broken line showing of a fragmented golf club shaft is included for the purpose of illustrating and forms no part of the claimed design;

FIG. 2 is an additional bottom perspective view of a portion of a tip end of a golf club shaft rotated slightly from the position in FIG. 1;

FIG. 3 is a top perspective view of a portion of a tip end of a golf club shaft;

FIG. 4 is an additional top perspective view of a portion of a tip end of a golf club shaft rotated slightly from the position in FIG. 3;

FIG. 5 is a perspective view of a portion of a tip end of a golf club shaft looking down the shaft;

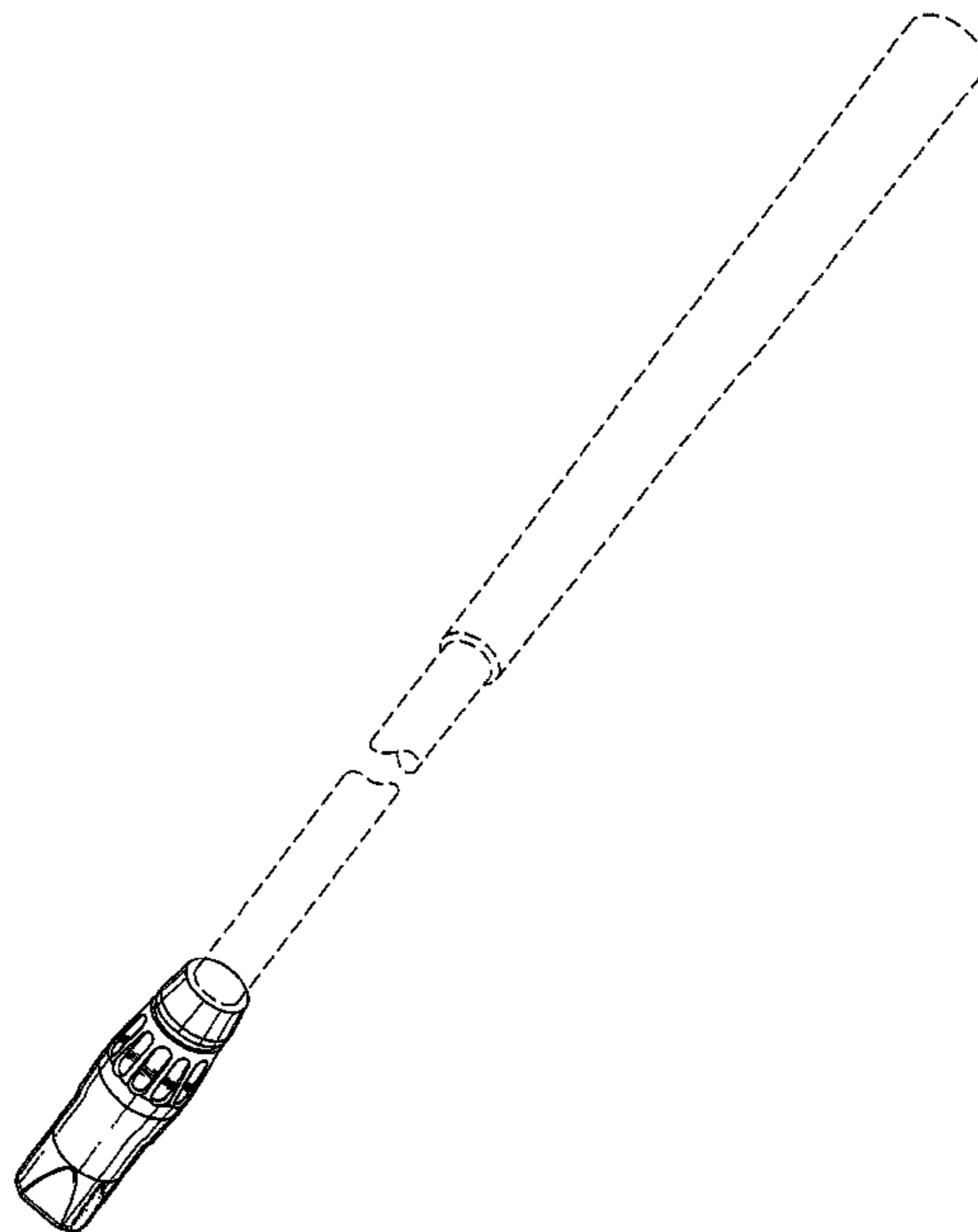
FIG. 6 is a front elevational view a portion of a tip end of a golf club shaft;

FIG. 7 is a front elevational view a portion of a tip end of a golf club shaft rotated slightly from the position in FIG. 6;

FIG. 8 is a front elevational view a portion of a tip end of a golf club shaft rotated slightly from the position in FIG. 7; and,

FIG. 9 is bottom plan view of a portion of a tip end of a golf club shaft.

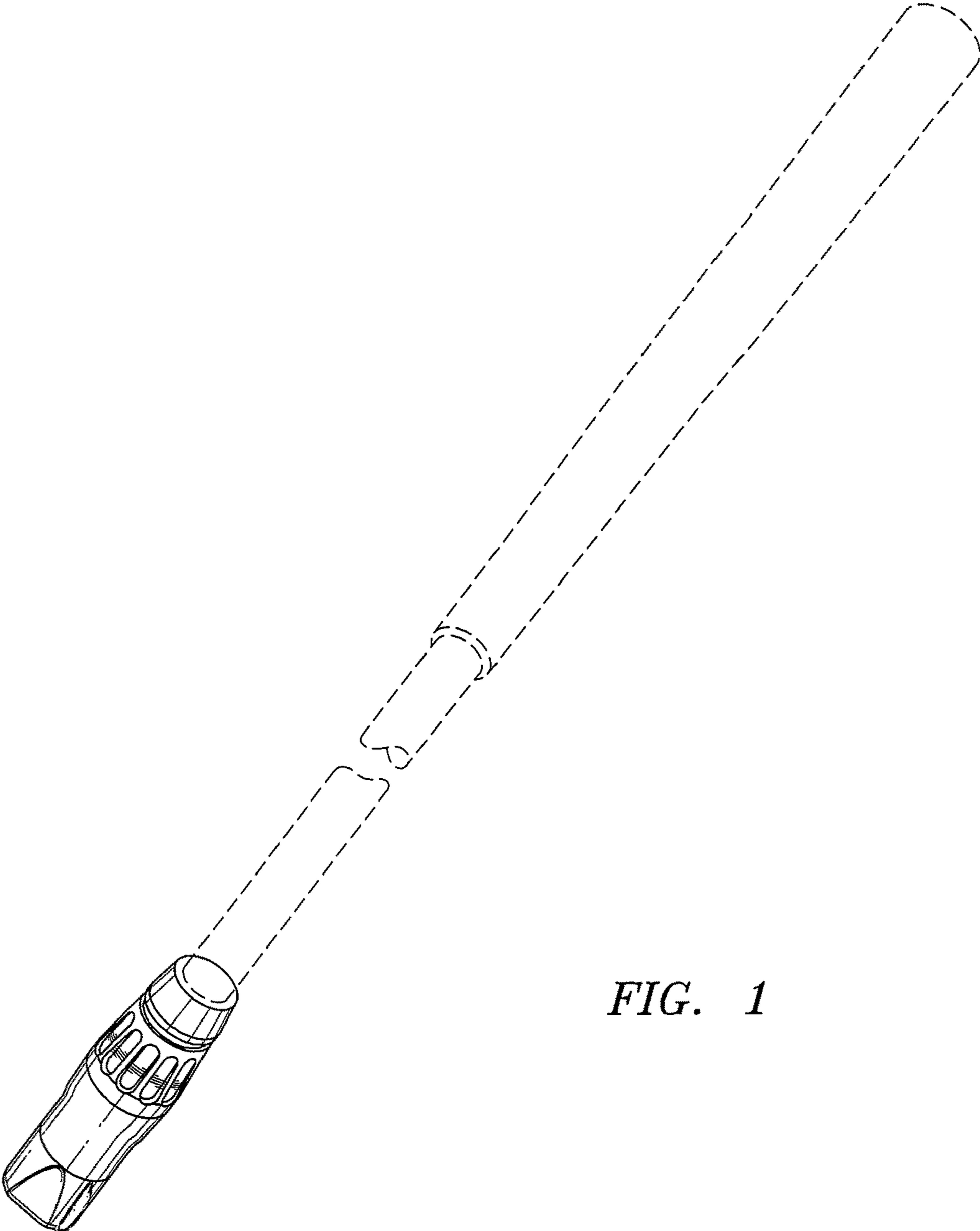
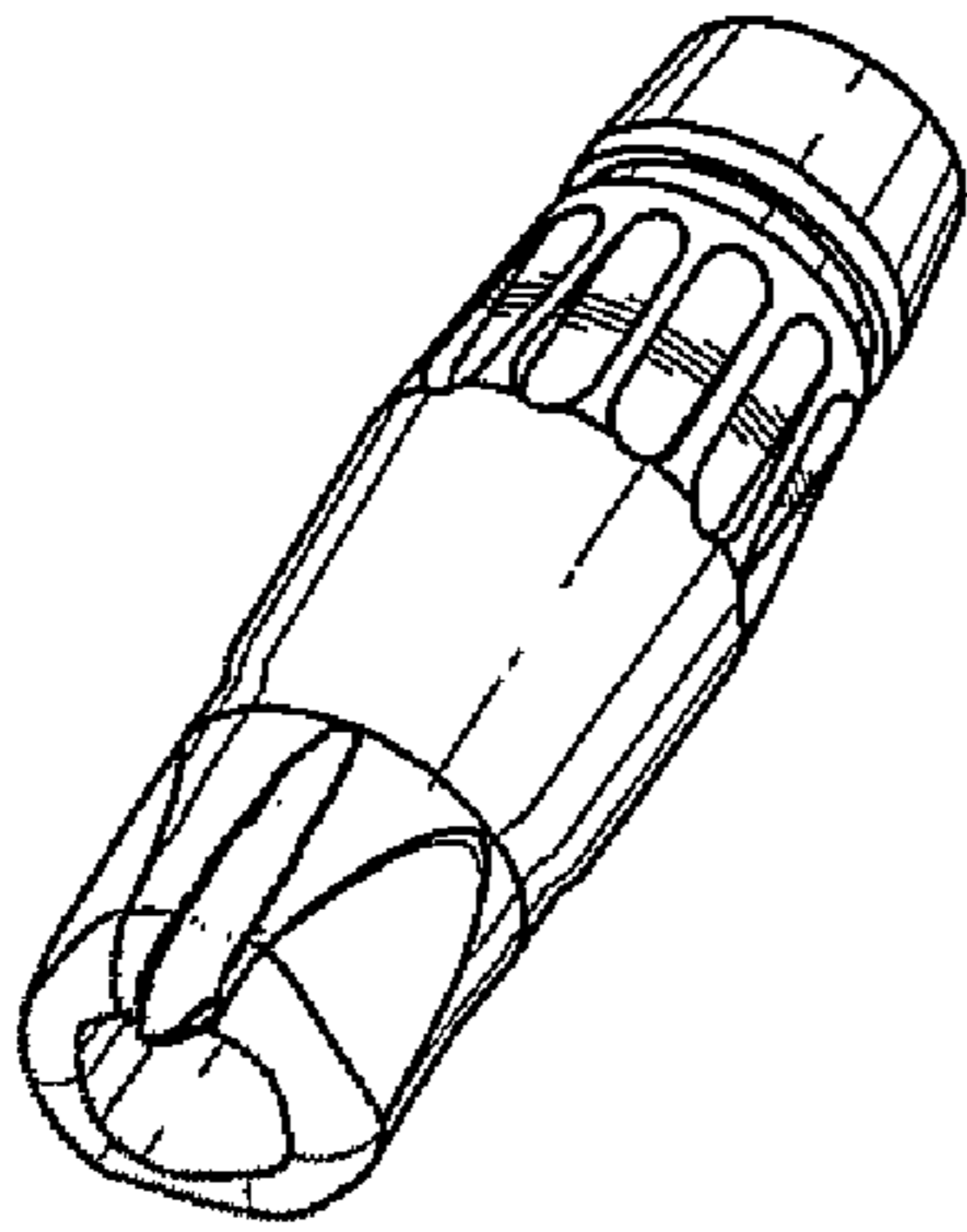
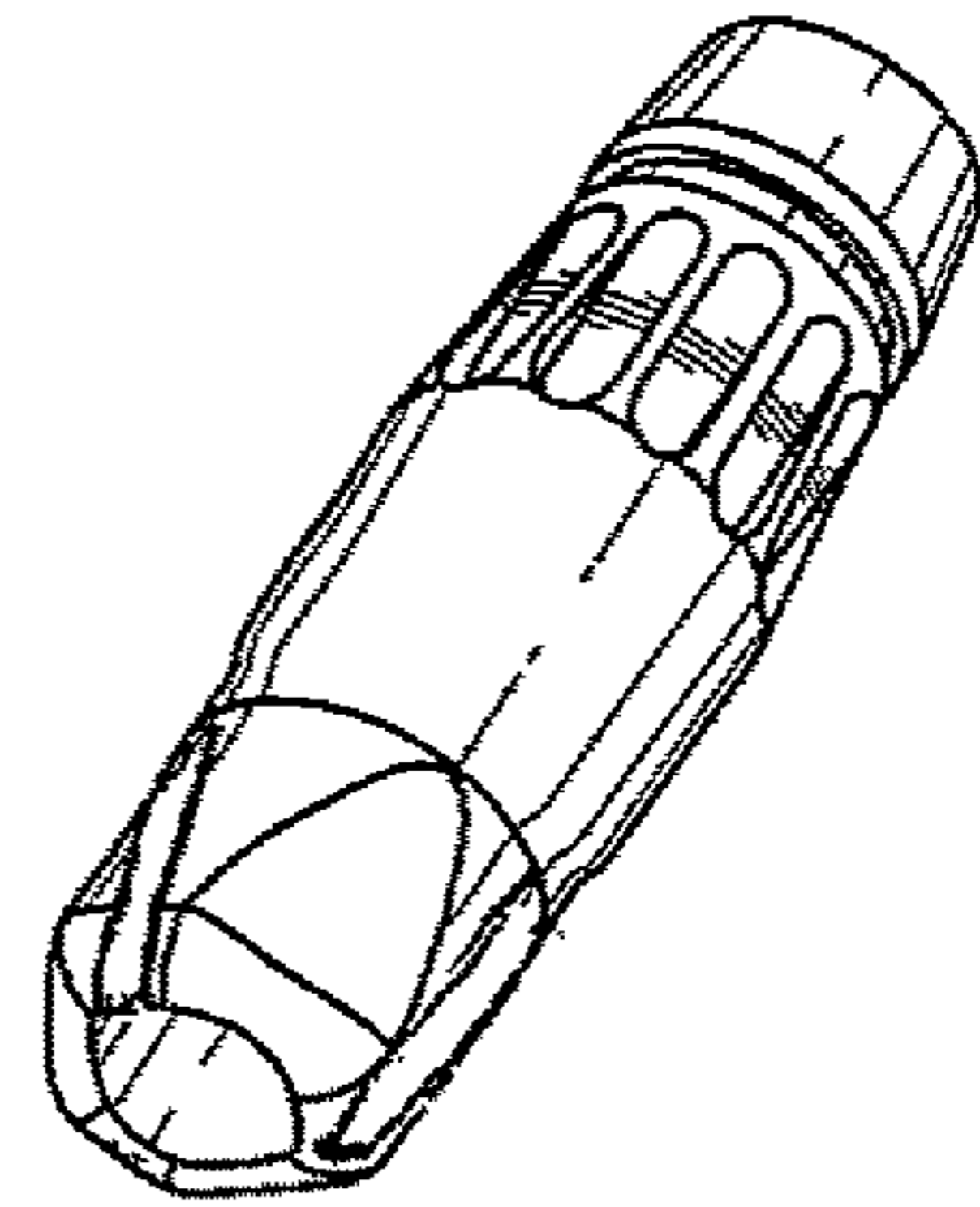


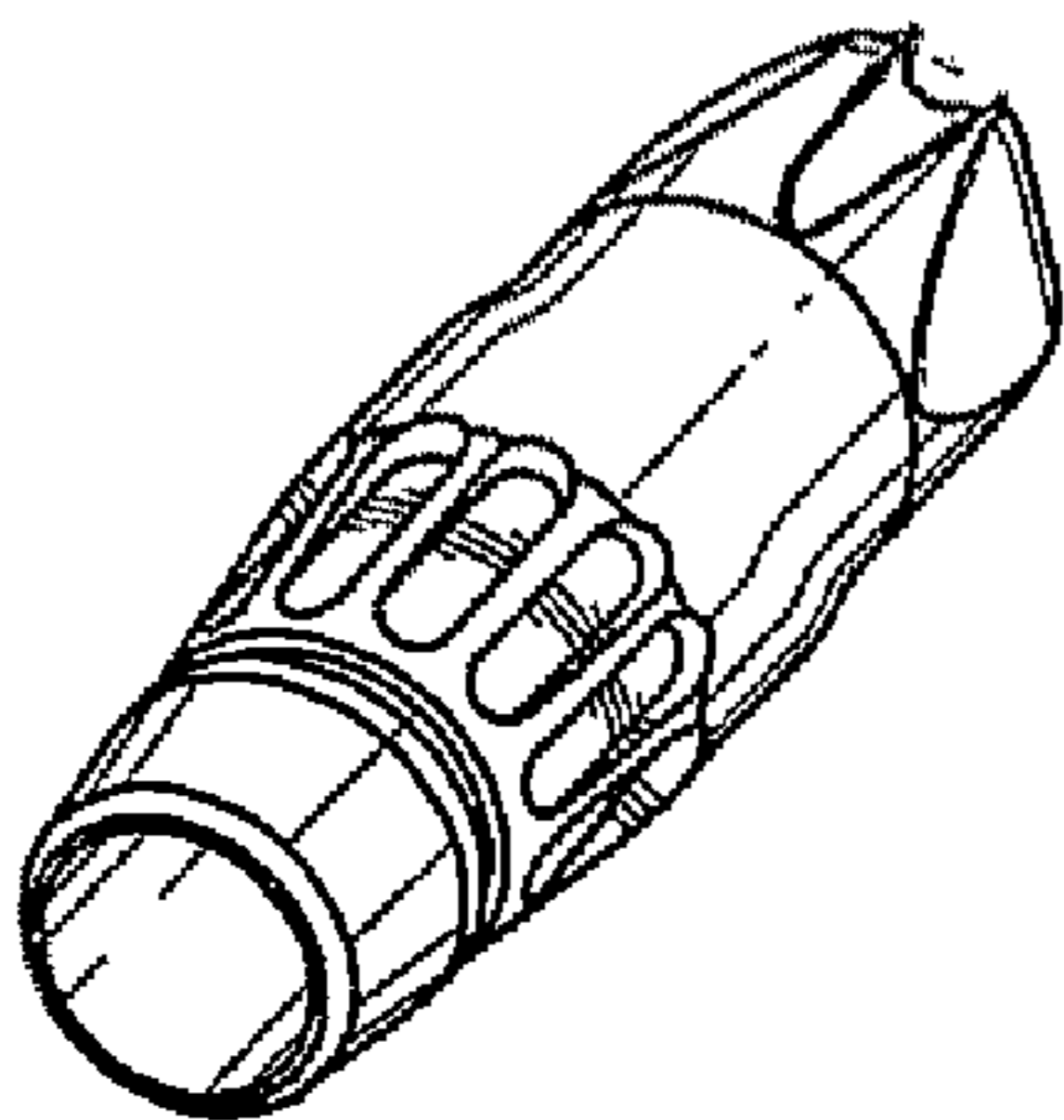

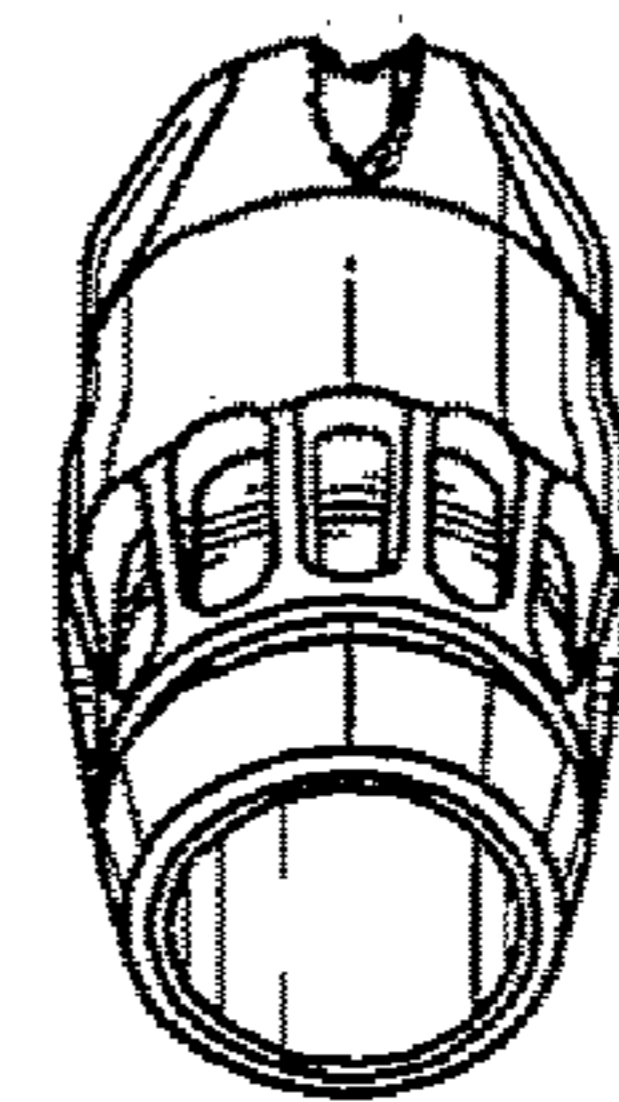

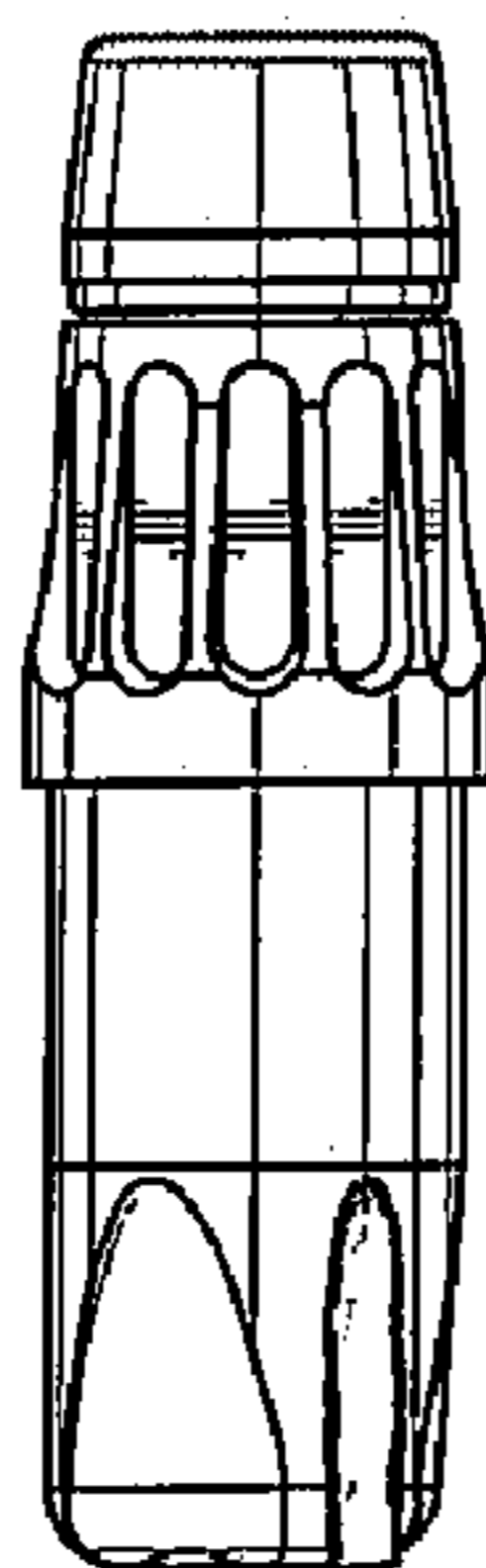

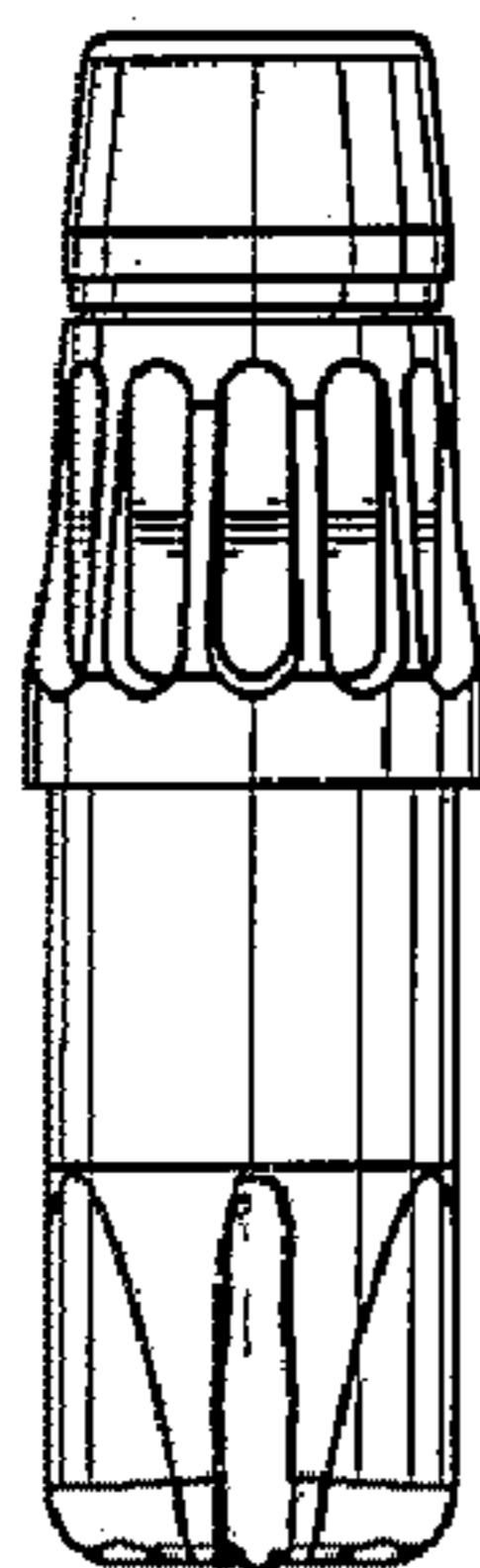

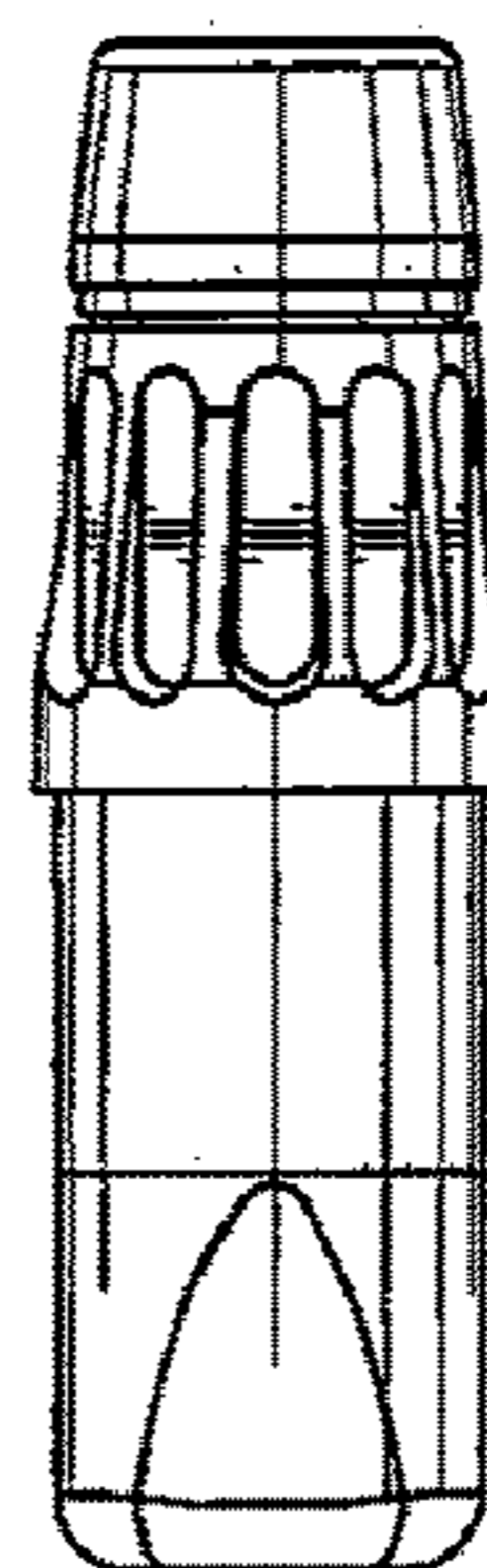

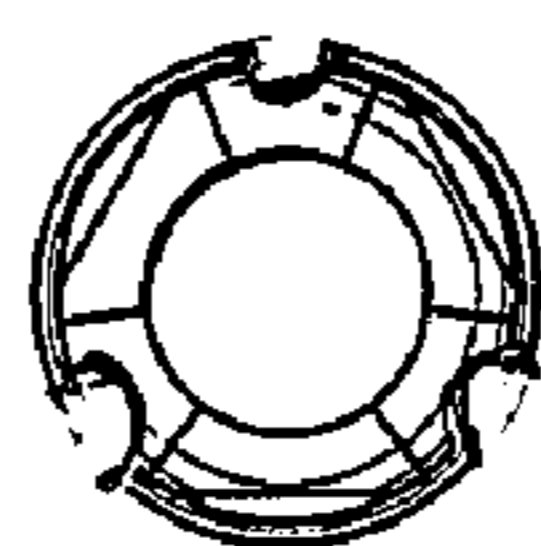
