The ornamental design for a ruffled disposable diaper, as shown and described.

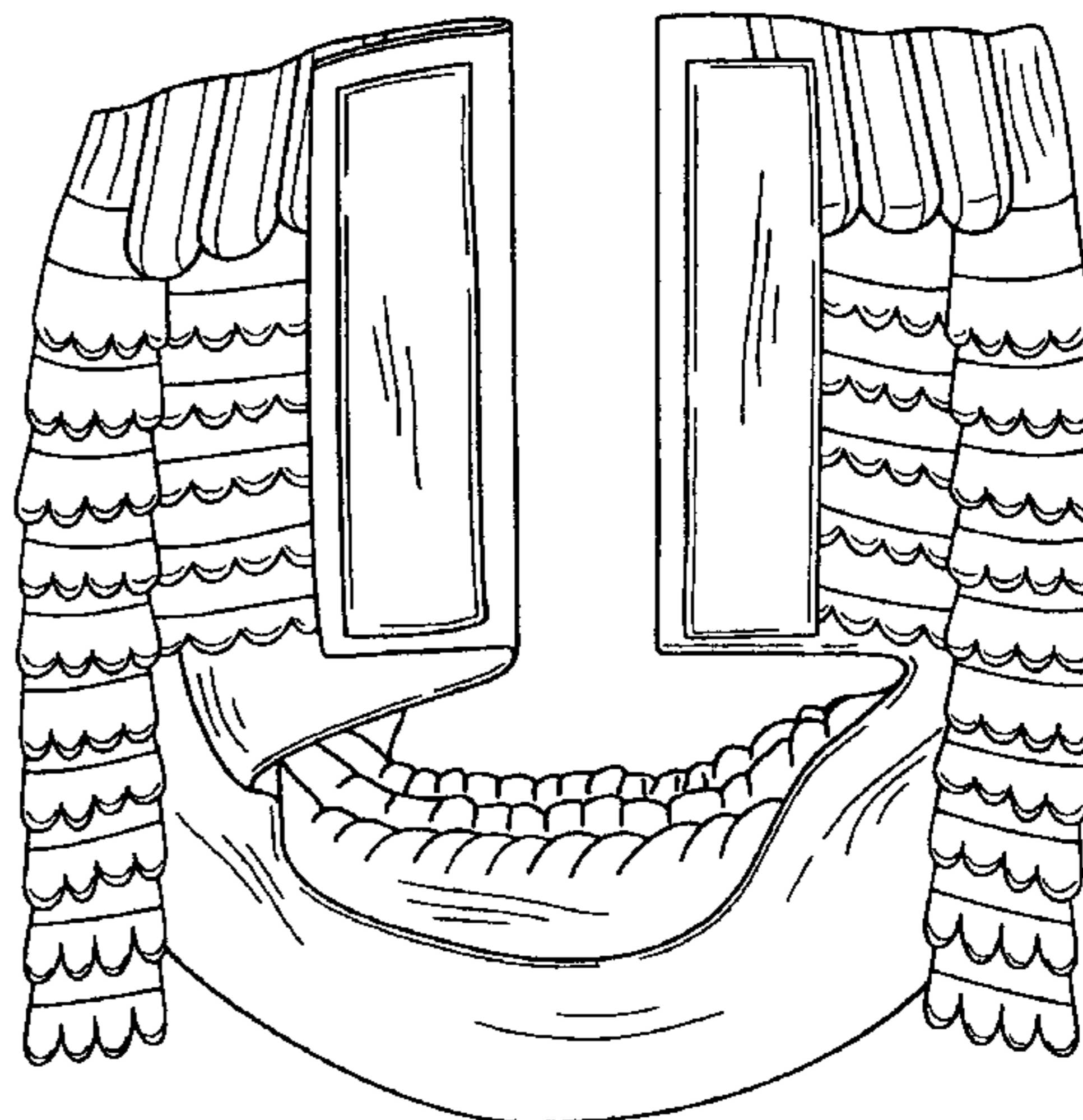
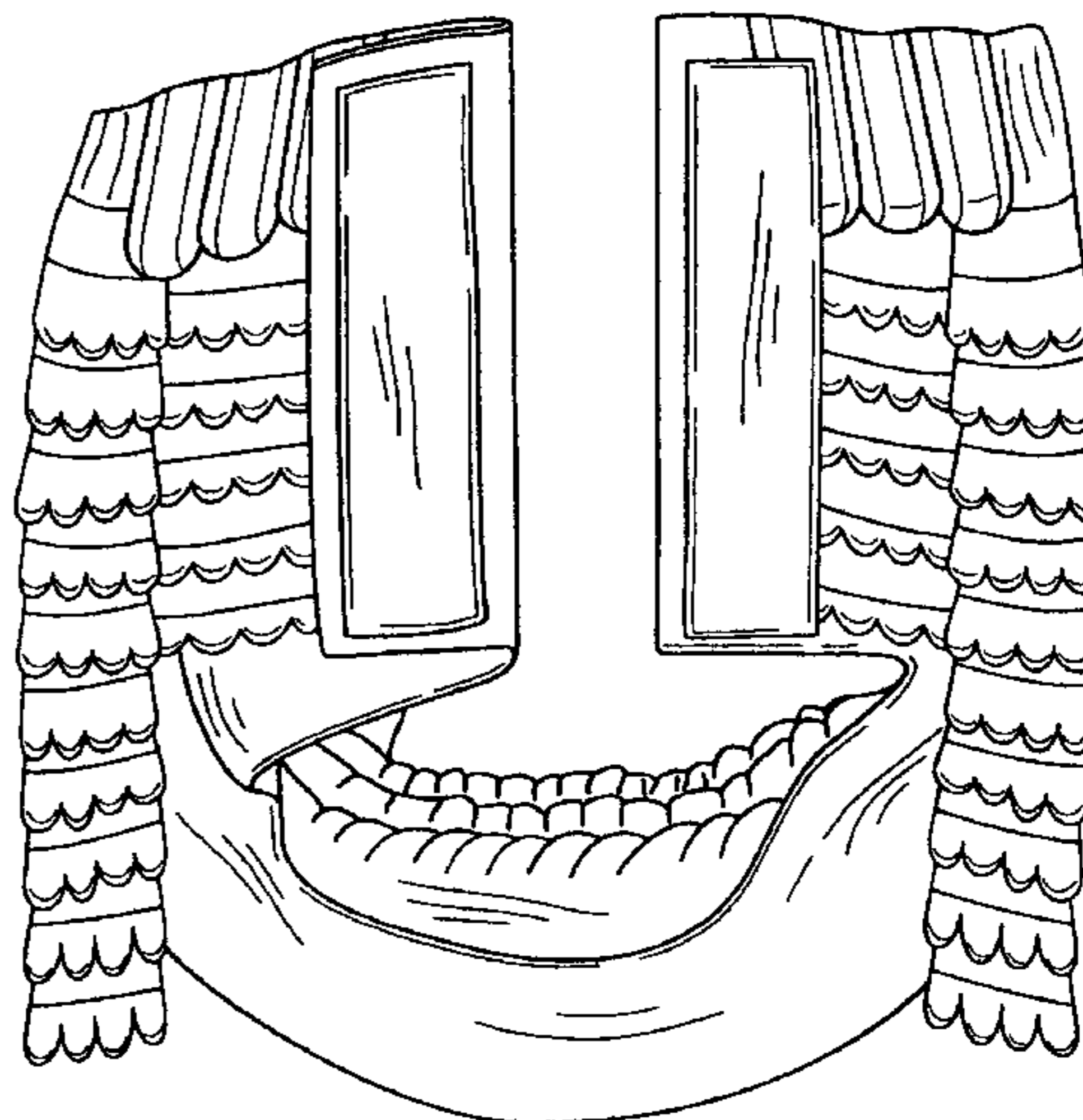
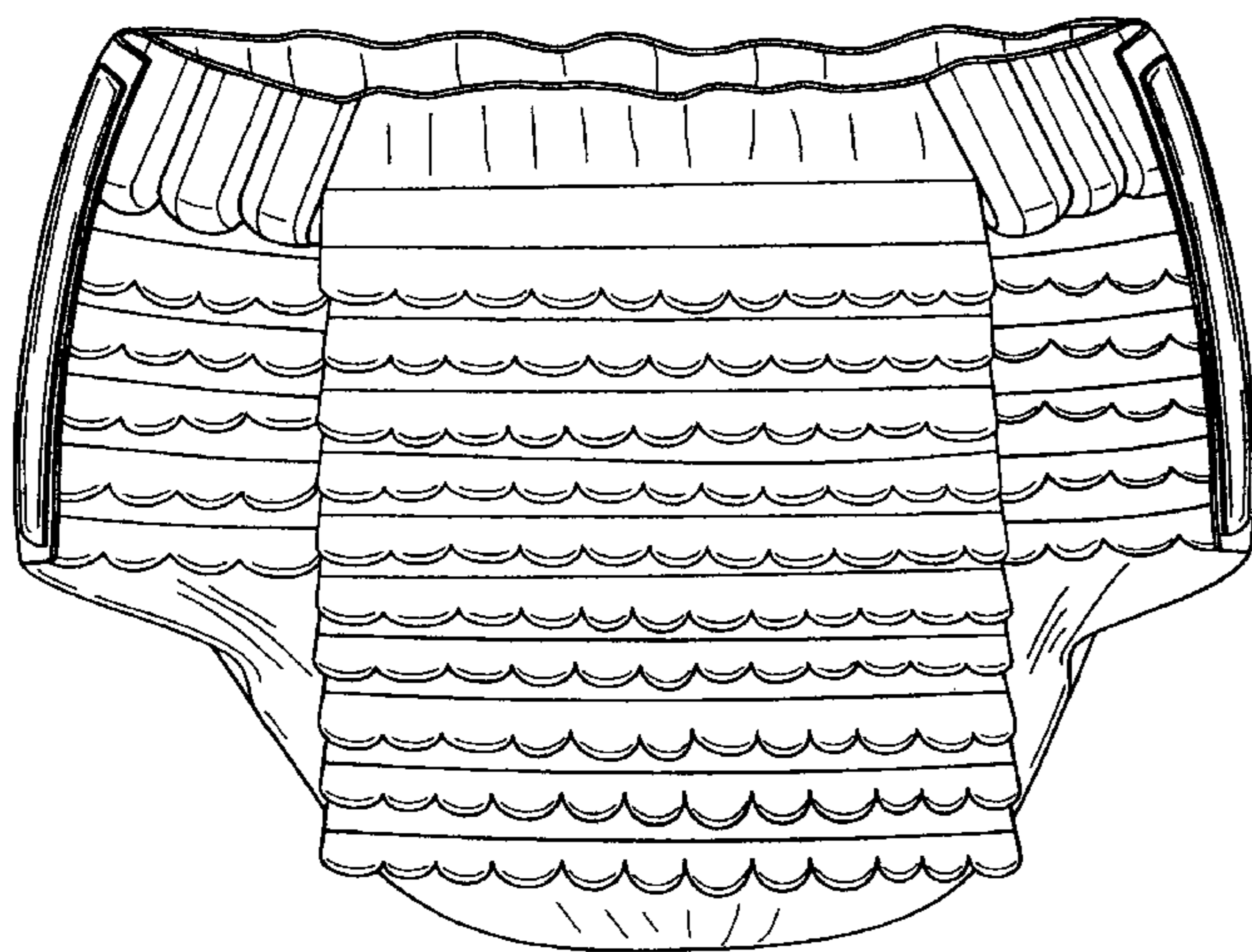
DESCRIPTION

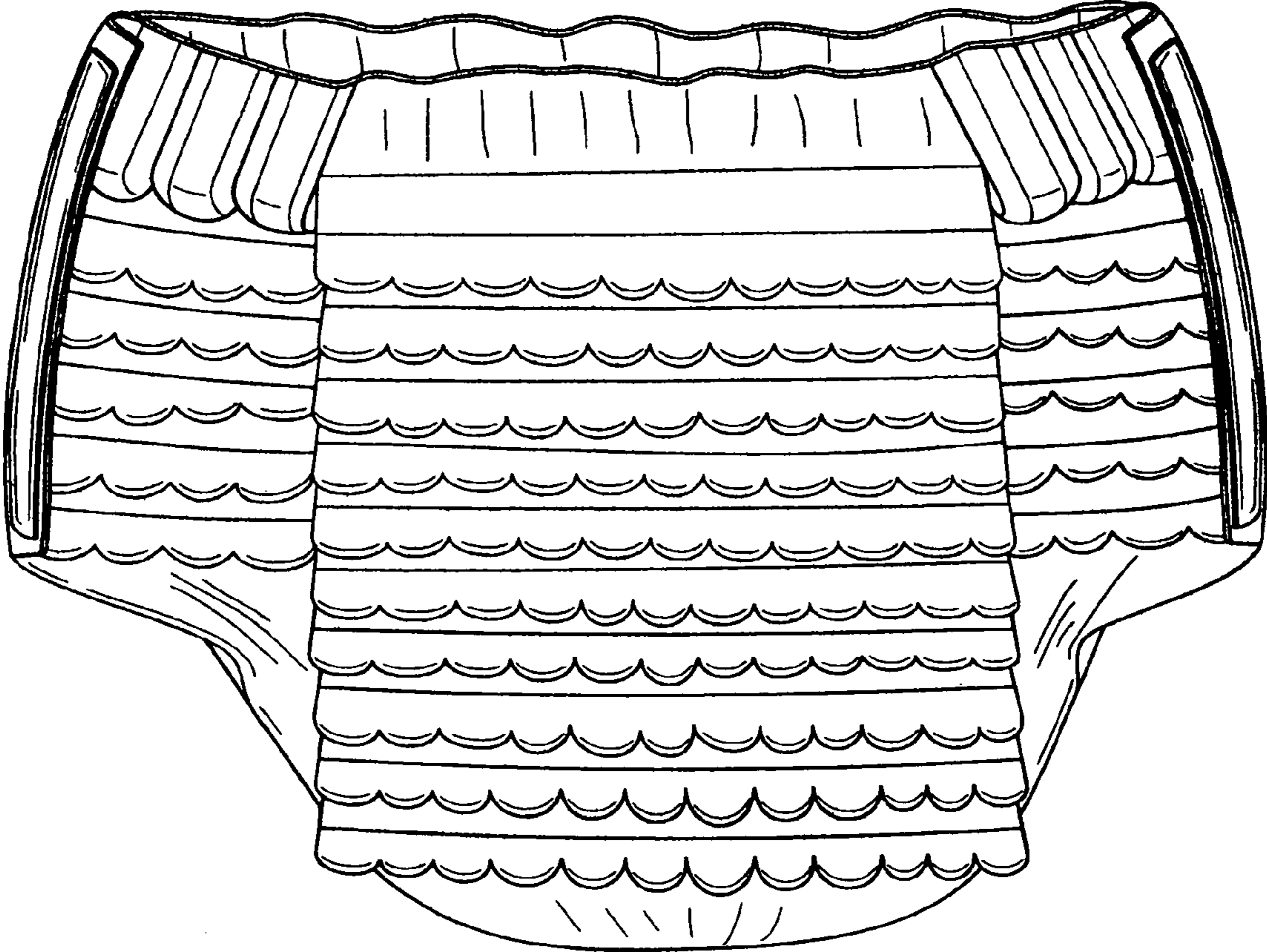

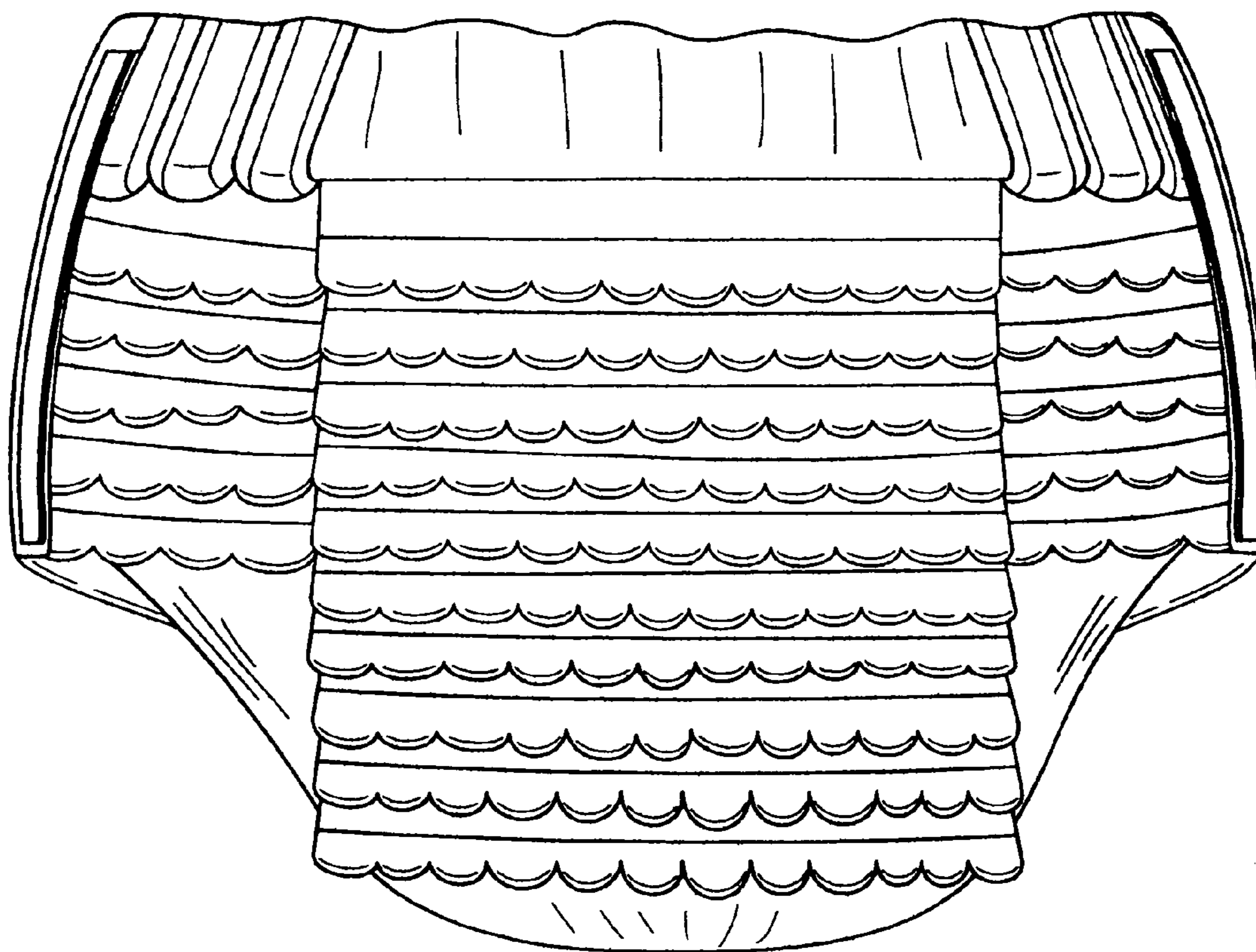
