The ornamental design for the flat panel door facing, as shown and described.

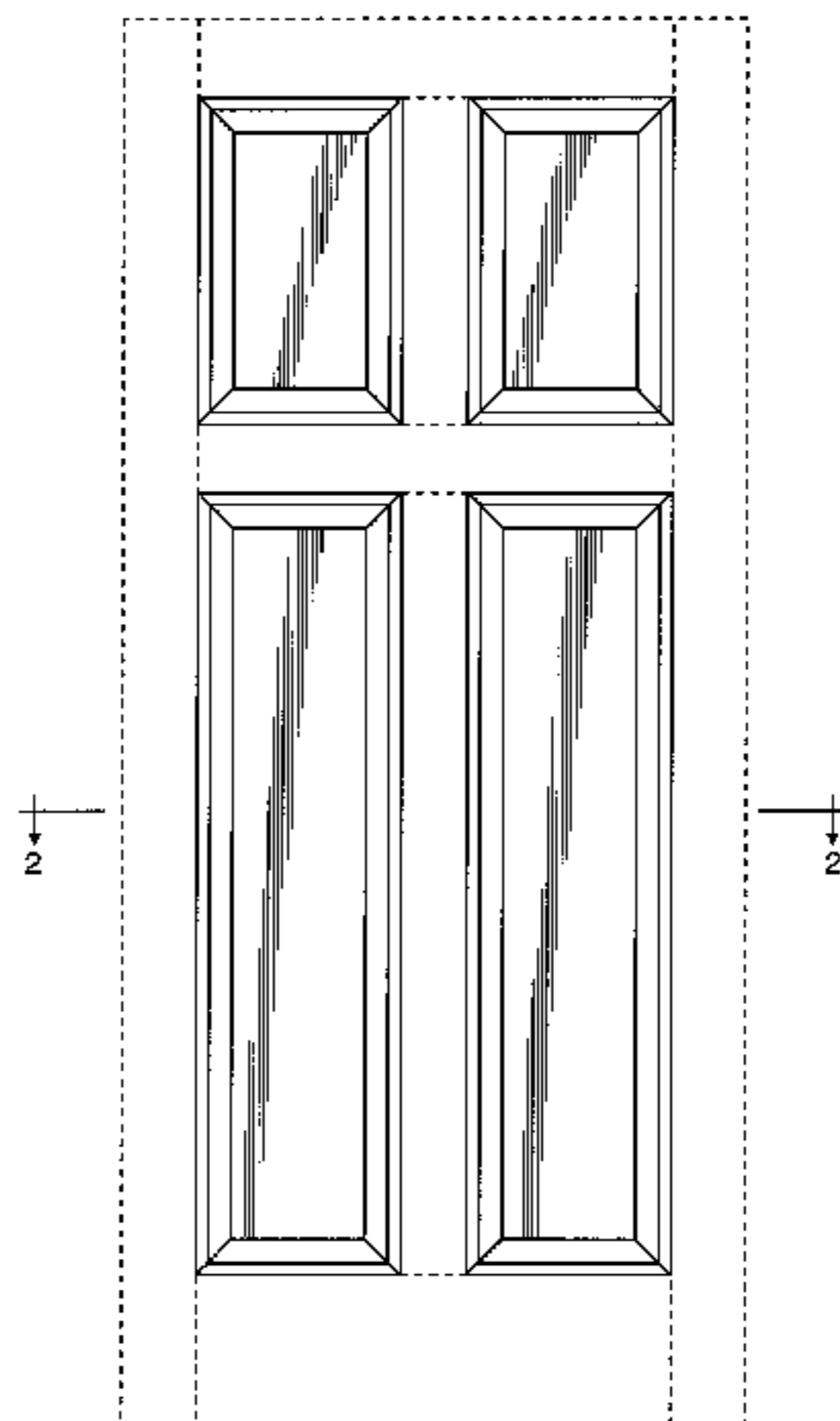
DESCRIPTION

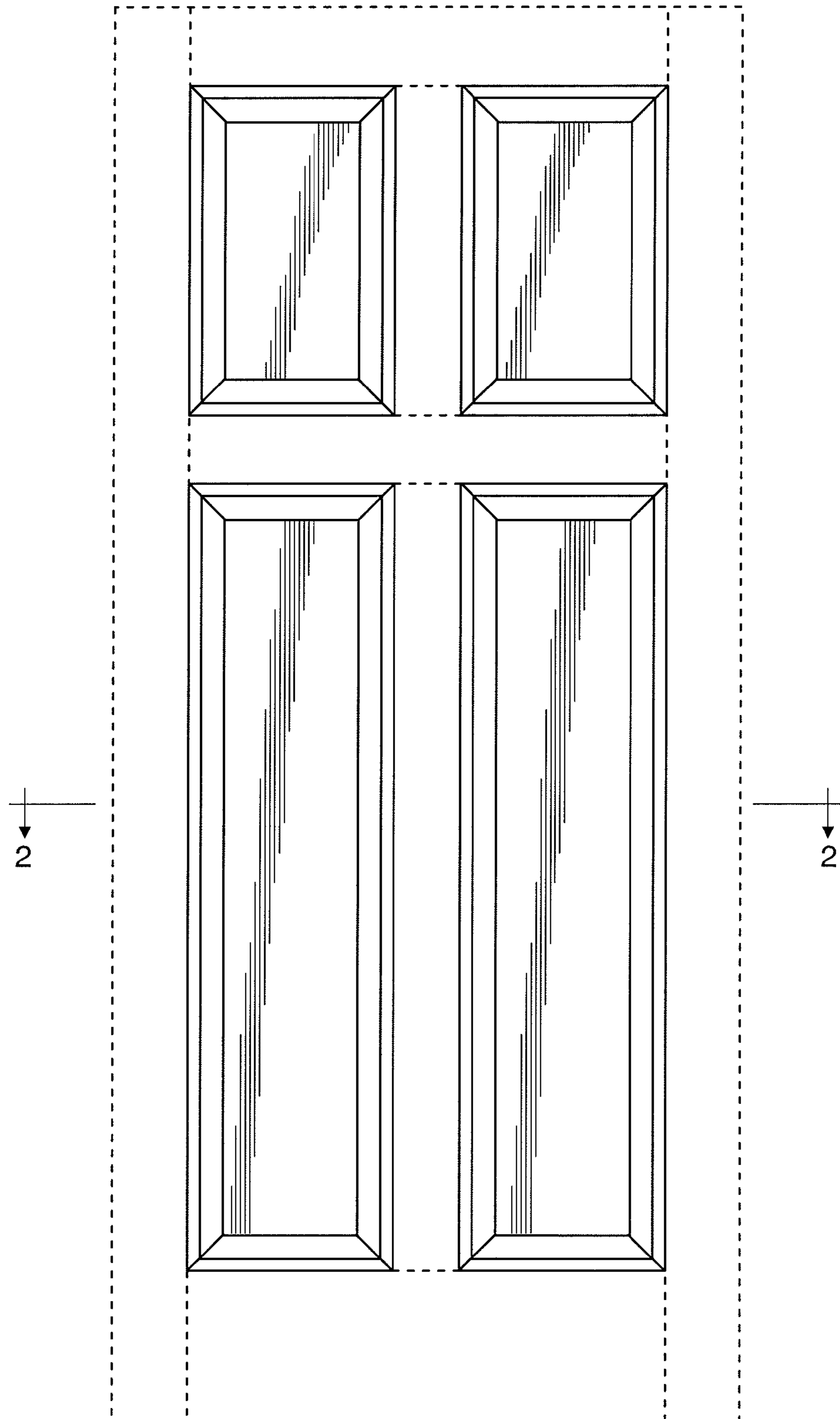
