The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the light fixture showing my new design.

FIG. 2 is a side view of the light fixture shown in FIG. 1.

FIG. 3 is bottom view of the light fixture shown in FIG. 1.

FIG. 4 is a perspective view of a variant of the light fixture.

FIG. 6 is a bottom view of the light fixture shown FIG. 4.

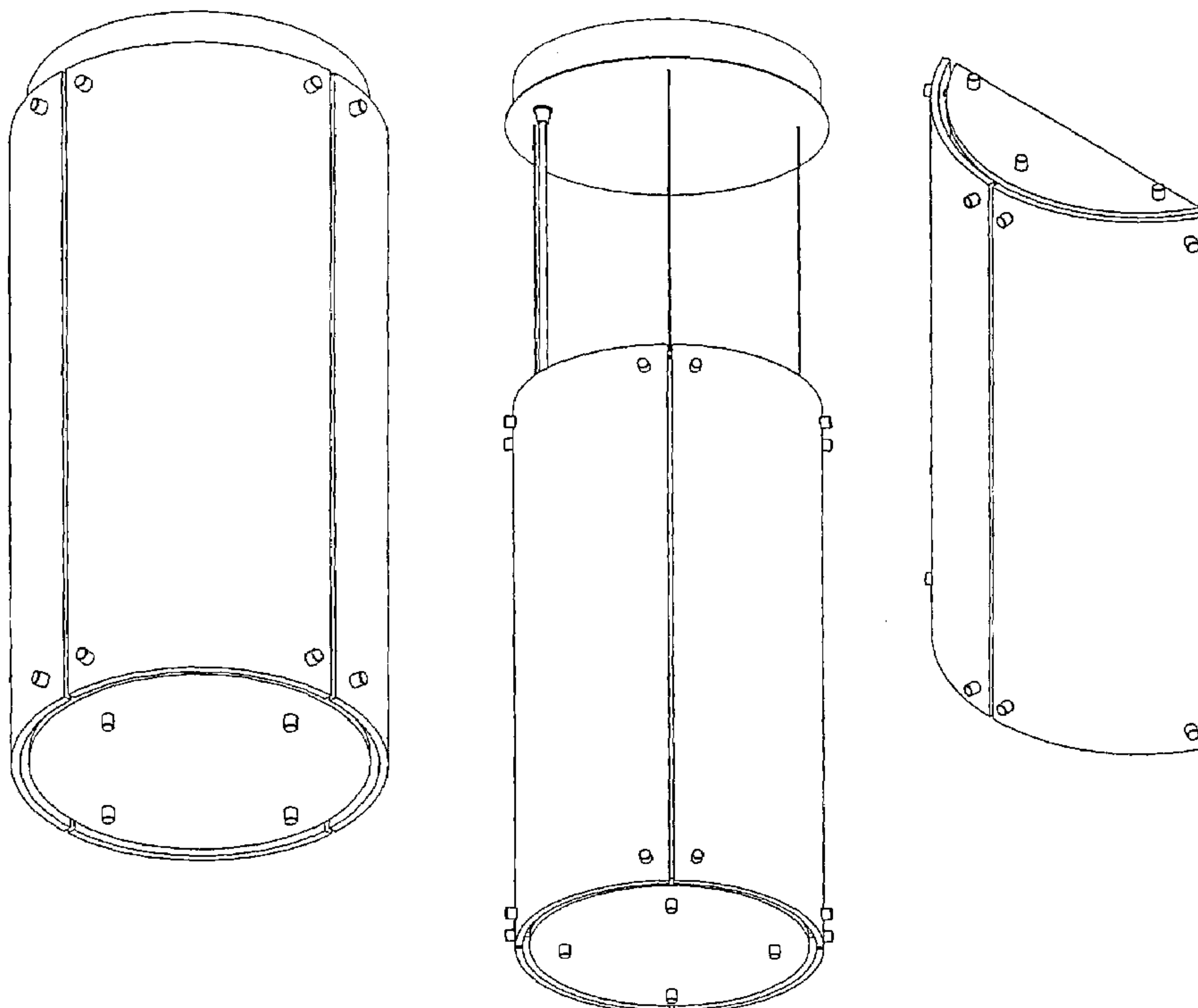
FIG. 7 is a perspective view of a second variant of the light fixture.

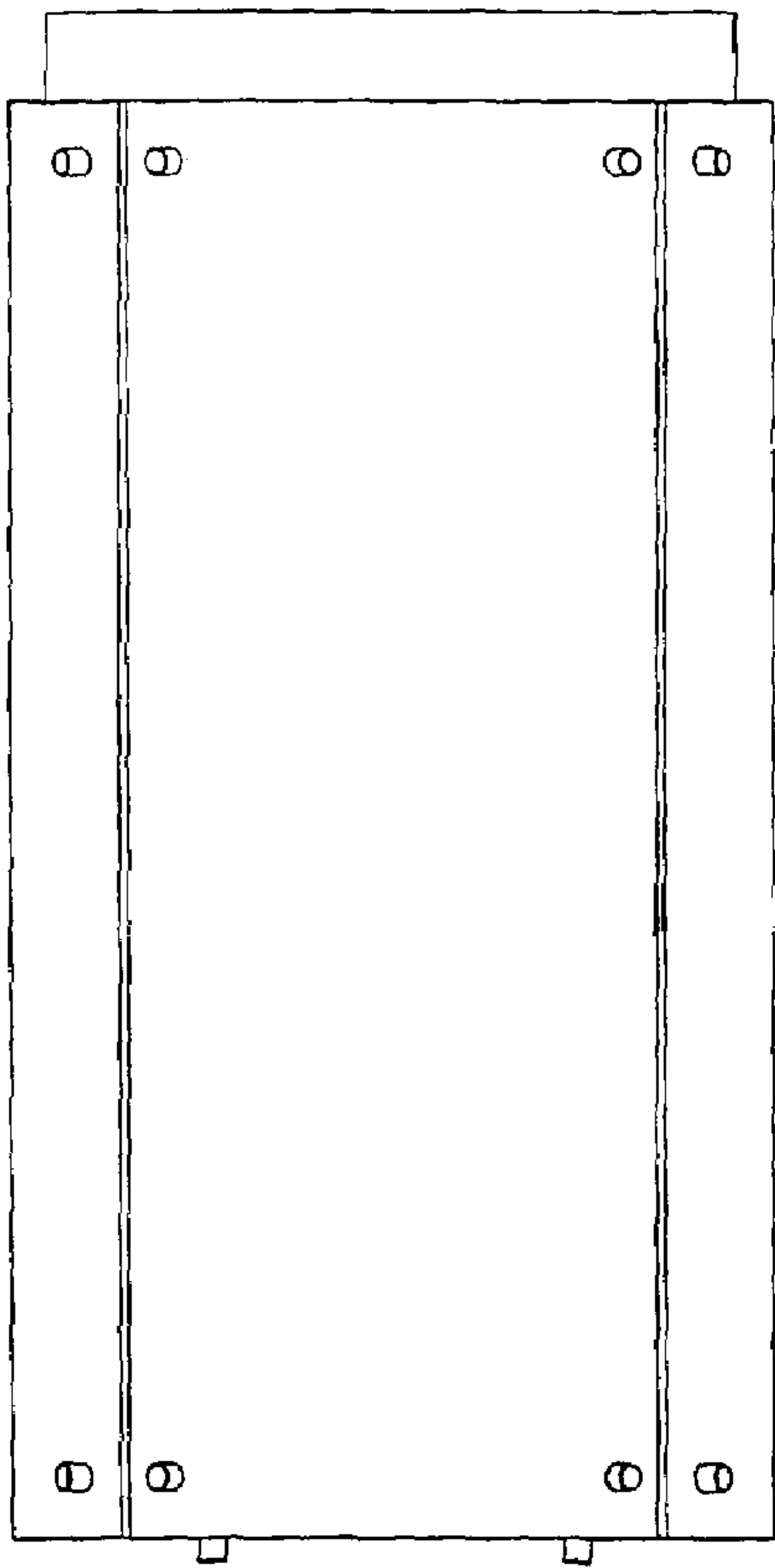

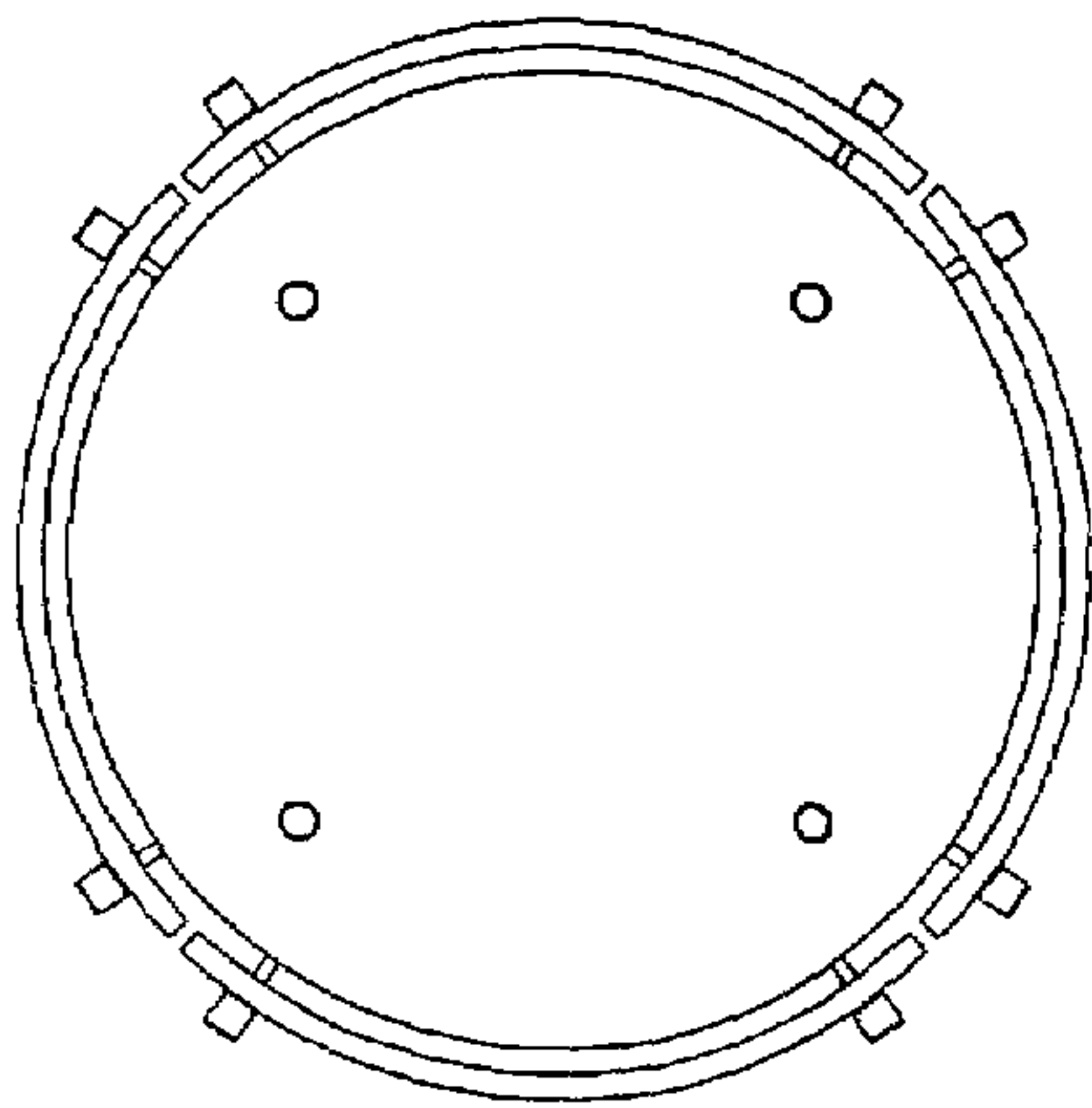

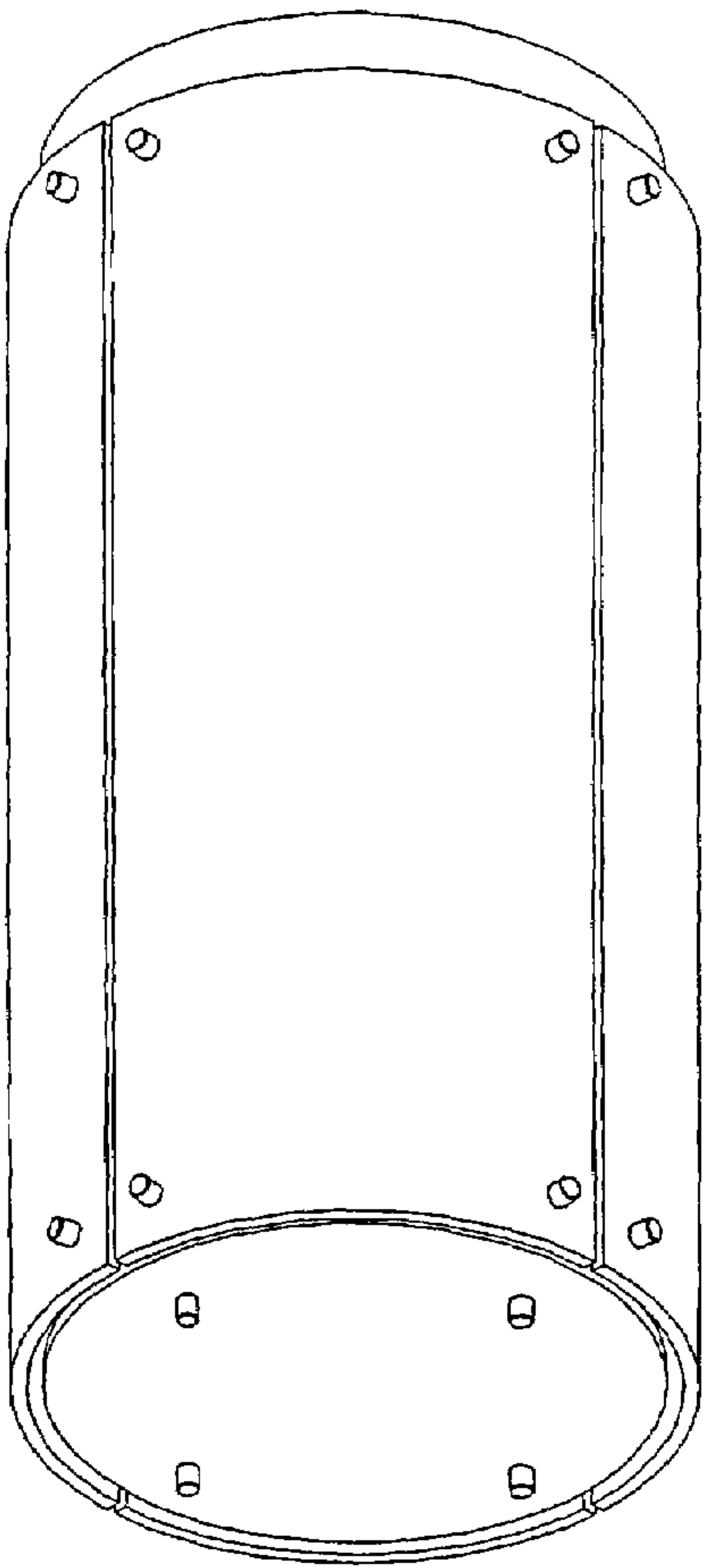

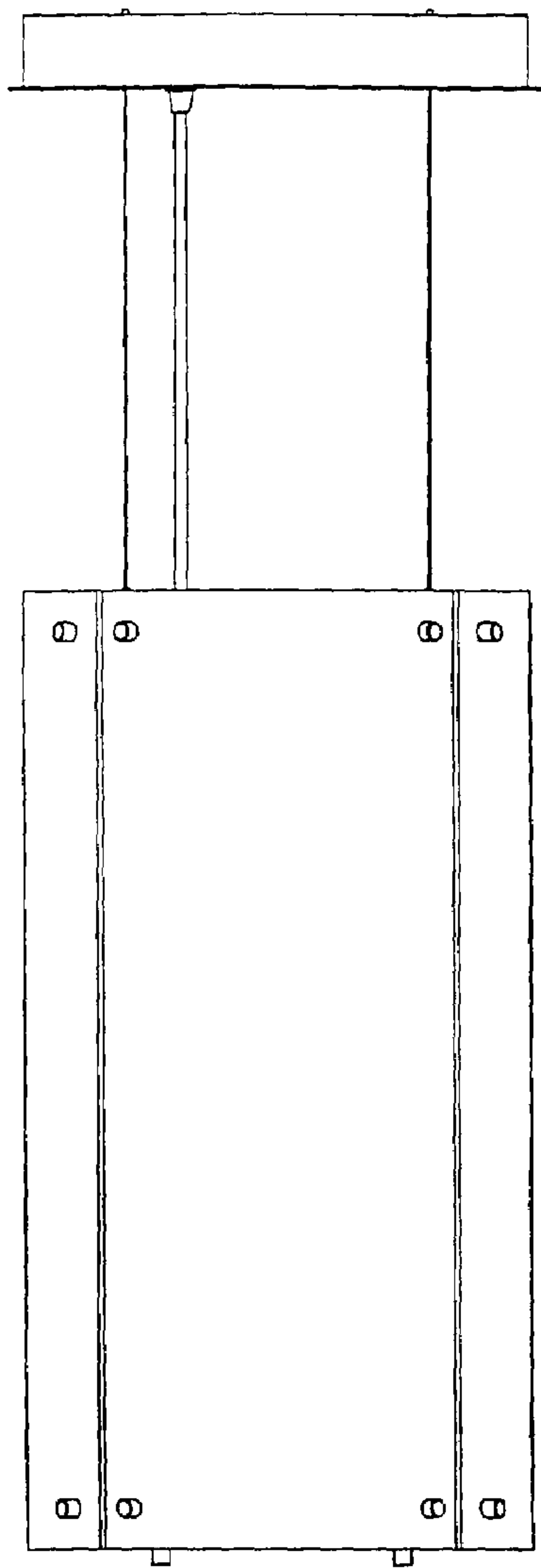

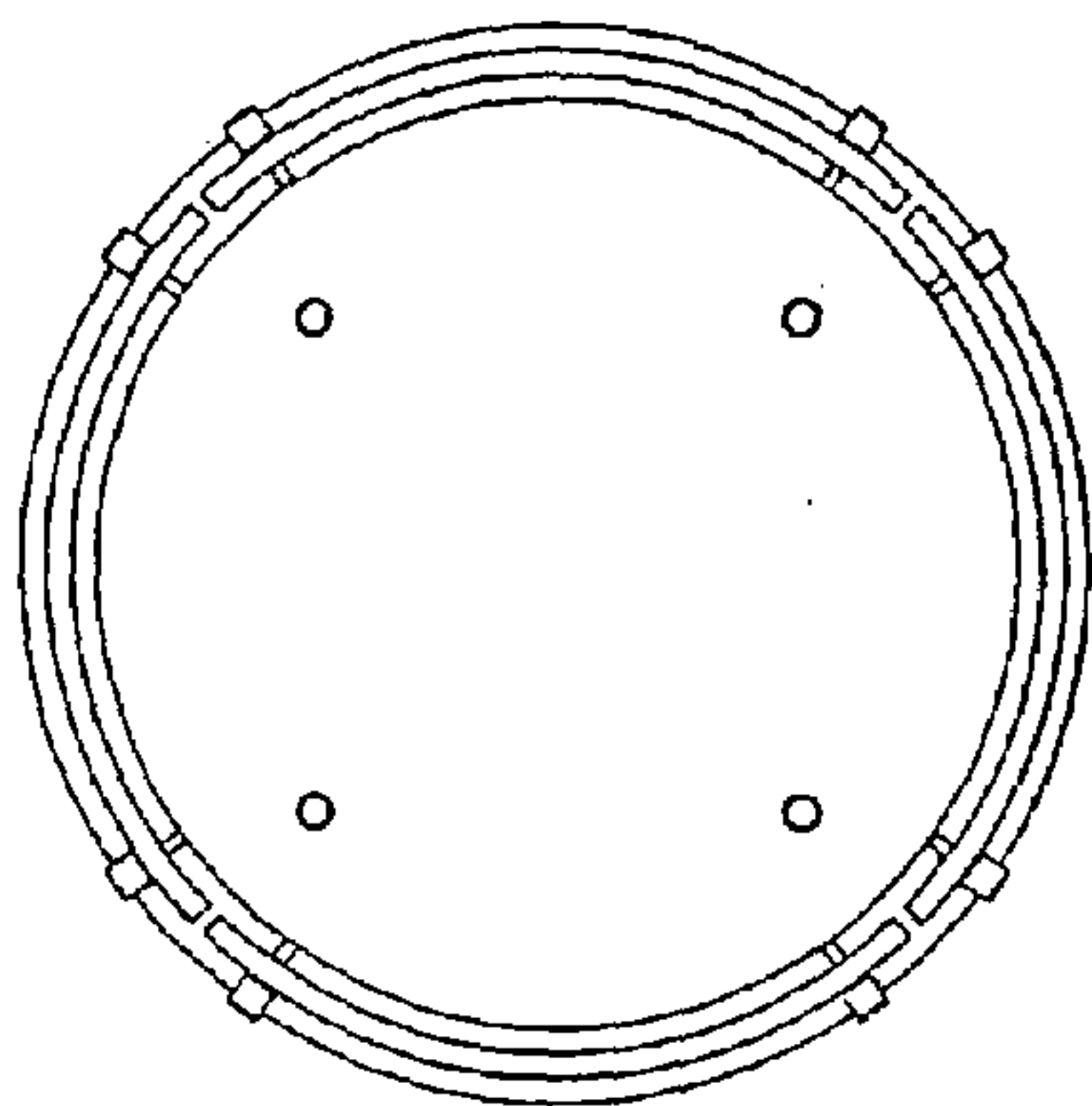

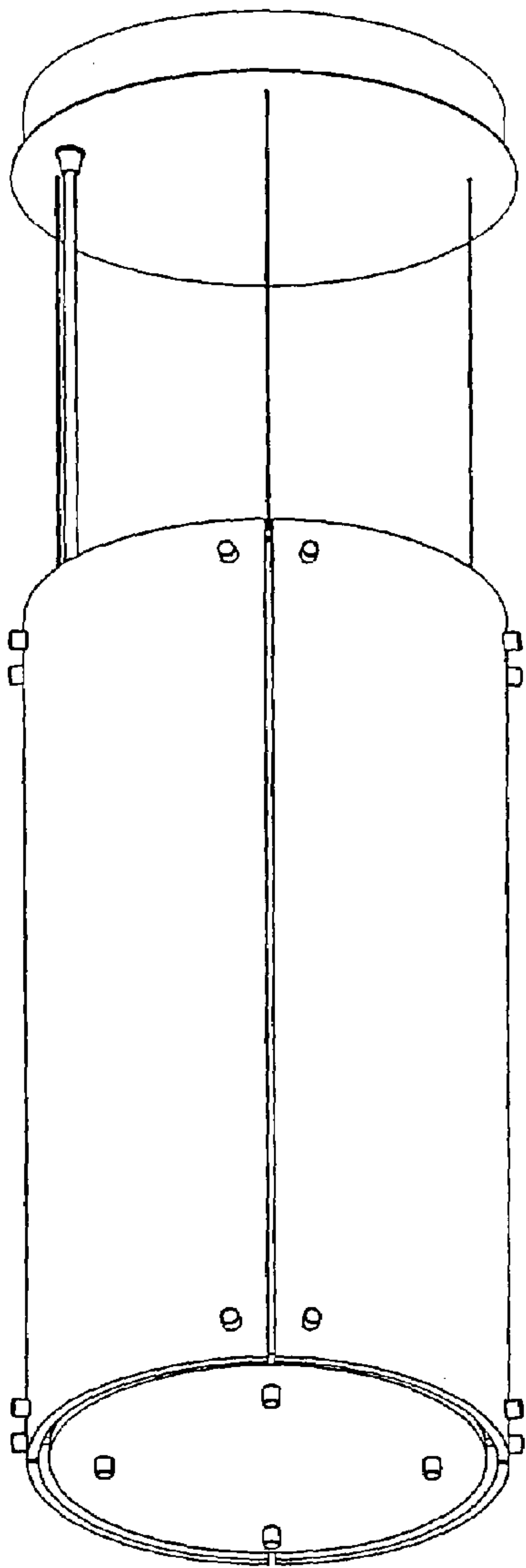

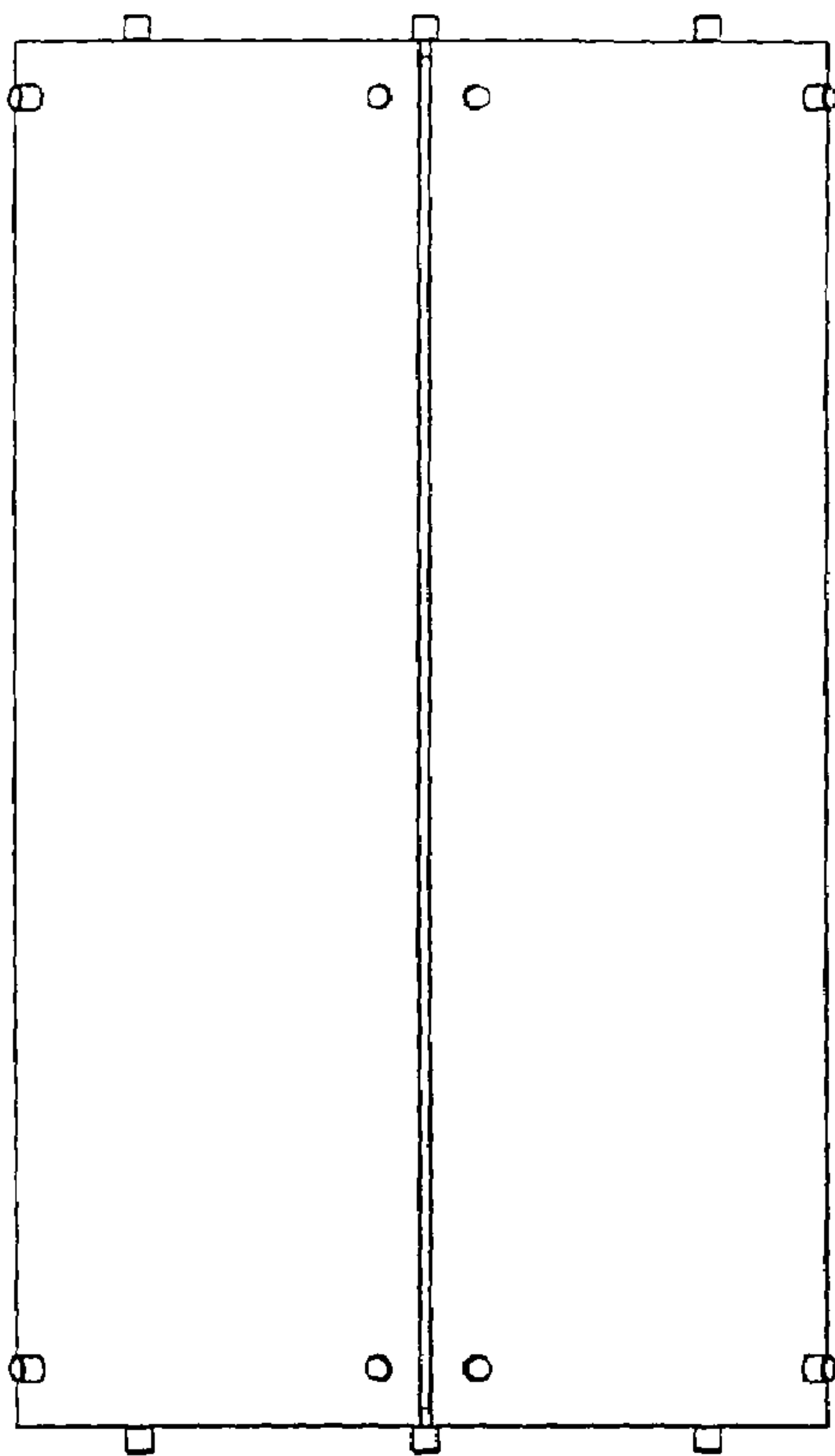

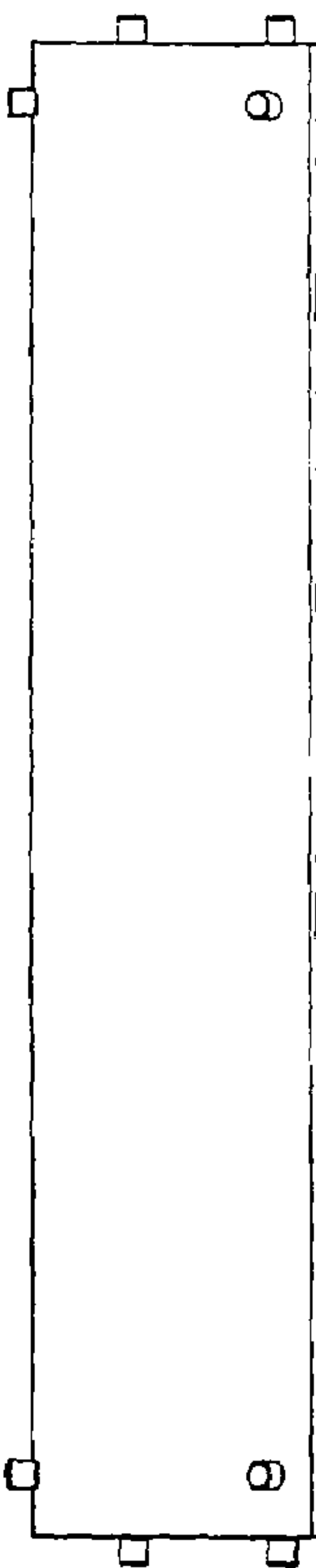

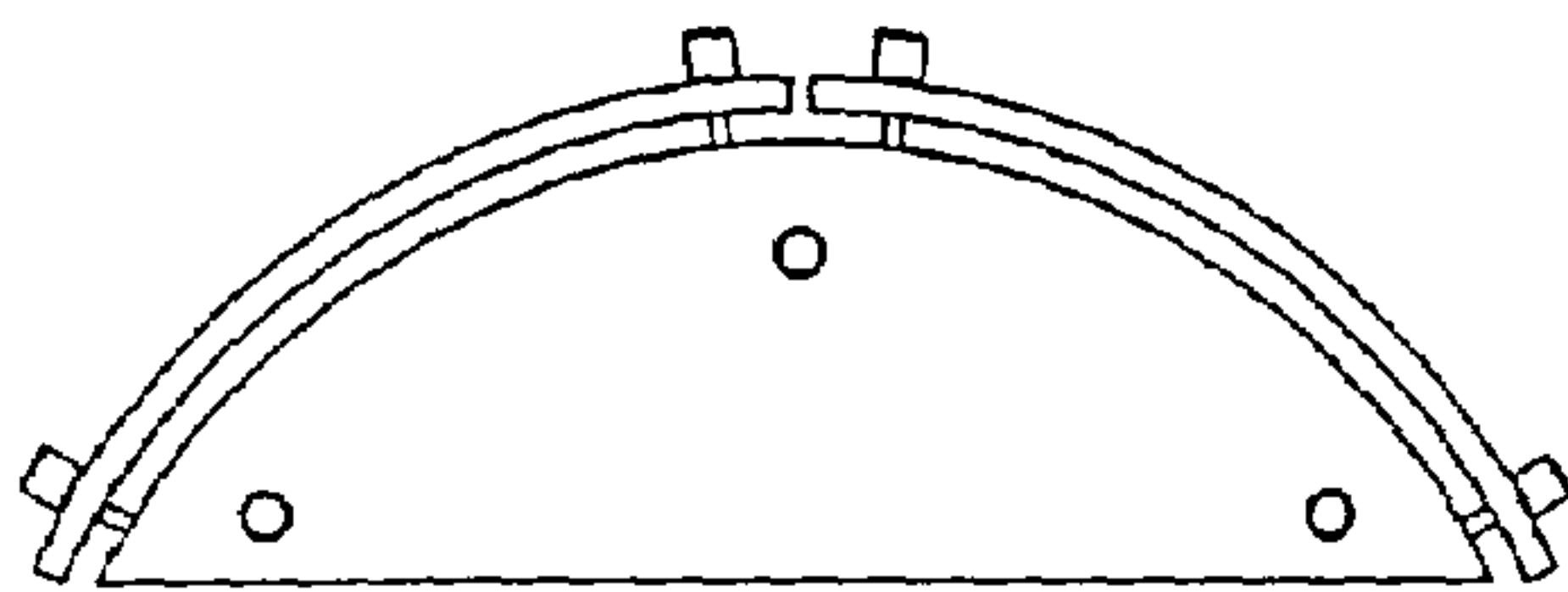

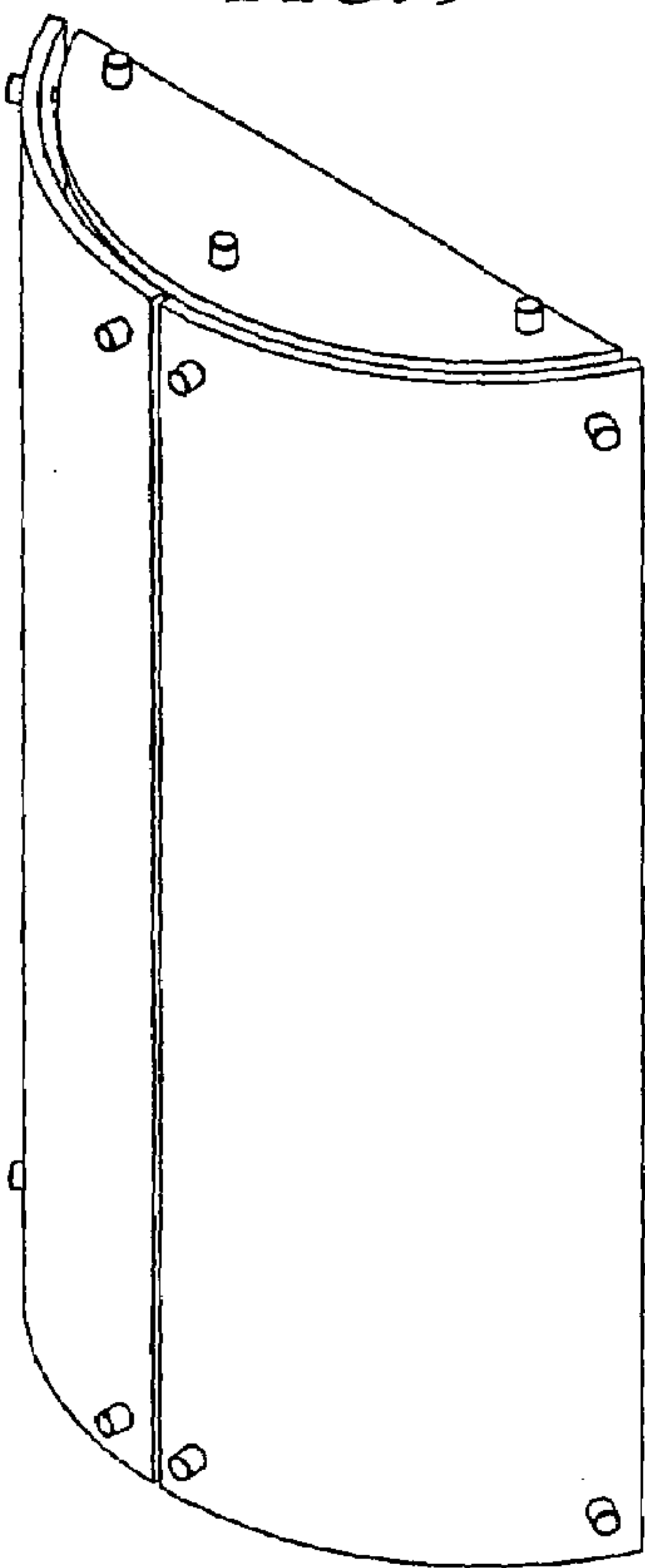
