FIG. 3 is a left side elevational view of the bra of FIG. 2;

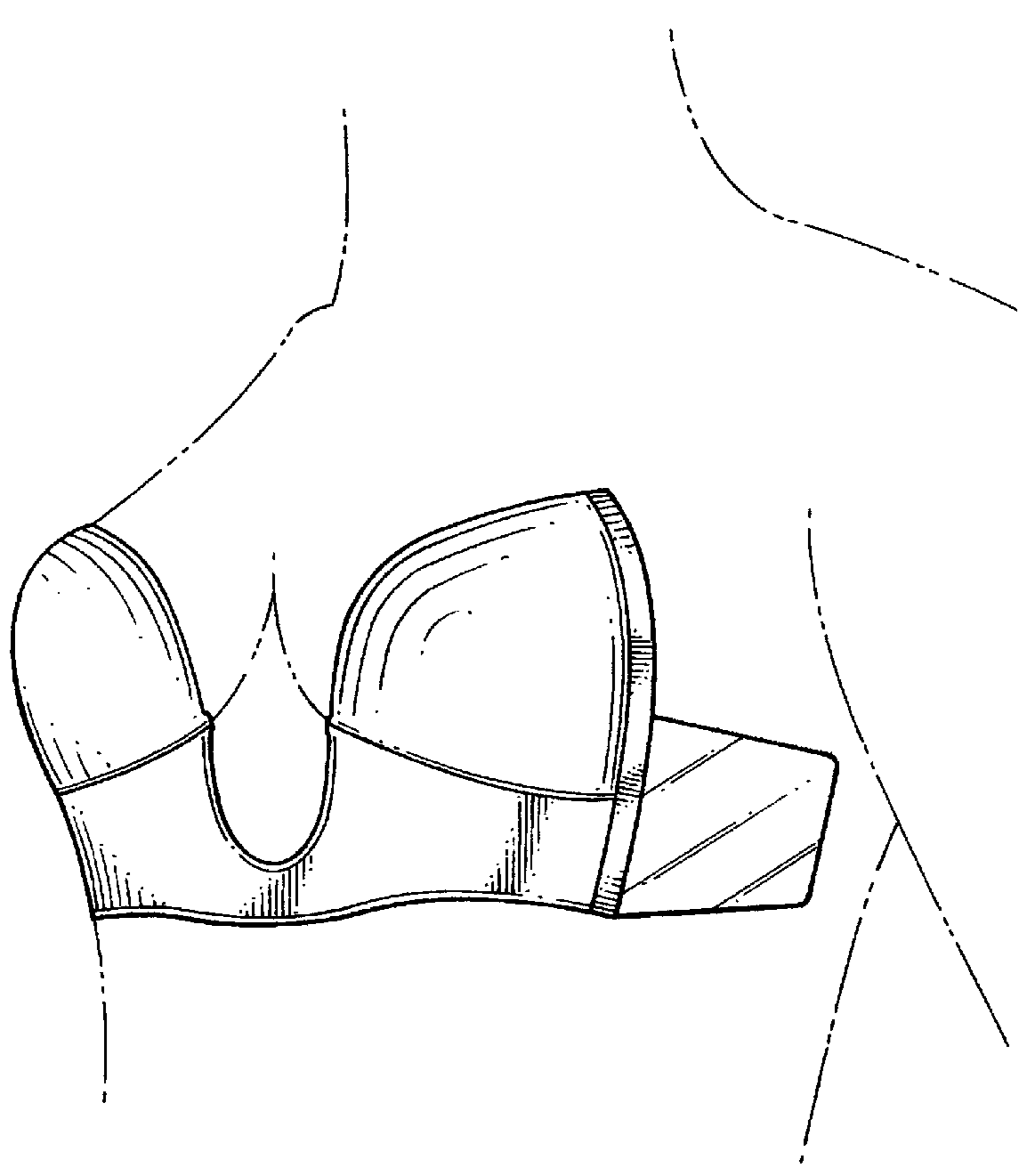
FIG. 4 is a rear elevational view of the bra of FIG. 1;

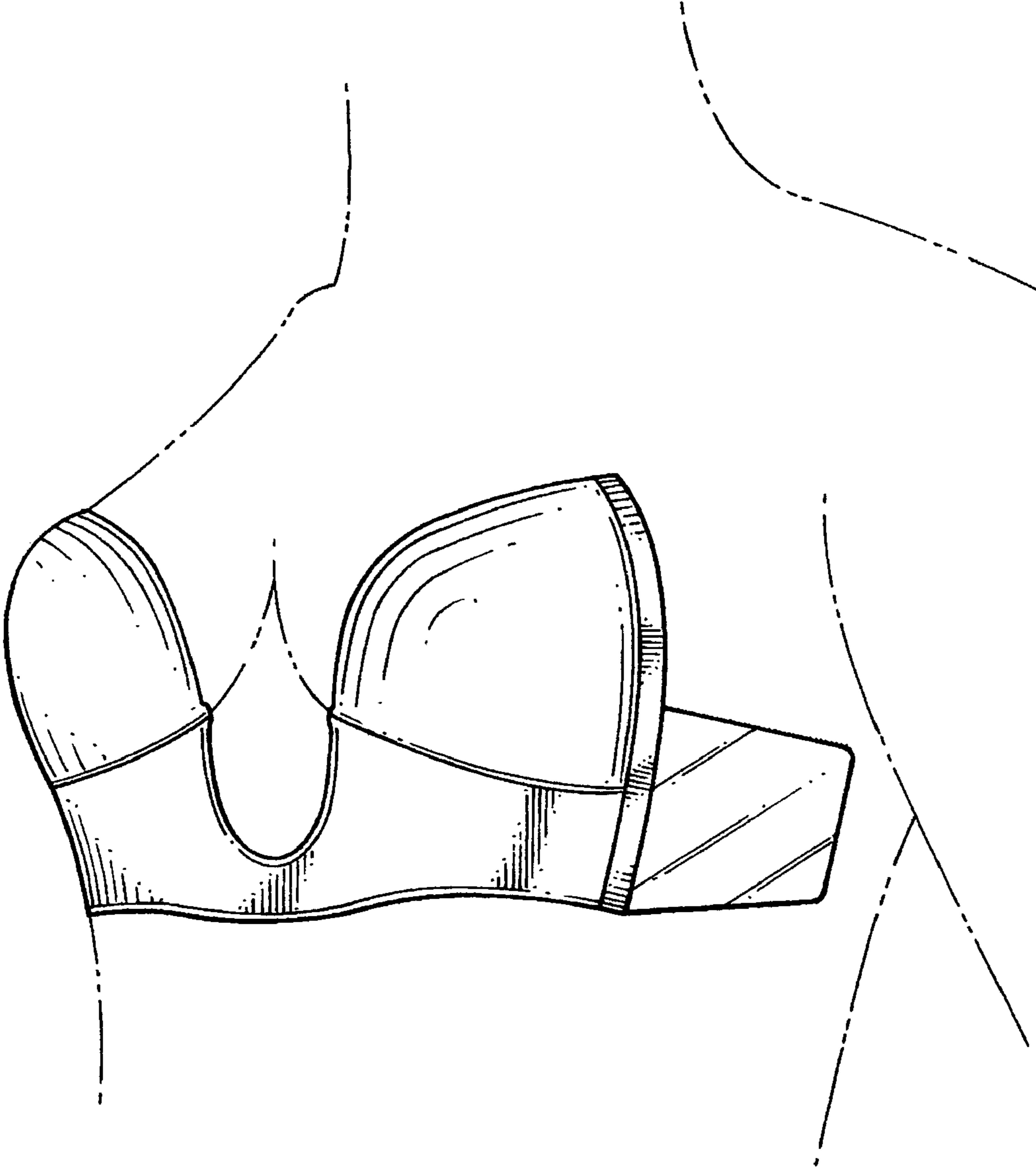

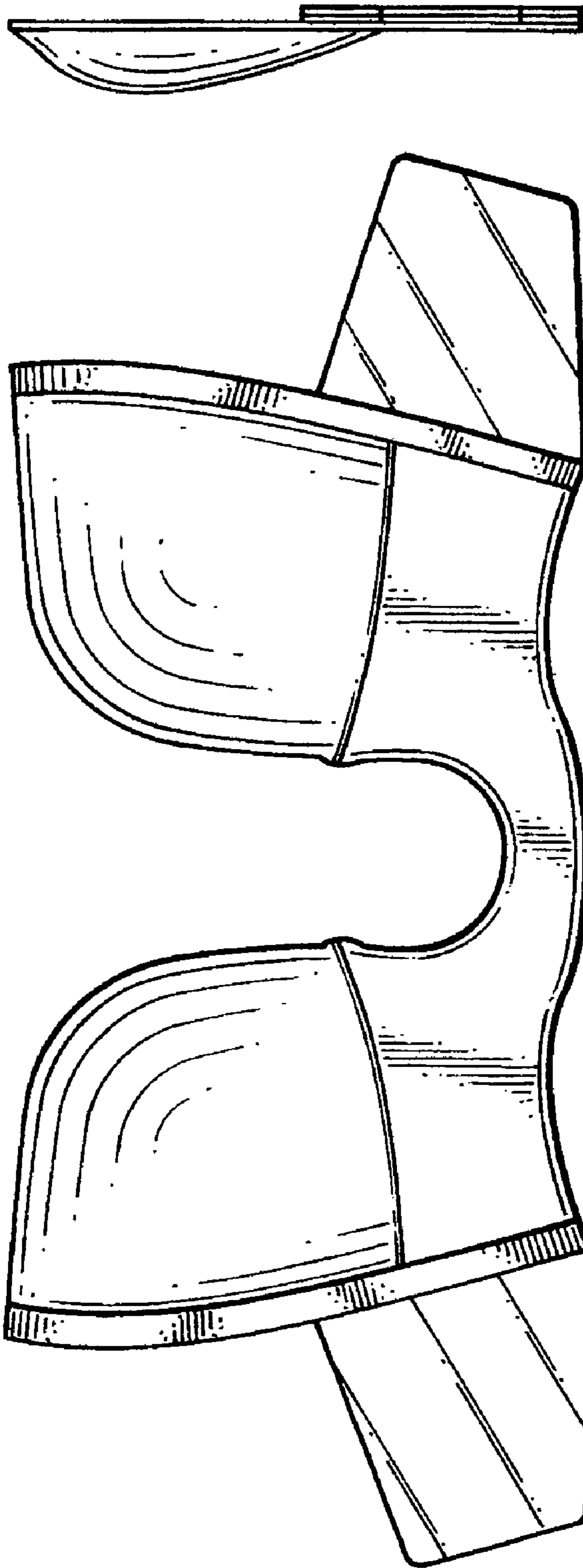

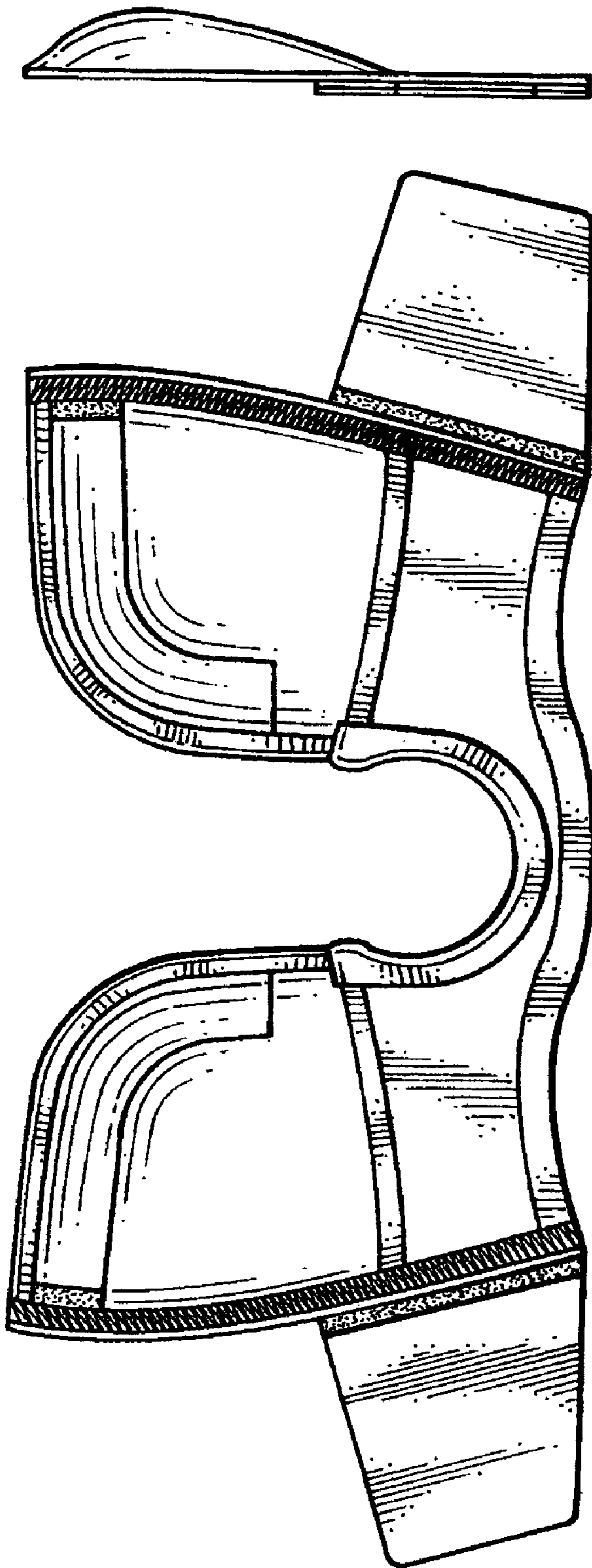
