I claim the ornamental design for triangle nesting pillow, as shown and described.

**DESCRIPTION**

FIG. 1 an exploded front, side perspective view of the circle nesting pillows, showing my new design;

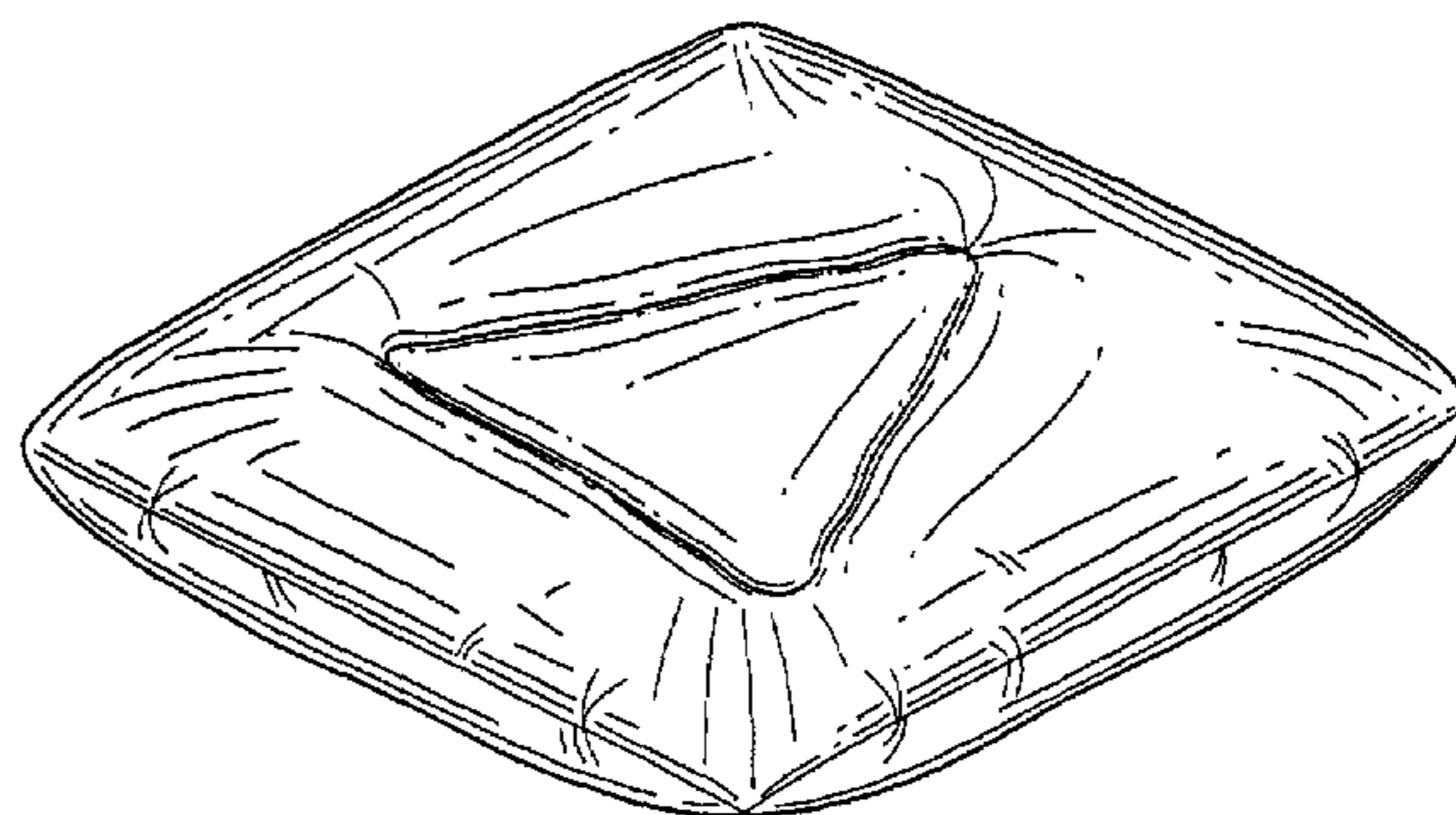
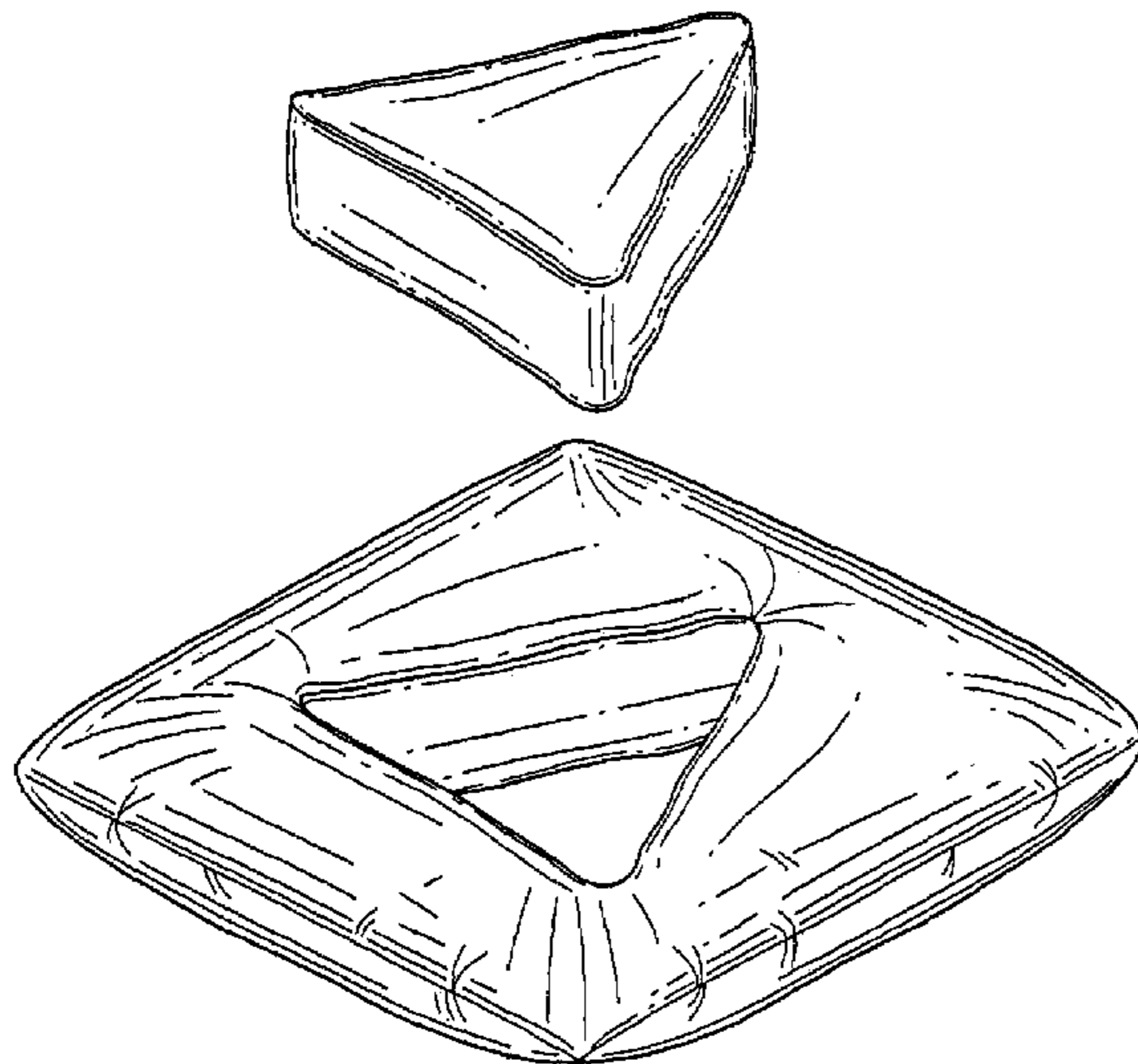

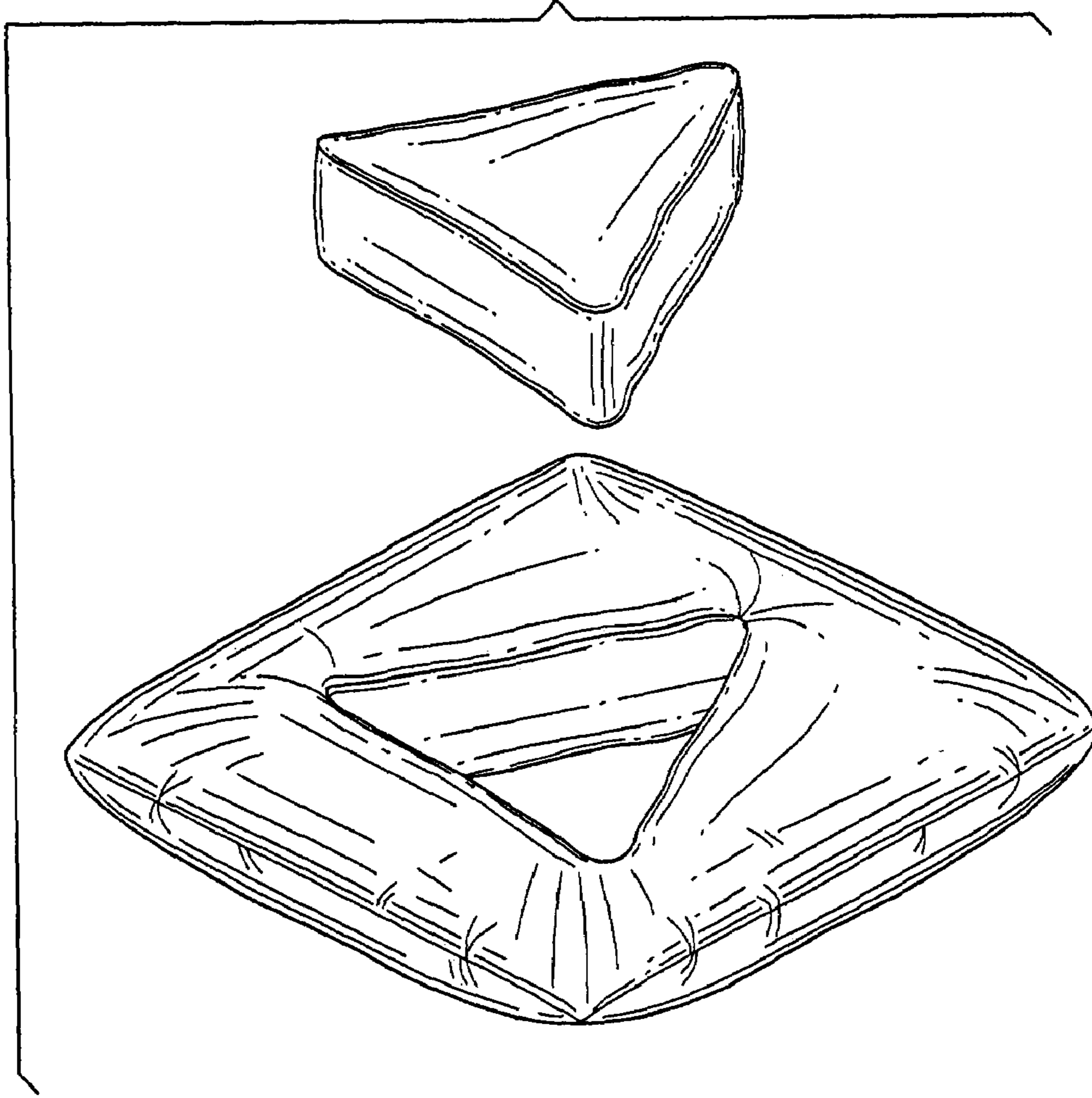

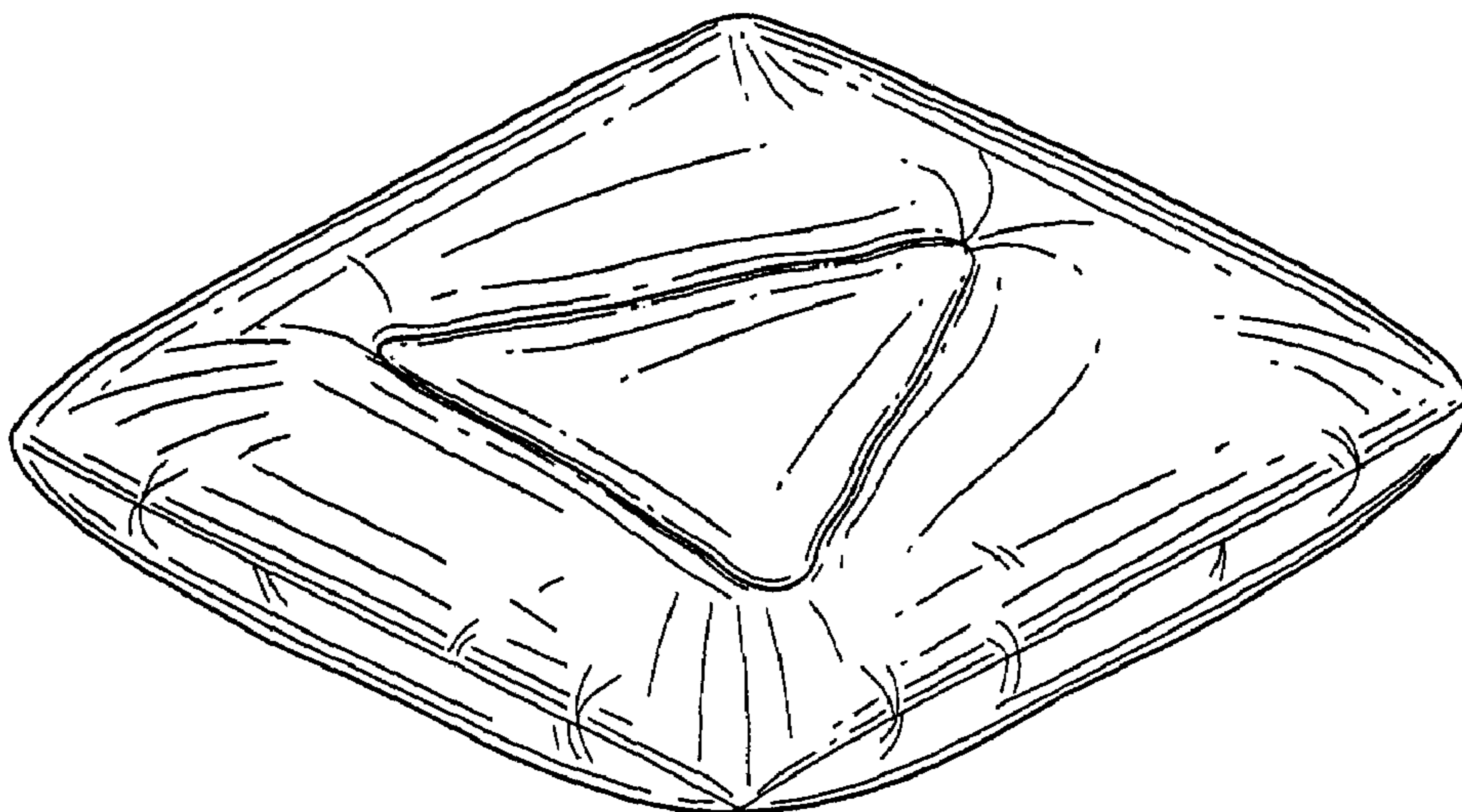

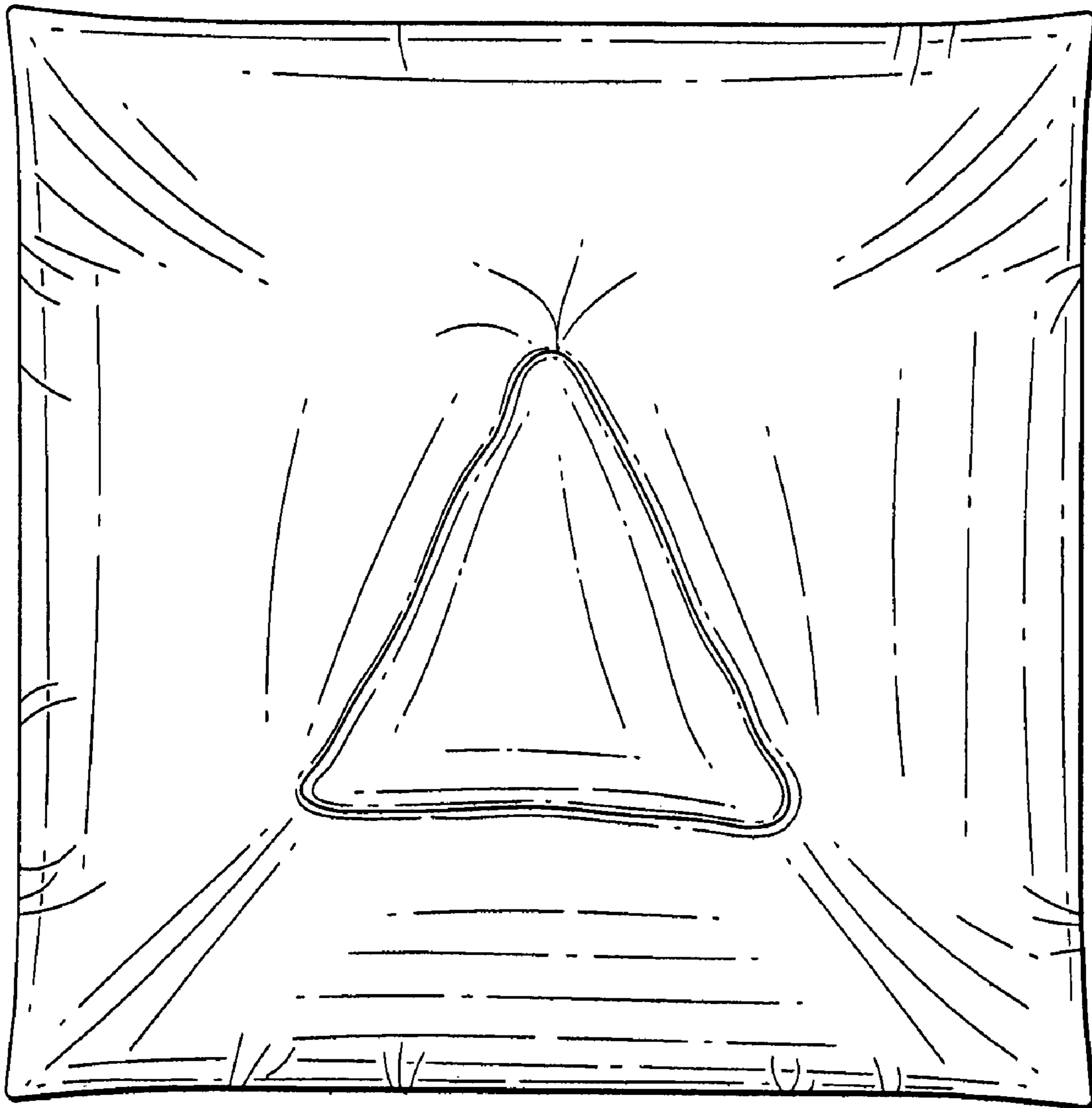
