(57) **CLAIM**

The ornamental design for interconnecting shot glasses, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of one glass of the interconnecting shot glasses showing my new design with the connectors and other glasses removed for ease of illustration;

FIG. 2 is a side view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a bottom view thereof;

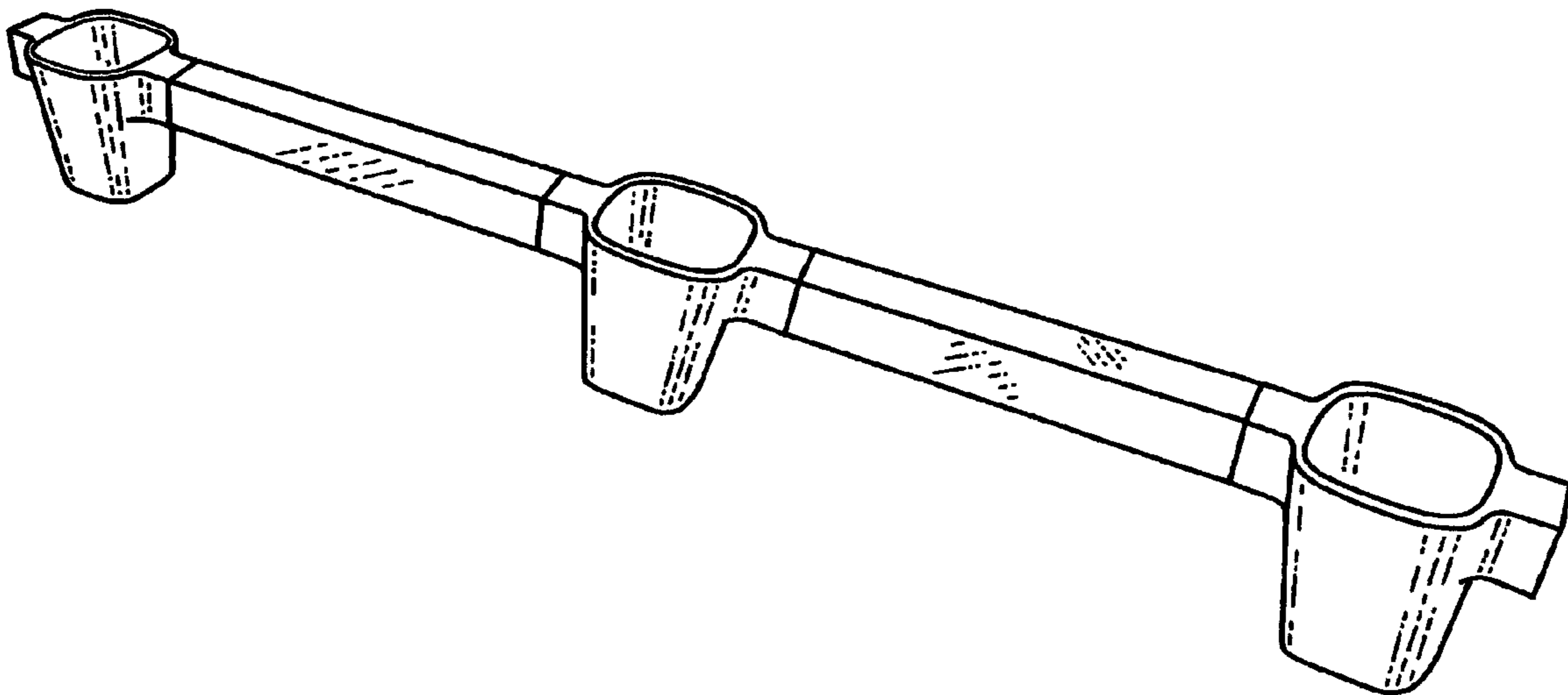
FIG. 5 is a top view of the connector of the interconnecting shot glasses with the other connectors and glasses removed for ease of illustration;

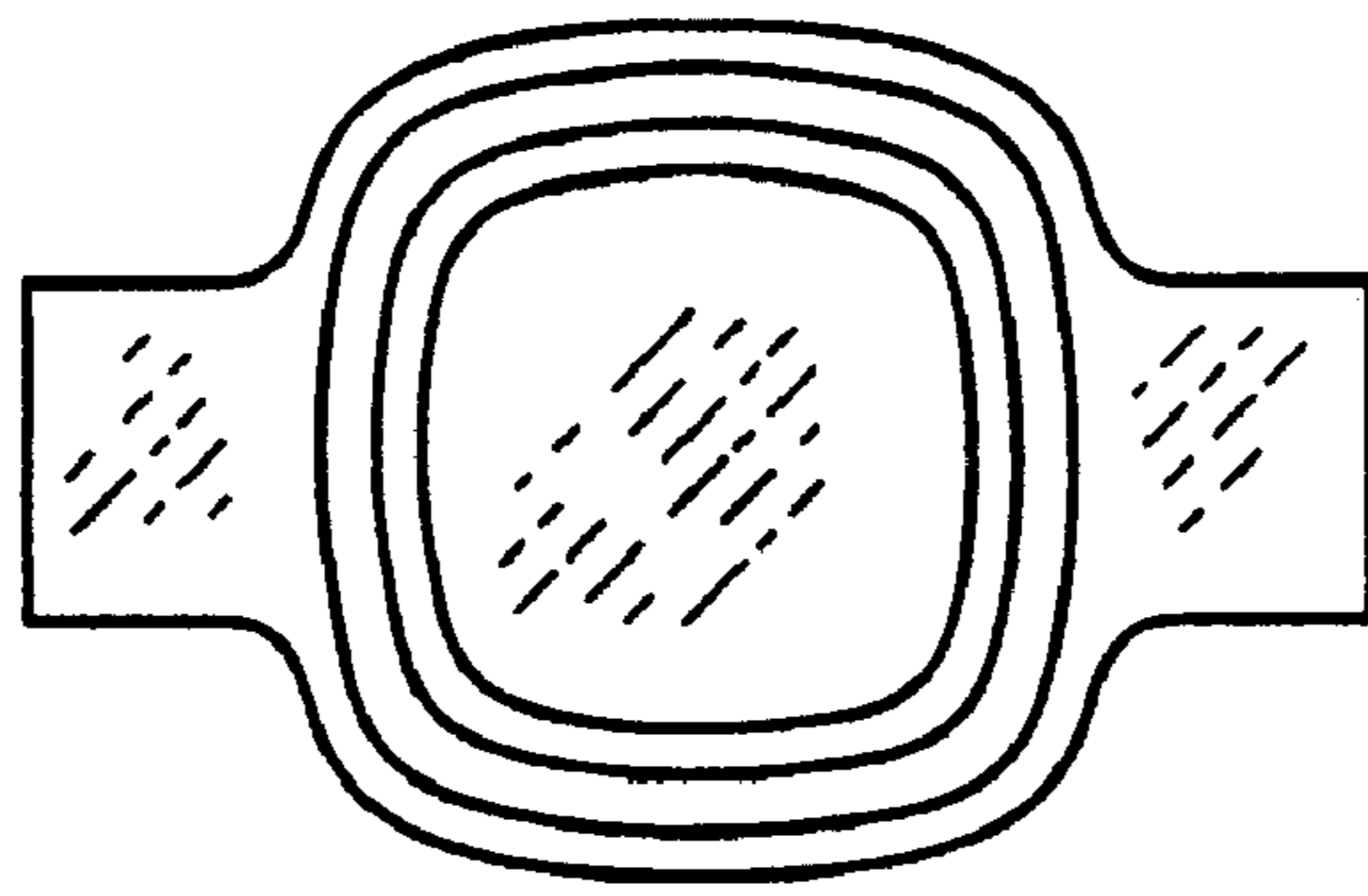

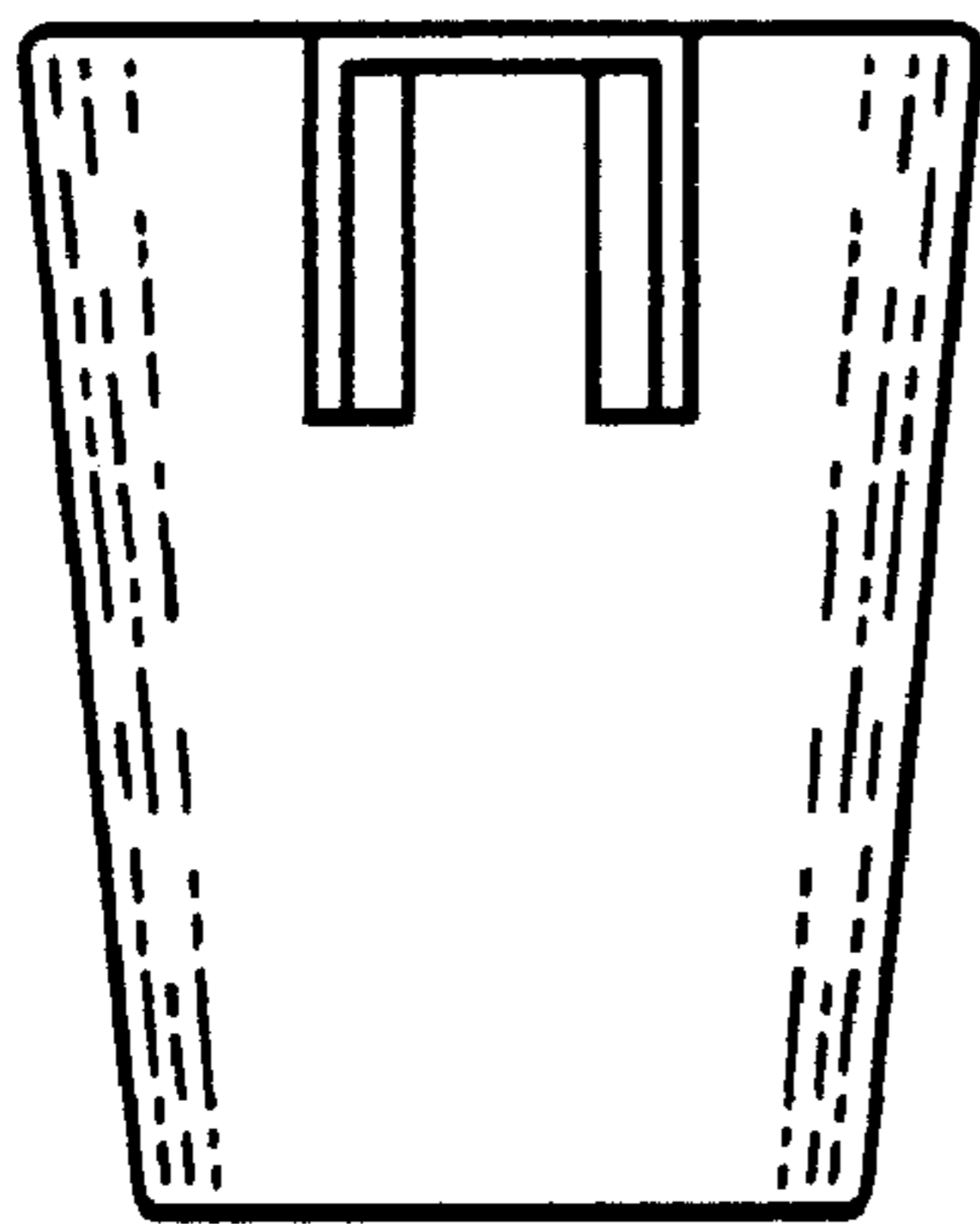

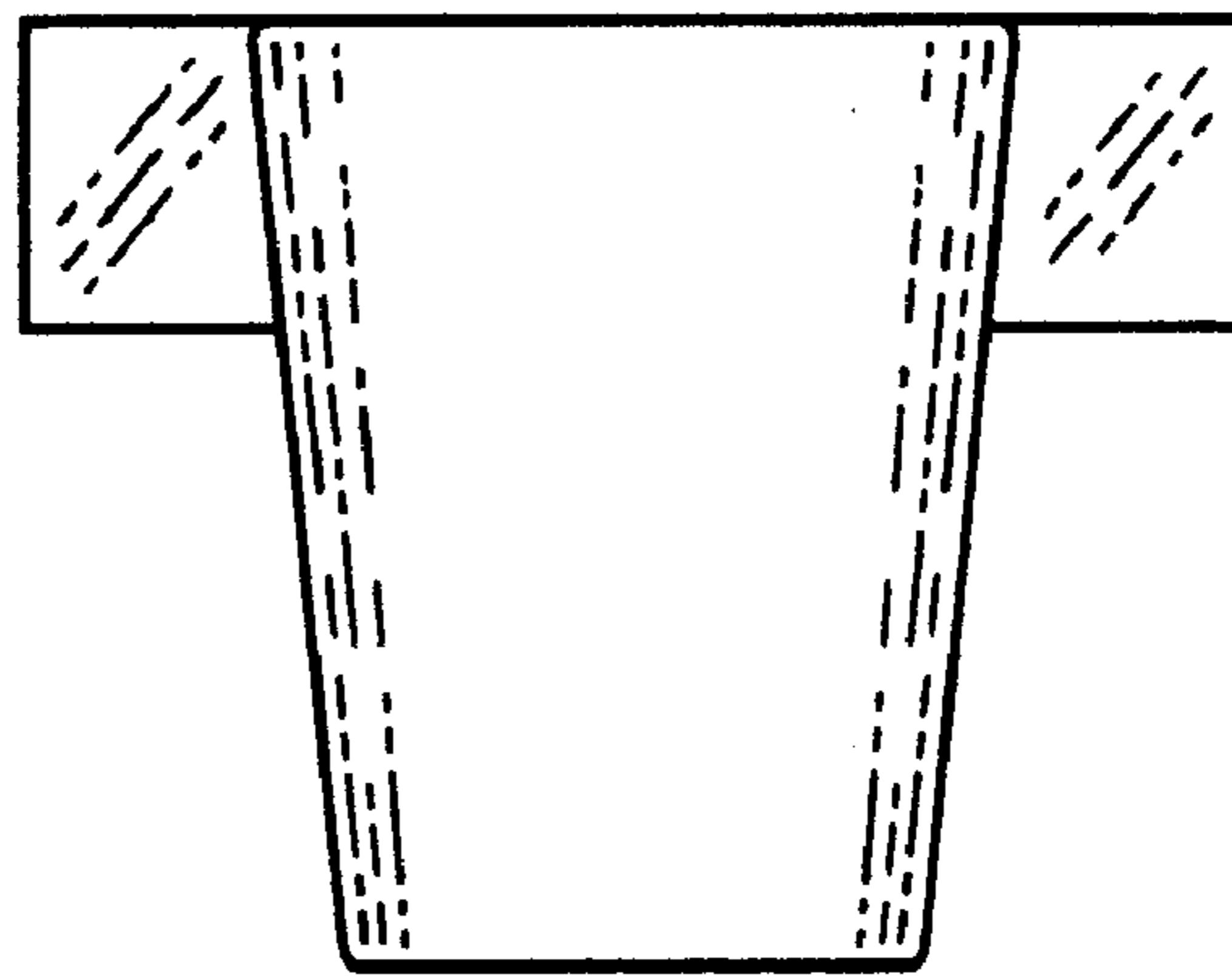

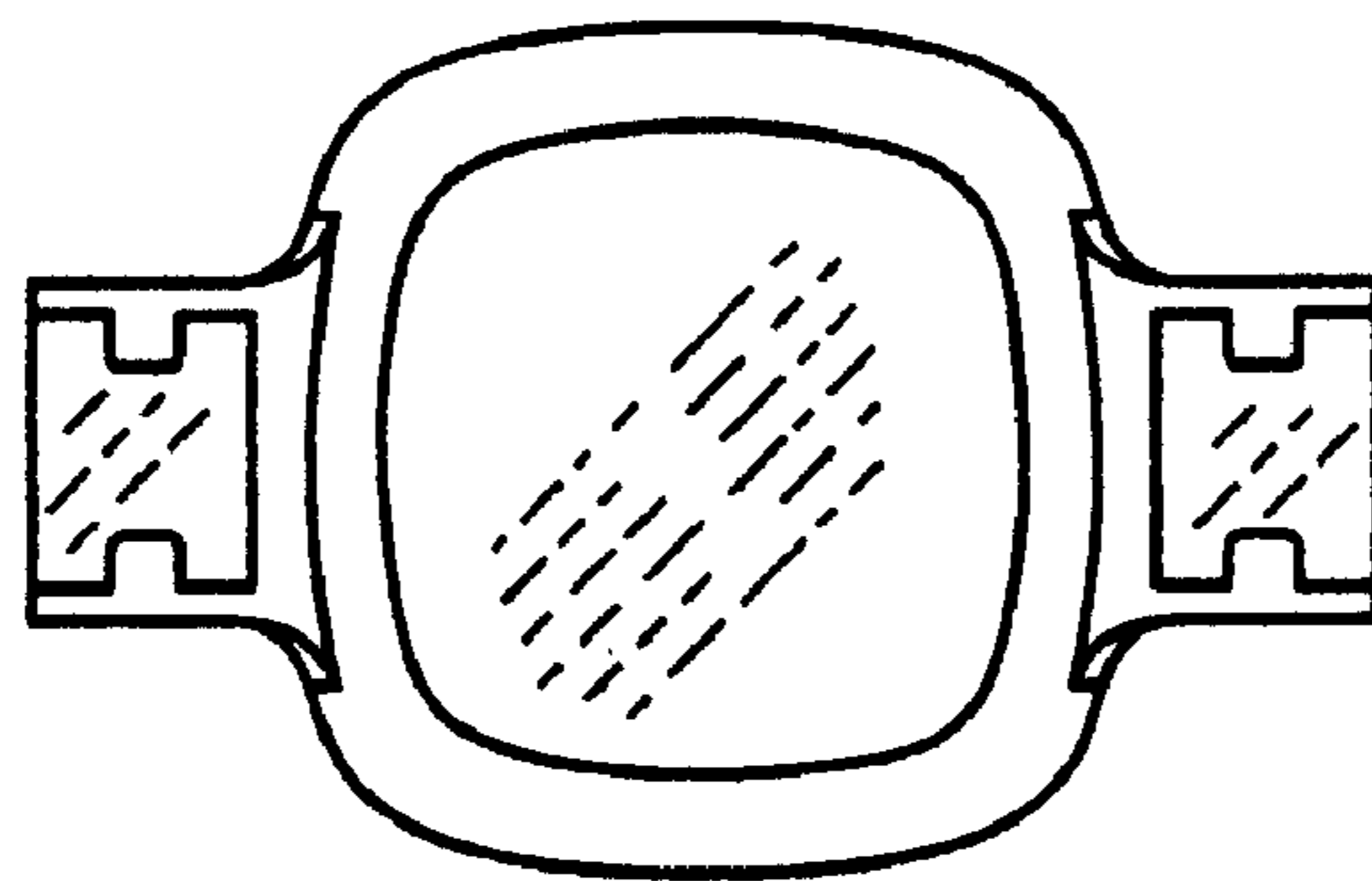

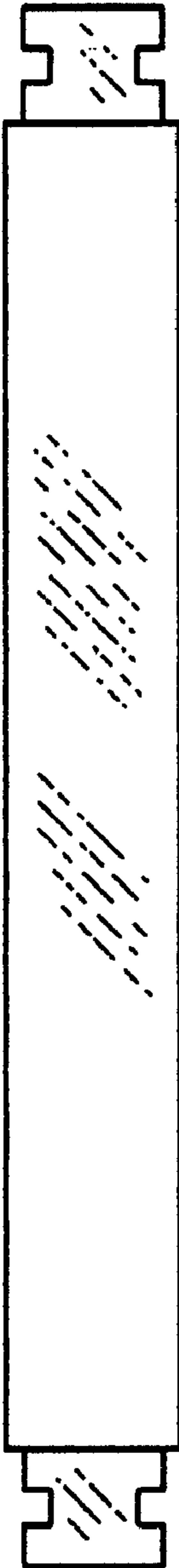

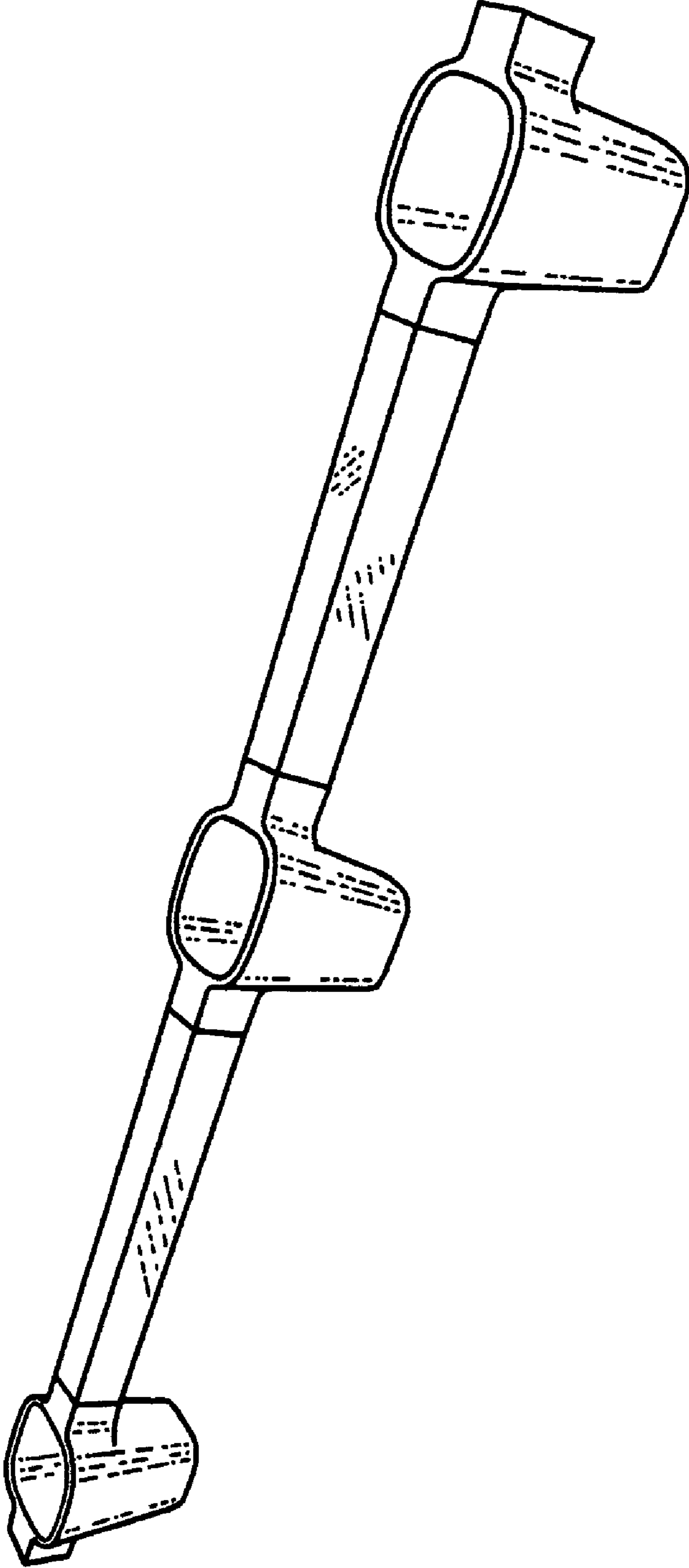
