FIG. 1 is a perspective view of a paint shield showing my new design;

FIG. 2 is a top view thereof;

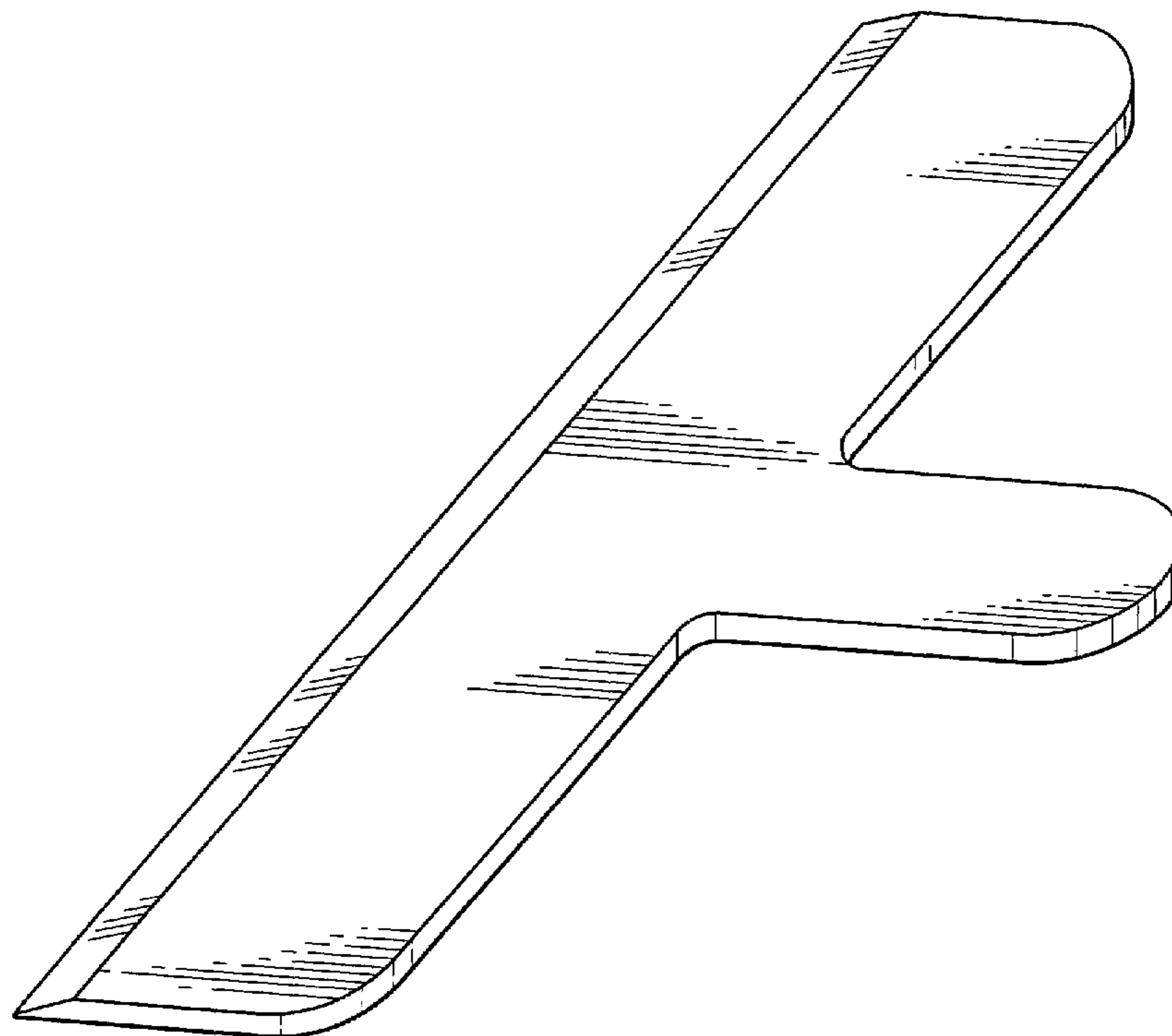
FIG. 3 is a left side elevational view thereof with the right side being a mirror image of the left side;

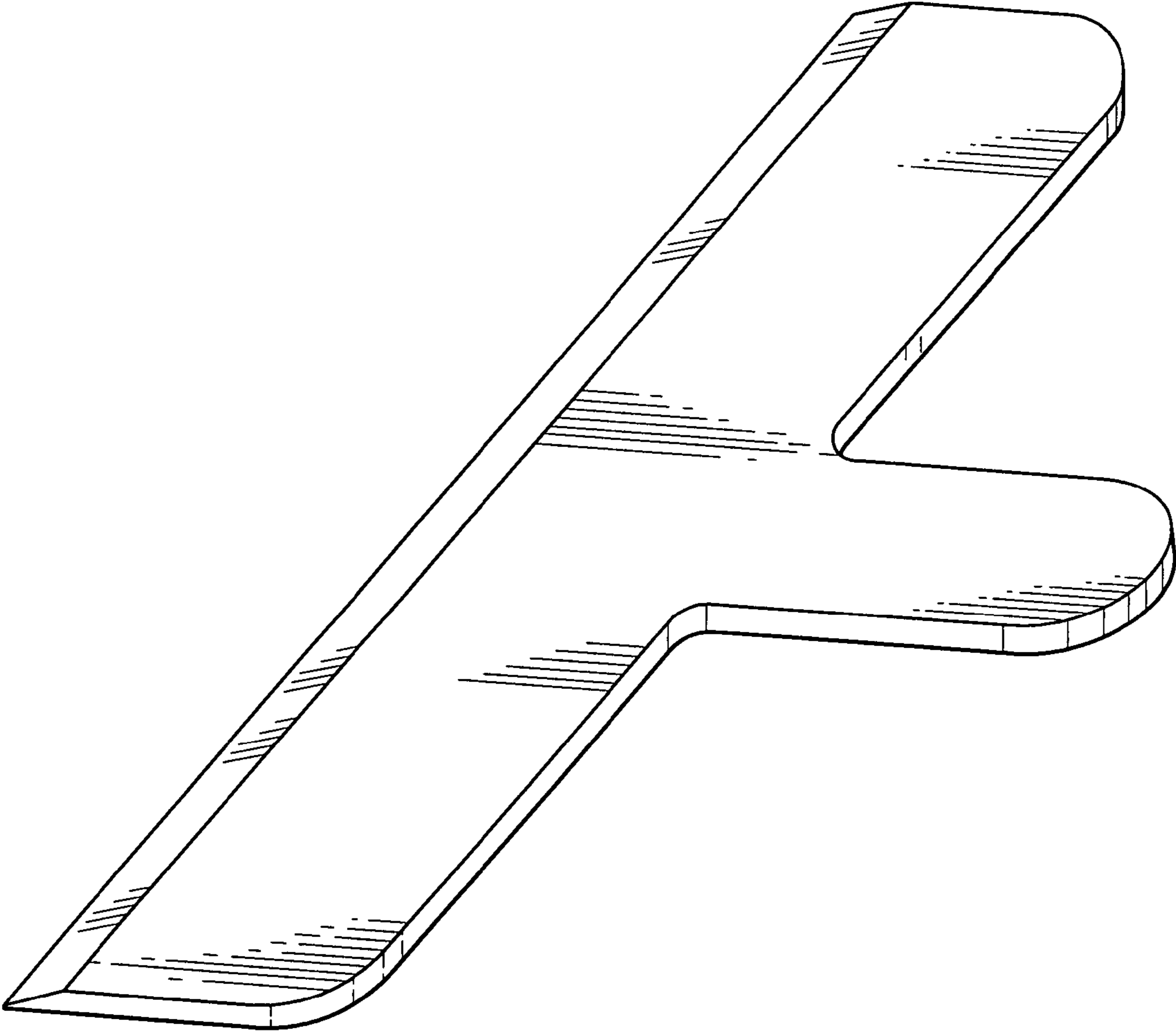

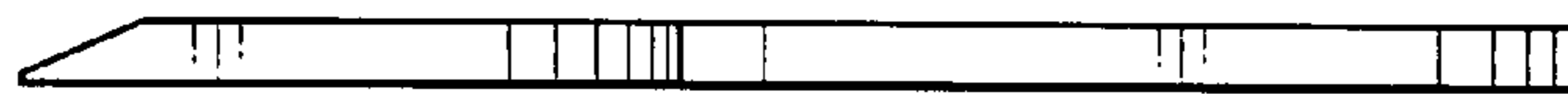

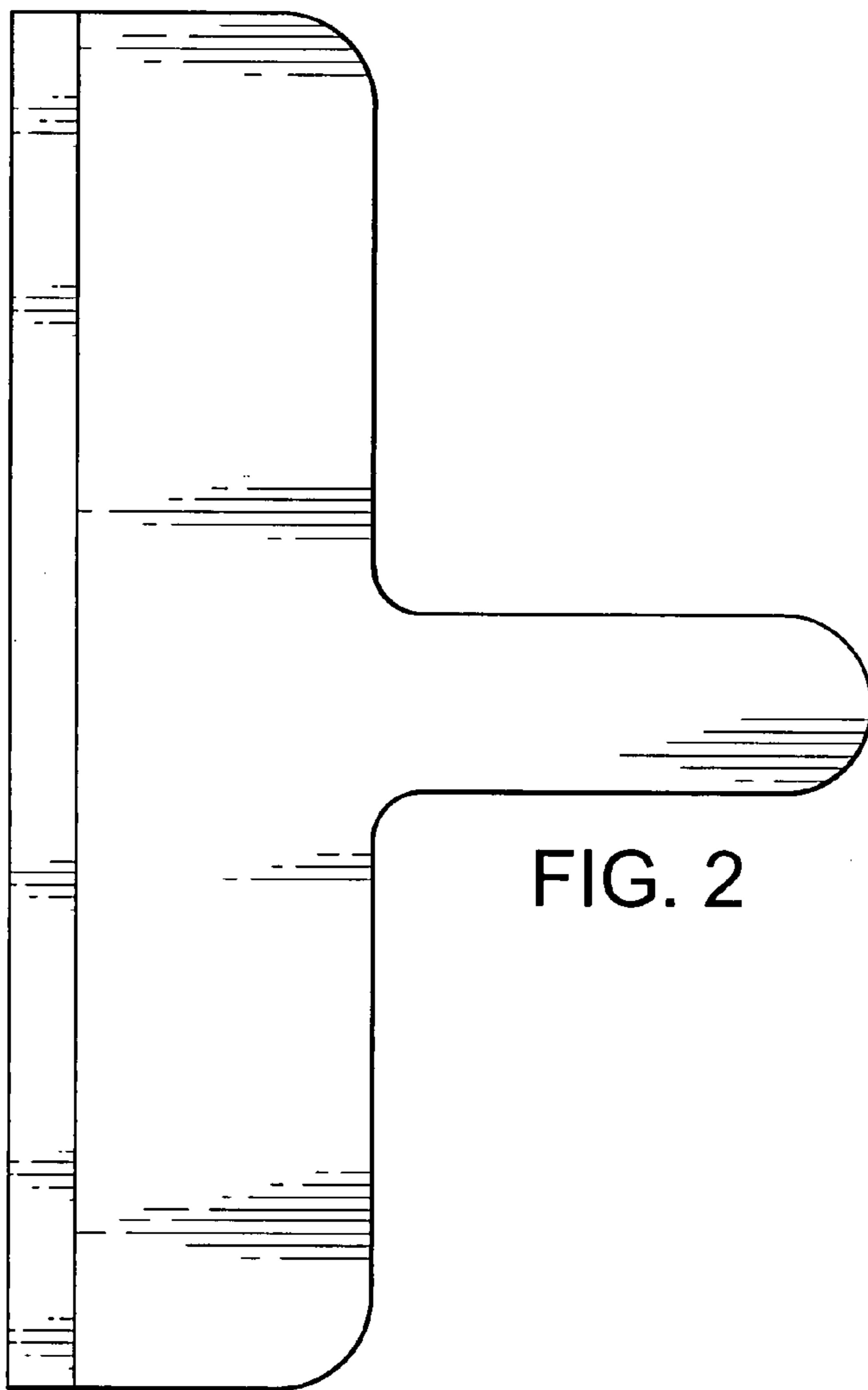
