FIG. 1 is a front elevation view of the wall mount for exerciser.

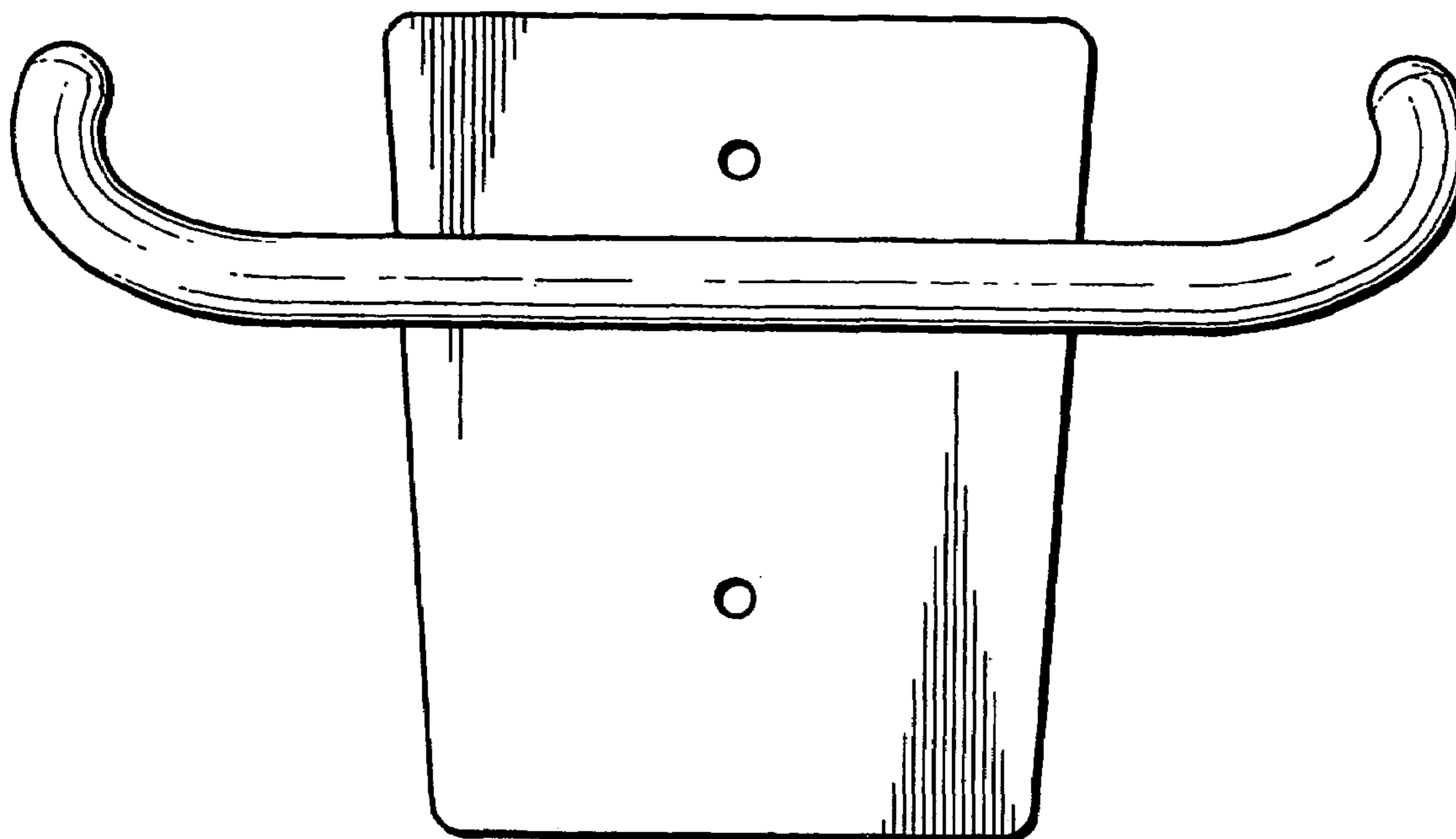
FIG. 2 is a rear elevation view thereof.

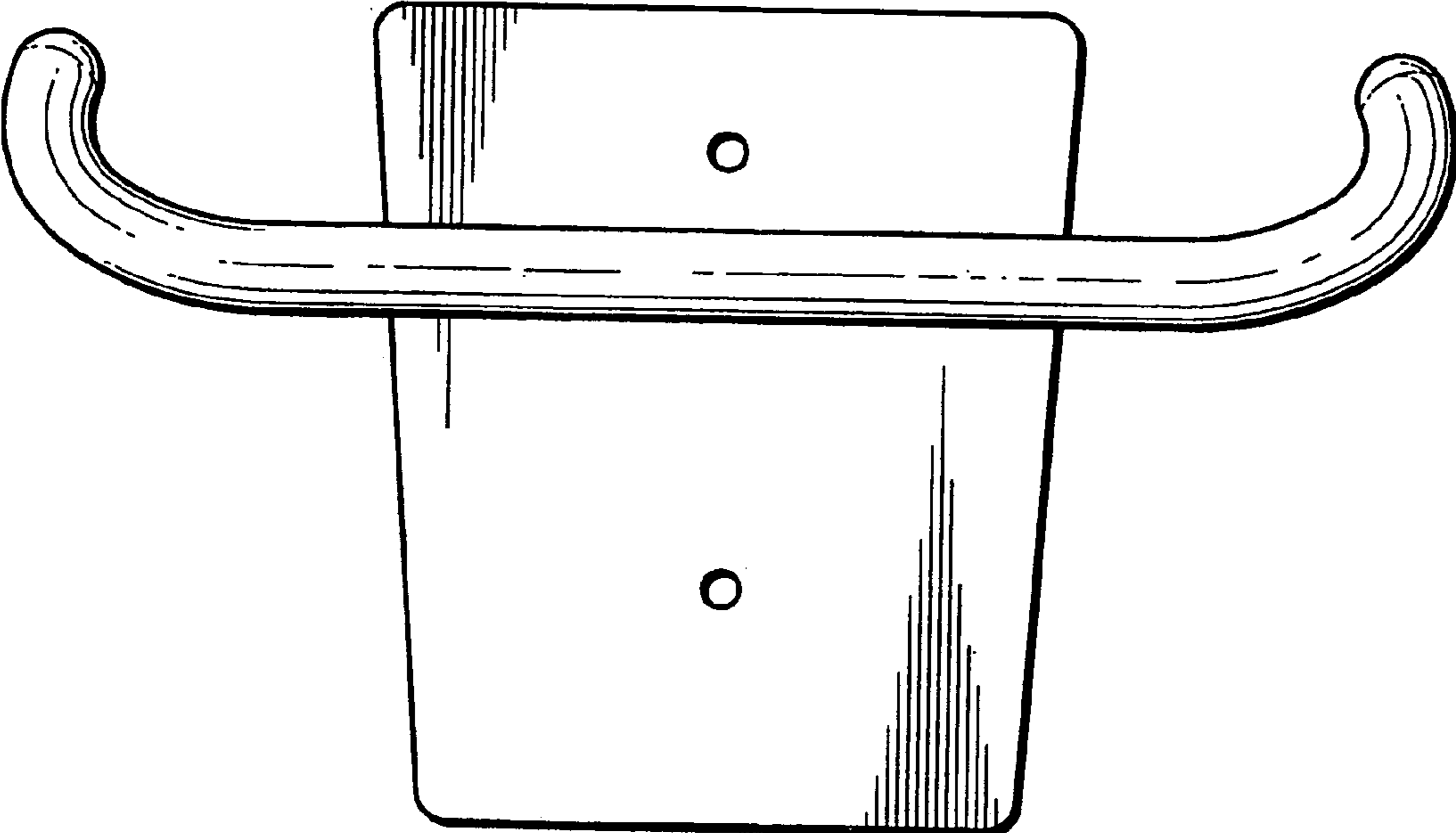

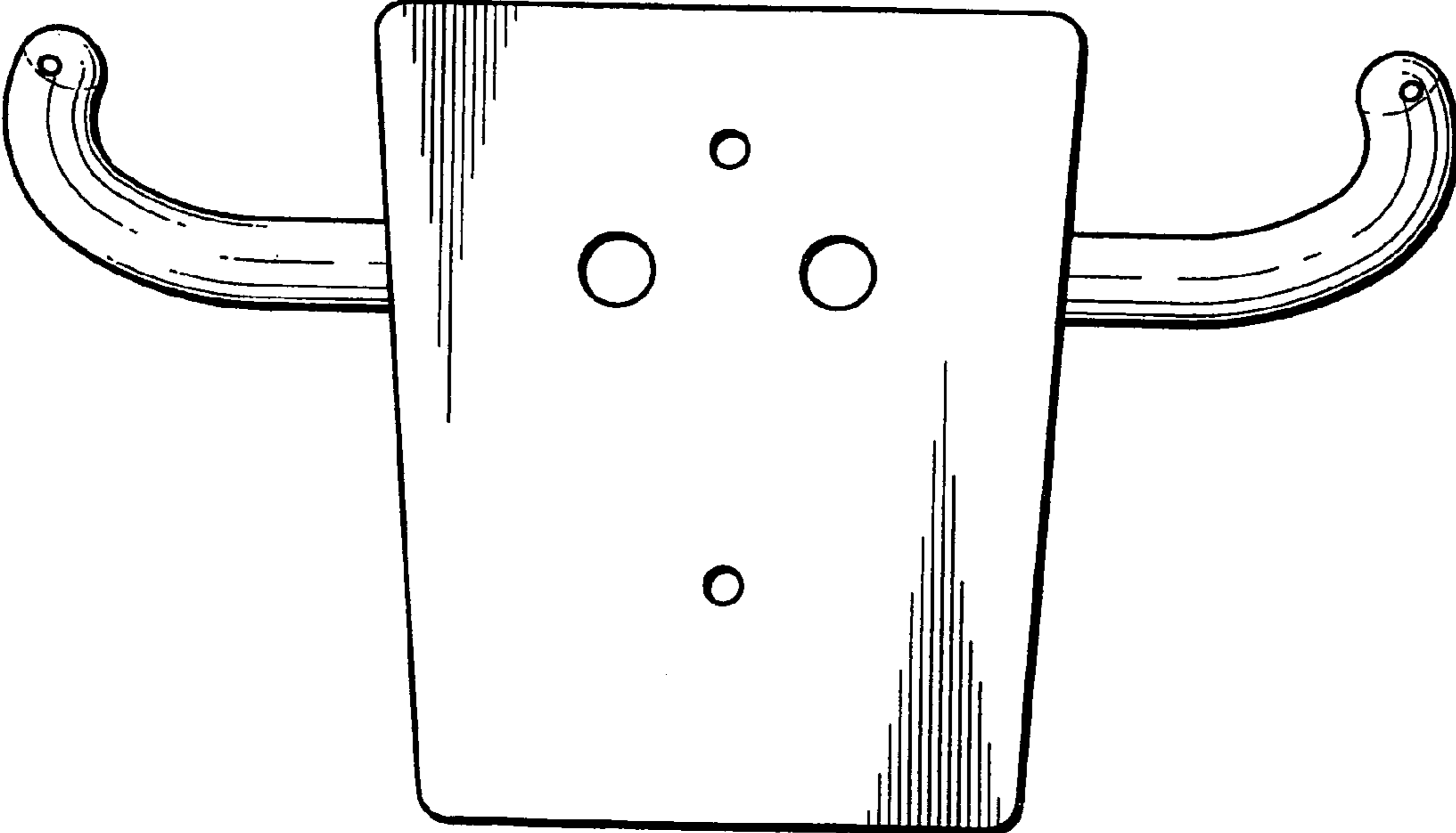

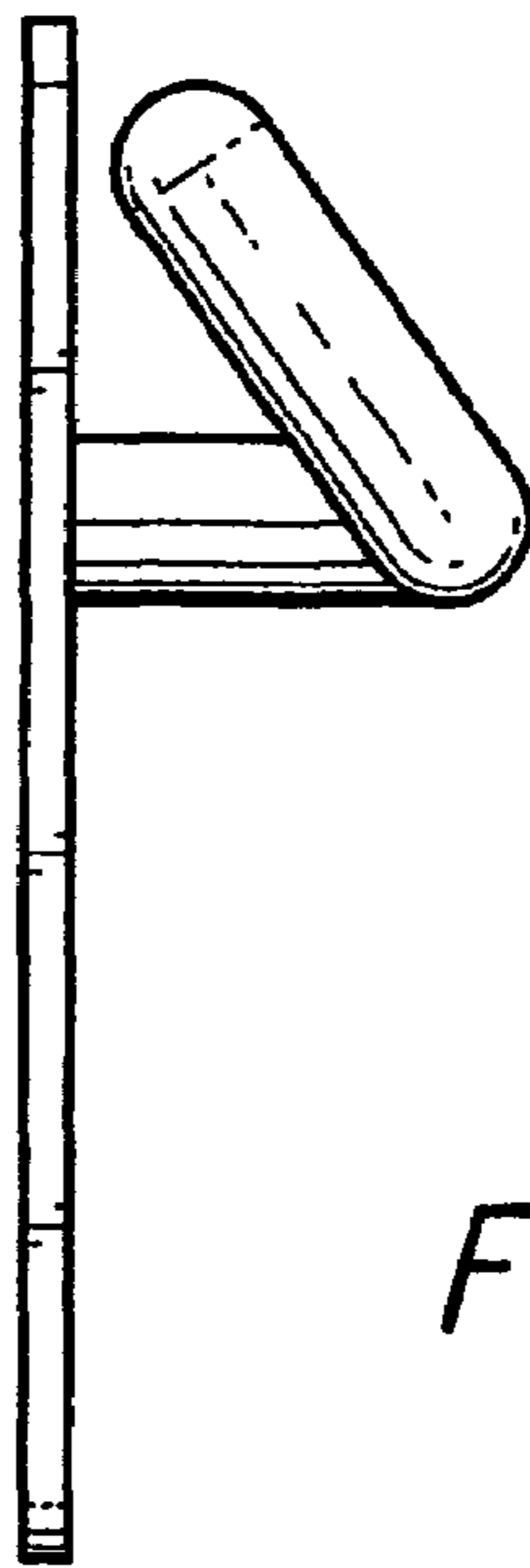

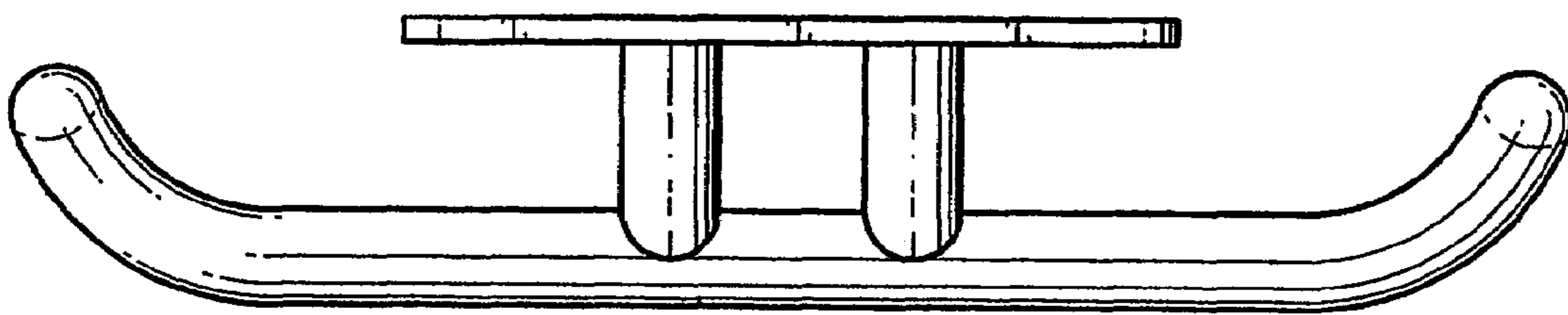

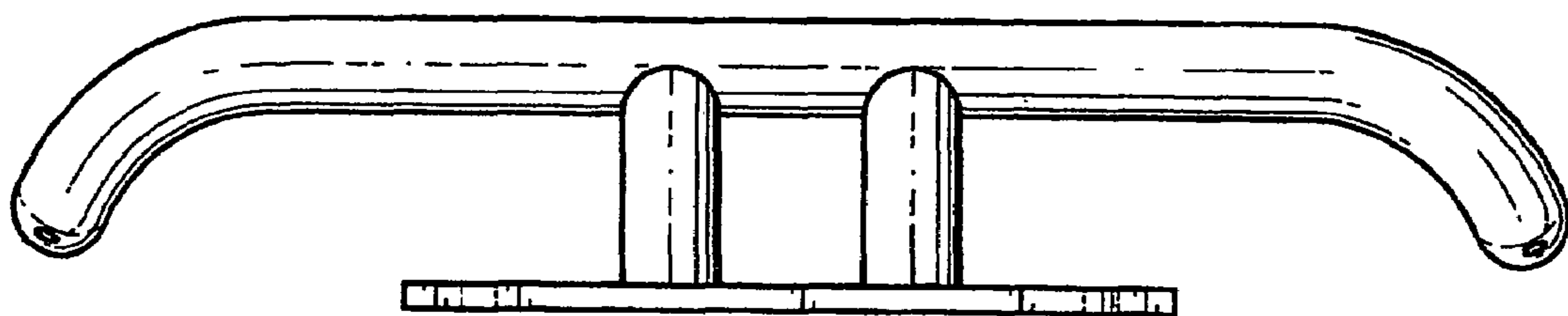
