(57) **CLAIM**

The ornamental design for a door for a vehicle, as shown and described.

DESCRIPTION

This application is related to the following co-pending application: application Ser. No. 29/294,059, entitled "Vehicle, Toy, or Likeness Thereof".

FIG. 1 is a left perspective view of a first embodiment of a door for a vehicle according to my novel design;

FIG. 2 is a right perspective view thereof;

FIG. 7 is a left perspective view of FIG. 6;

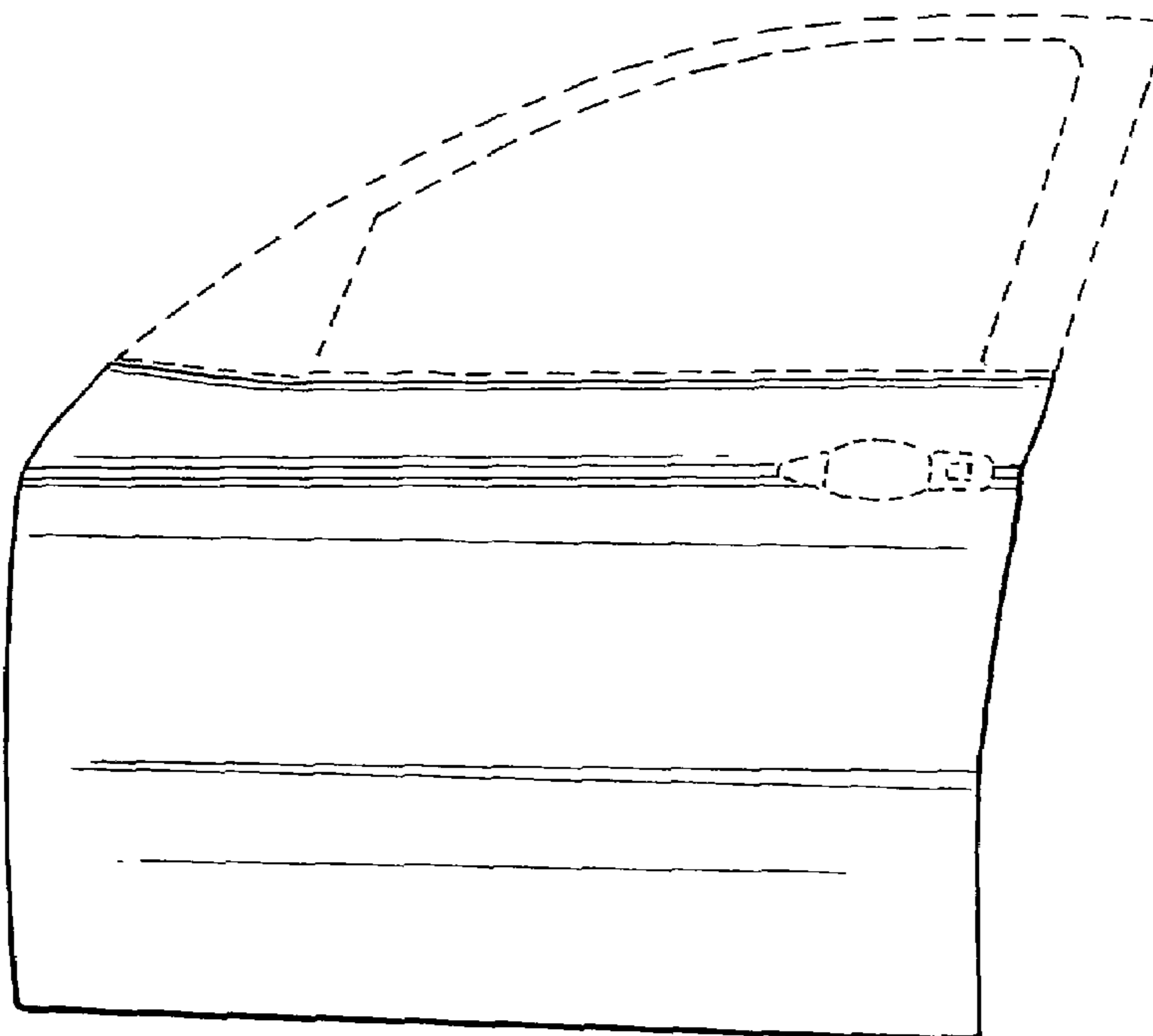
FIG. 8 is a front view of FIG. 6;

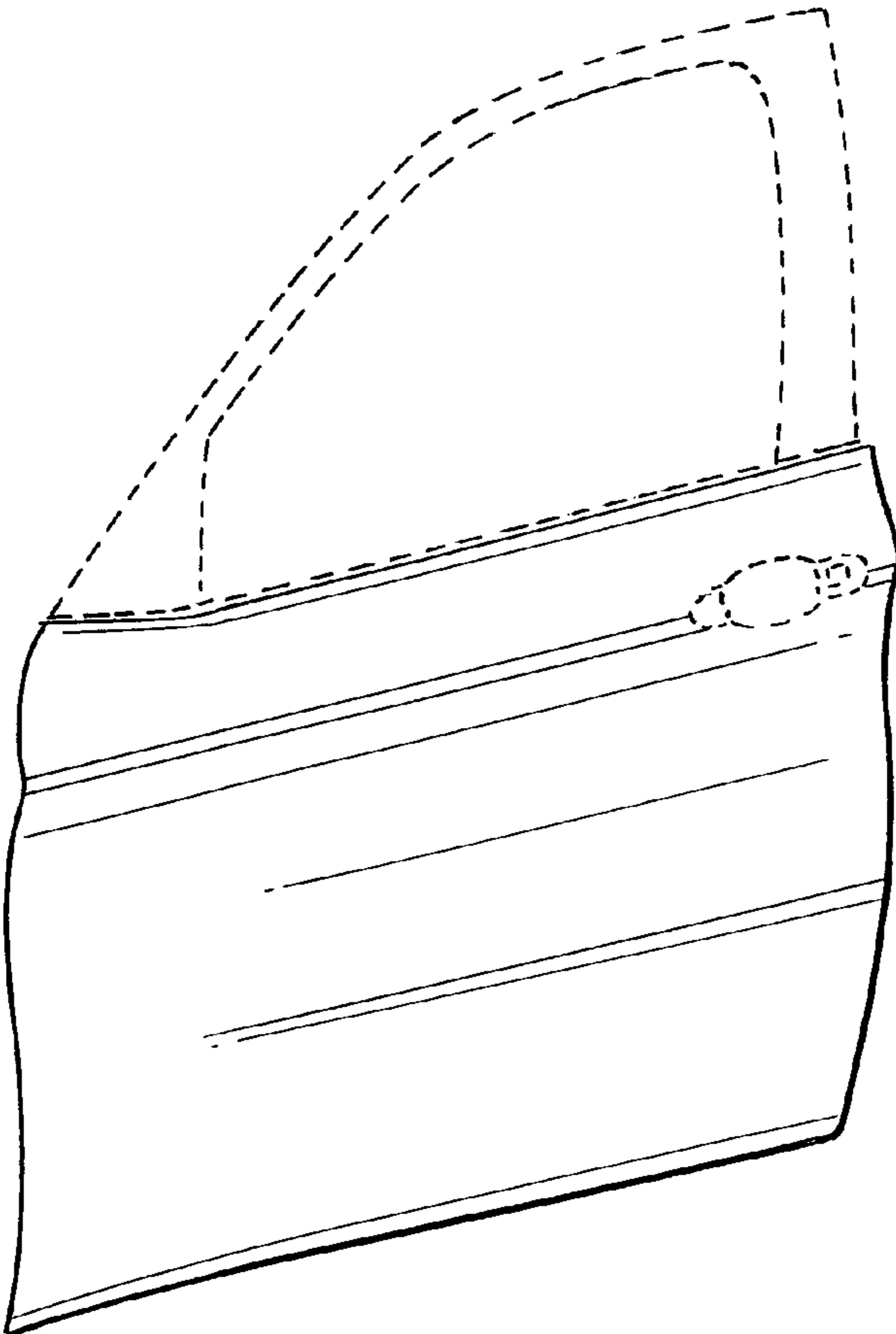

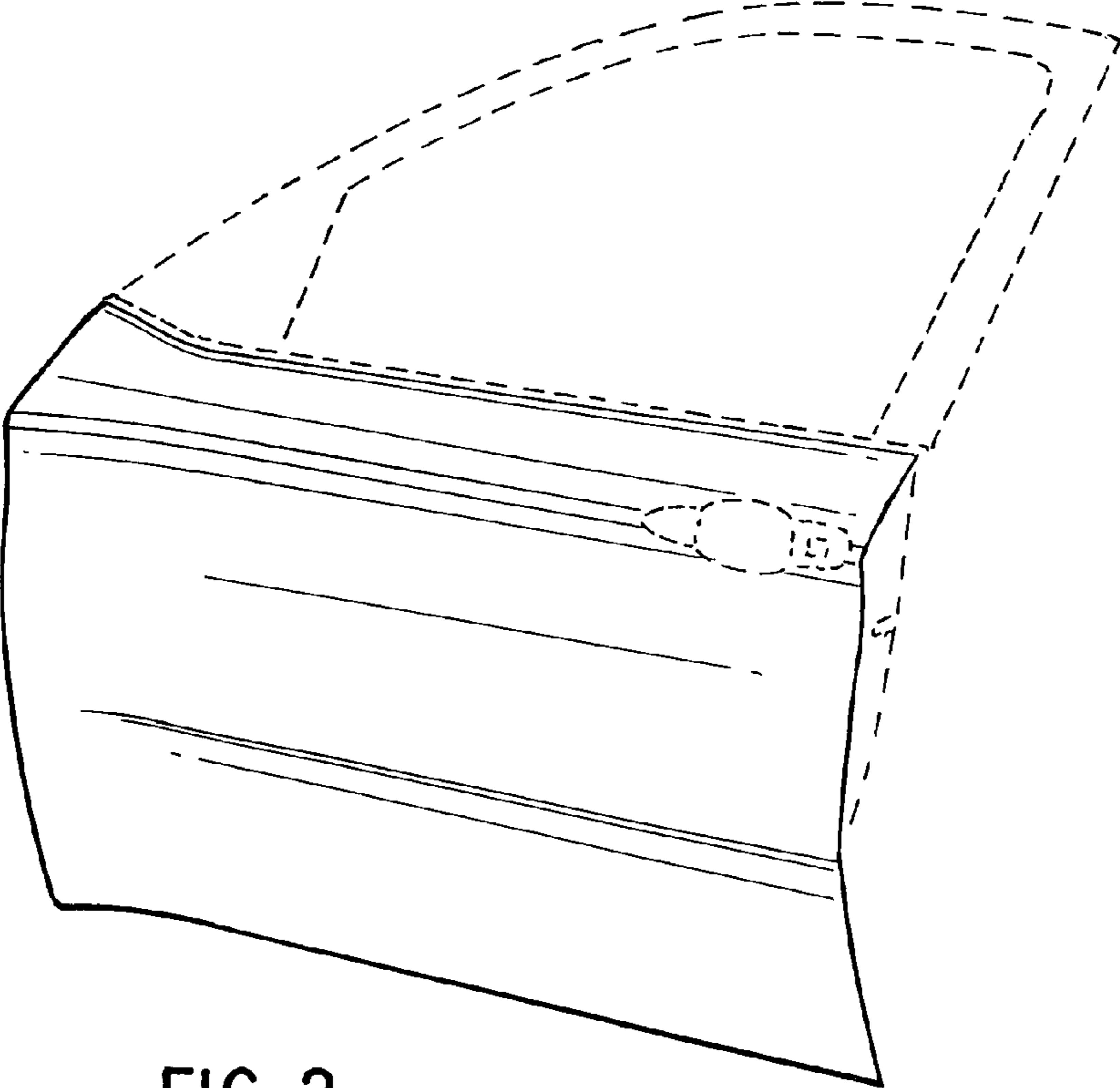

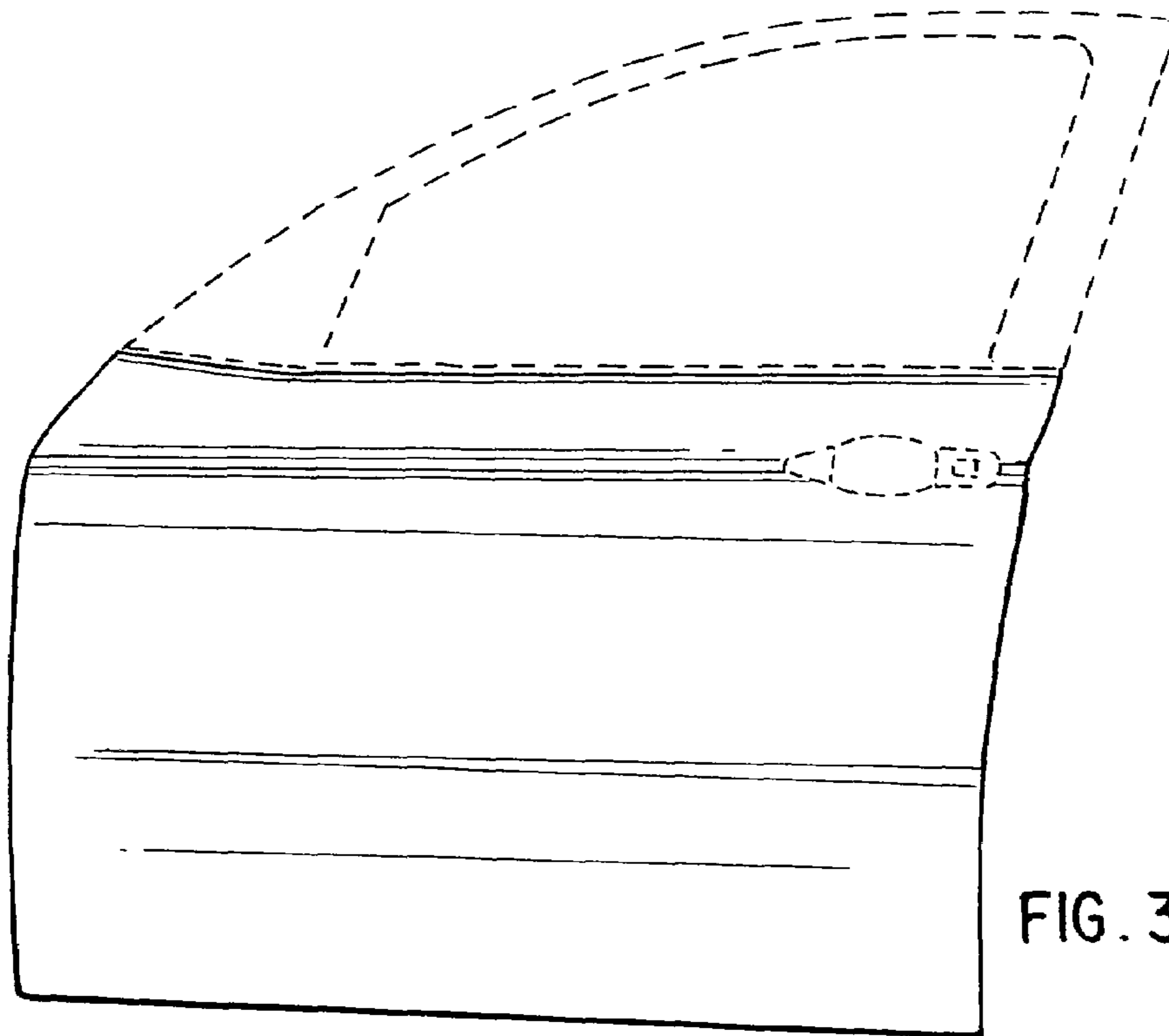

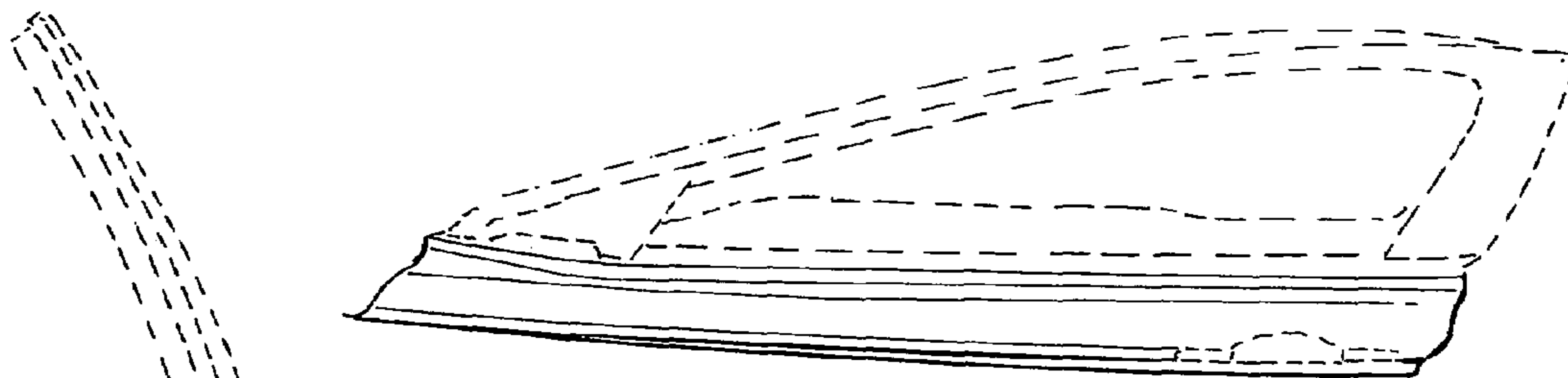

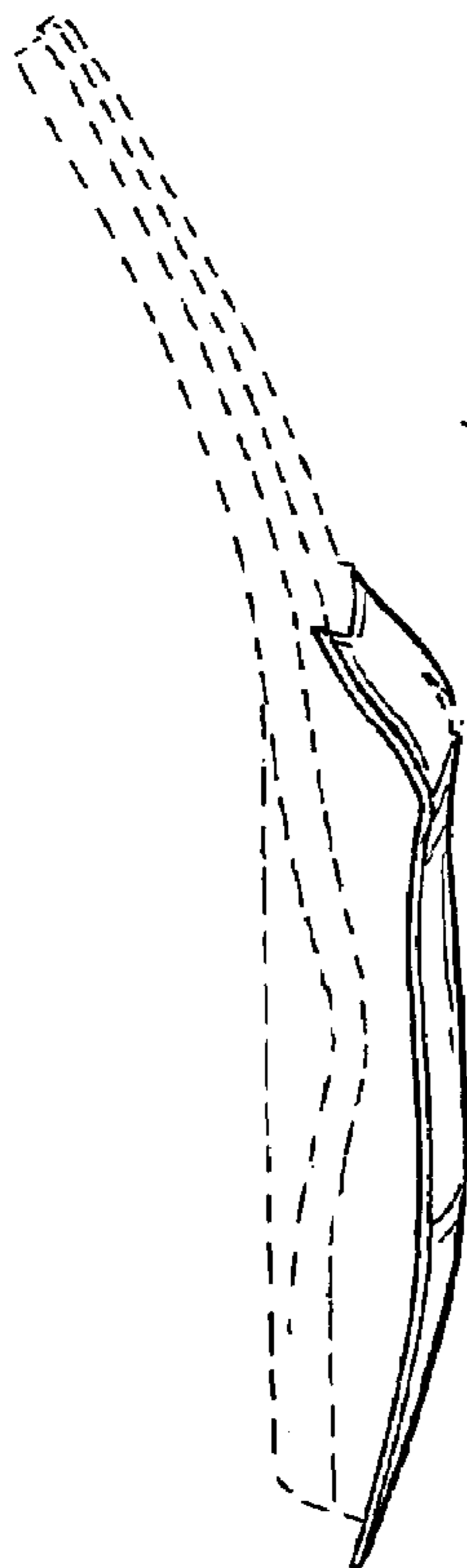

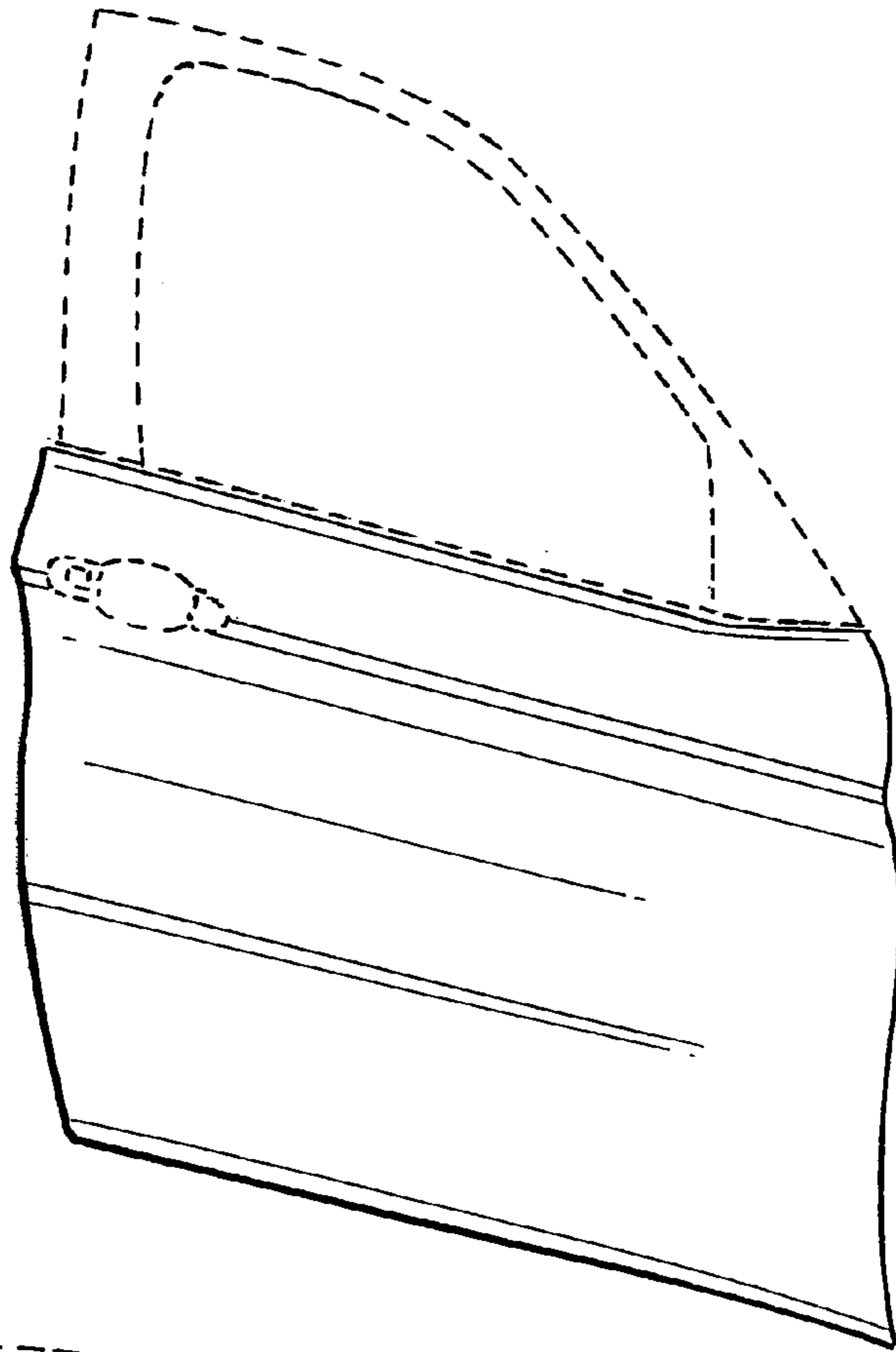
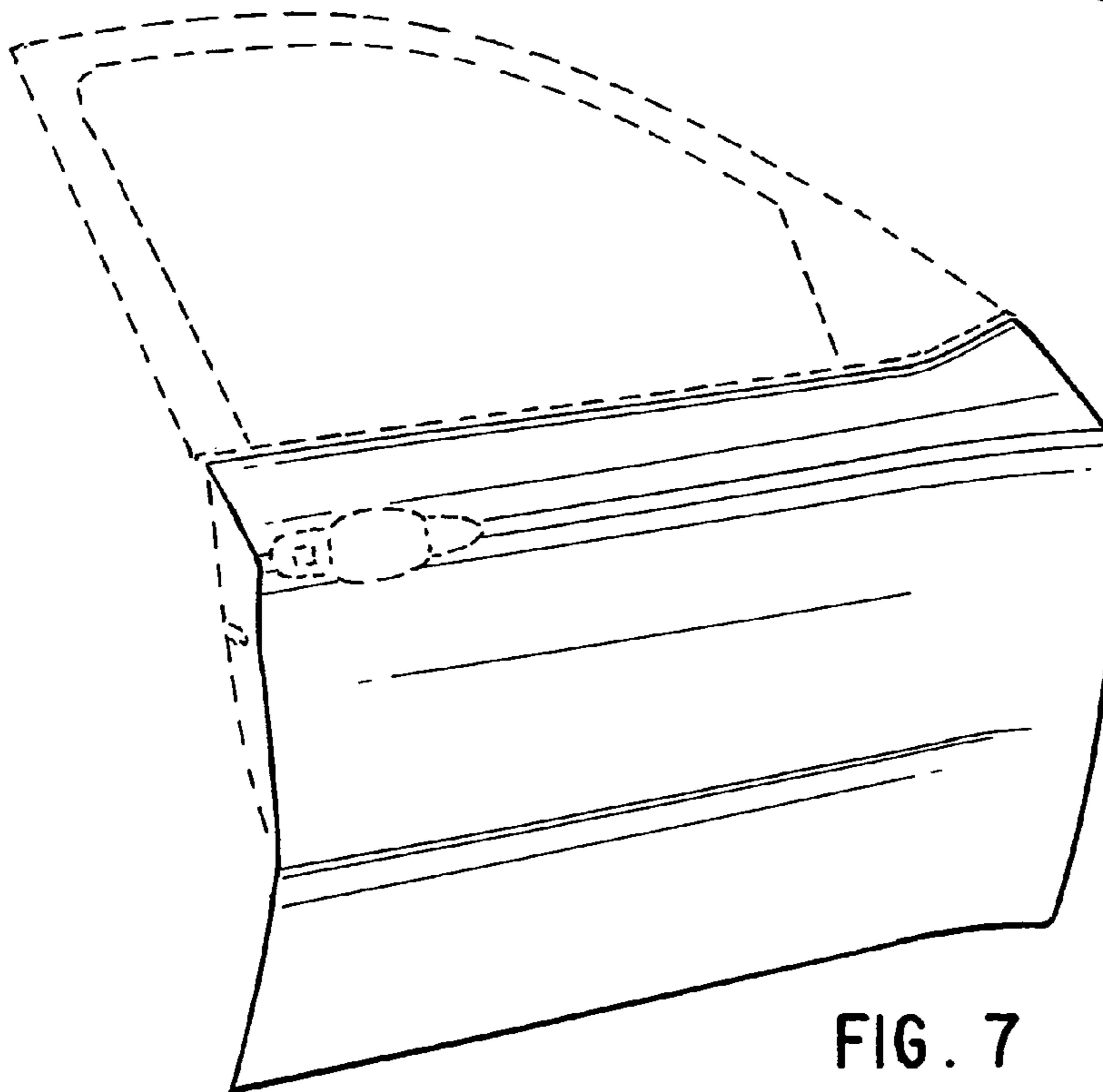

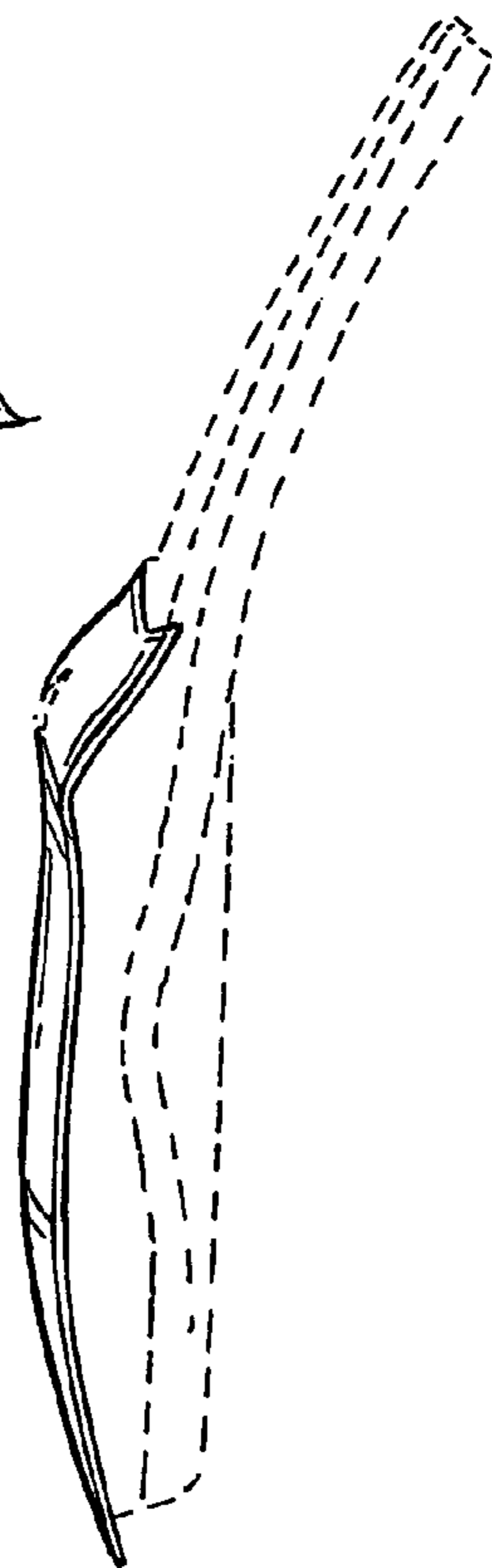
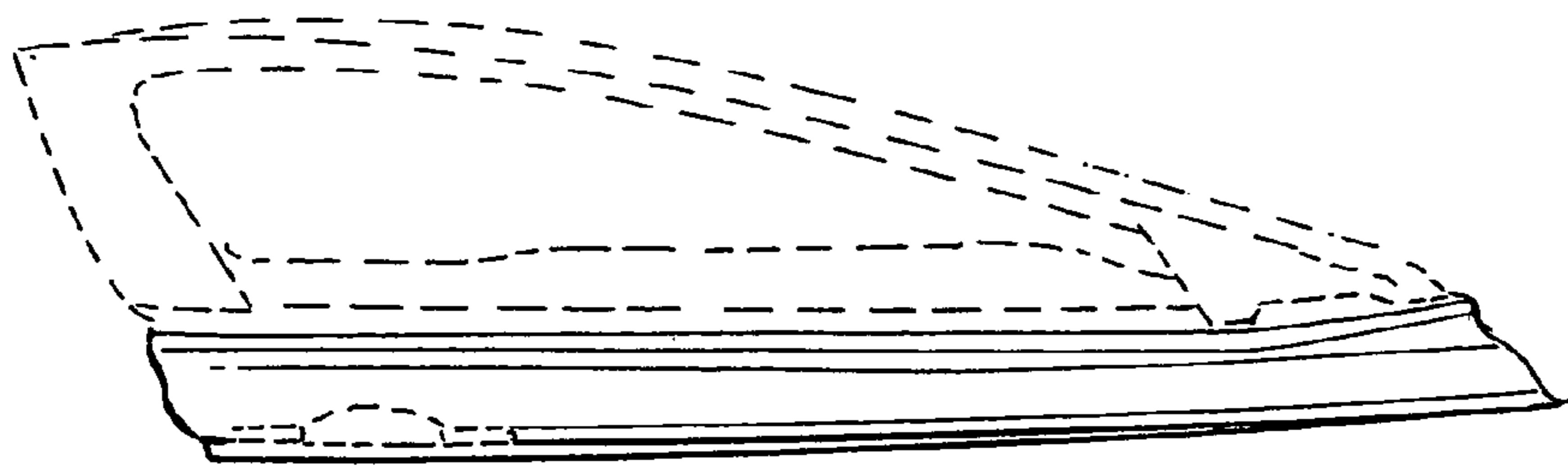
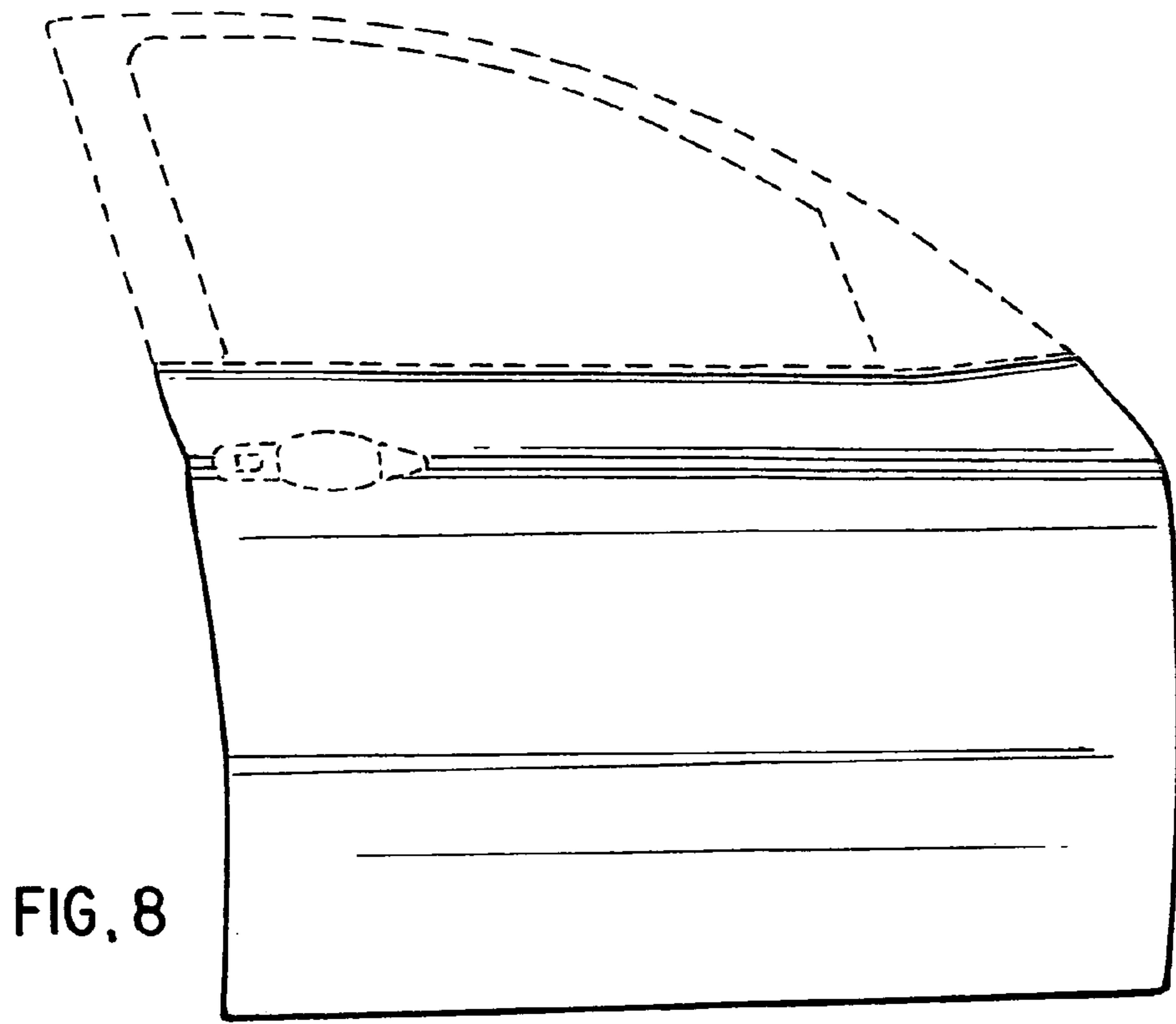
