DESCRIPTION

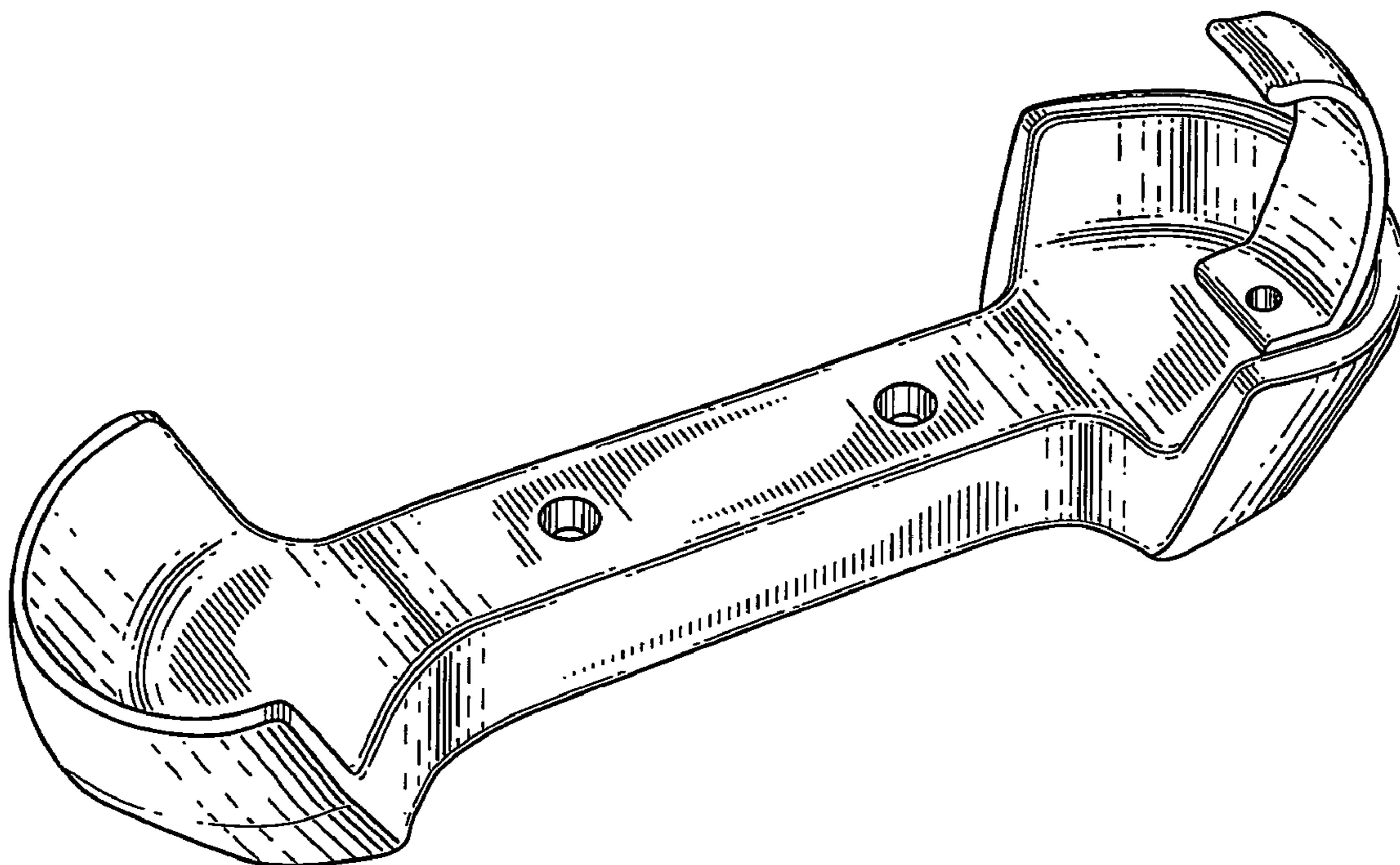
FIG. 1 is a top, left side perspective view of a telephone handset cradle showing my new design;
FIG. 2 is a top plan view thereof;

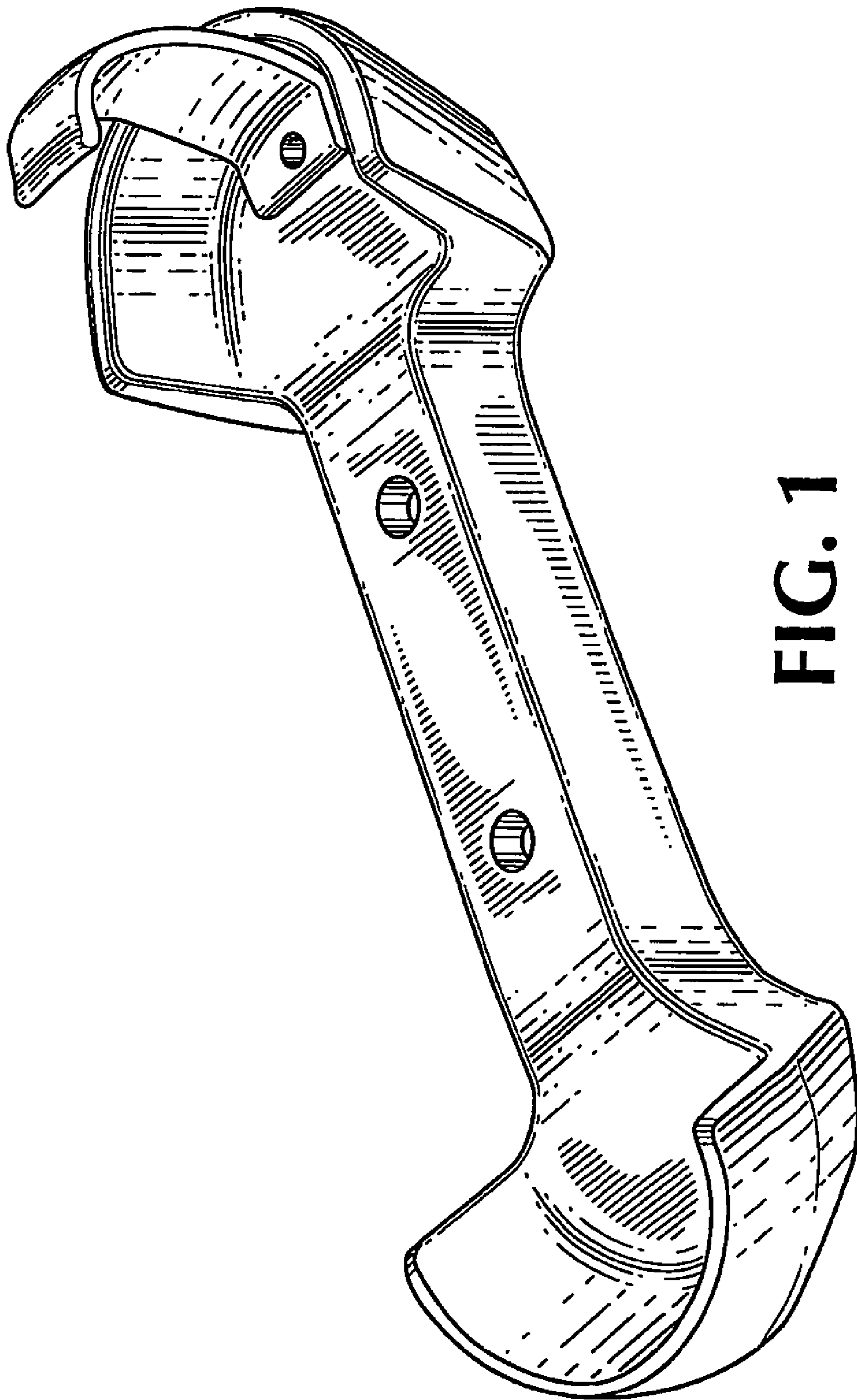

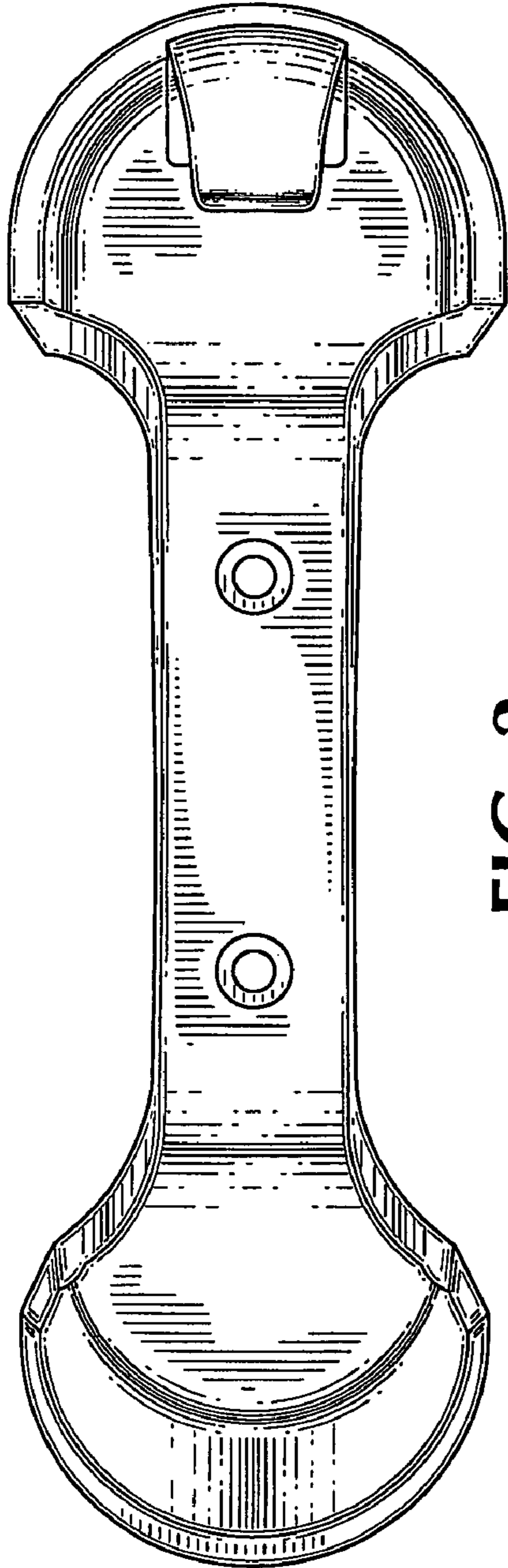

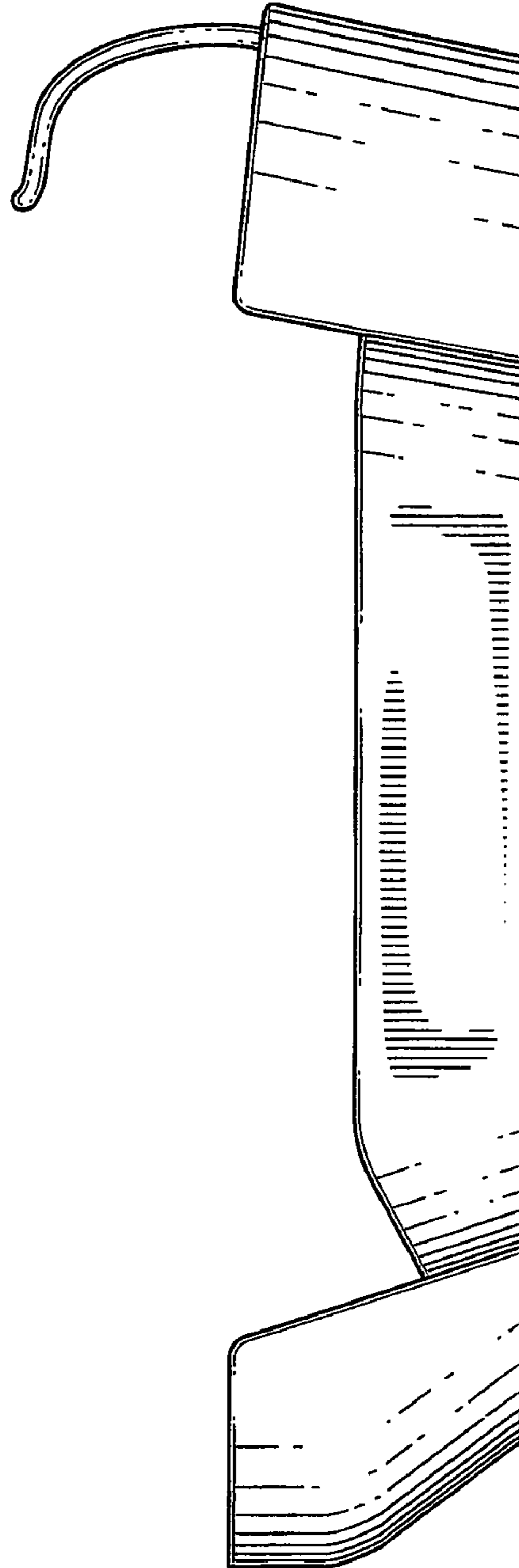

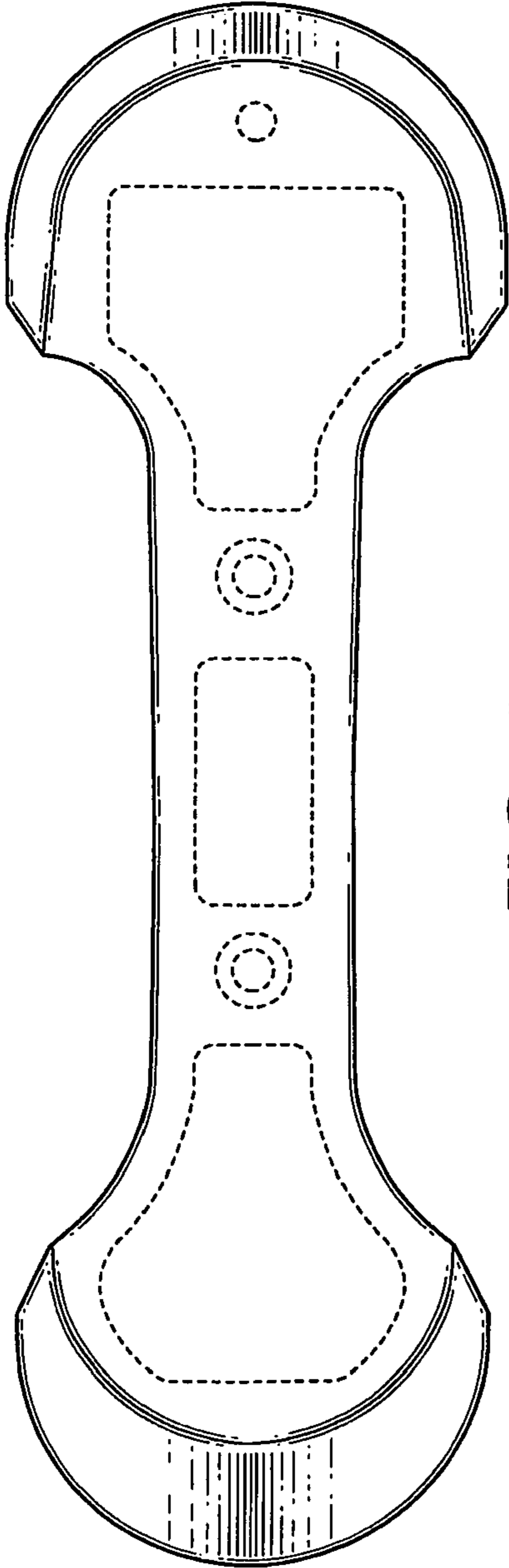

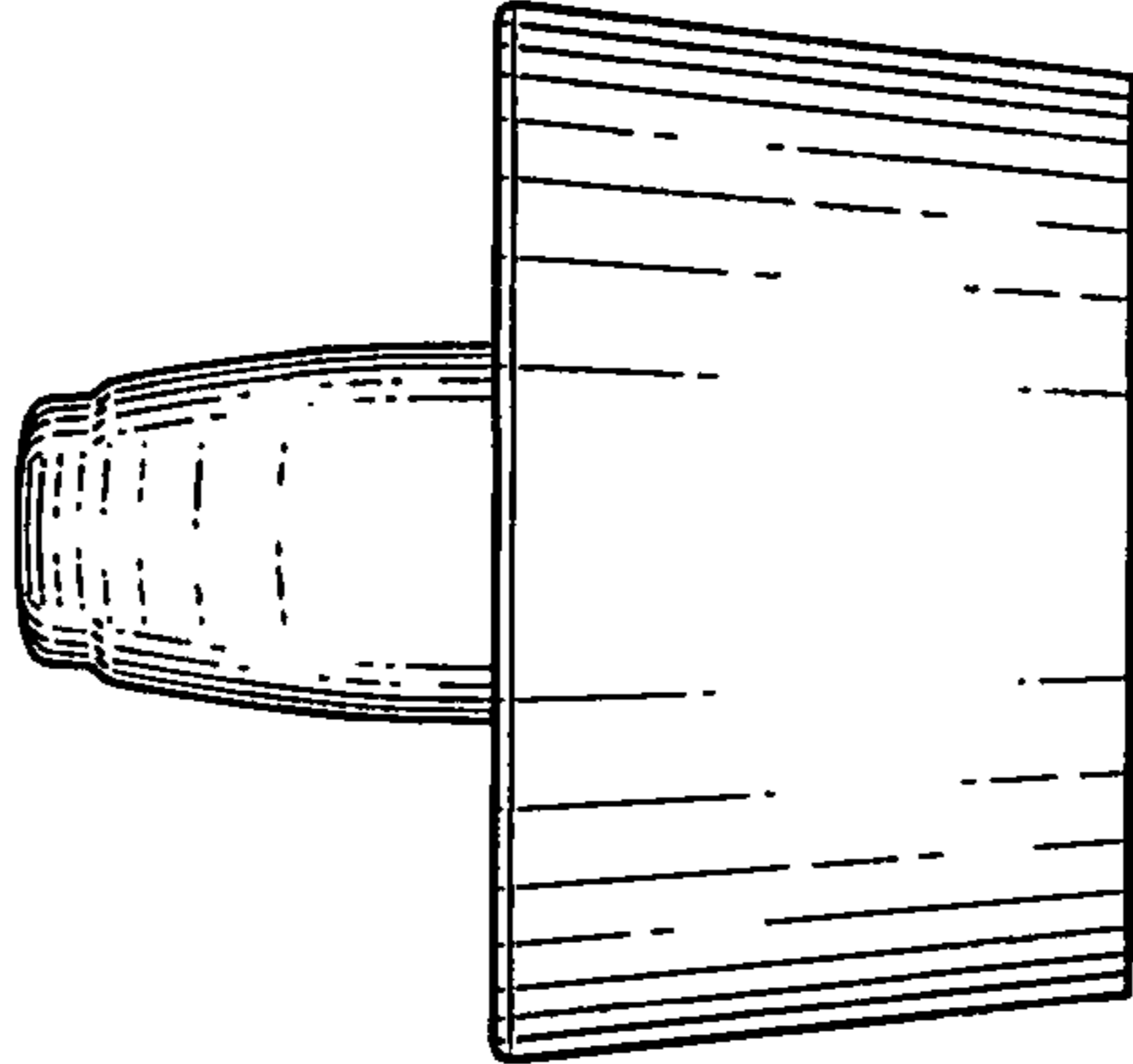

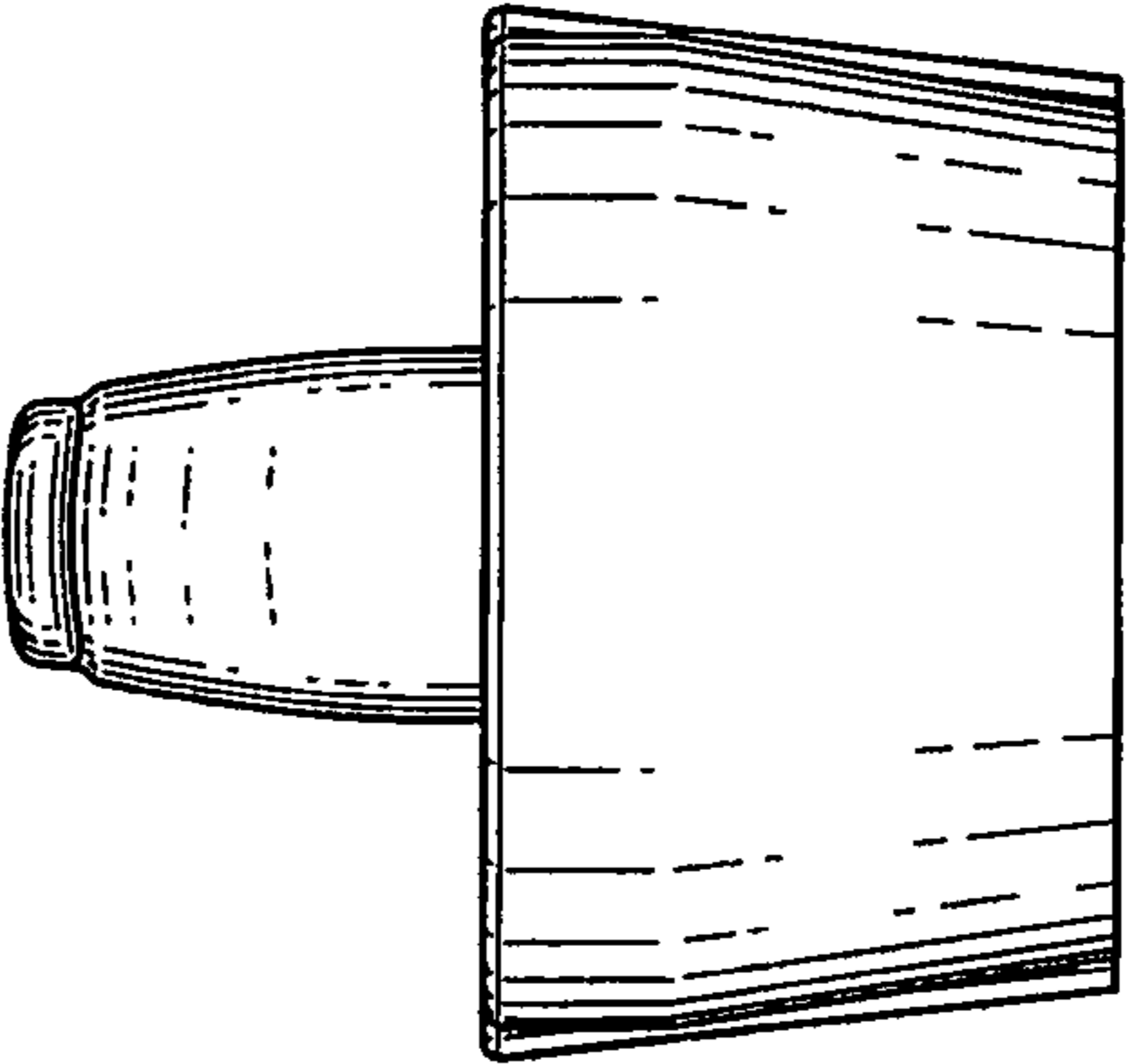
